The ornamental design for an extractor hood, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an extractor hood showing my ornamental design;

FIG. 2 is a perspective view showing the extension of the extractor hood embodiment shown in FIG. 1;

FIG. 3 is a front plan view of the extractor hood embodiment shown in FIG. 1;

FIG. 4 is a right side view showing the extension of the extractor hood embodiment shown in FIG. 2;

FIG. 5 is a right side view of the extractor hood embodiment shown in FIG. 1;

FIG. 6 is a left side view showing the extension of the extractor hood embodiment shown in FIG. 2;

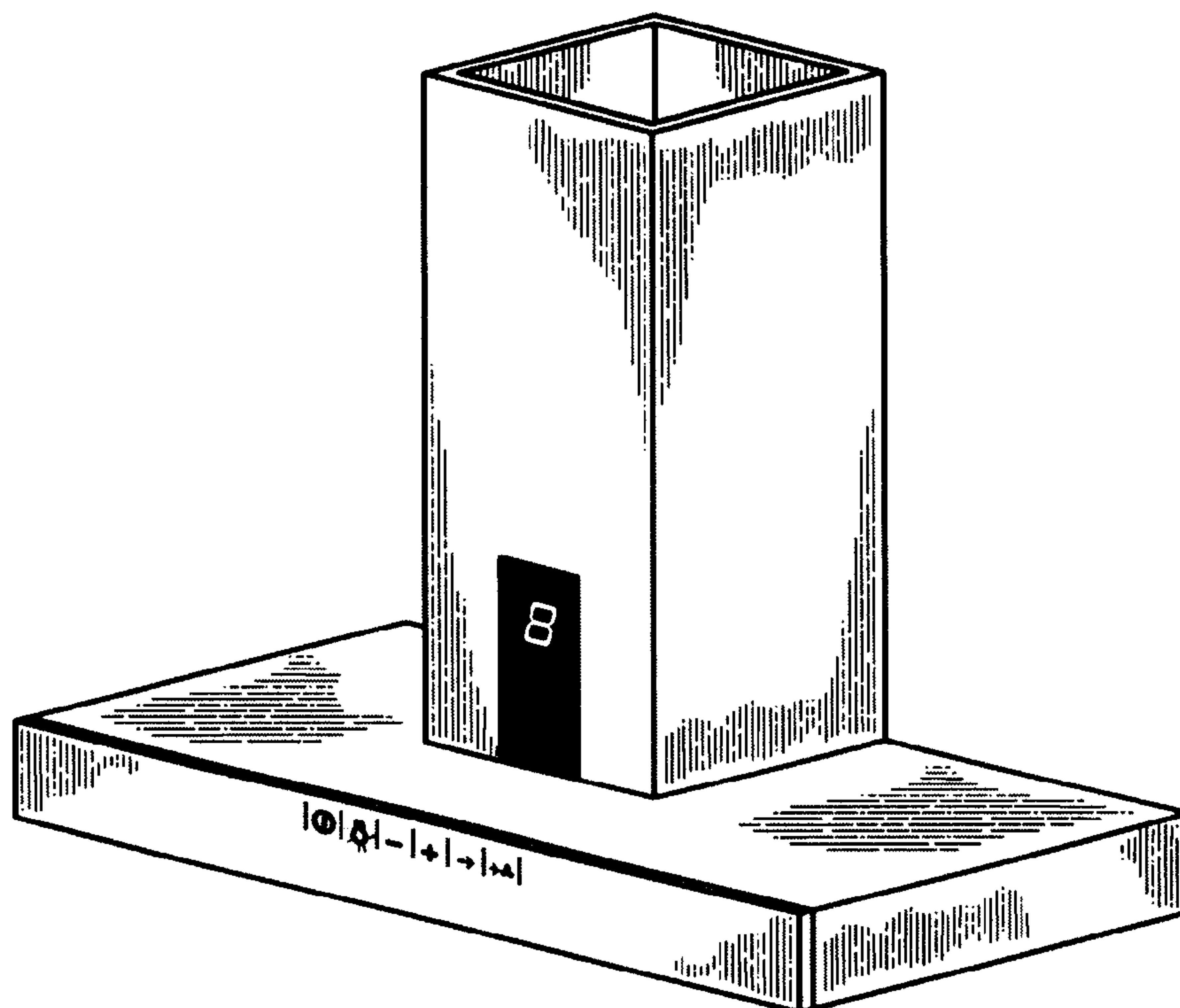
FIG. 7 is a left side view of the extractor hood embodiment shown in FIG. 1;

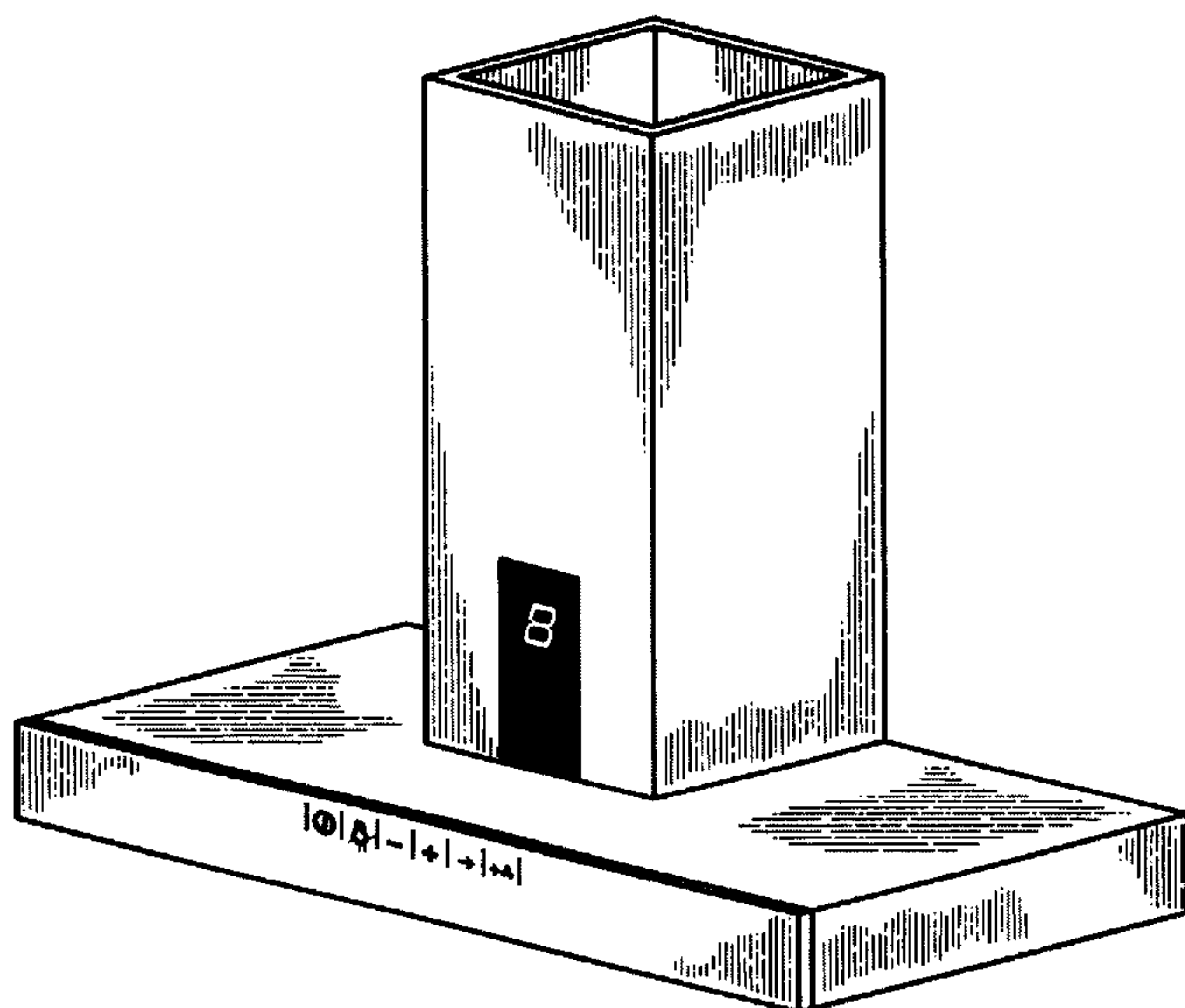

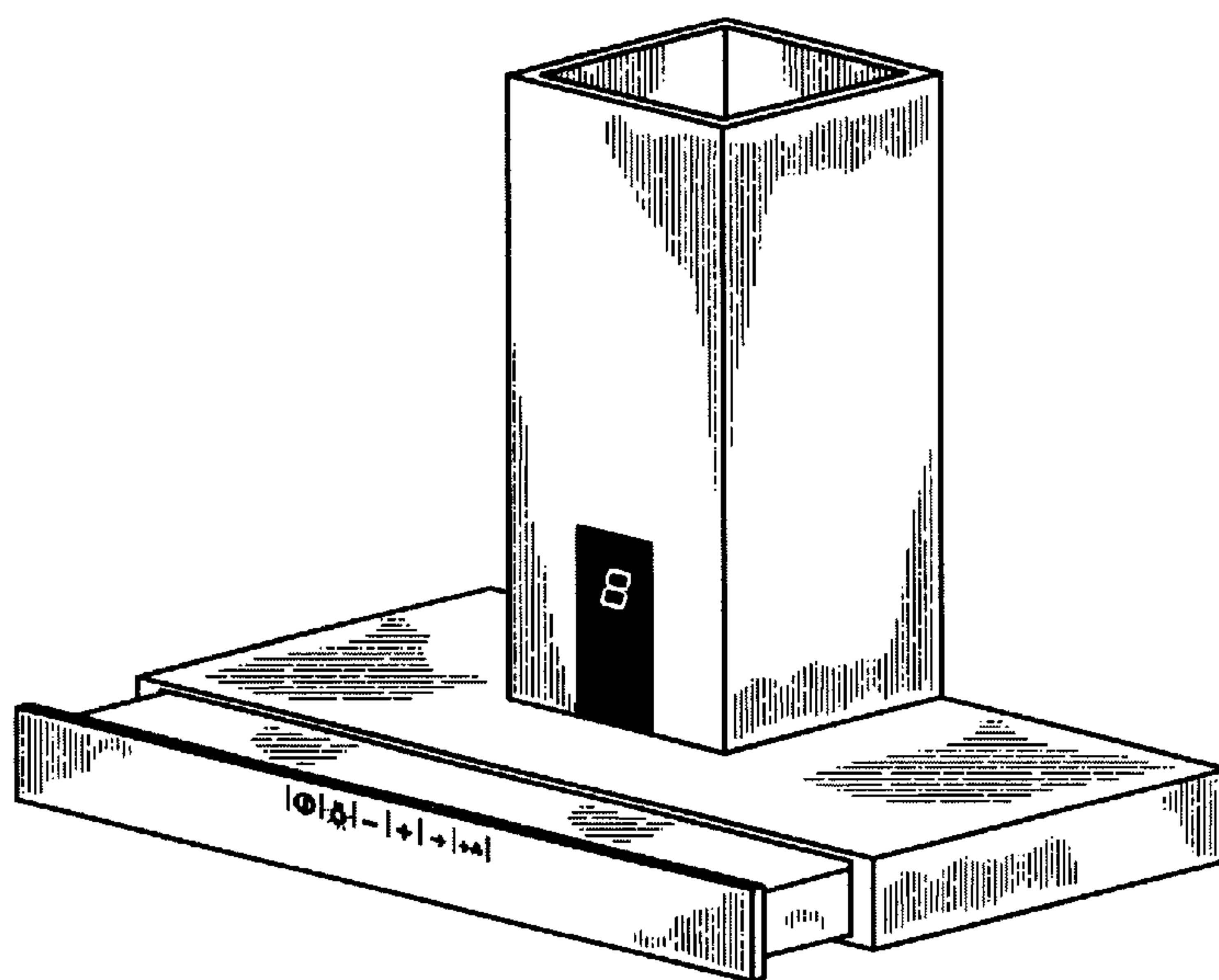

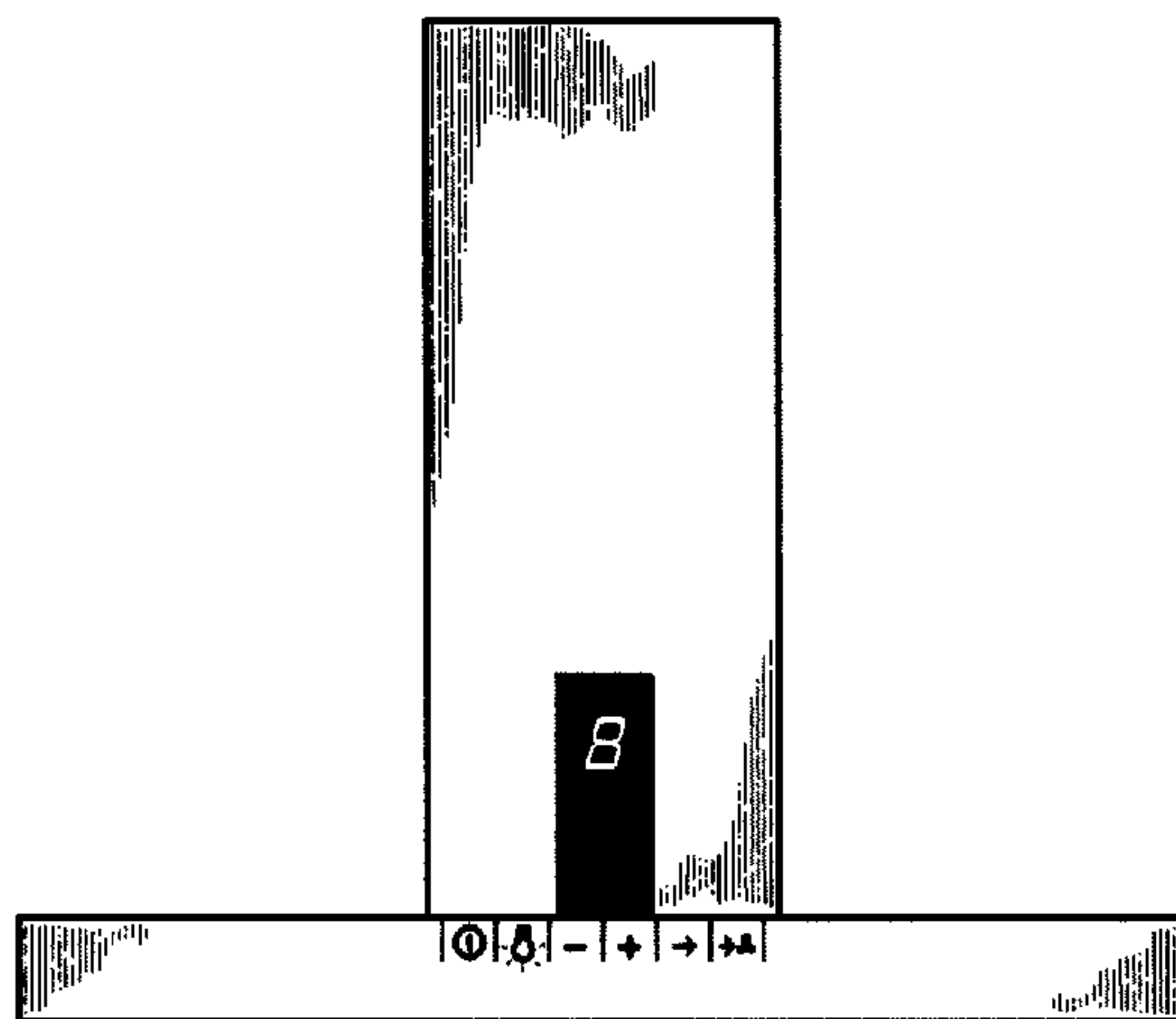

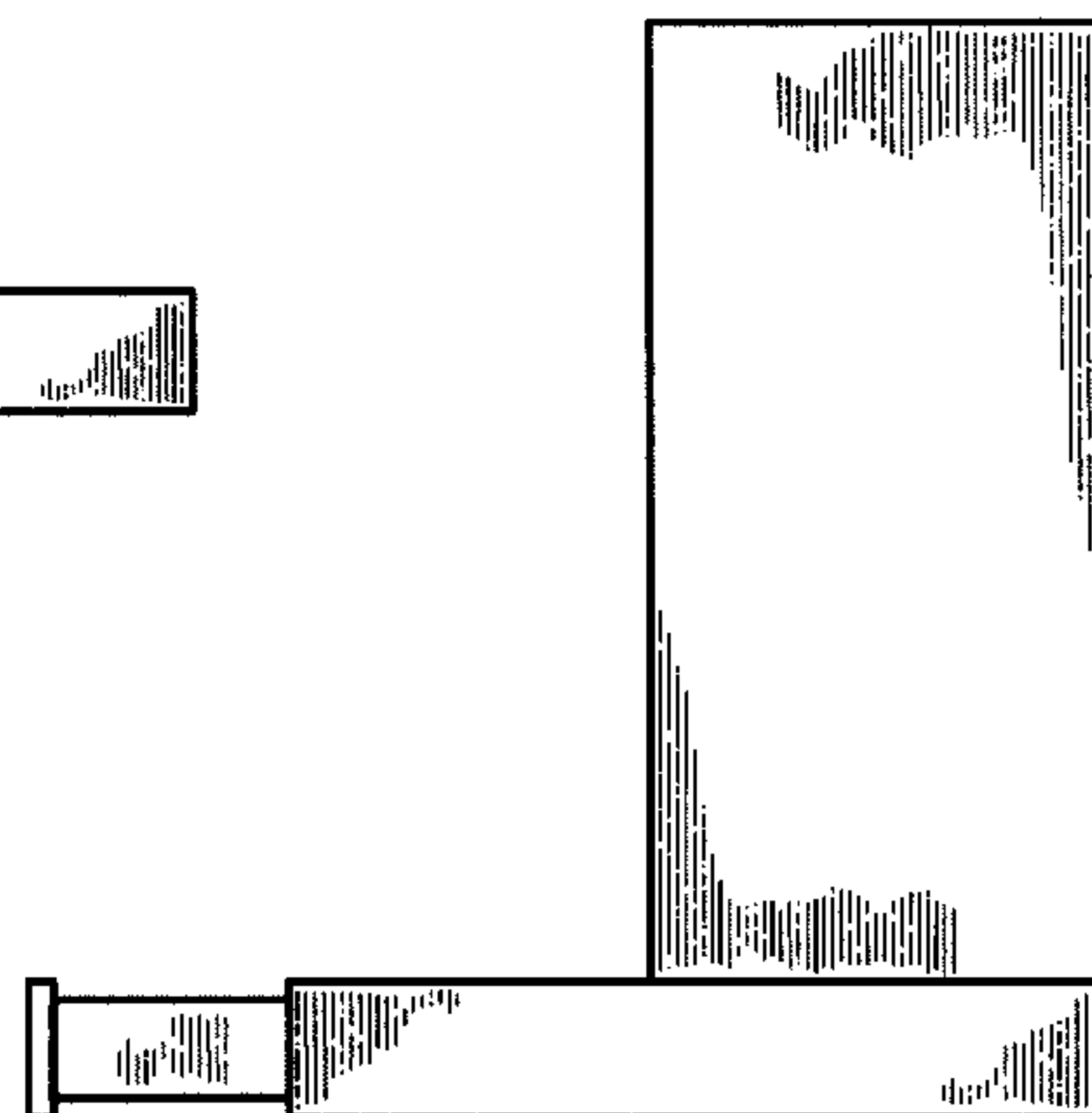

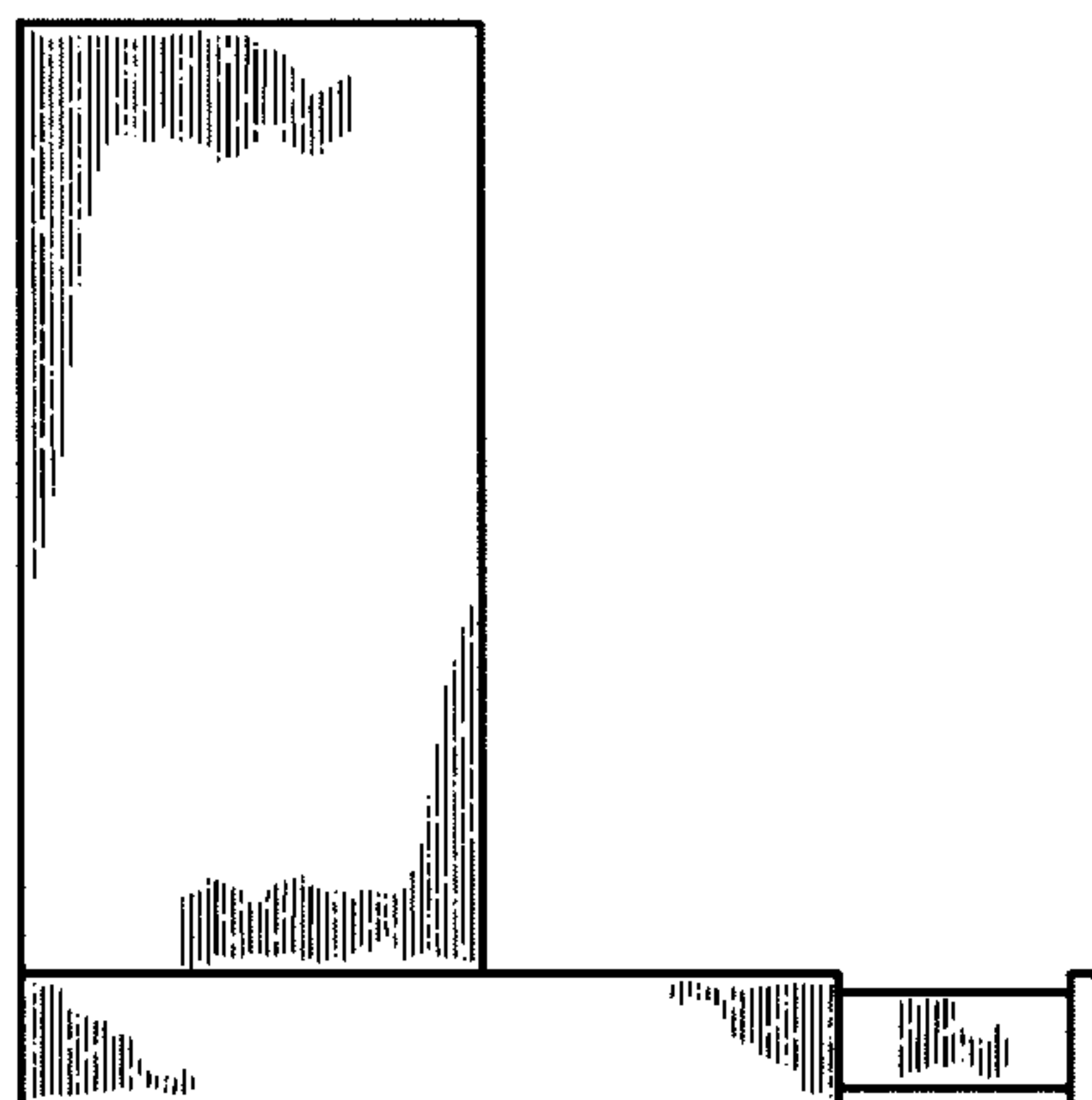

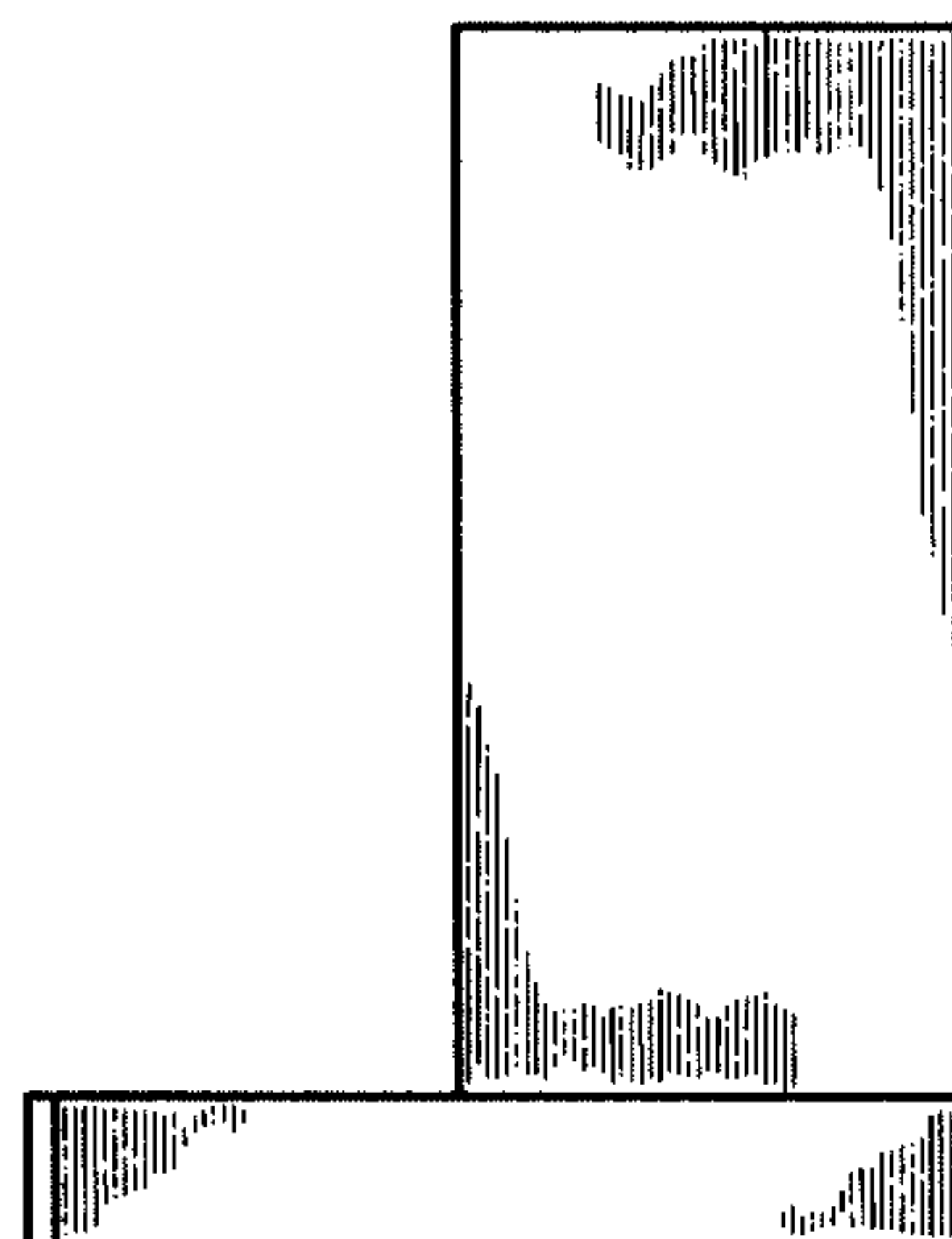

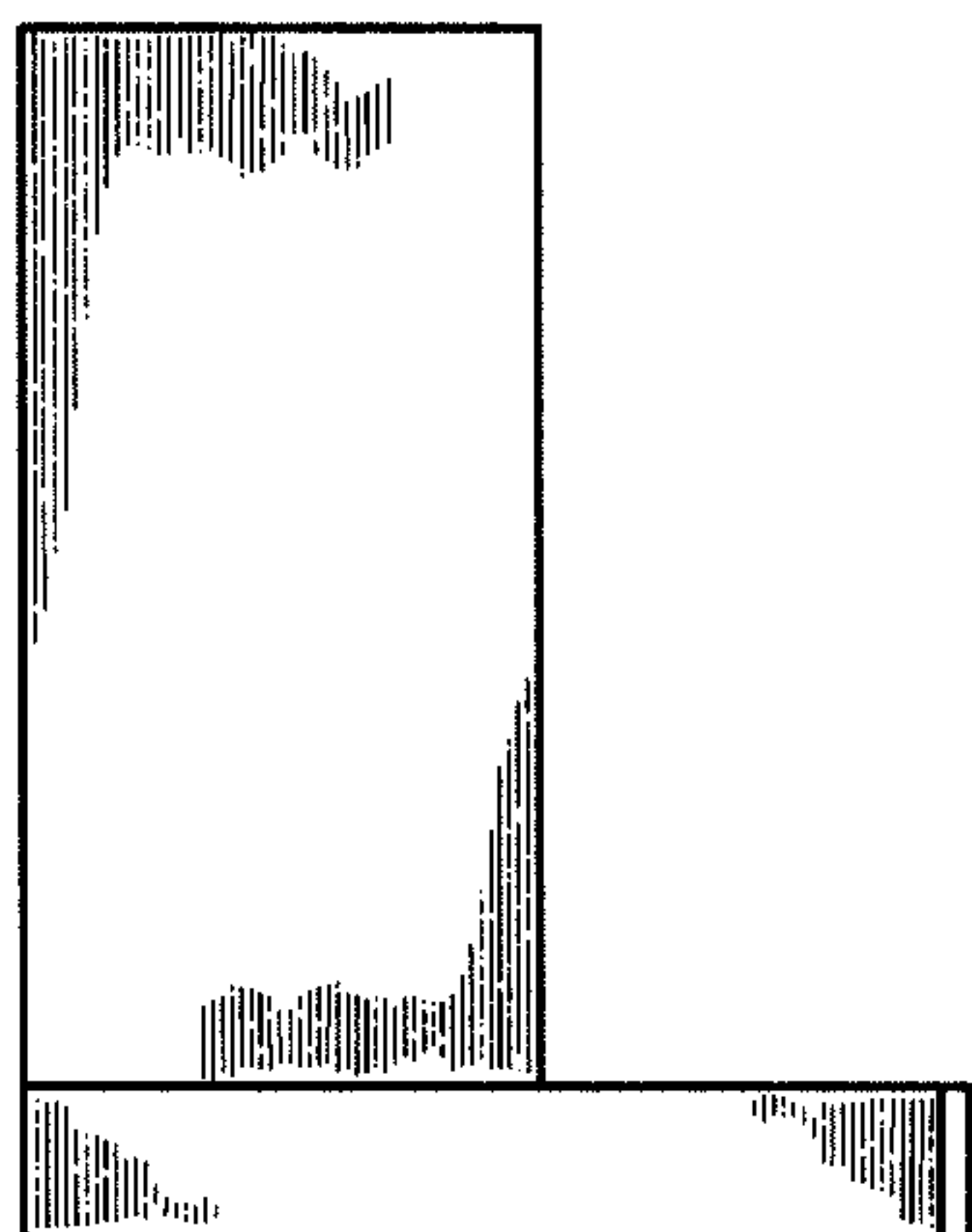

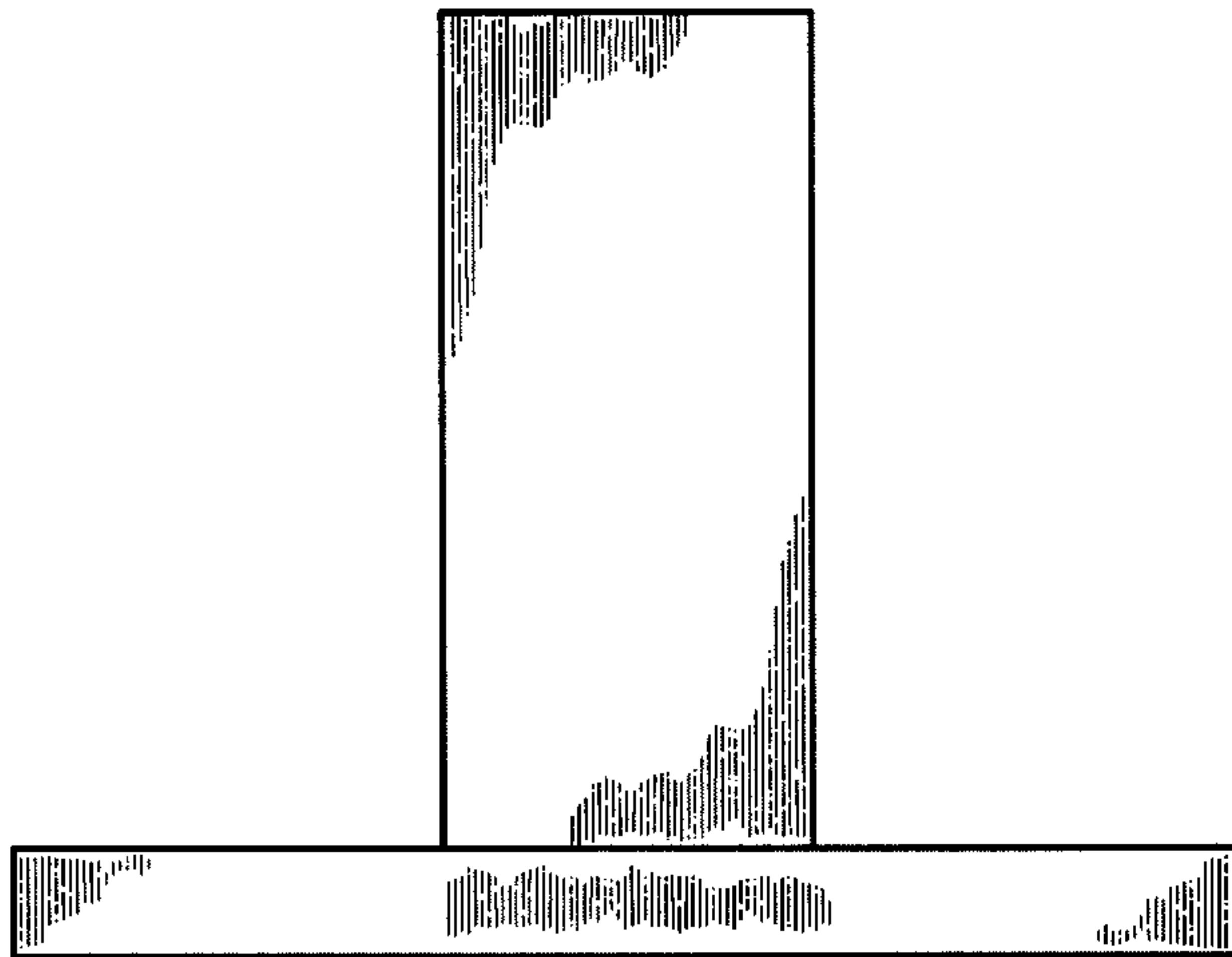

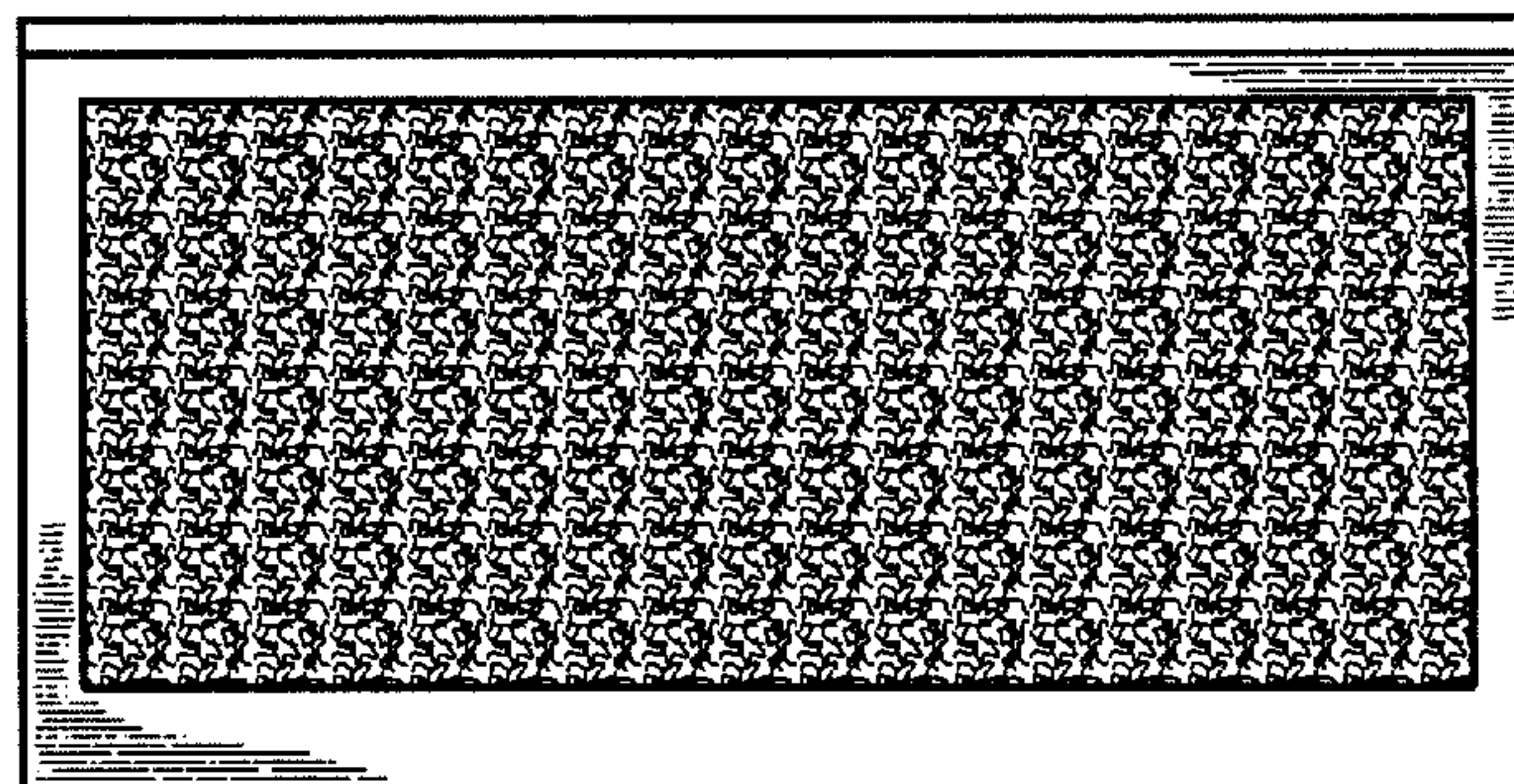

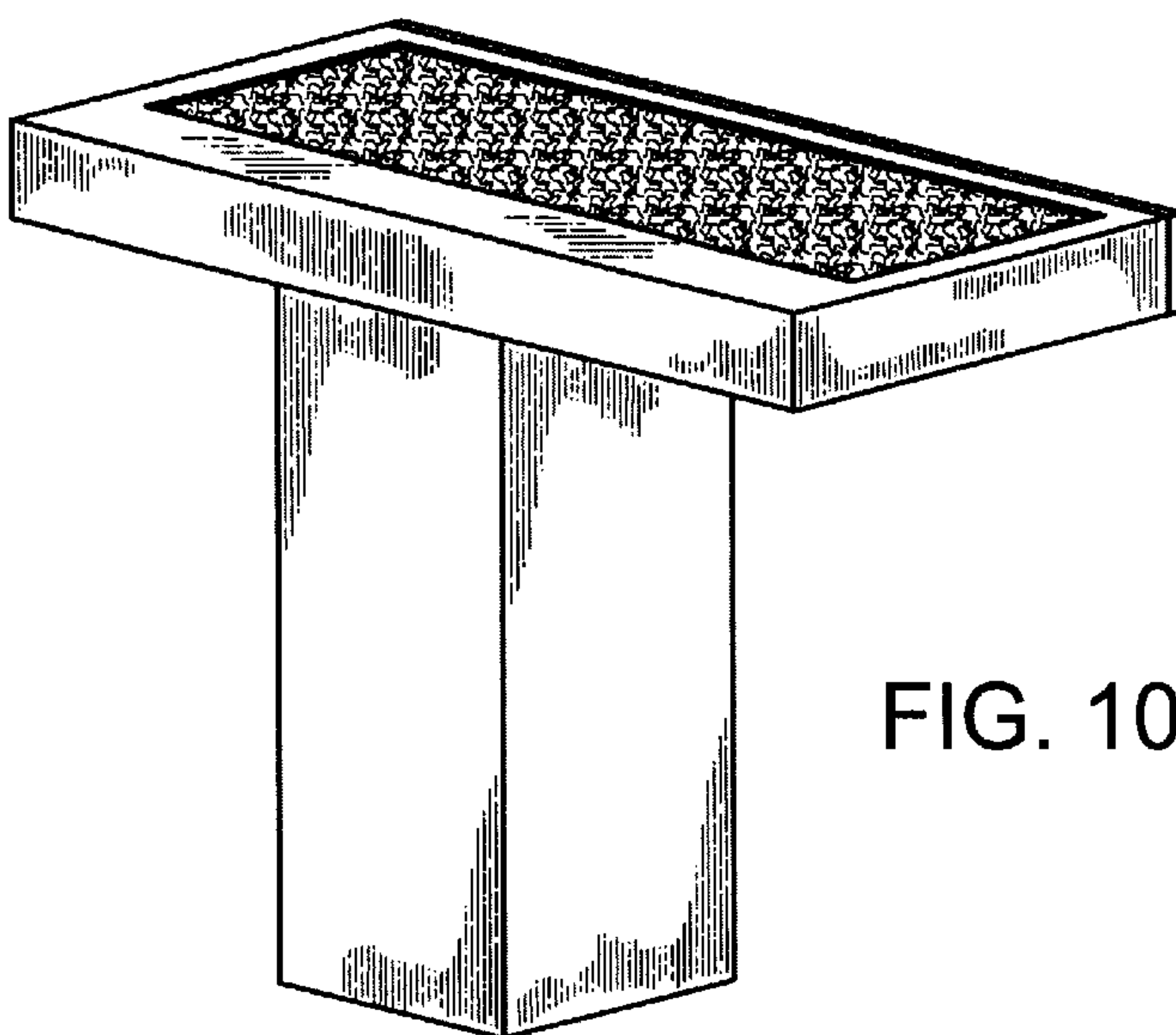
