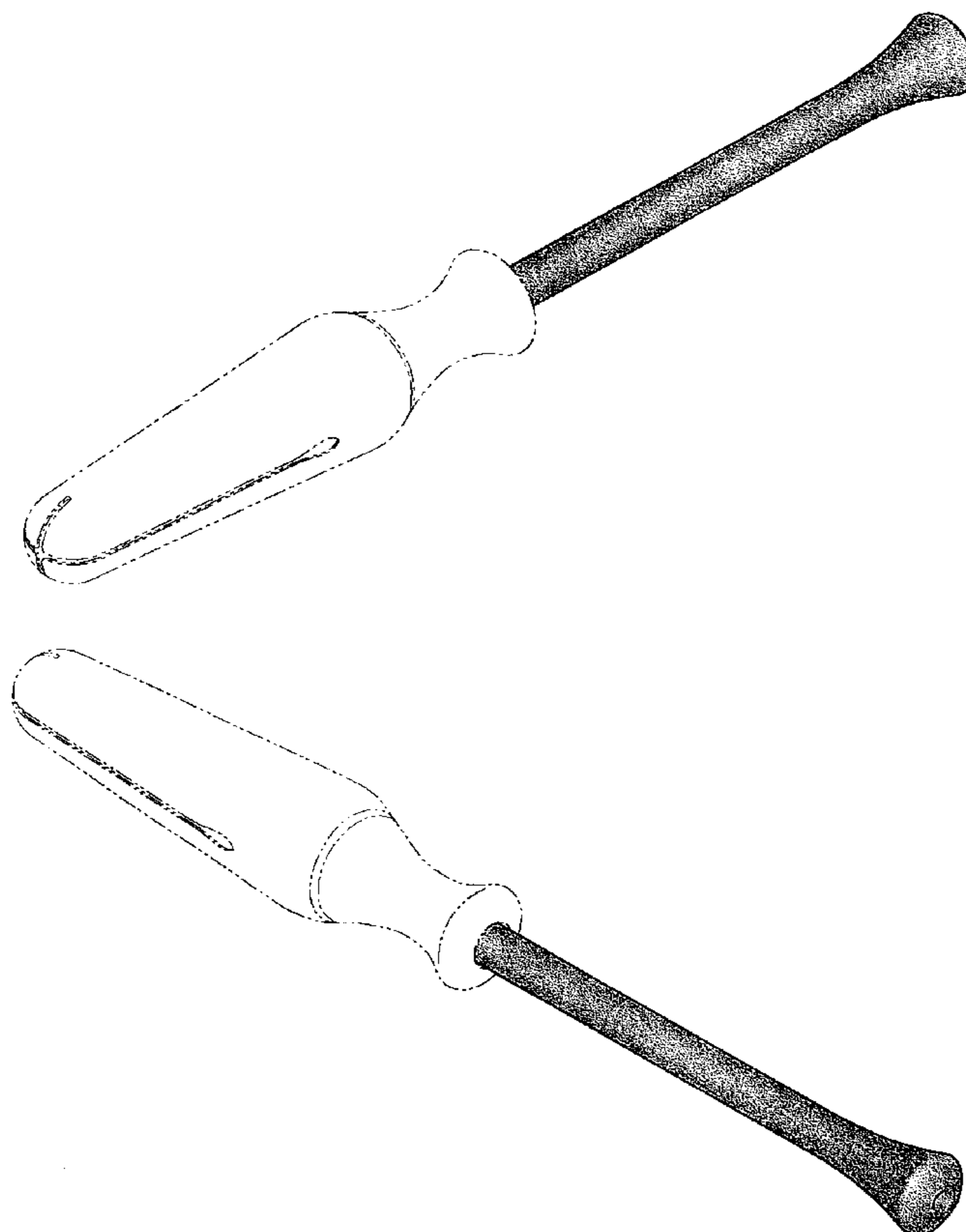
(57) **CLAIM**

The ornamental design for a tampon applicator plunger, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tampon applicator plunger according to the present invention;
FIG. 2 is a rear perspective view of the tampon applicator plunger of FIG. 1;
FIG. 3 is a top view of the tampon applicator plunger of FIG. 1;
FIG. 4 is a front end view of the tampon applicator plunger of FIG. 1; and,
FIG. 5 is a rear end view of the tampon applicator plunger of FIG. 1.

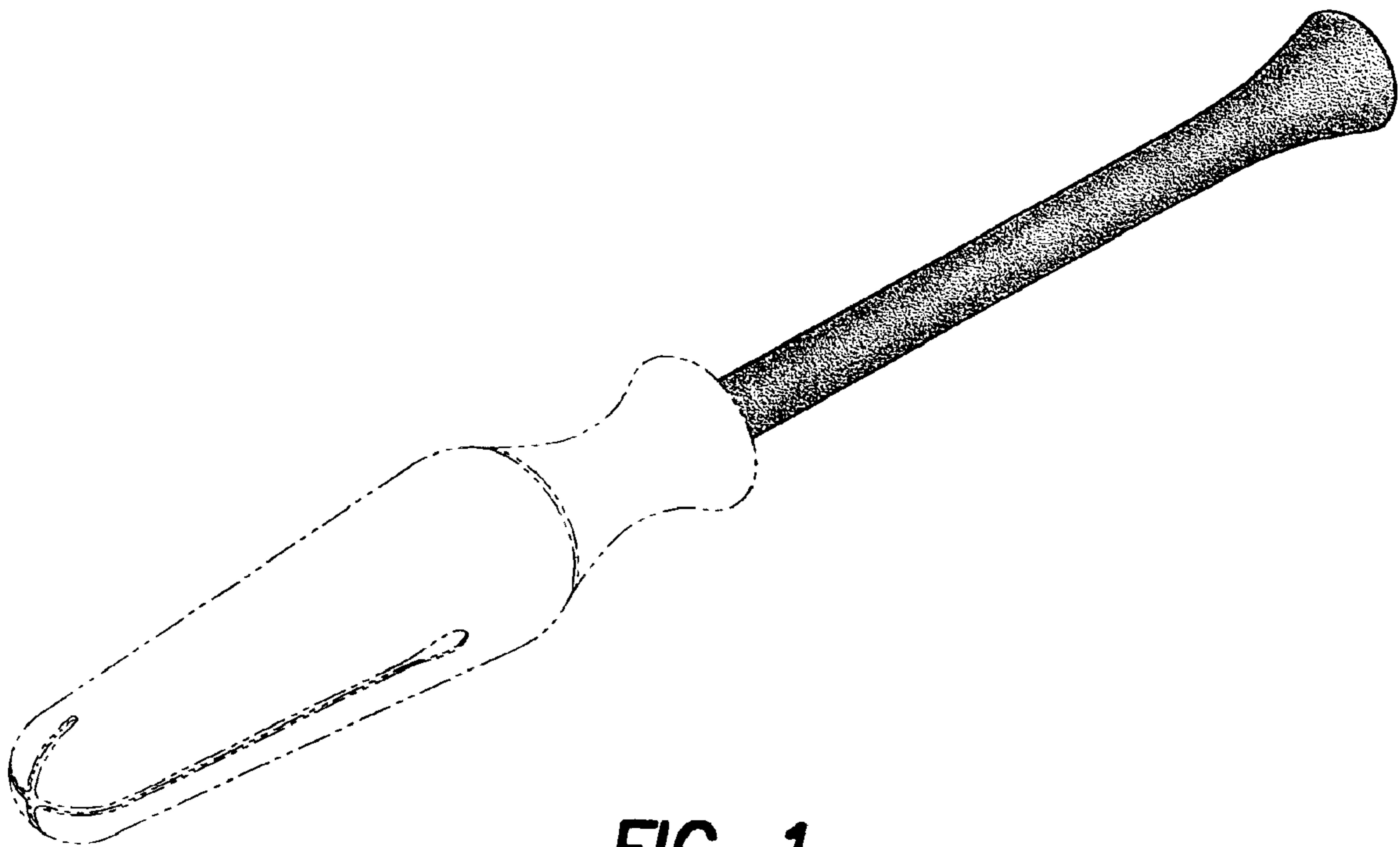

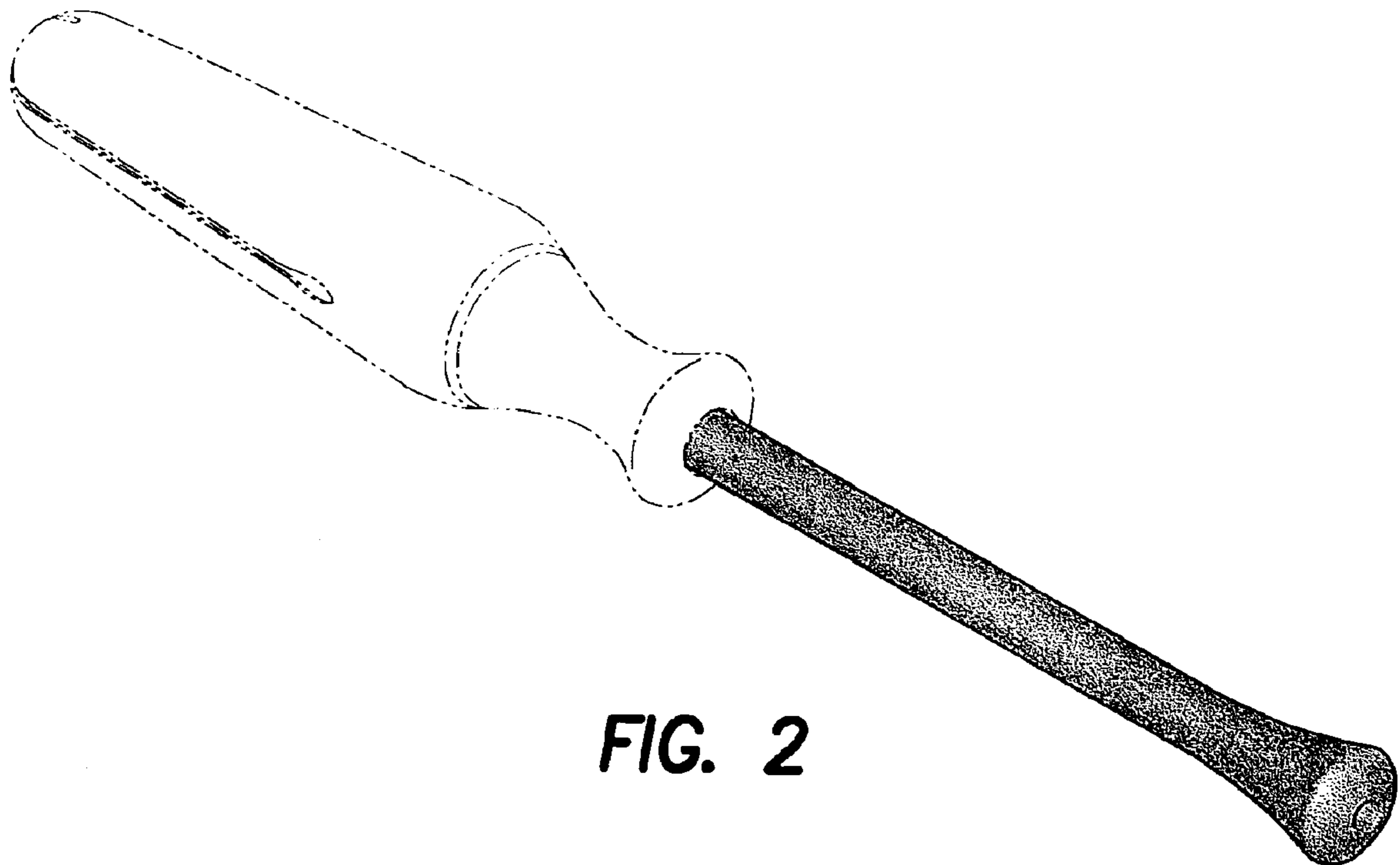

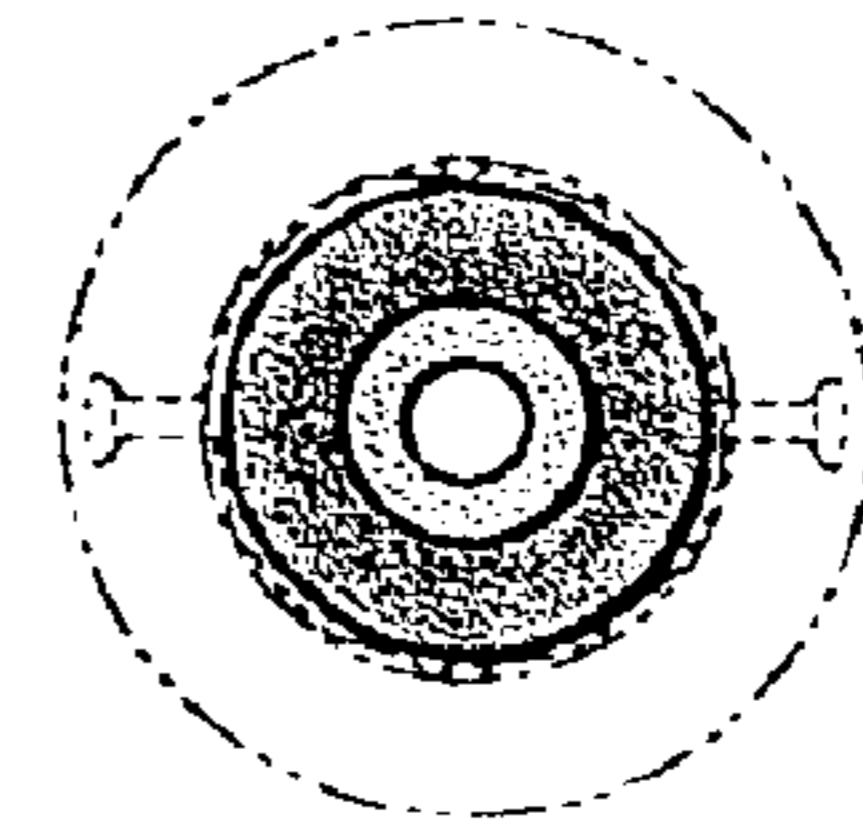
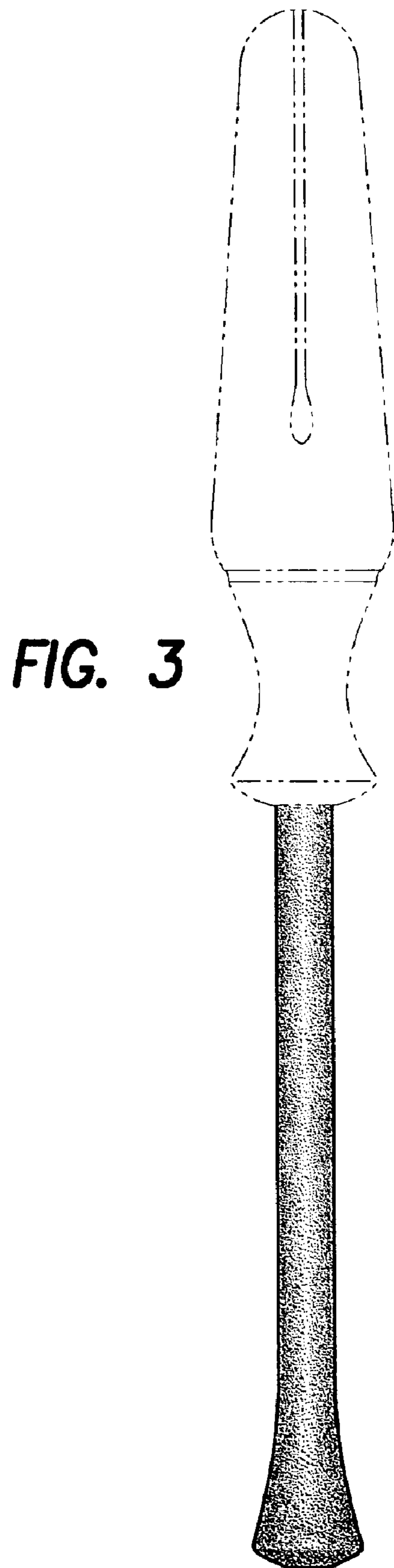

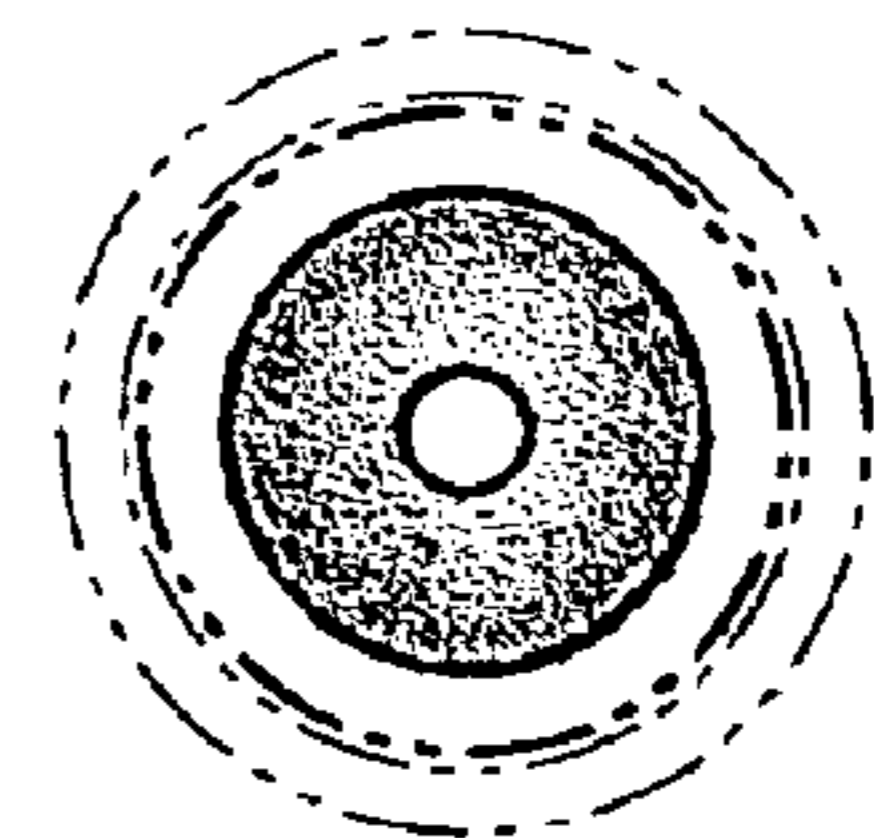
