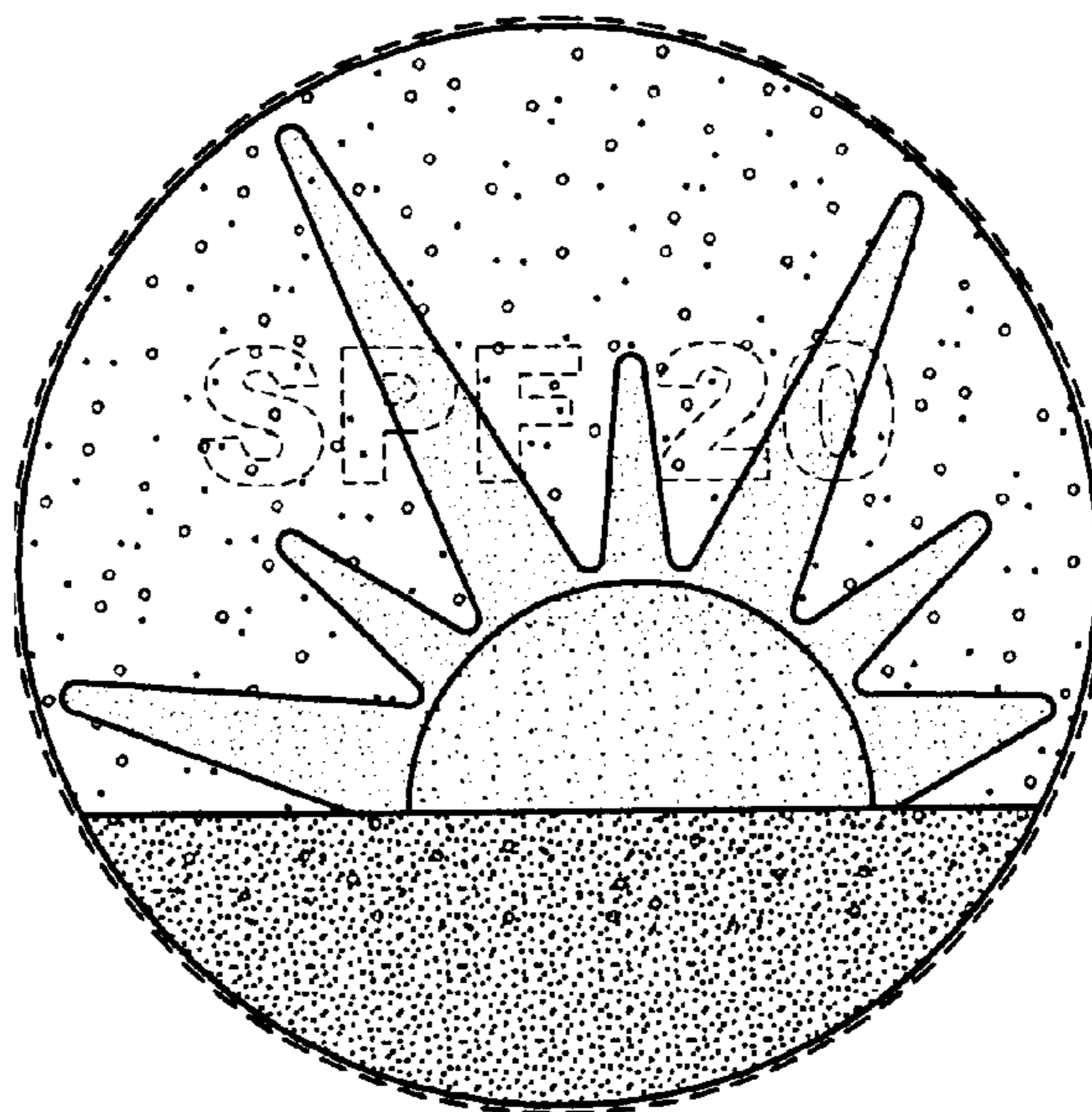
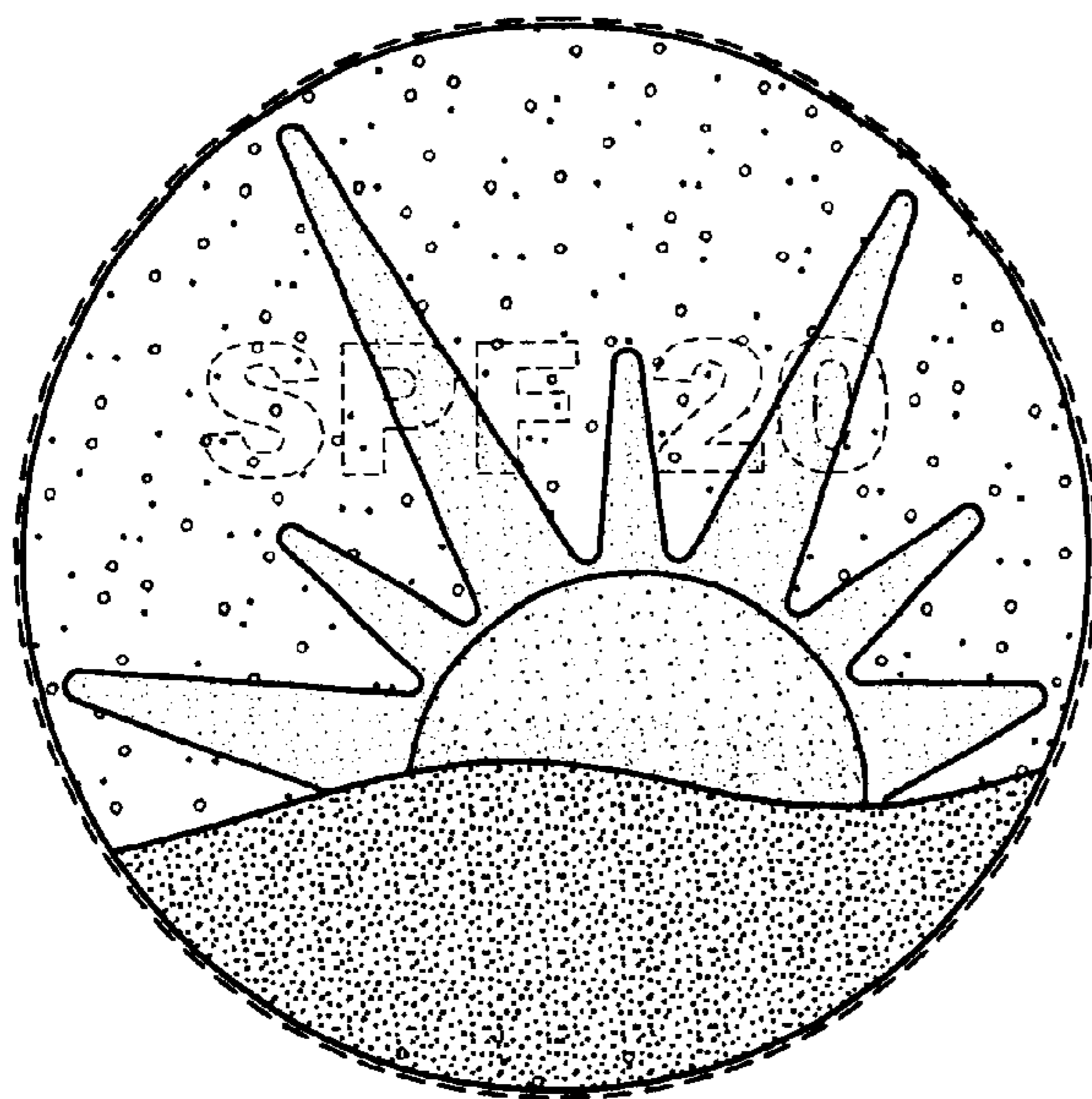
(57) **CLAIM**

The ornamental design for a cosmetic block, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cosmetic block showing my new design; and, FIG. 2 is a top plan view of a second embodiment thereof, the difference being the configuration of the horizon. The bottom plan view of the cosmetic block for each of these embodiments is a flat unornamented surface. The "SPF 20" shown in broken lines in each of these drawings is for illustrative purposes and forms no part of the claimed design. 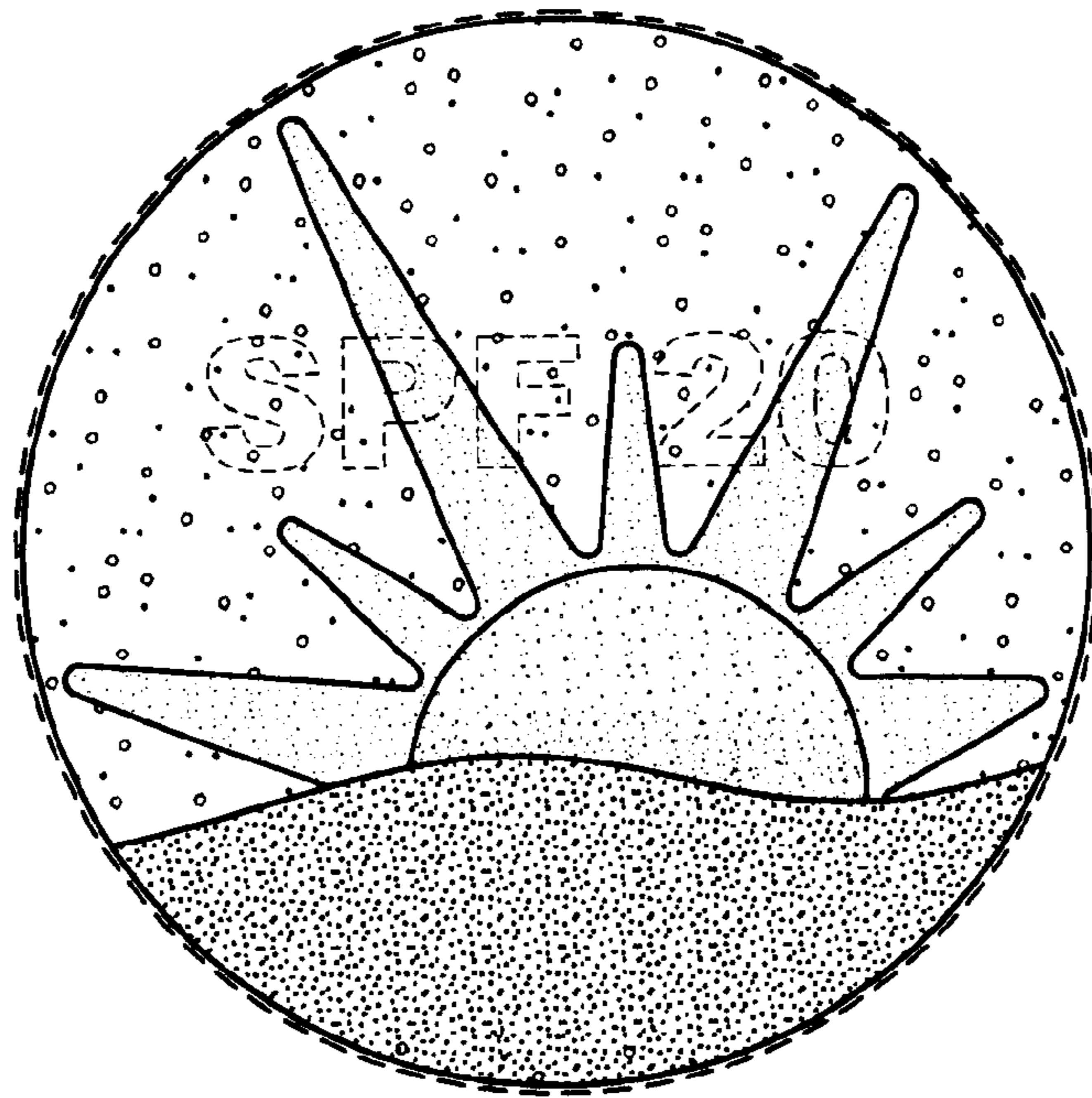

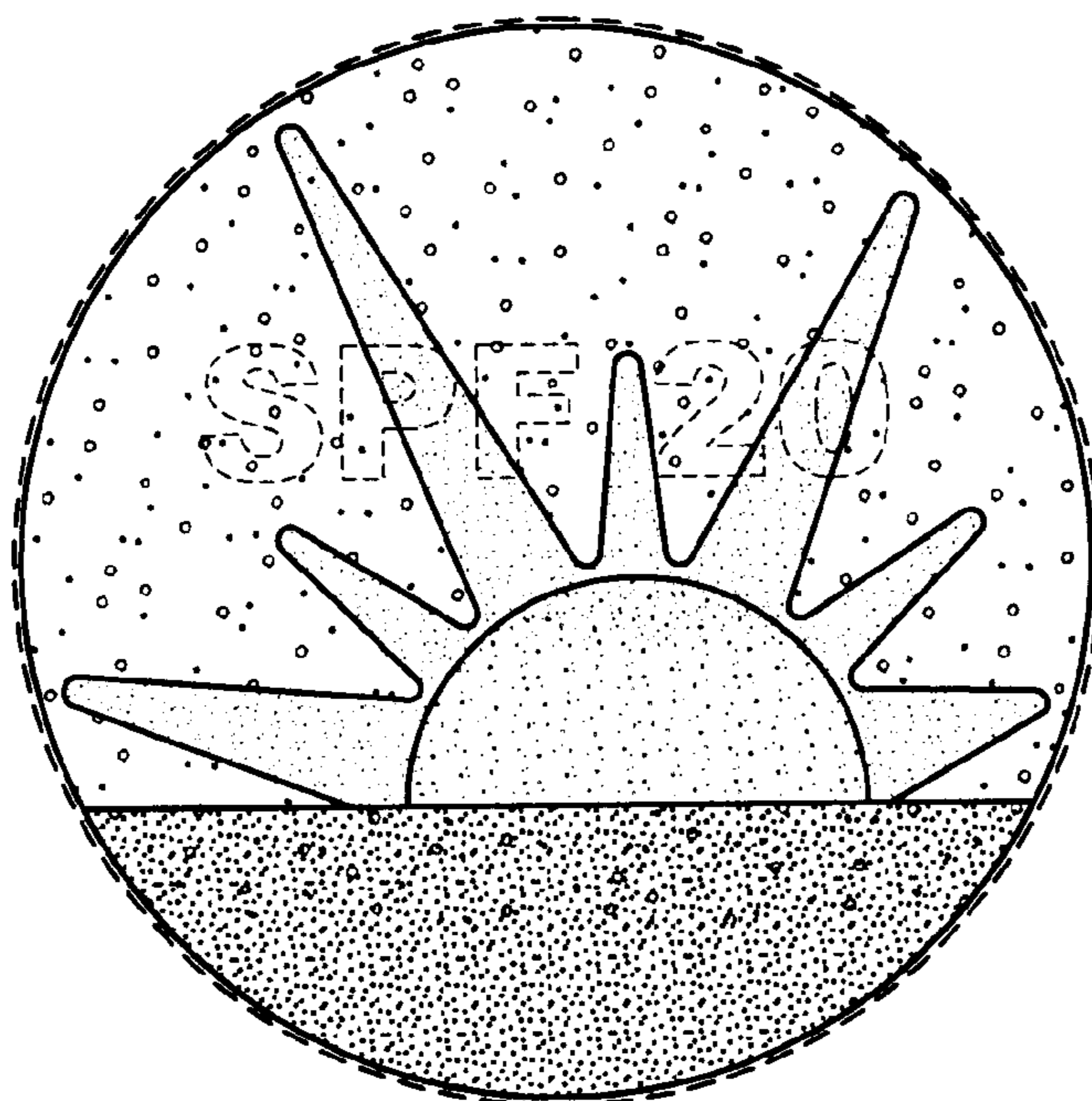
