FIG. 1 is a top, rear perspective view of a right foot athletic shoe having a heel showing our new design, the athletic shoe is shown for context but is not a portion of the claimed design and a left foot athletic shoe would be a mirror image thereof,

FIG. 2 is a bottom, rear perspective view thereof,

FIG. 3 is a back elevation view thereof,

FIG. 4 is a side view thereof,

FIG. 5 is a top, rear perspective view of a larger shoe having a larger heel showing our new design thereof; and,

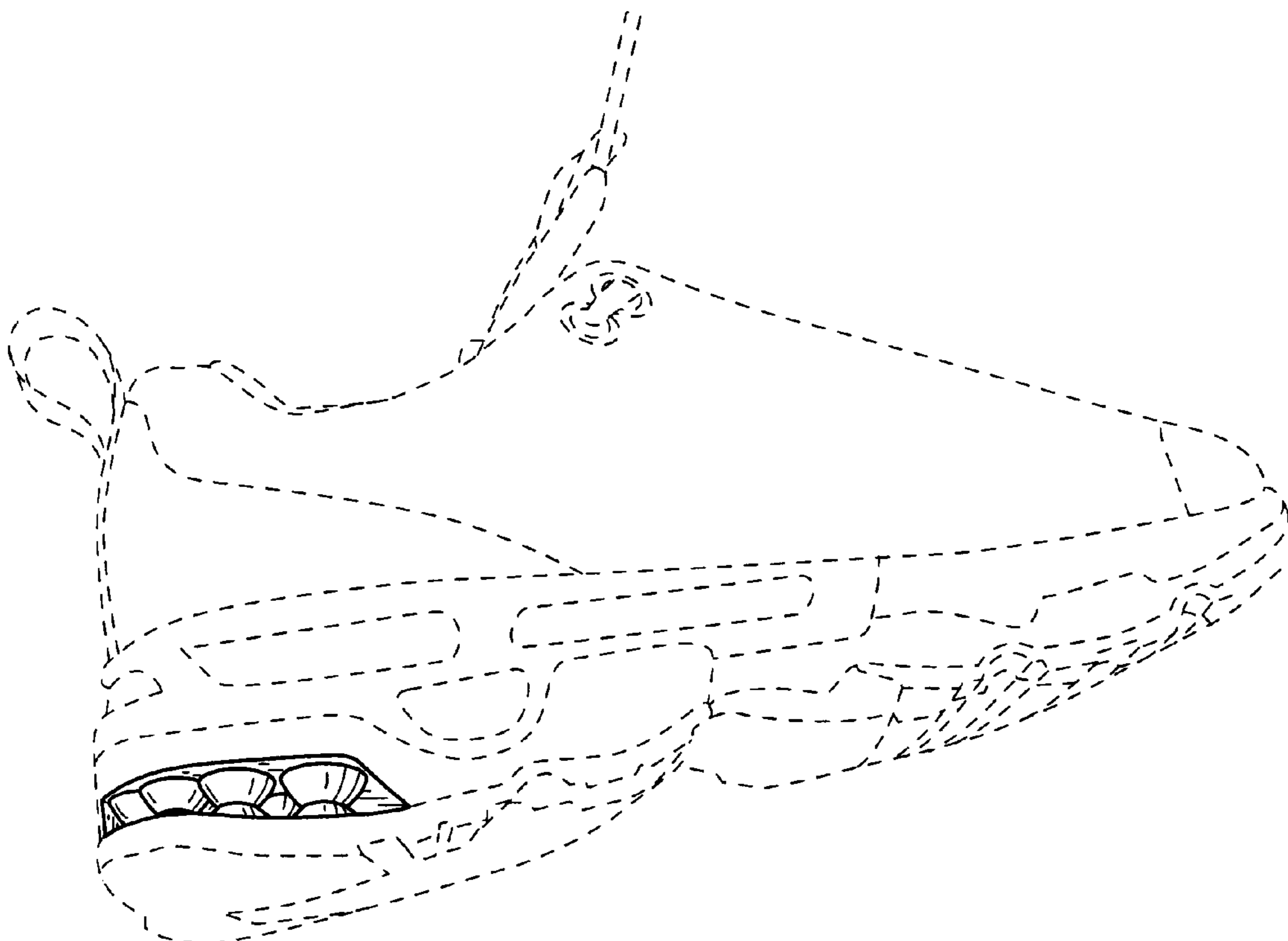
FIG. 6 is a top, rear perspective view of a smaller shoe having a smaller heel showing our new design thereof.

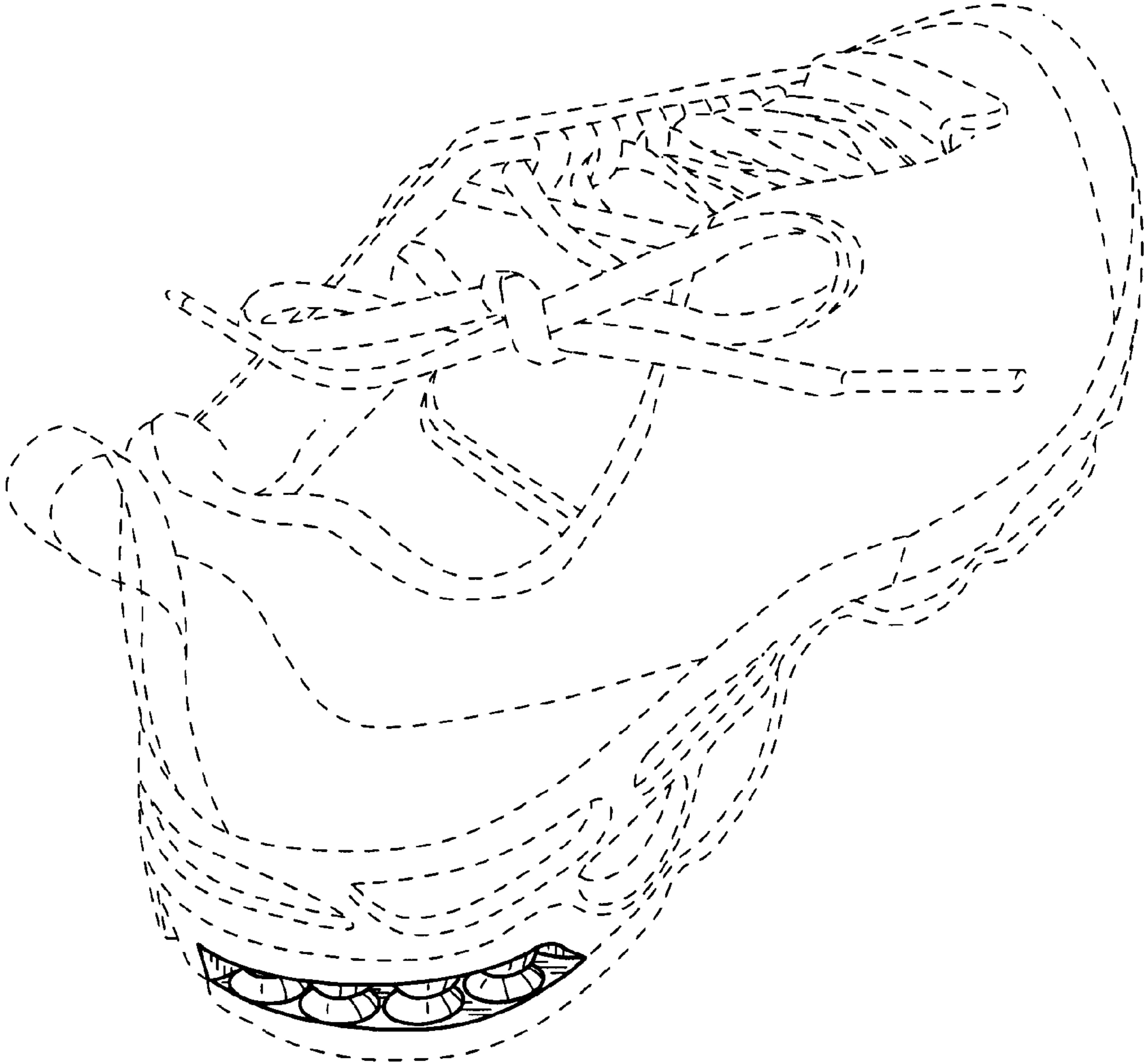

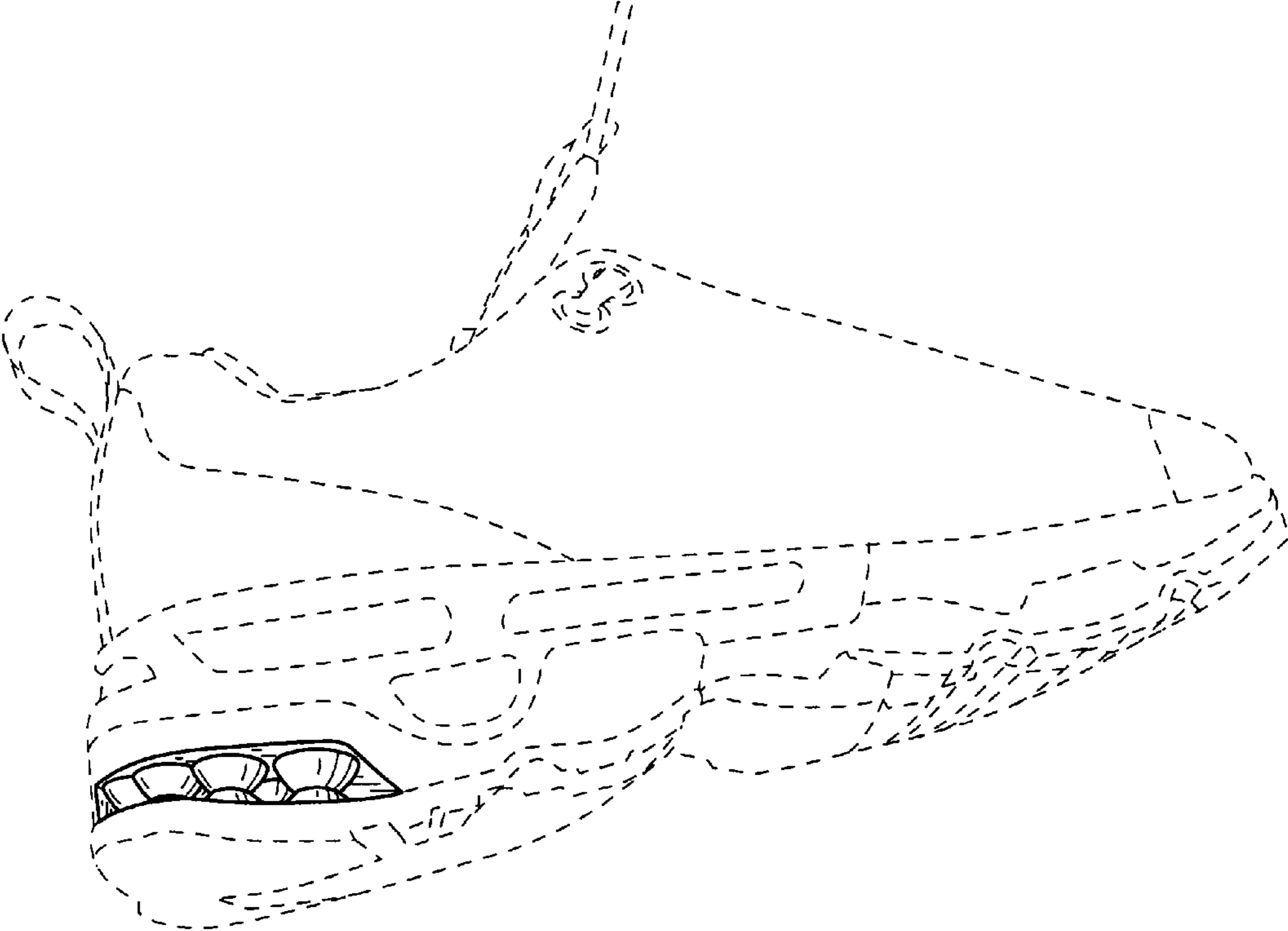

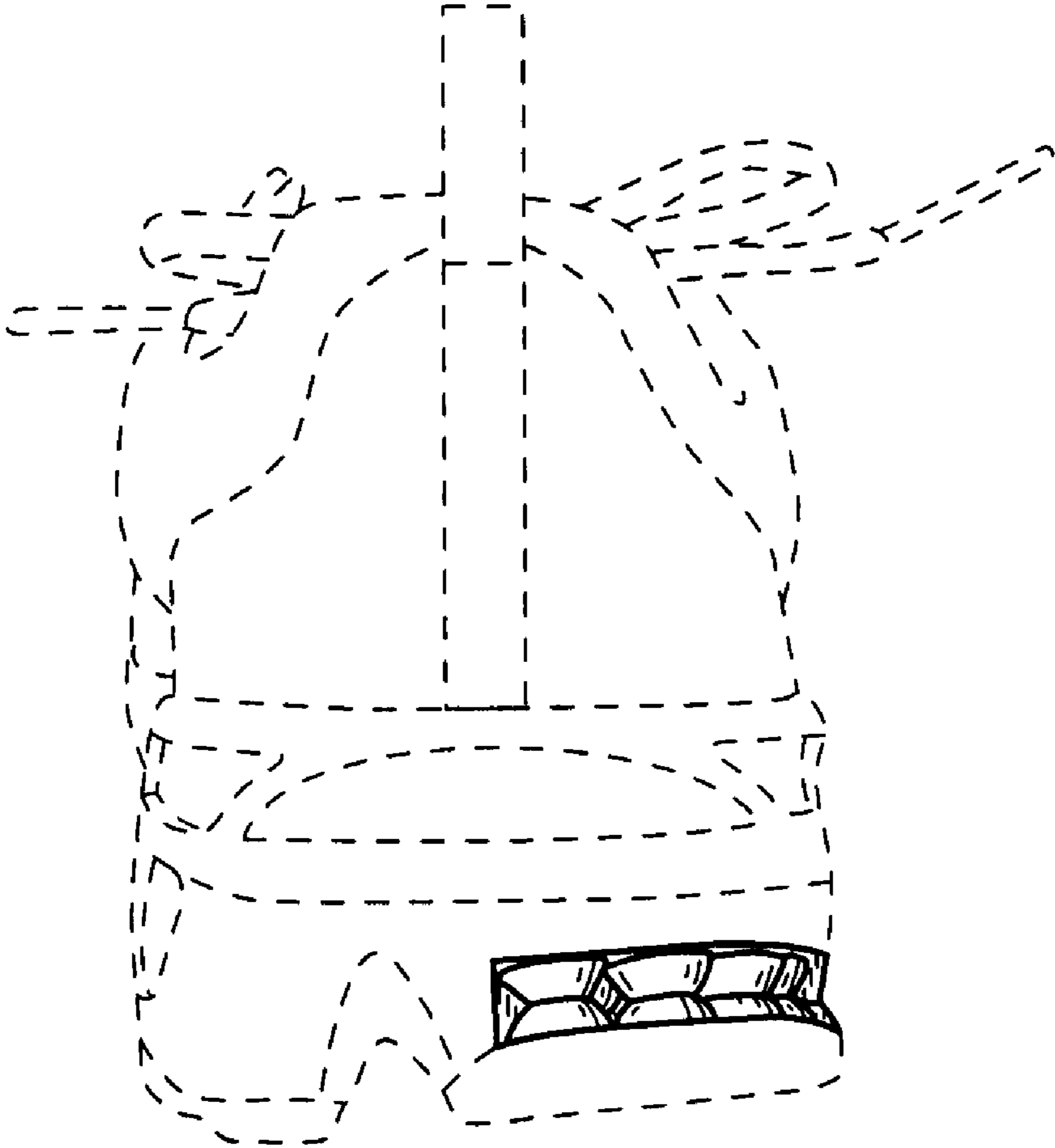

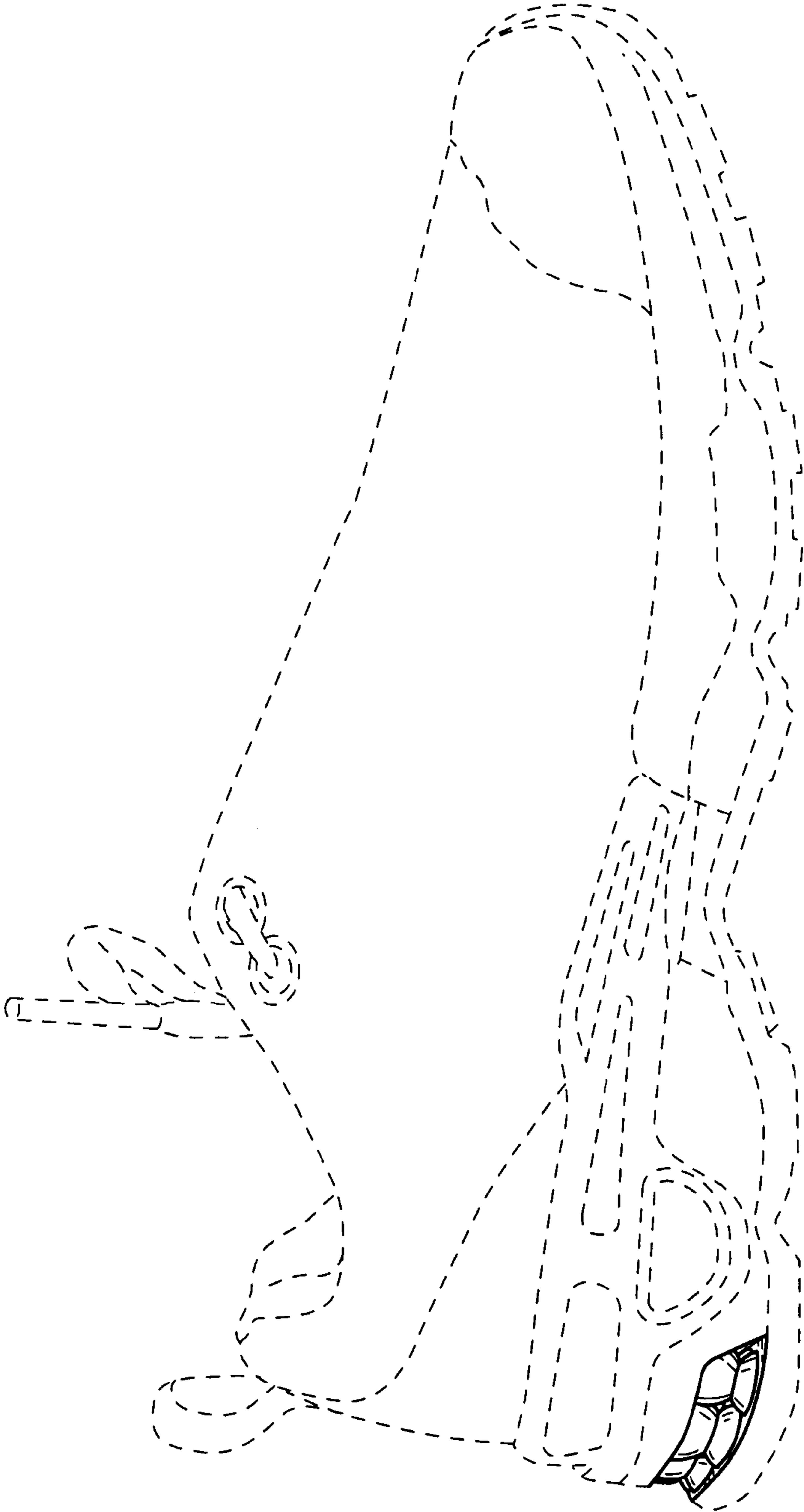

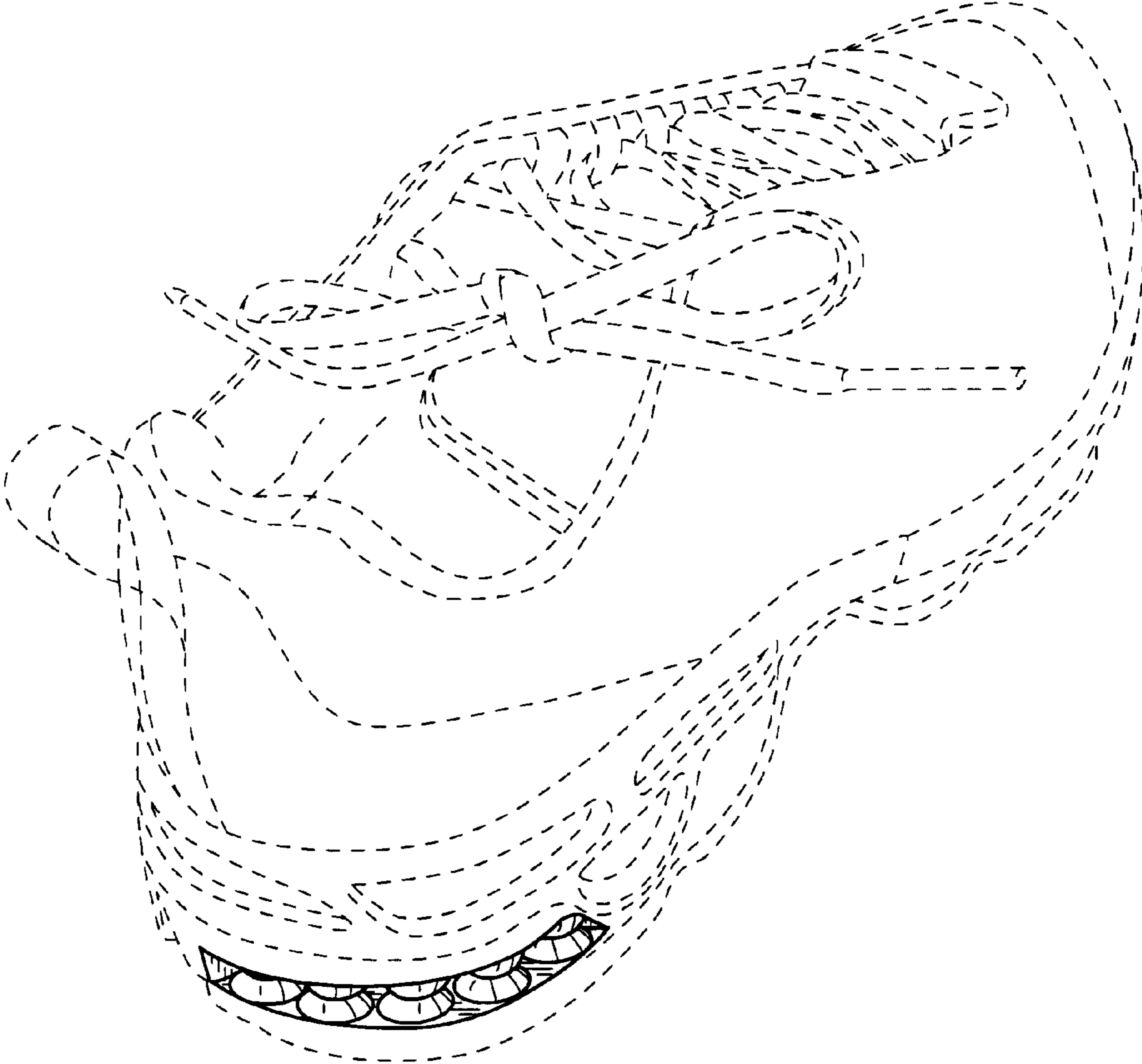

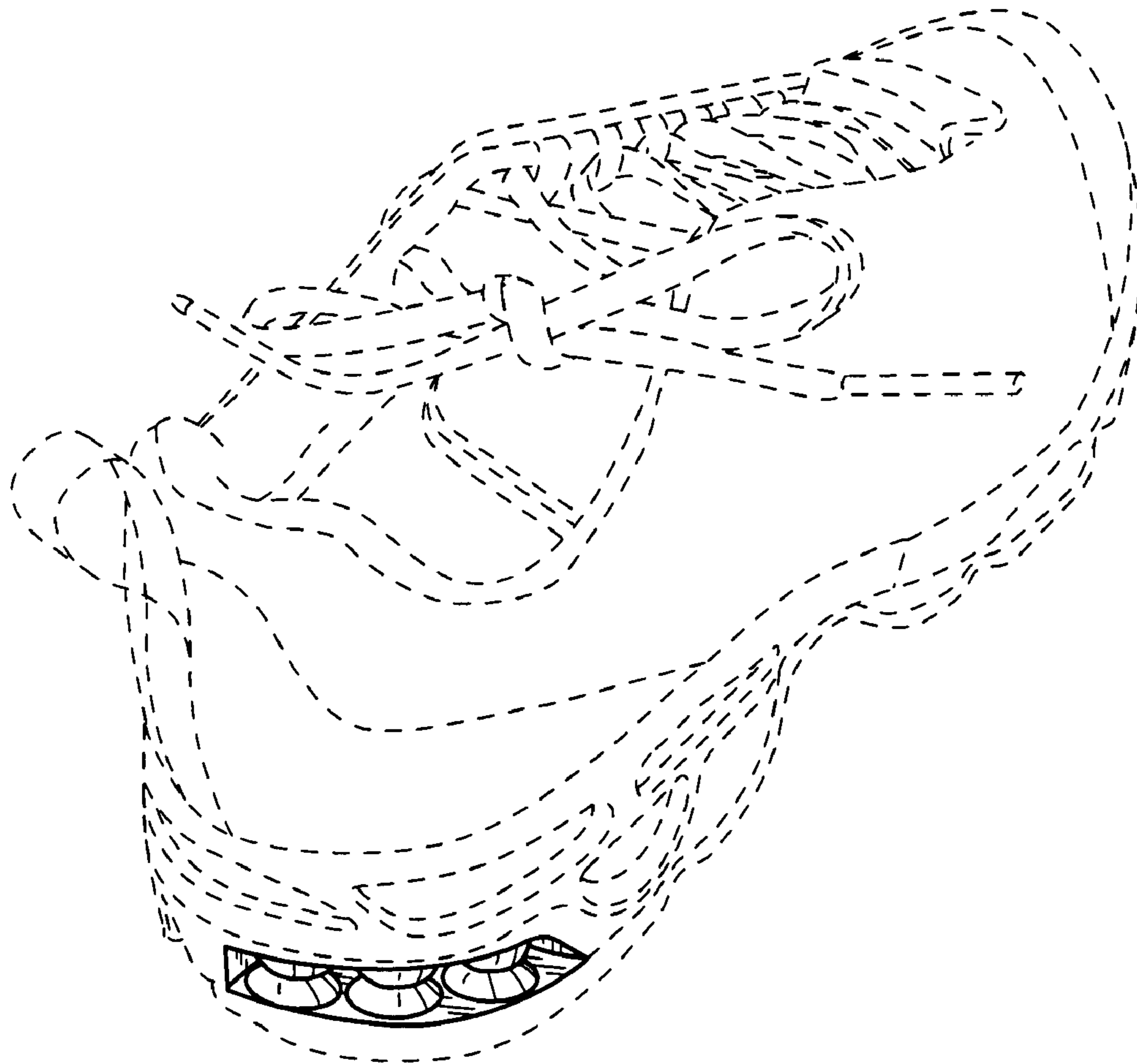


FIG. 6
