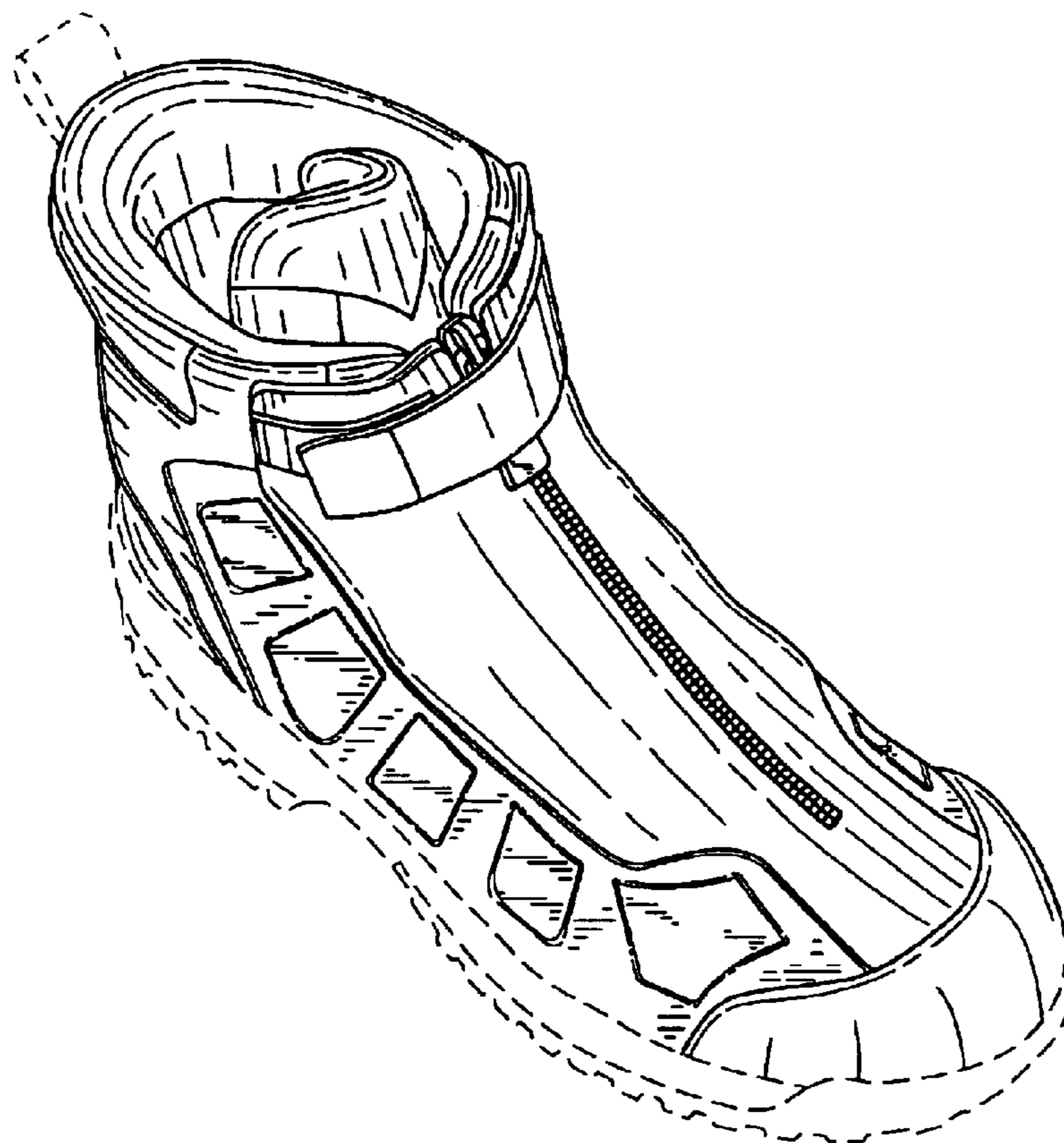

In FIGS. 1–7, the outsole, laces, and heel loop shown in broken lines do not form any part of the claimed design.

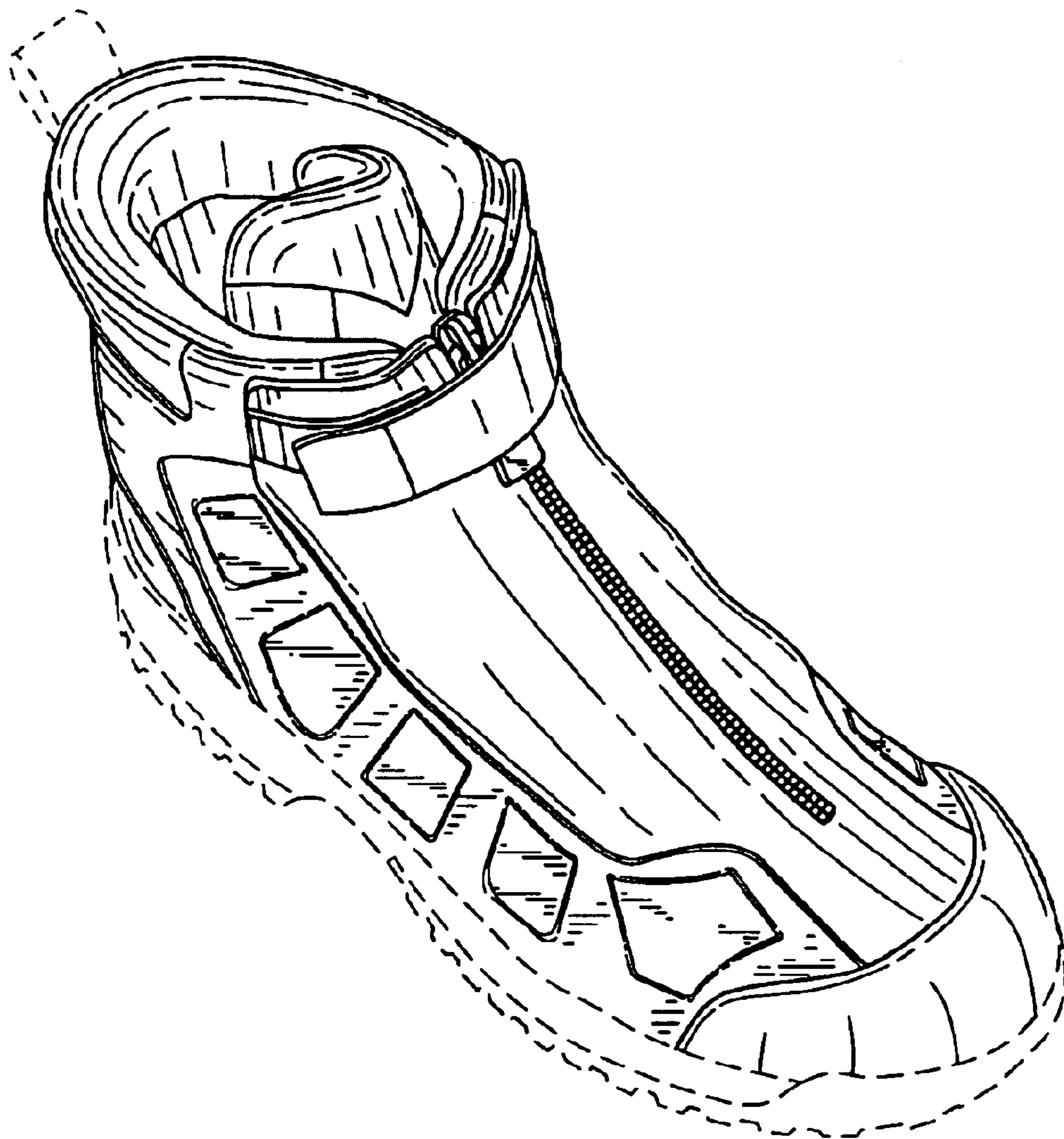

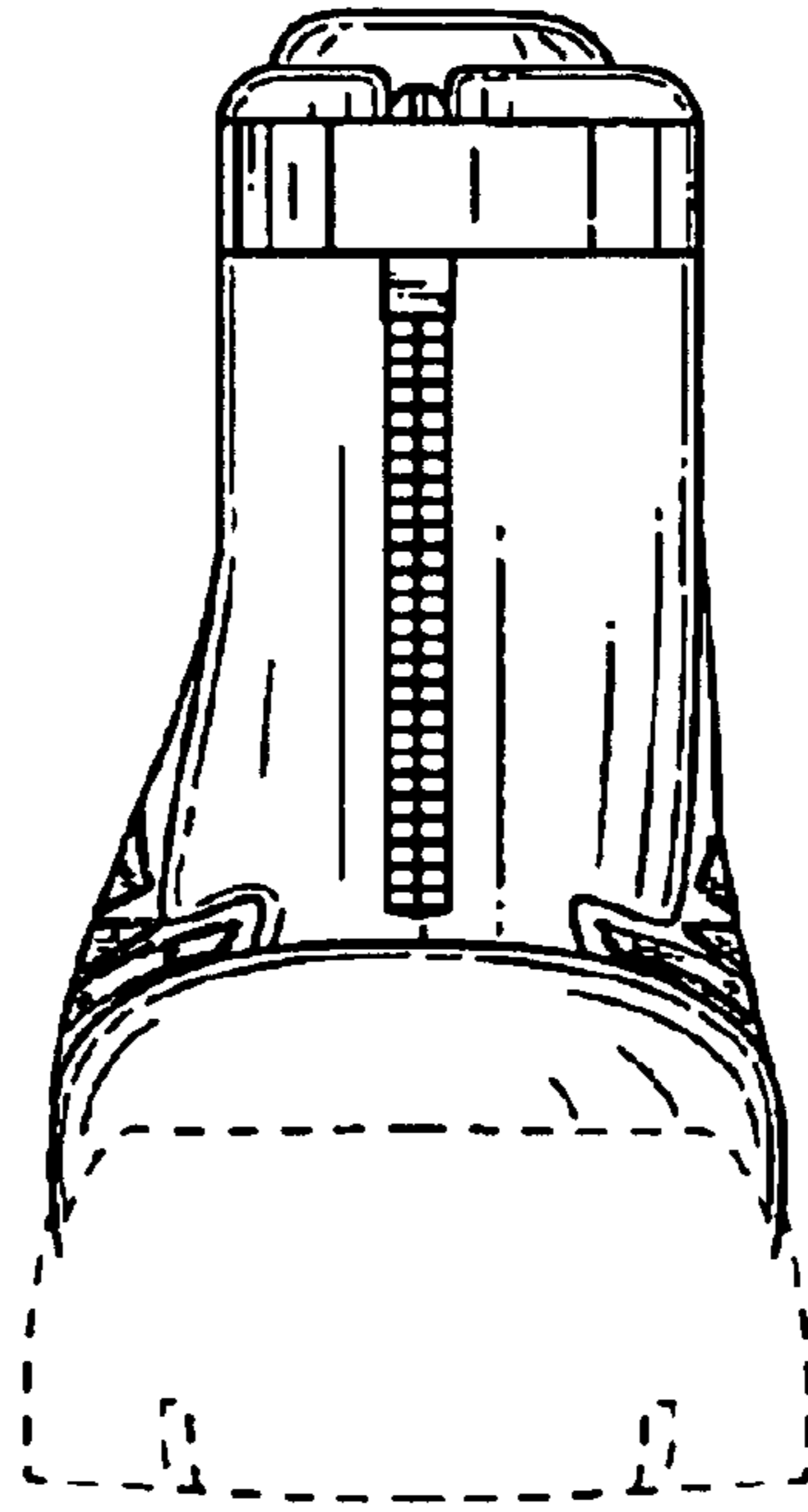

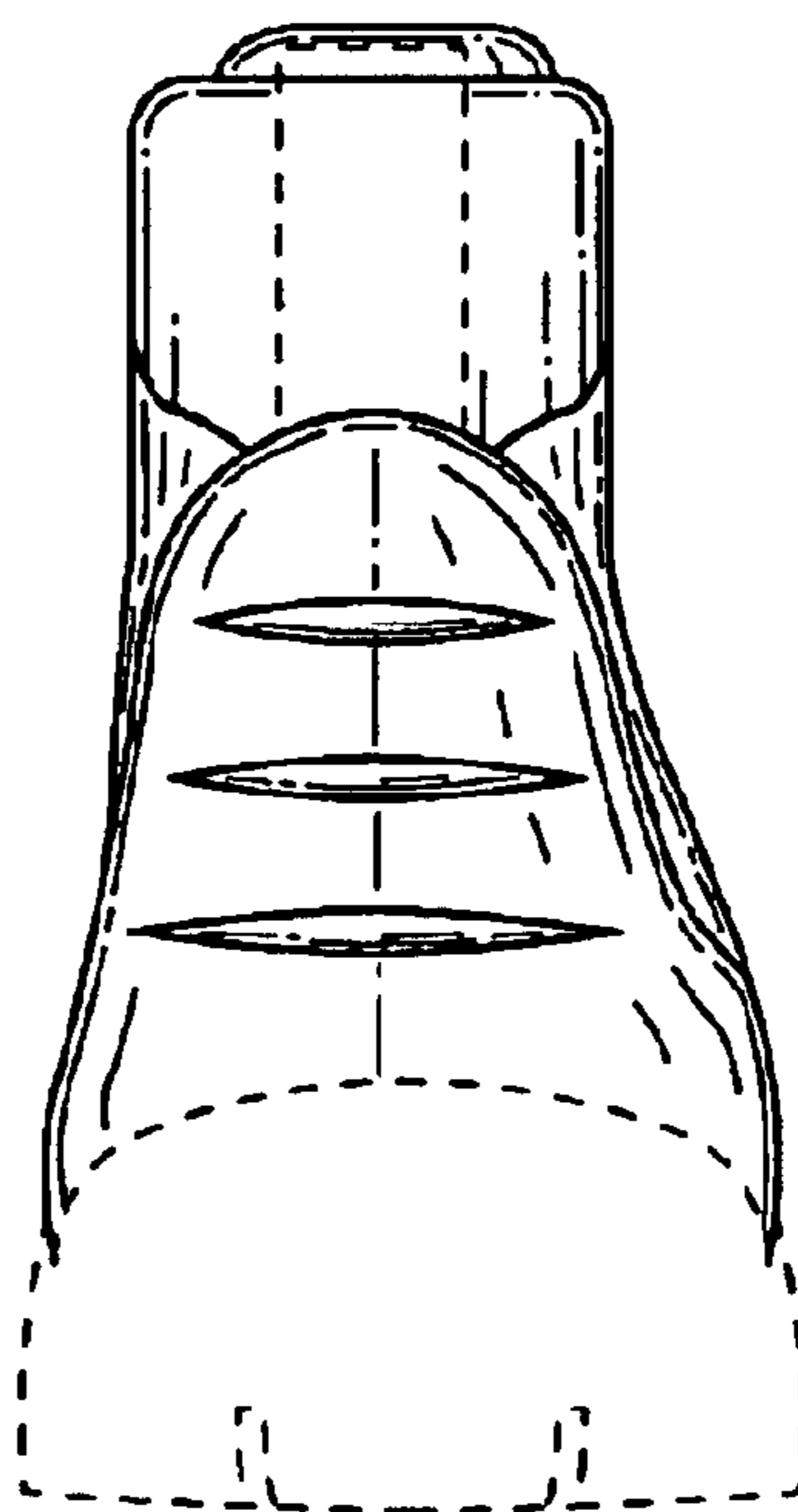

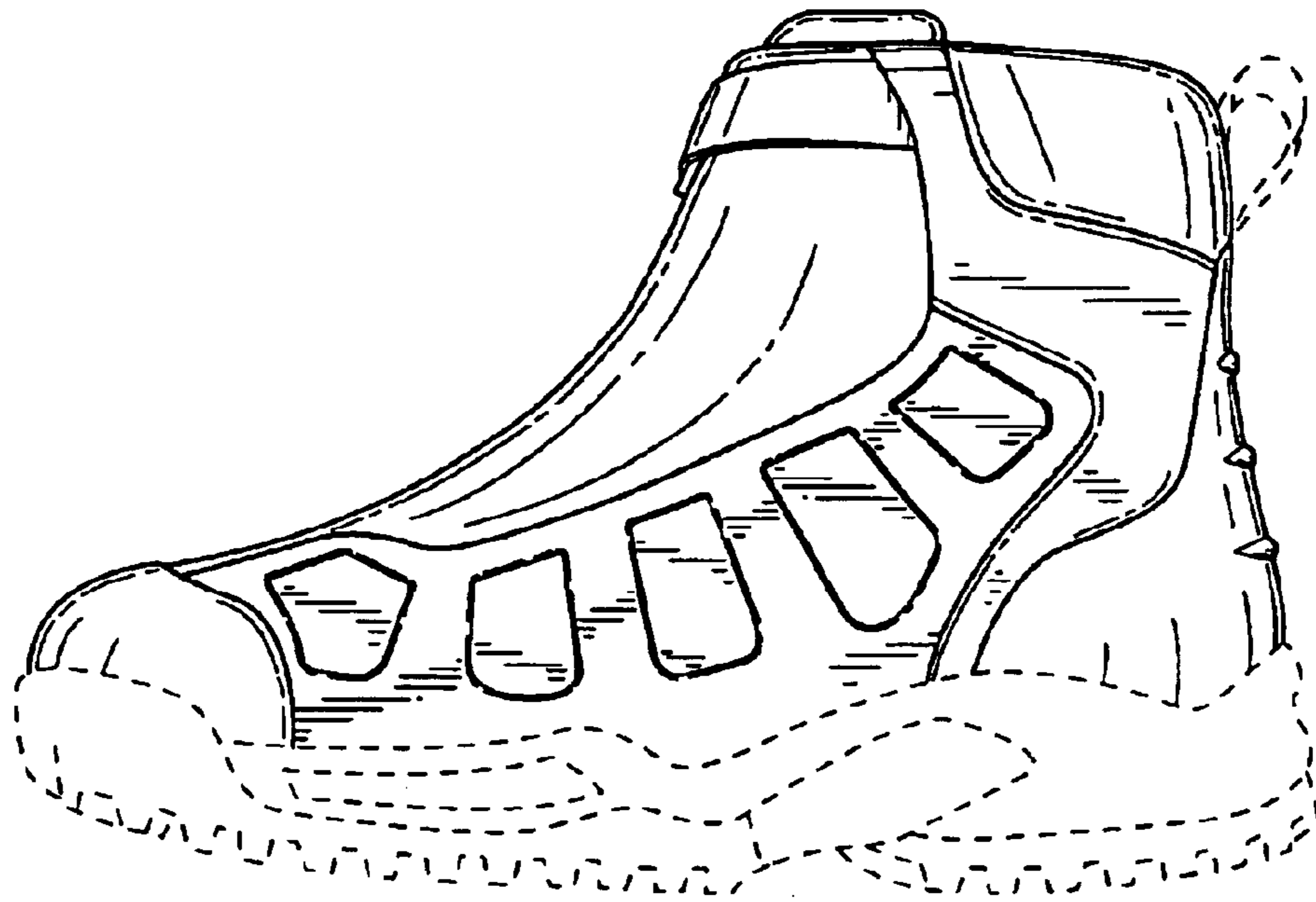

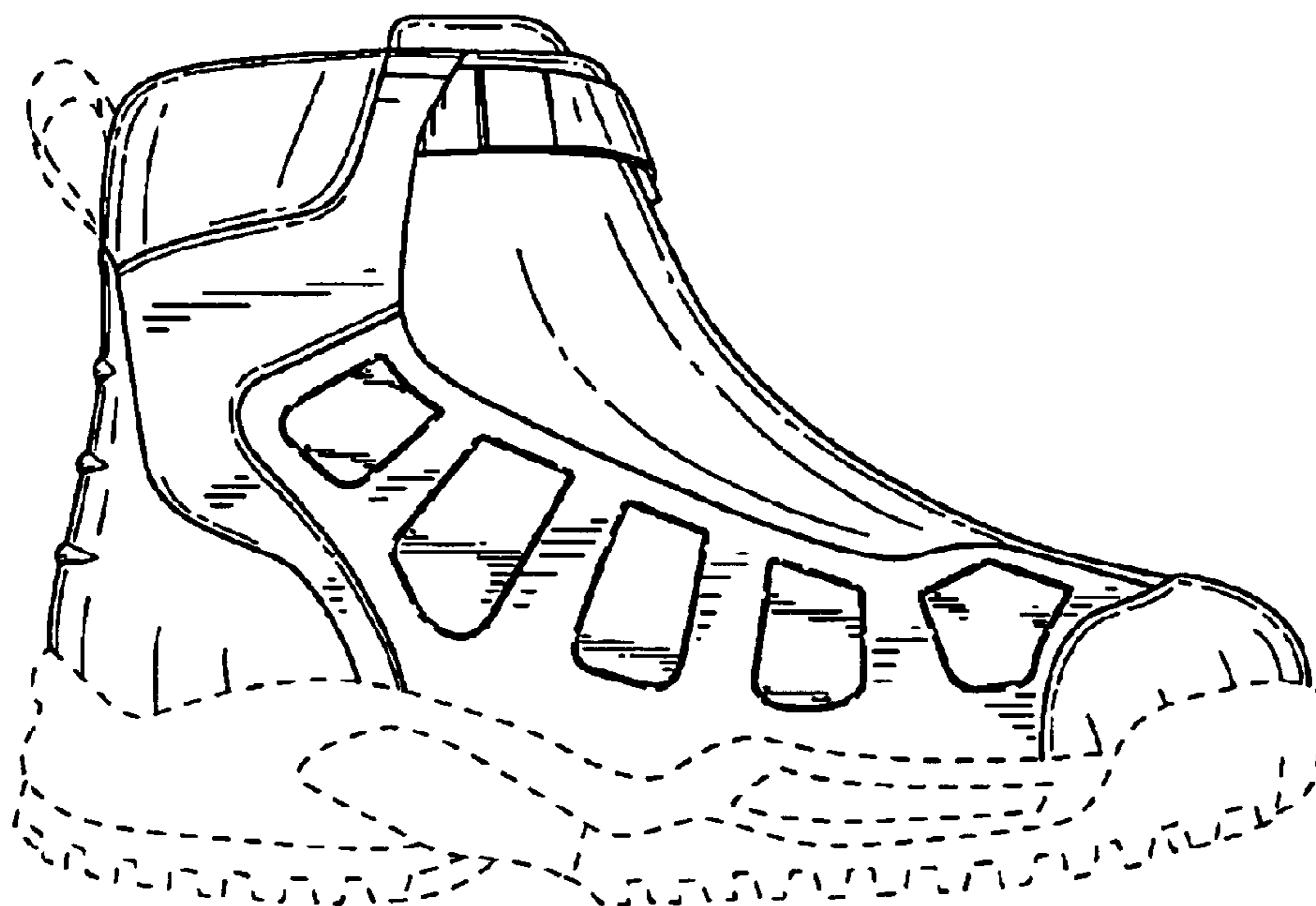

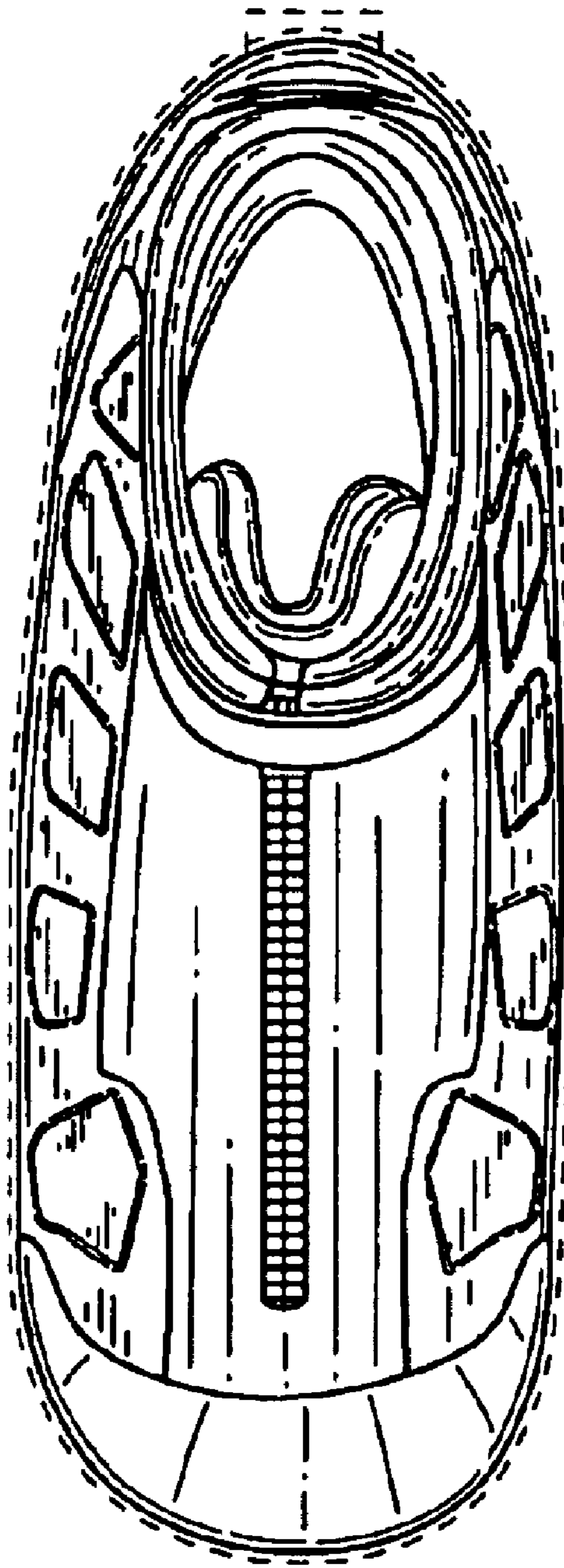

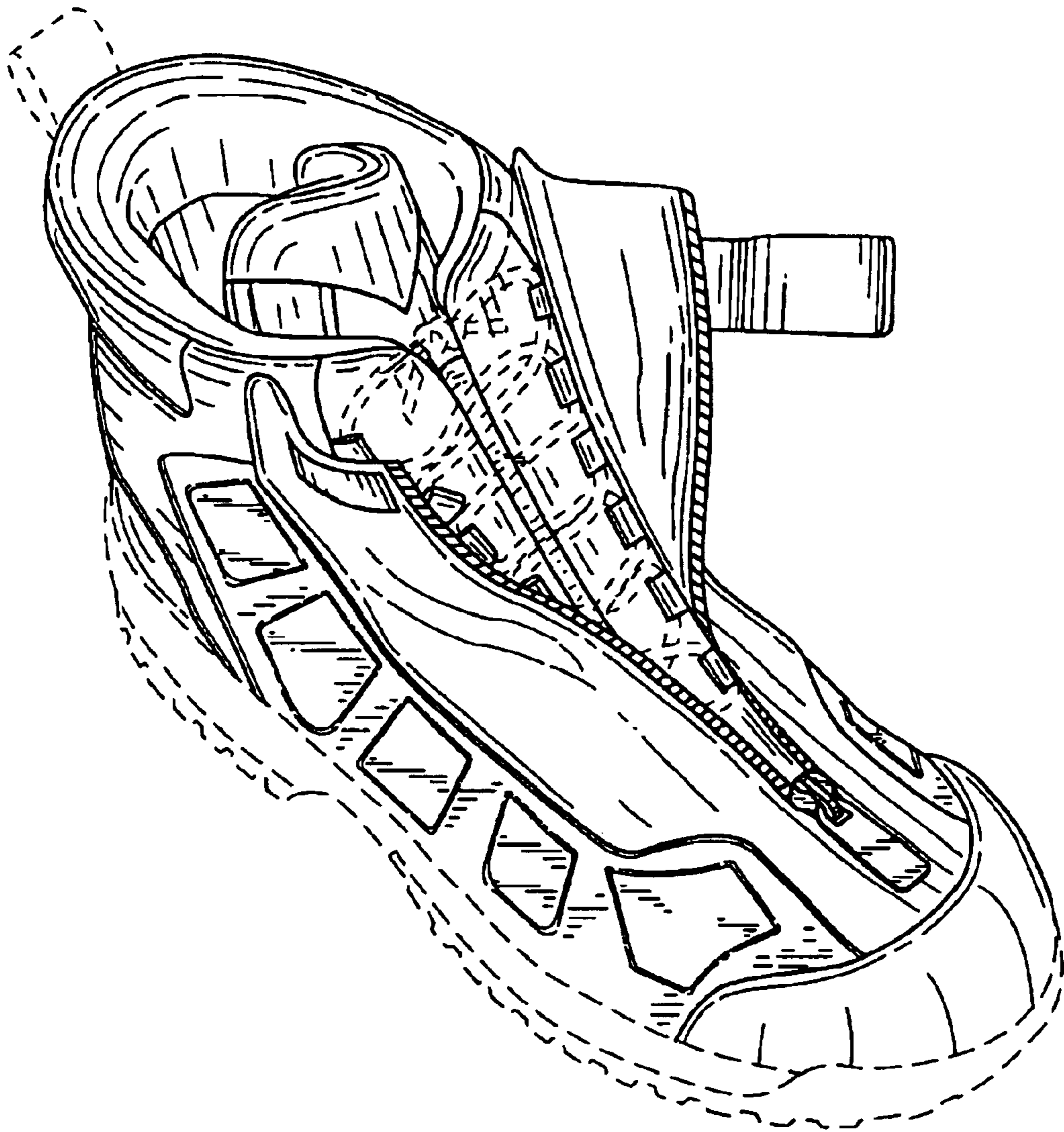
