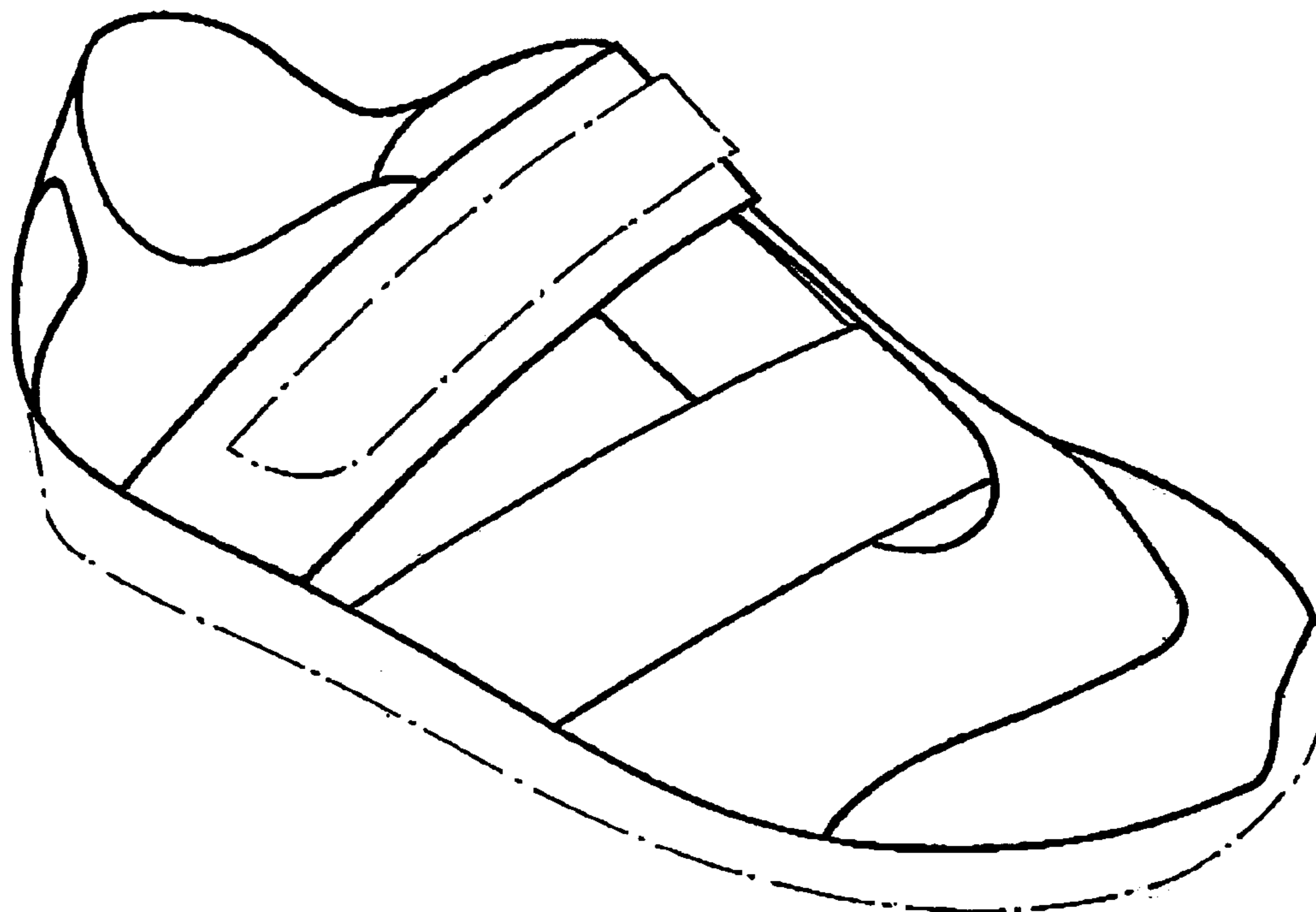

from the front and right side thereof, showing our new
design;

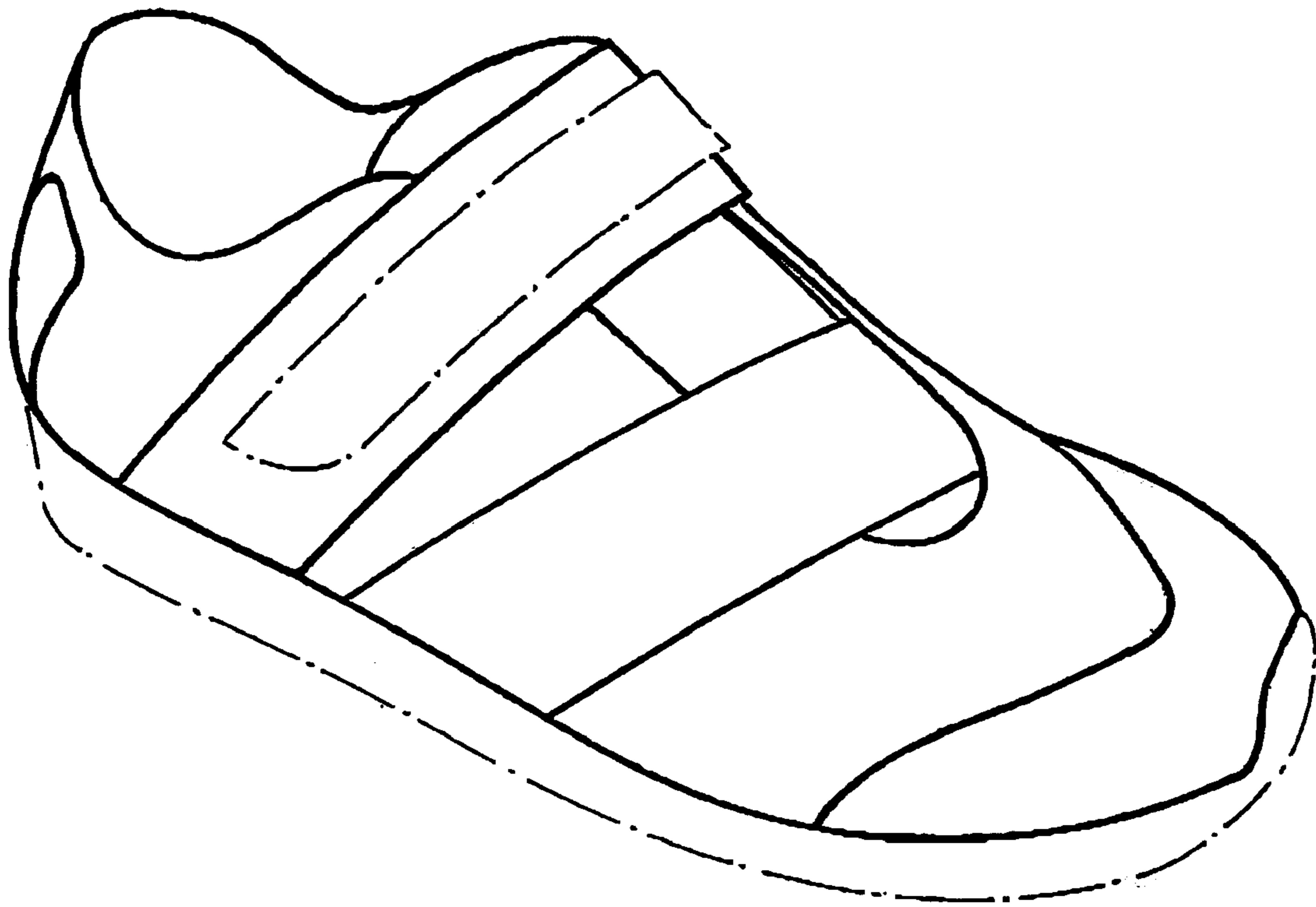

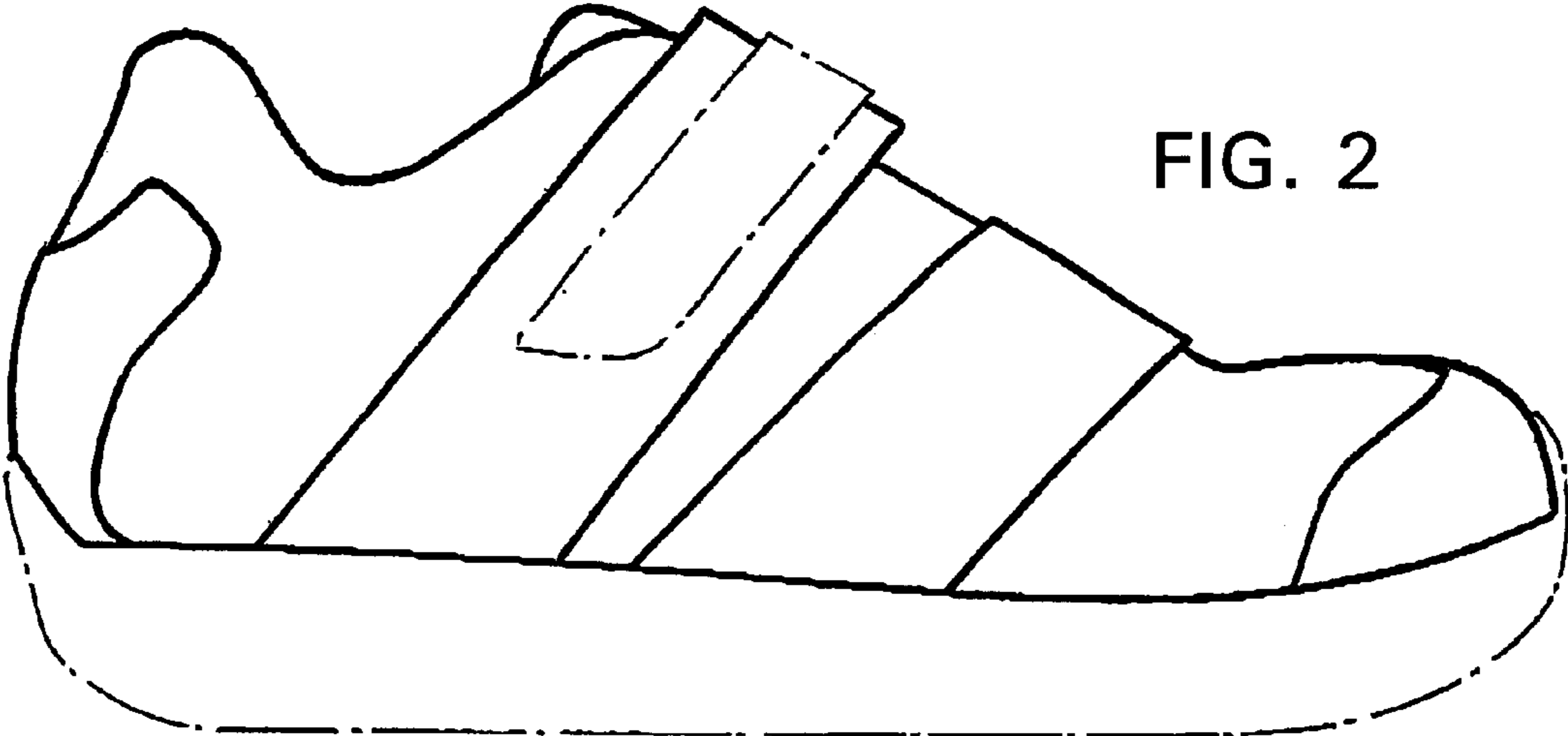

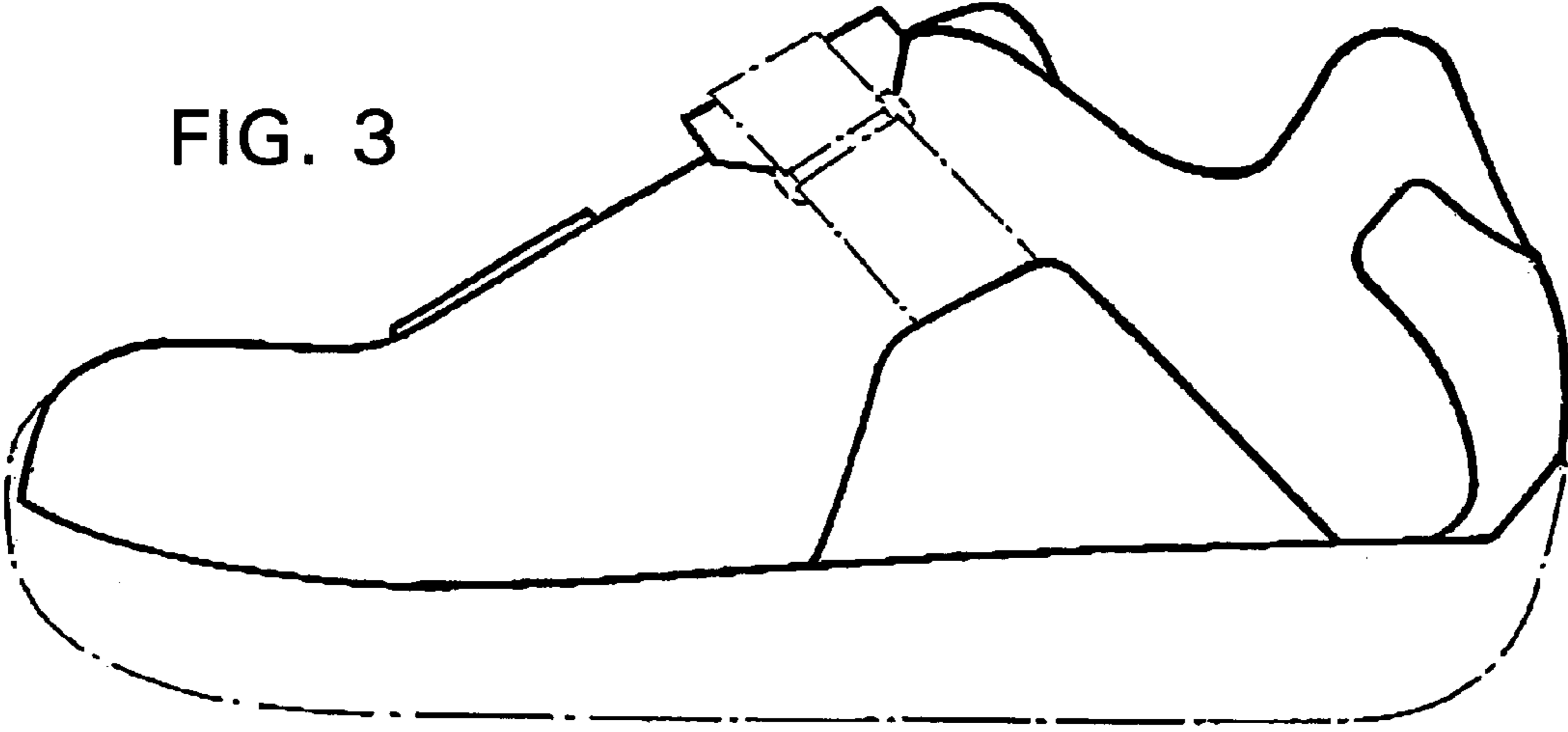

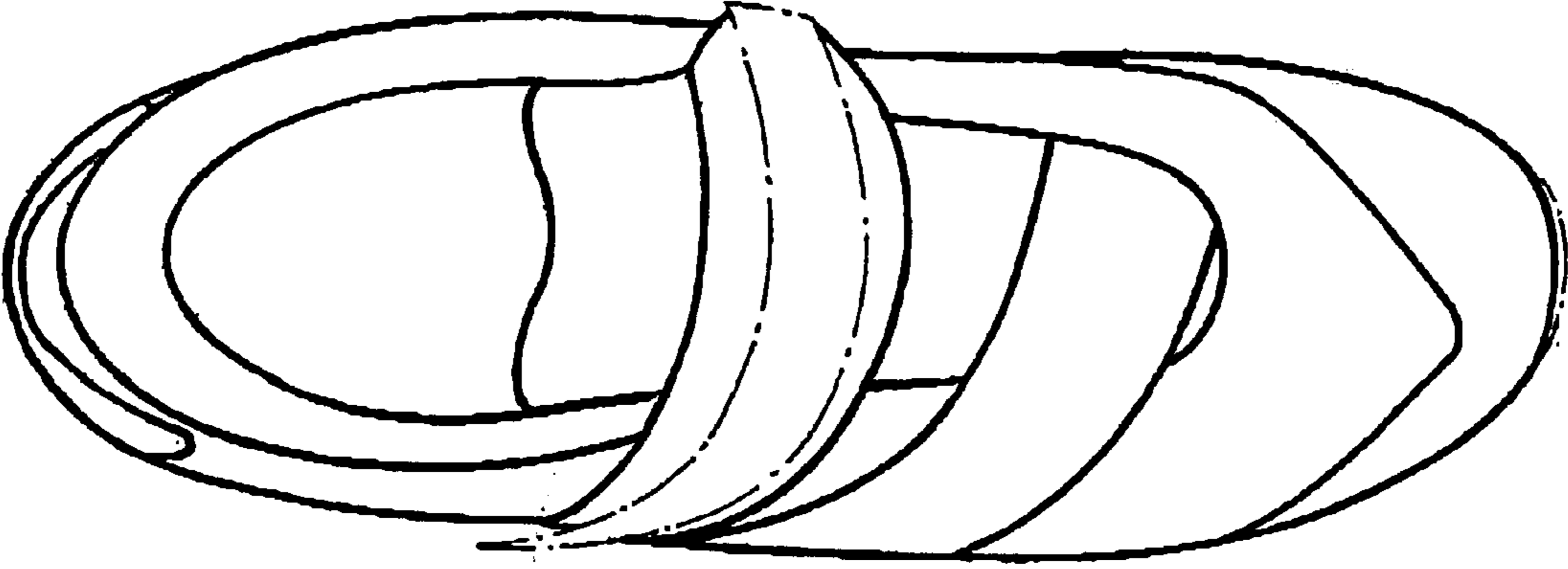

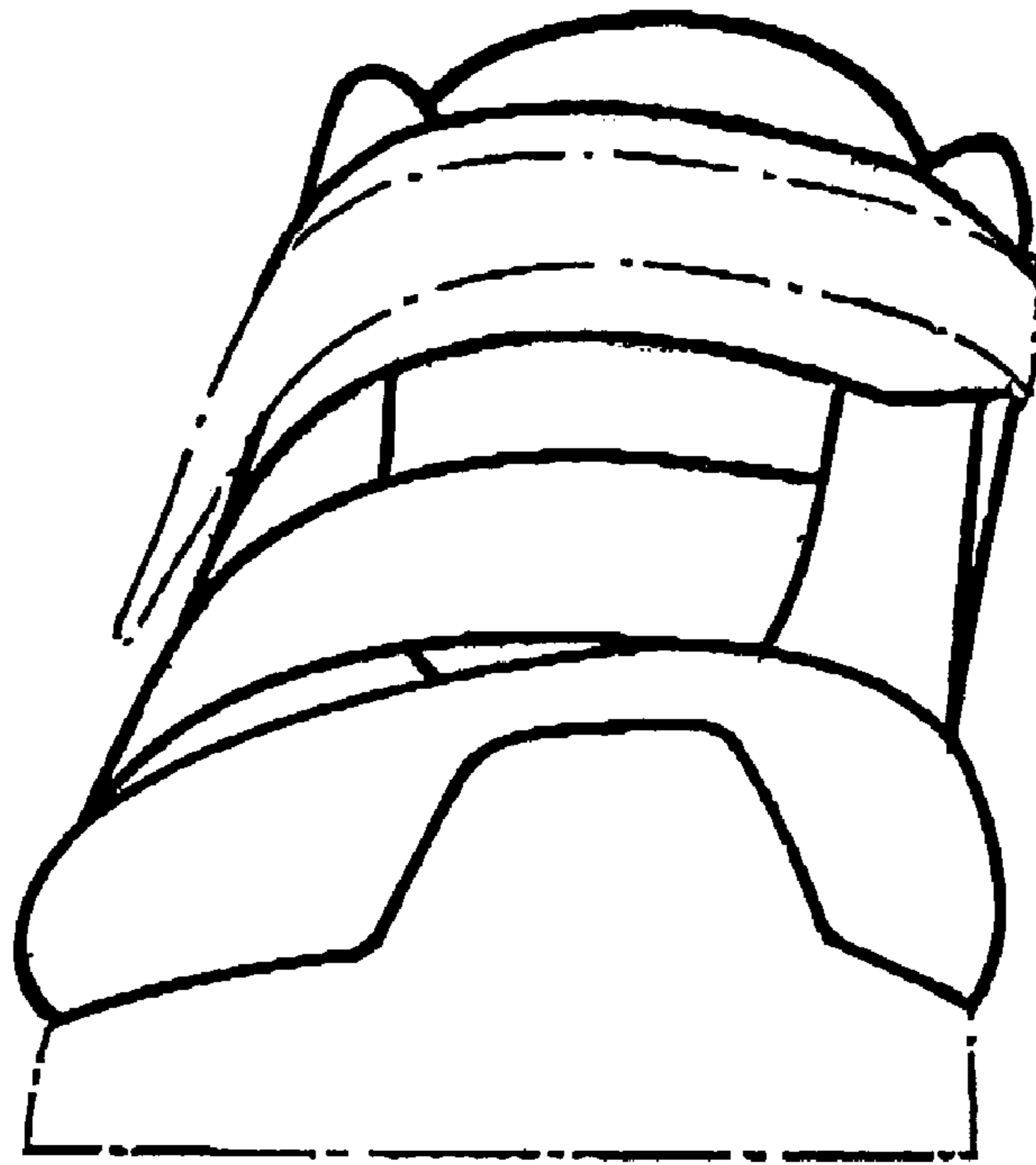

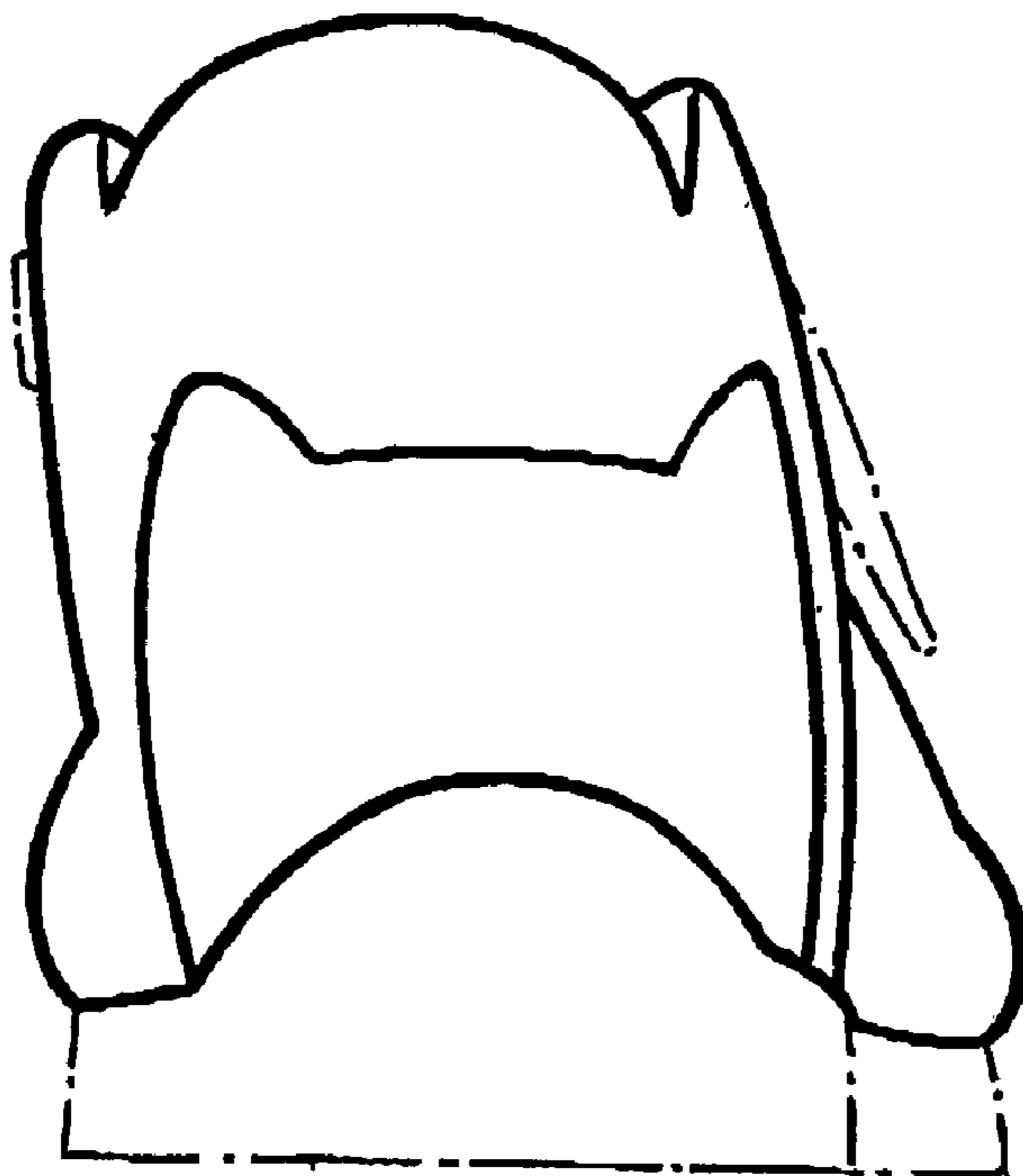
