DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my shoe design;

FIG. 2 is a left side view of the shoe shown in FIG. 1,*

FIG. 3 is a right side view of the shoe shown in FIG. 1; and, FIG. 4 is a top view of the shoe shown in FIG. 1.

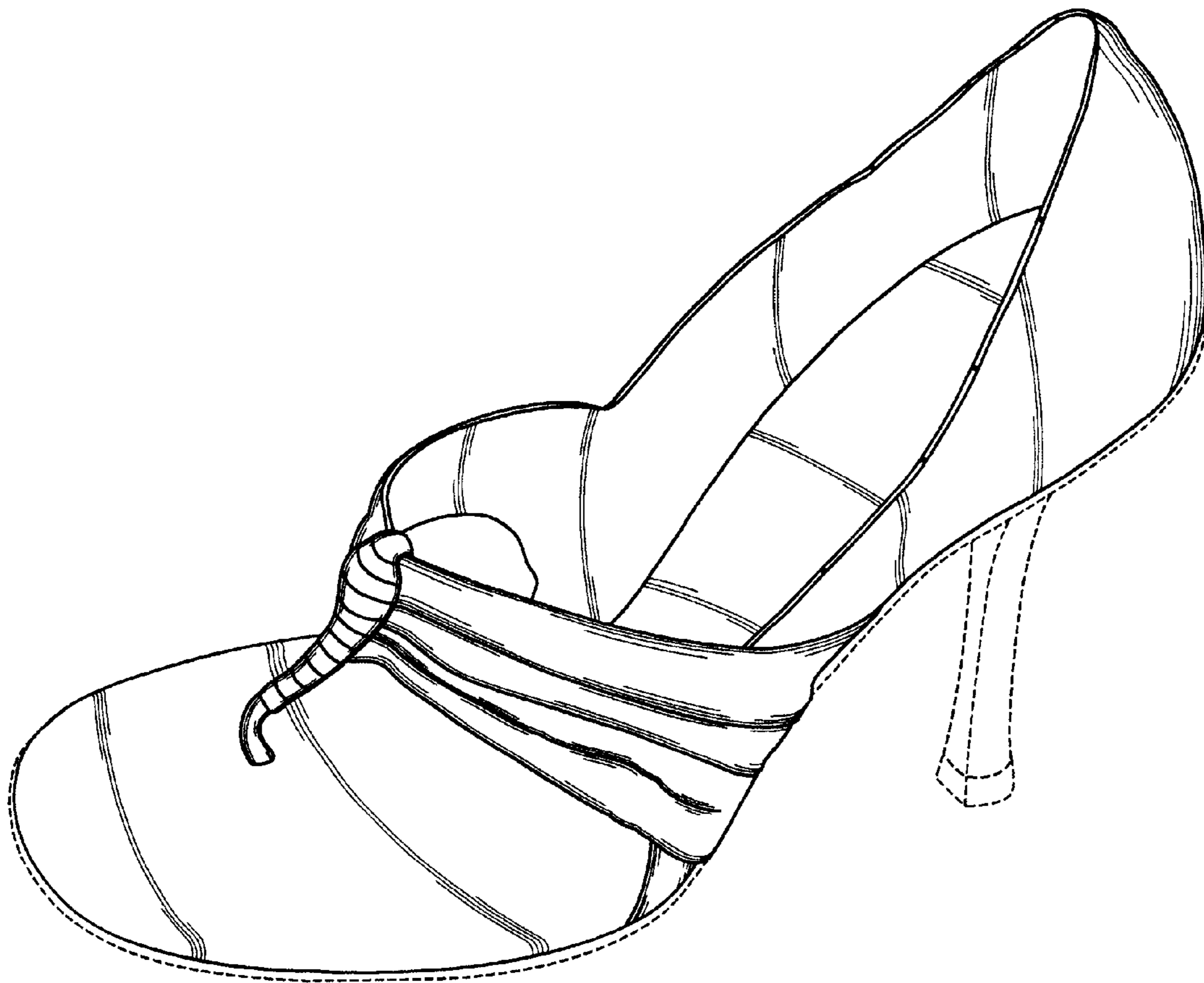

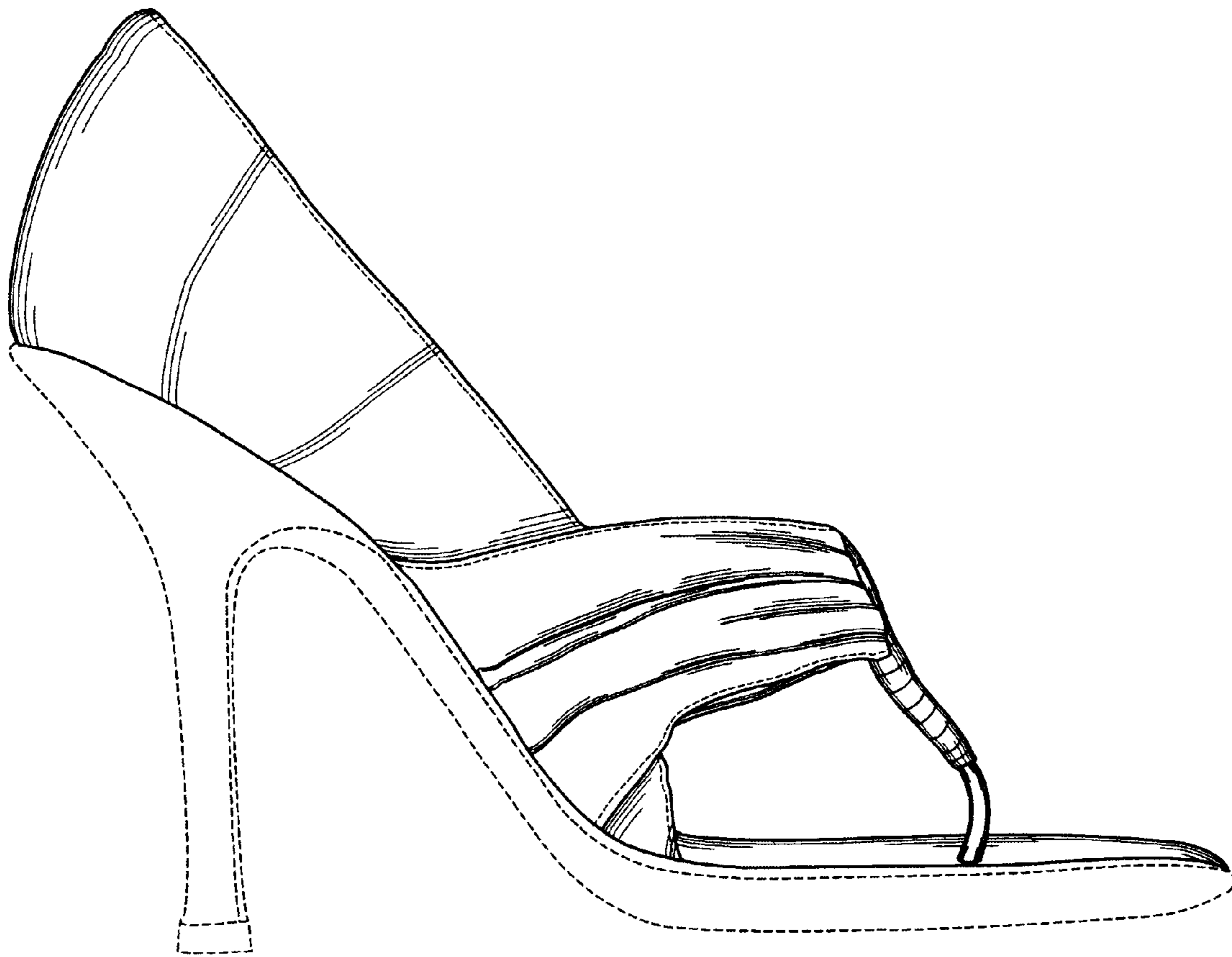

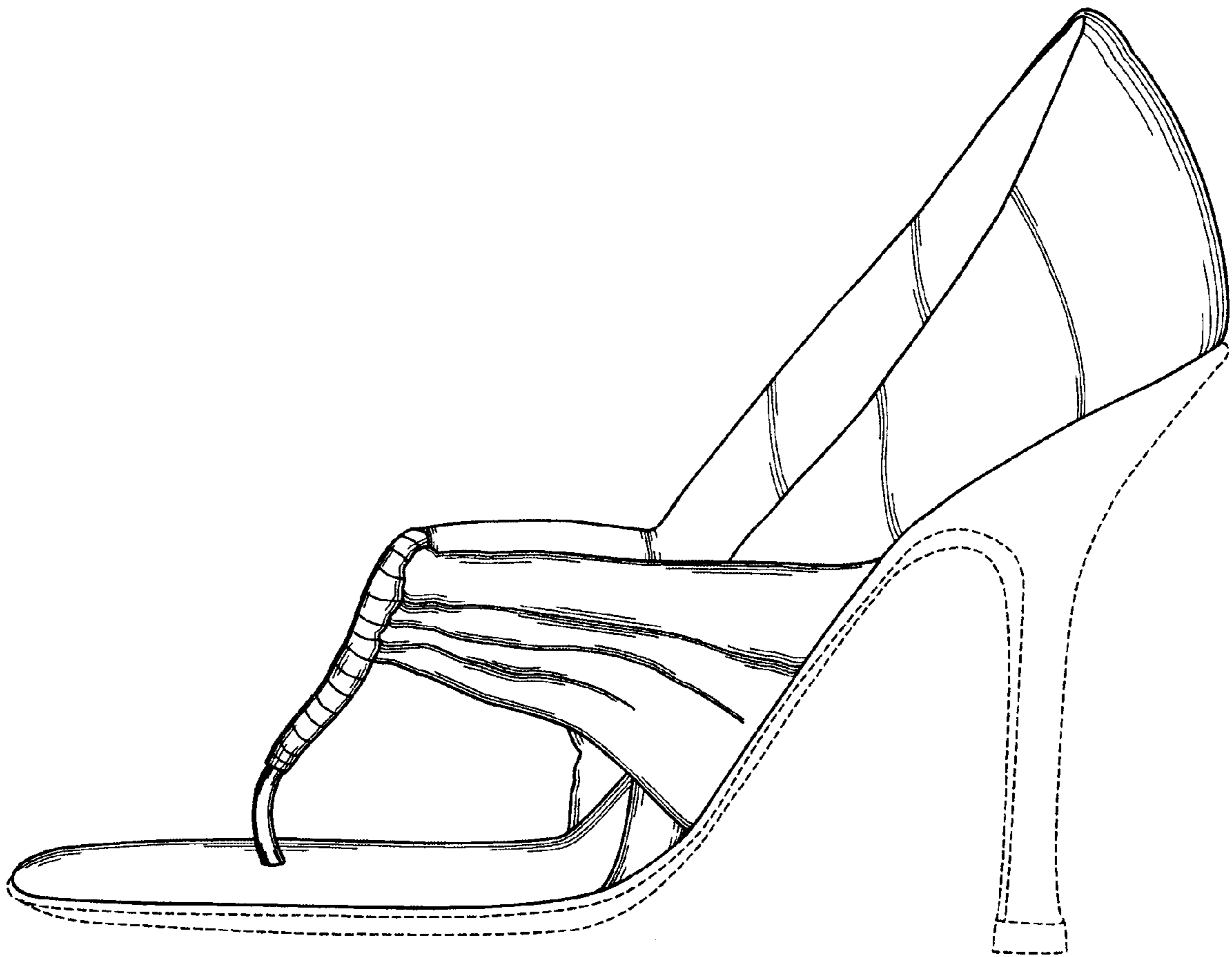

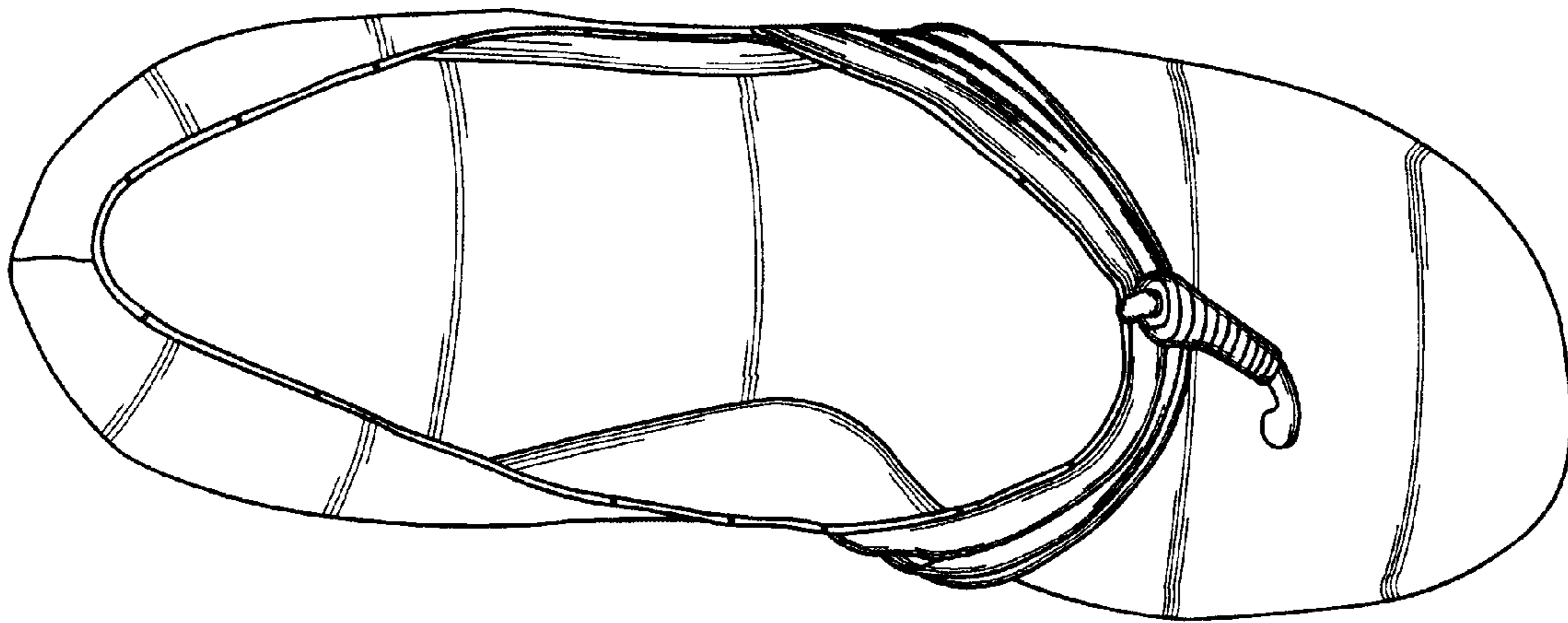
