I claim the ornamental design for a combined cell phone and CD player pouch, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left perspective view of a combined cell phone and CD player pouch showing my new design;  
 FIG. 2 is a front and right perspective view of a second embodiment of FIG. 1;  
 FIG. 3 is a front and left perspective view of a third embodiment of FIG. 1;  
 FIG. 4 is a front and right perspective view of a fourth embodiment of FIG. 1;  
 FIG. 5 is a front perspective view of FIGS. 2 and 3; and,  
 FIG. 6 is a front perspective view of FIGS. 1 and 3.

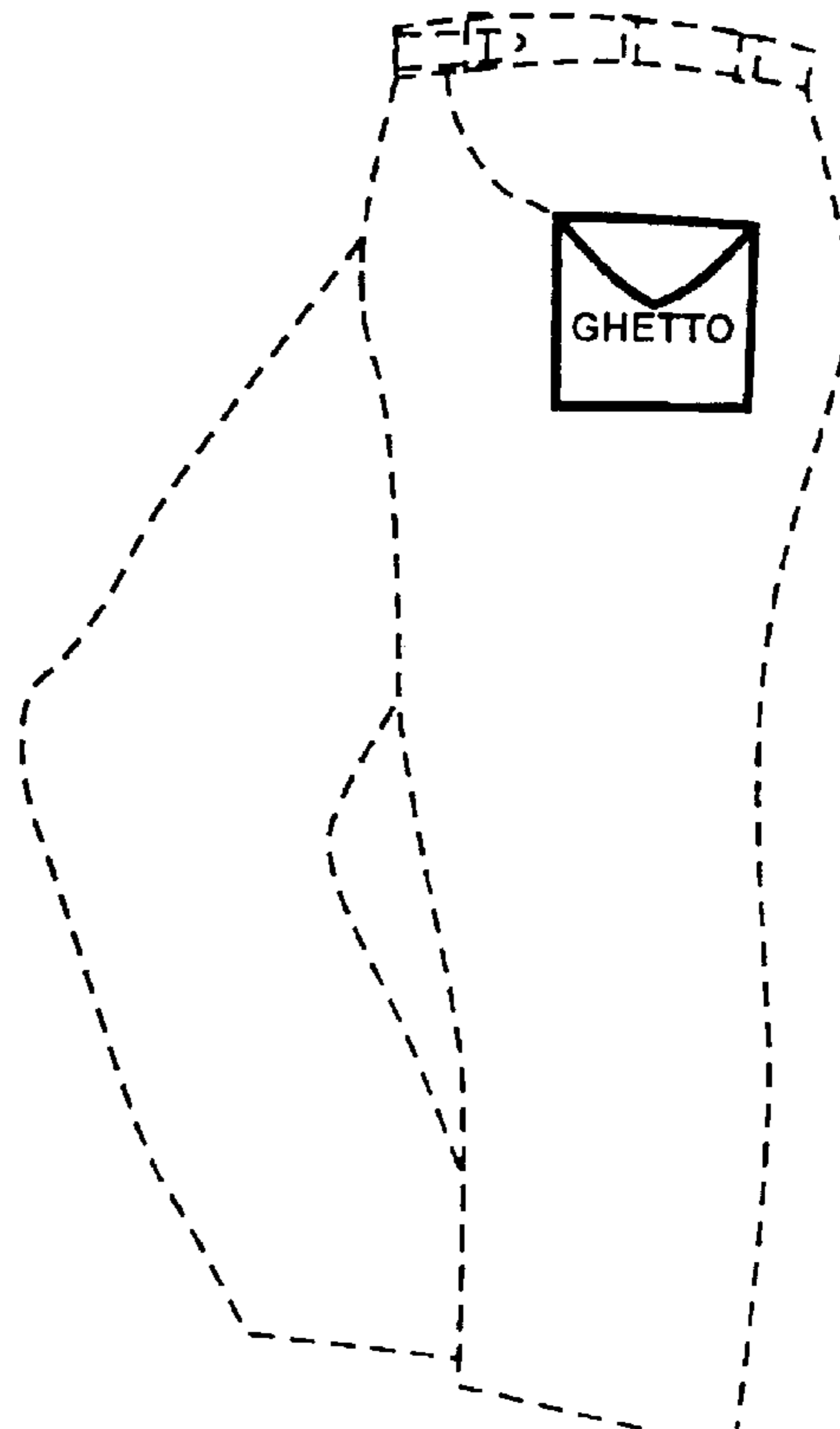
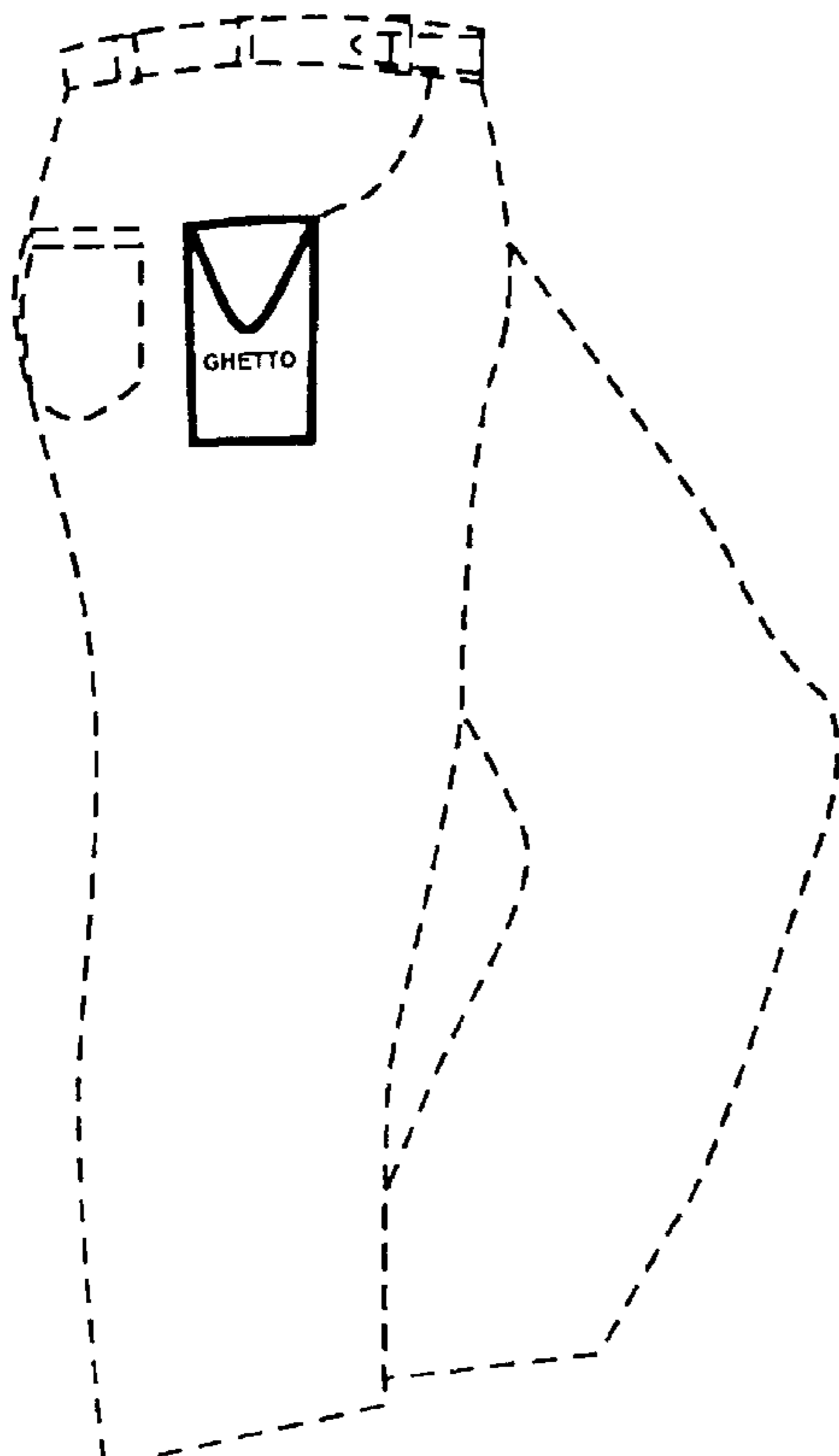

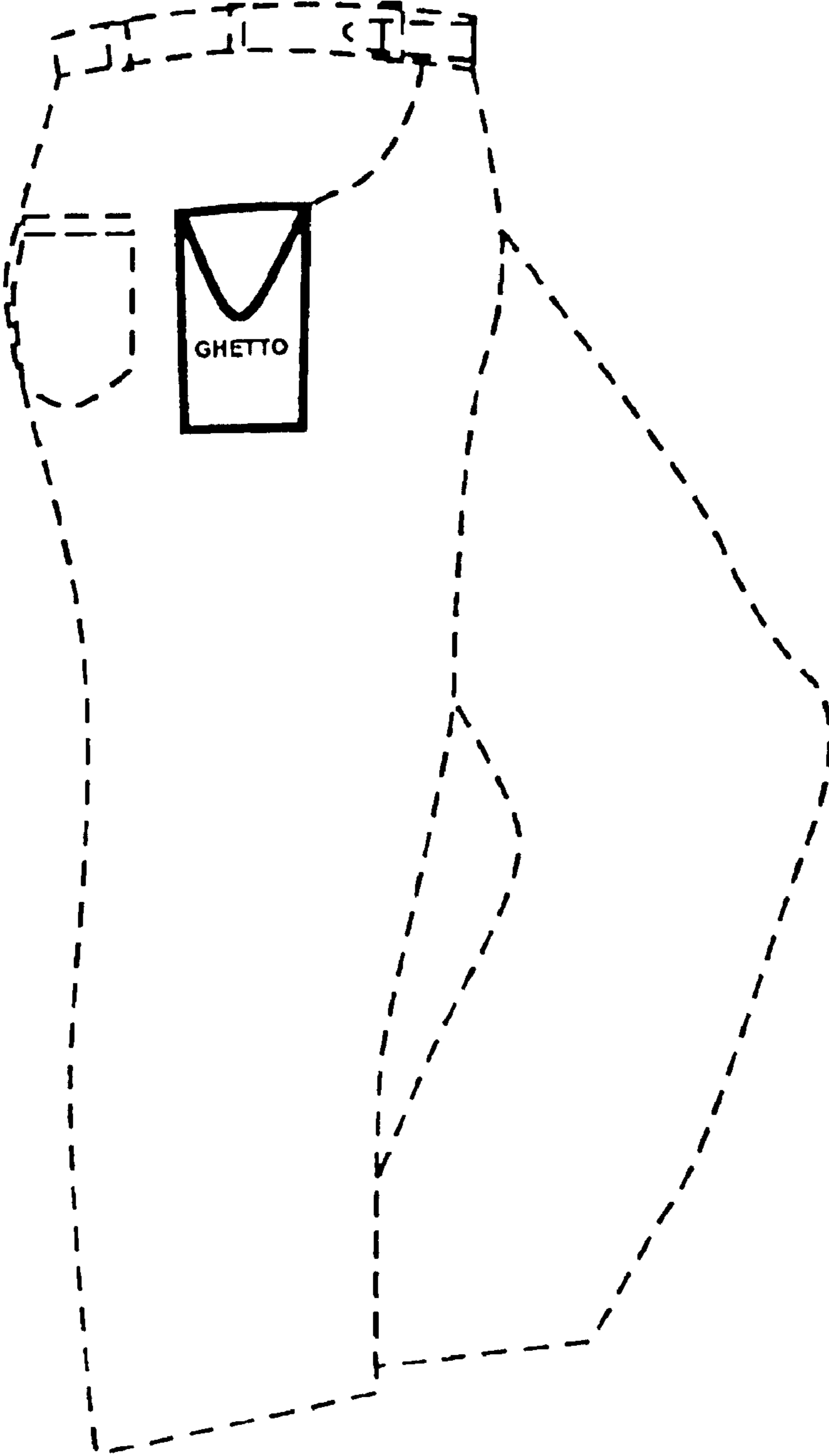

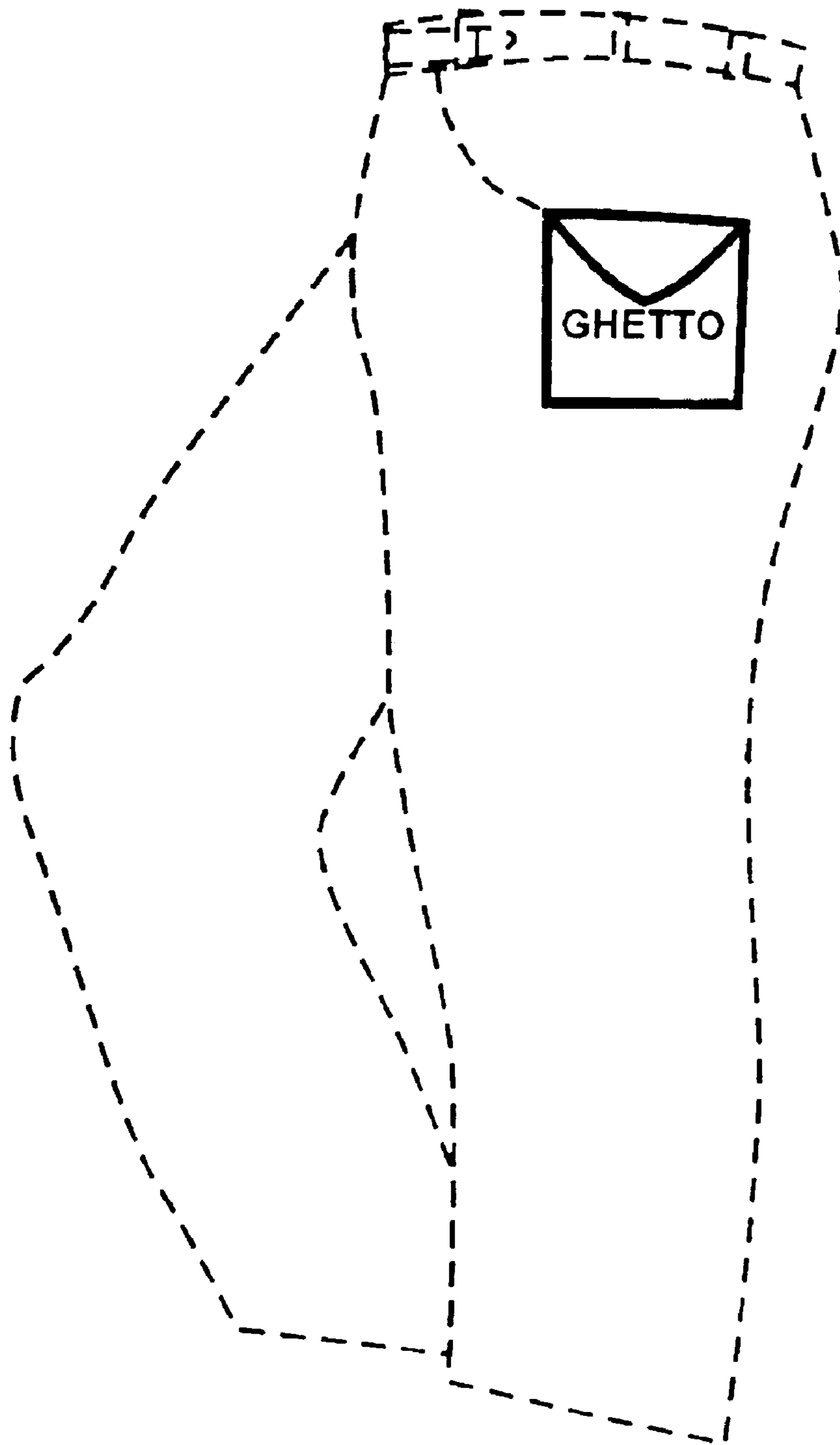
