(57) **CLAIM**

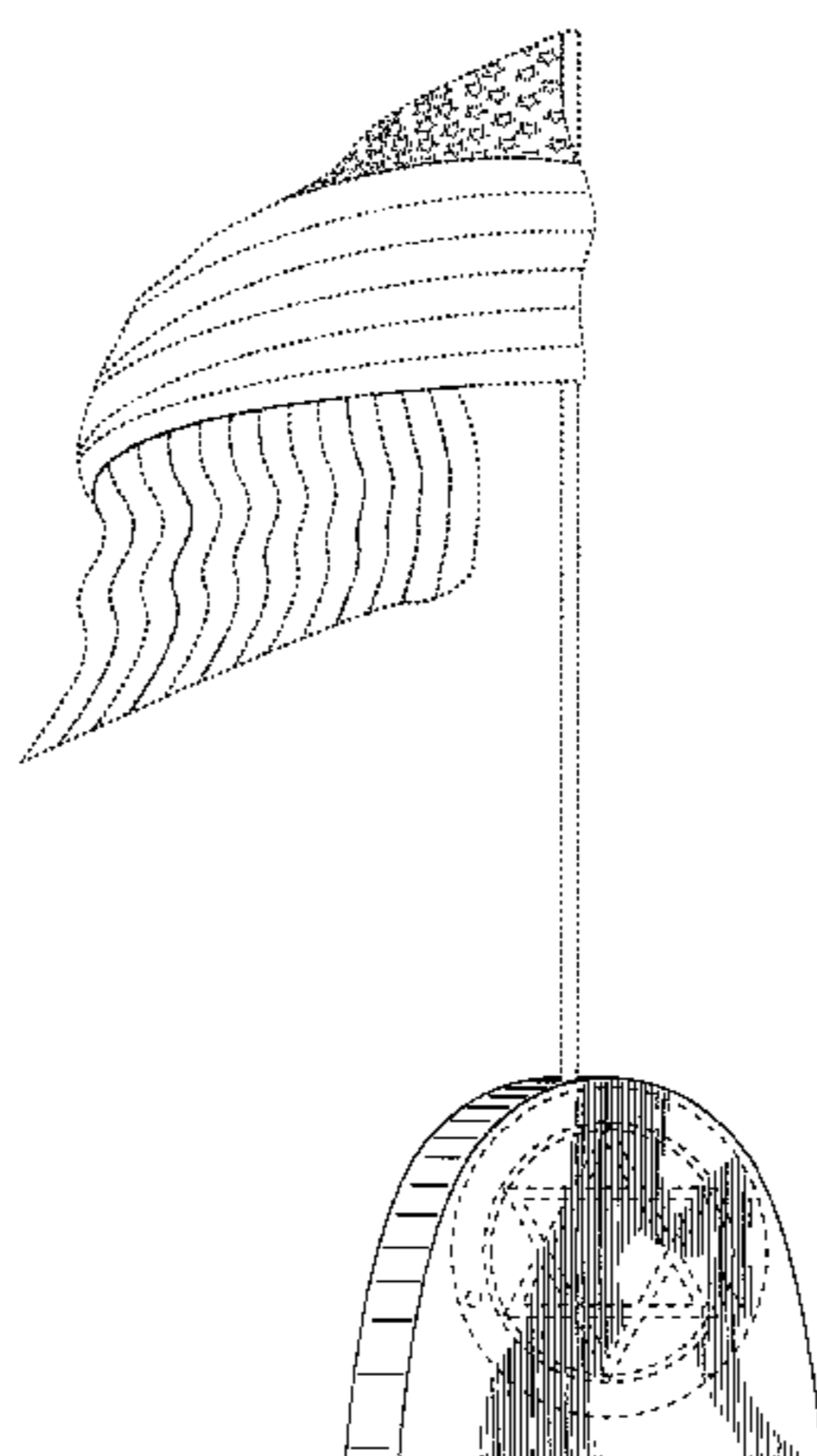
The ornamental design for a commemorative memorial flag holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side perspective view of the commemorative memorial flag holder with a flag and flagpole inserted in the top showing my new design; FIG. 2 is a front view of FIG. 1 without the flag and flagpole; FIG. 3 is a side view of FIG. 2; FIG. 4 is a back view of FIG. 2; and, FIG. 5 is a top view of FIG. 2.

The commemorative memorial flag holder may have double stick adhesive on the back to make it adhere to cemetery monuments. The flag, flagpole, and design shown in broken lines in the drawings are provided for illustrative purposes only and form no part of the claimed design.

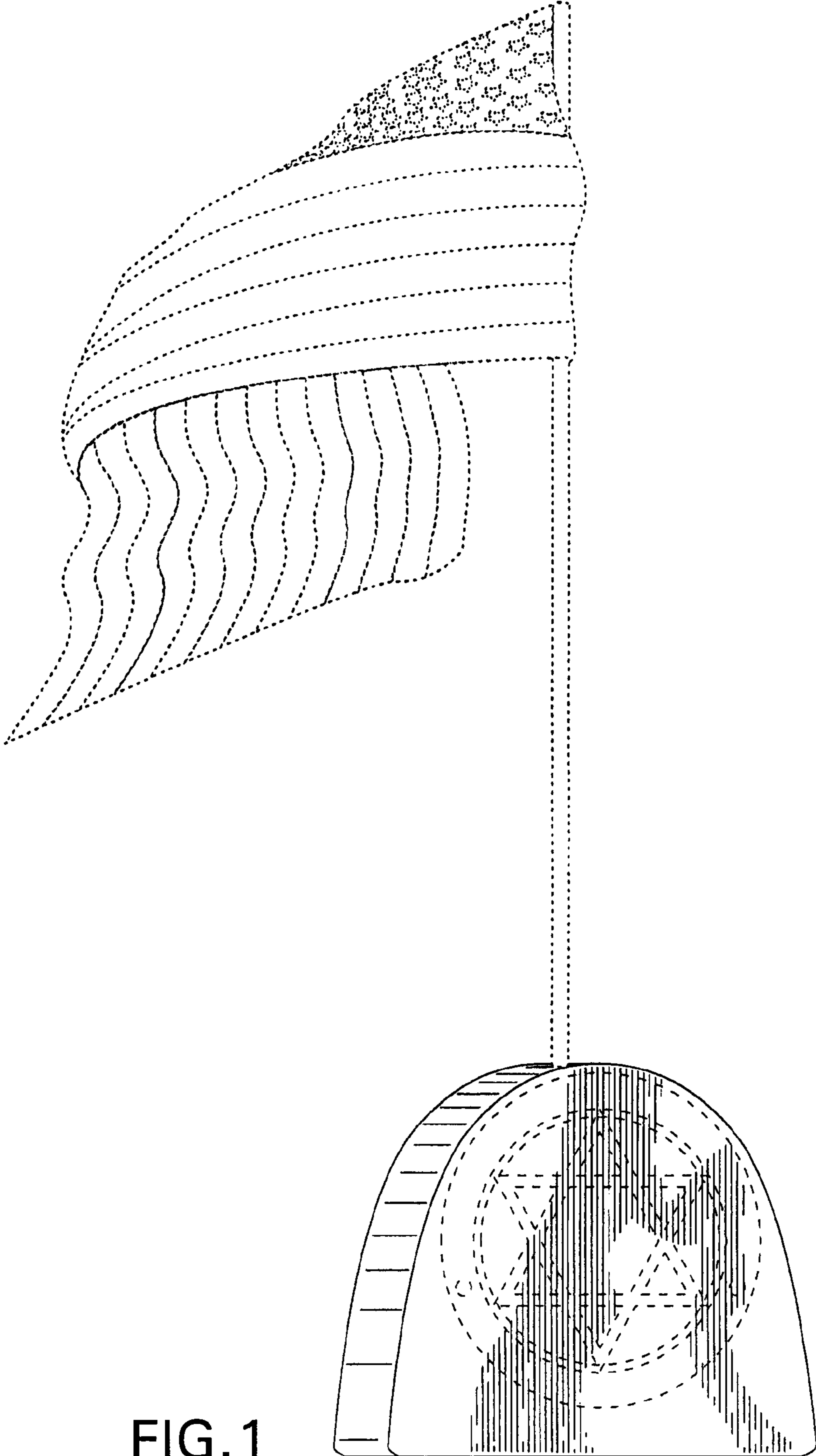

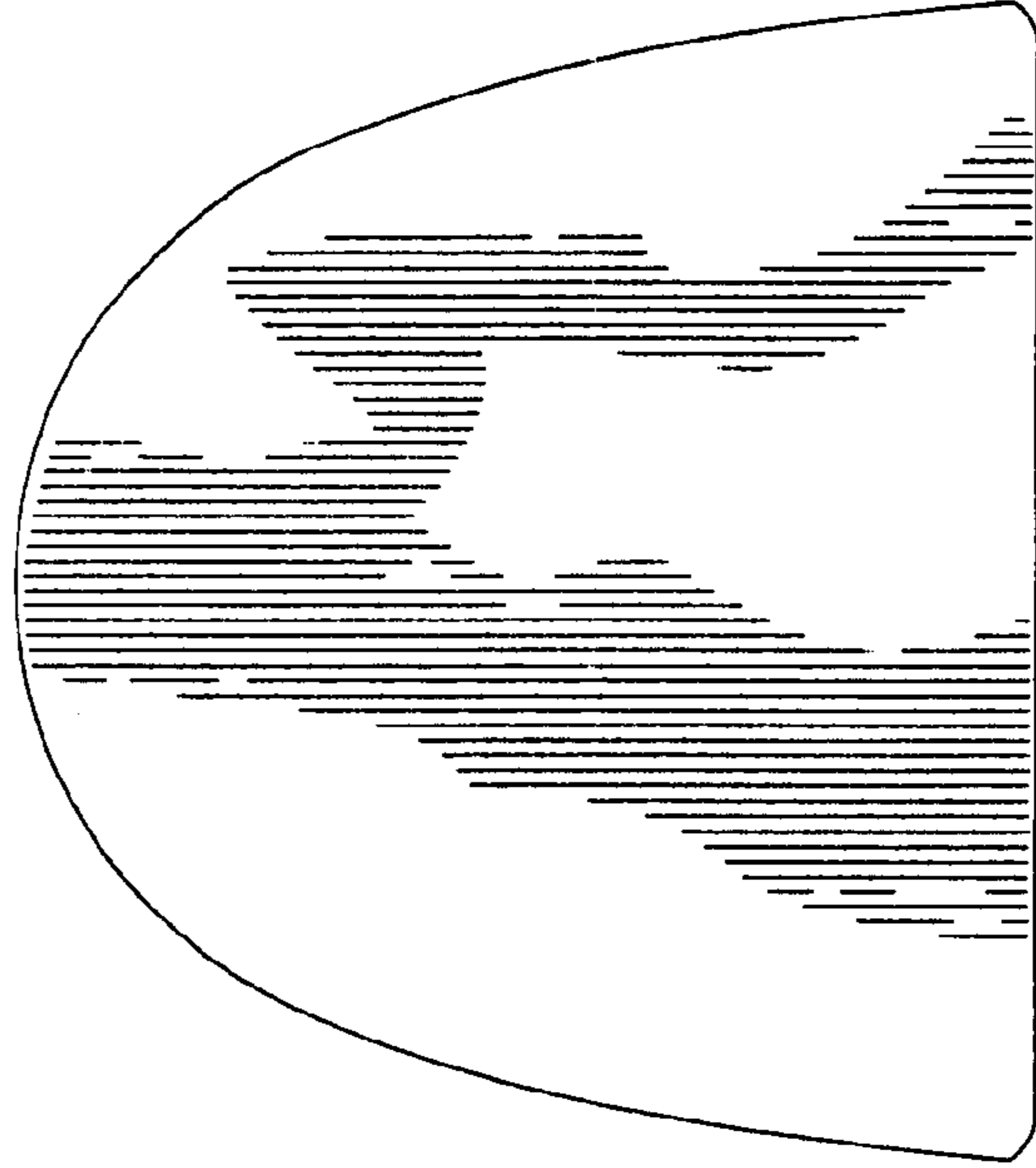

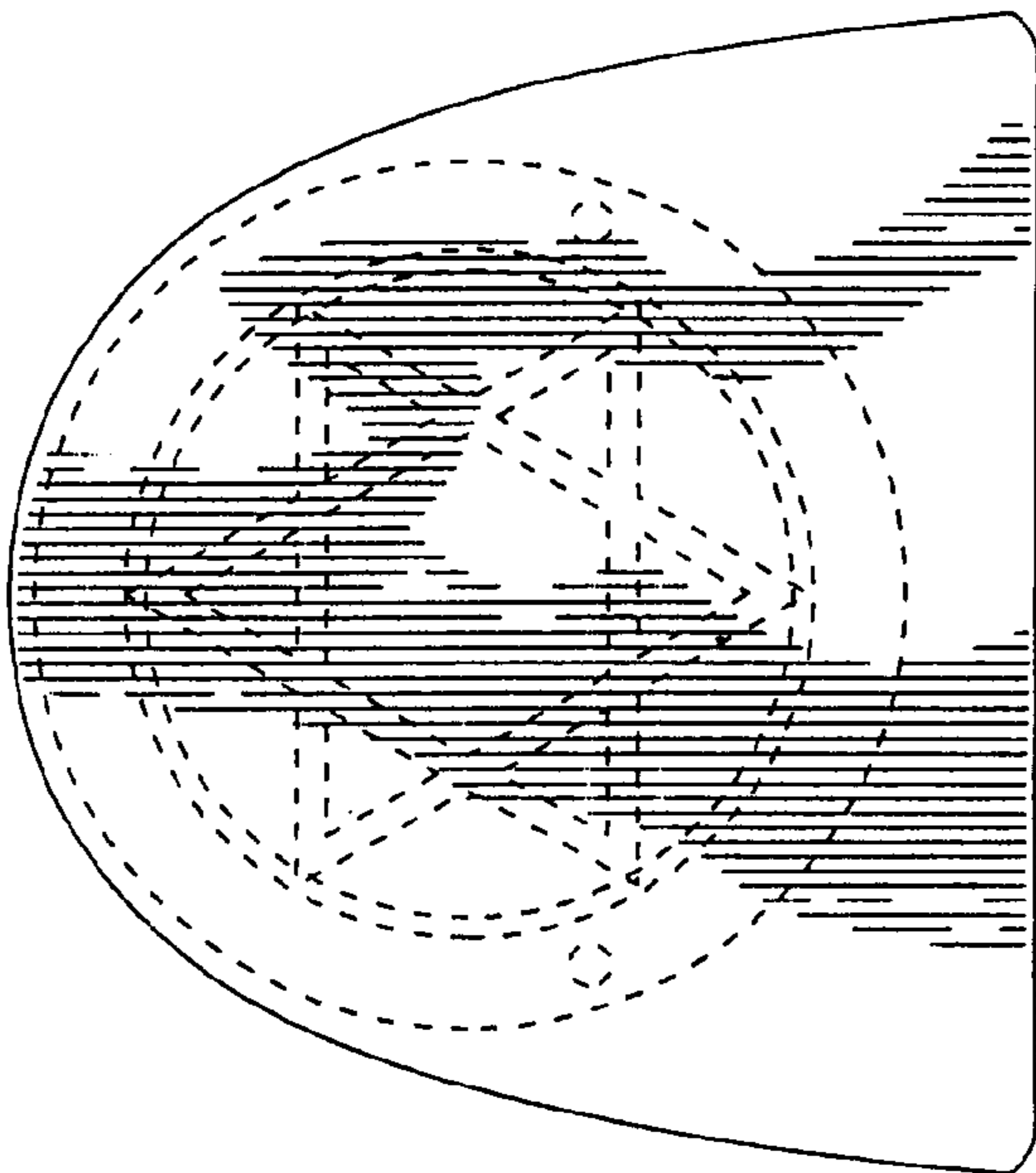

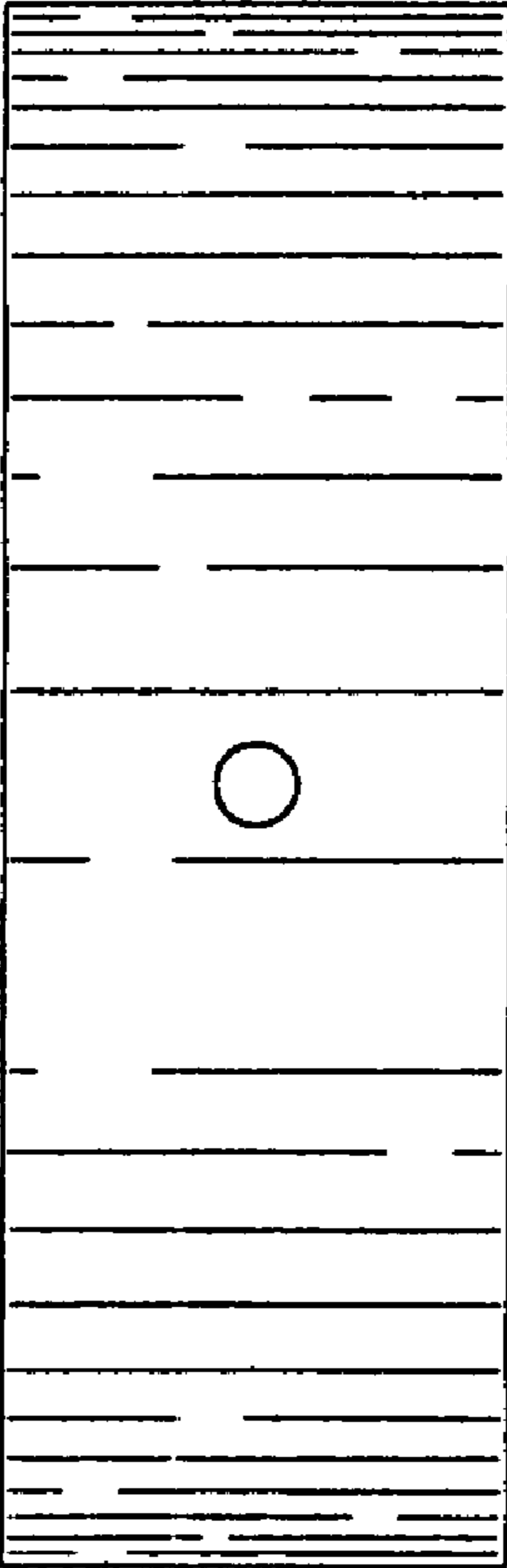
