FIG. 7 is a front elevation view thereof.

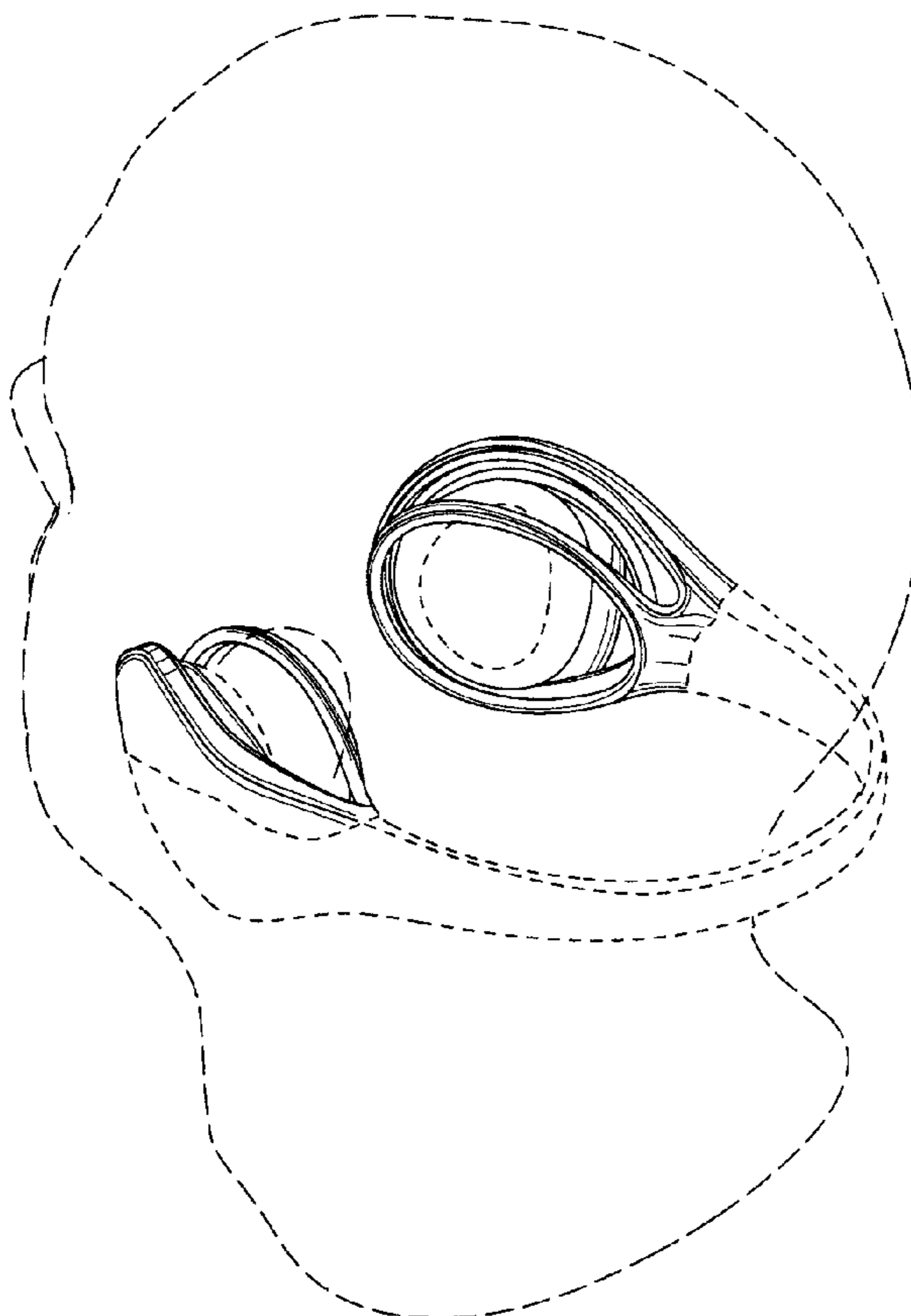

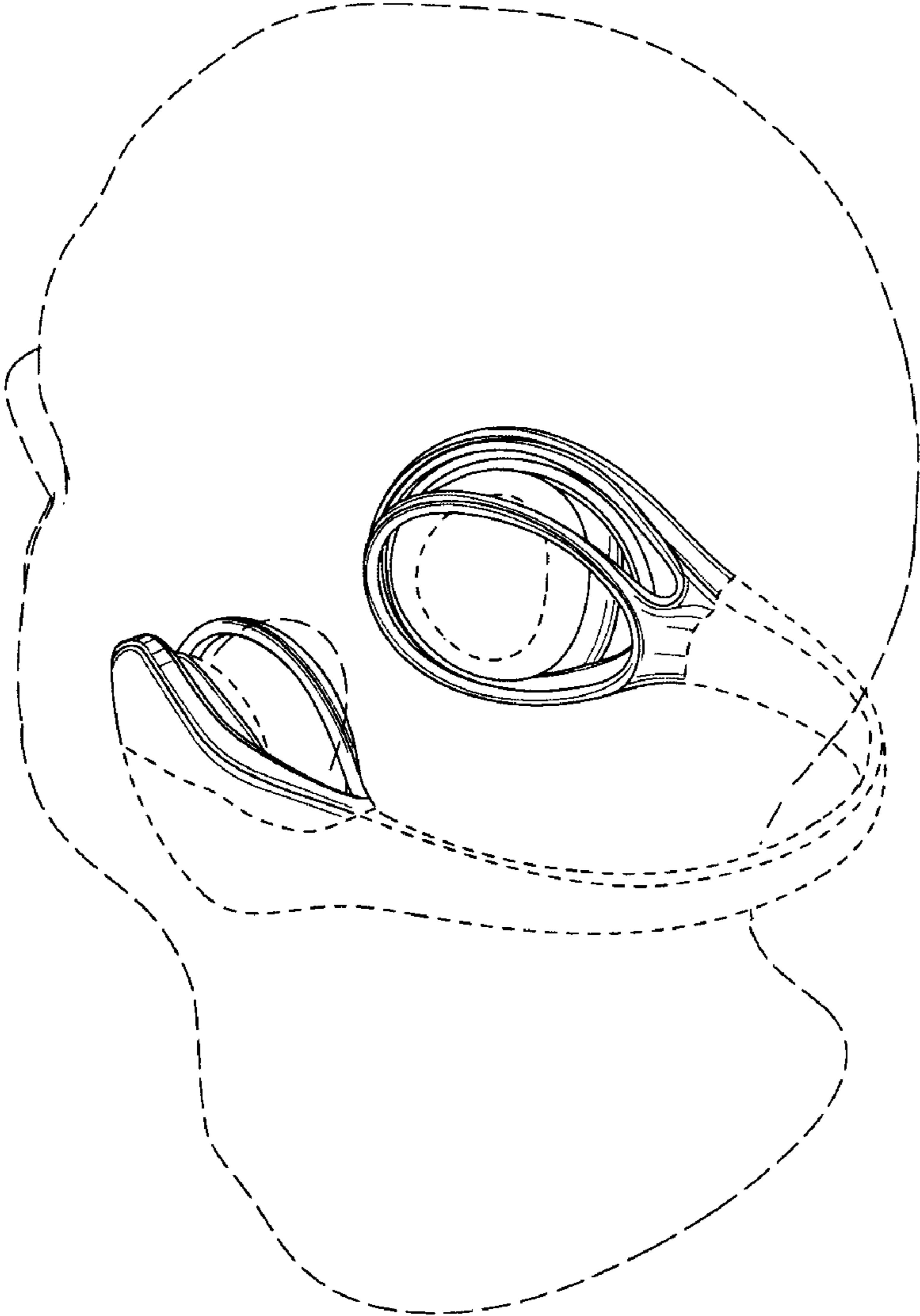

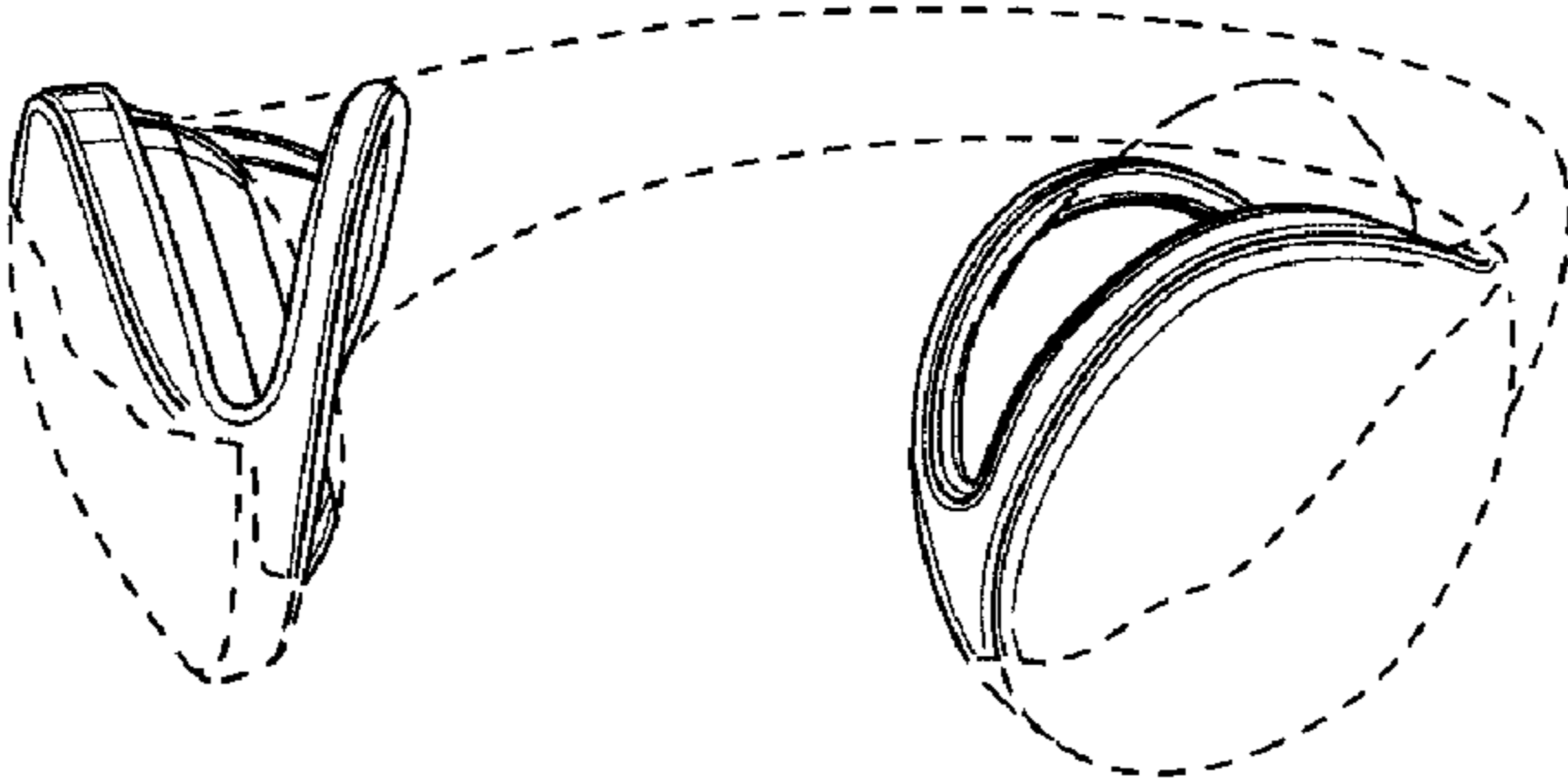

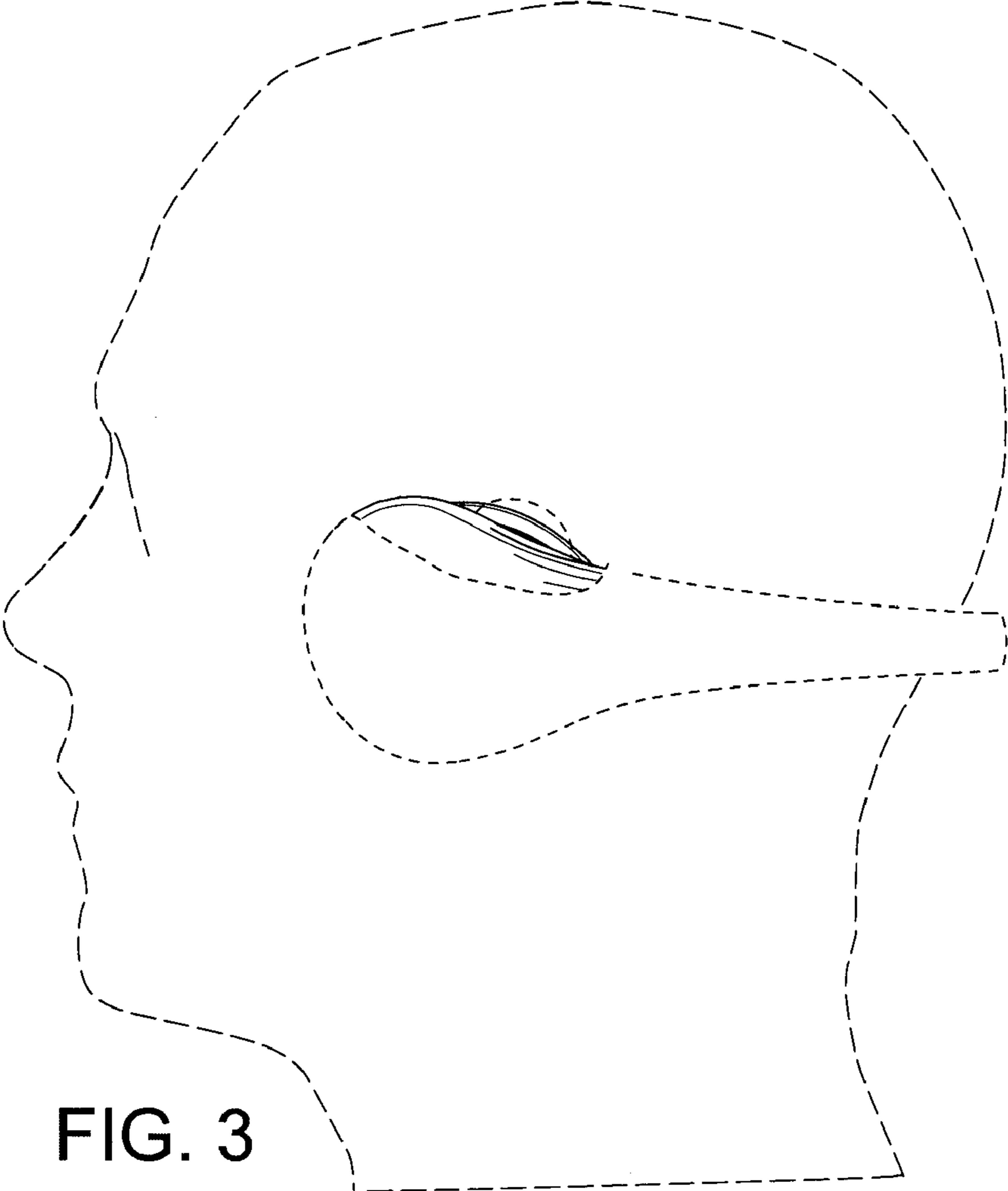

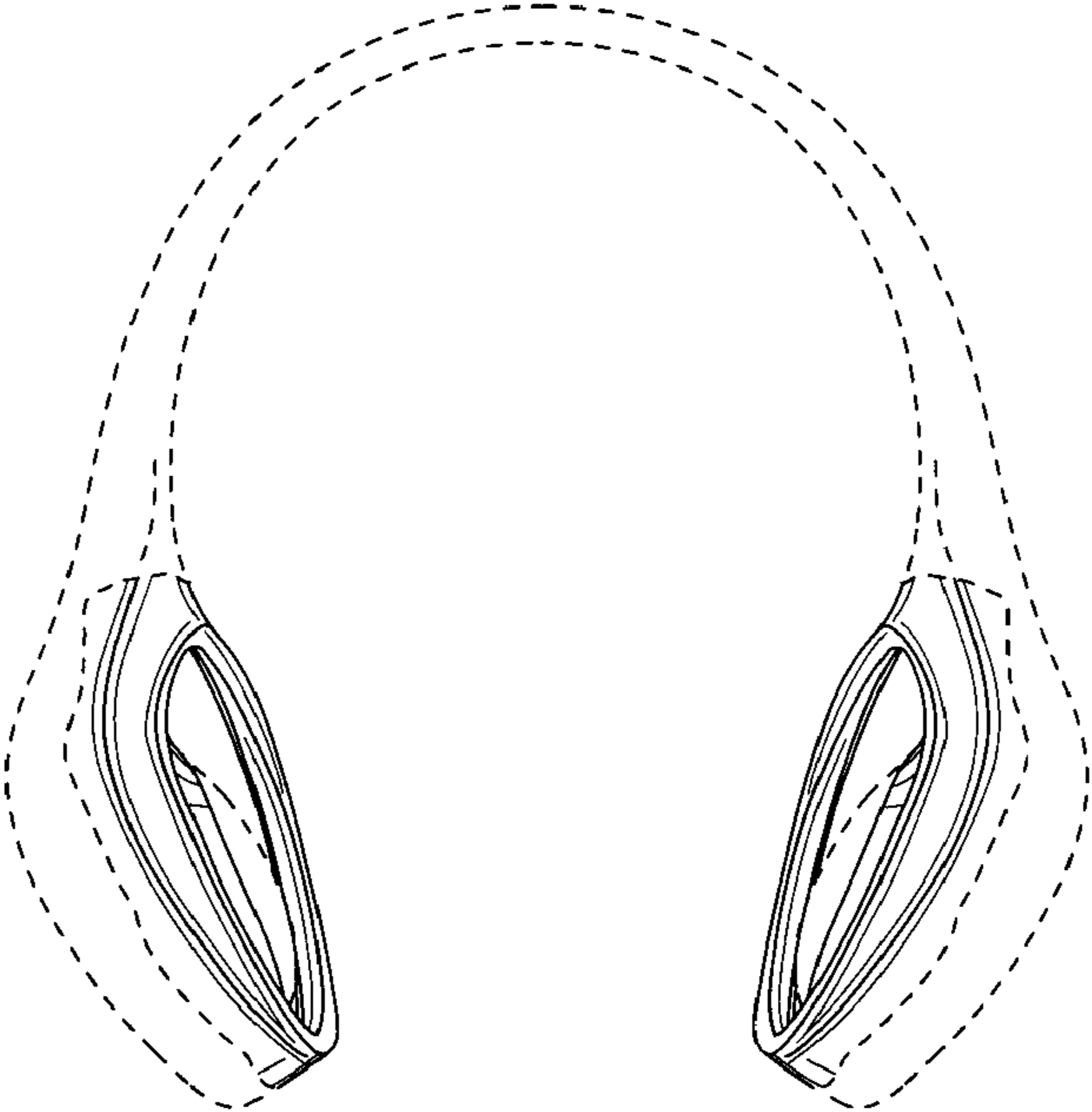

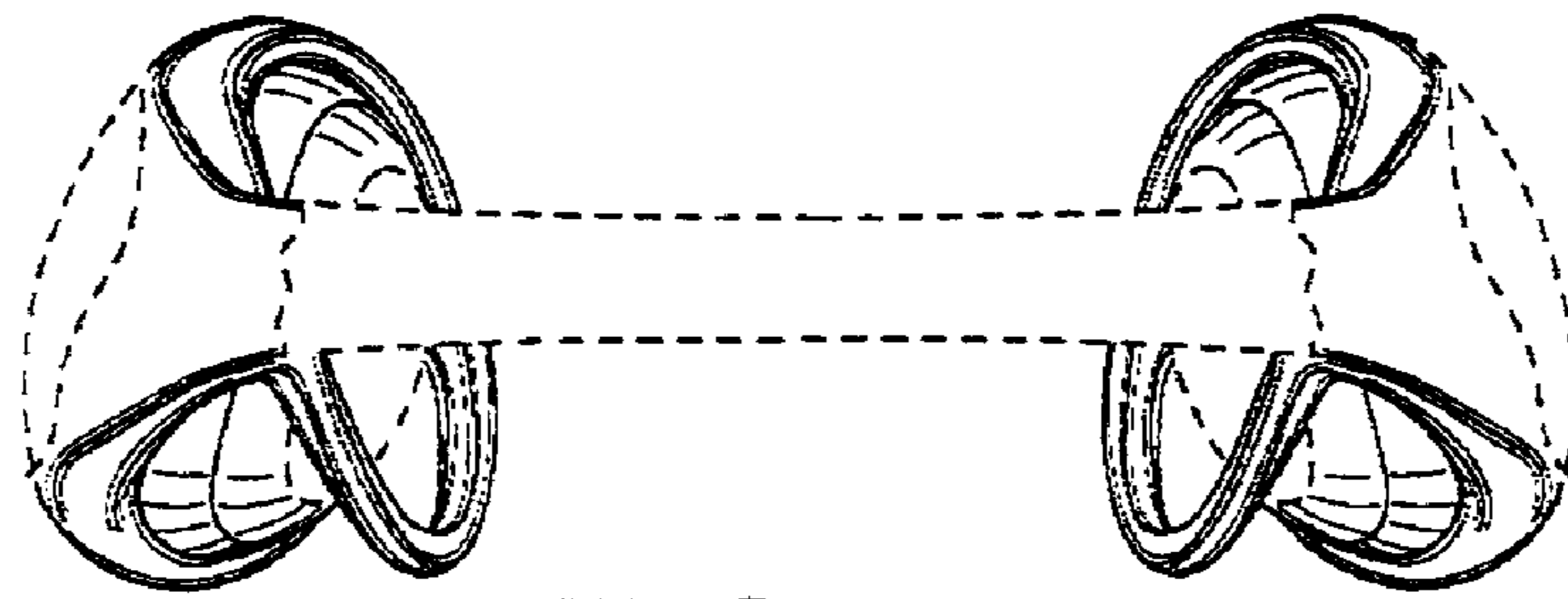

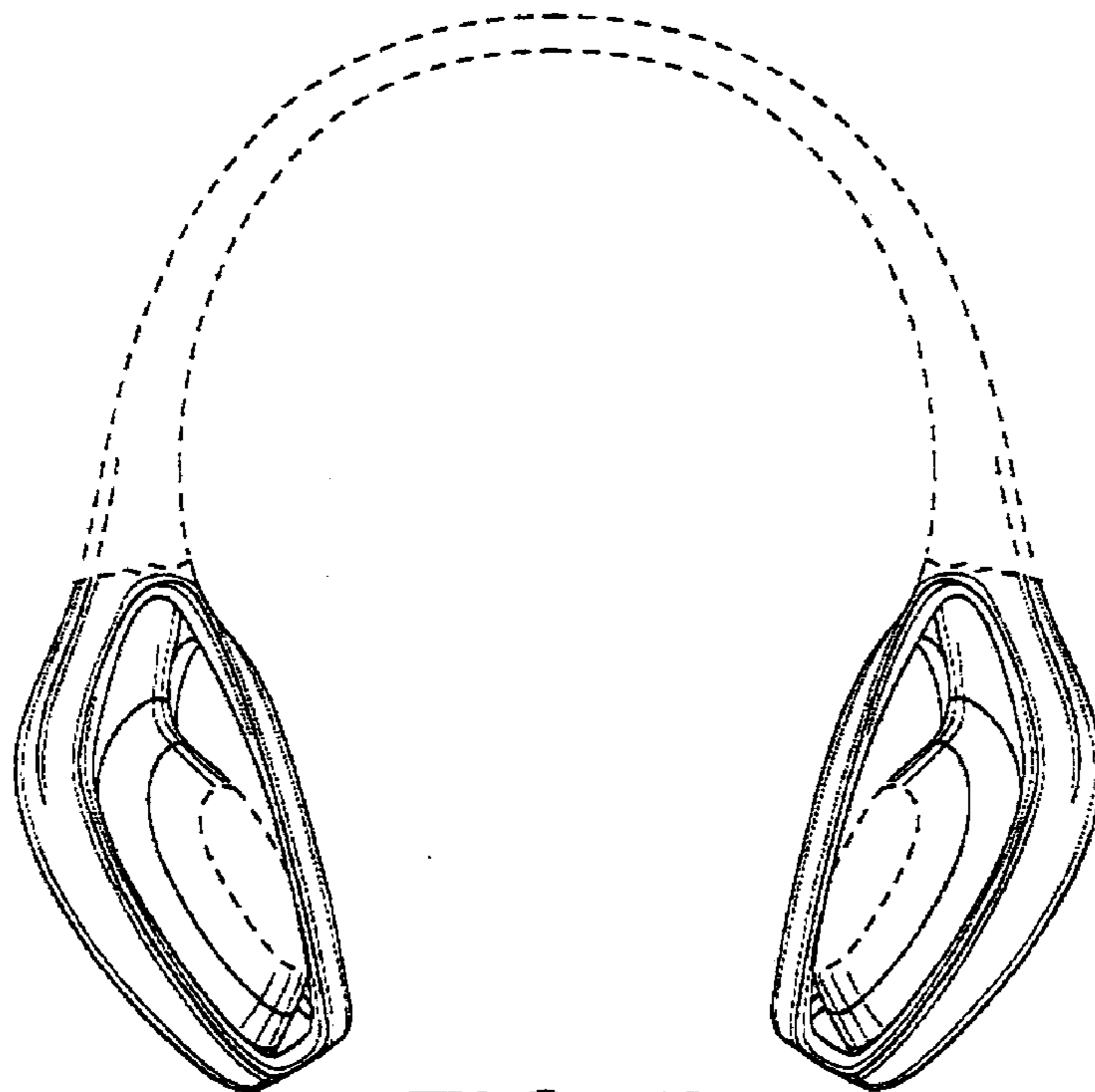

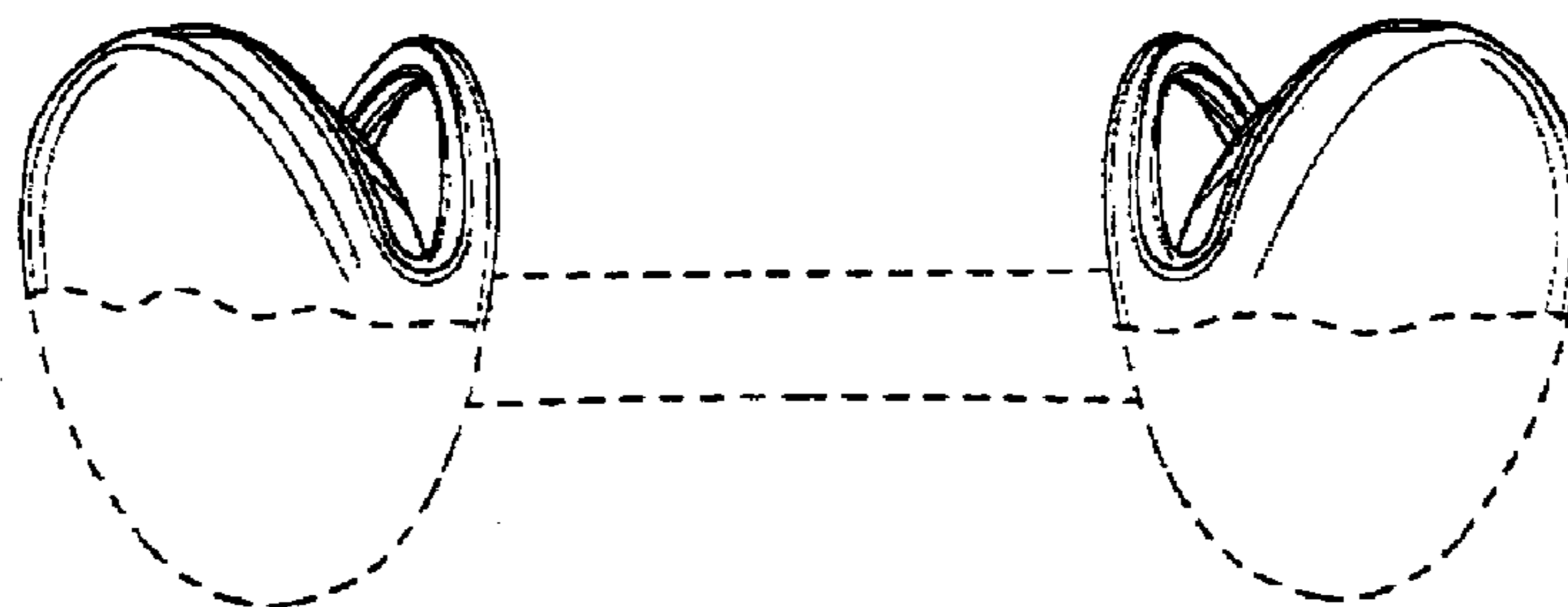
