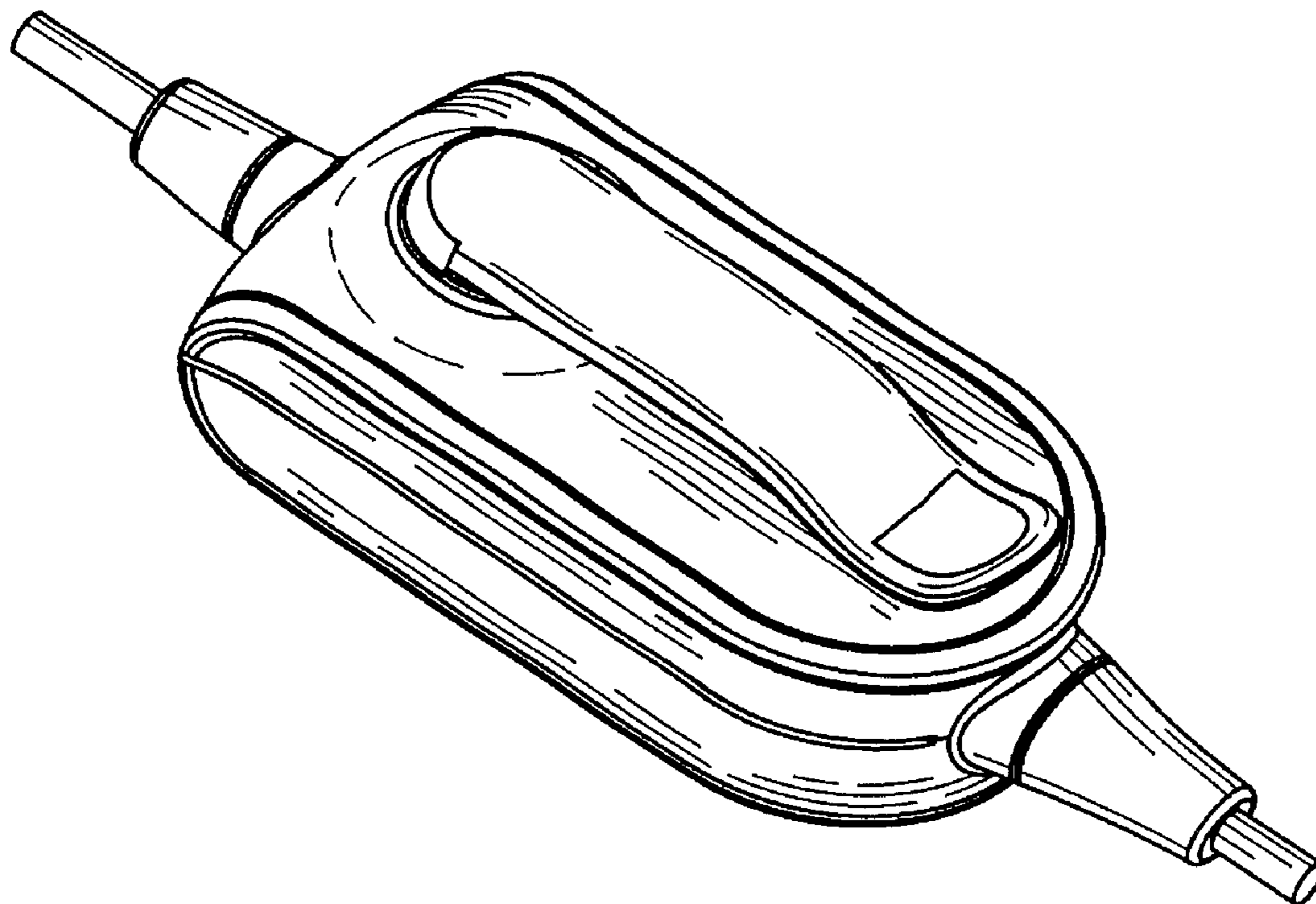
(57) **CLAIM**

The ornamental design for a control pod for communications headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a lower rear right perspective view of a control pod for a communications headset.  
FIG. 2 is a lower front left perspective view of the control pod.  
FIG. 3 is a top plan view of the control pod.  
FIG. 4 is a bottom plan view of the control pod.  
FIG. 5 is a rear elevational view of the control pod.  
FIG. 6 is a front elevational view of the control pod.  
FIG. 7 is a left side elevational view of the control pod; and, FIG. 8 is a right side elevational view of the control pod.

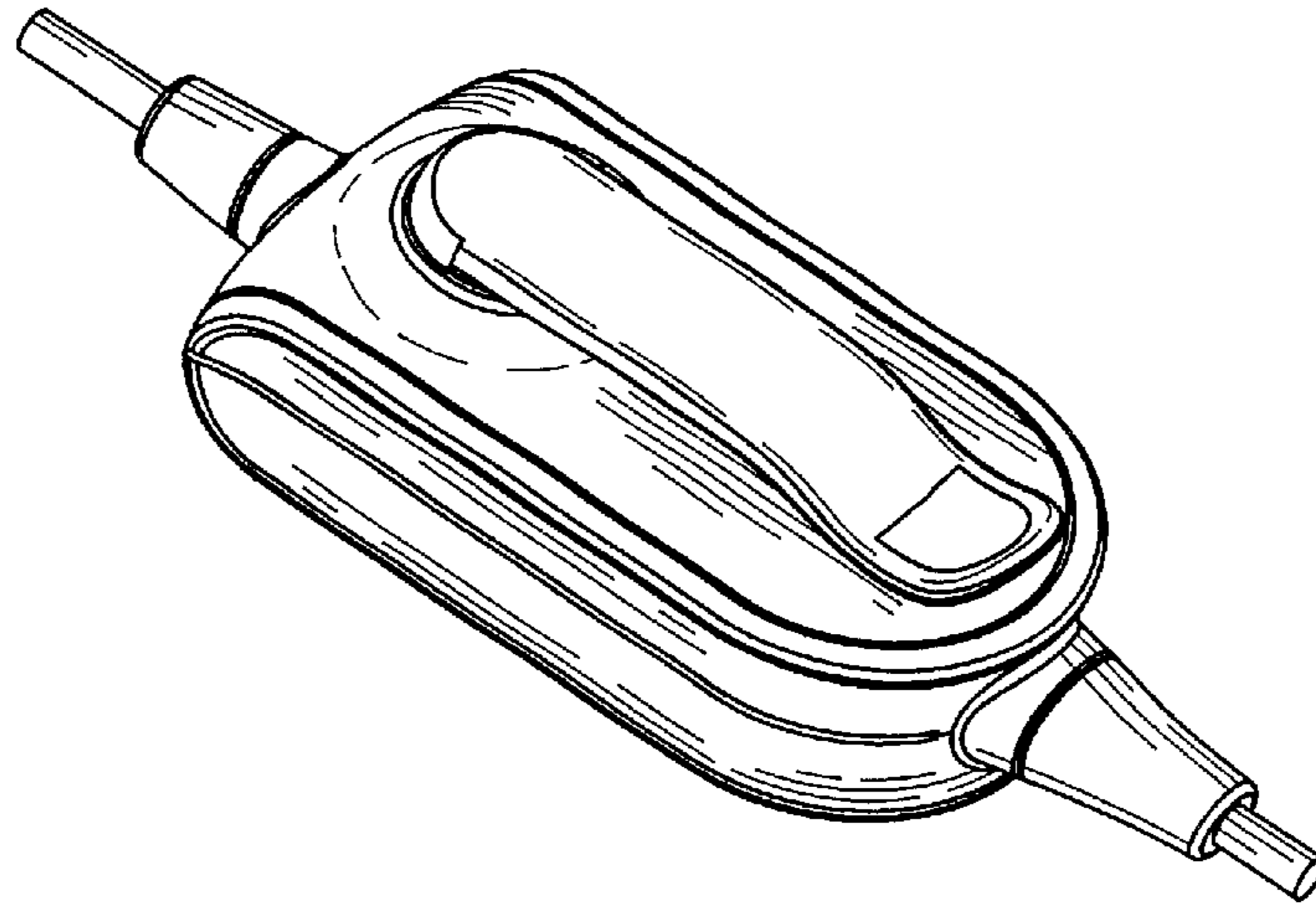

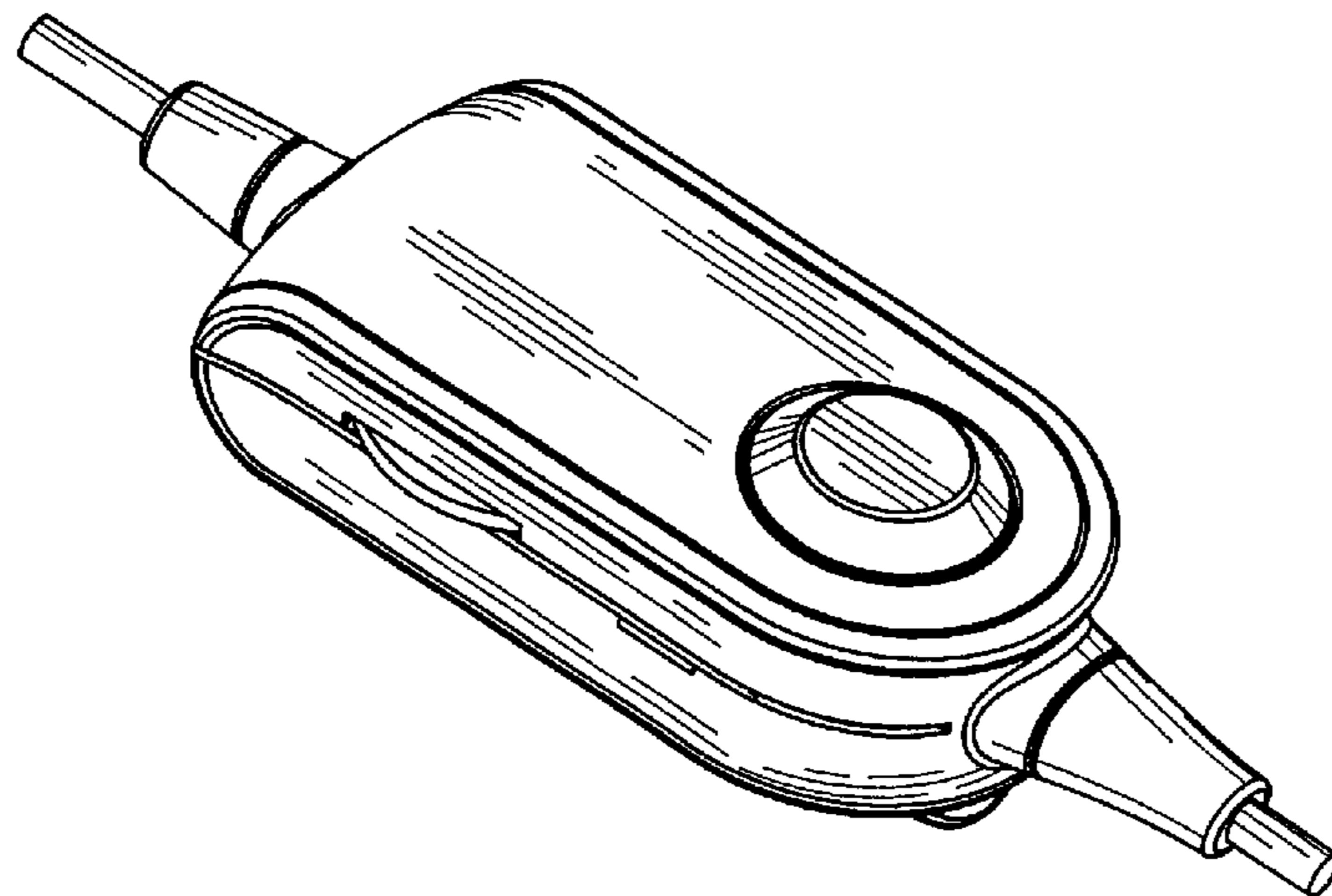

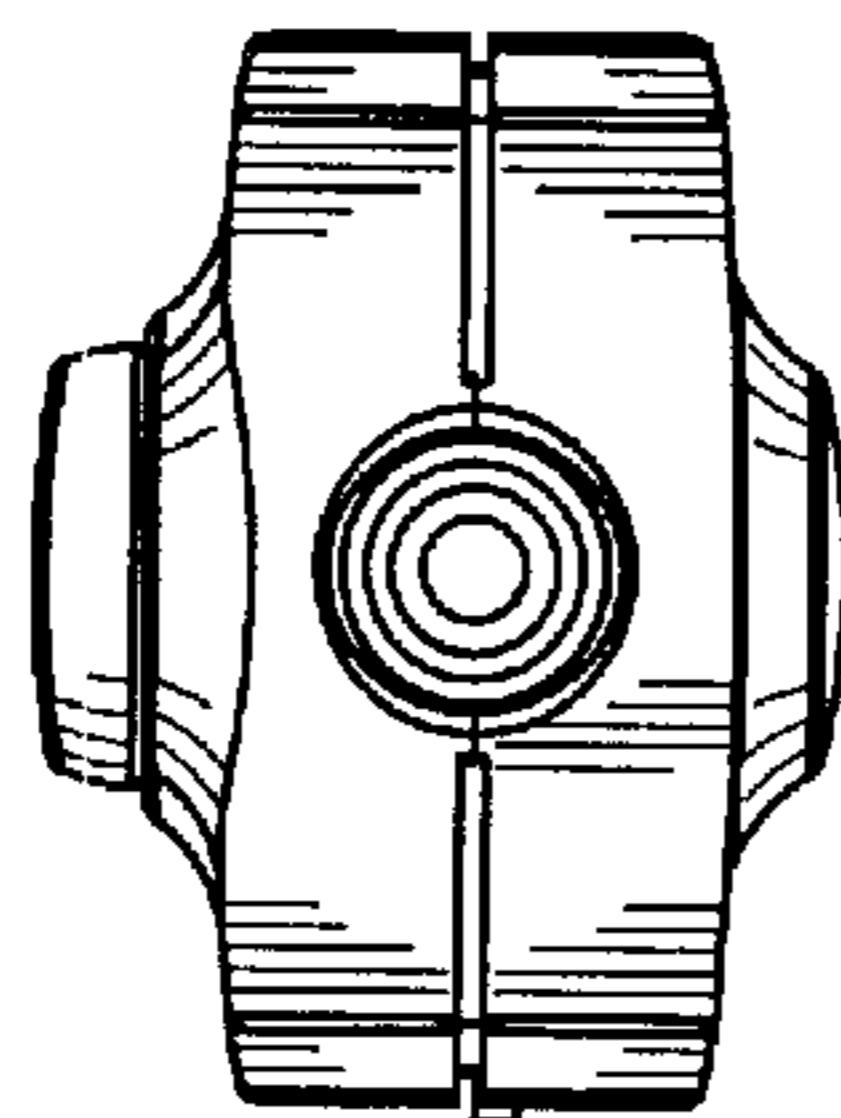

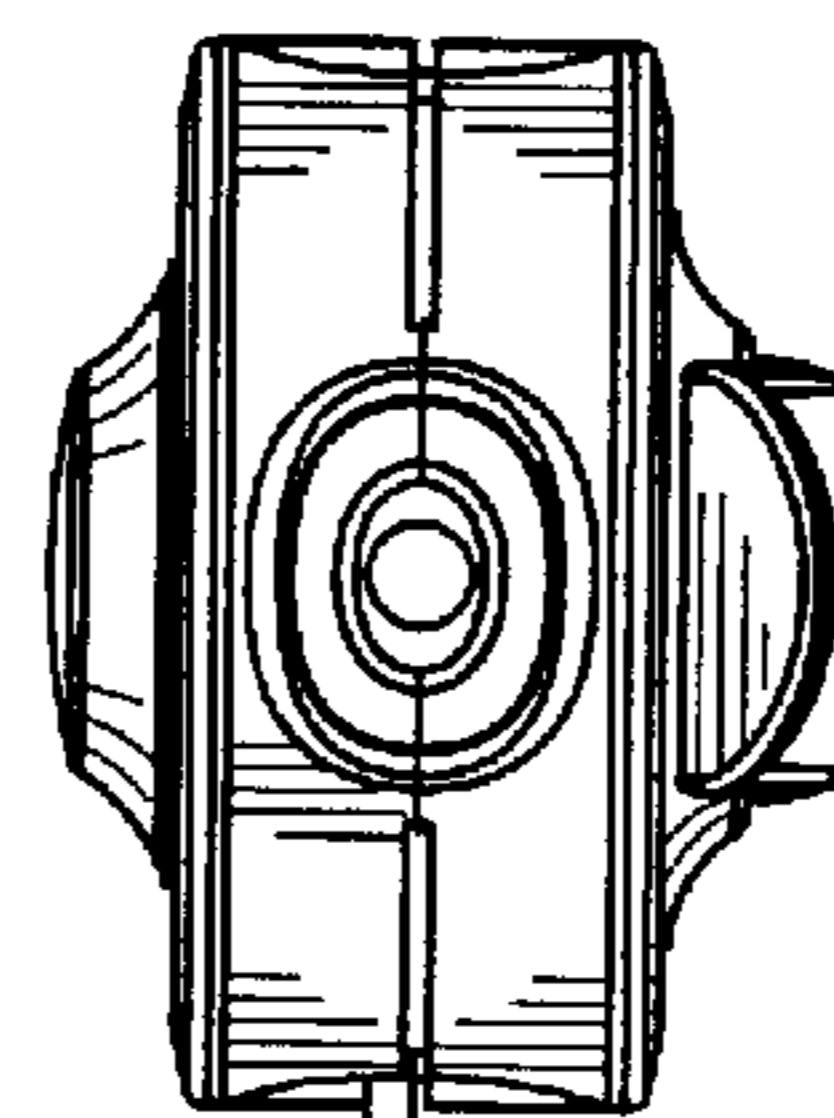

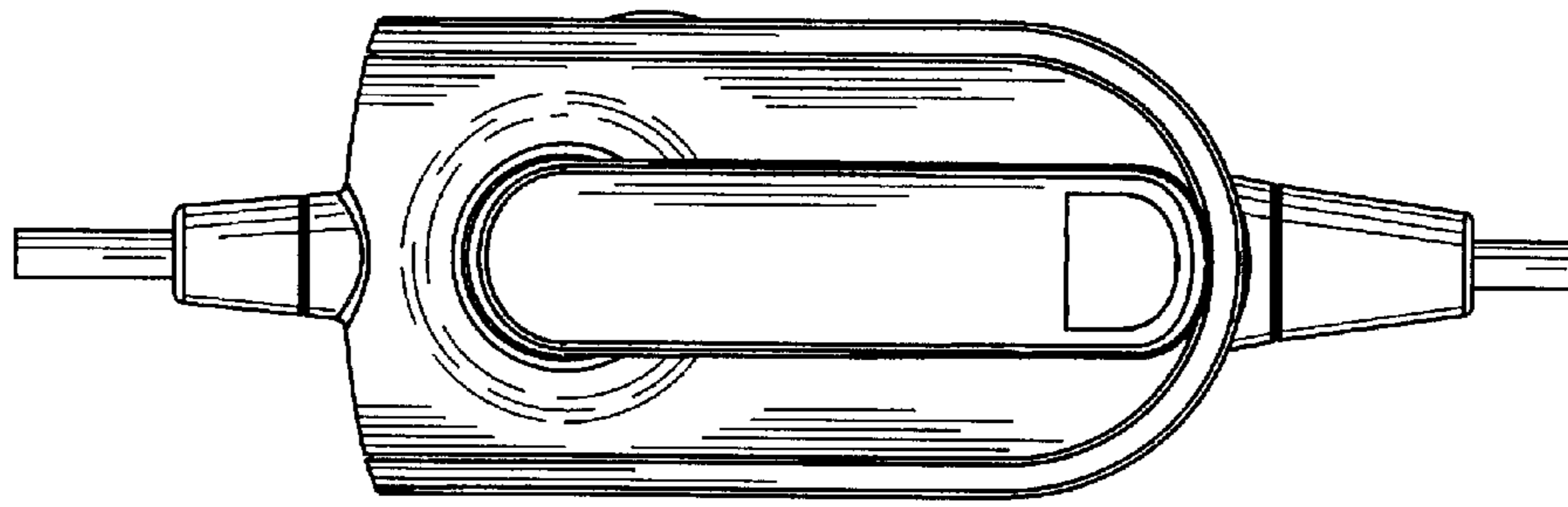

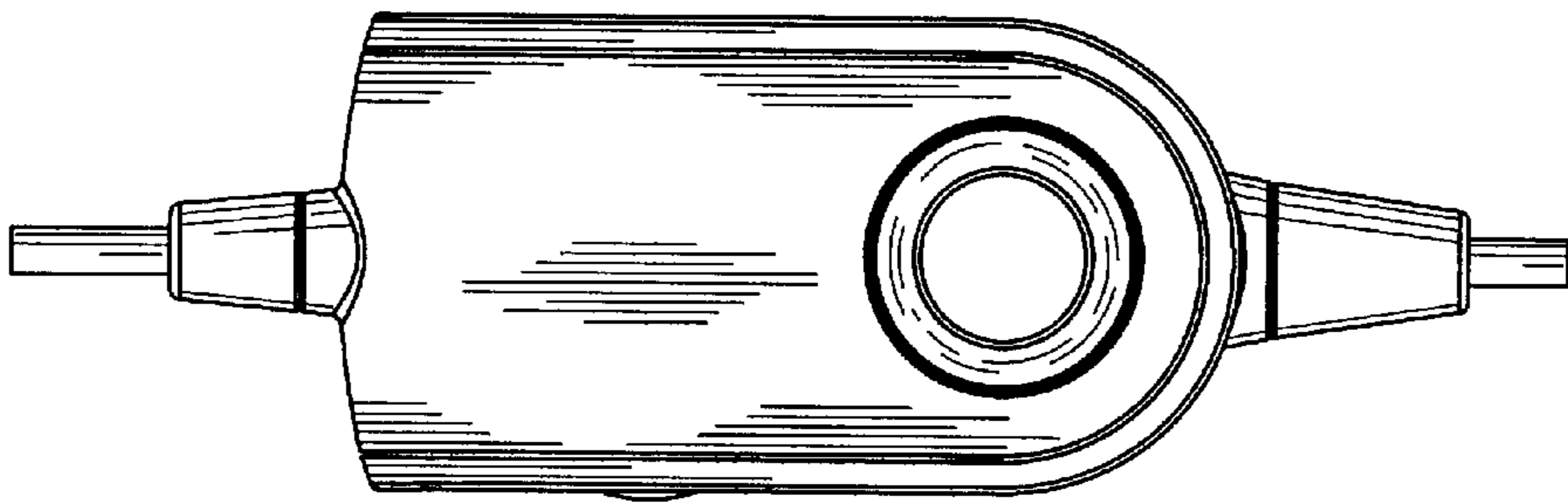

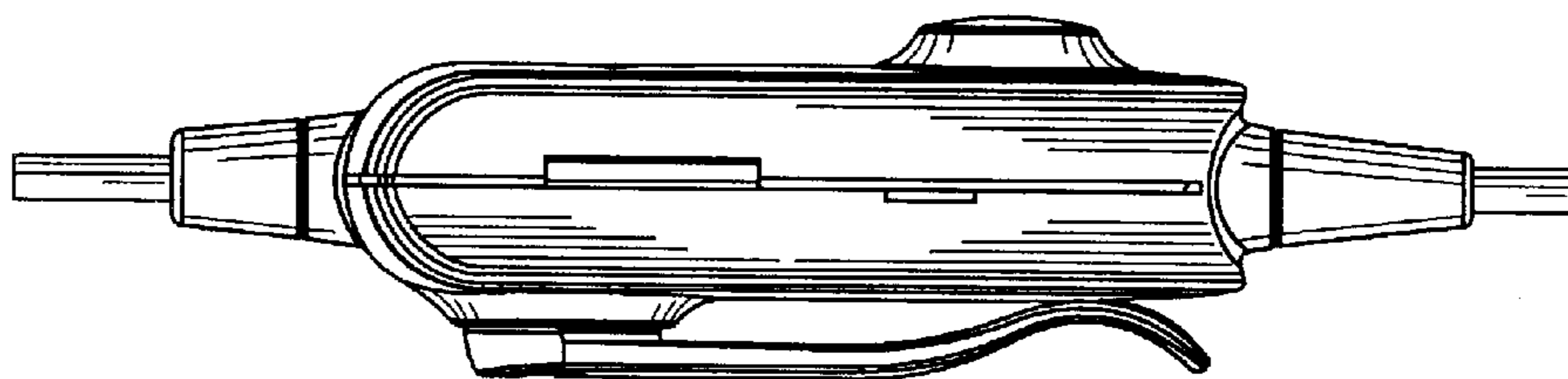

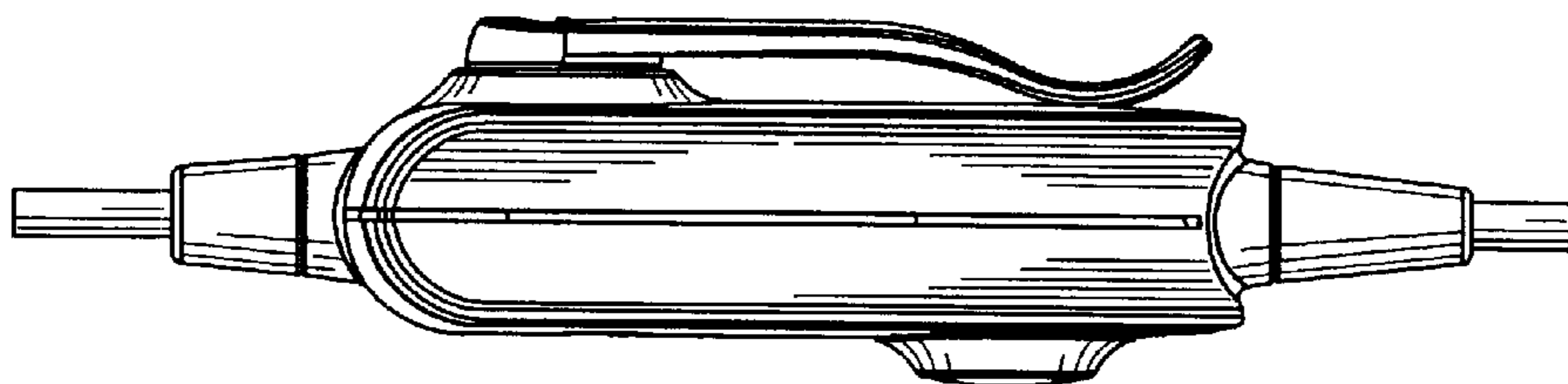
