(57) **CLAIM**

The ornamental design for a computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a computer showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a right side elevational view thereof wherein lines 7—7 are shown;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof; and,  
FIG. 7 is an enlarged view thereof taken along the lines 7—7 in the direction of the arrows shown in FIG. 4.  
Portions of FIGS. 1 and 3—7 that are shown as broken lines are for illustrative purpose only and form no part of the claimed design. The broken lines shown in FIG. 7 define the lines 7—7, but are not included in the boundaries of the claimed design.

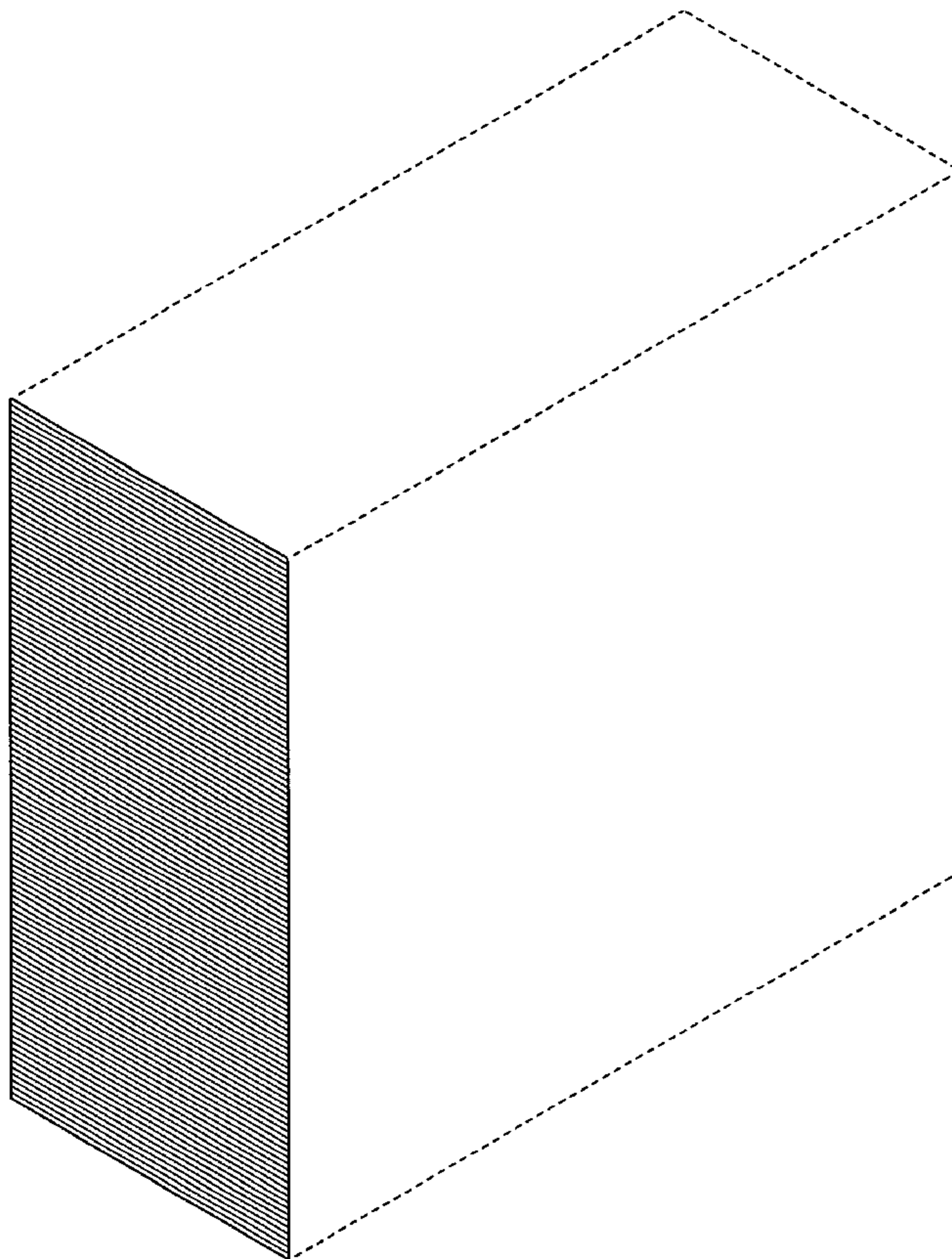
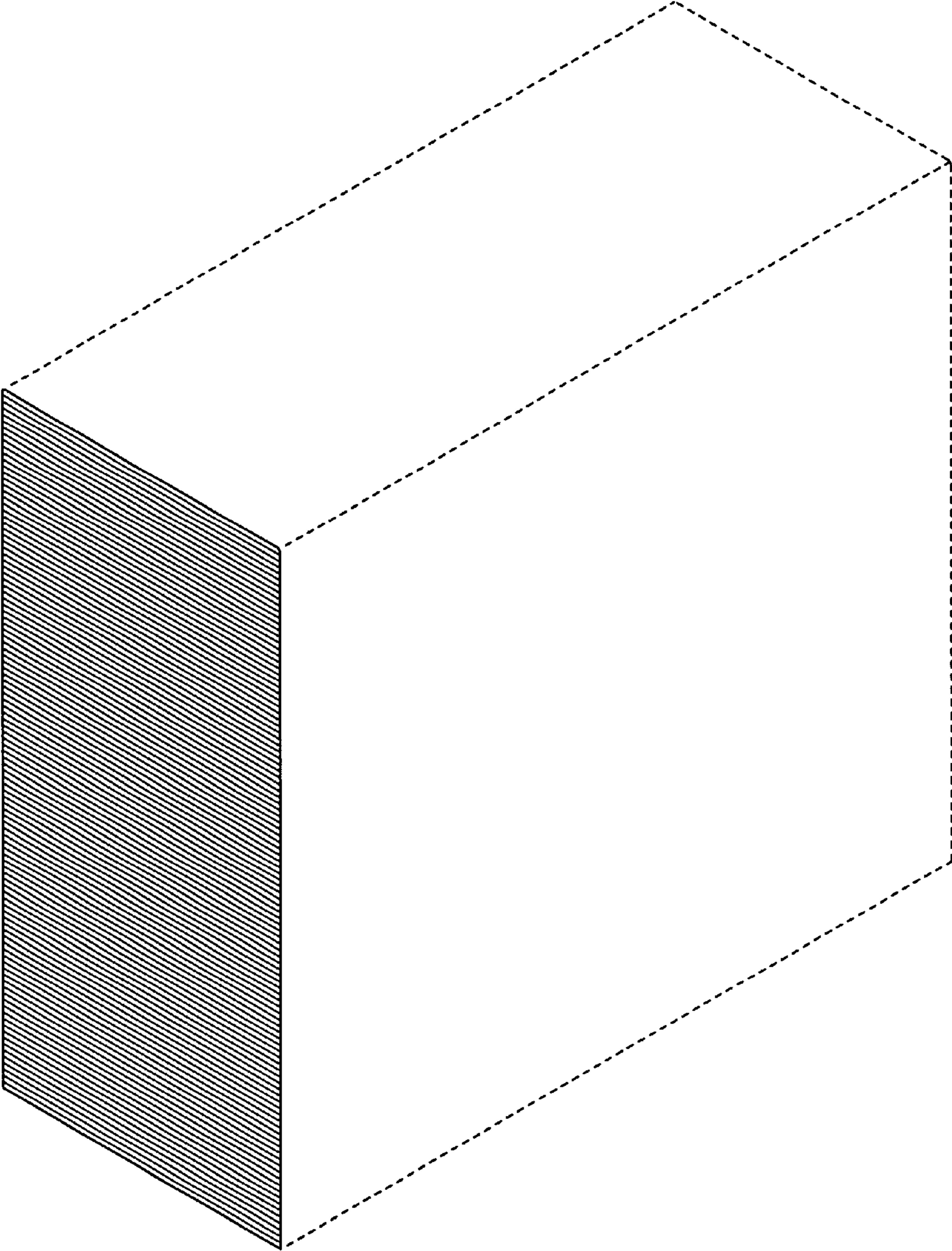

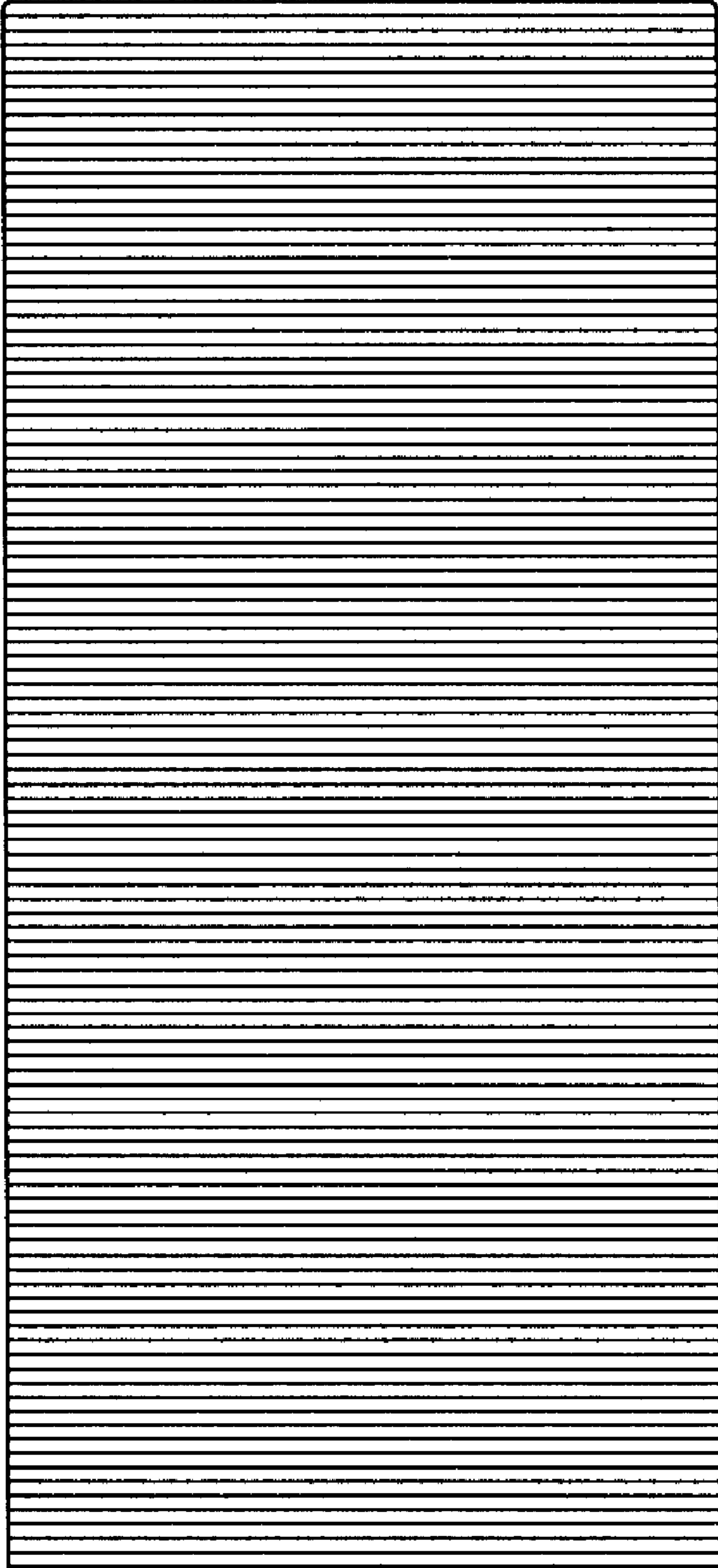
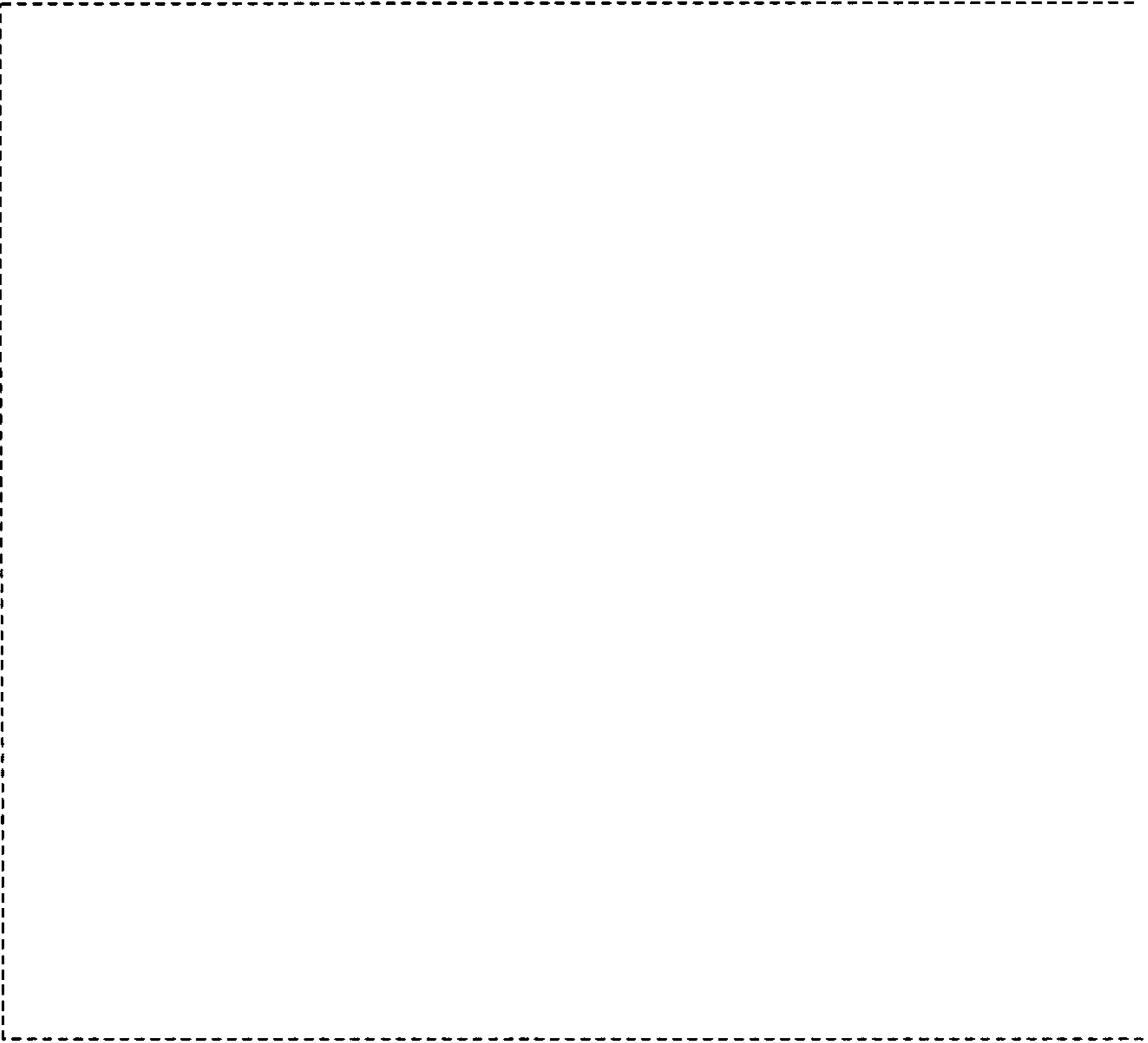

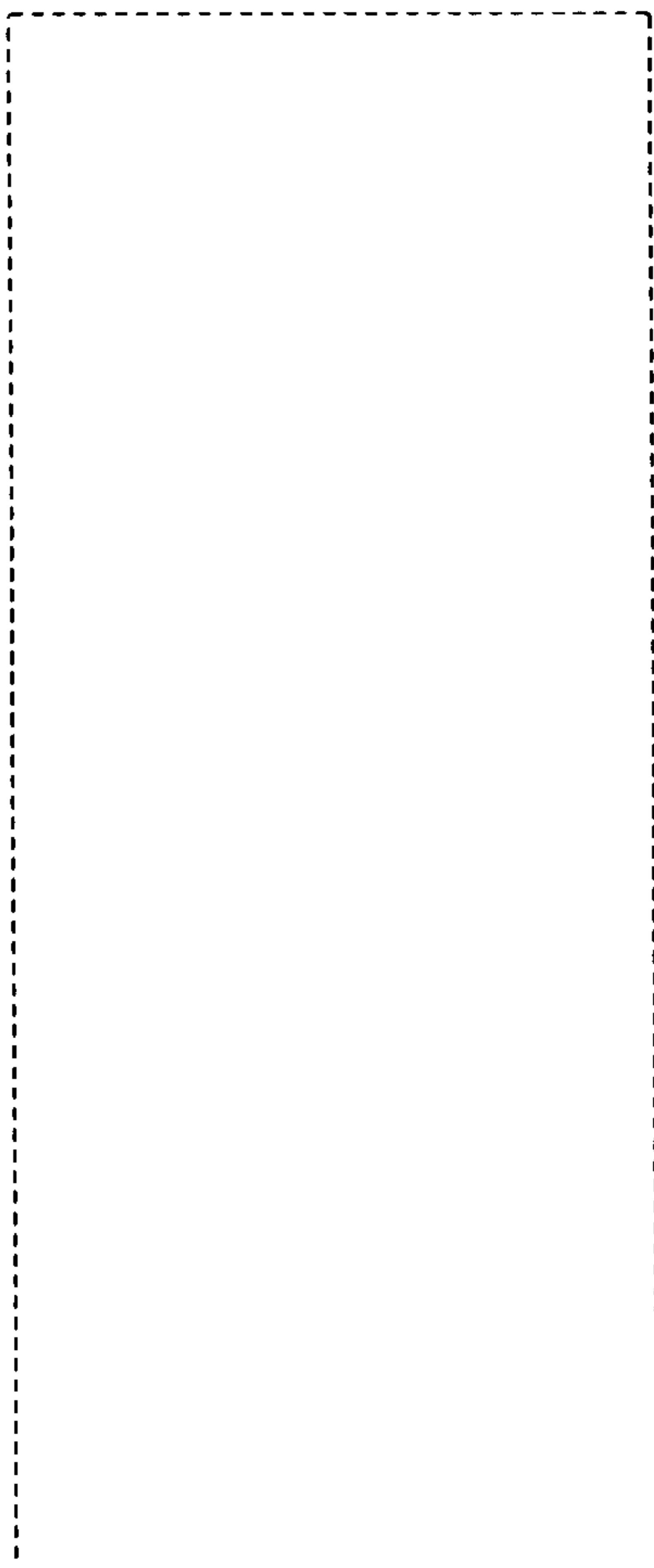

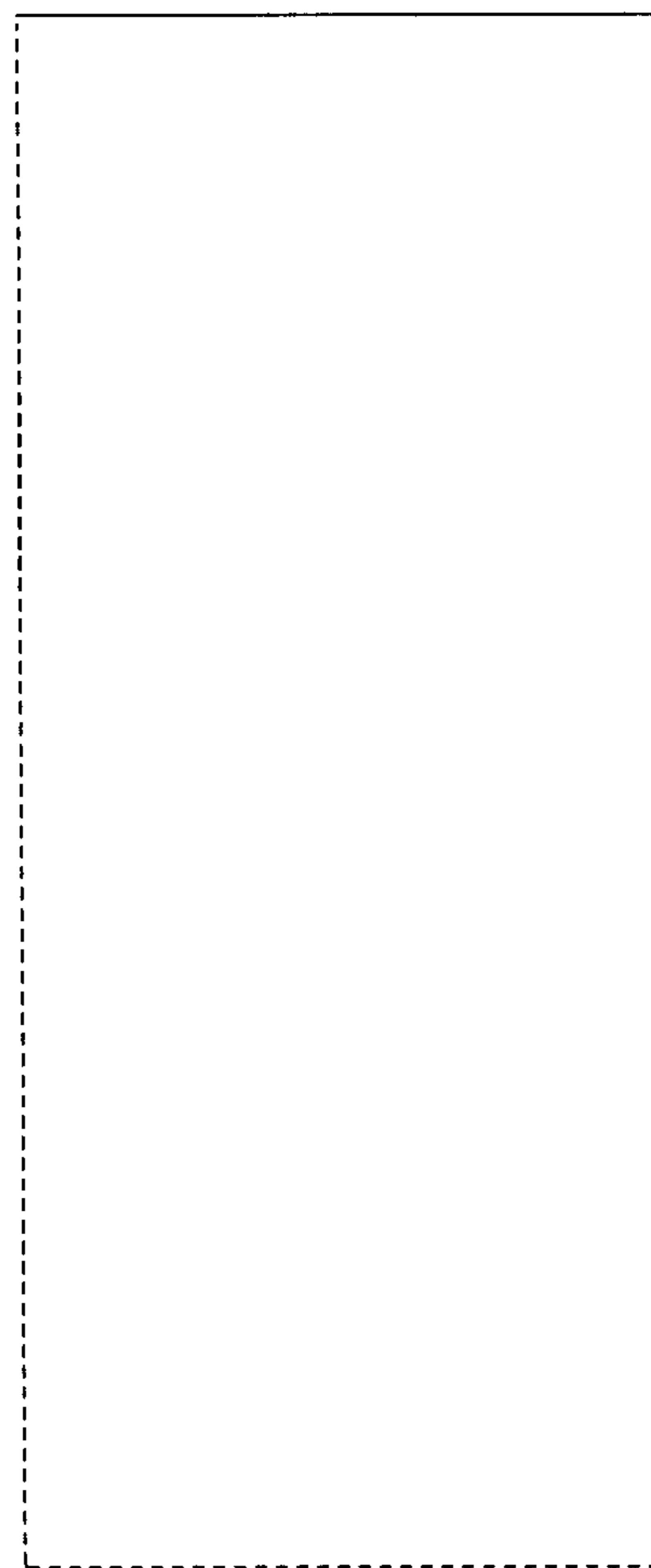
