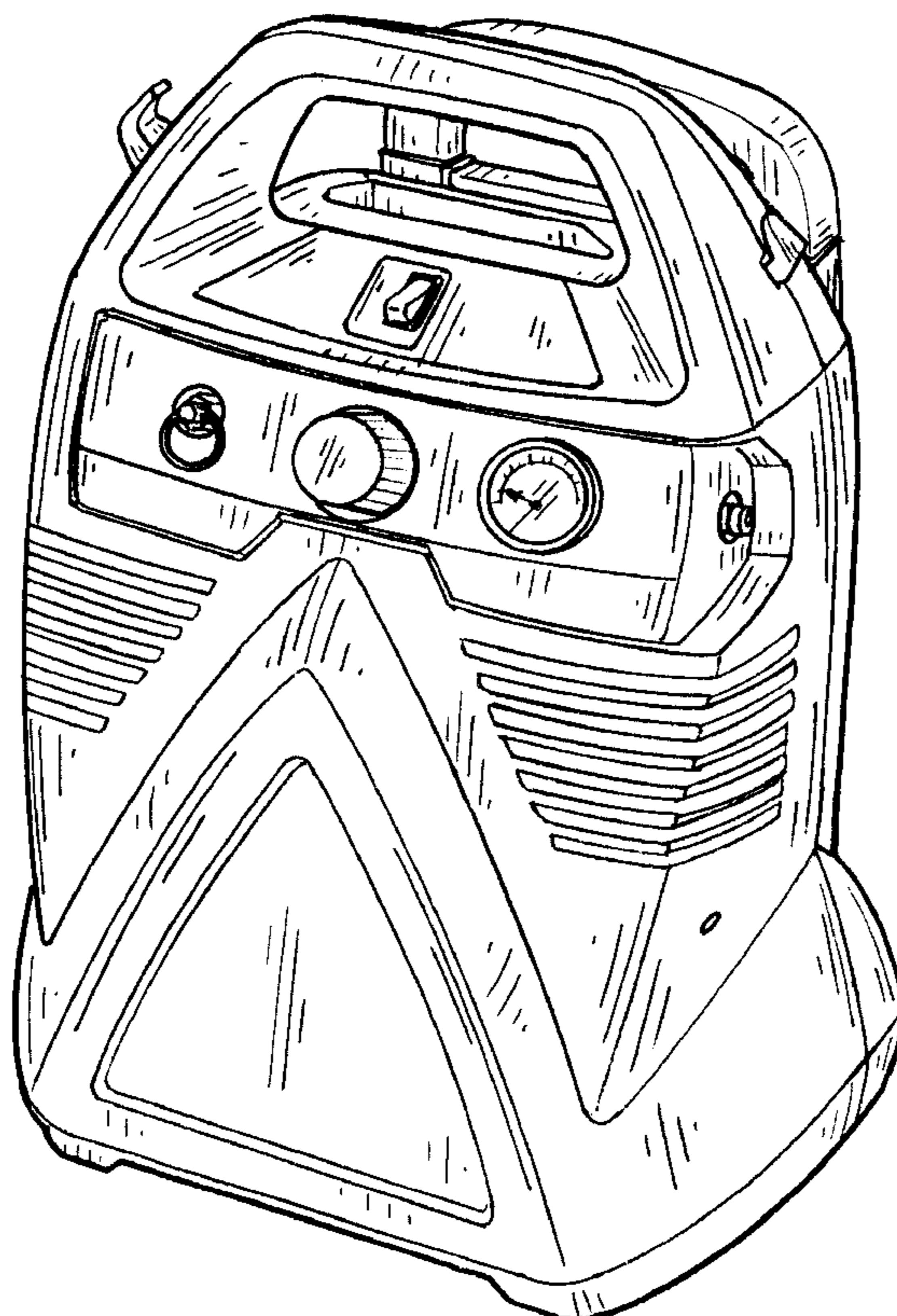
(57) **CLAIM**

The ornamental design for an air compressor, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a first embodiment of an air compressor showing our new design;
FIG. 2 is a top plan view of the first embodiment;
FIG. 3 is left side elevation view of the first embodiment;
FIG. 4 is a front elevation view of the first embodiment;
FIG. 5 is a right side elevation view of the first embodiment;
FIG. 6 is a rear elevation view of the first embodiment;
FIG. 7 is a bottom plan view of the first embodiment;
FIG. 8 is an isometric view of the air compressor in FIG. 1, shown with the handle extended;
FIG. 9 is a top plan view of FIG. 8;
FIG. 10 is left side elevation view of FIG. 8;
FIG. 11 is a front elevation view of FIG. 8;
FIG. 12 is a right side elevation view of FIG. 8;
FIG. 13 is a rear elevation view of FIG. 8; and,

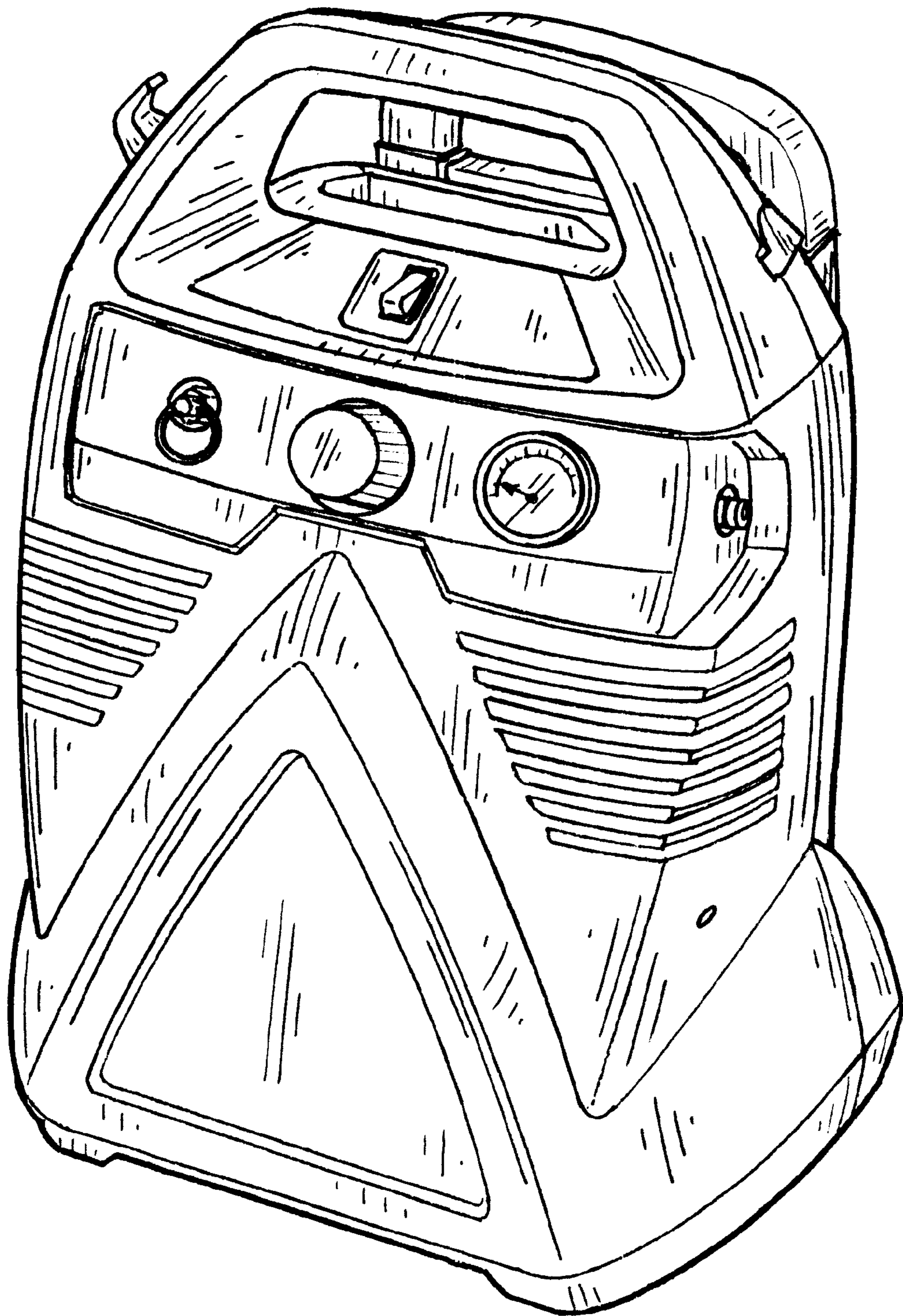

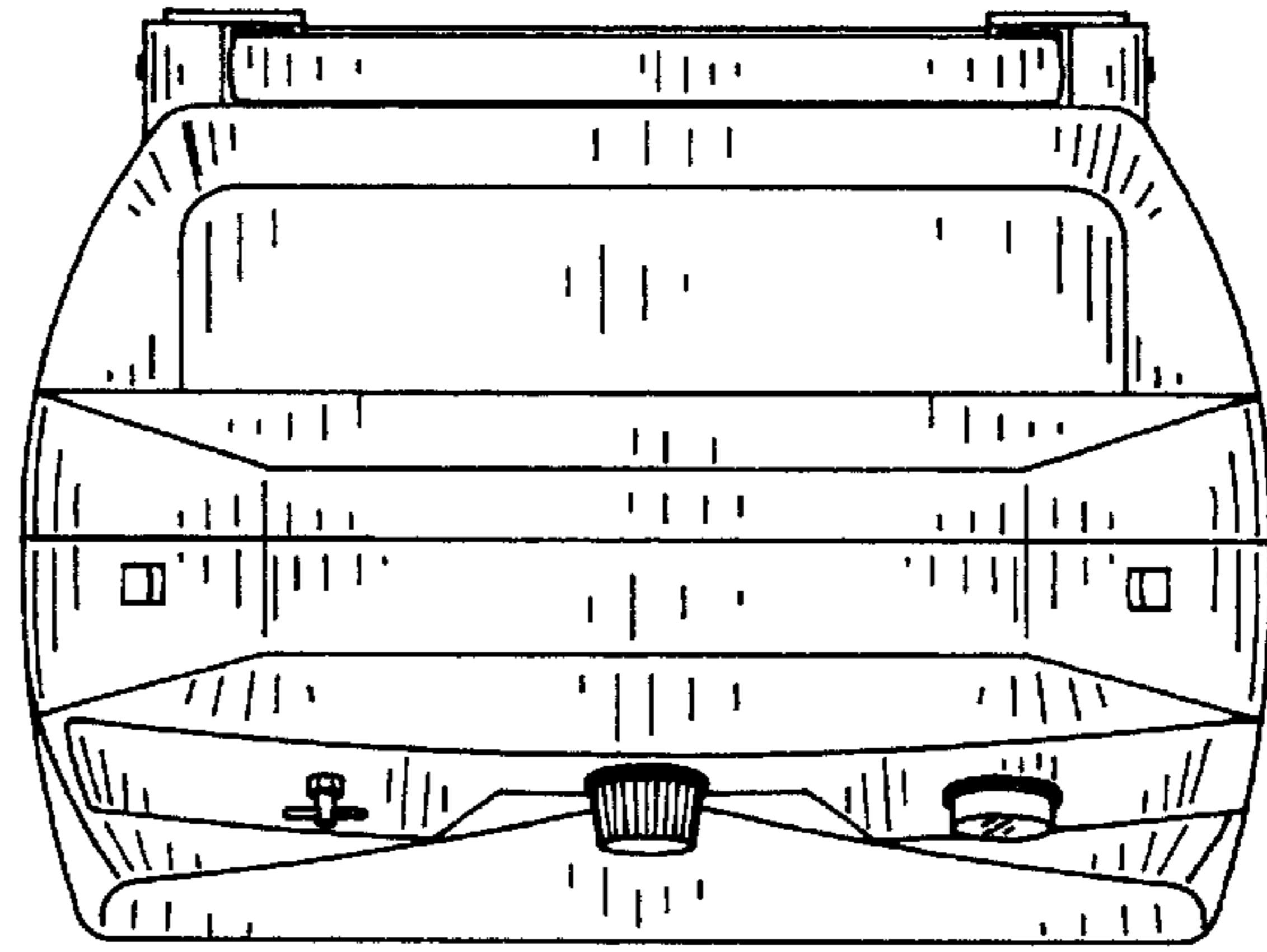

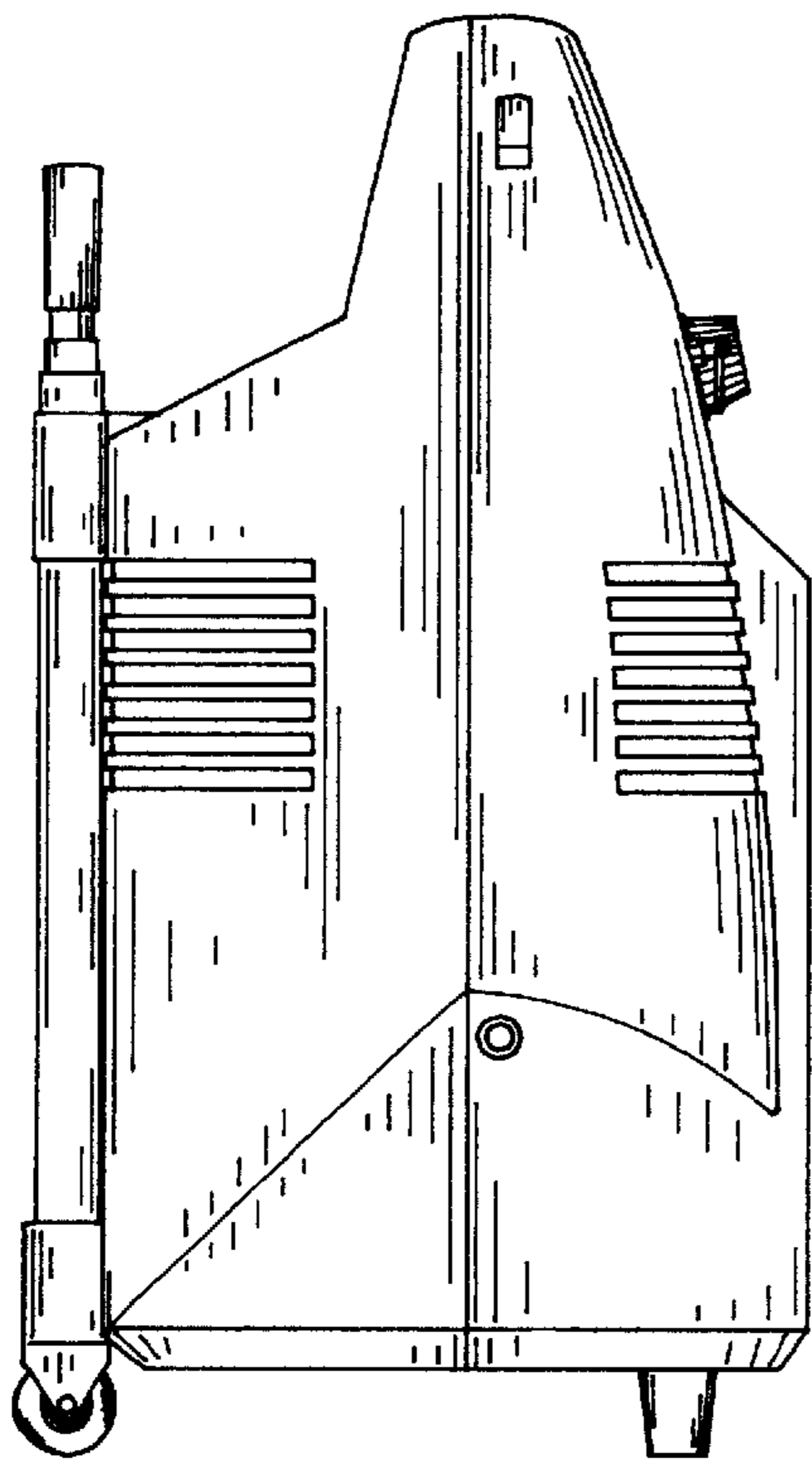

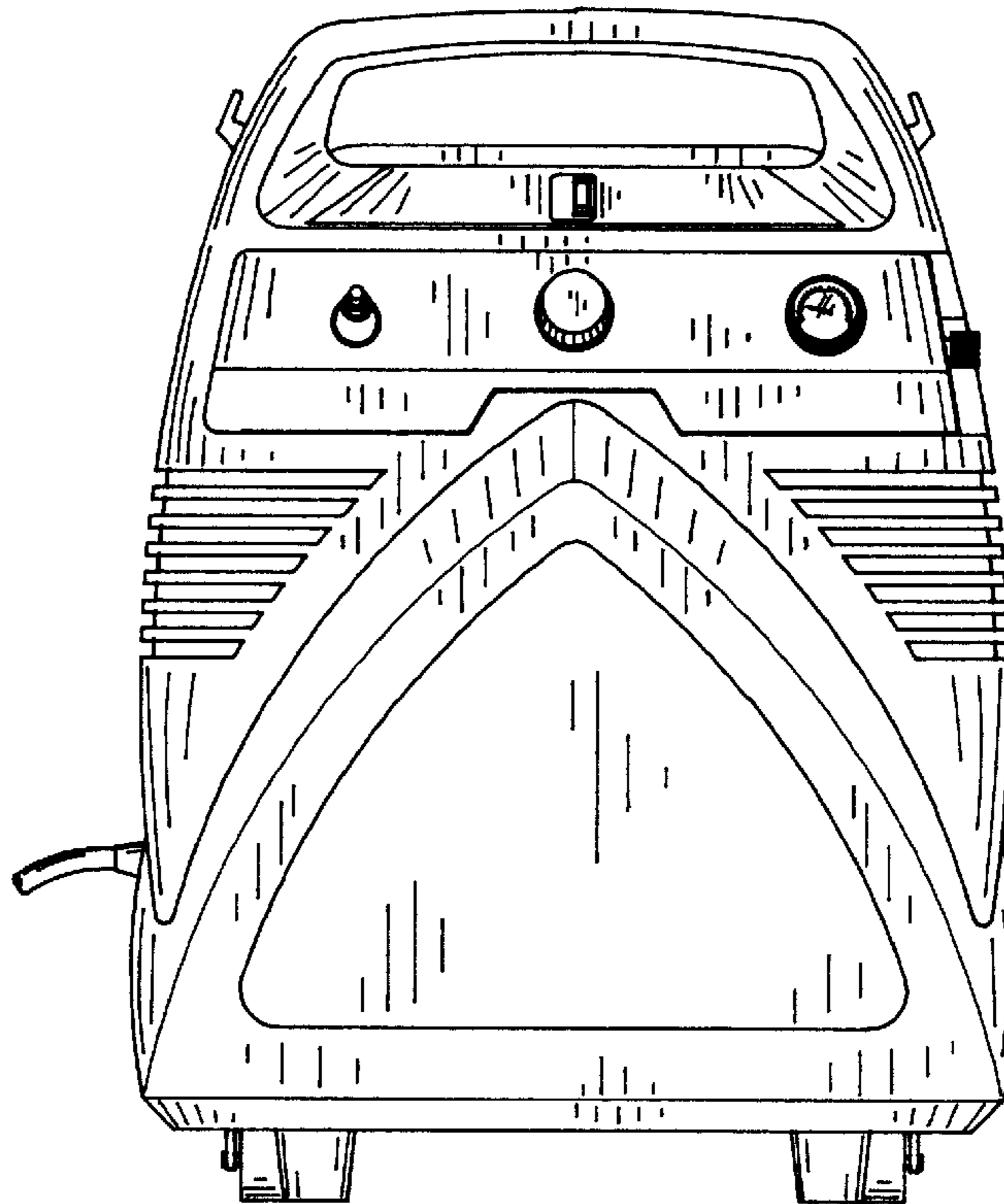

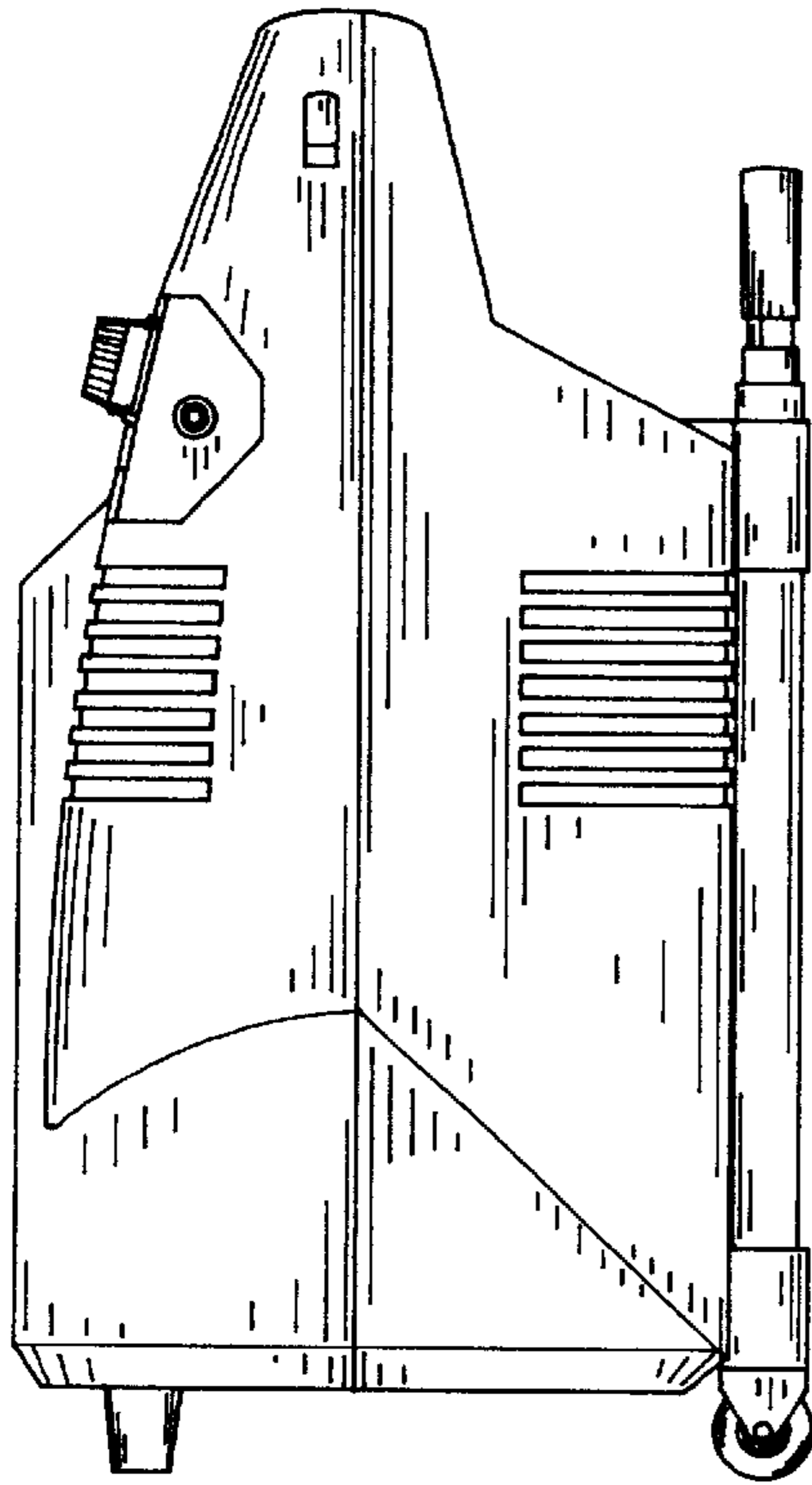

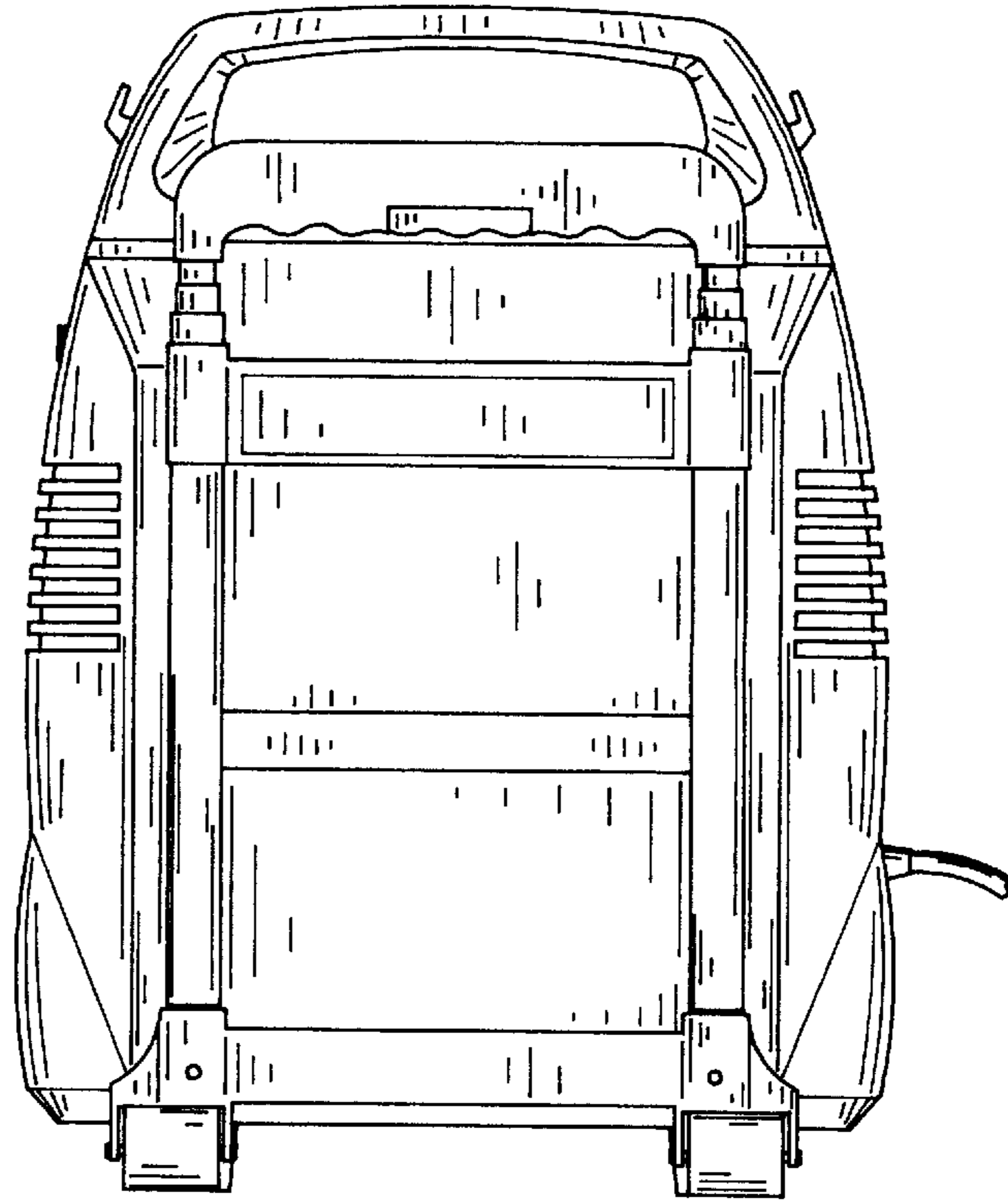

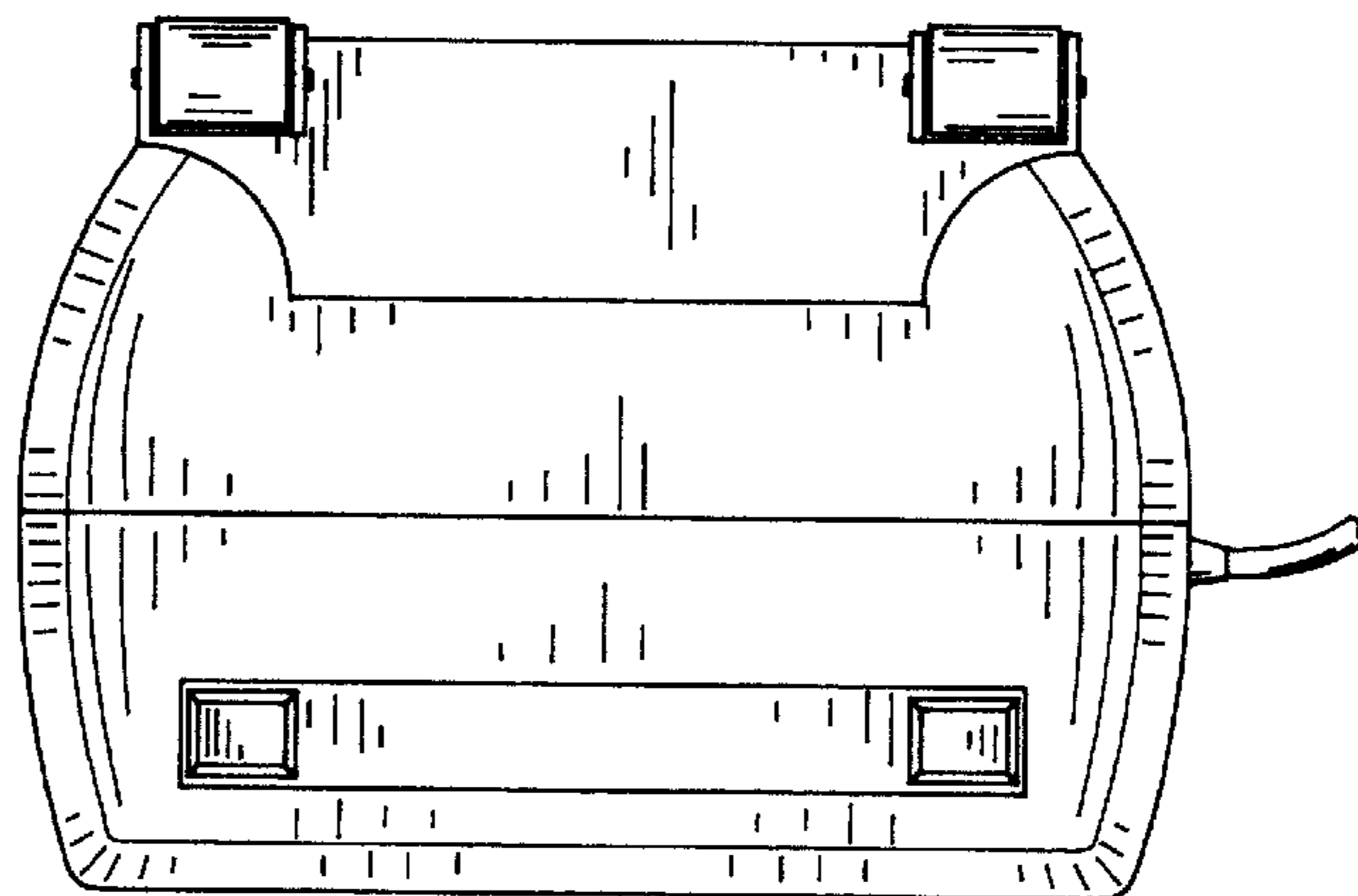

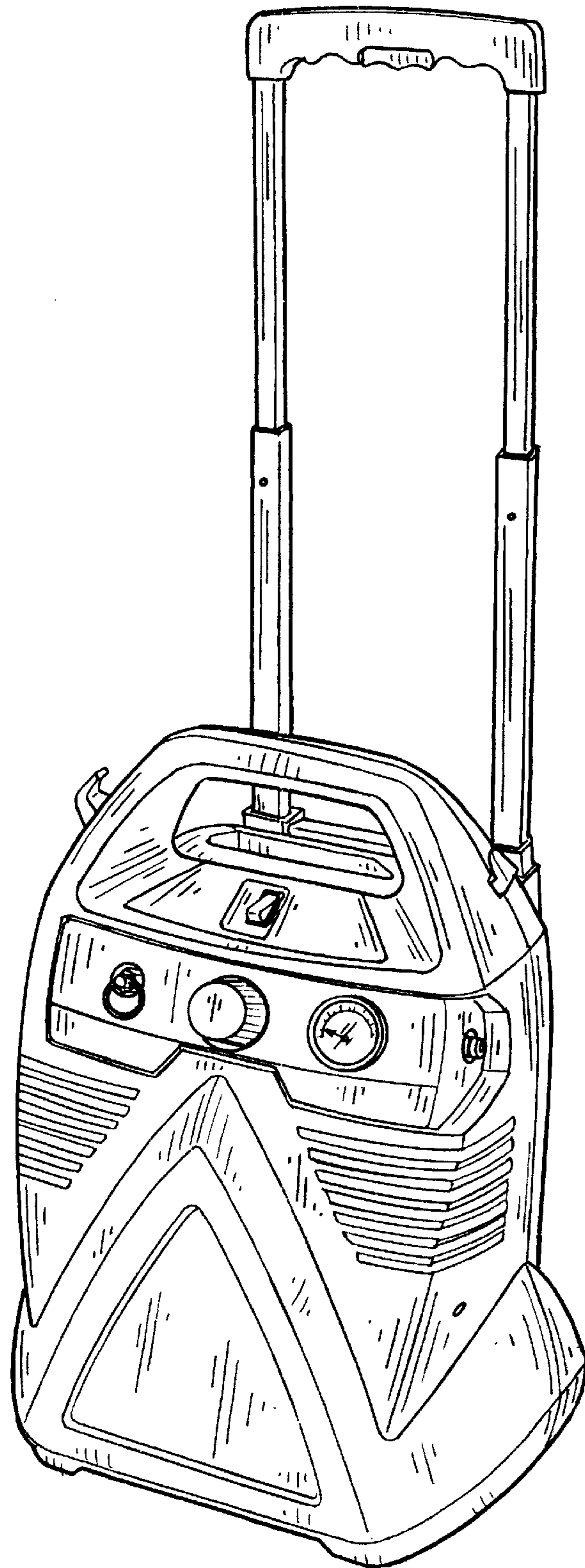

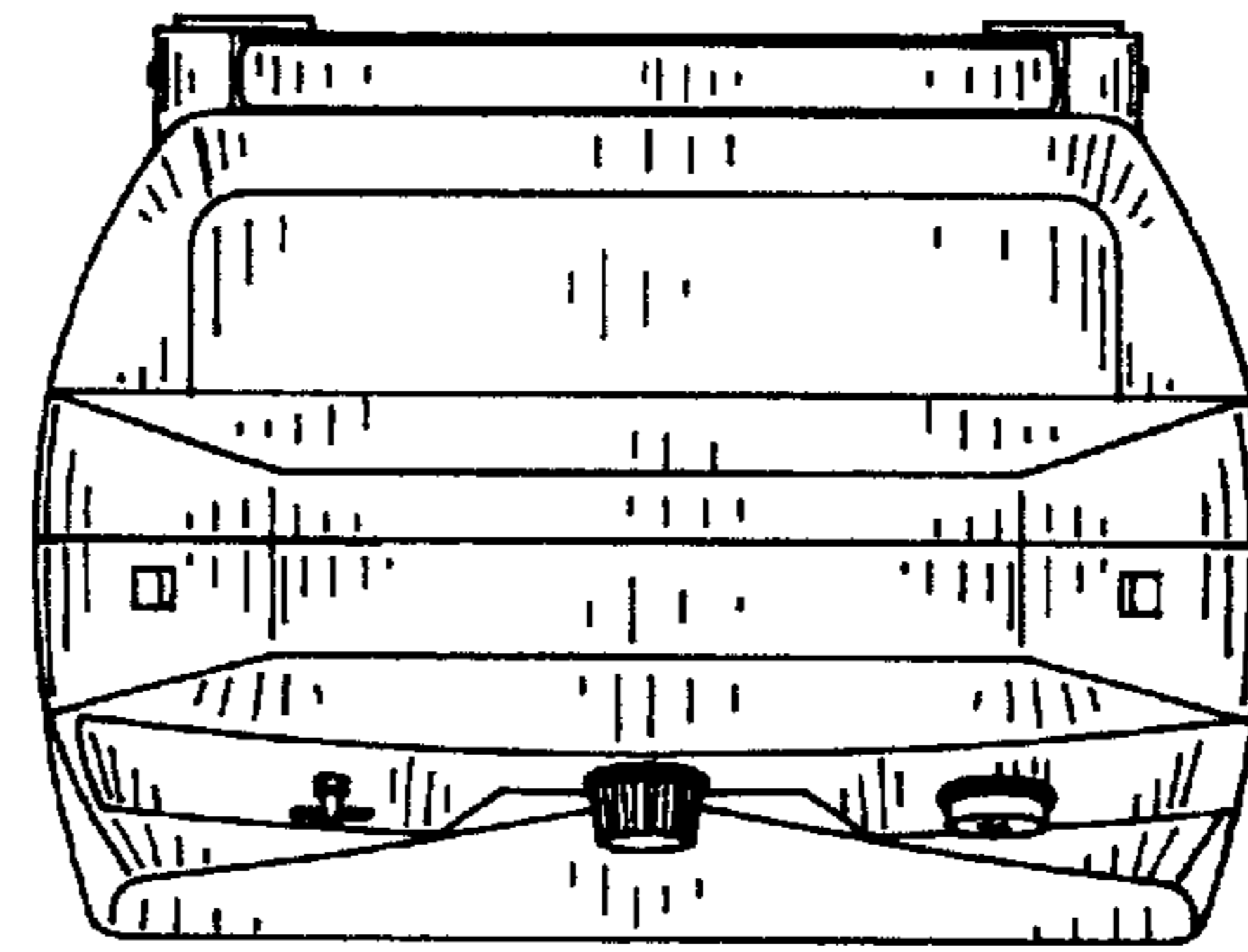

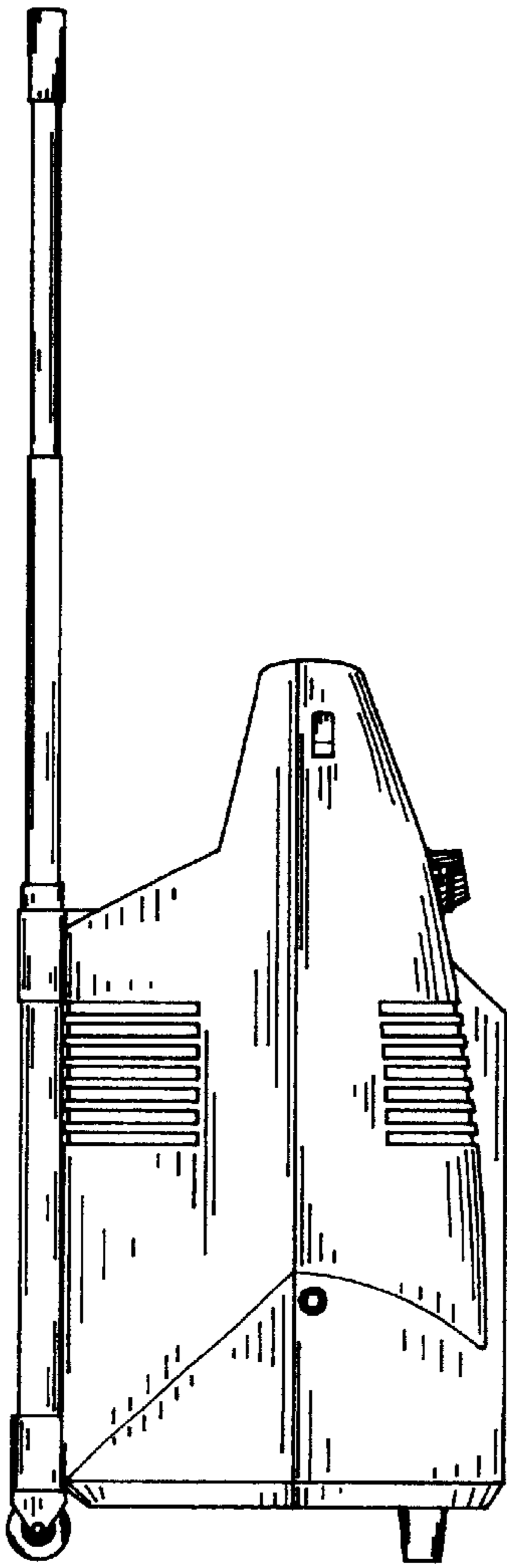

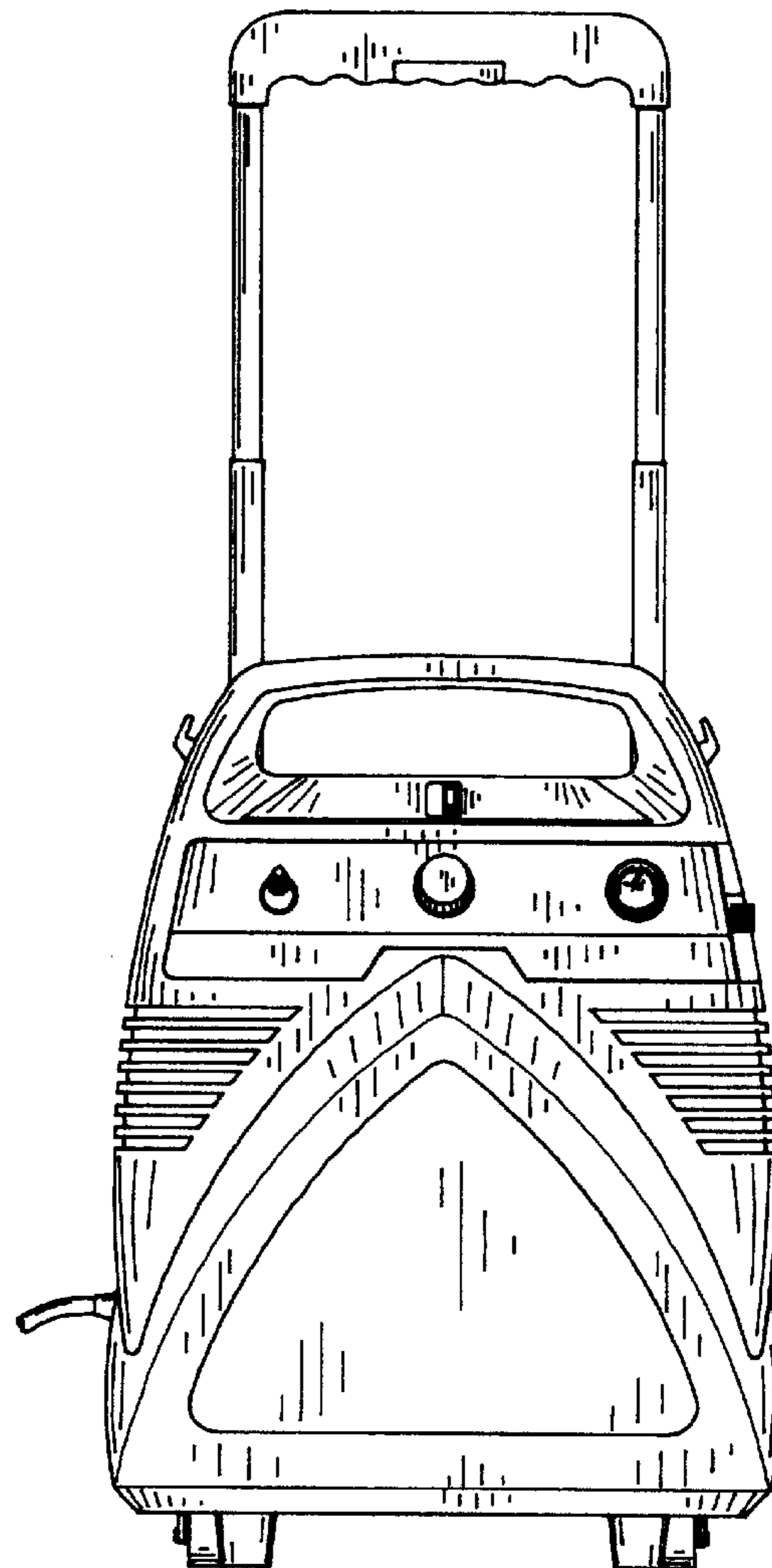

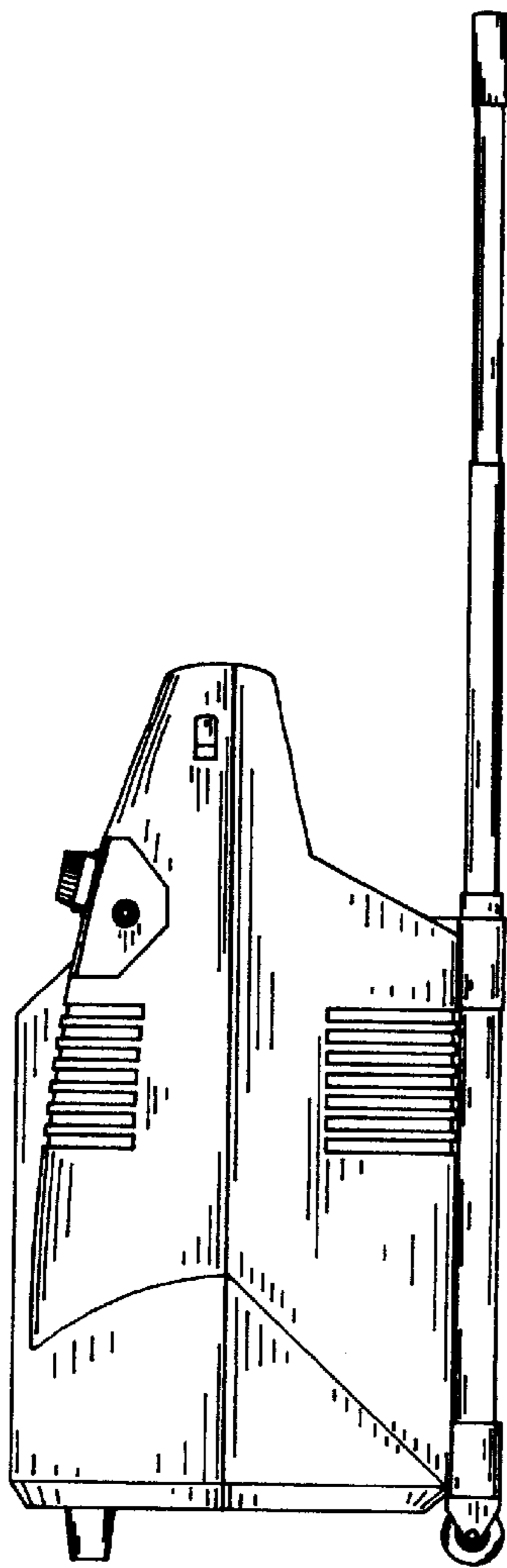

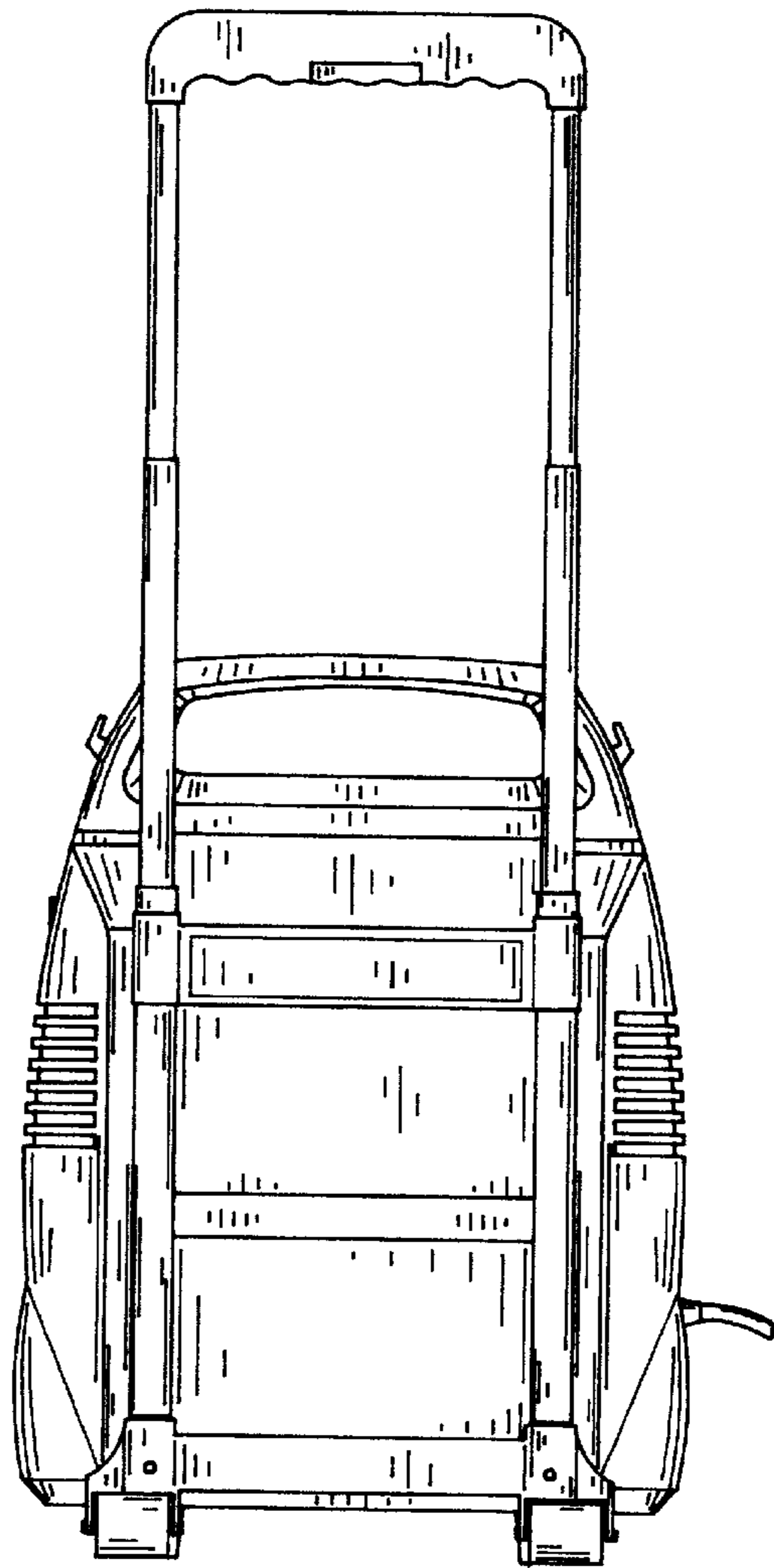

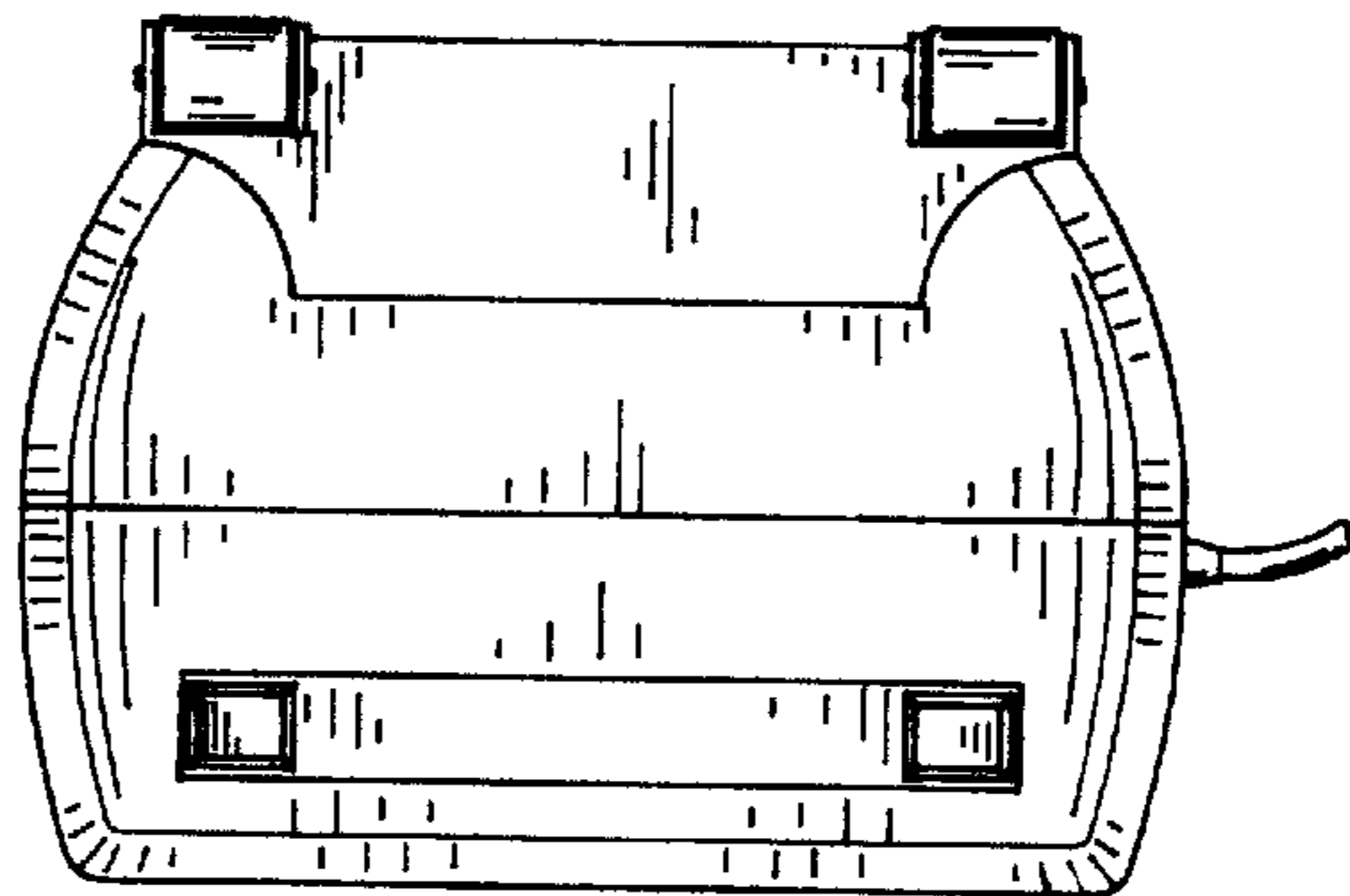
