(57) **CLAIM**

I claim the ornamental design for an air deodorizer, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of an air deodoriser comprising the present invention.

FIG. 2 is a front elevational view of the air deodoriser shown in FIG. 1.

FIG. 3 is a rear elevational view of the air deodoriser shown in FIG. 1 and FIG. 2.

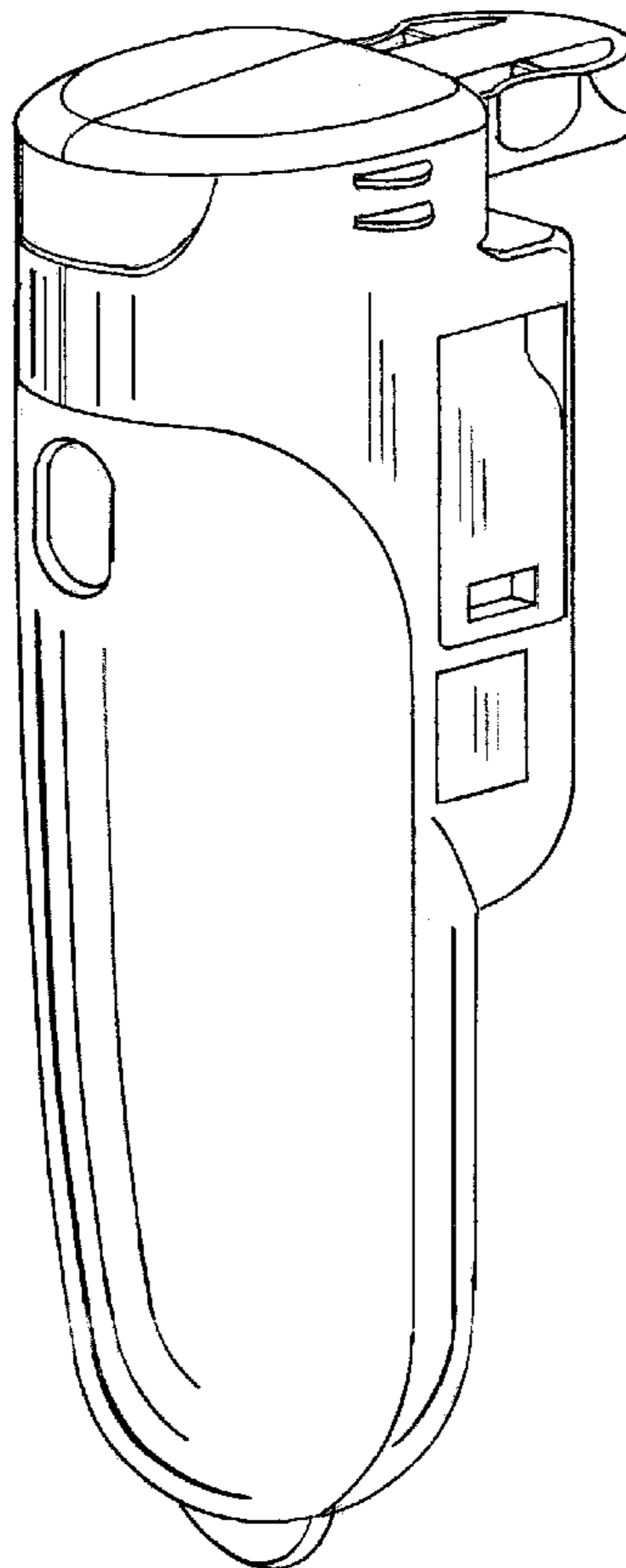
FIG. 4 is a side elevational view of the air deodoriser shown in FIG. 1, FIG. 2, and FIG. 3.

FIG. 5 is another side elevational view of the air deodoriser shown in FIG. 1, FIG. 2, FIG. 3, and FIG. 4.

FIG. 7 is a bottom elevational view of the air deodoriser shown in FIG. 1, FIG. 2, FIG. 3, FIG. 4, FIG. 5, and FIG. 6.

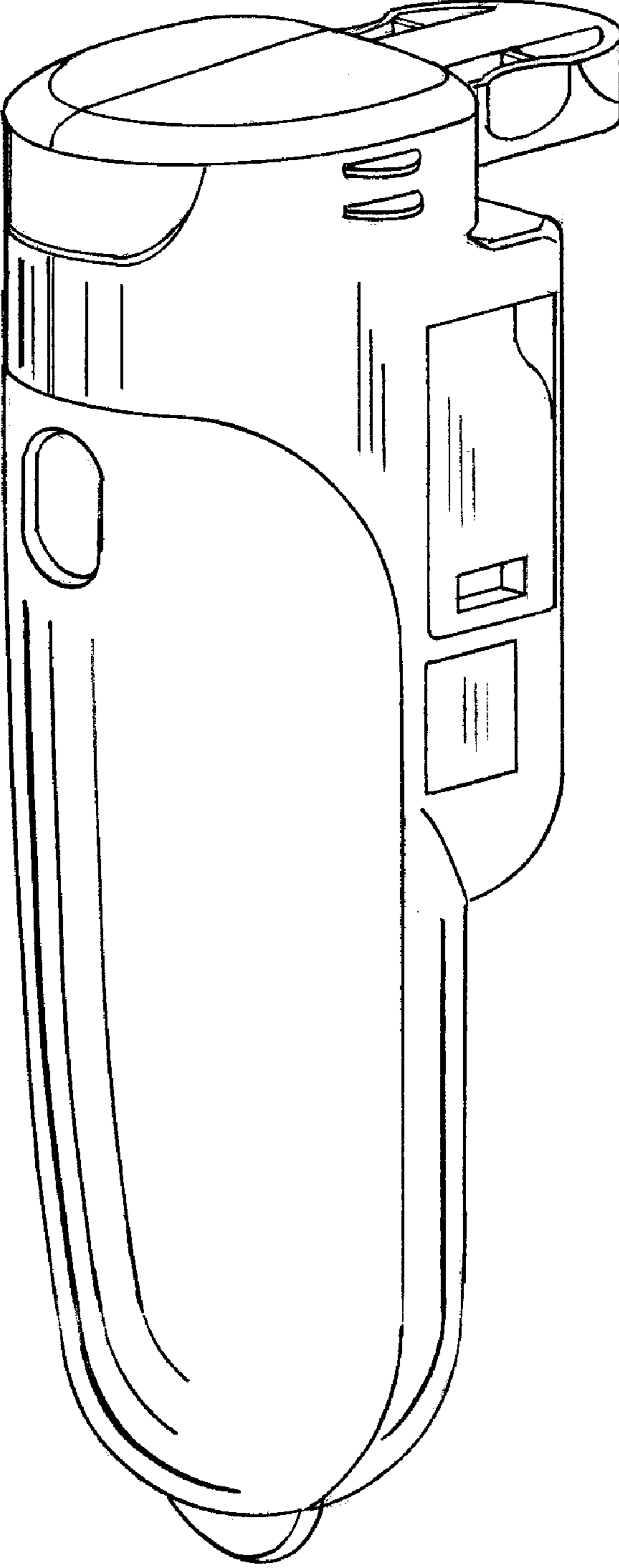

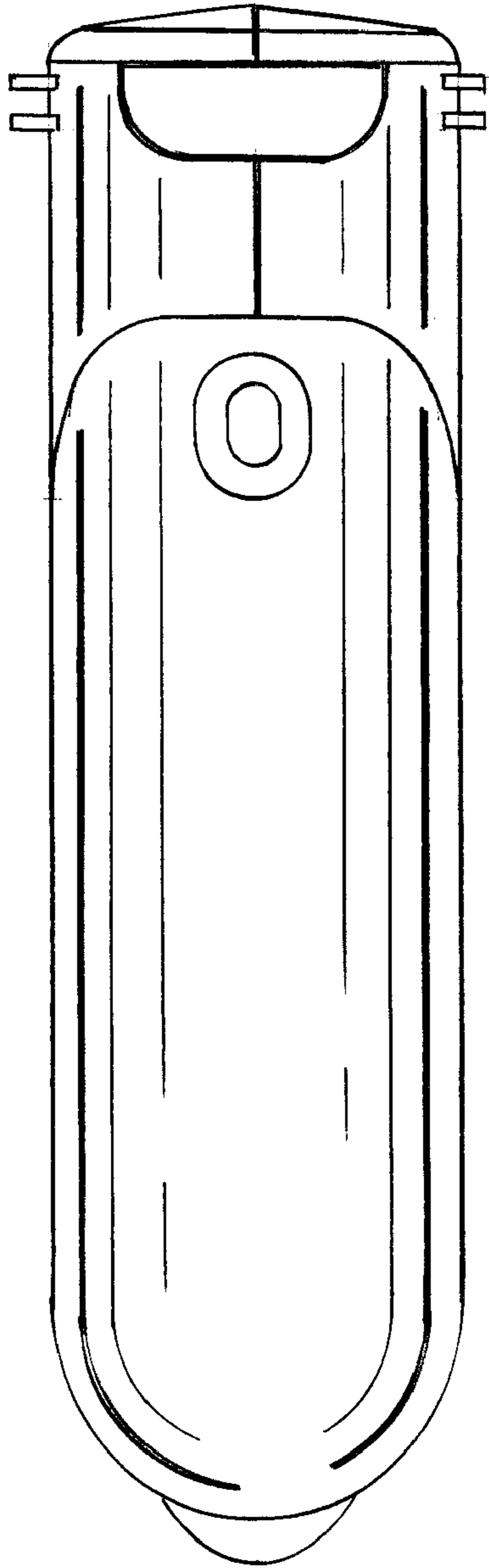

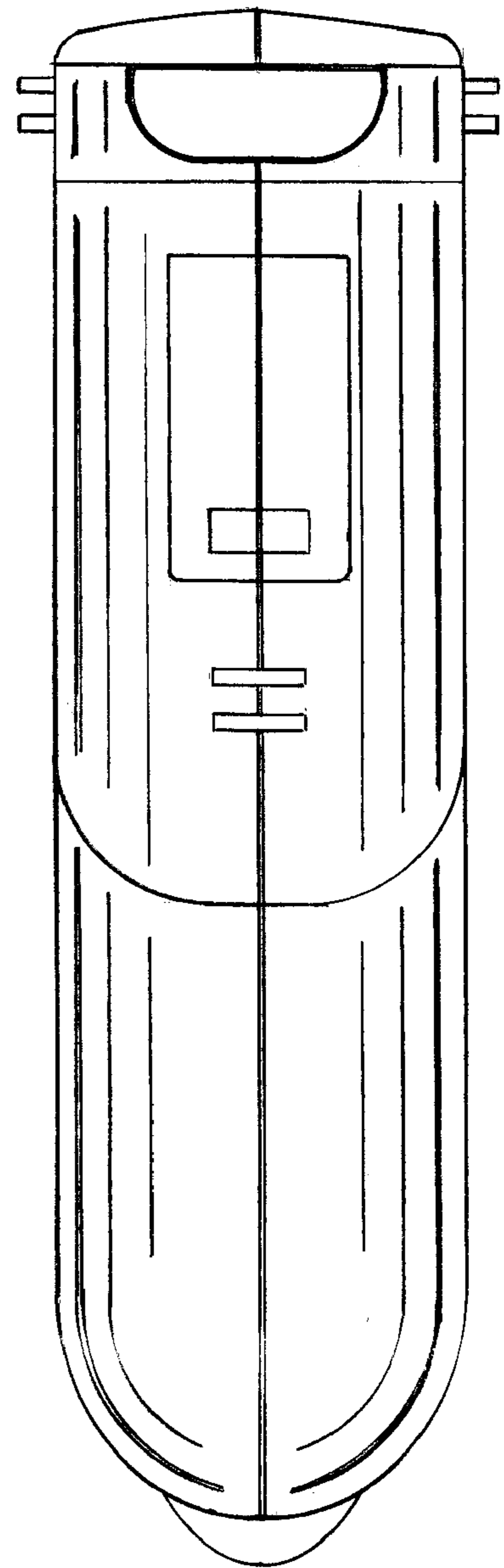

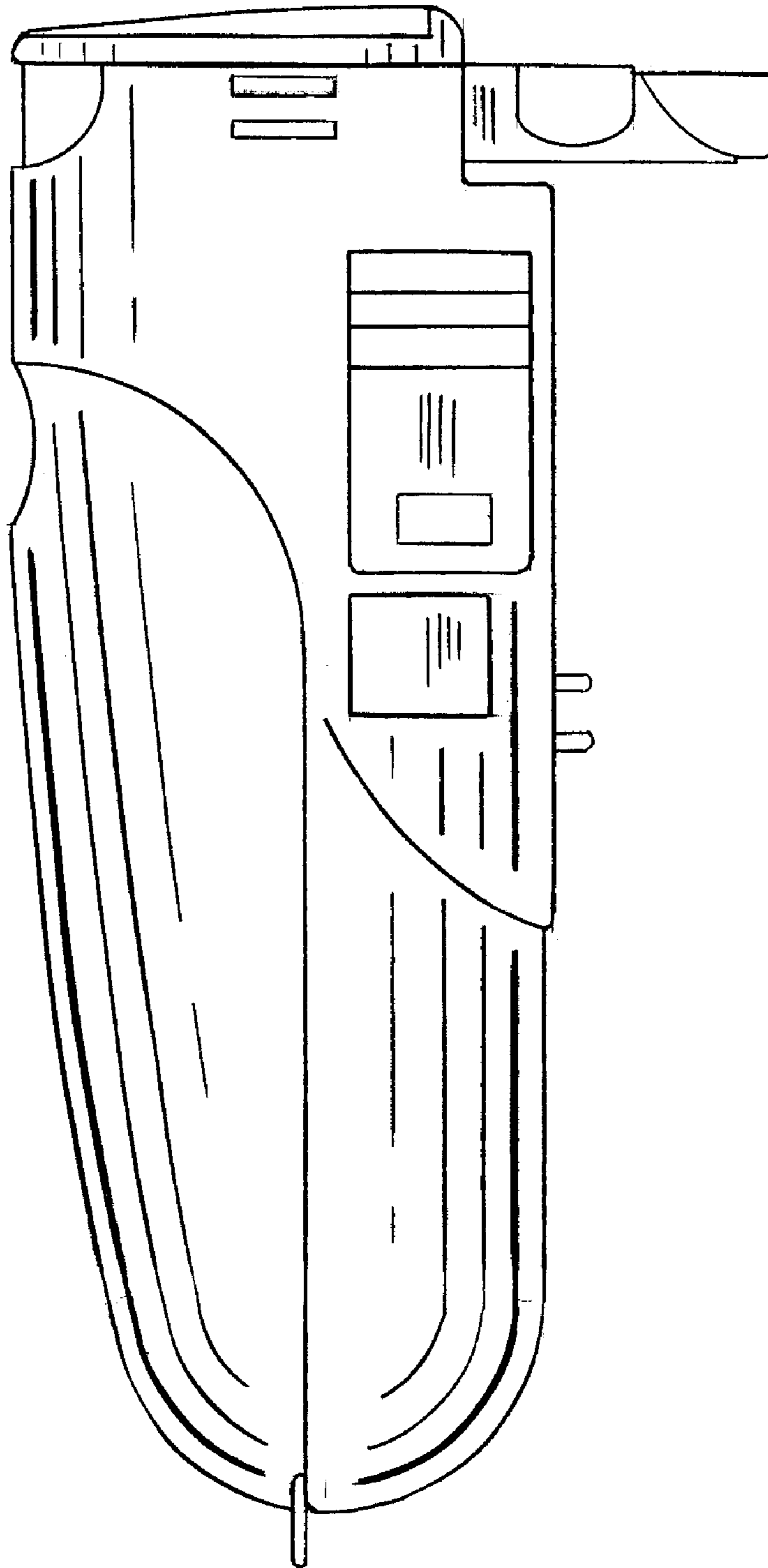

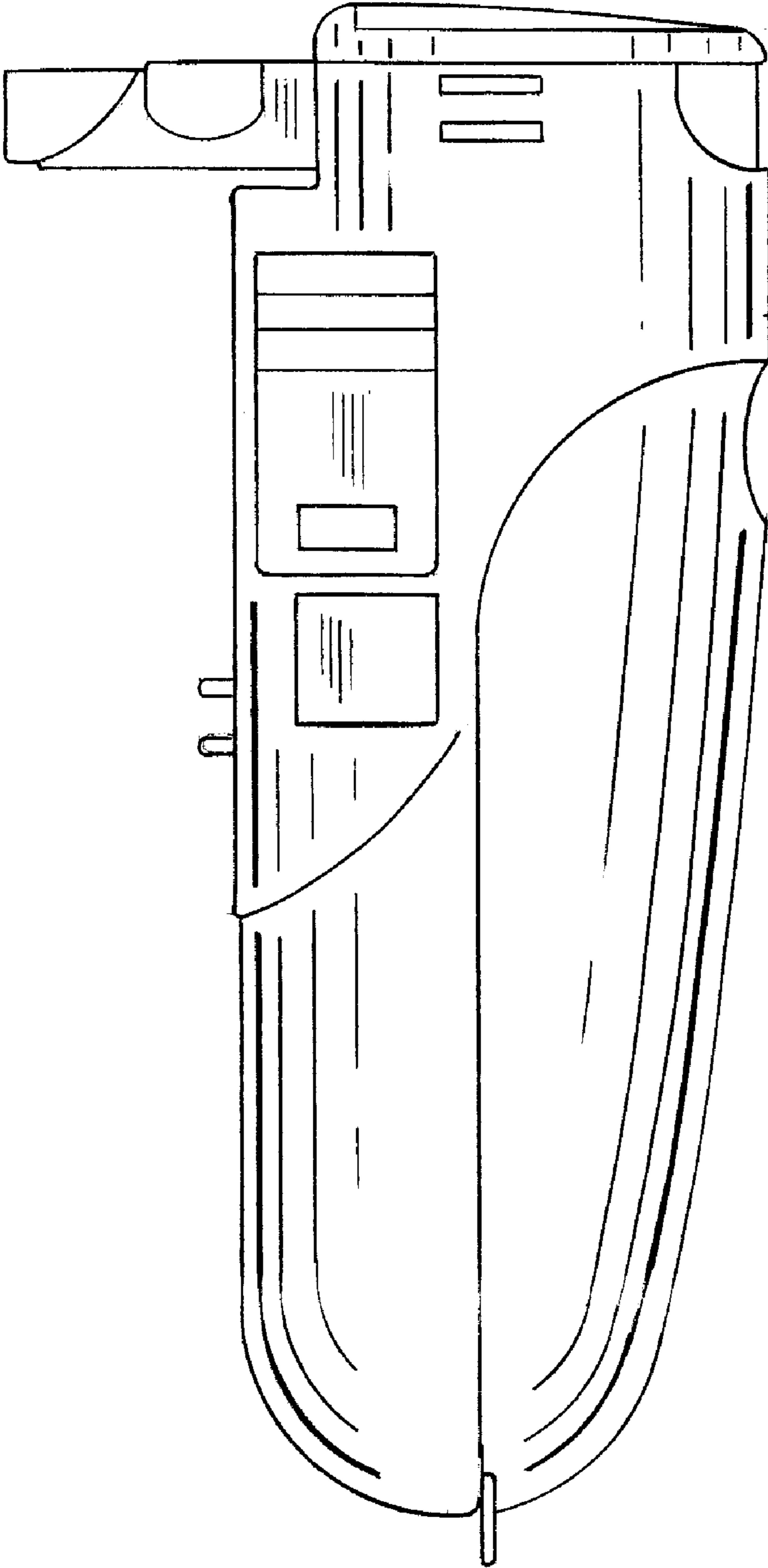

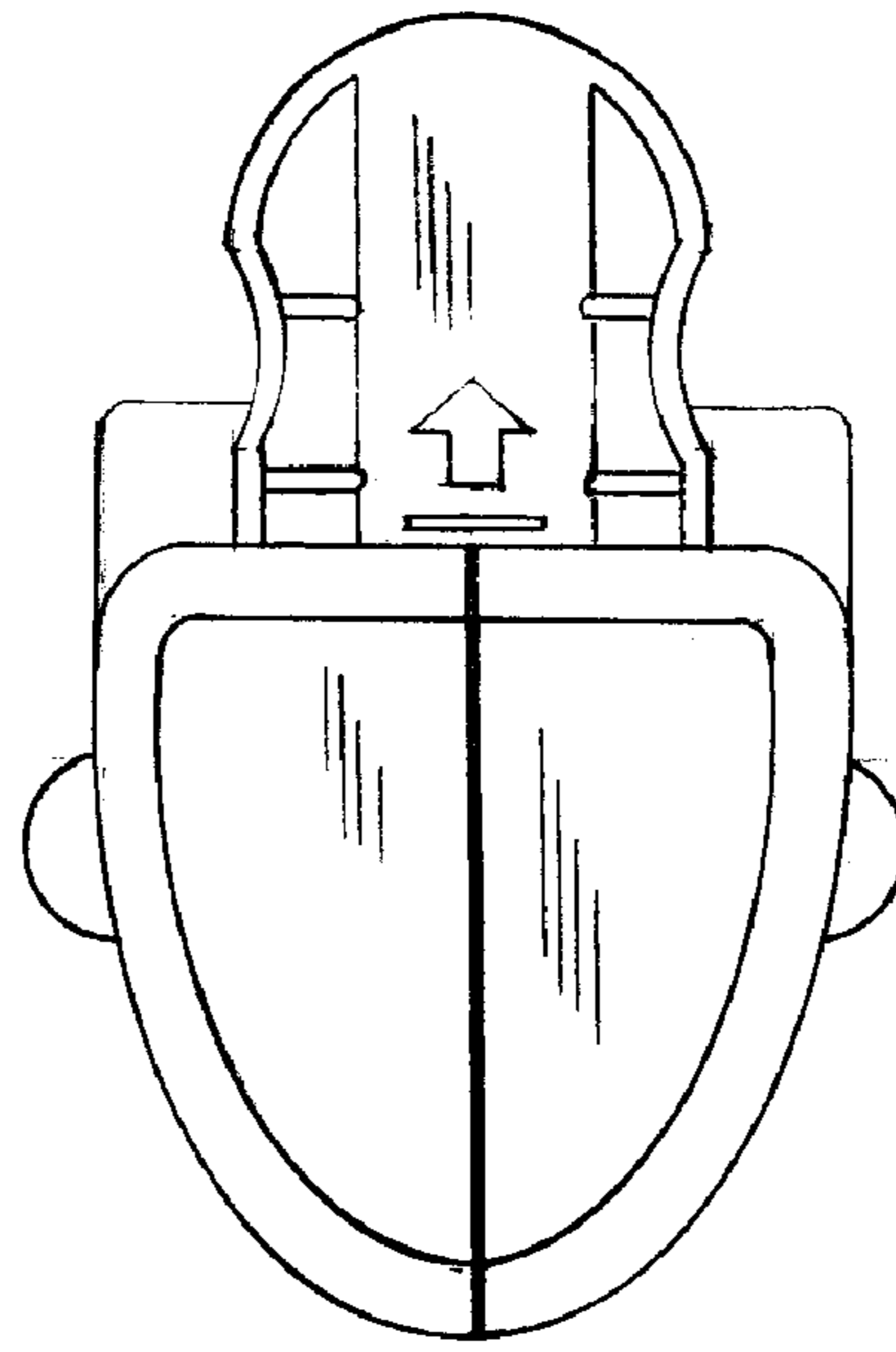

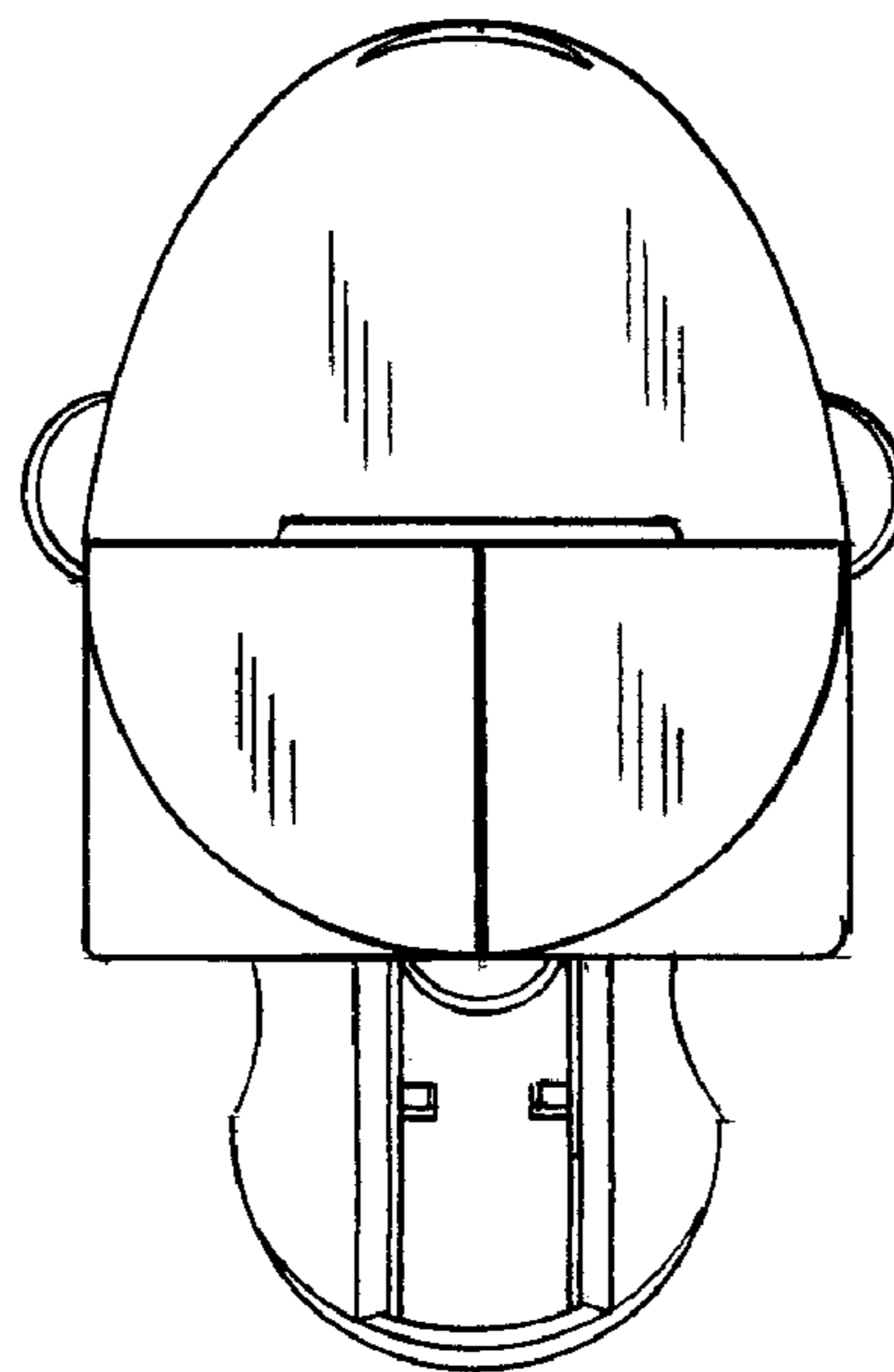

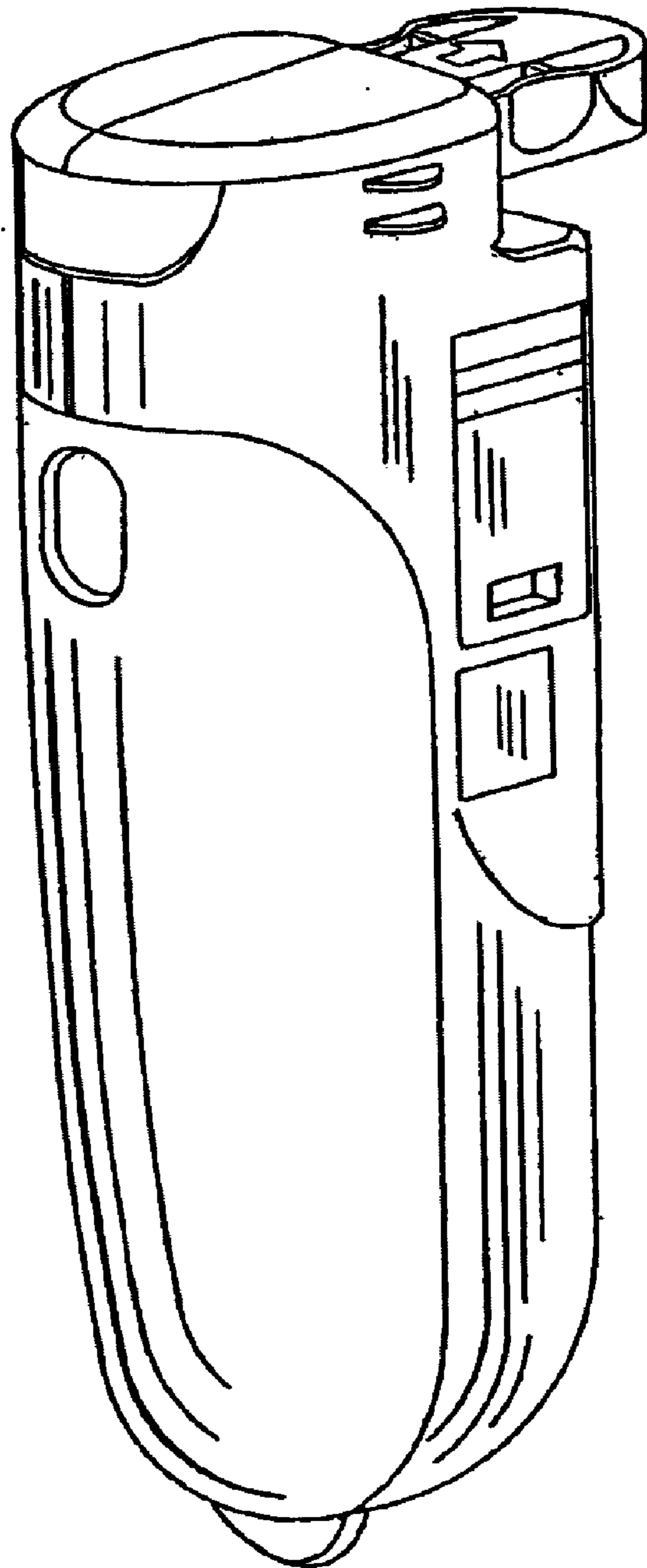
