(57) **CLAIM**

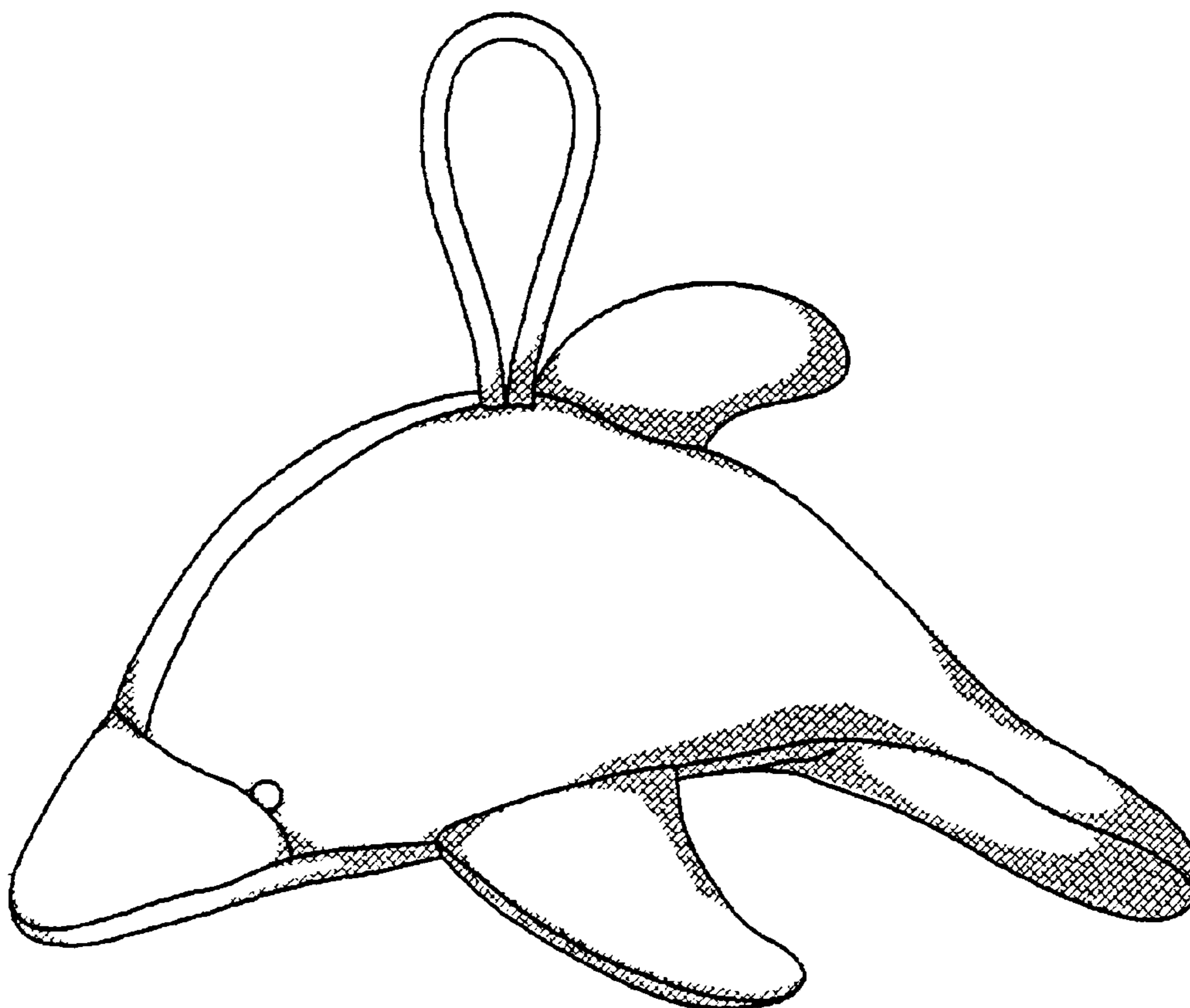
The ornamental design for a dolphin-form air freshener device, as shown.

DESCRIPTION

FIG. 1 is perspective view of a dolphin-form air freshener device embodying the present invention;
FIG. 2 is a front view of the air freshener device;
FIG. 3 is a rear view of the air freshener device;
FIG. 4 is a left side view of the air freshener device;
FIG. 5 is a right side view of the air freshener device;
FIG. 6 is a top plan view of the air freshener device; and,
FIG. 7 is a bottom view of the air freshener device.

The crisscross pattern of lines in the drawings represent material and is understood to be distributed uniformly throughout the implied area.

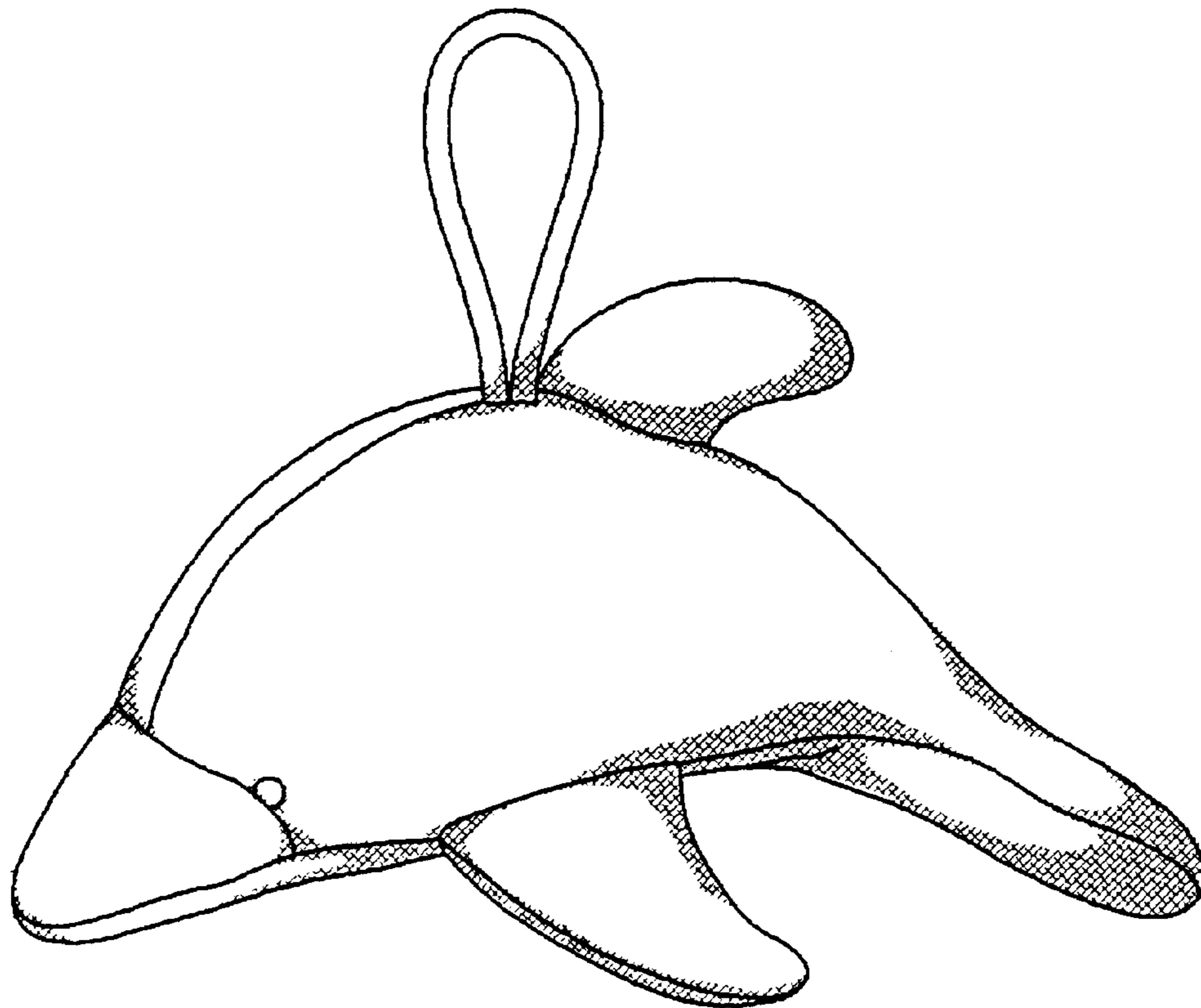

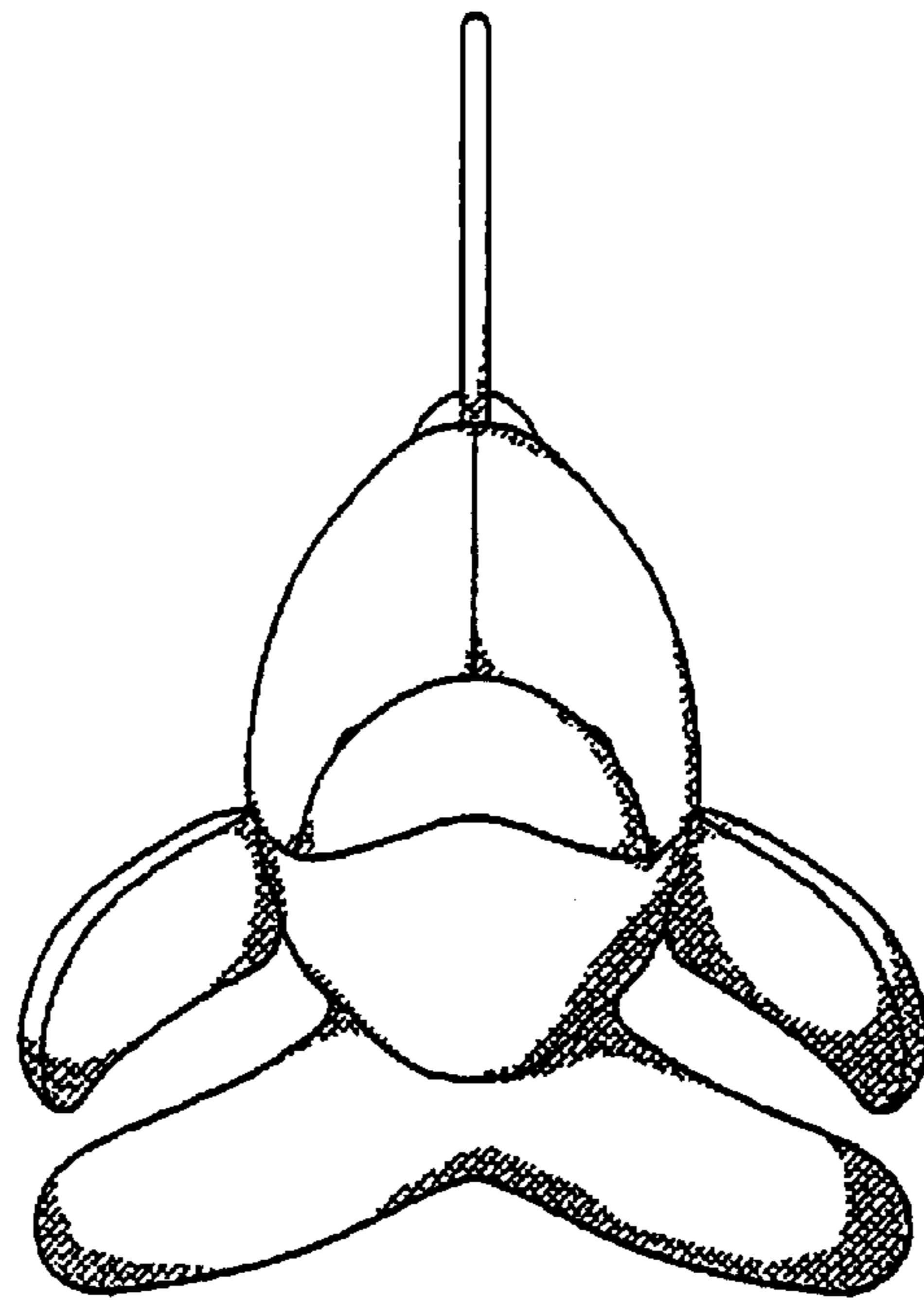

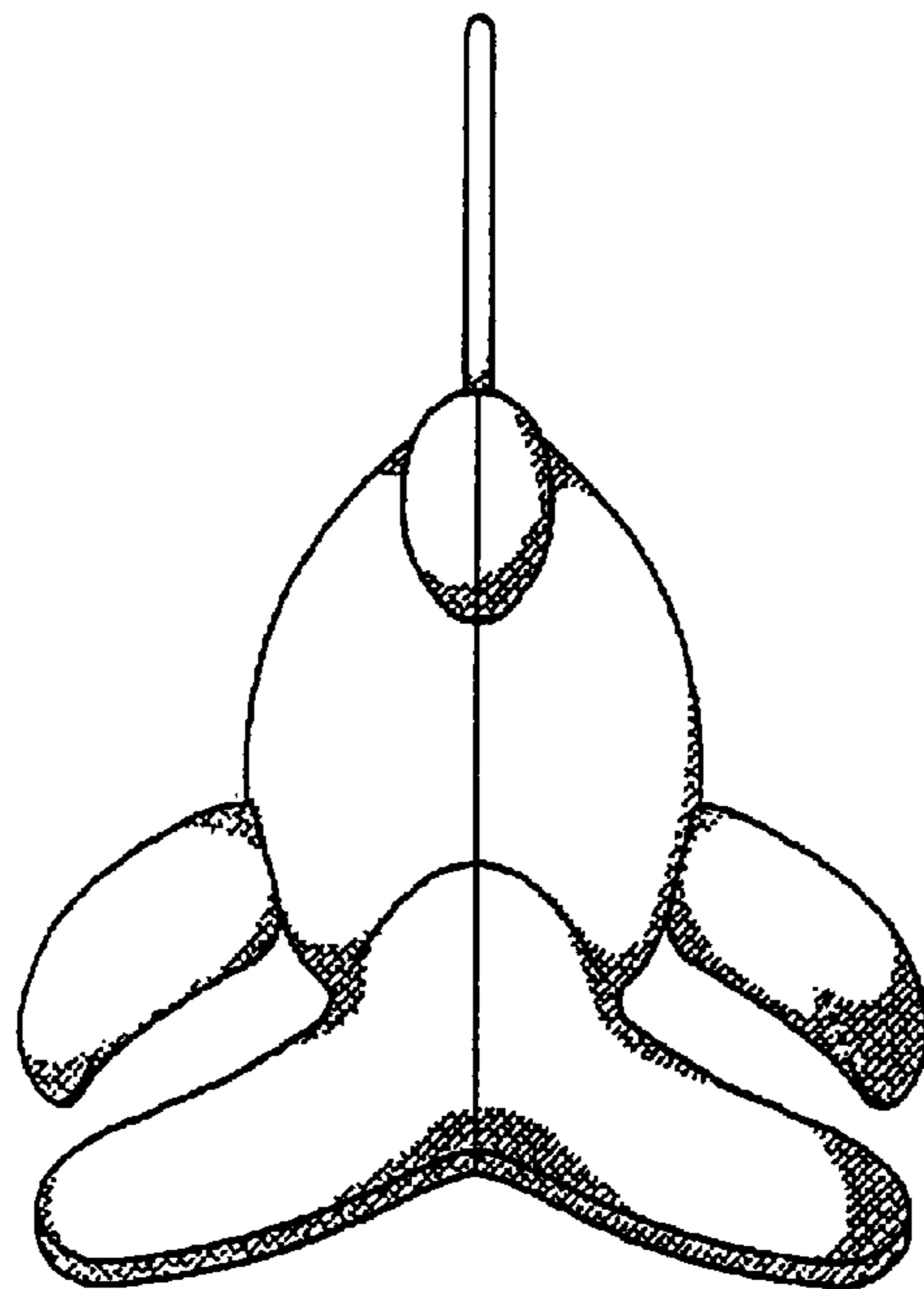

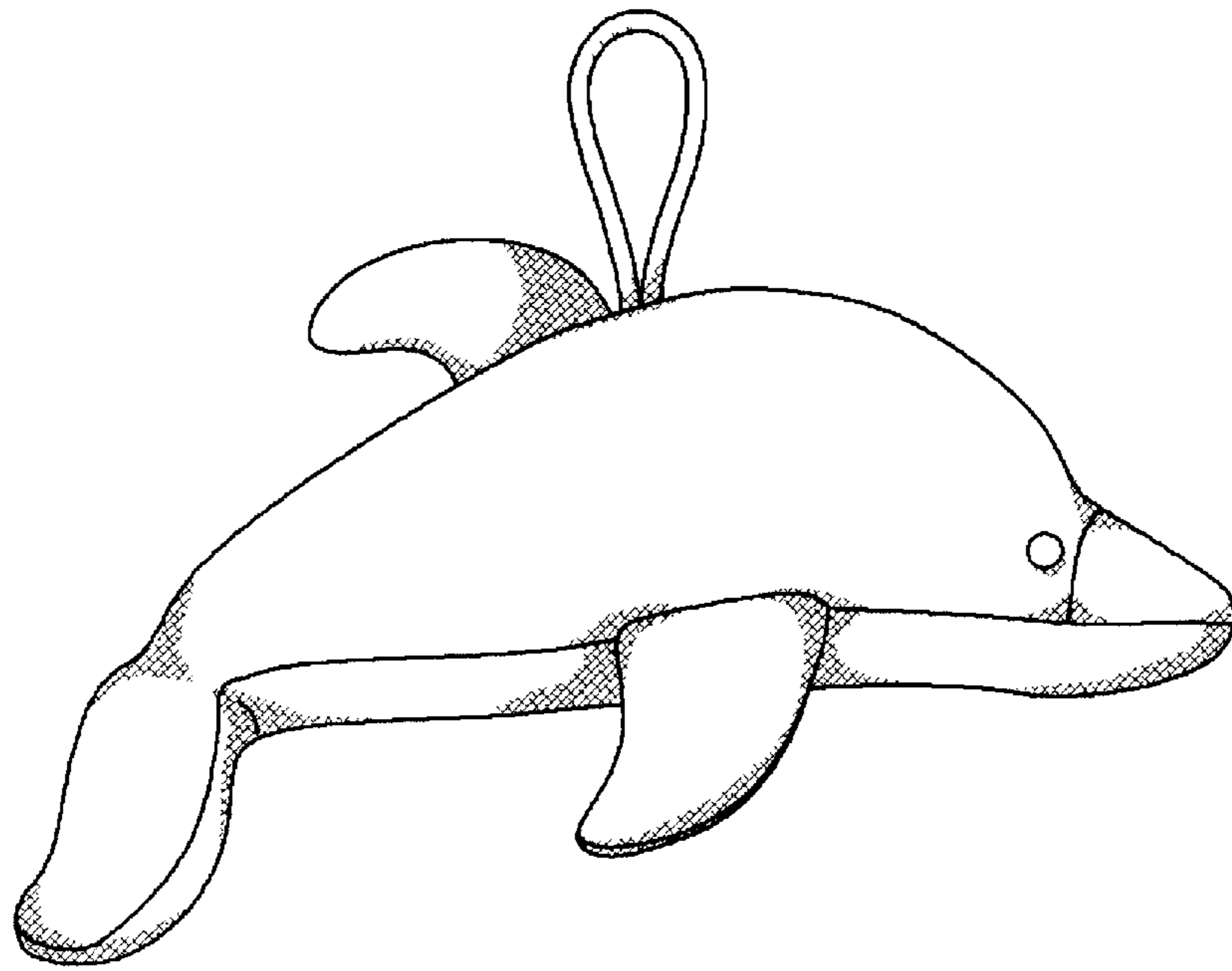

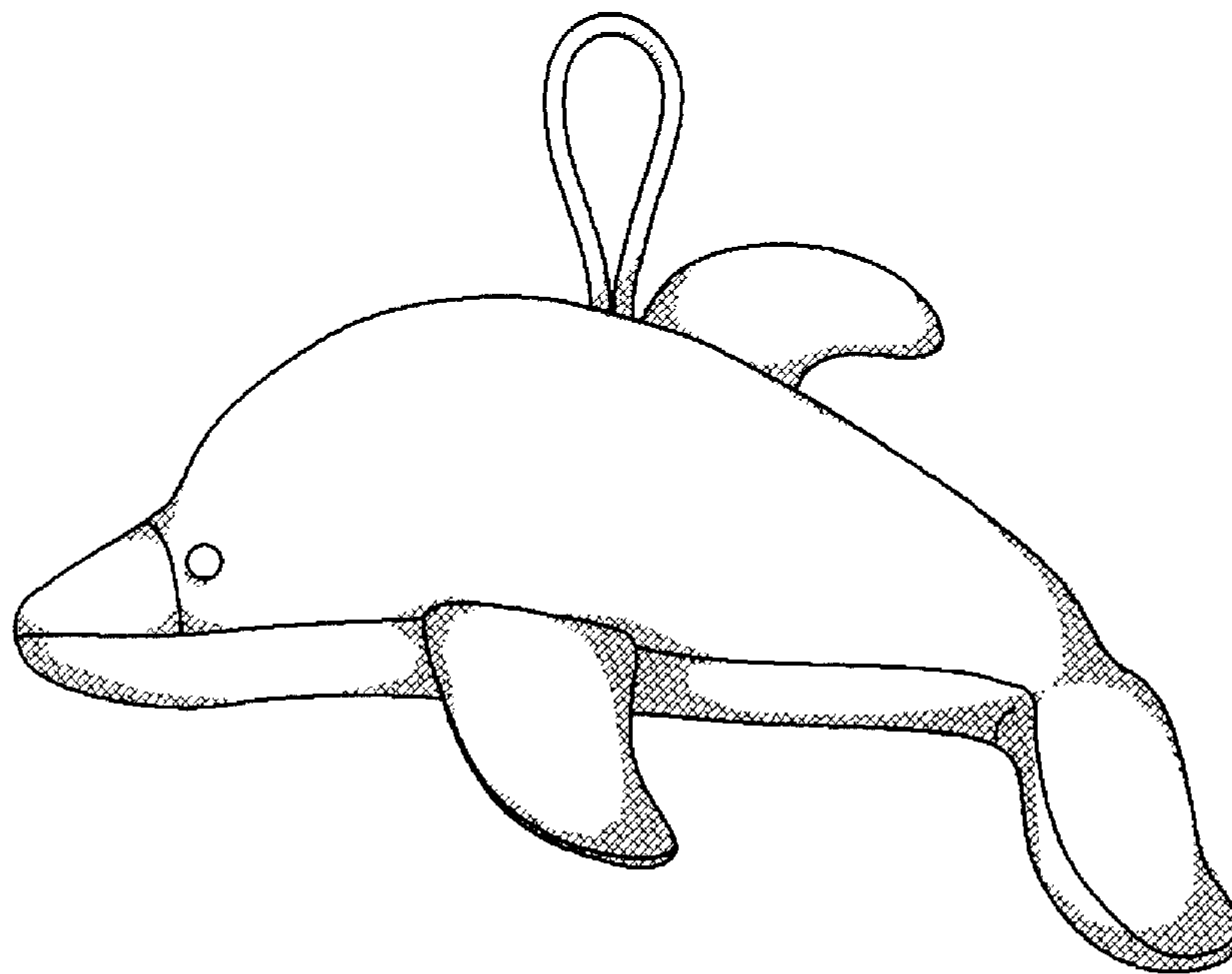

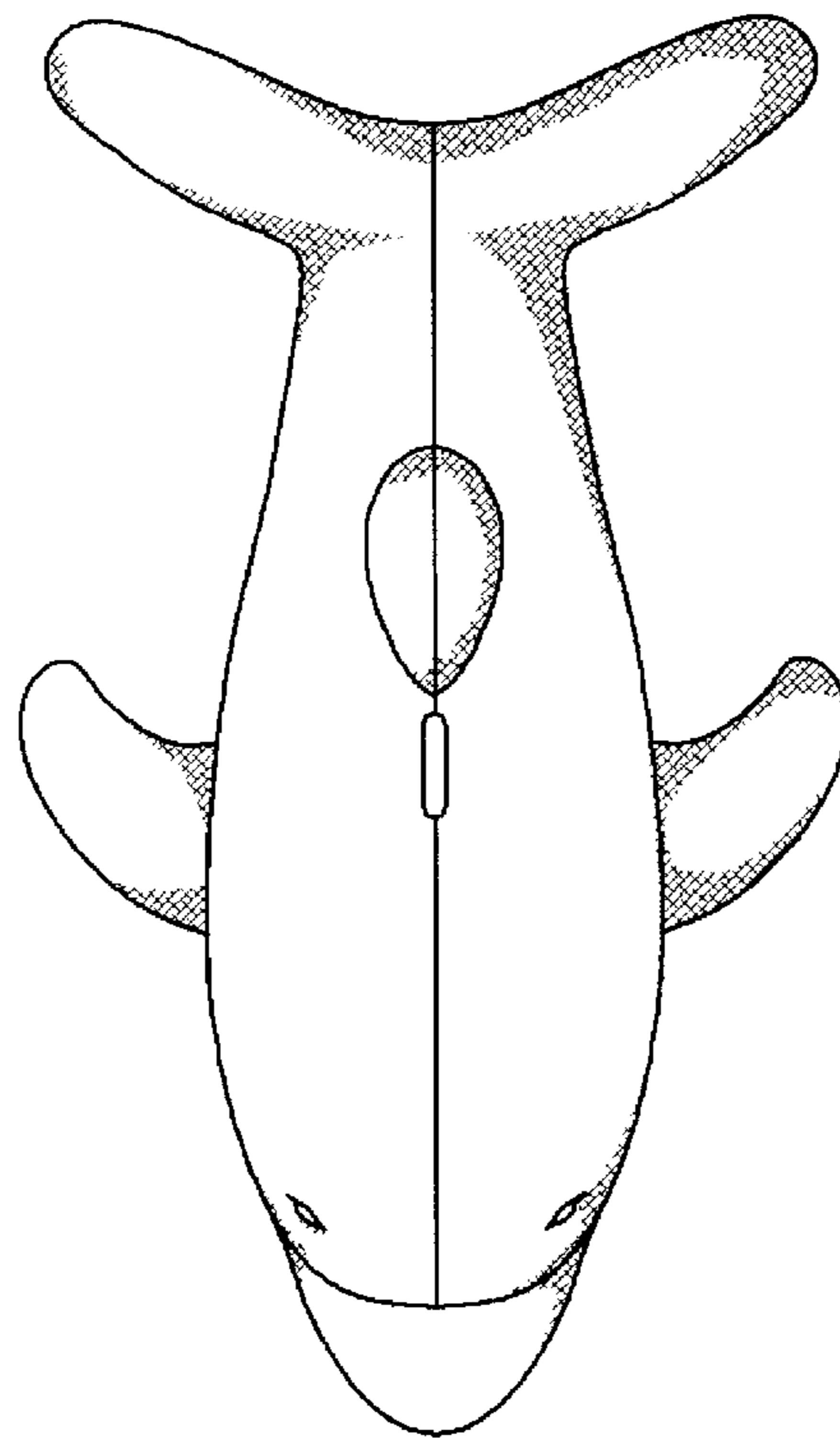

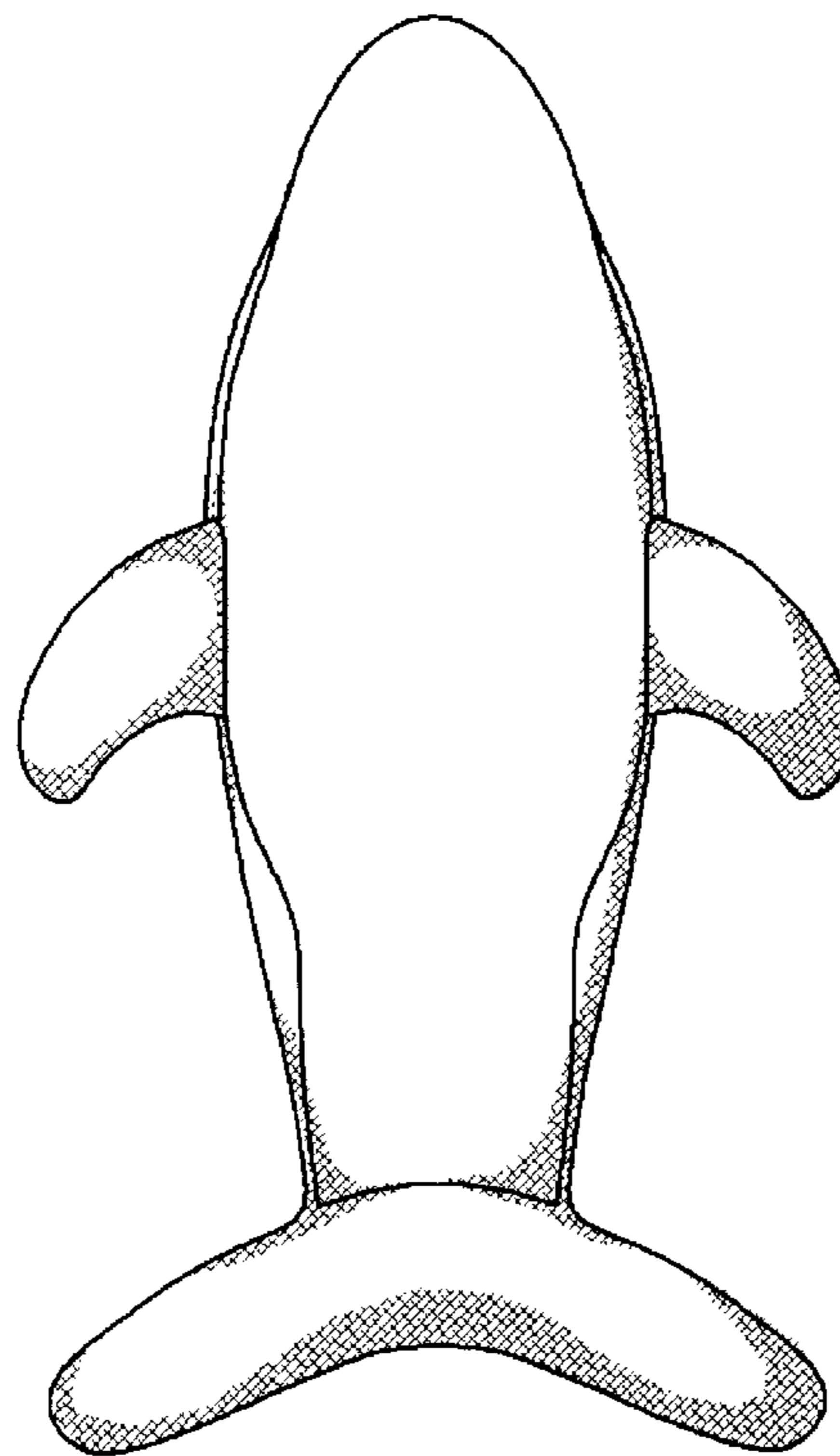
