(57) **CLAIM**

The ornamental design for a surface configuration of a headlight for a vehicle, as shown and described.

**DESCRIPTION**

This application is related to the following co-pending application, of the inventors, filed on even date herewith: Application Ser. No. 29/199,263, entitled “Surface Configuration of a Vehicle, Toy and/or Other Replicas”.

FIG. 3 is a perspective view of the first embodiment of the surface configuration of a headlight for a vehicle according to our novel design;

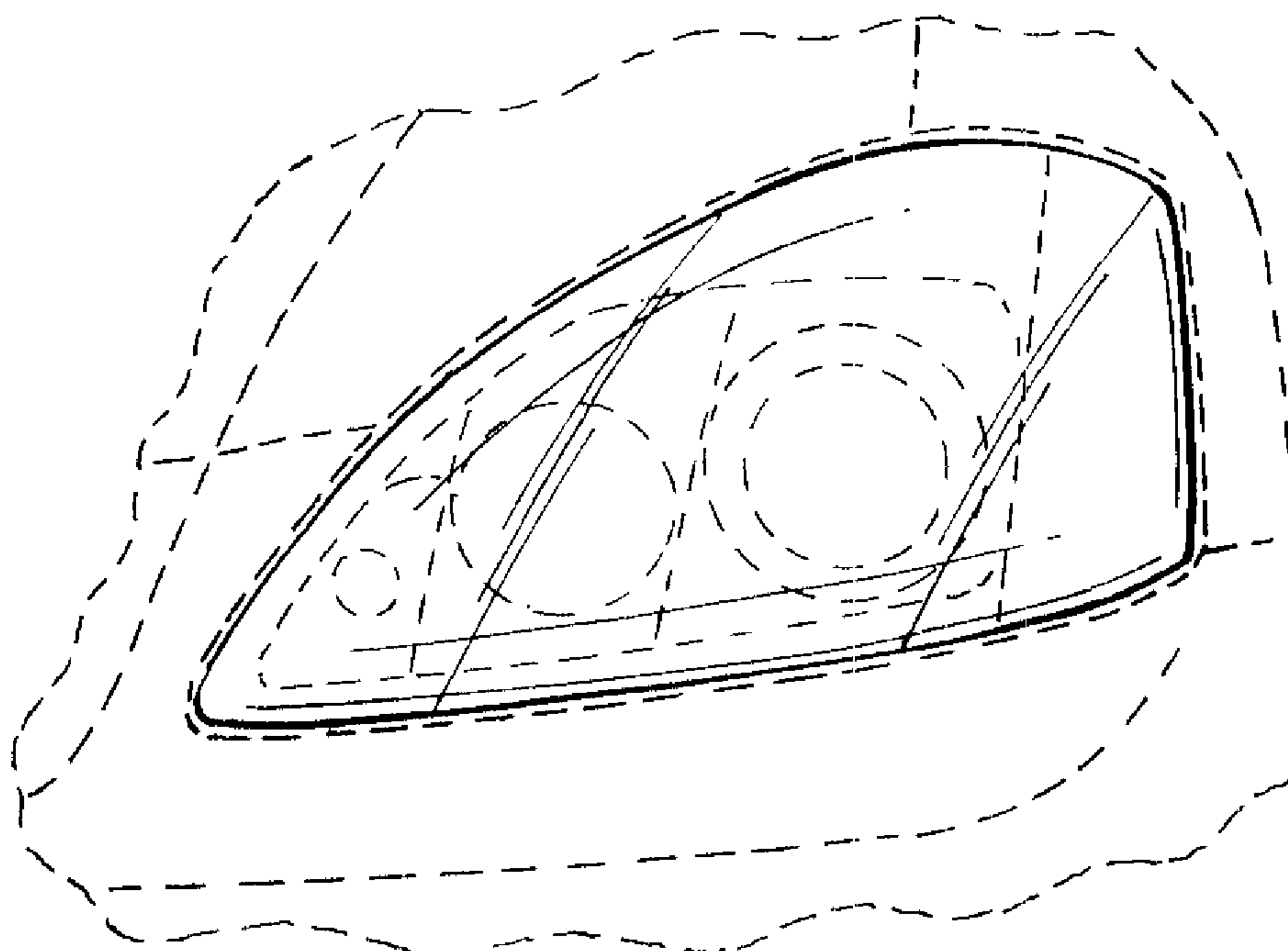
FIG. 4 is a front view of a second embodiment of the surface configuration of a headlight for a vehicle according to our novel design;

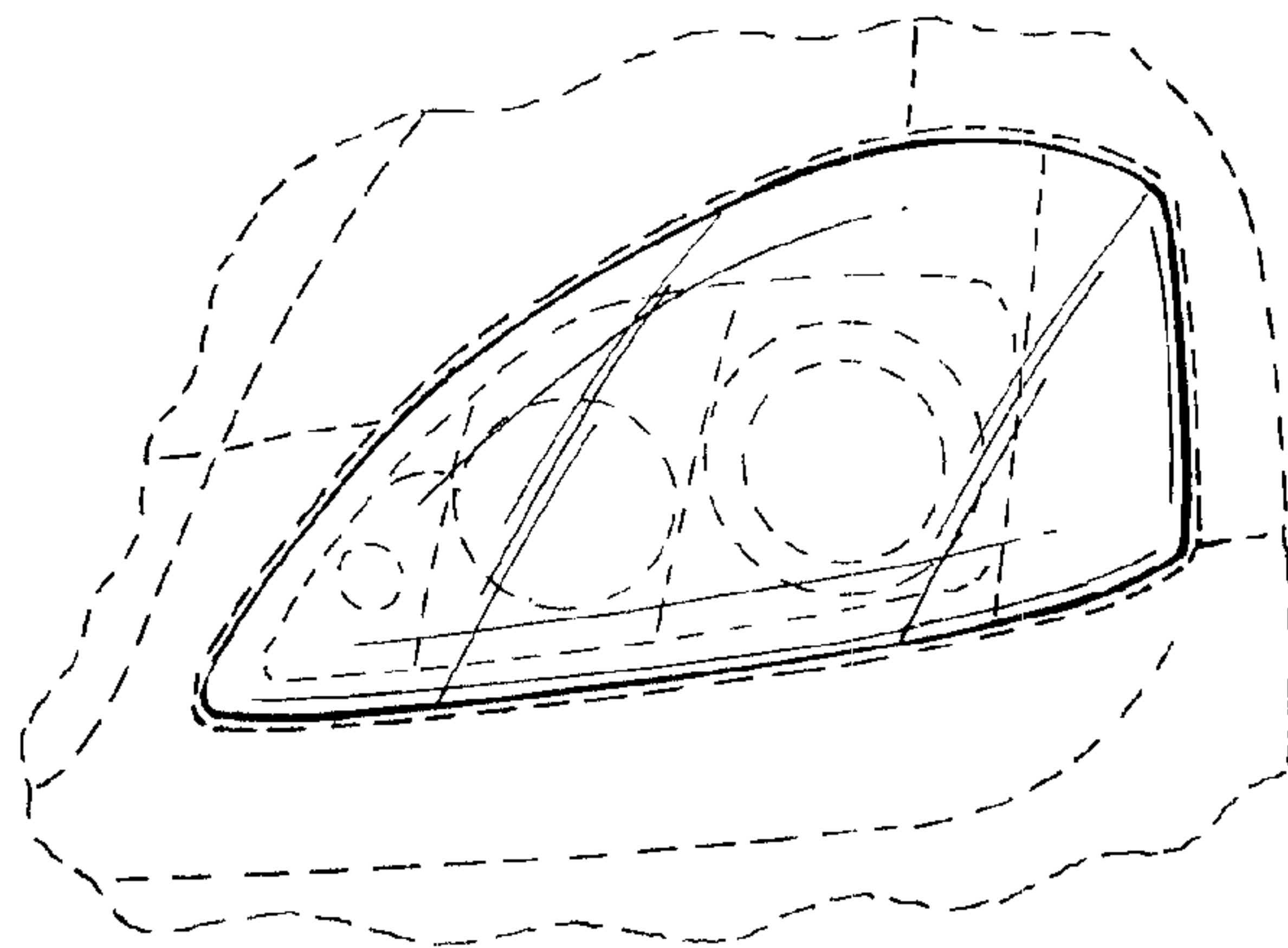

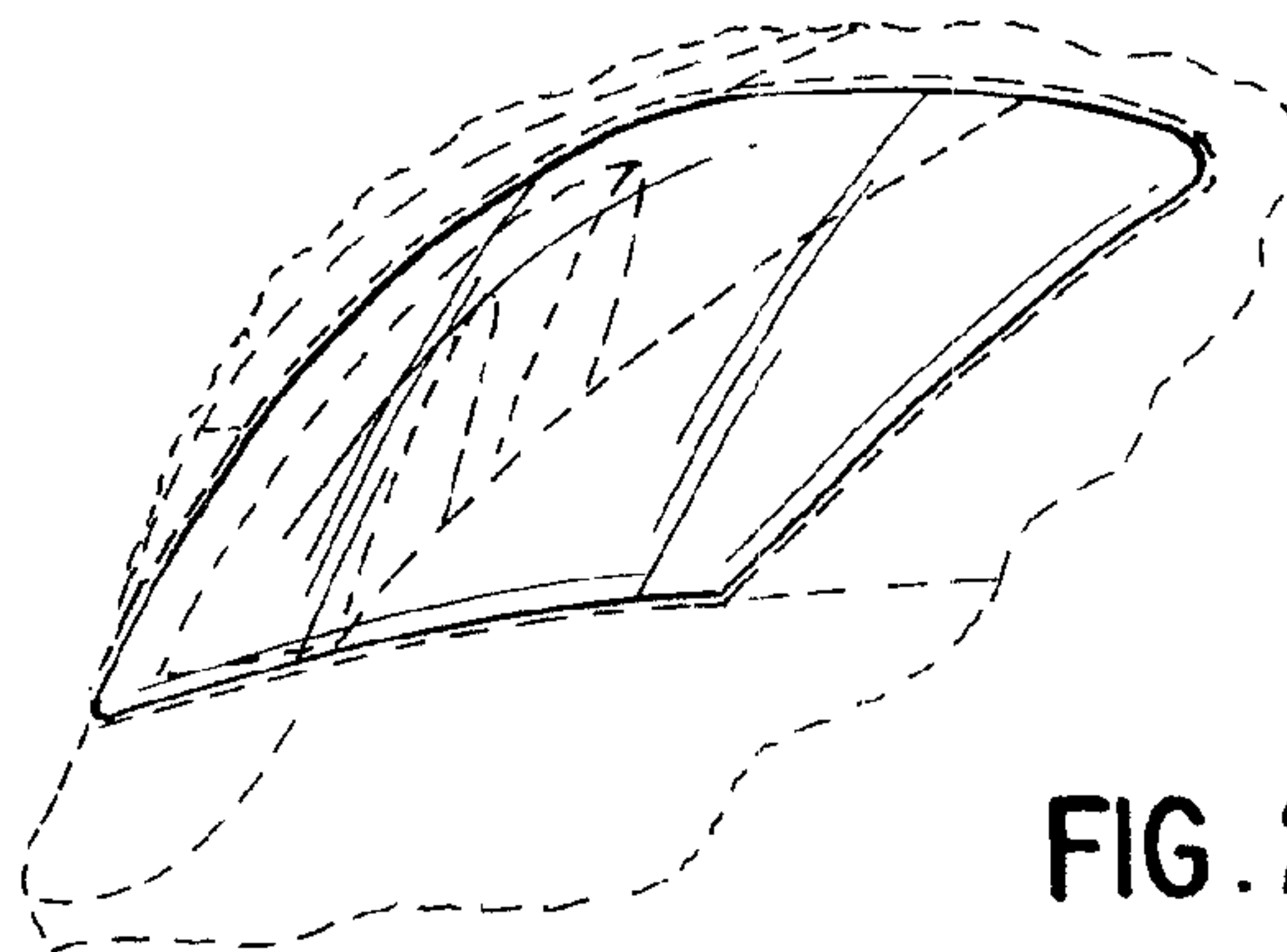

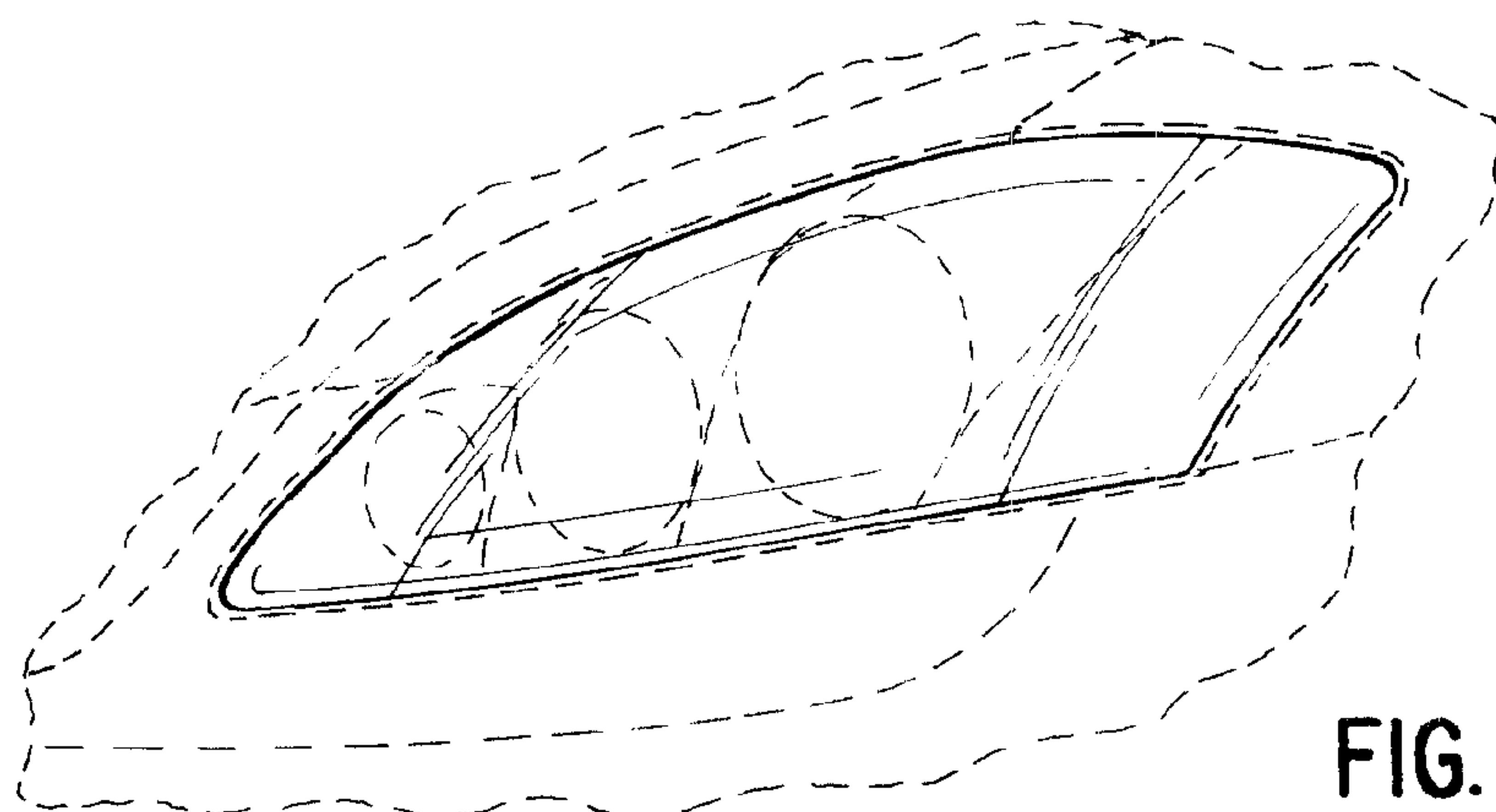

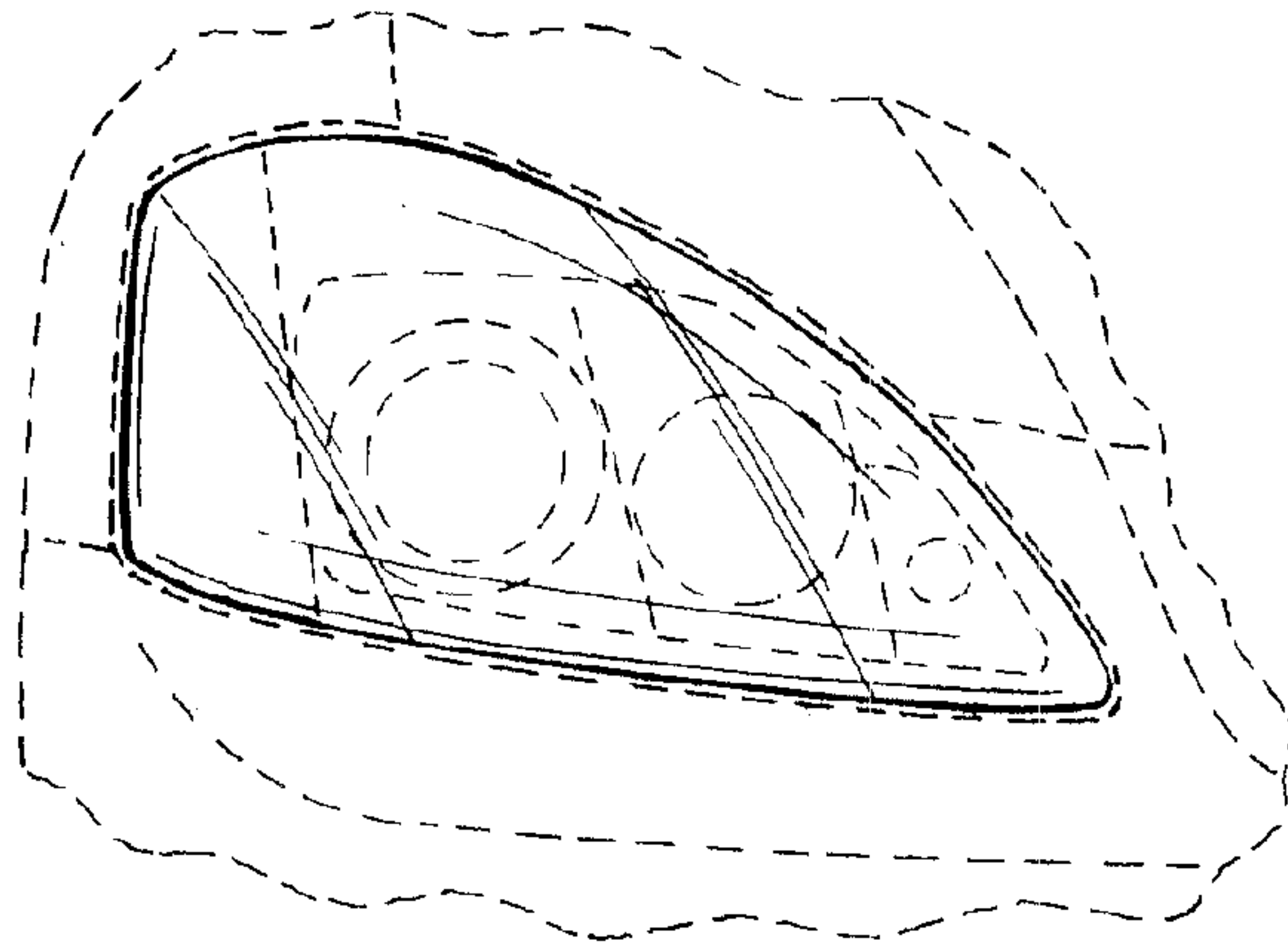

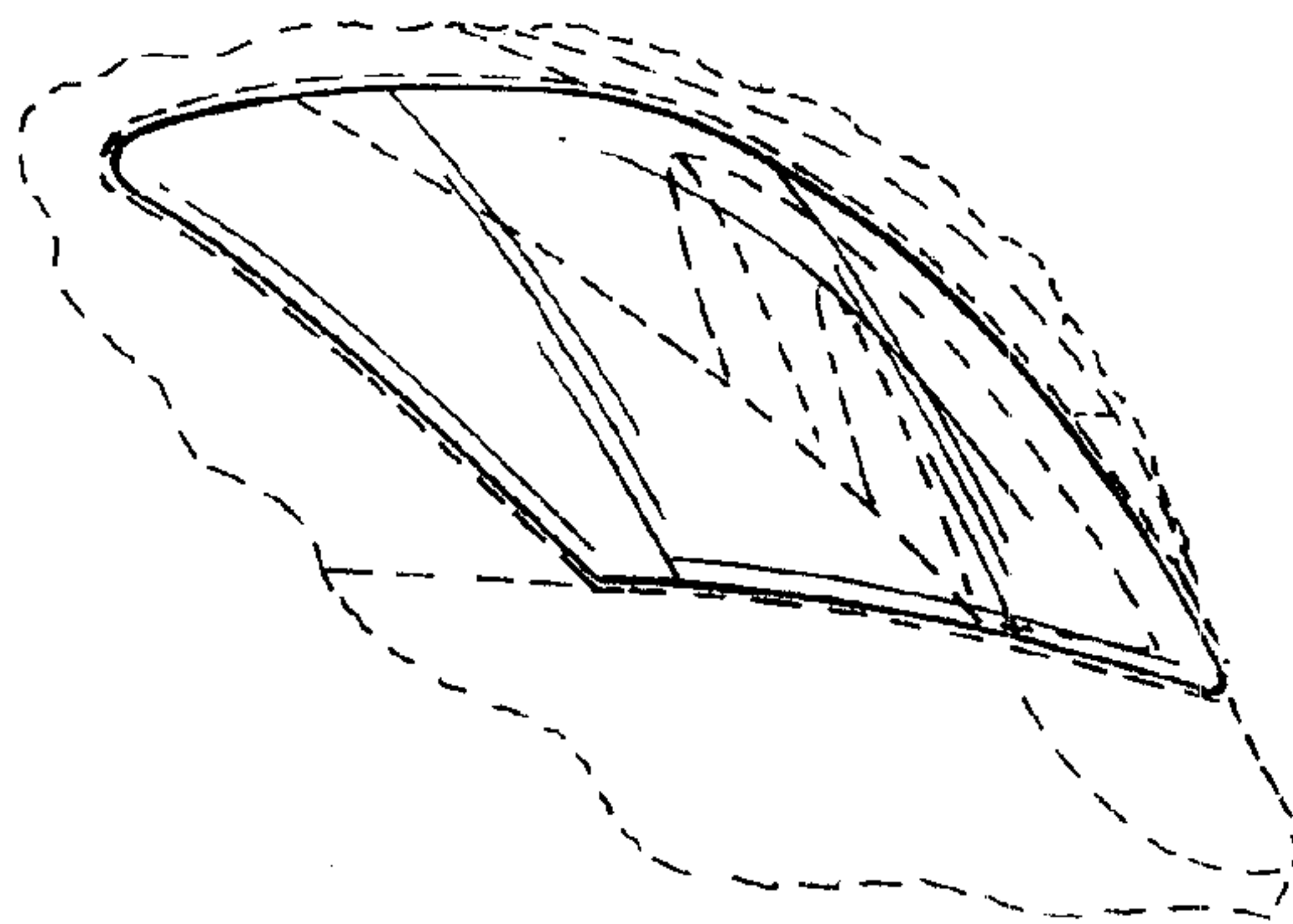

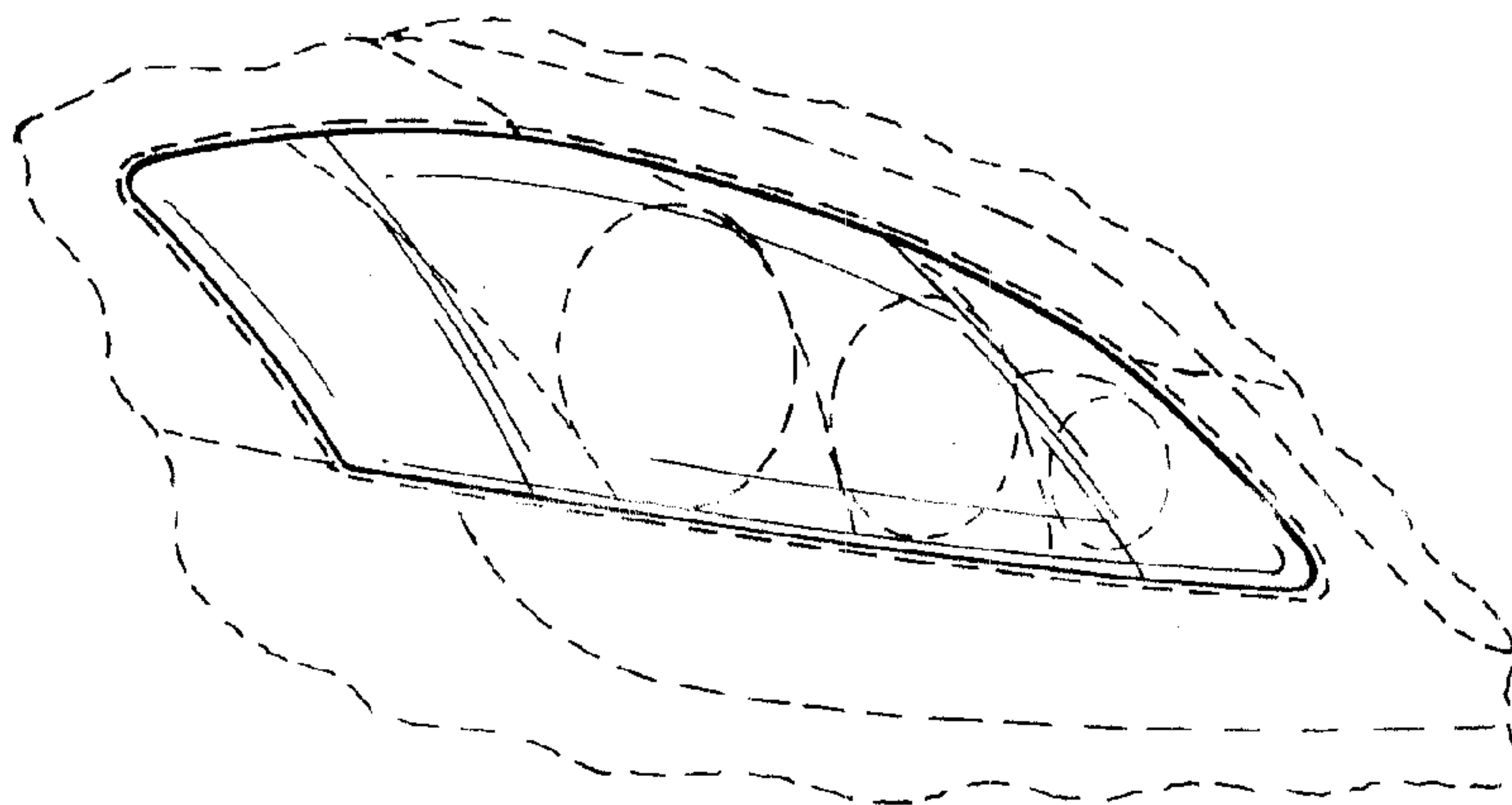
