(57) **CLAIM**

The ornamental design for a crown for a cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a crown for a cap showing my new design;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a right side elevational view FIG. 1 : the left side is a mirror image; and,

FIG. 4 is a top plan view of FIG. 1.

The broken line showing of the visor is for illustrative purpose only and forms no part of the claimed design, and the broken lines on the crown represent stitching.

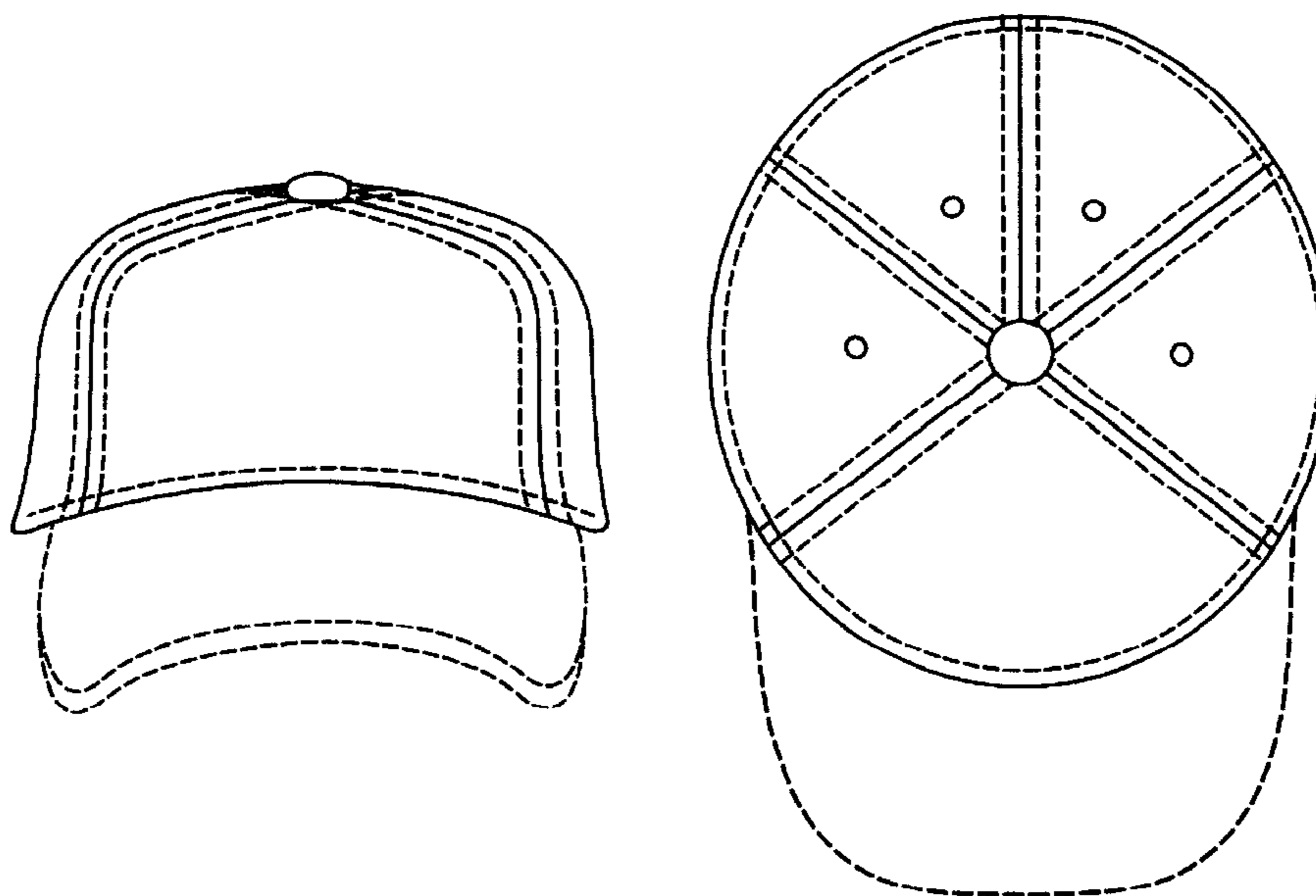

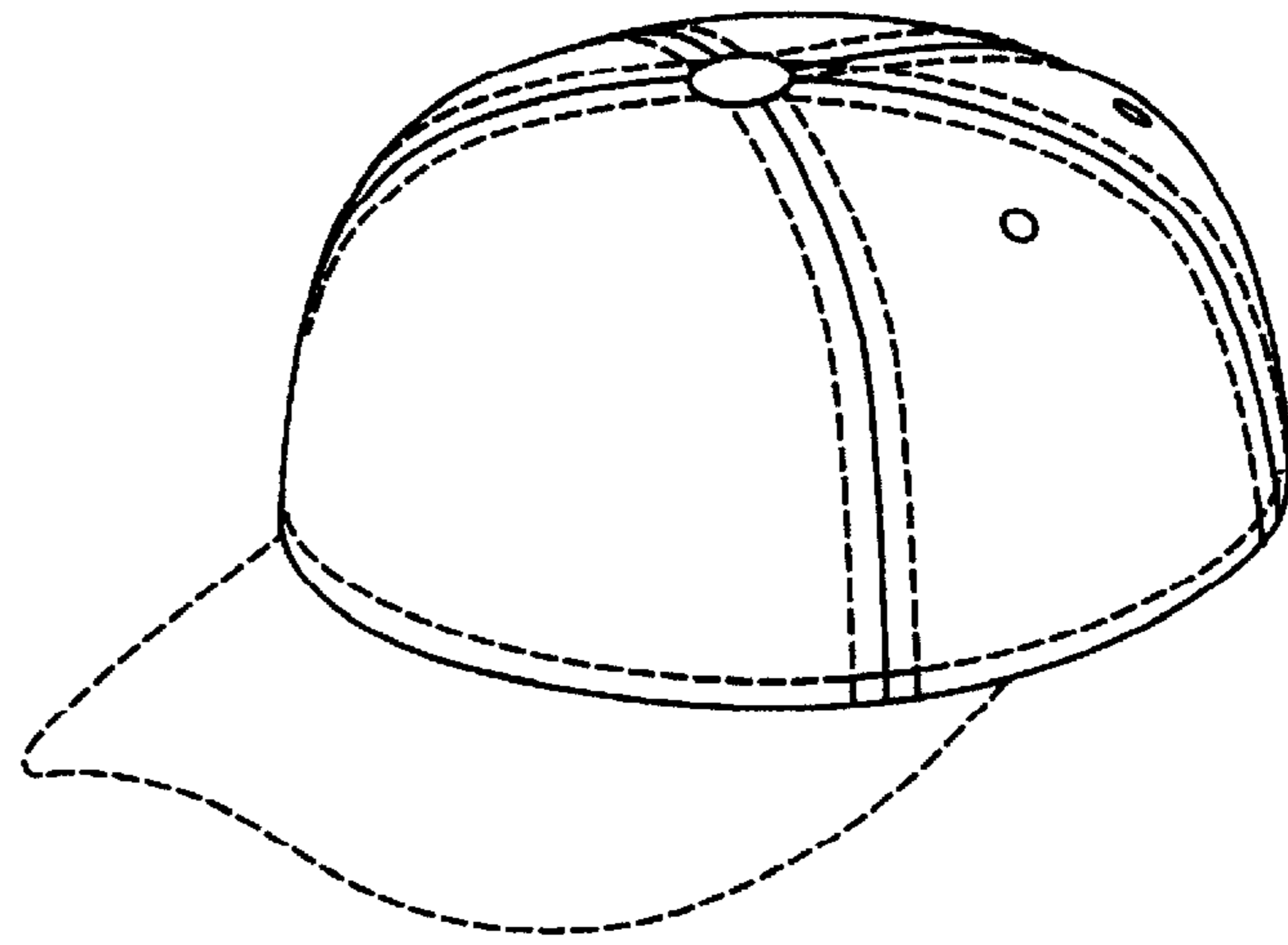

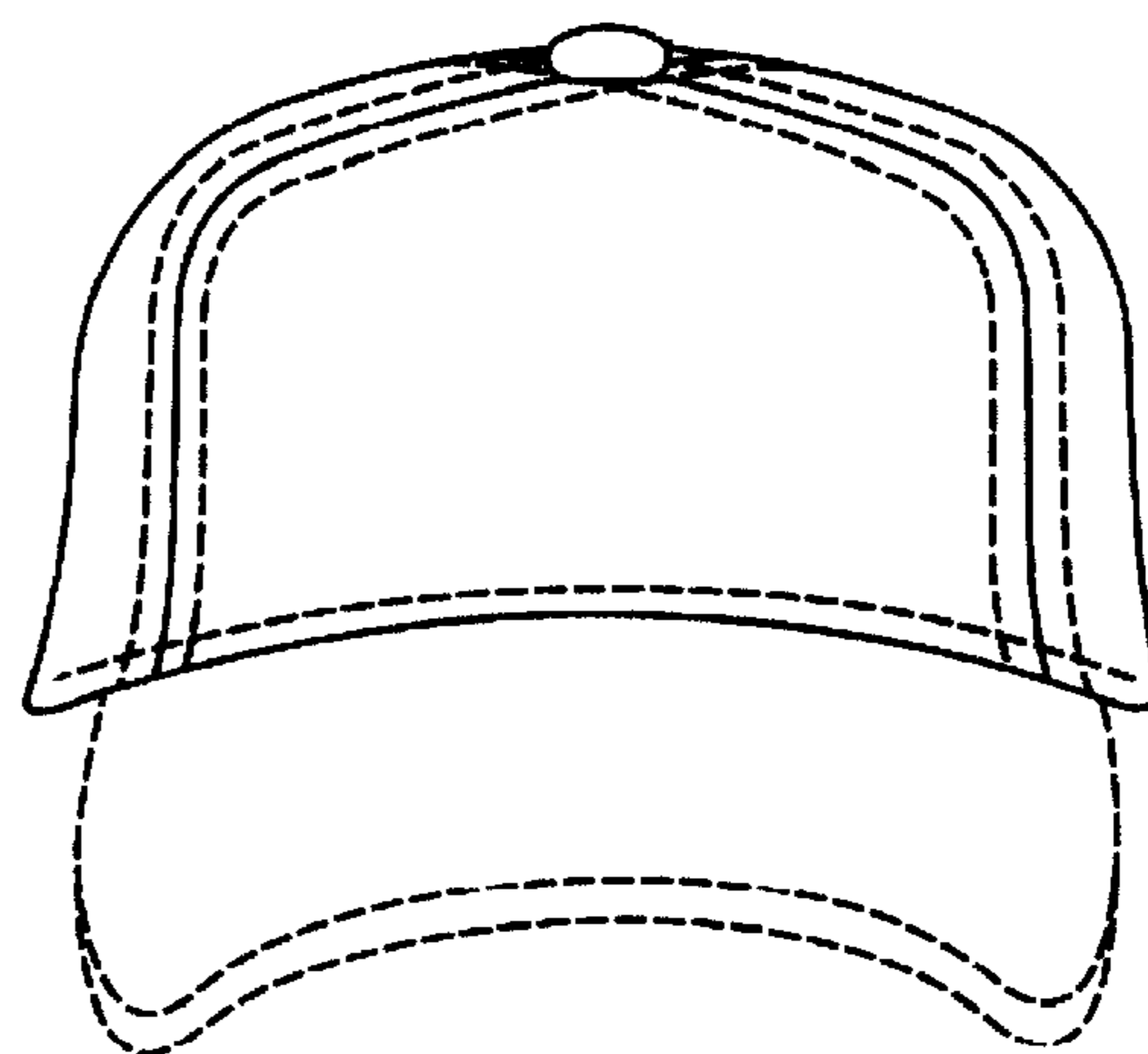

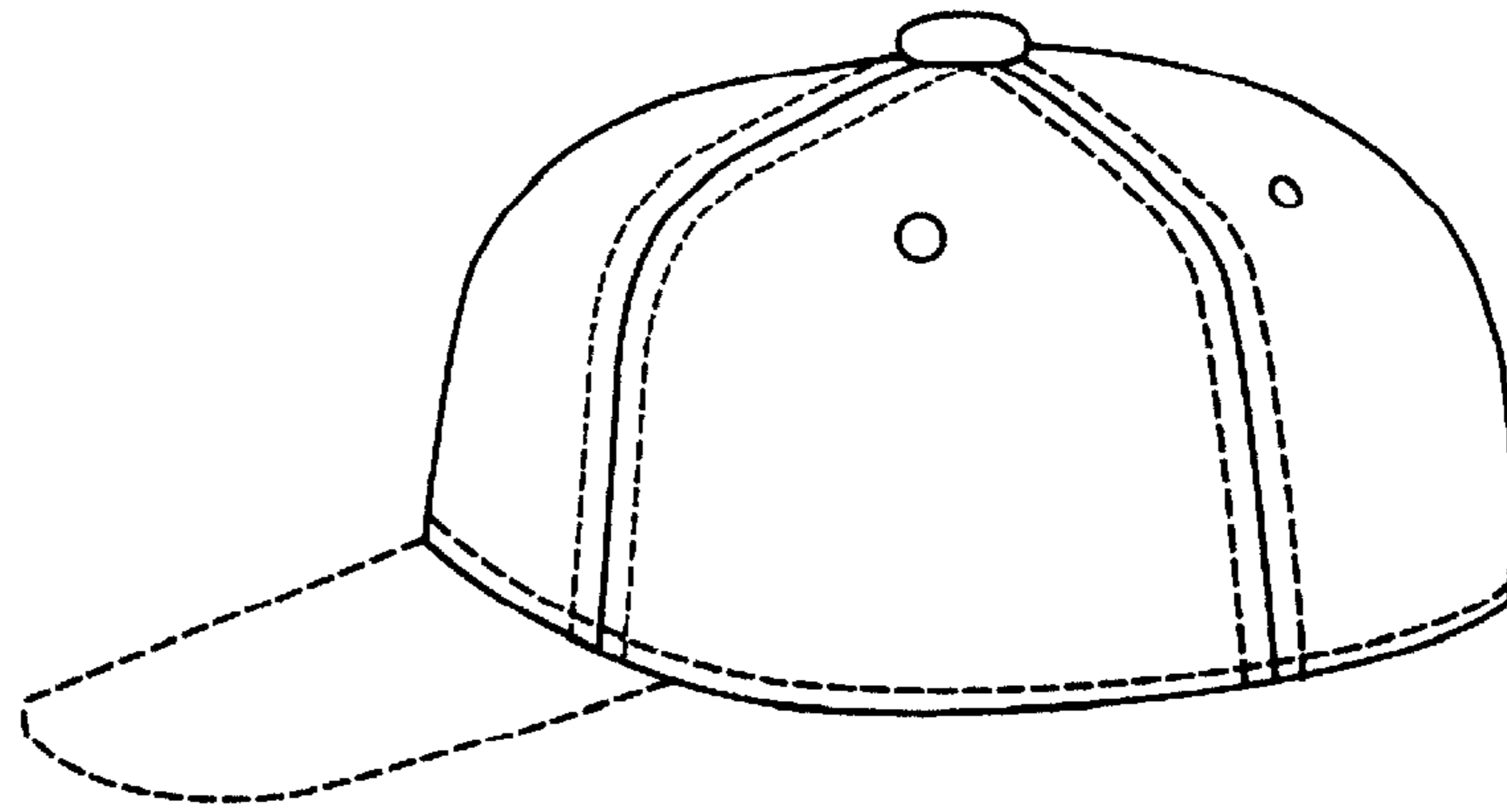
