We claim the ornamental design for a footwear upper portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an article of footwear, seen from the front and right side thereof, showing our new design;

FIG. 2 is a right side view thereof;

FIG. 3 is a left side view thereof;

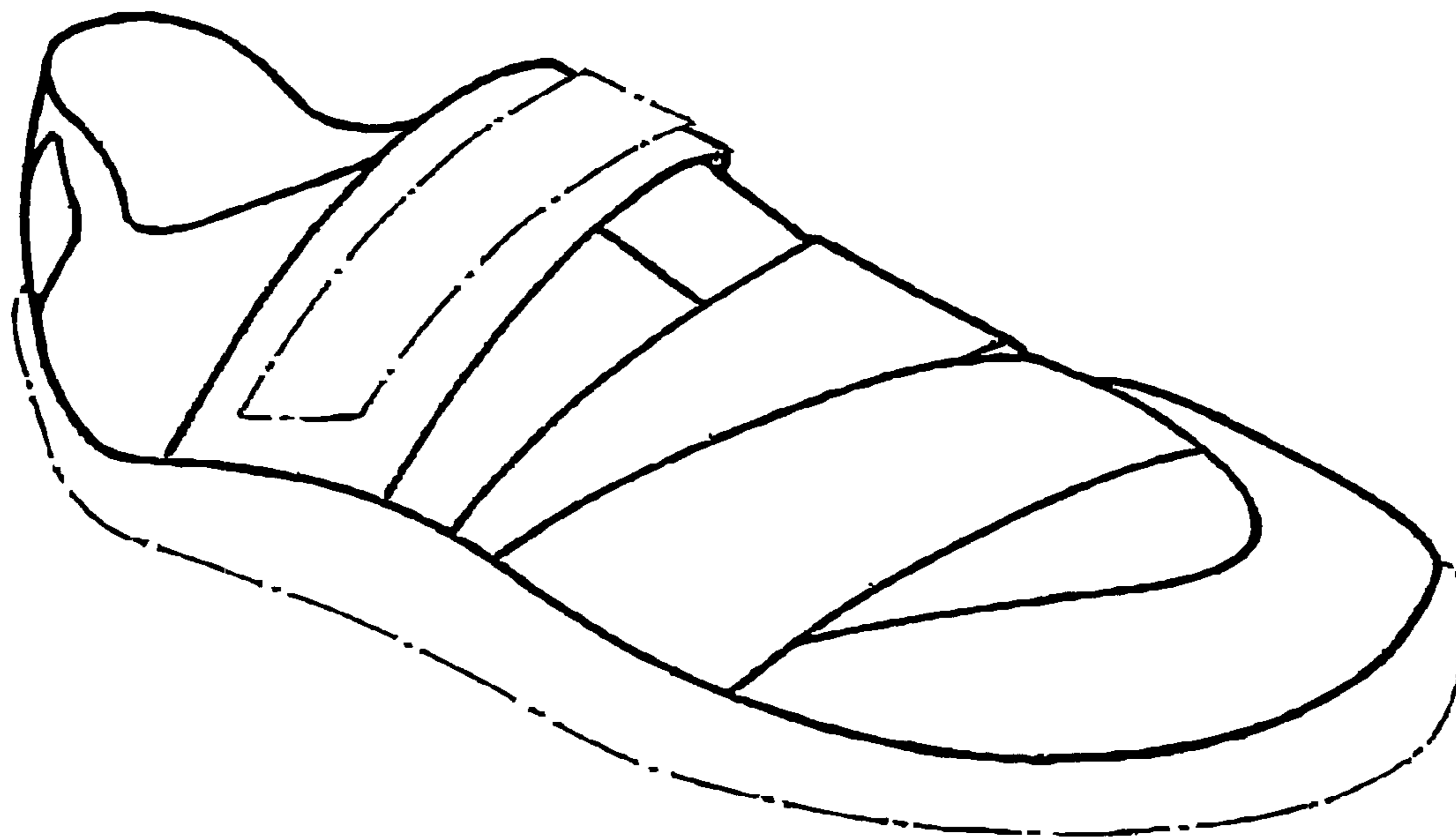
FIG. 4 is a top view thereof;

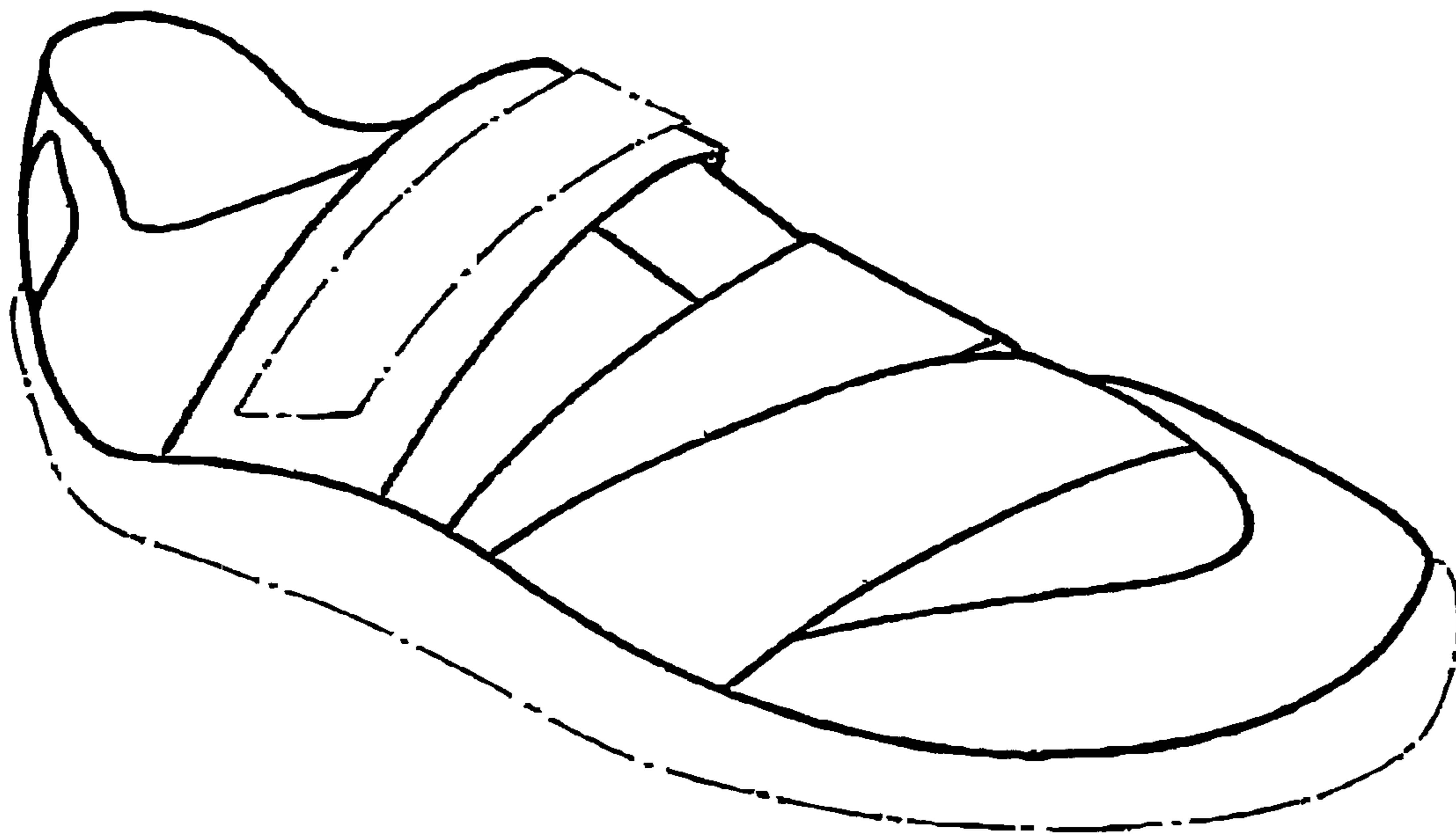

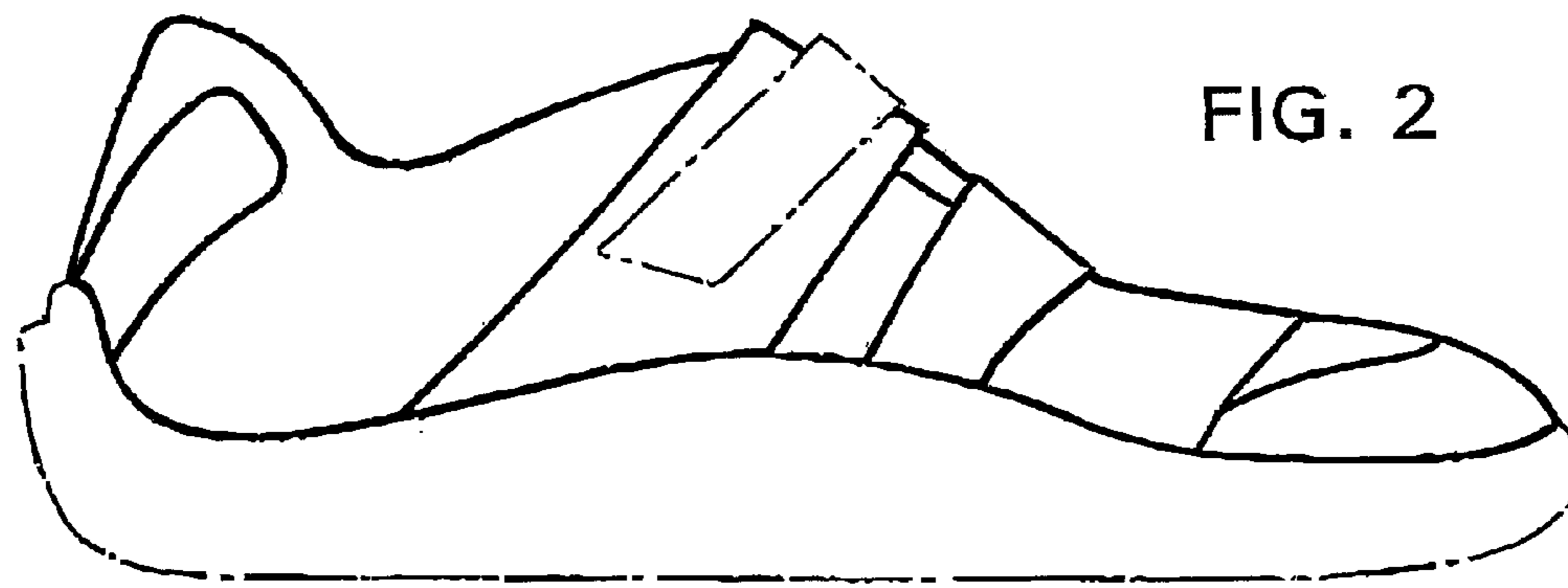

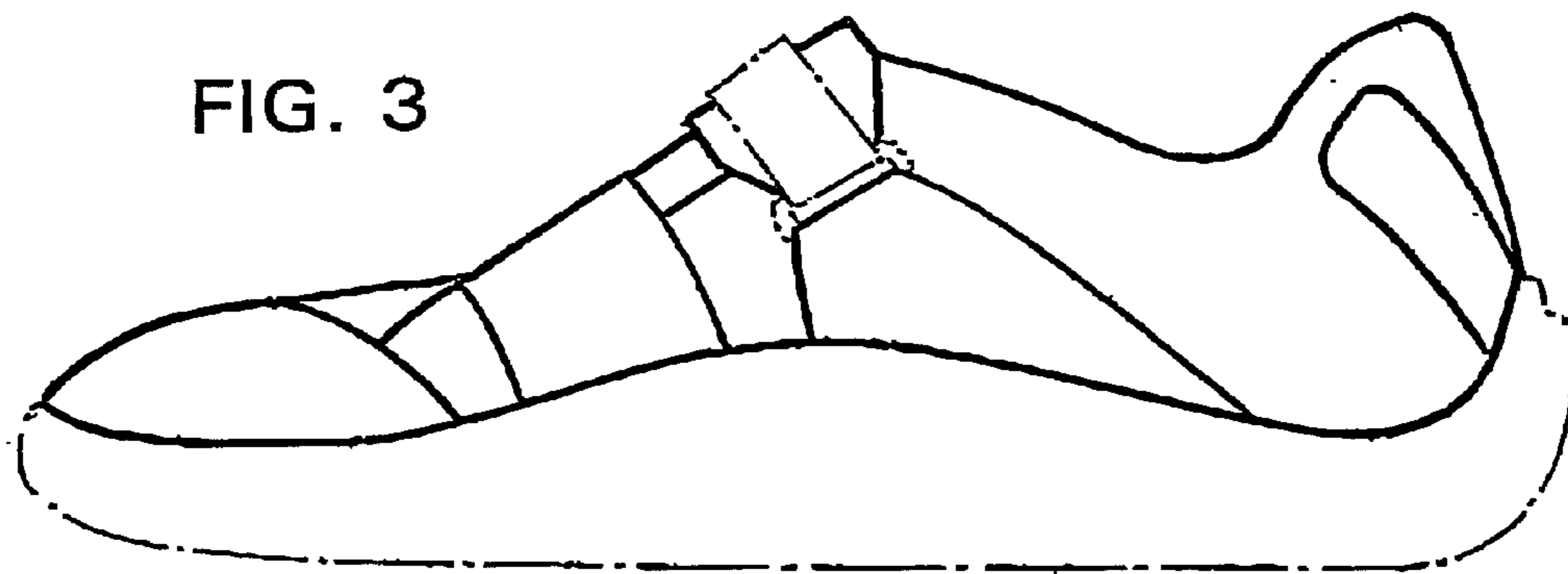

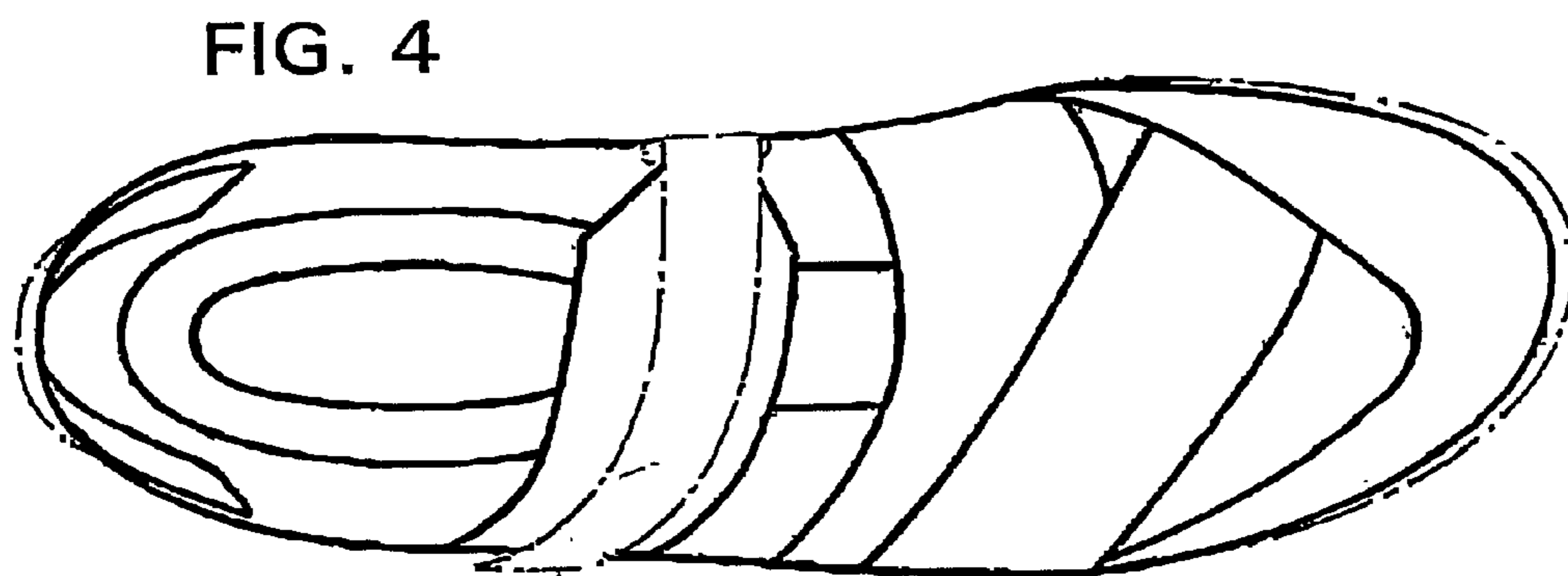

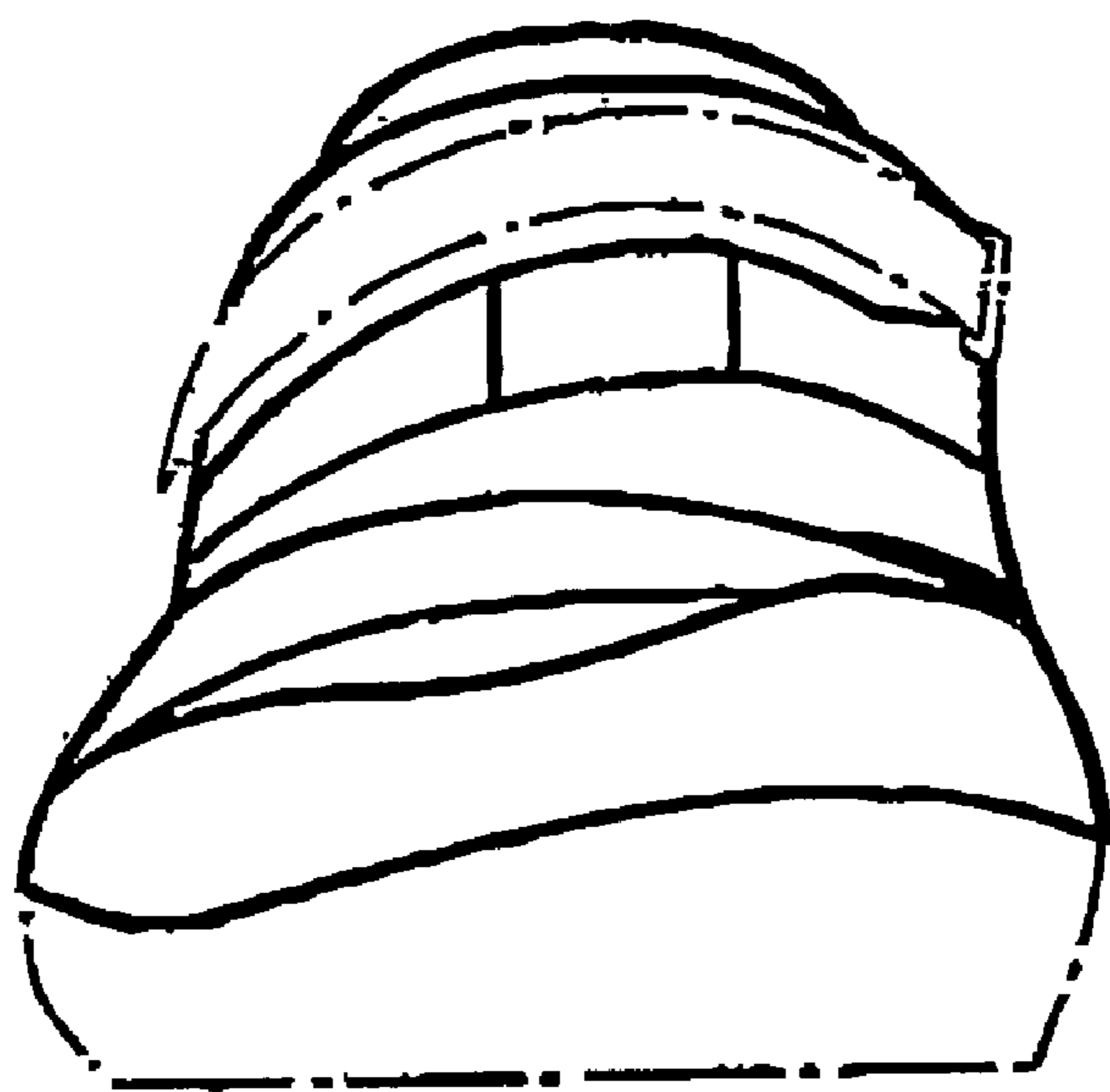

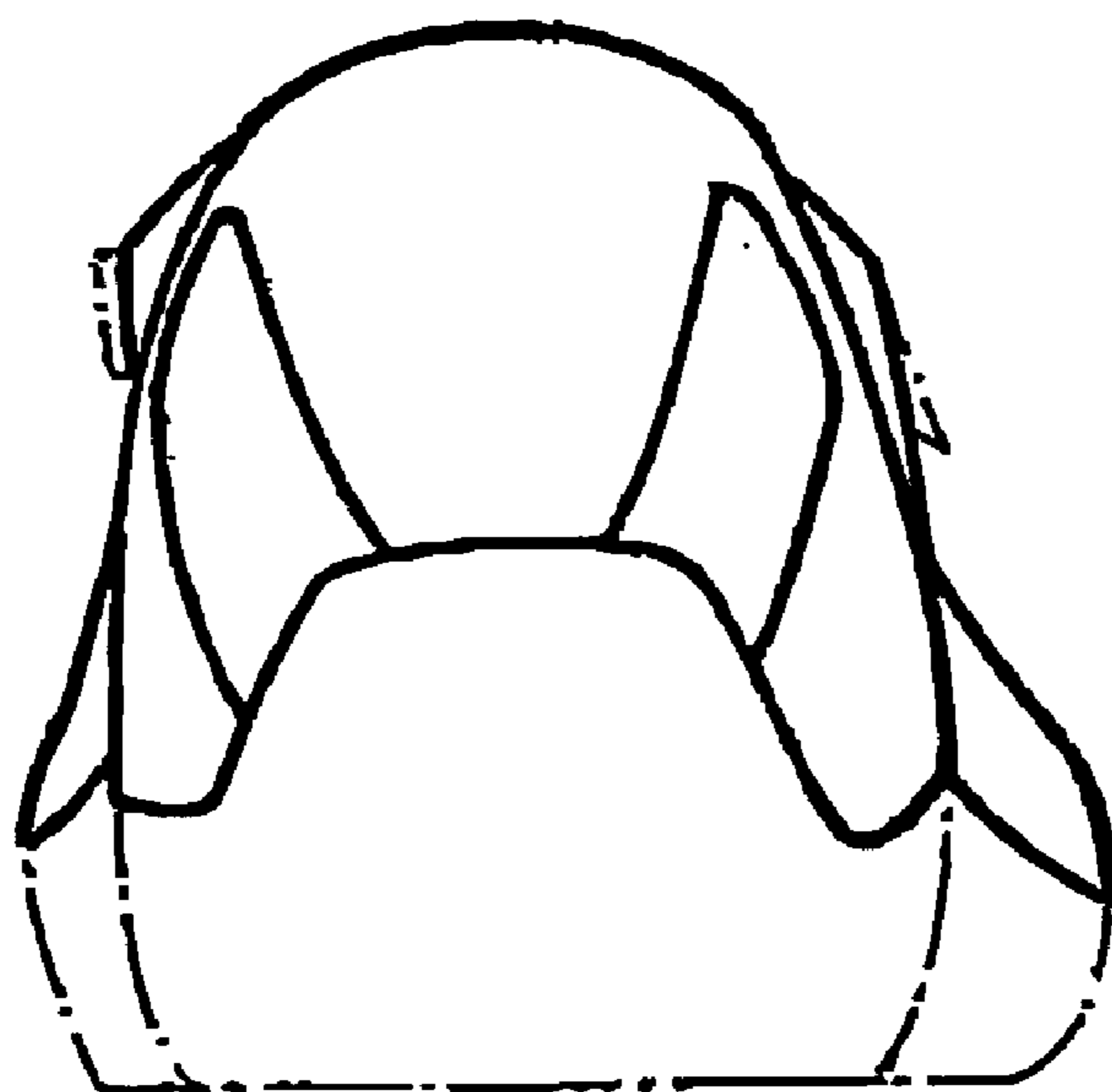
