(57) **CLAIM**

The ornamental design for a wall mountable support, as shown and described.

DESCRIPTION

In a preferred embodiments, the nature of this product a single towel bar and a double towel bar.

FIG. 1 is a left, top, front perspective view of a wall mountable support according to my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof, the bottom plan view being a mirror image of the top view shown;

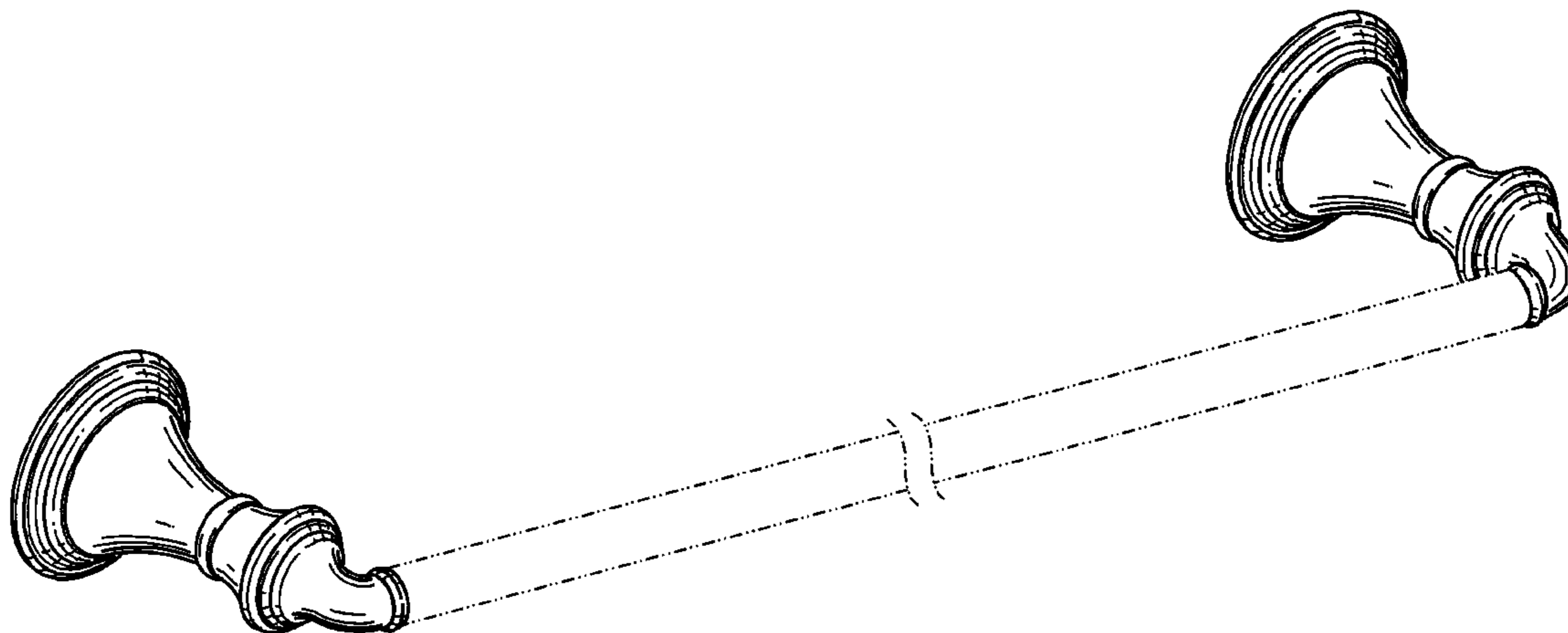
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image the left side shown;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a left, top, front perspective view of the wall mountable support according to my new design shown with a double towel bar environment.

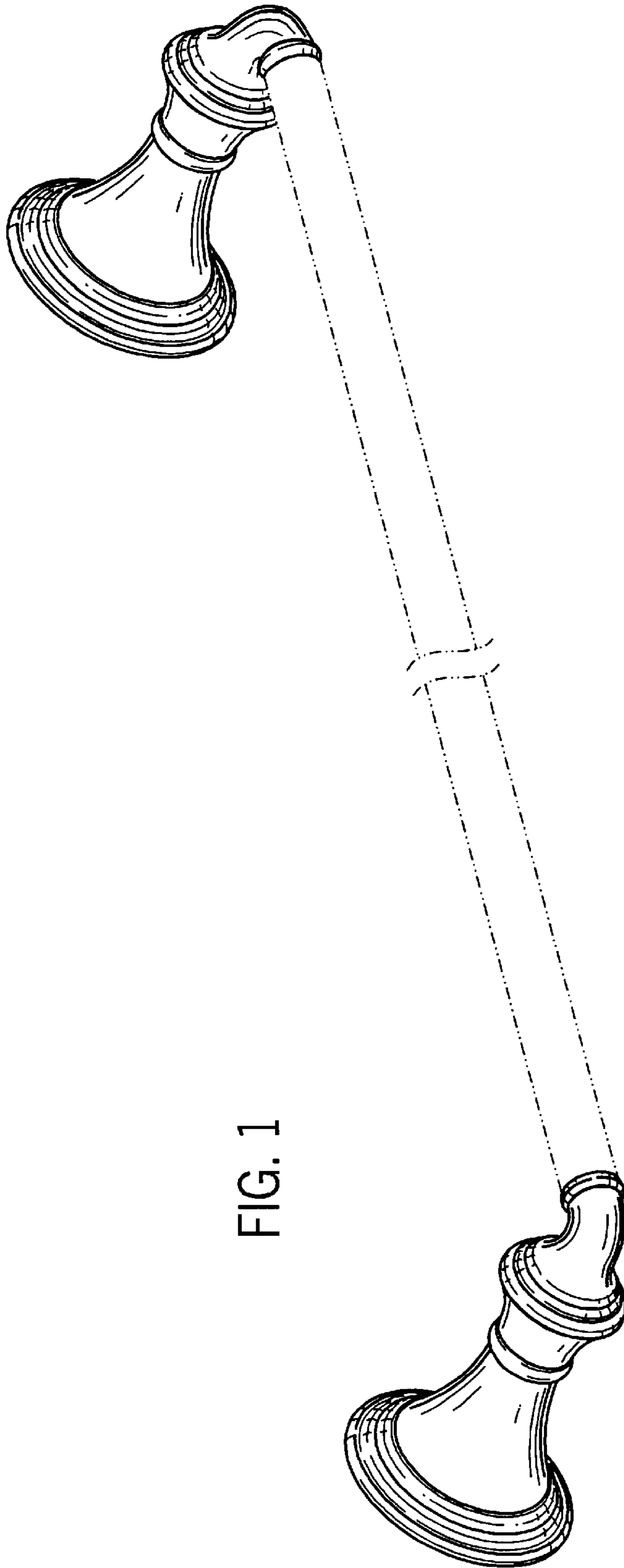

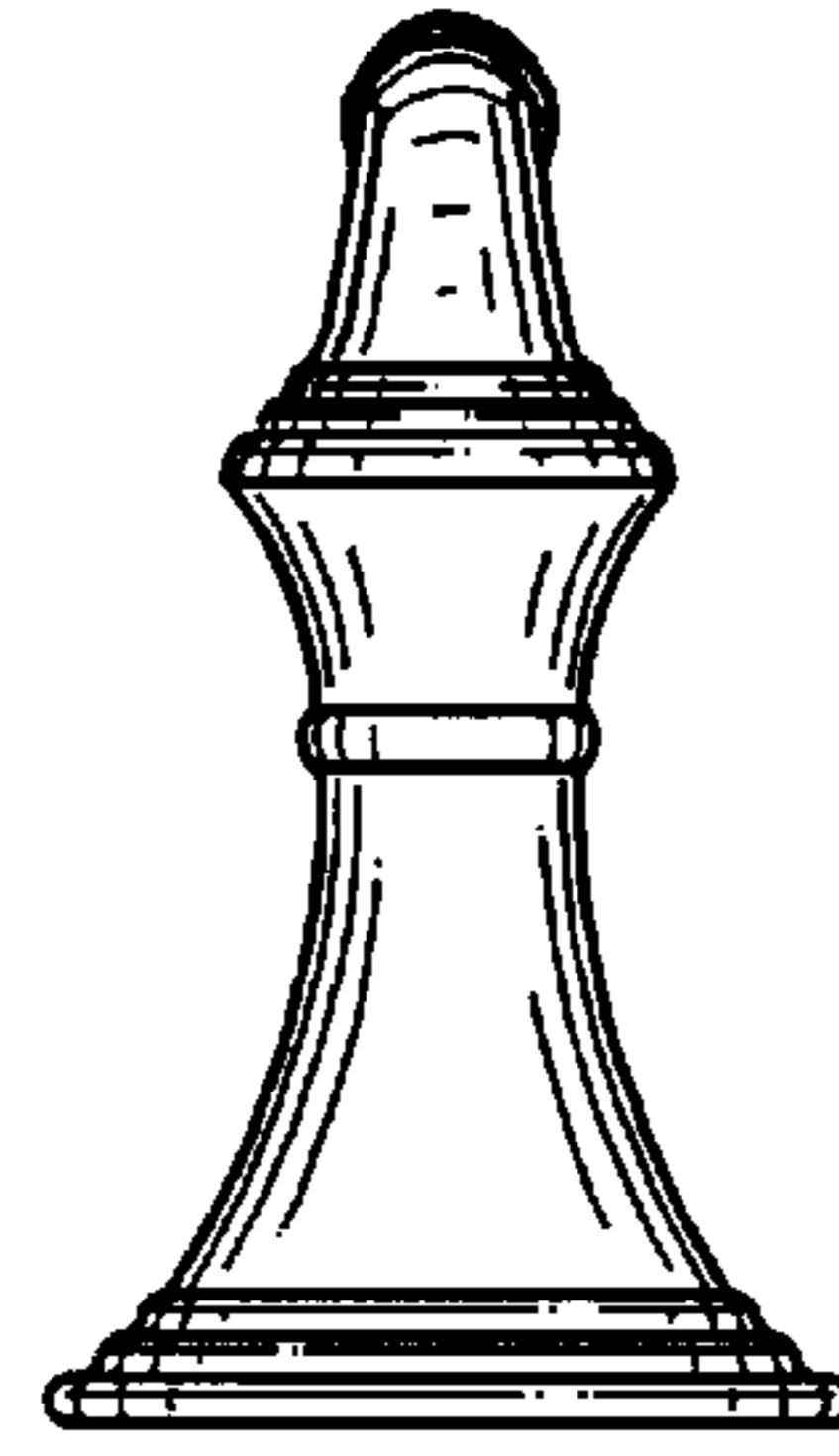

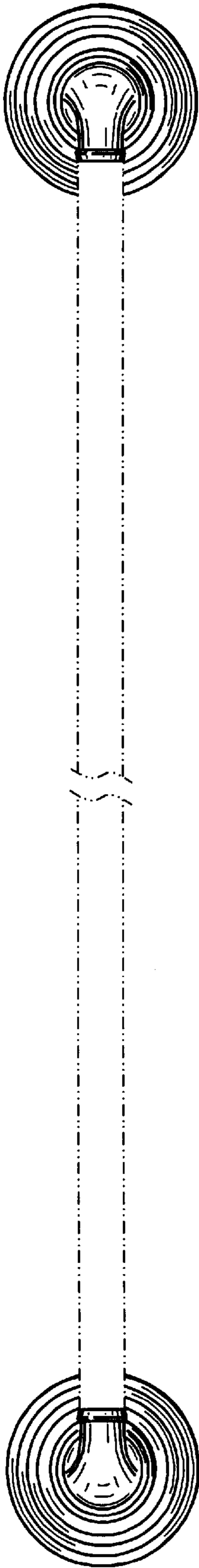

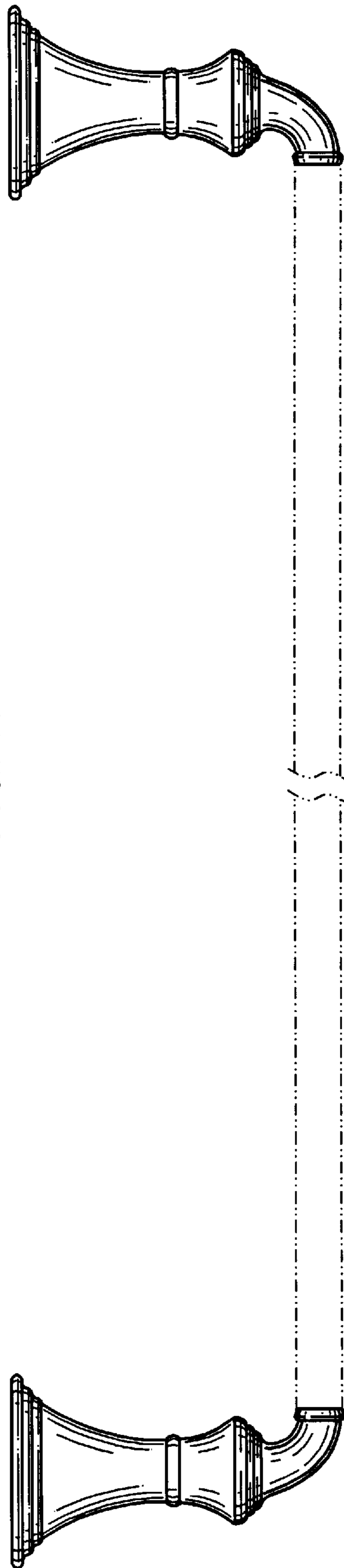

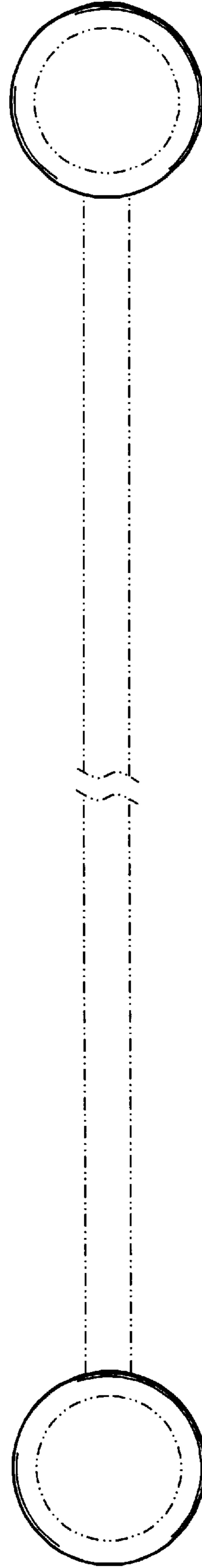

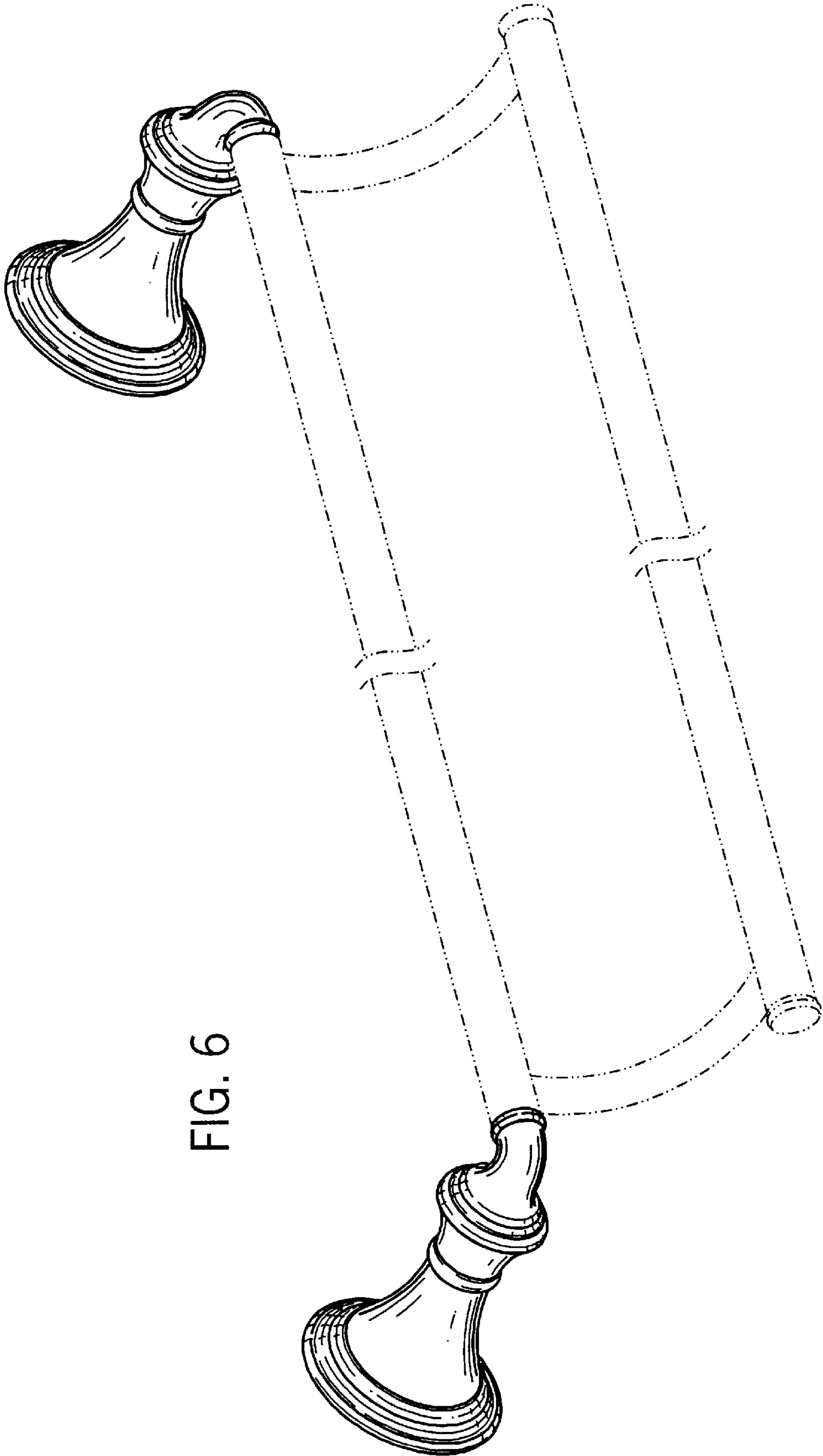
