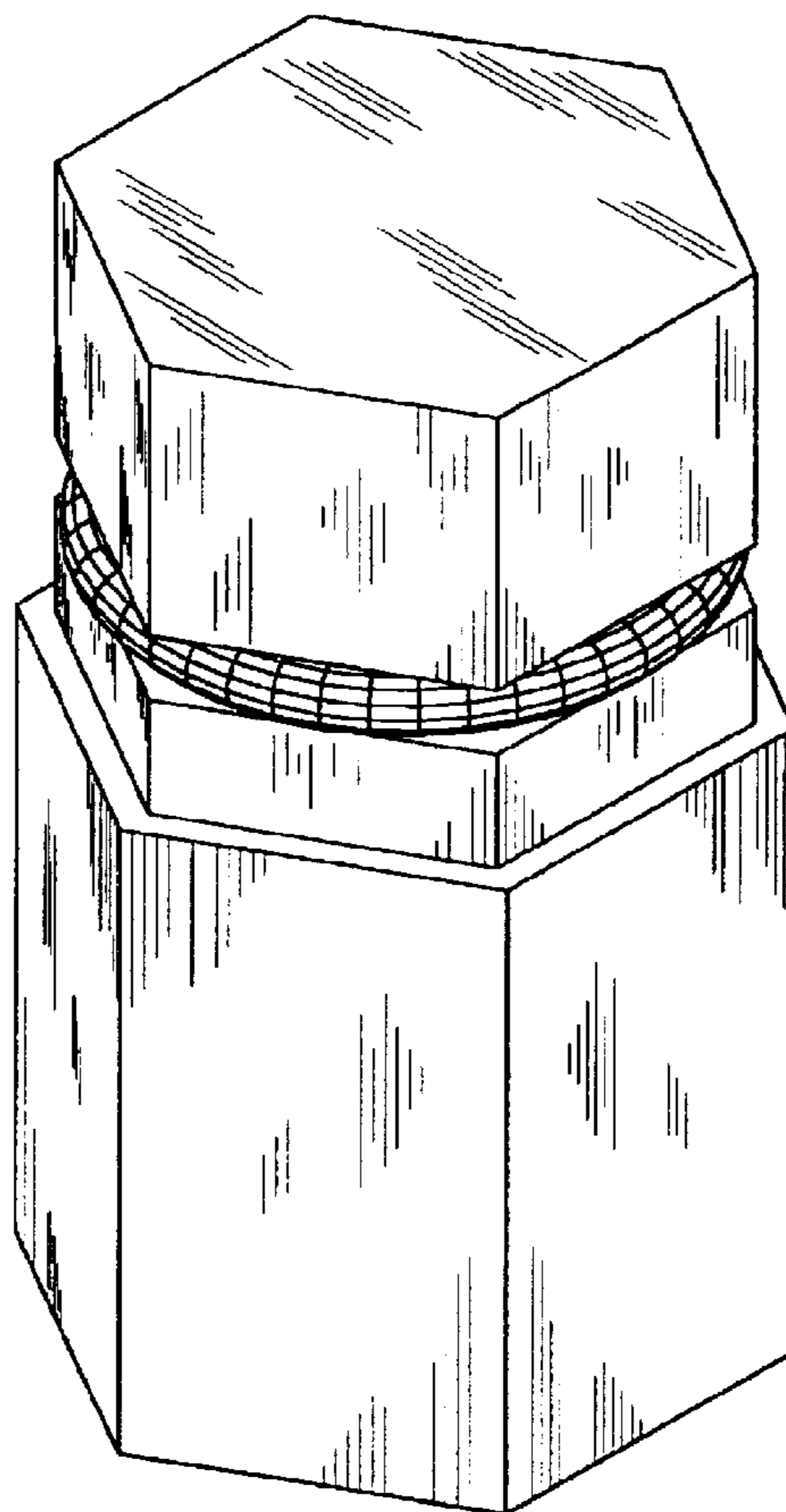
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a wrench extending adaptor showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a right side elevational view thereof; the left side elevational view being a mirror image thereof; and,
 FIG. 5 is a front side elevational view thereof; the rear side elevational view being a mirror image thereof.

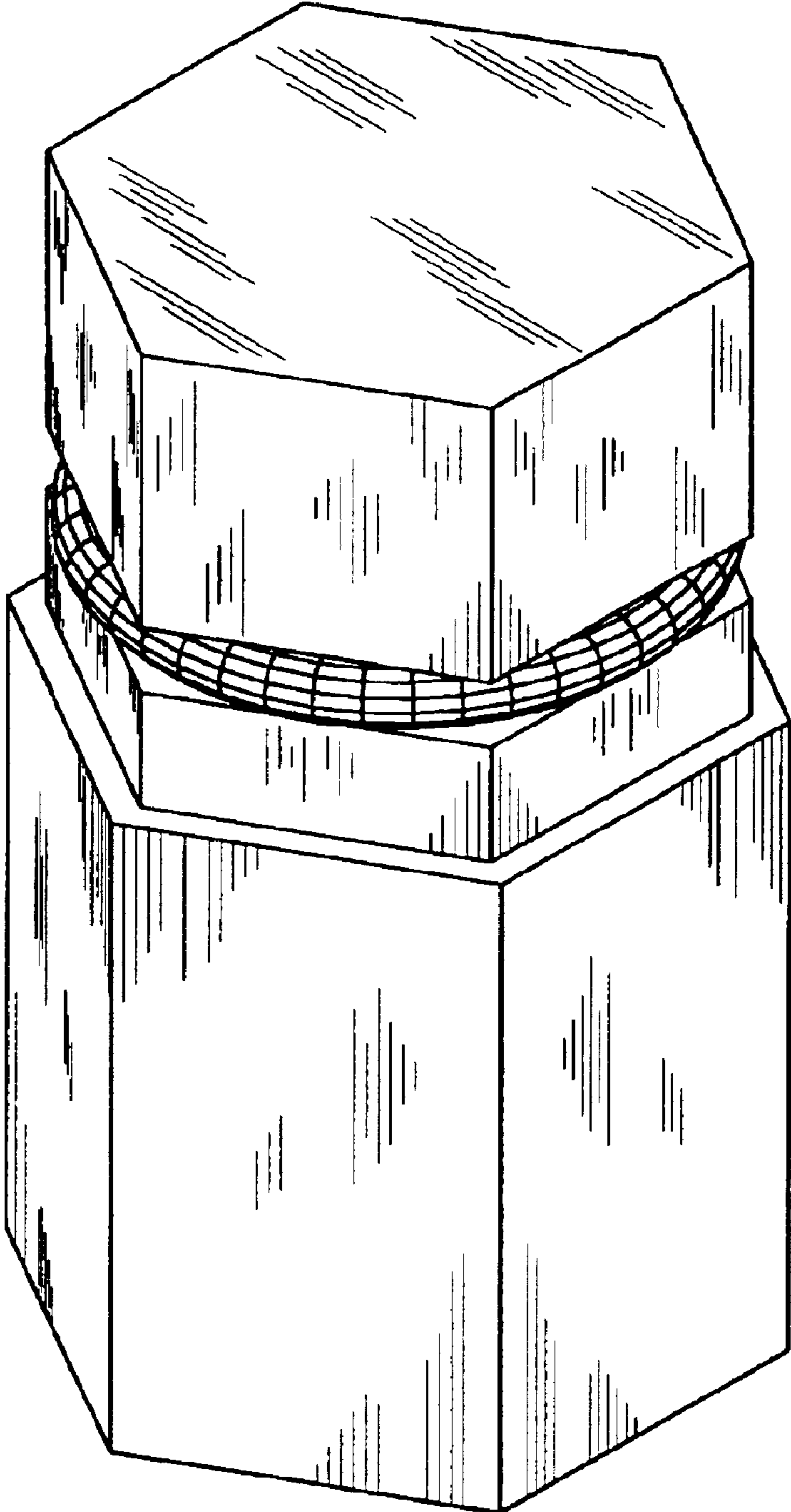

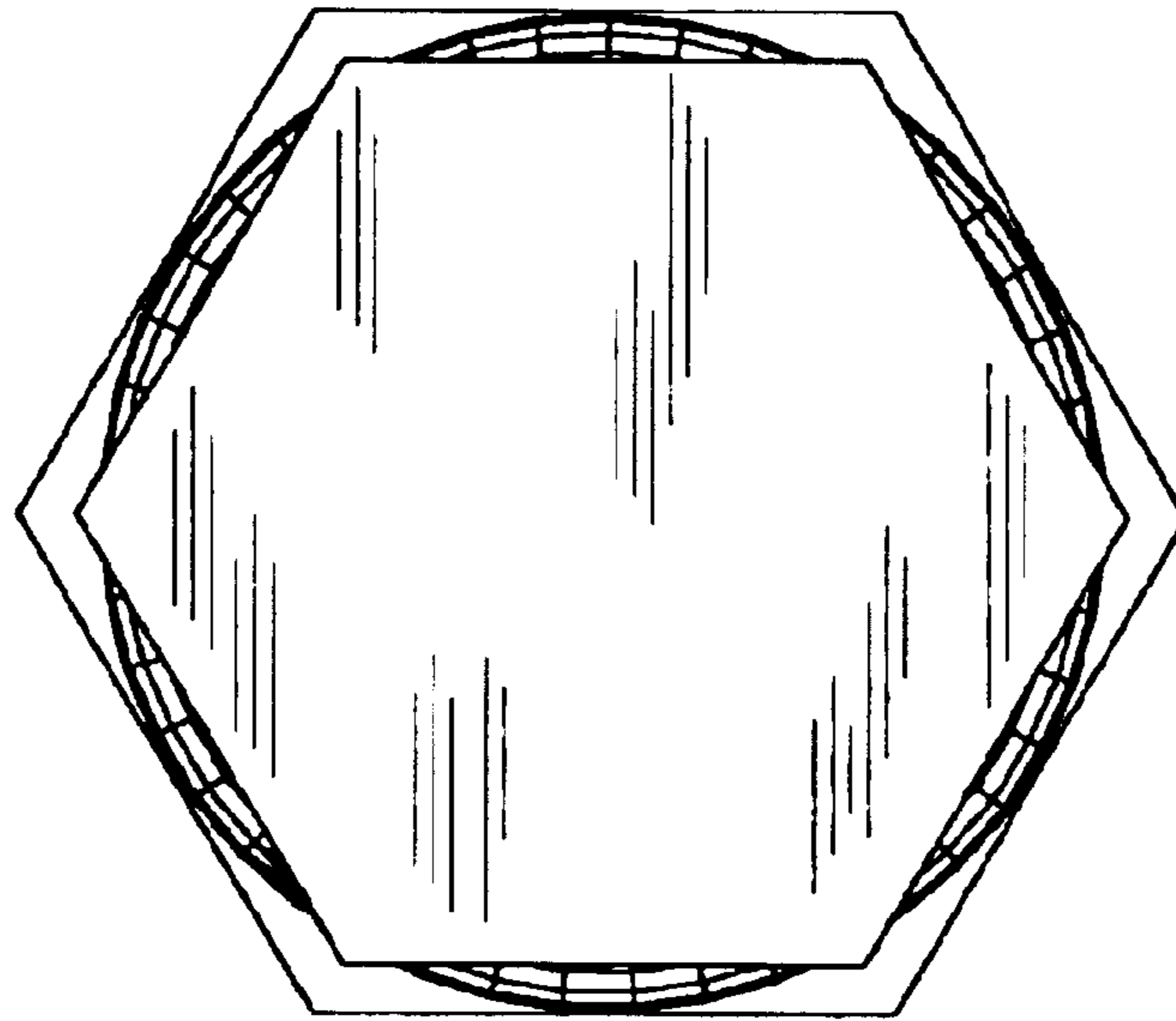

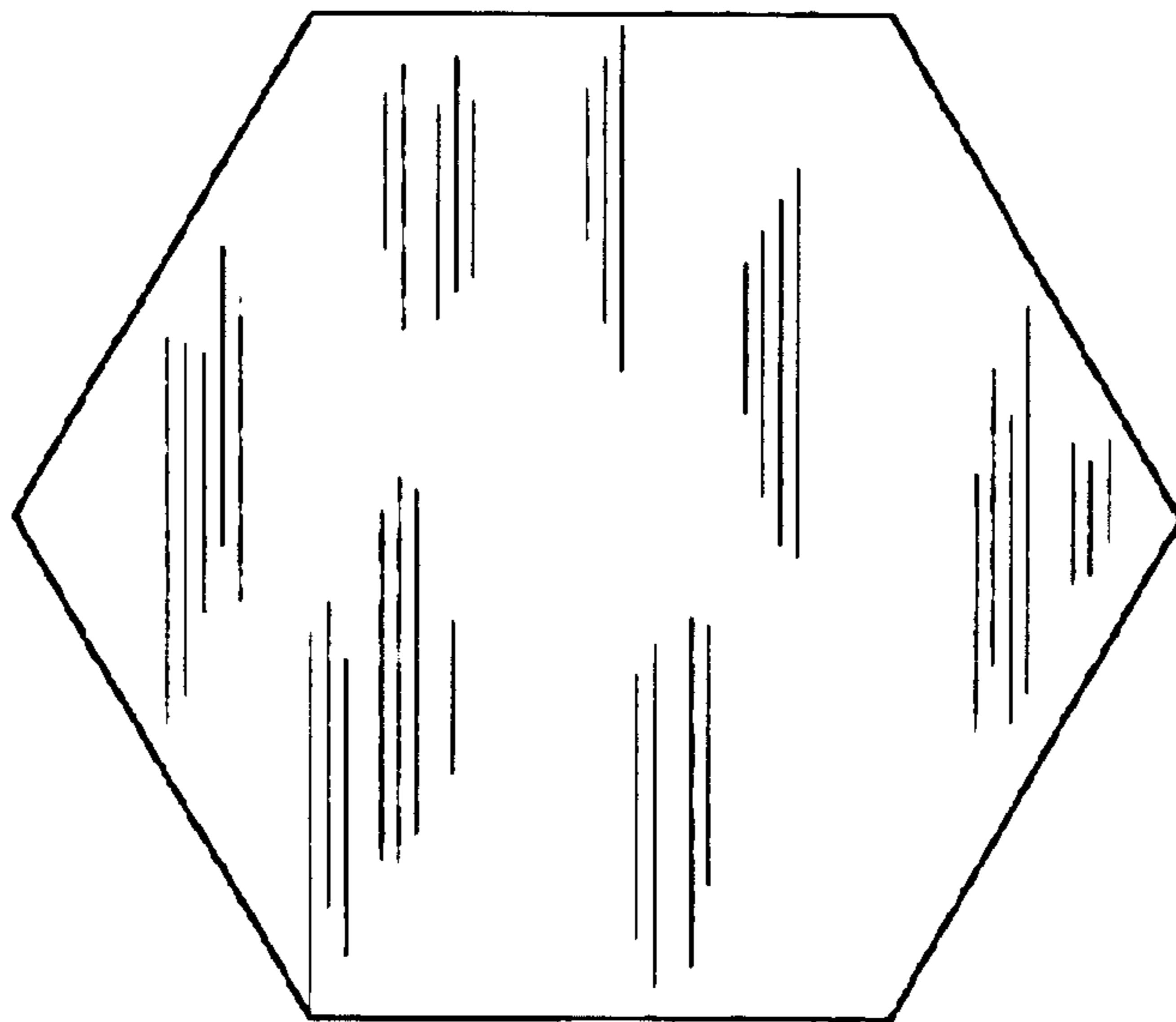

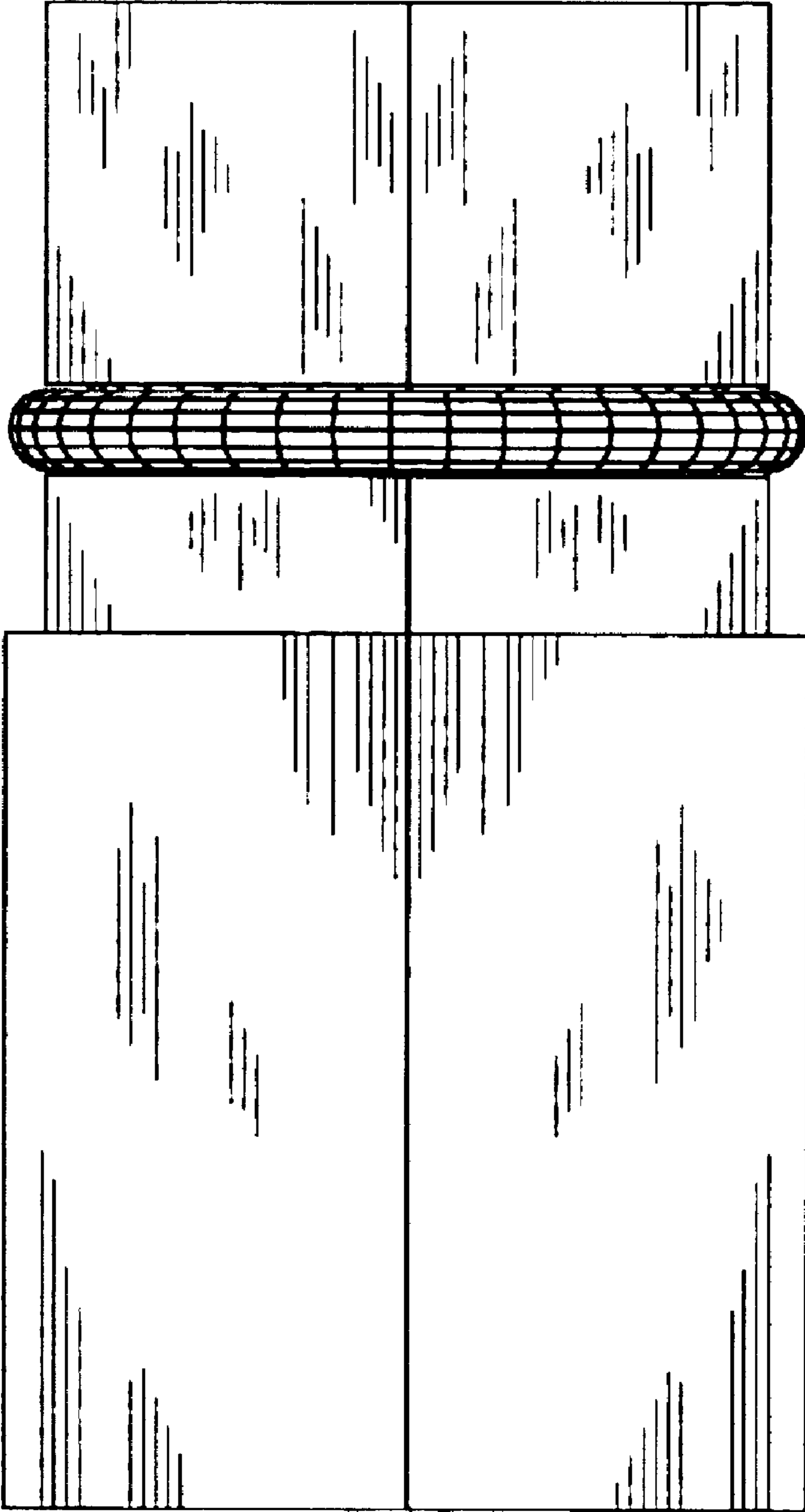

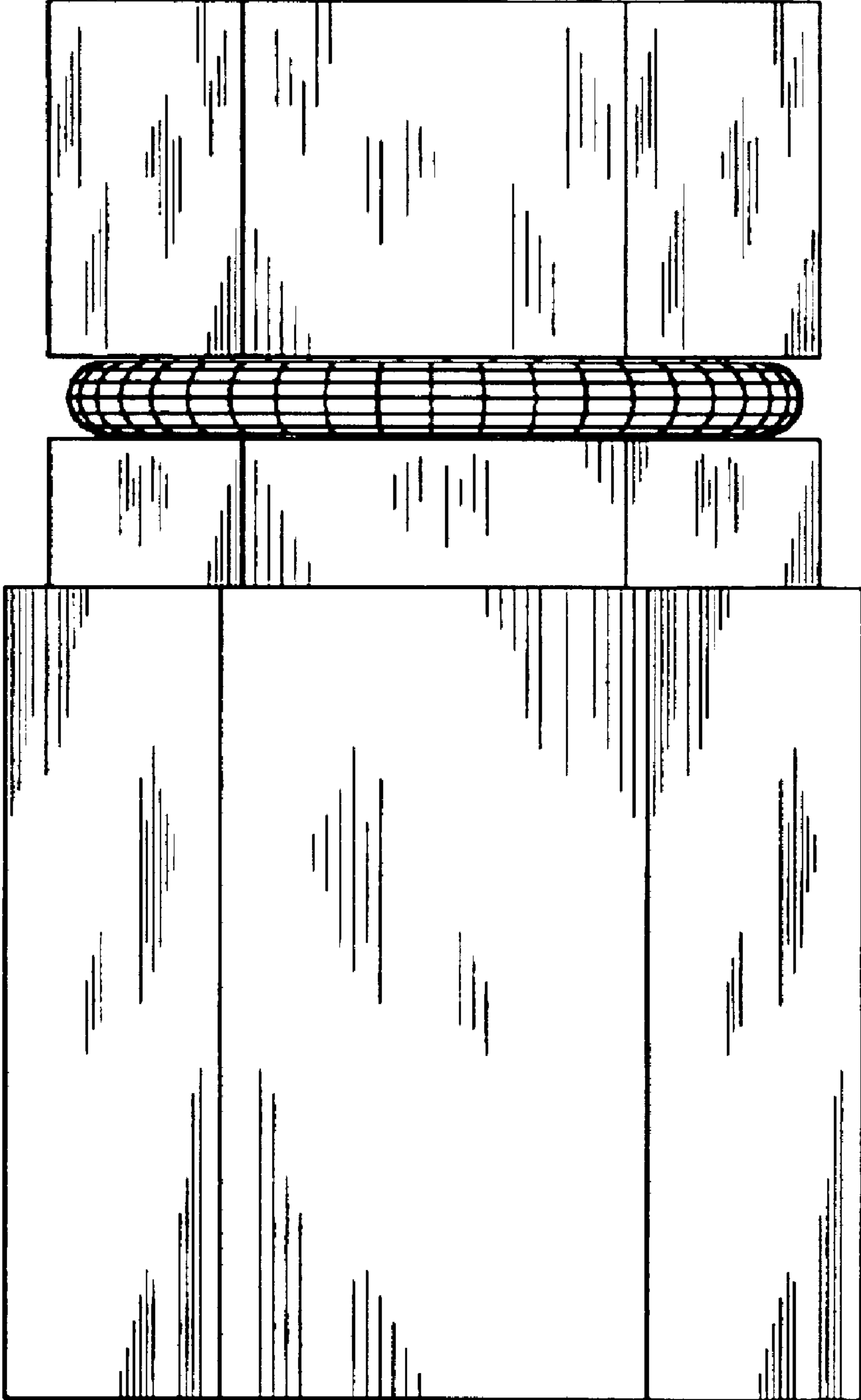
