(57) **CLAIM**

The ornamental design for a sports rosary, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a sports rosary showing my new design;

FIG. 2 is a front view of a second embodiment of FIG. 1;

FIG. 3 is a rear view of the embodiment shown in FIG. 2.

FIG. 4 is a front view of a third embodiment FIG. 1;
