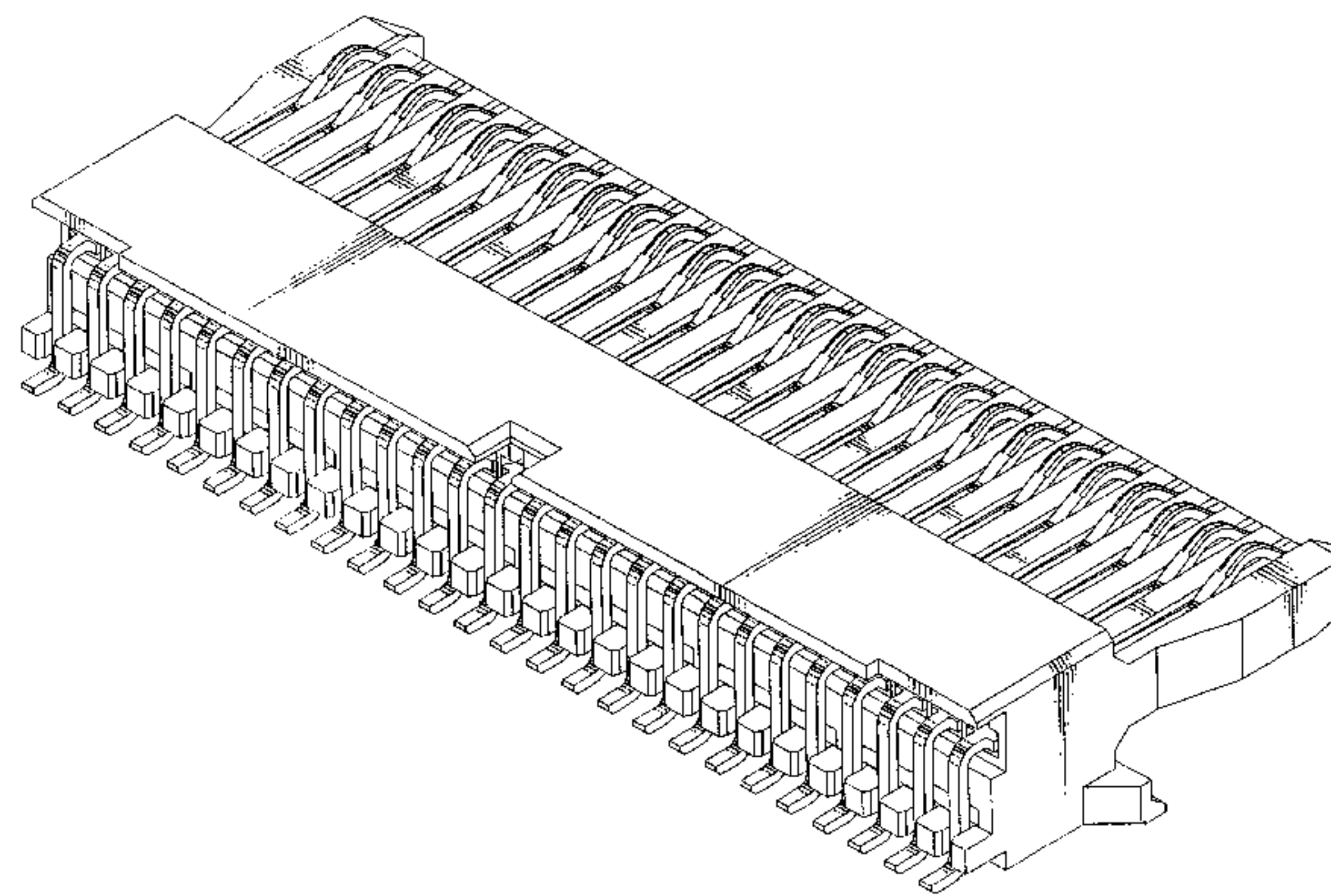
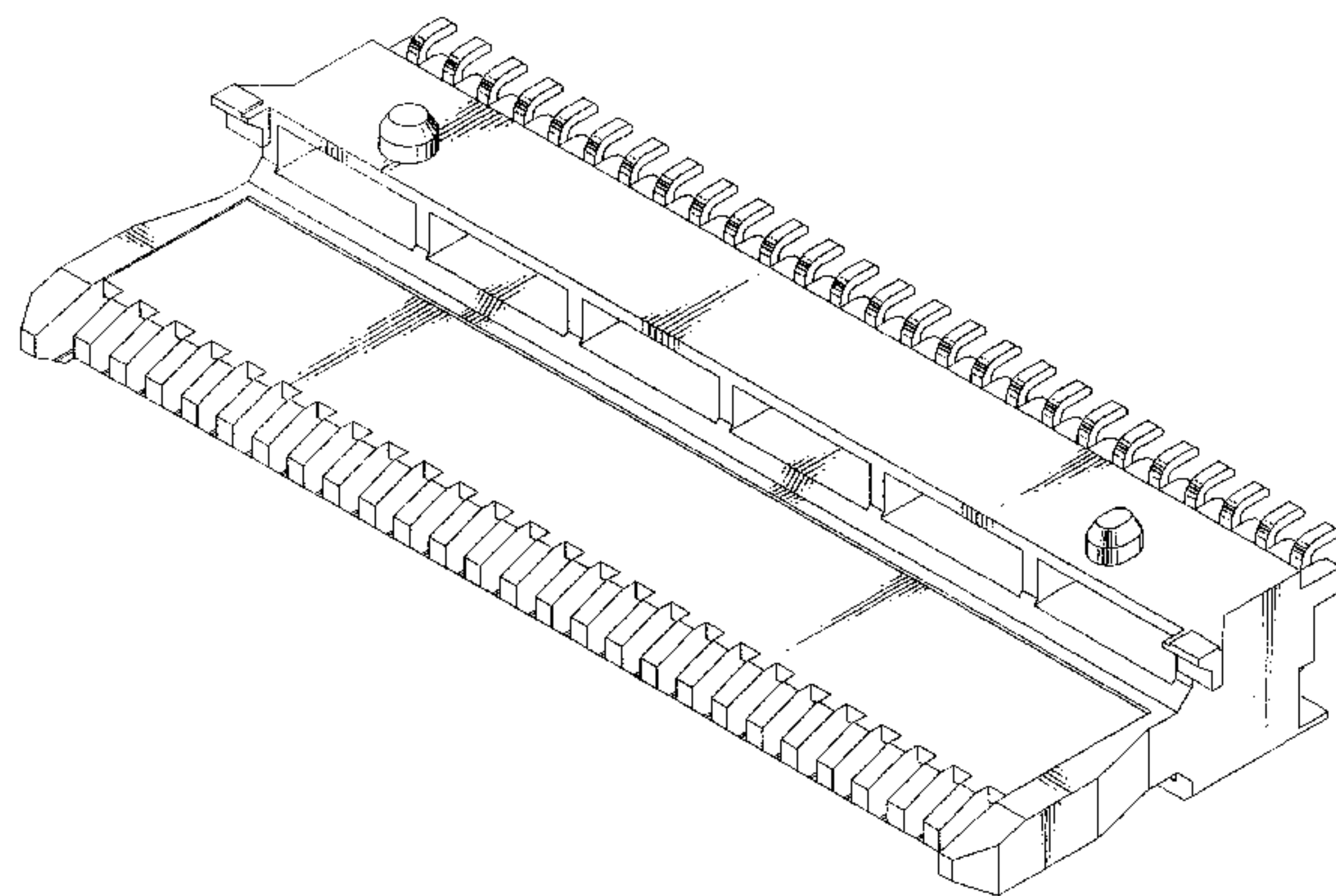
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of an electrical connector, showing our new design;

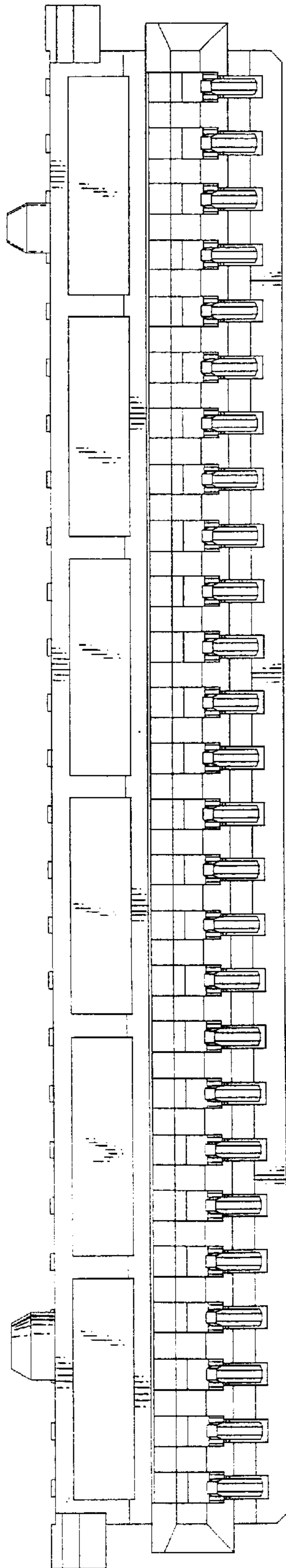

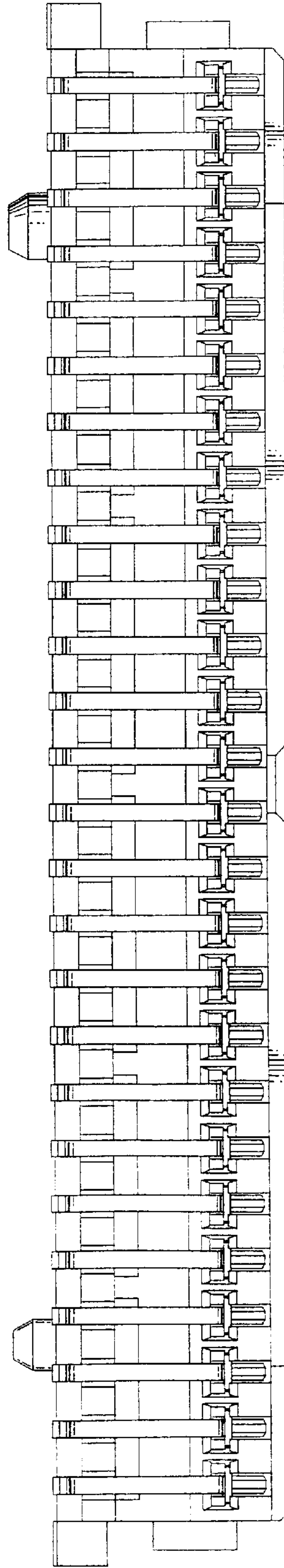

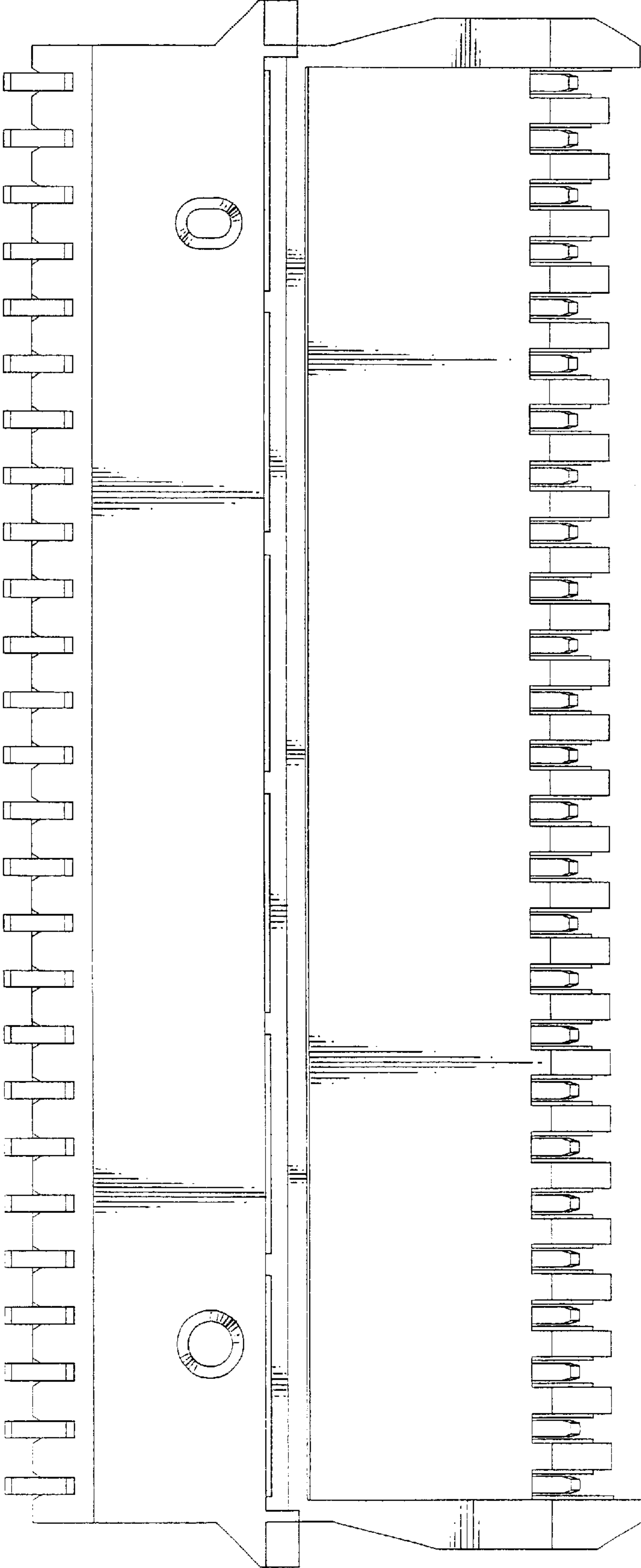

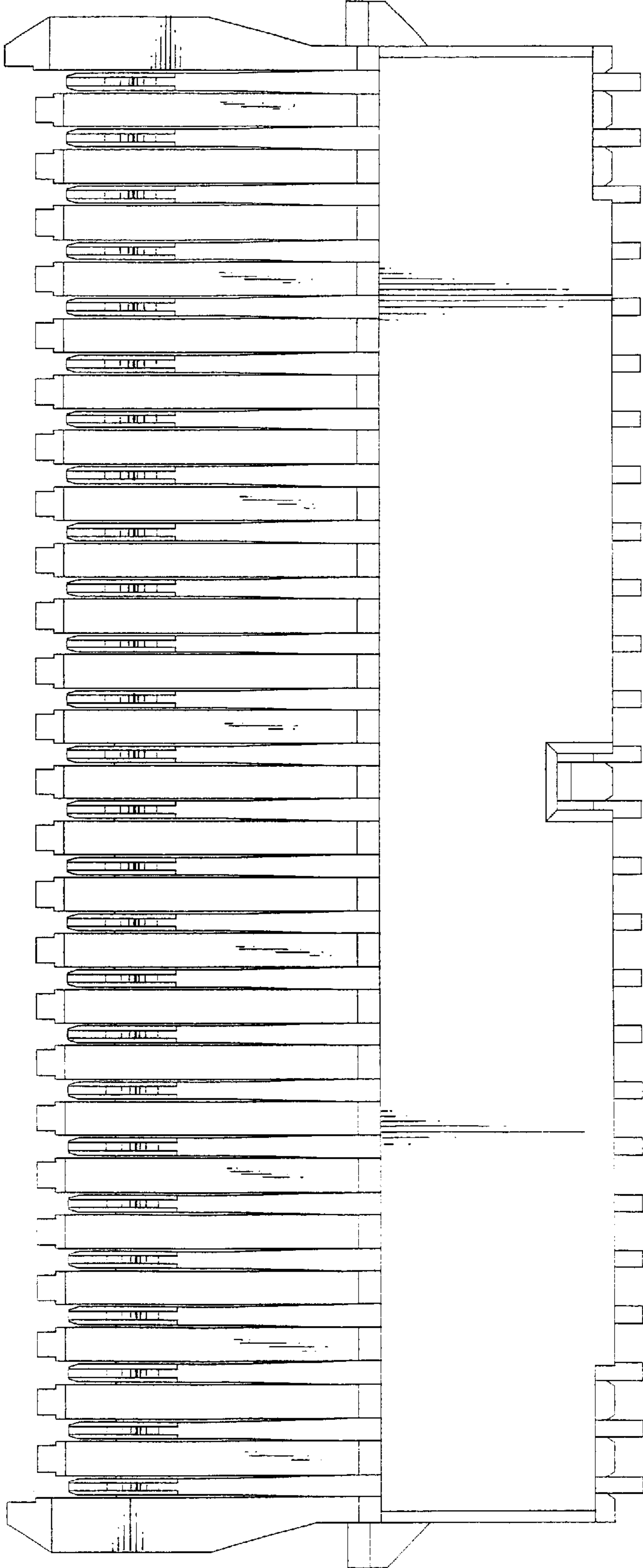

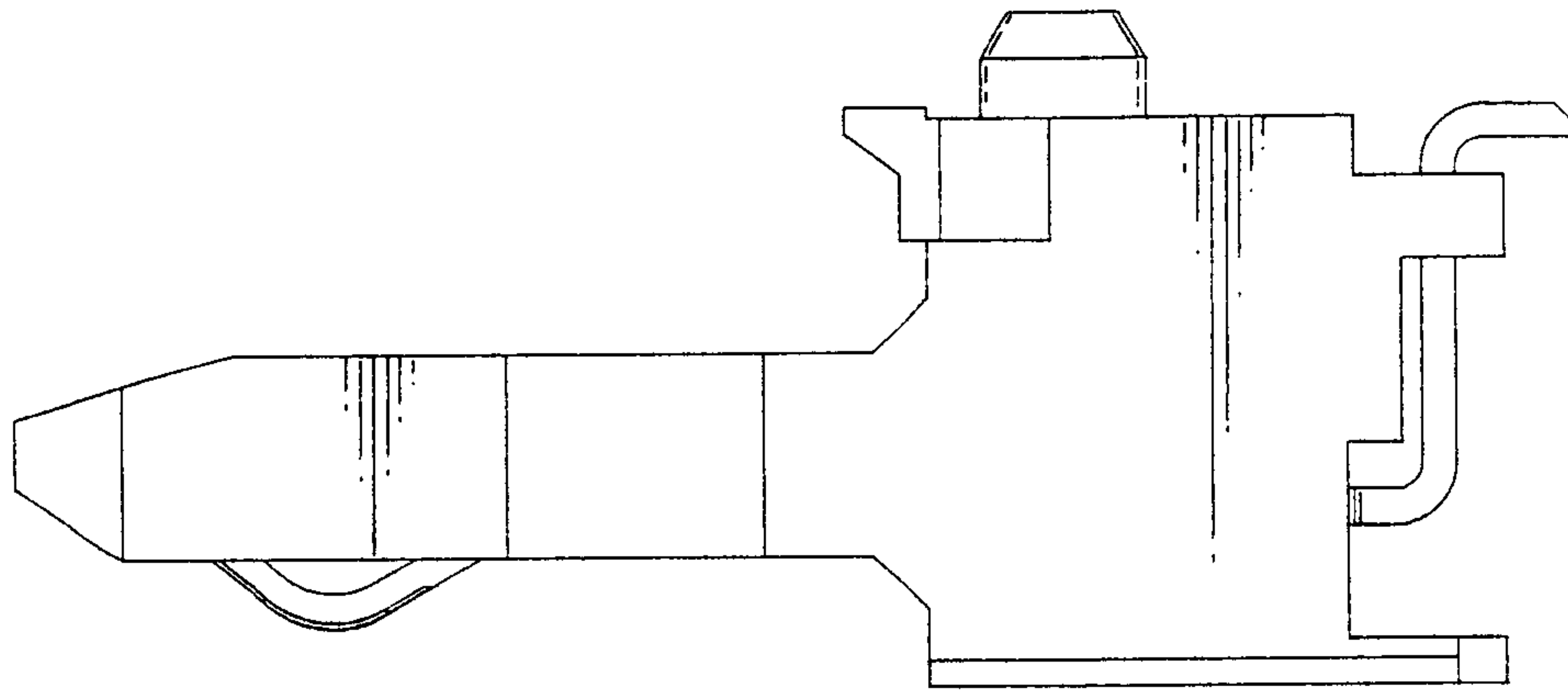

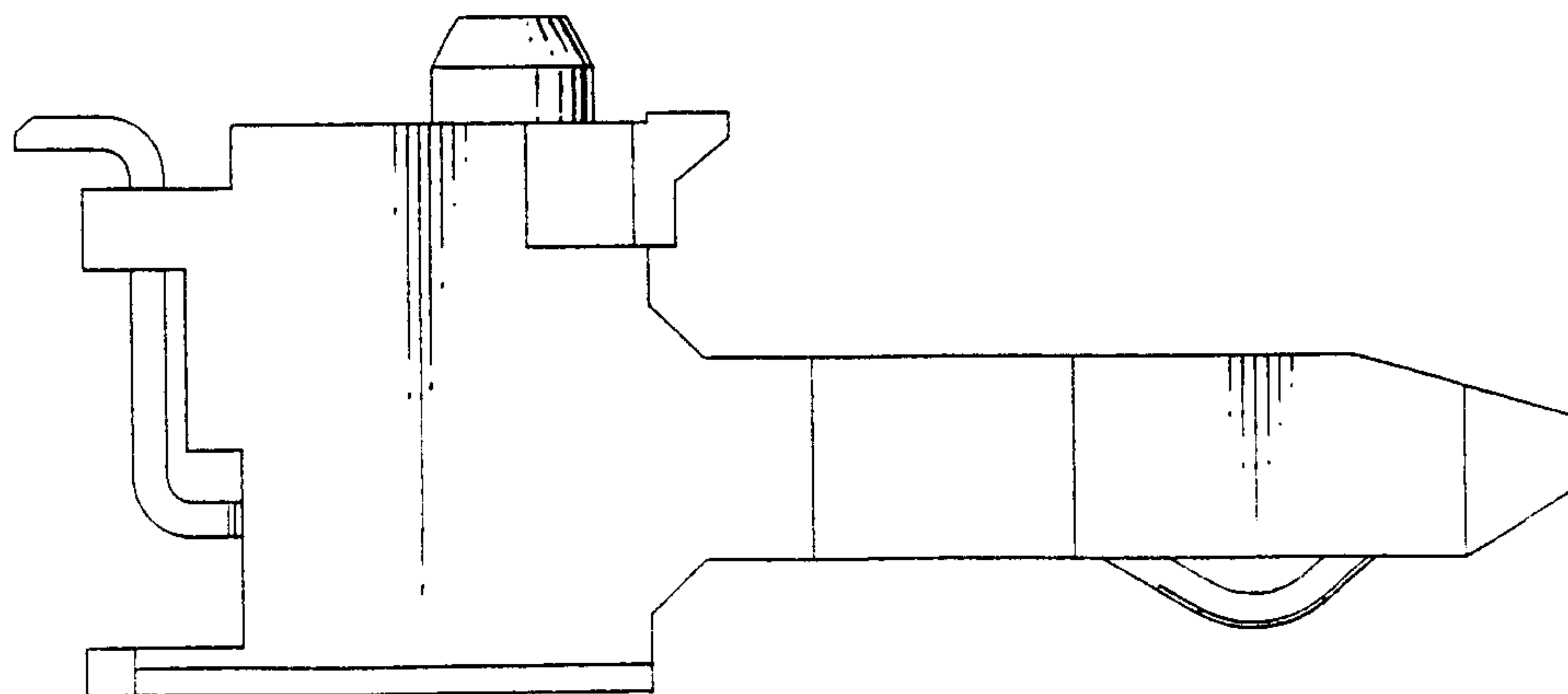

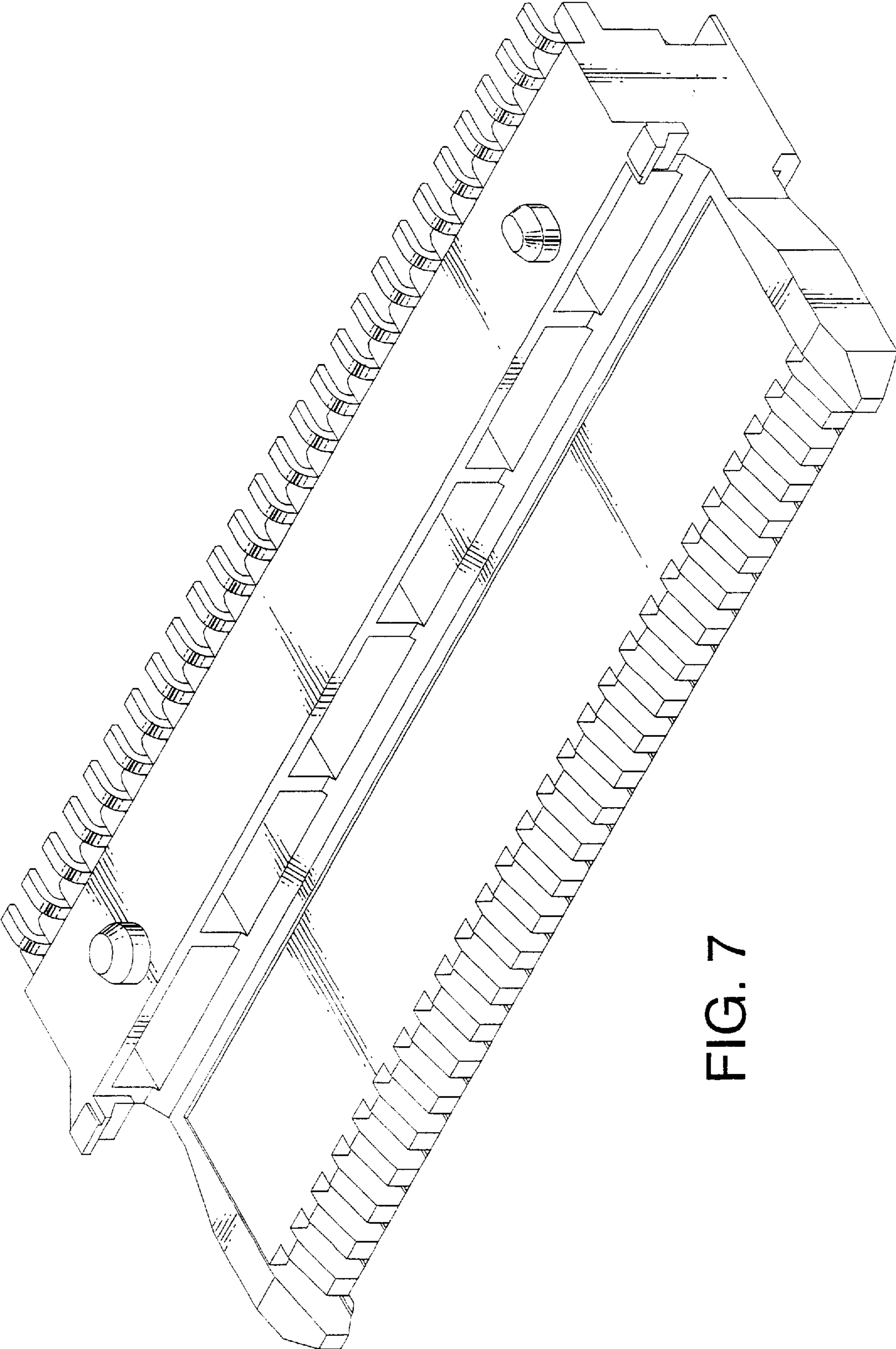

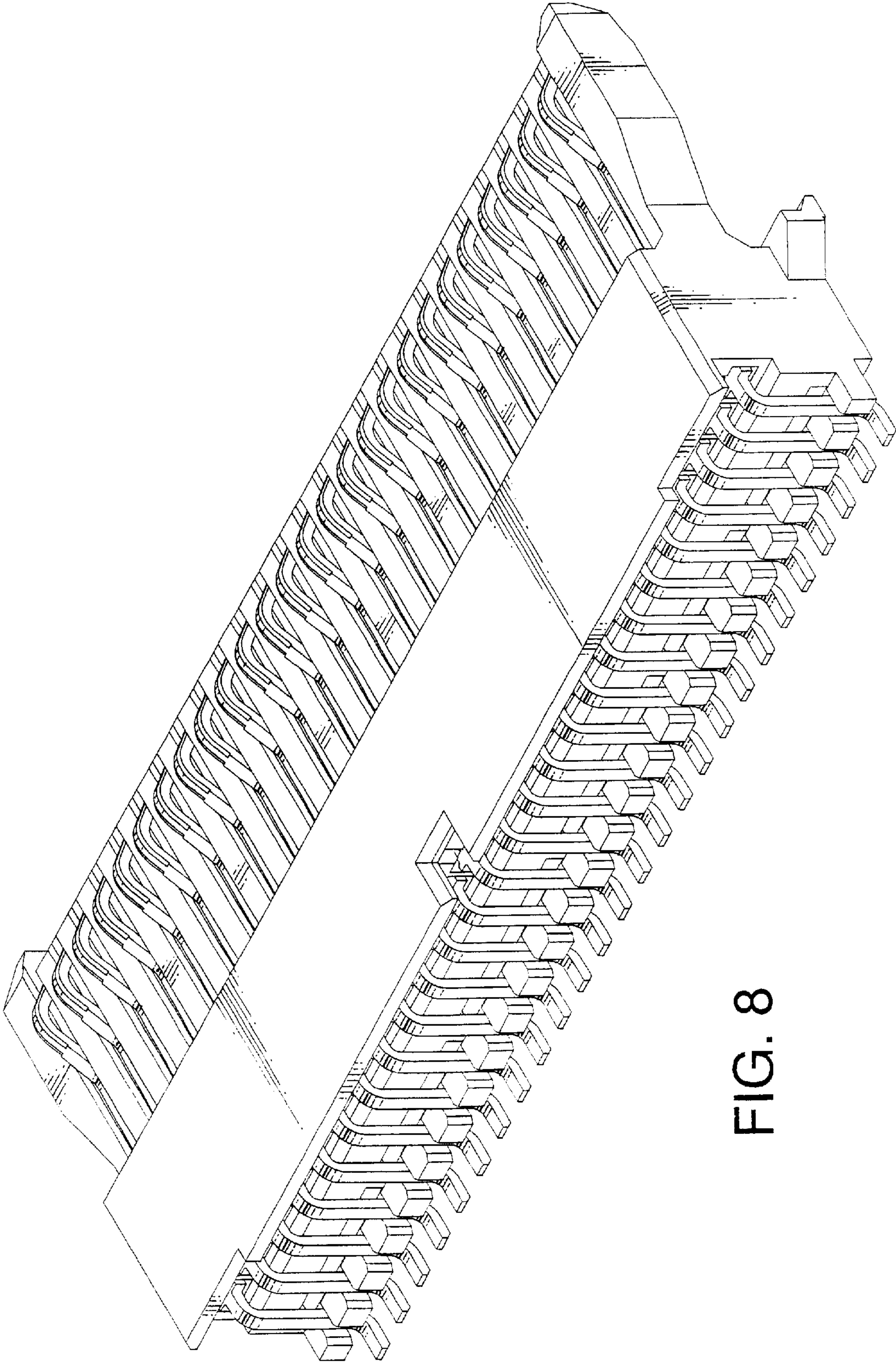
