FIG. 4 is a right side view of the microscope tube of our invention.

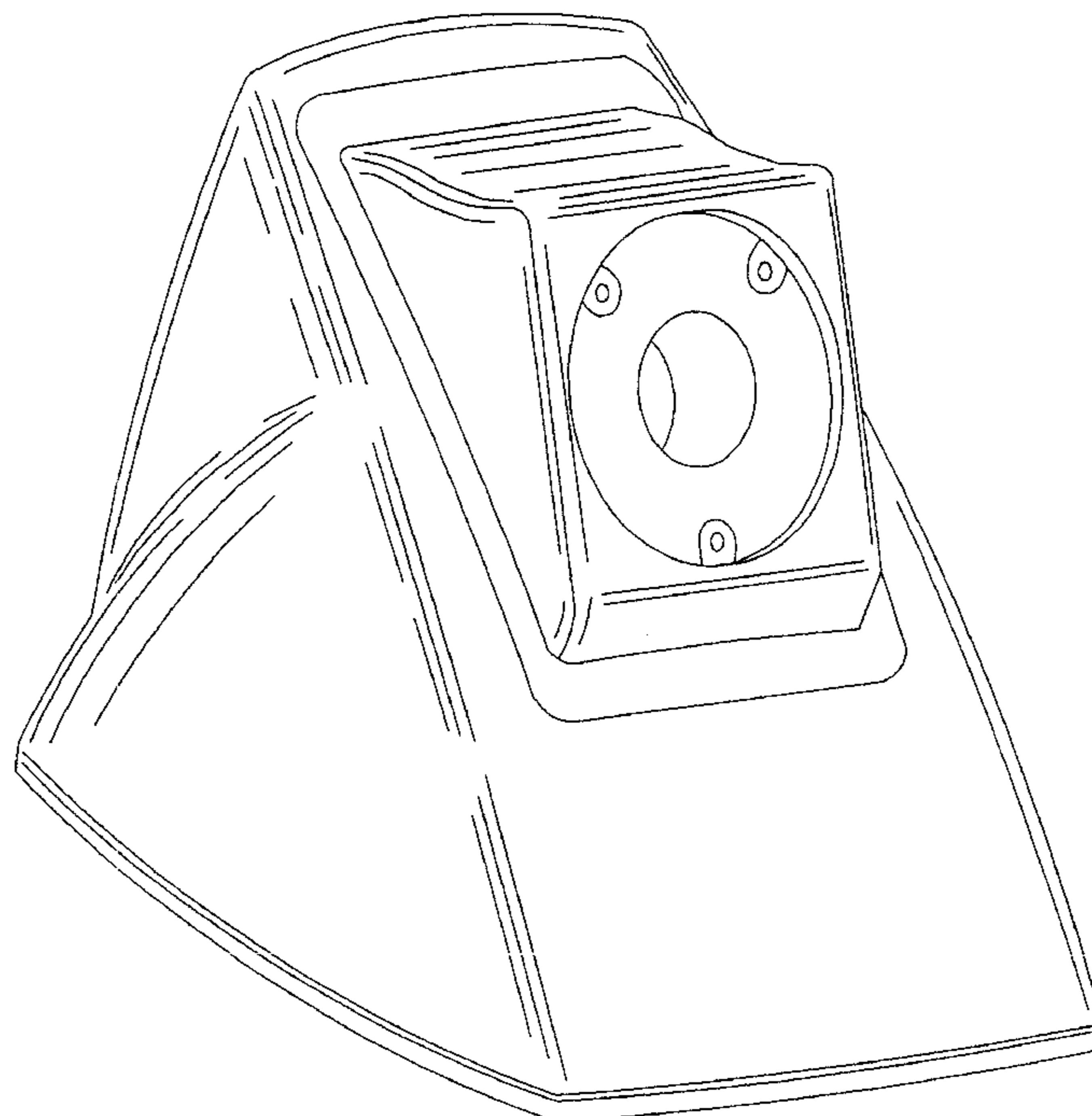
FIG. 5 is a rear view of the microscope tube of our invention.

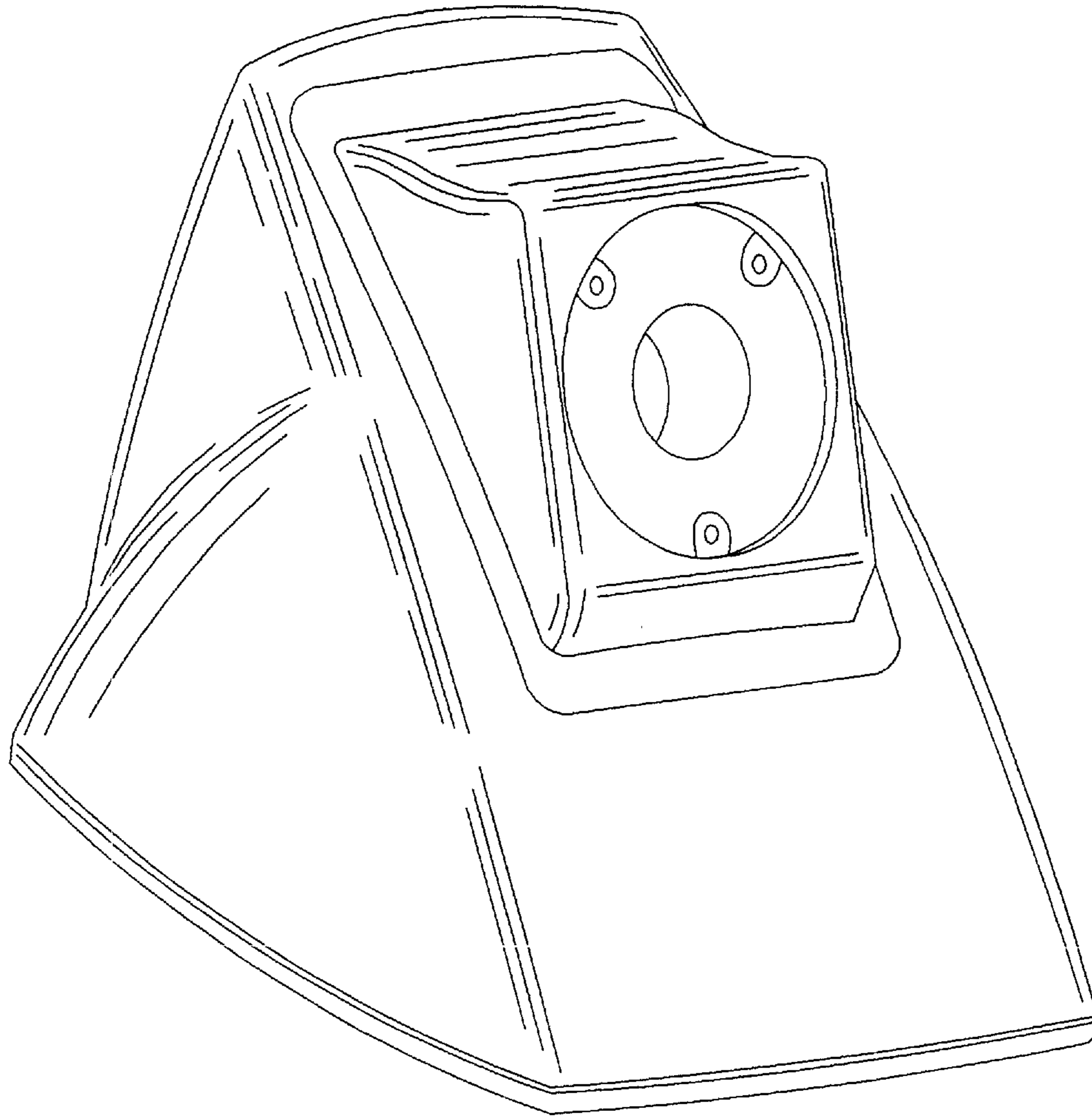

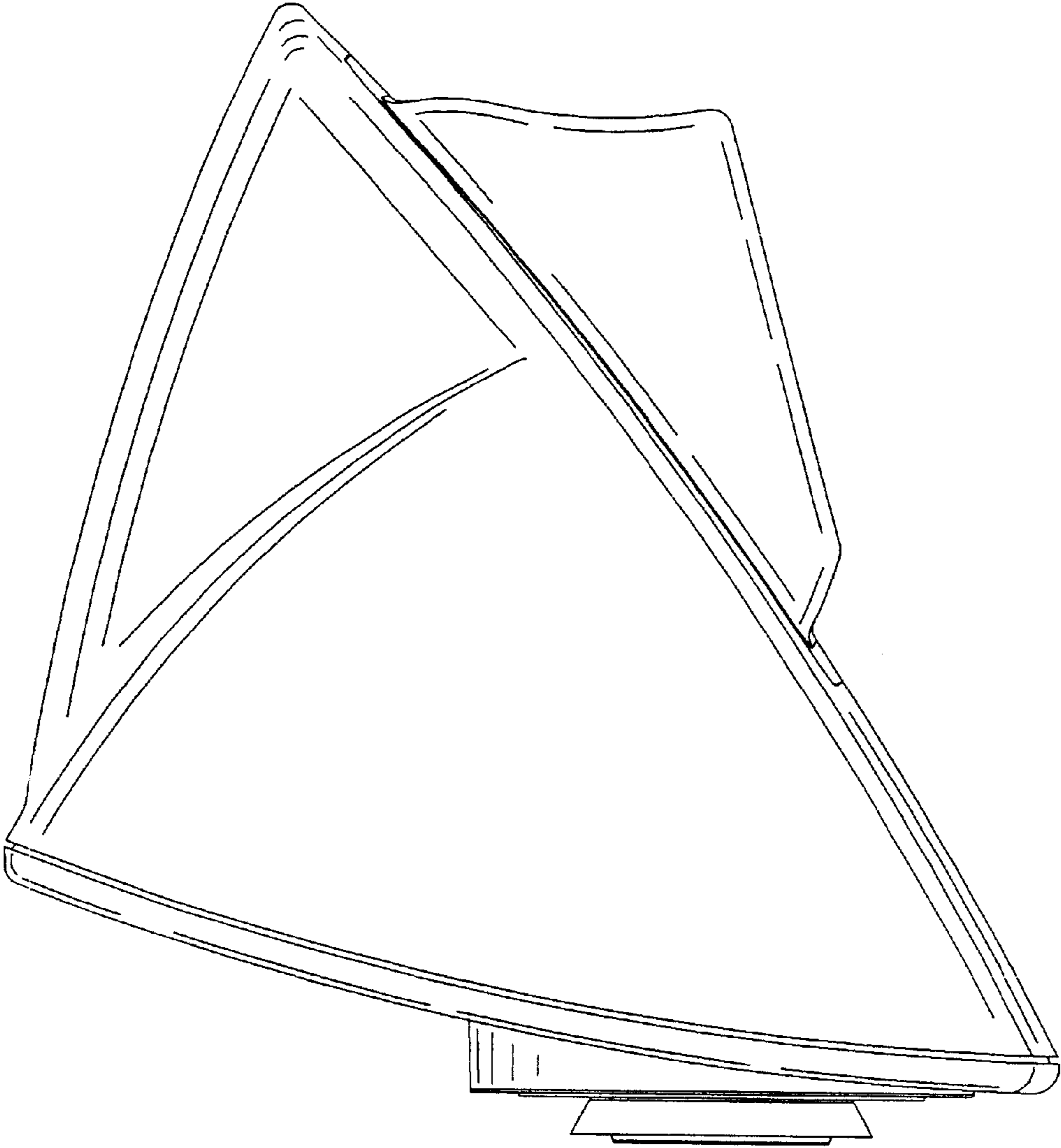

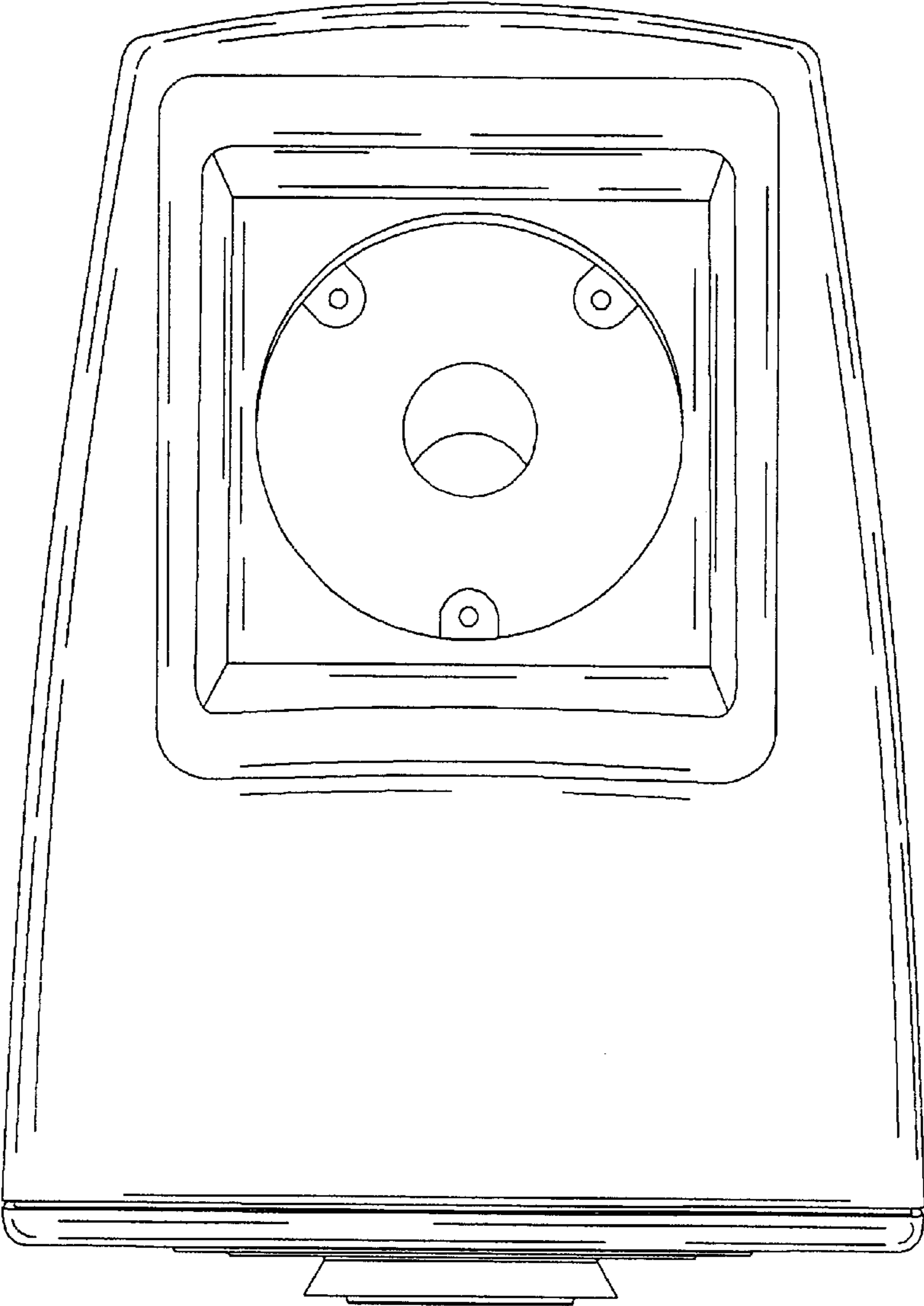

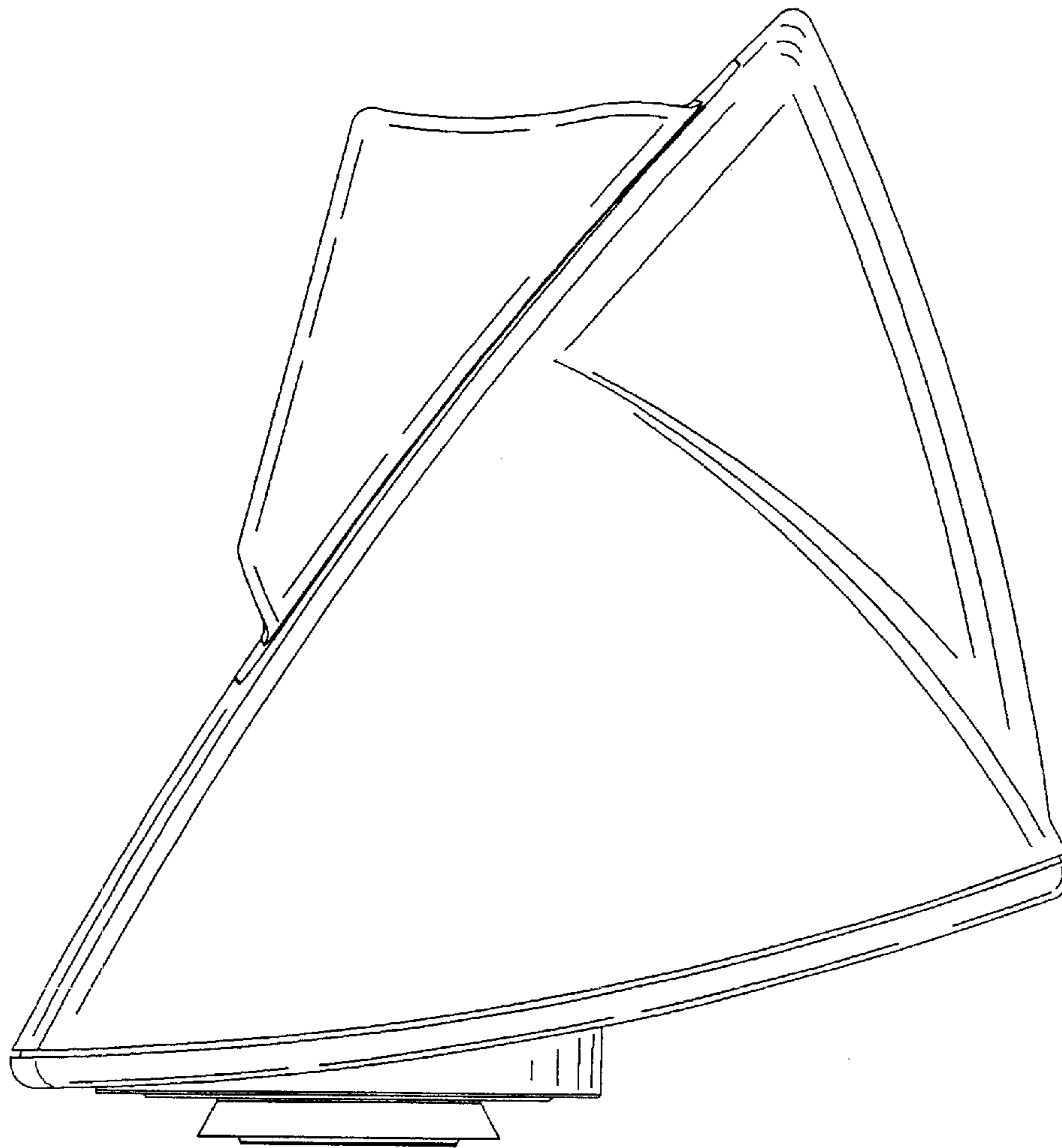

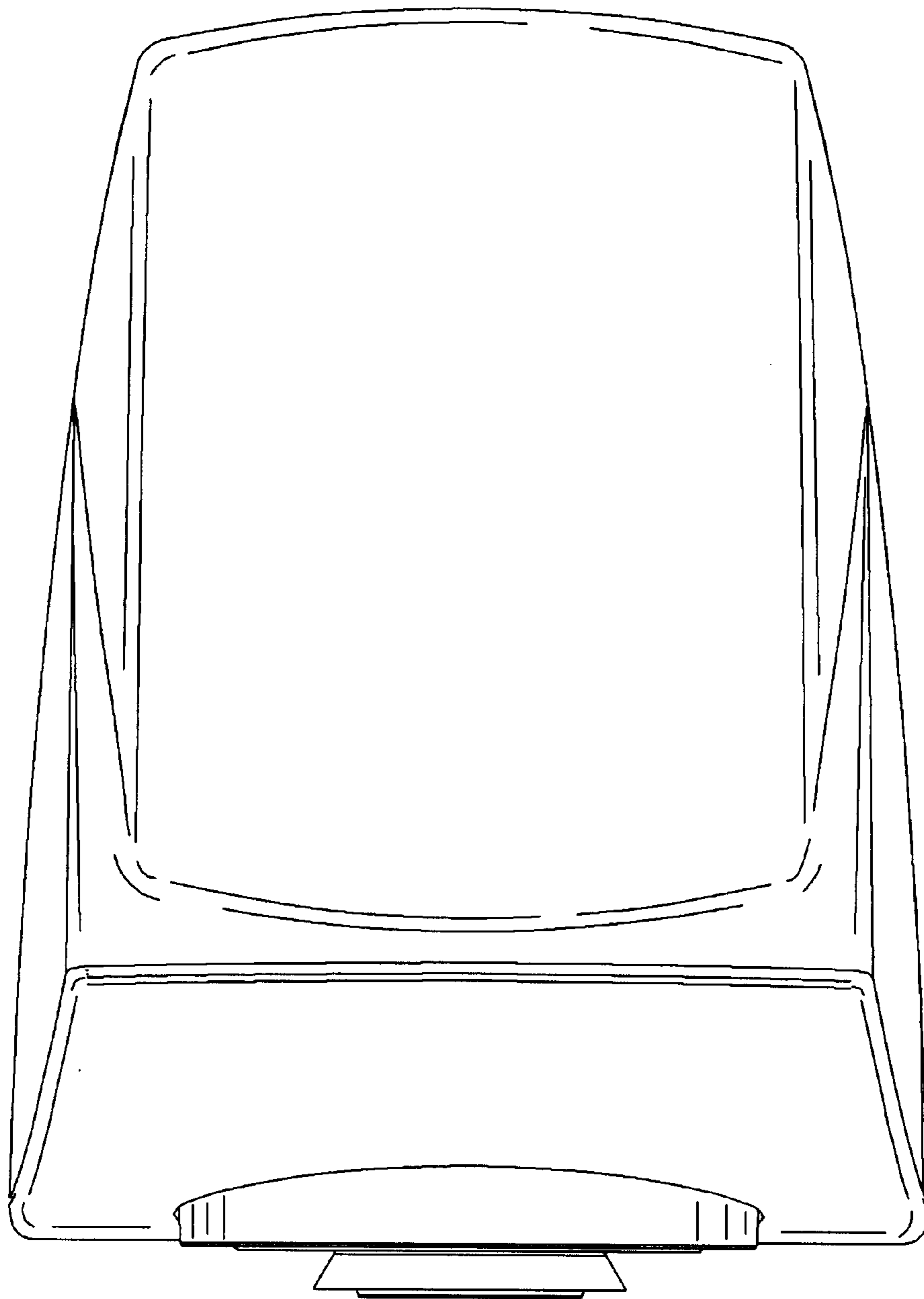

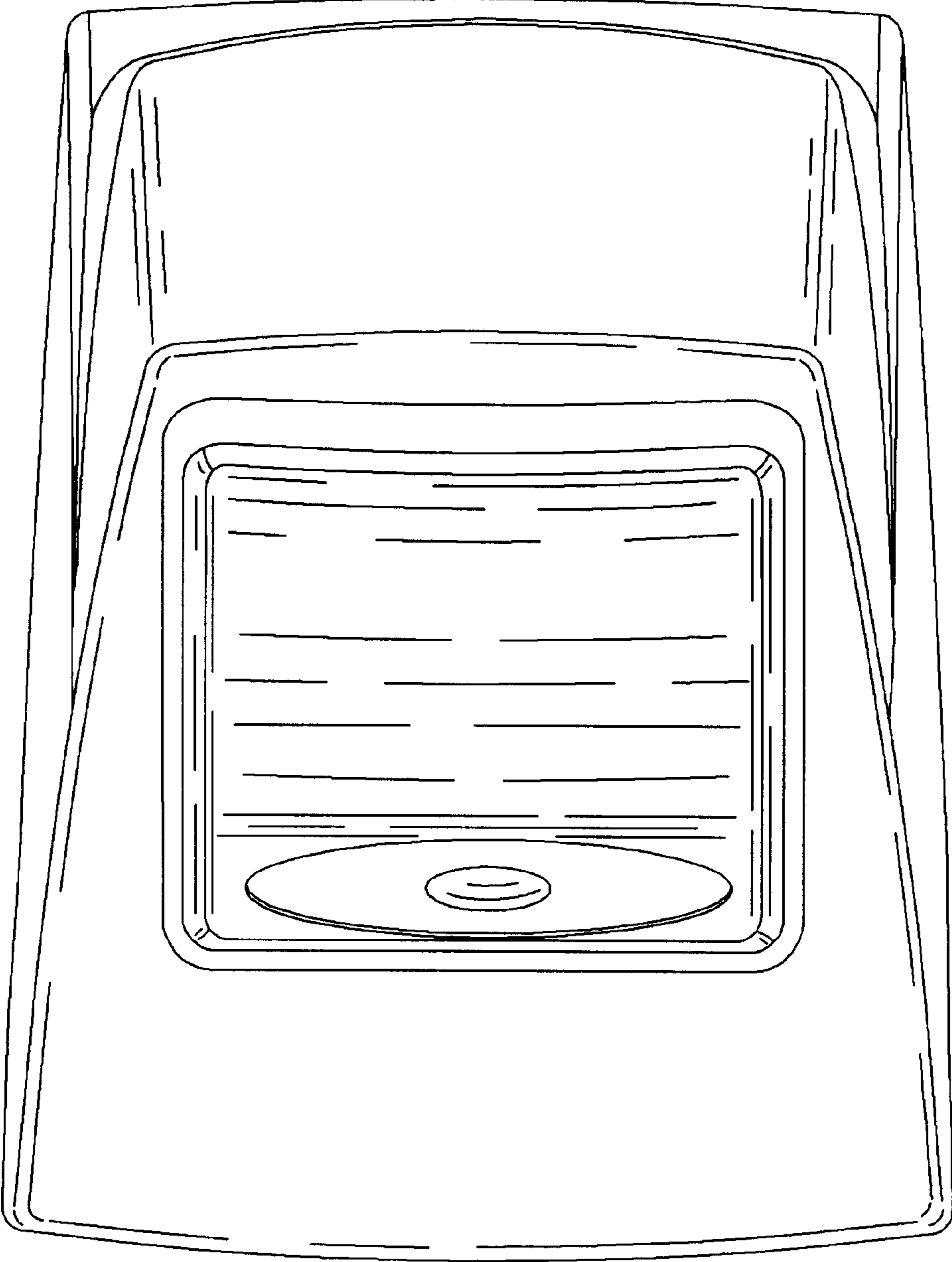

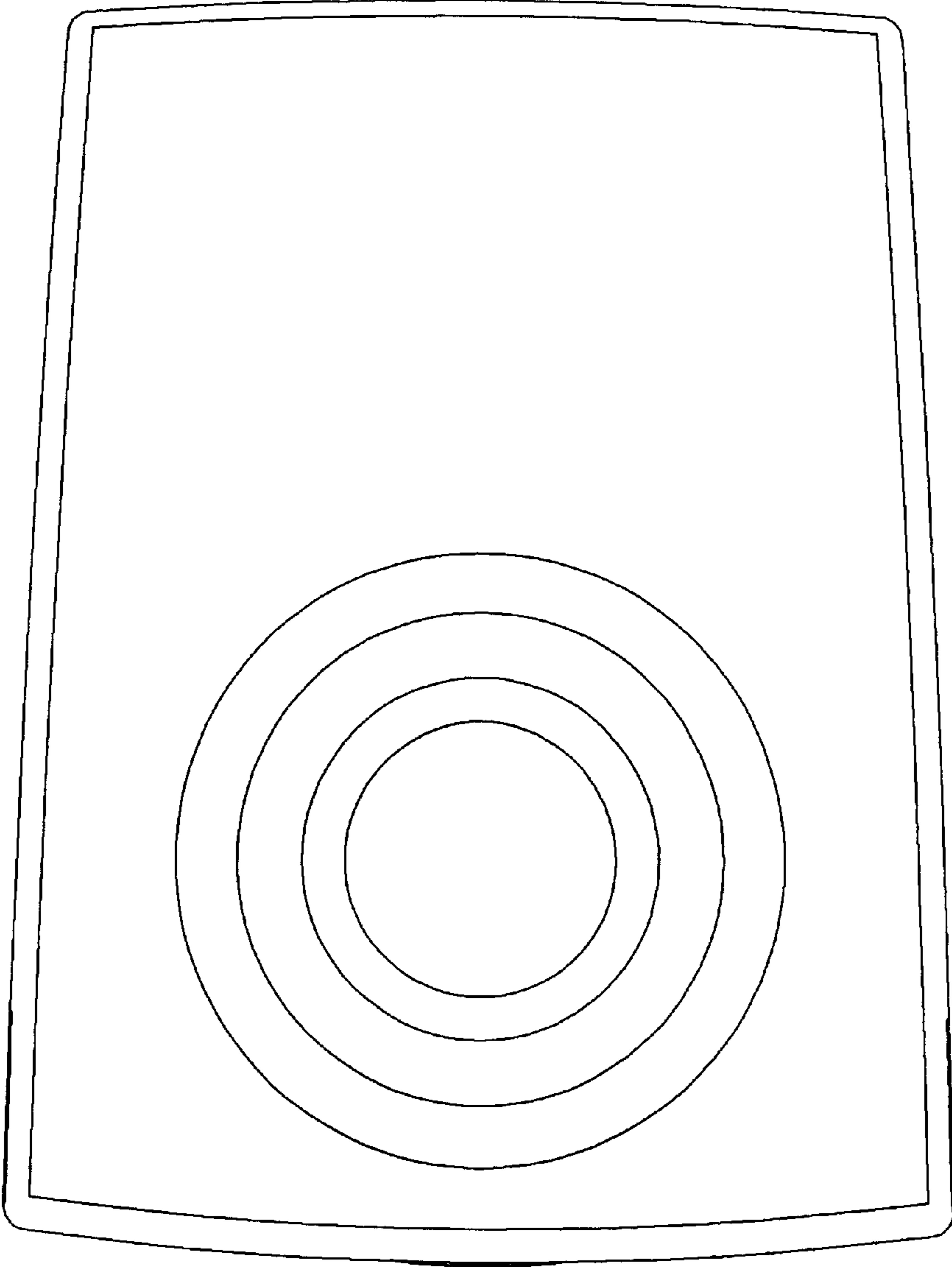

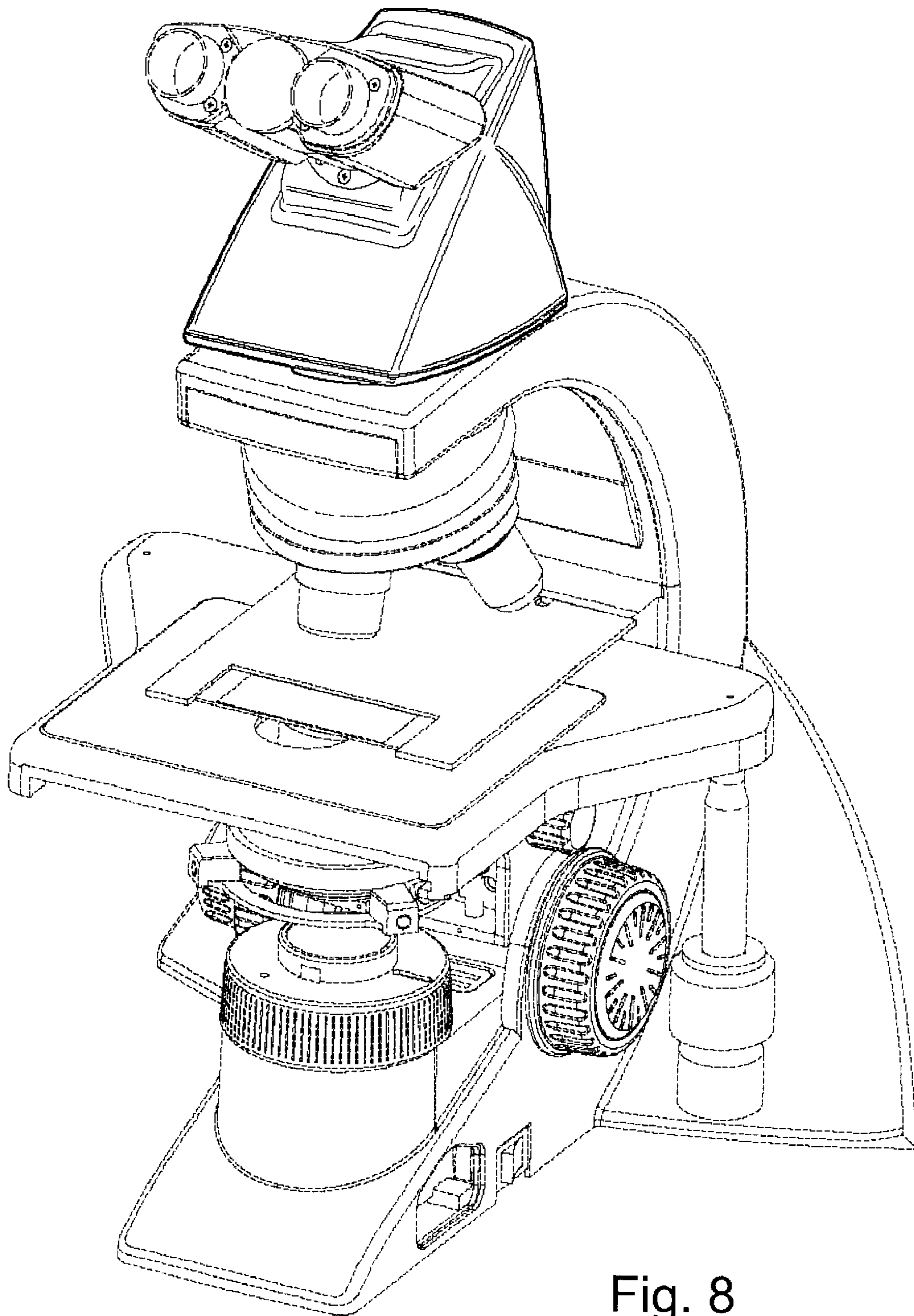
