(57) **CLAIM**

The ornamental design for a white key of an electronic keyboard musical instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a reduced scale front, left side, top perspective view of a white key of an electronic keyboard musical instrument showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an enlarged partial front elevational view thereof;

FIG. 9 is a sectional view of the upper portion taken along line 9—9 in FIG. 8;

FIG. 10 is a sectional view of the upper portion taken along line 10—10 in FIG. 8;

FIG. 11 is a sectional view of the upper portion taken along line 11—11 in FIG. 8;

FIG. 12 is a sectional view of the upper portion taken along line 12—12 in FIG. 8;

FIG. 13 is a sectional view of the upper portion taken along line 13—13 in FIG. 8;

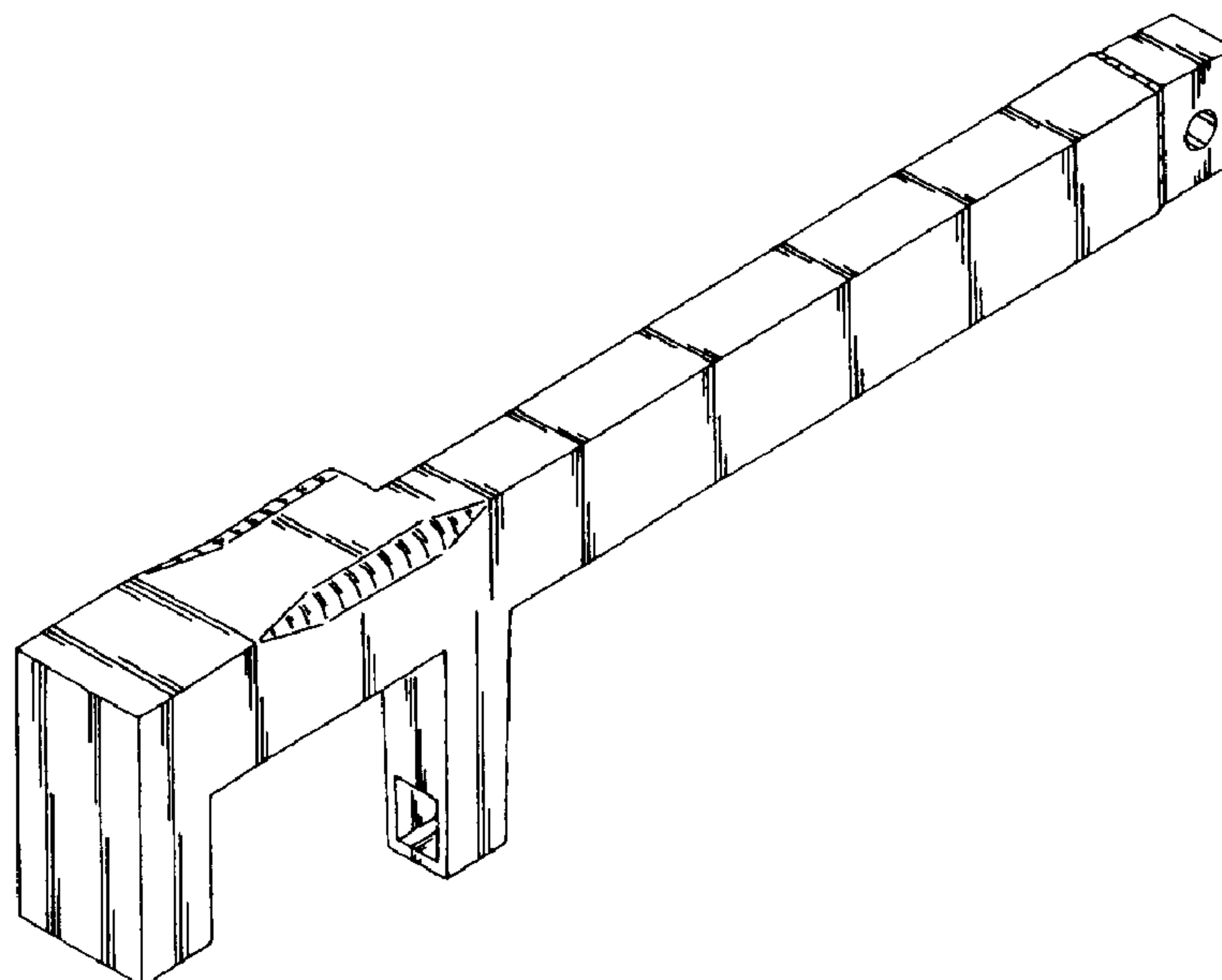
FIG. 14 is a sectional view of the upper portion taken along line 14—14 in FIG. 8;

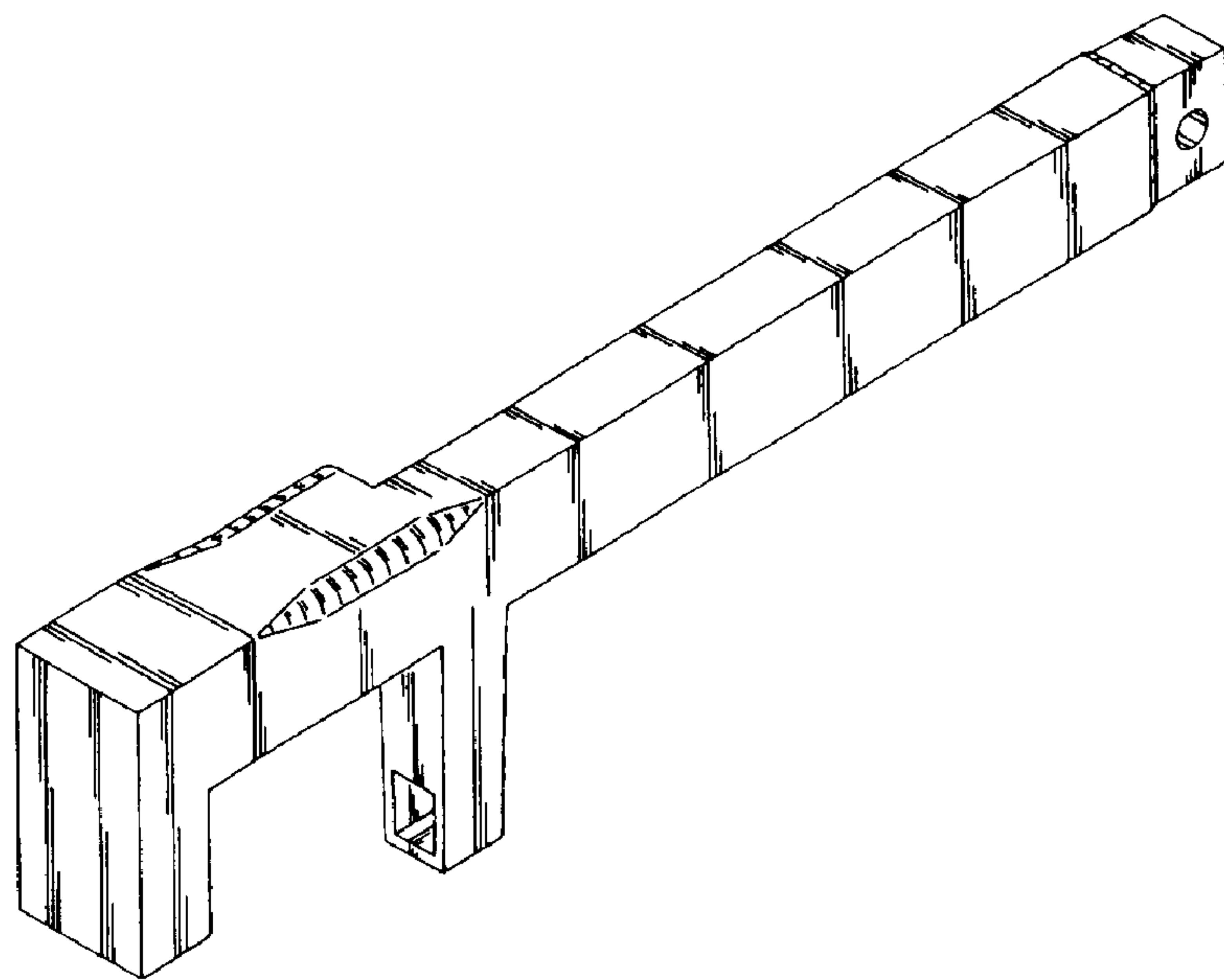

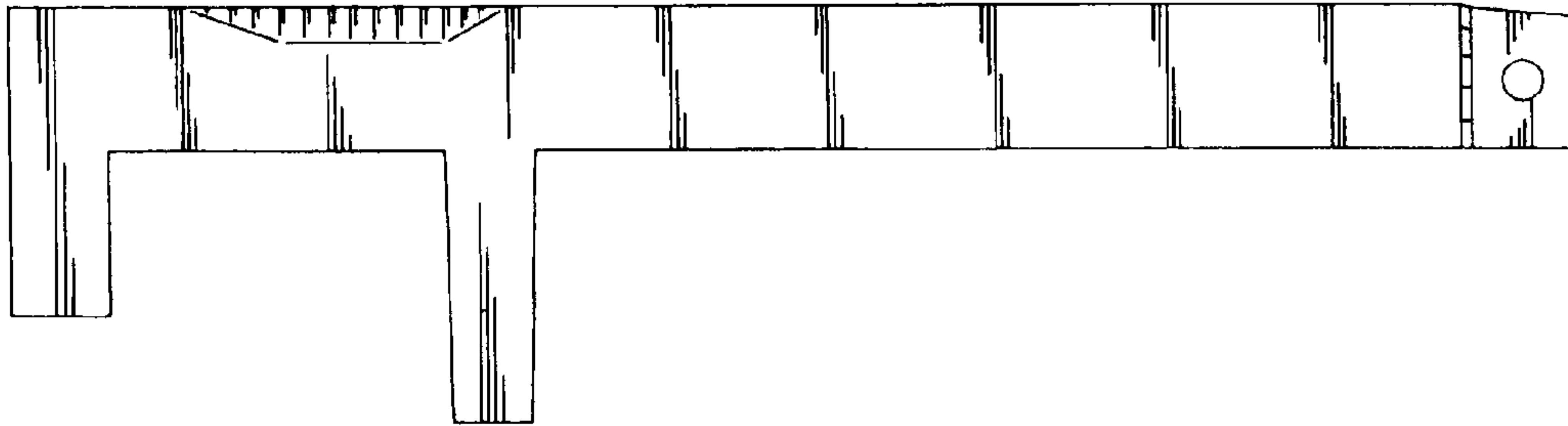

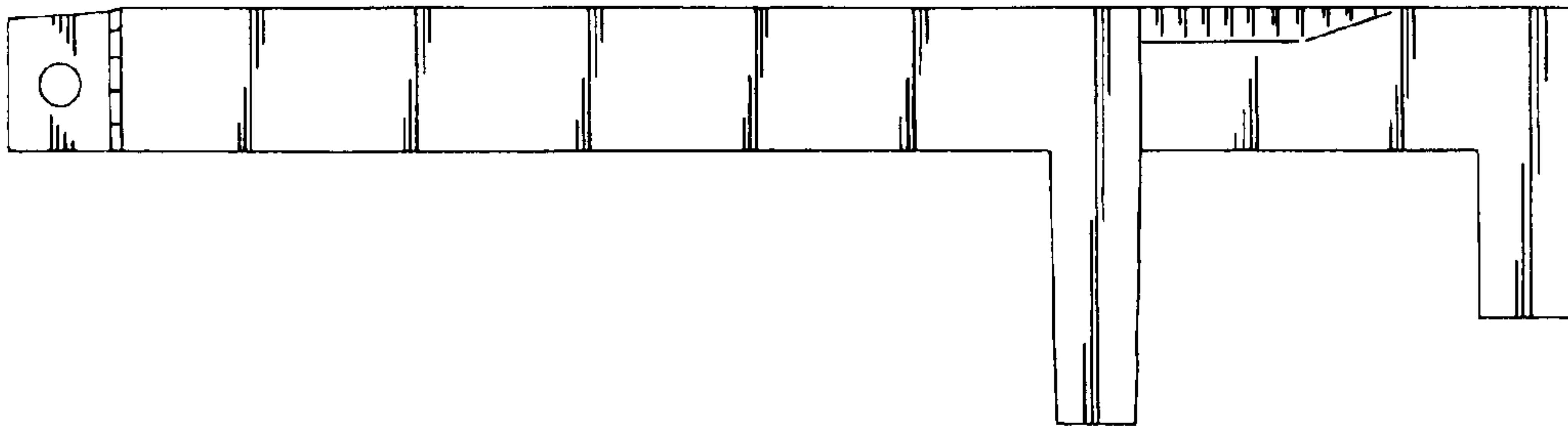

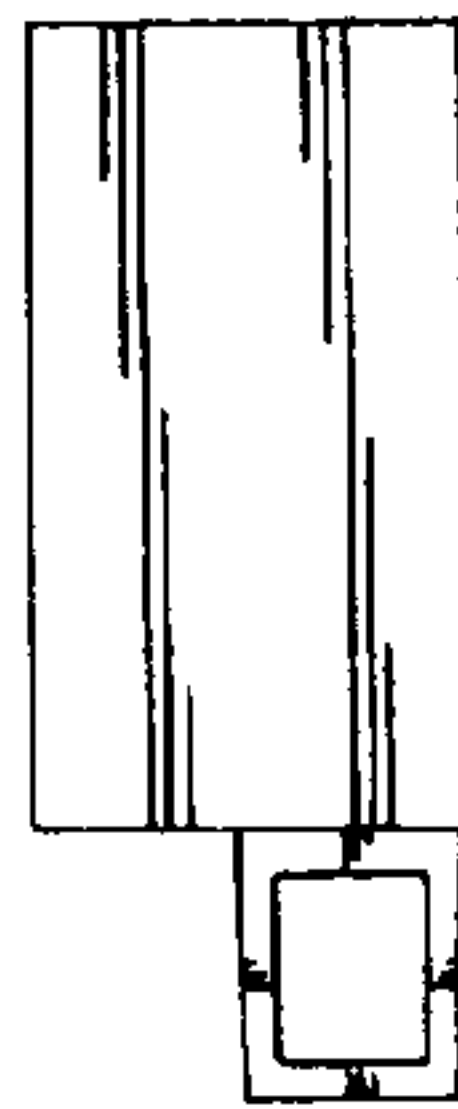

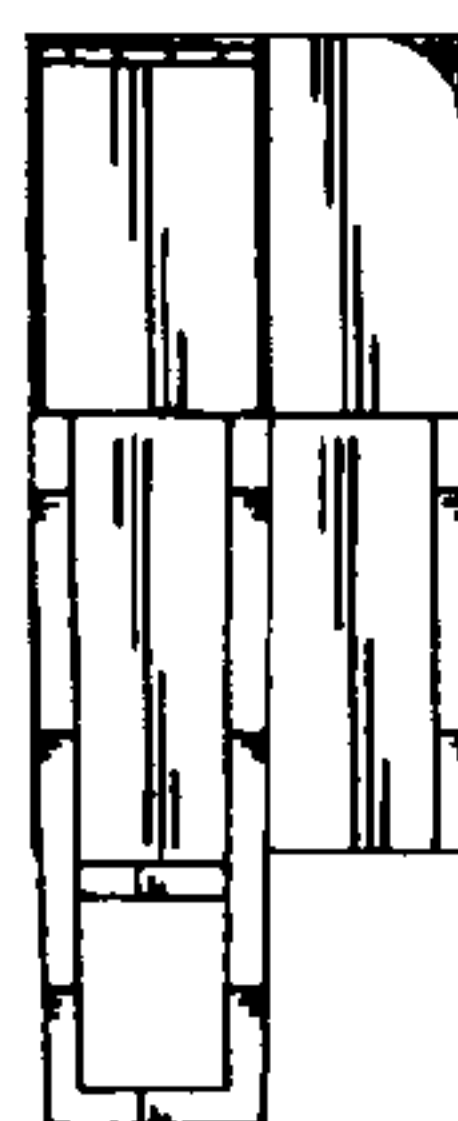

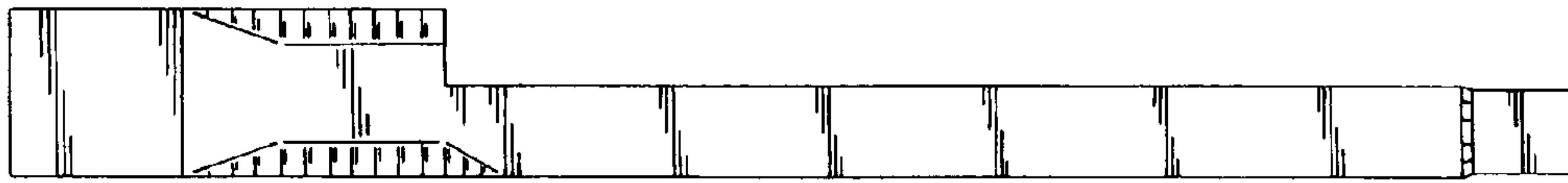

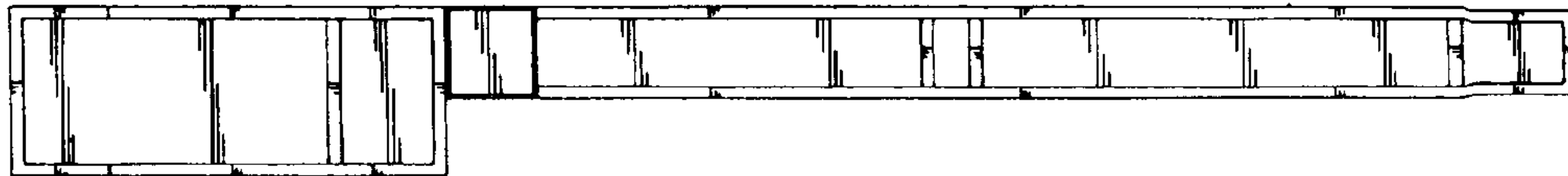

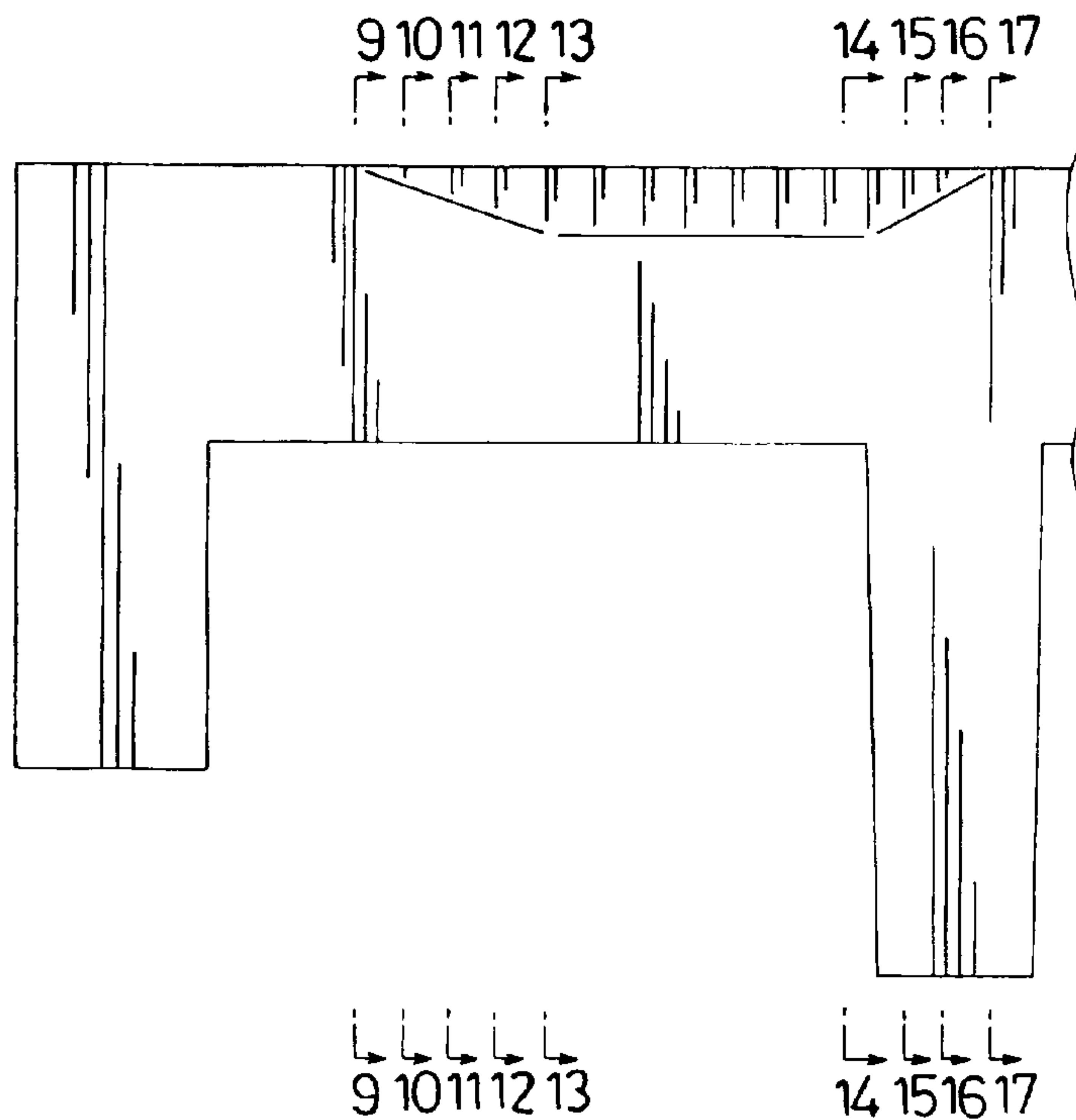
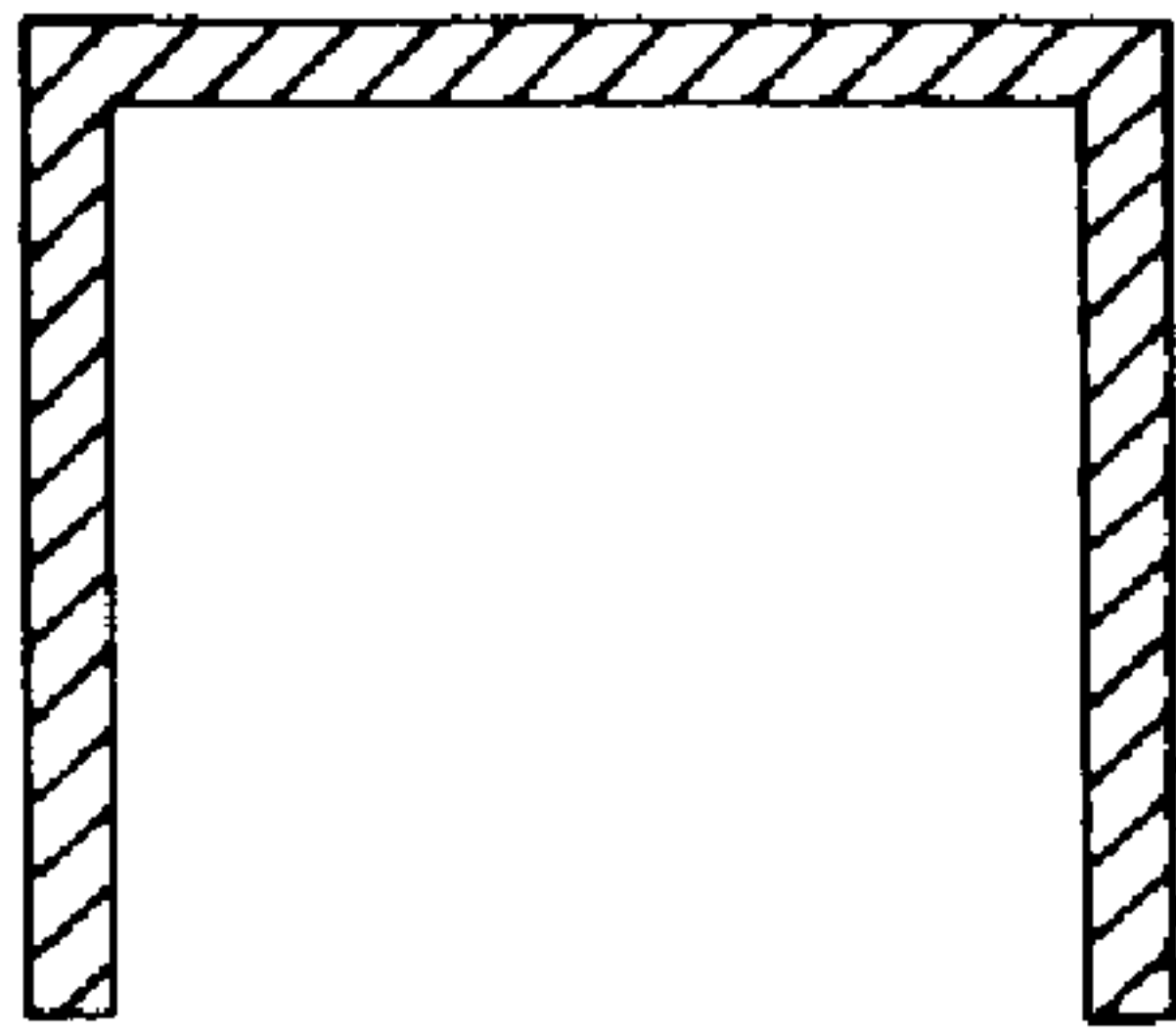
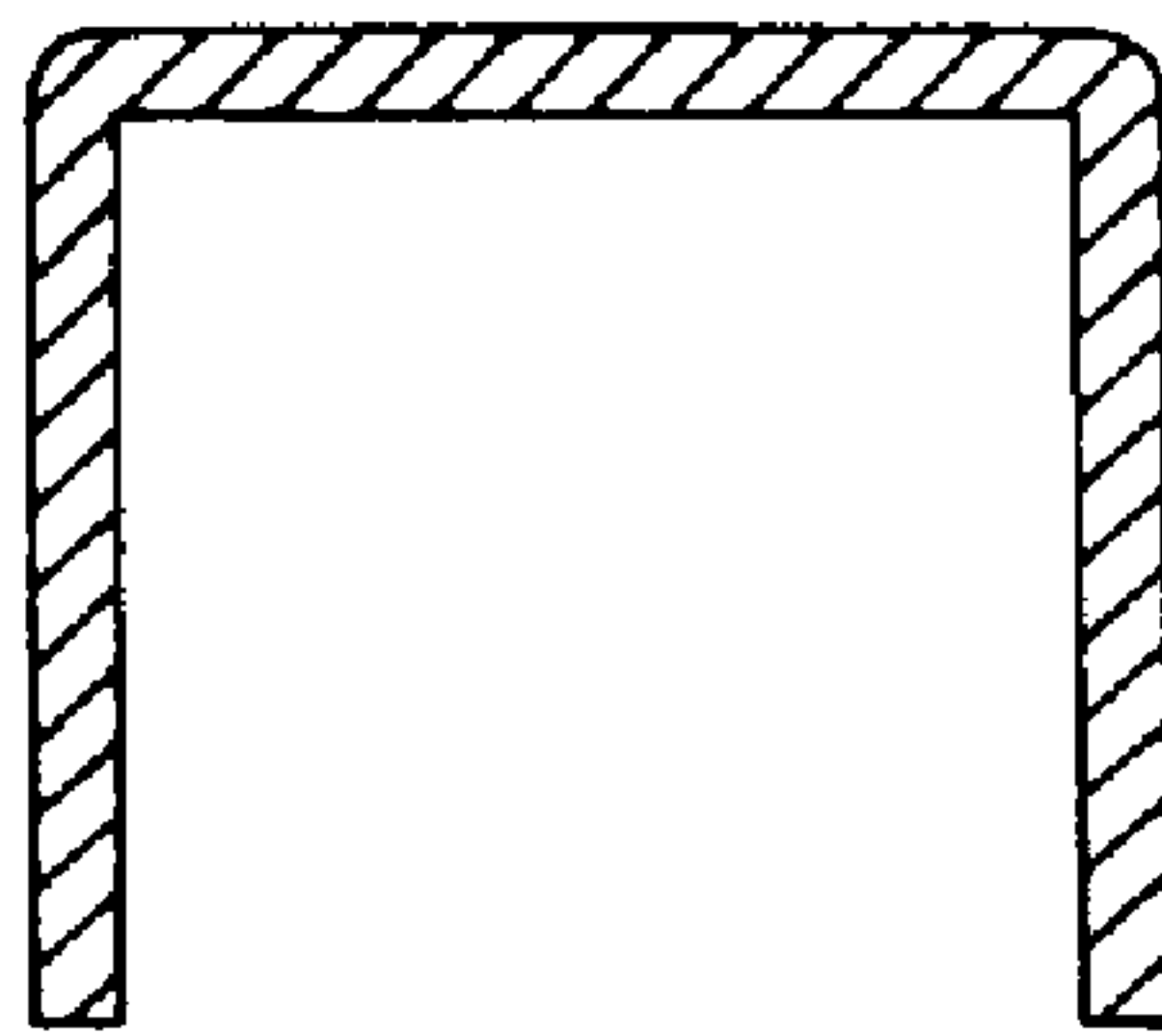

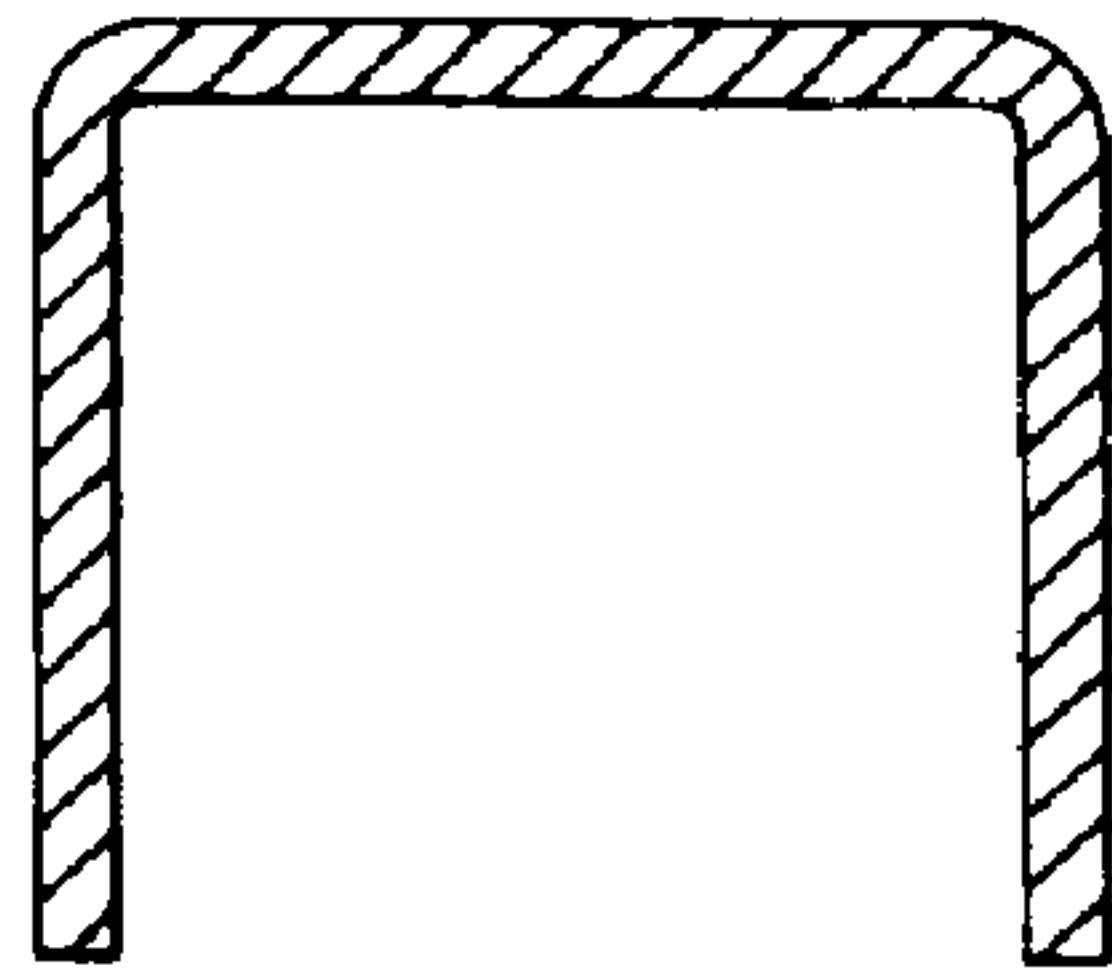

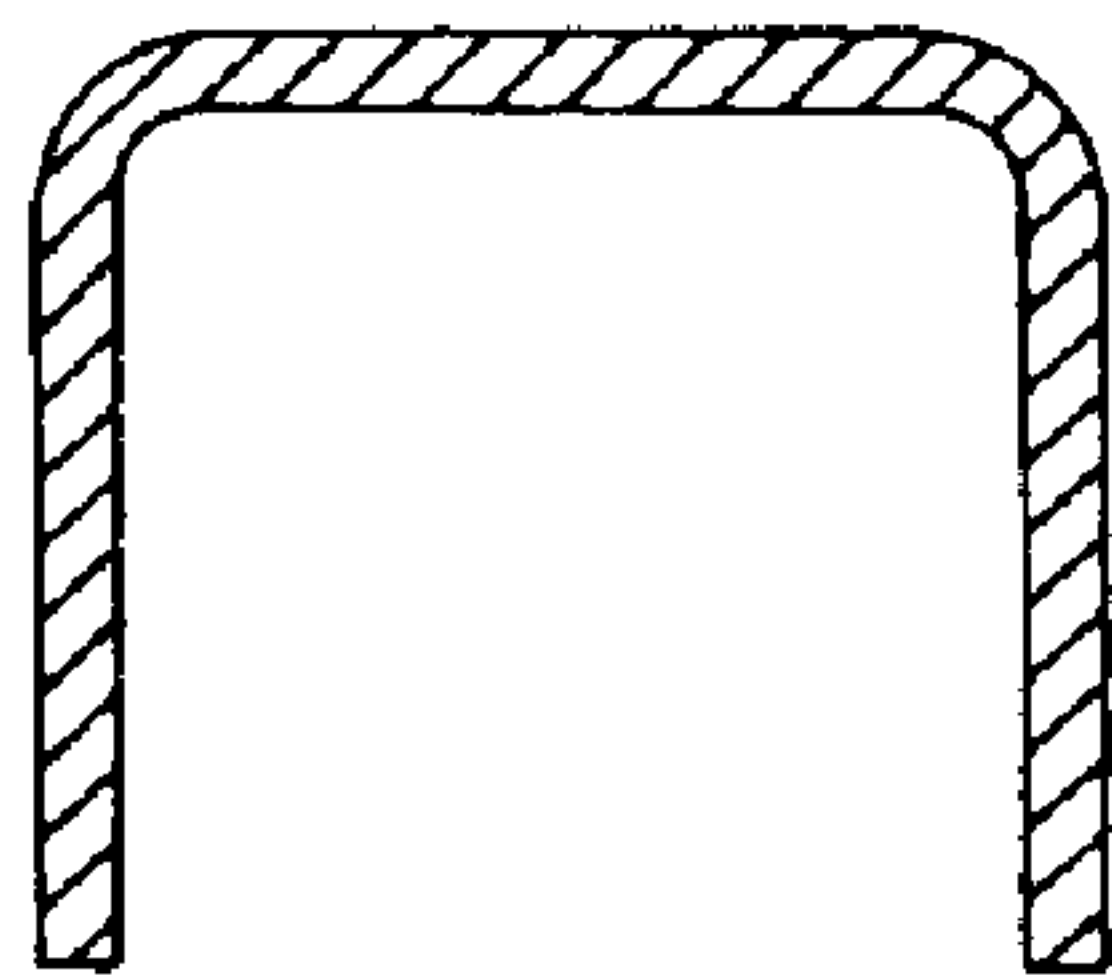

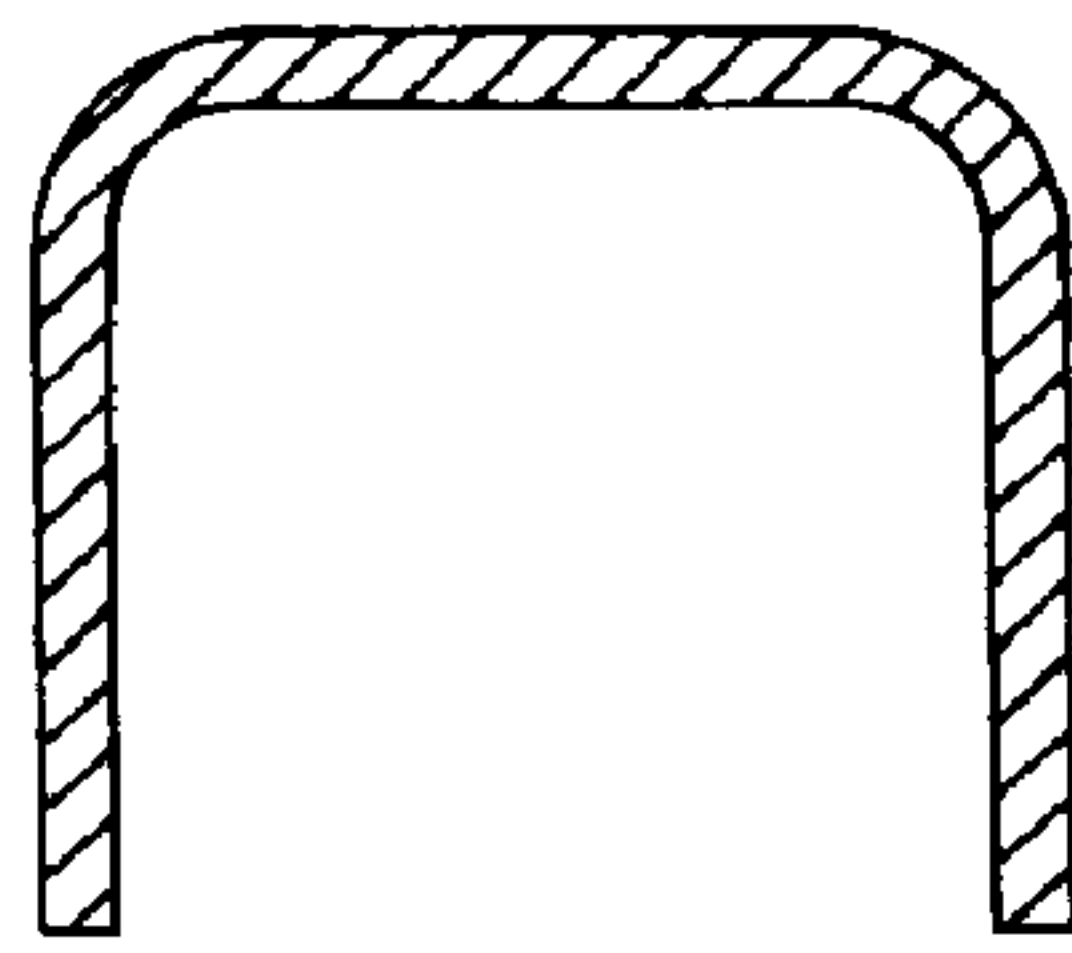

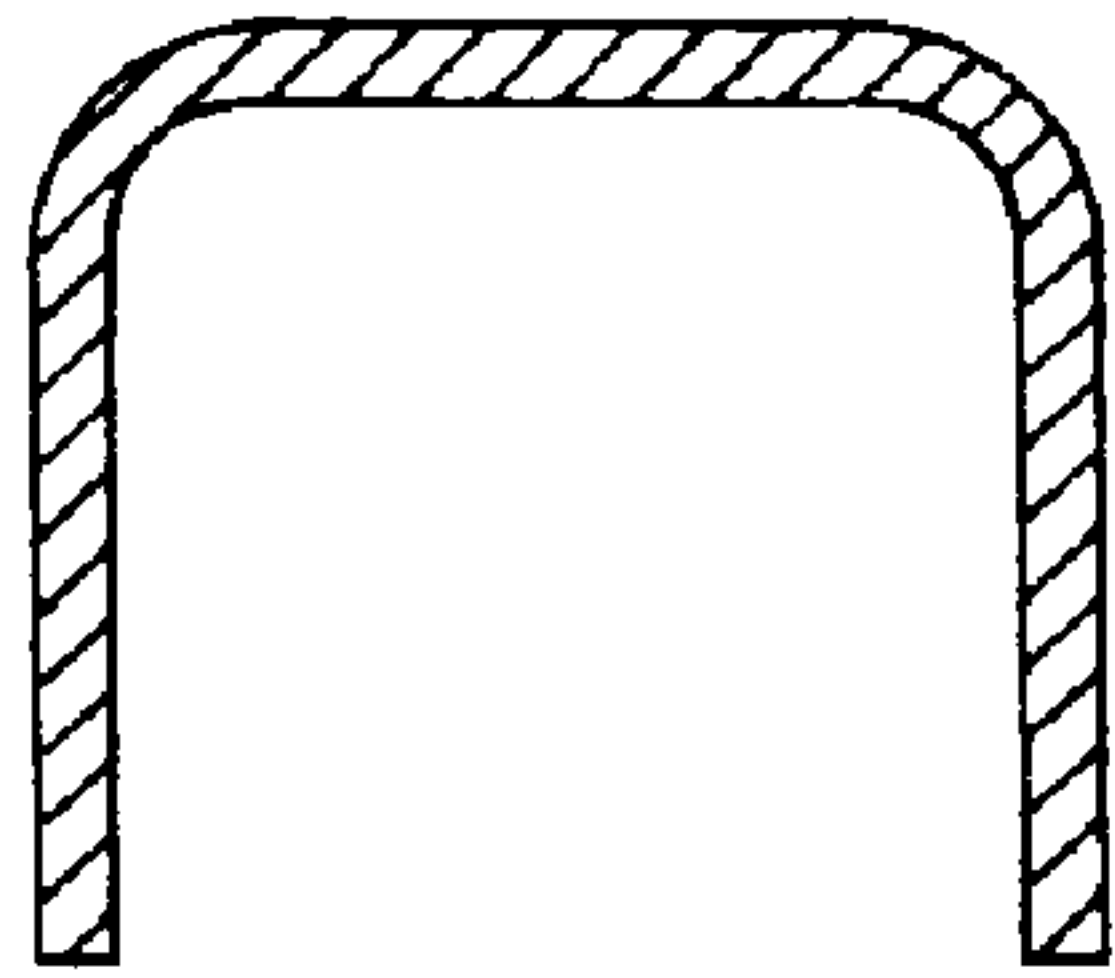

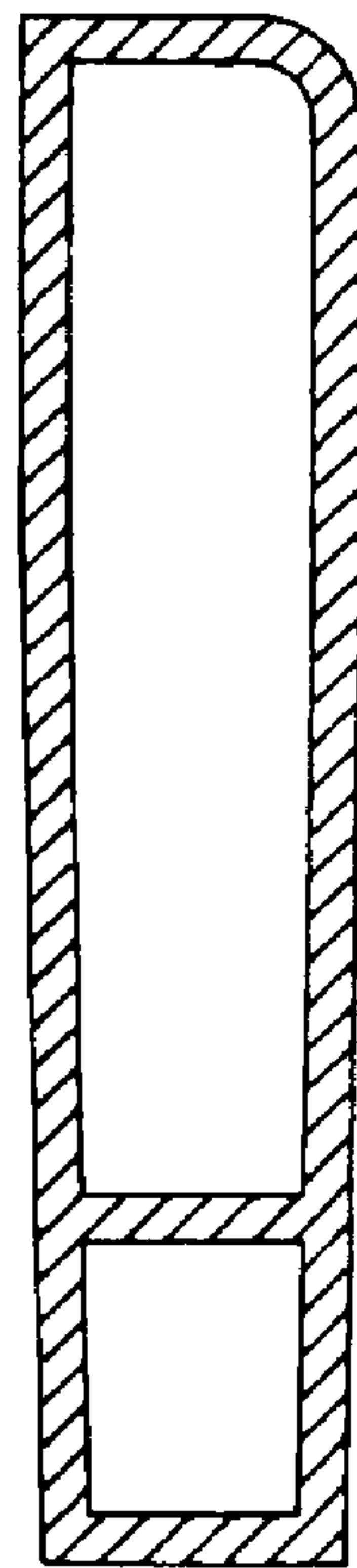

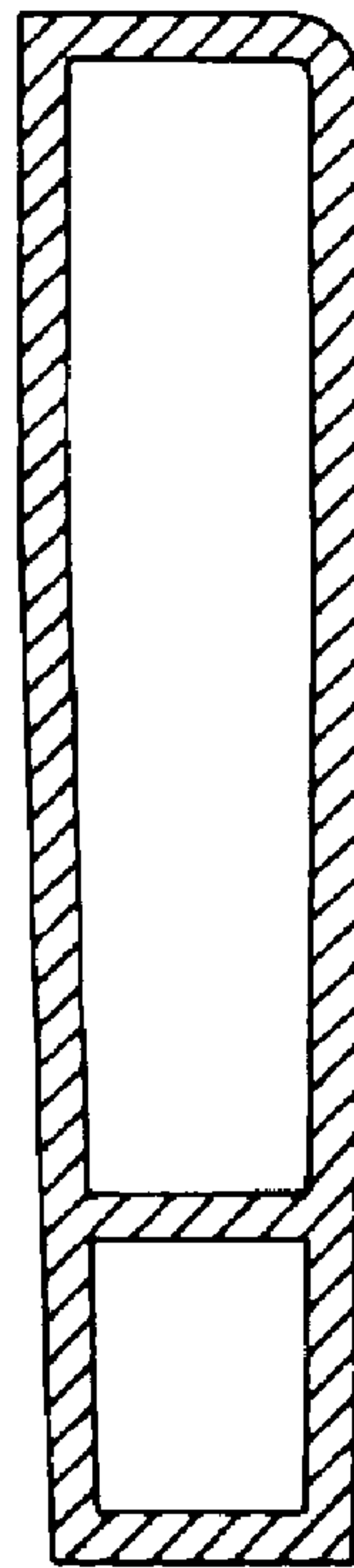

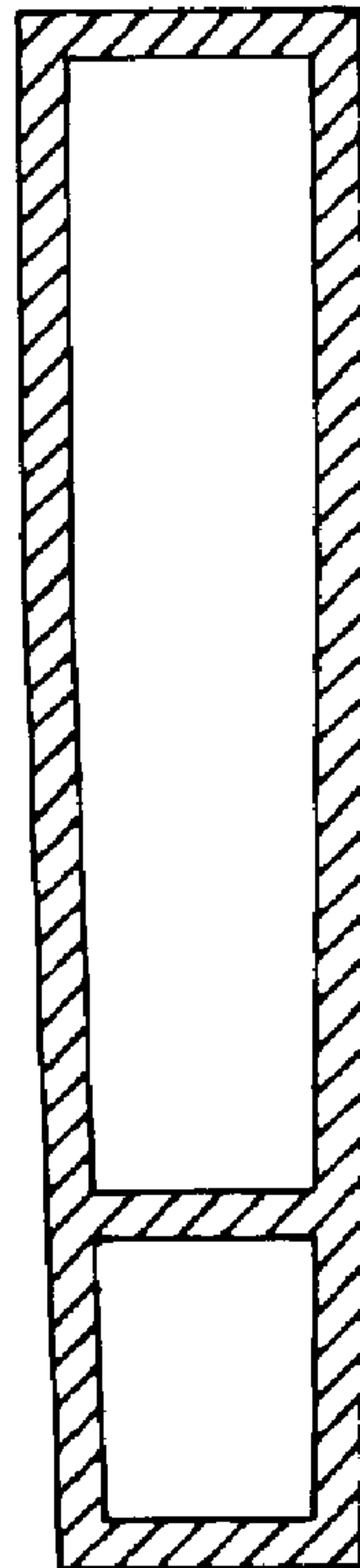
