FIG. 1 is a color drawing of the top plan view of the face of a credit card showing my new design wherein the top face surface is divided into four colored regions in which adjacent regions are differently colored as shown by the shading signifying dark blue (Pantone Matching System Color No. PMS 289), grey (Pantone Matching System Color No. PMS Cool Gray 3), light blue (Pantone Matching System Color No. PMS 7461), and silver (Crown Foil 422 with BW-88 Release) colors.

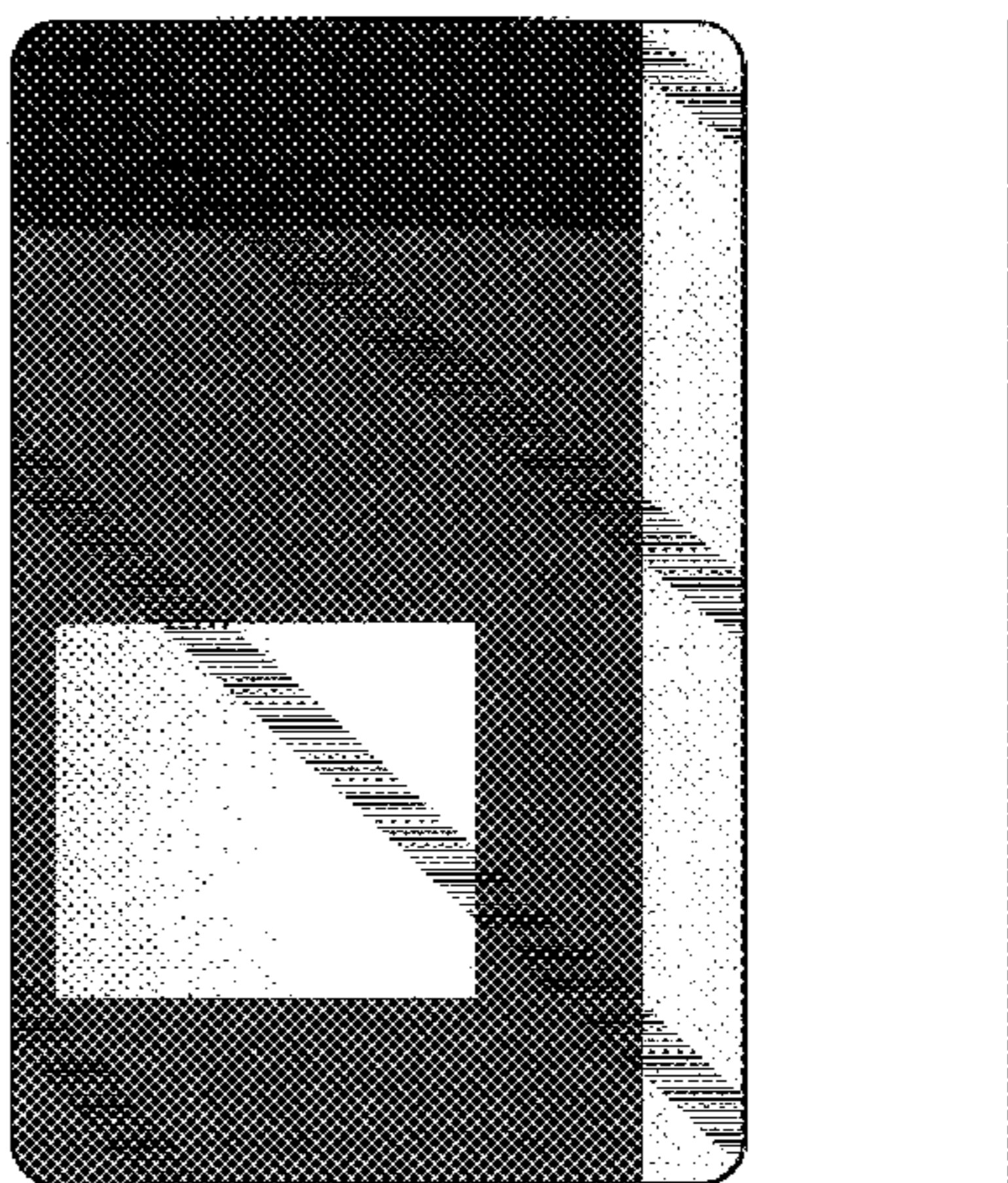
FIG. 2 is a front elevational view thereof, with the rear elevational view being identical to FIG. 2.

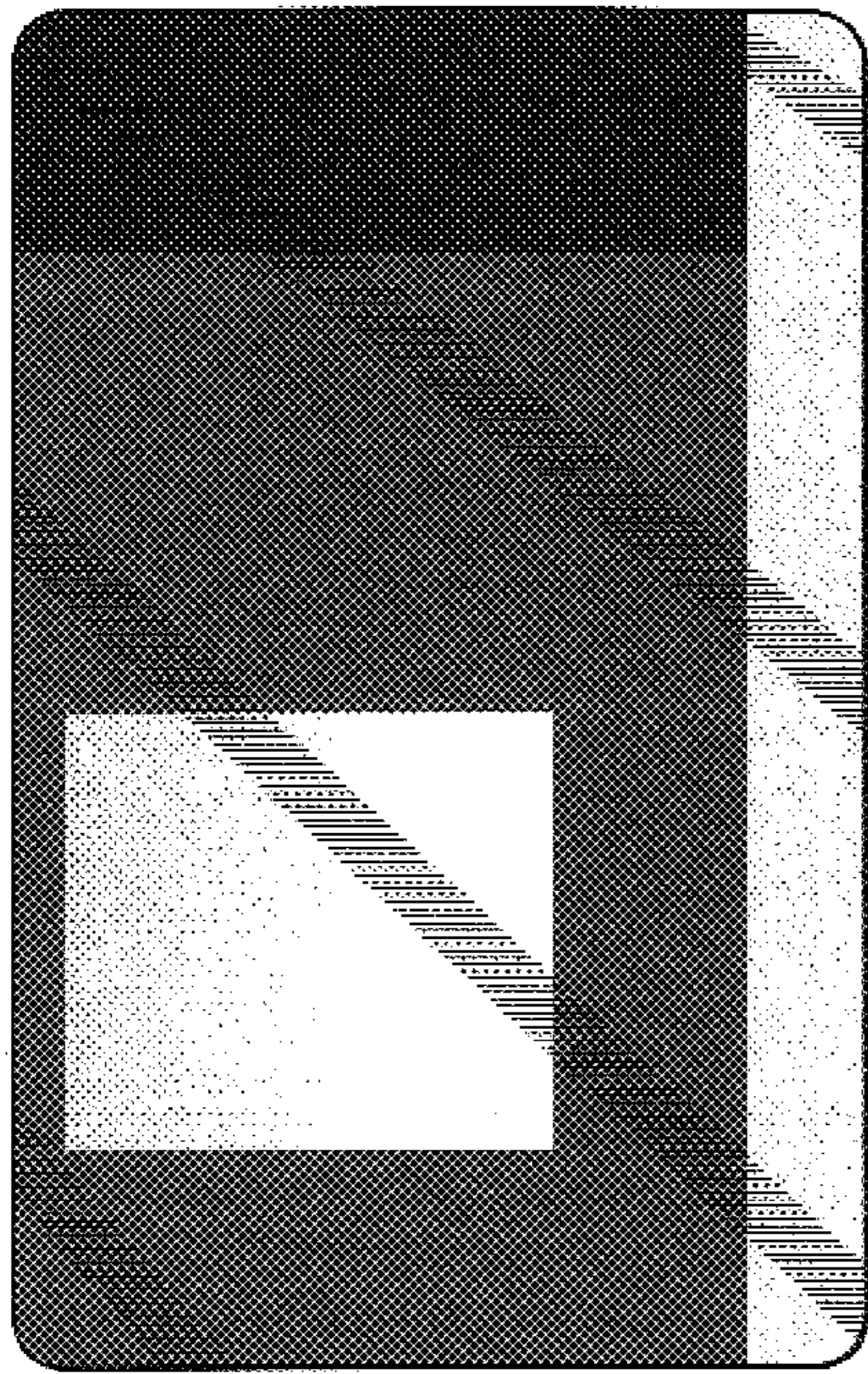

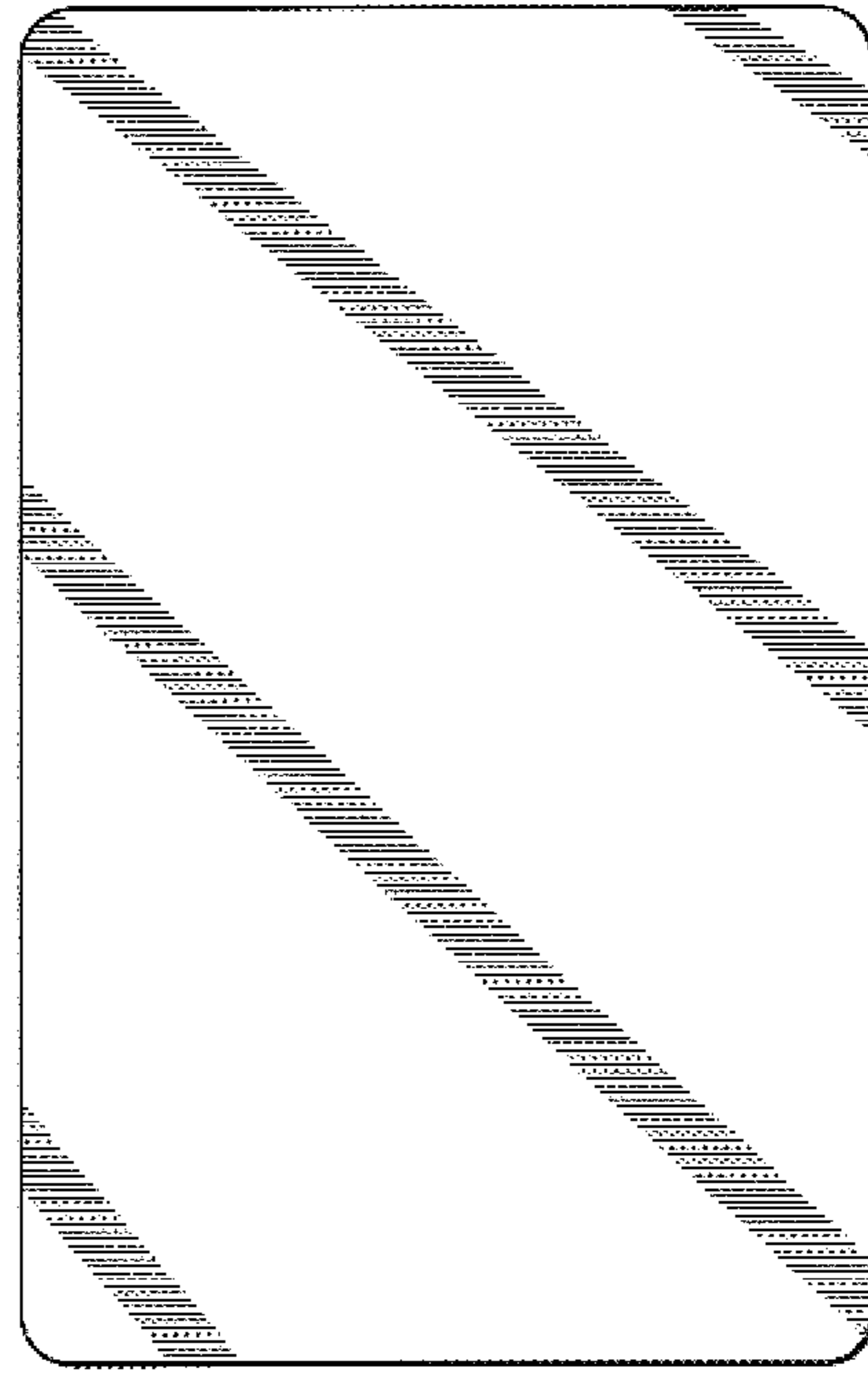
