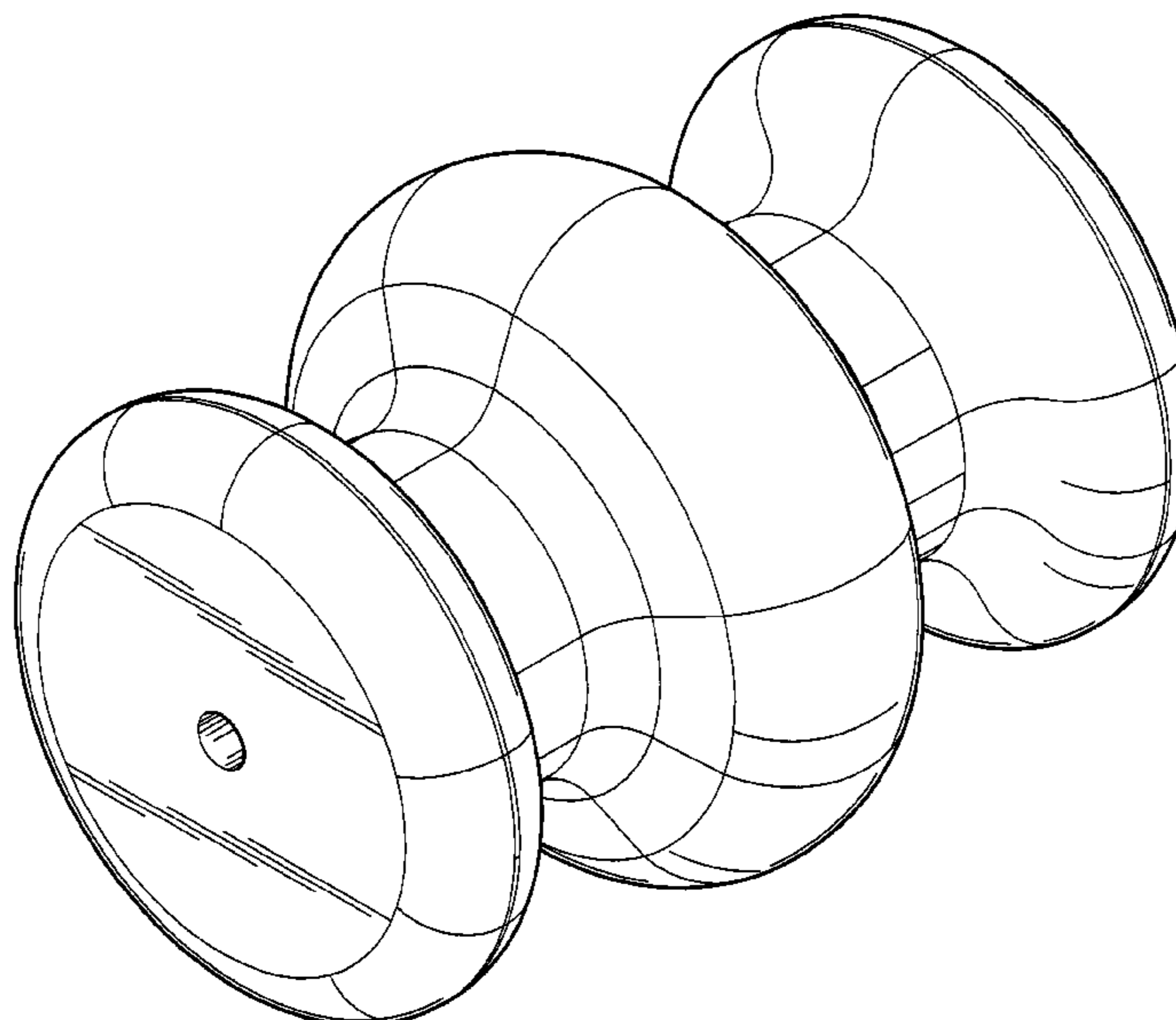
(57) **CLAIM**

I claim, the ornamental design for a wheel, as shown and described.

DESCRIPTION

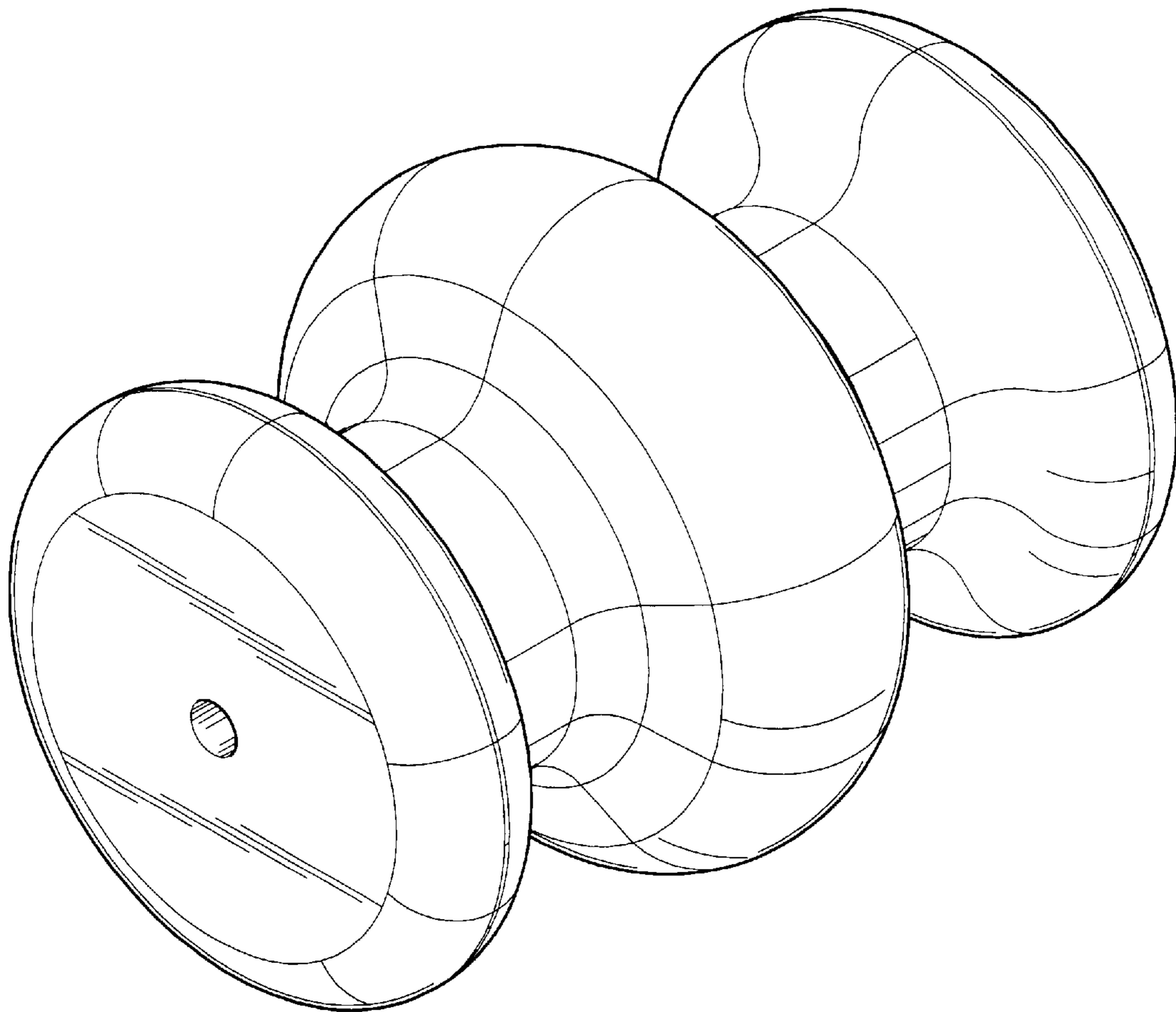

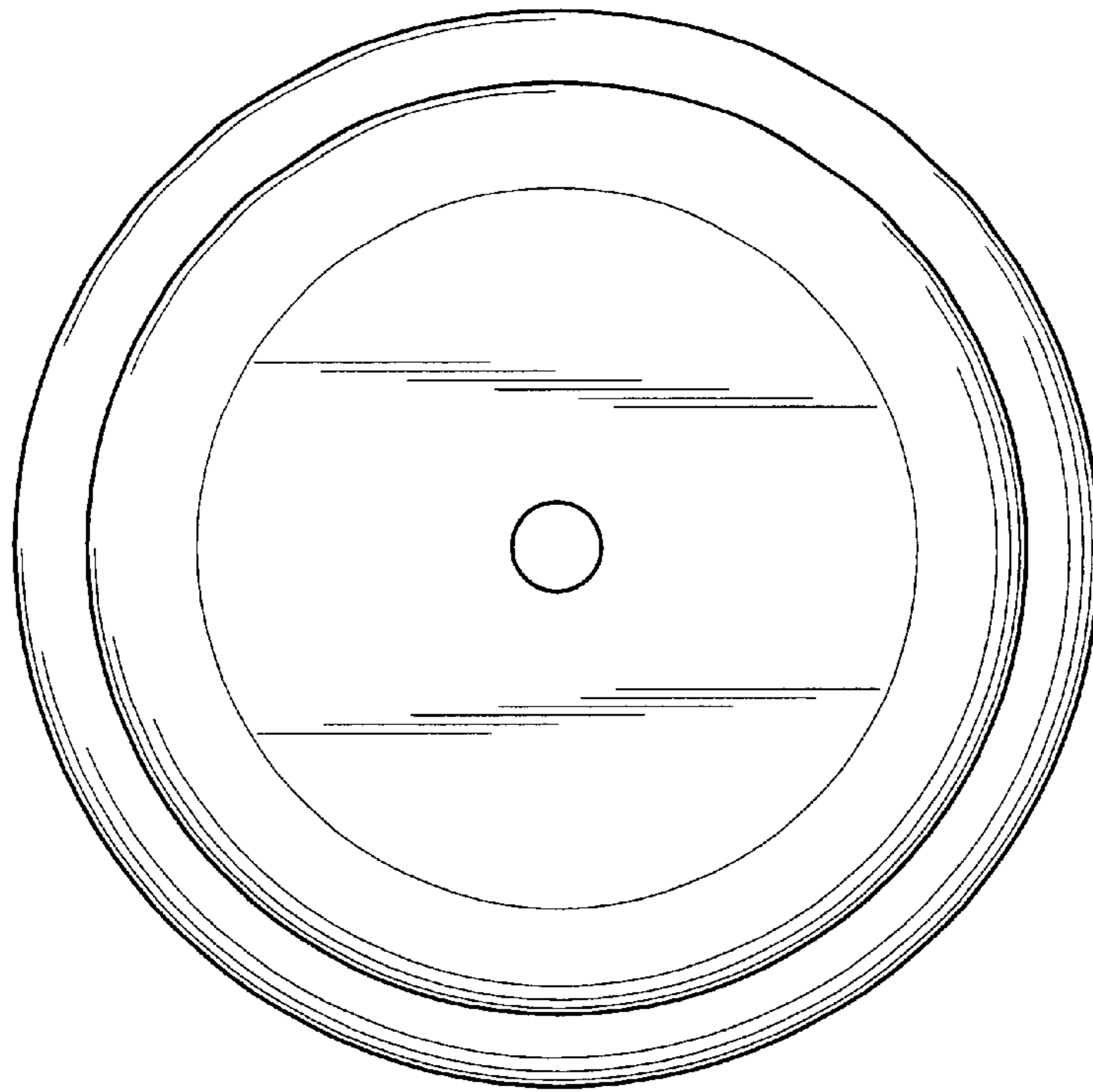

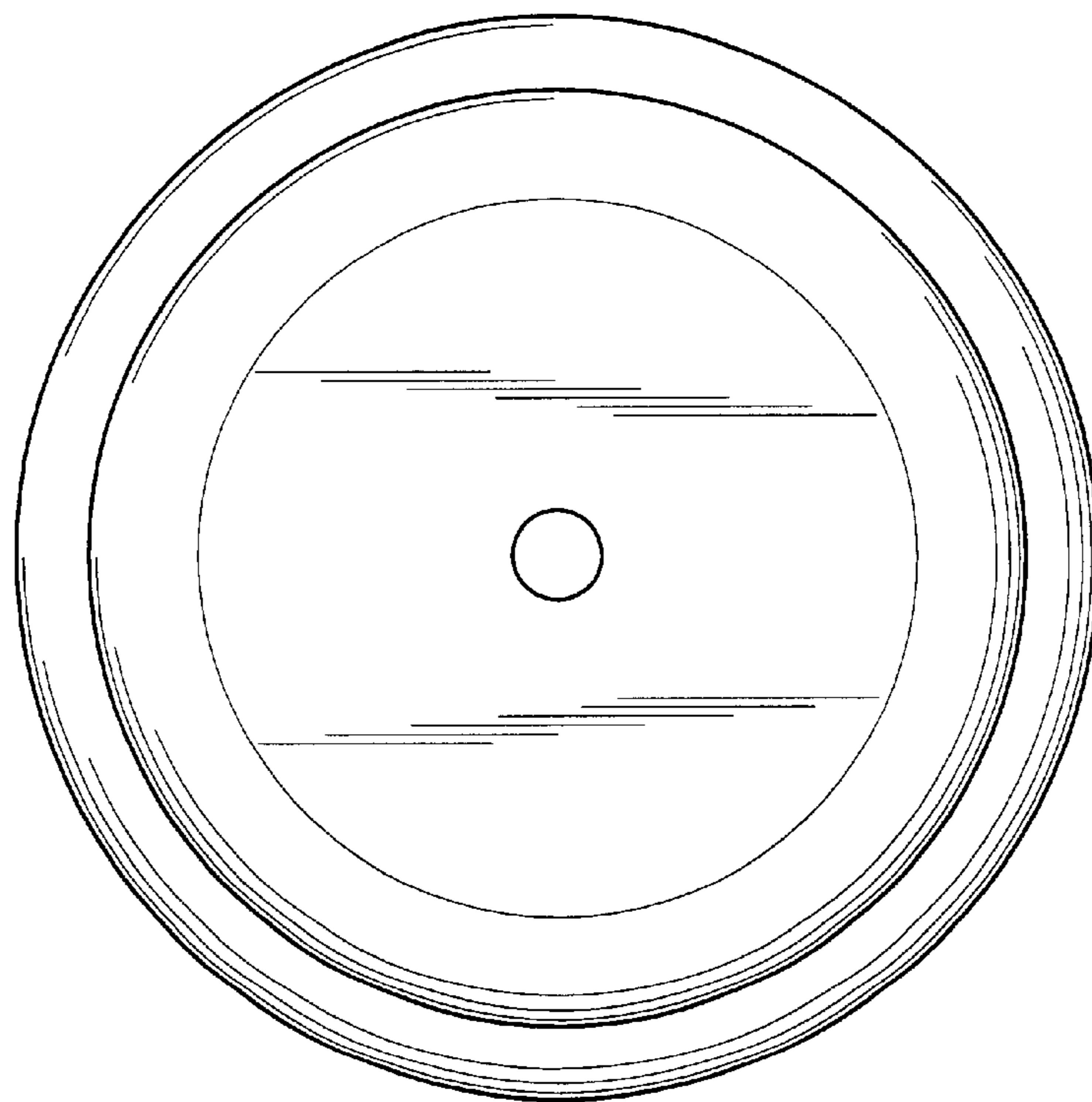

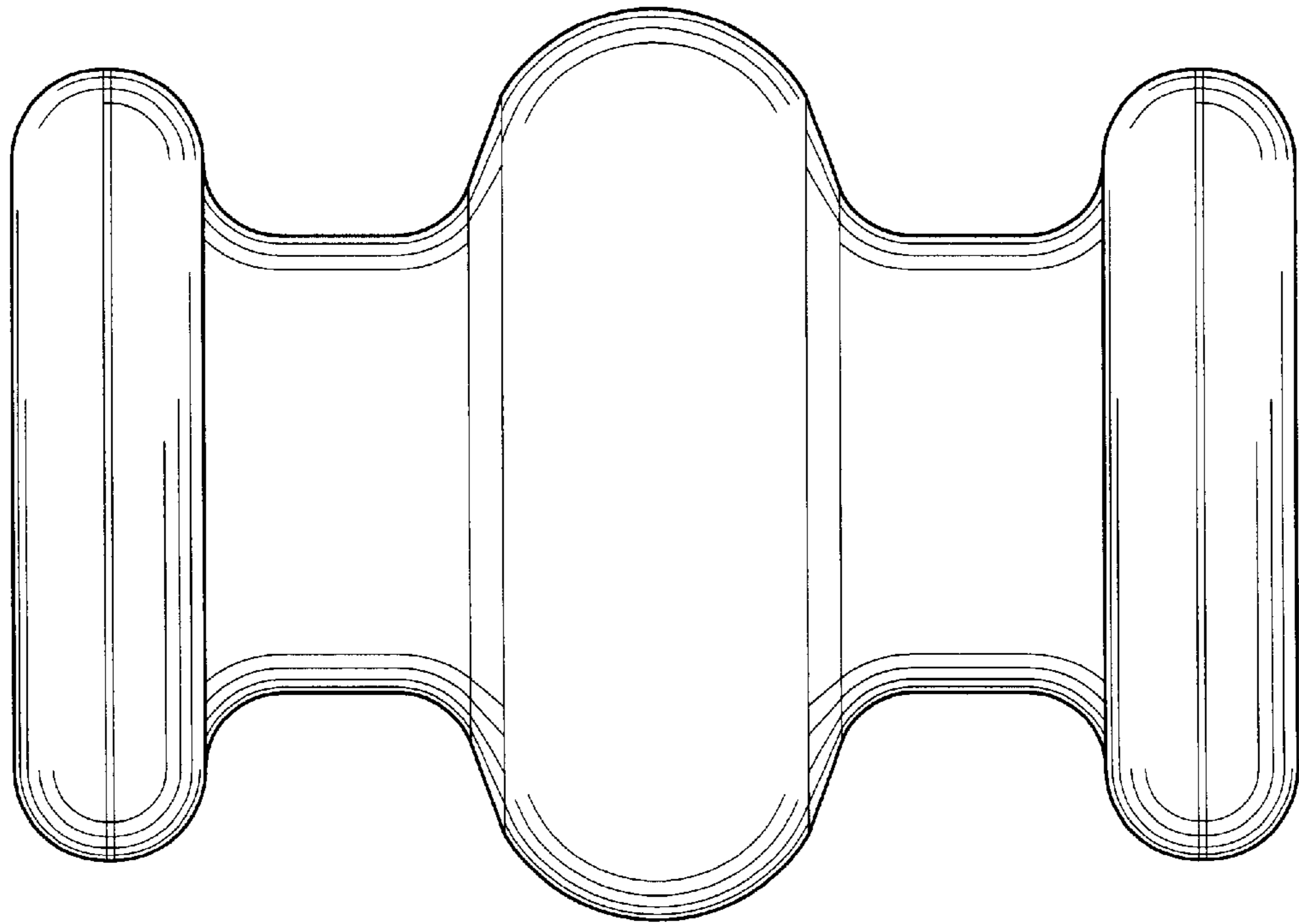

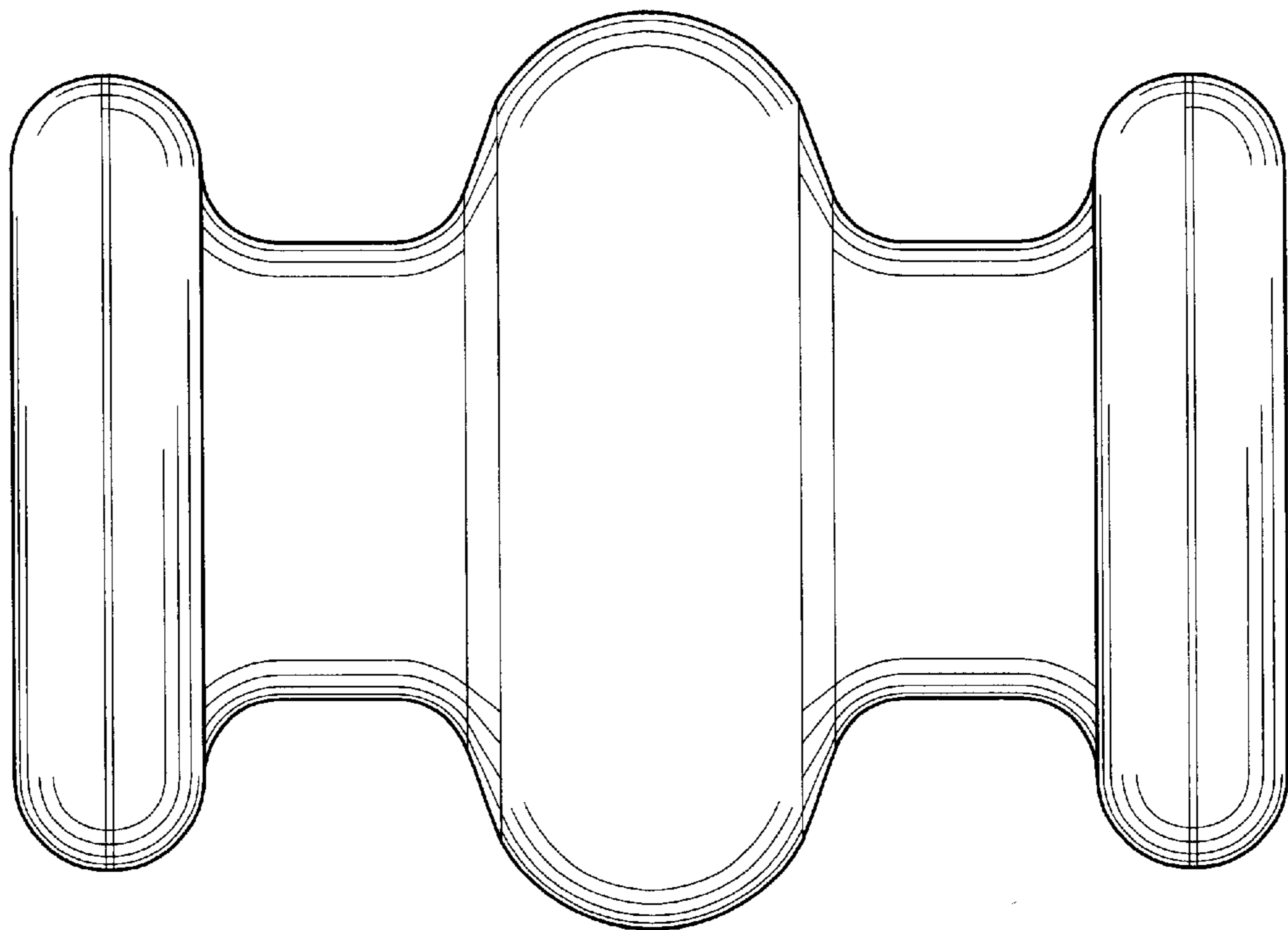

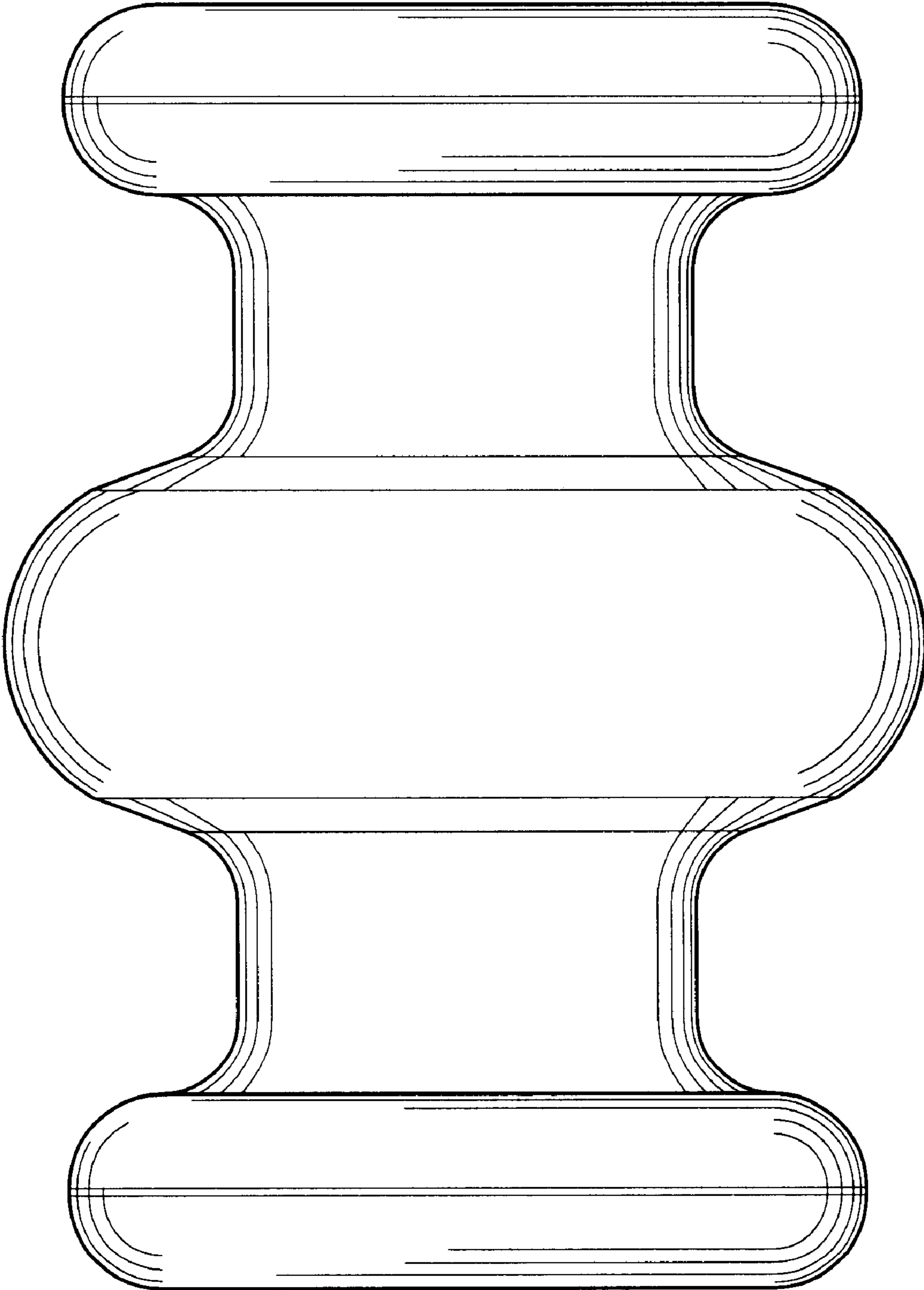

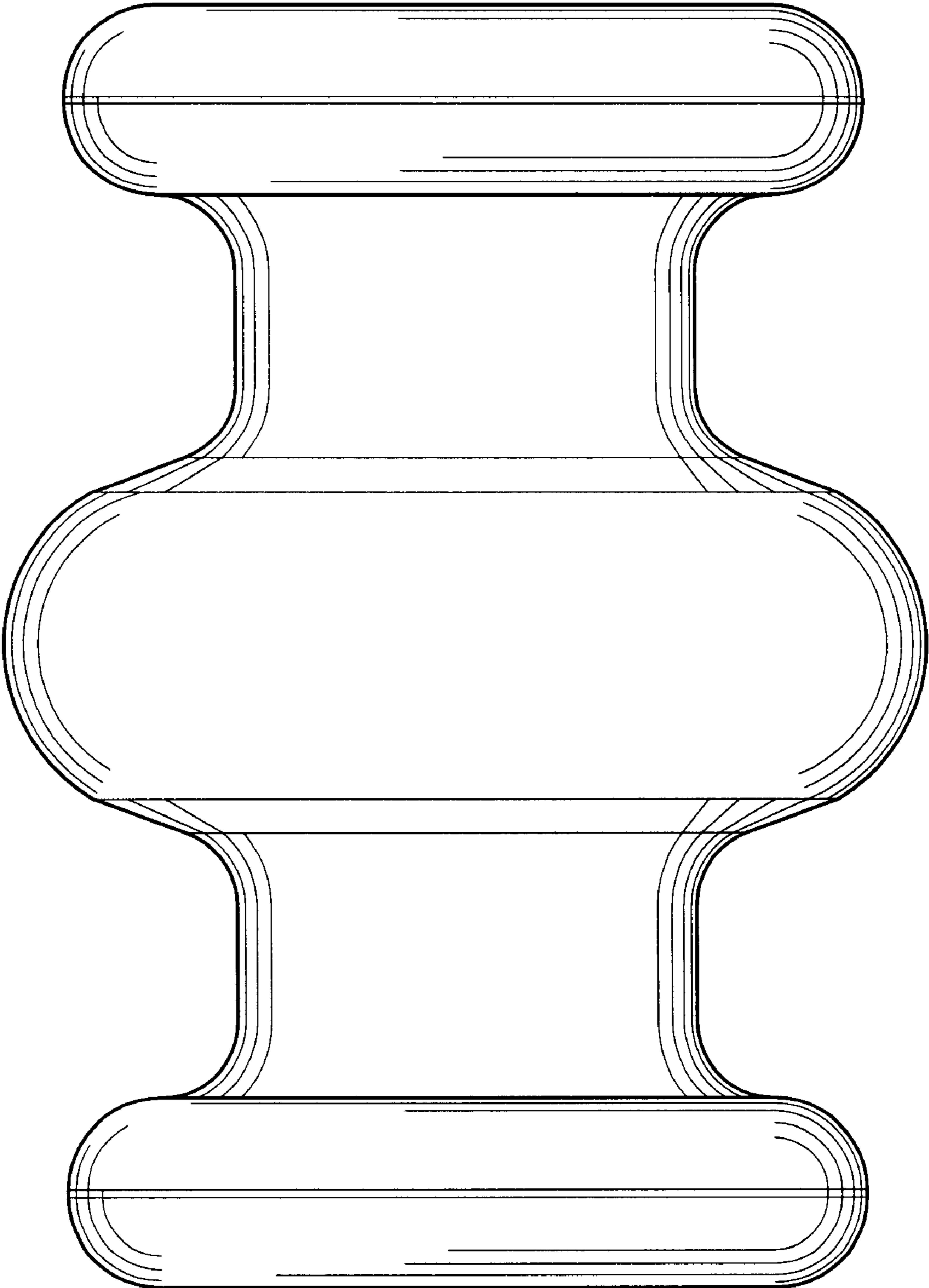
