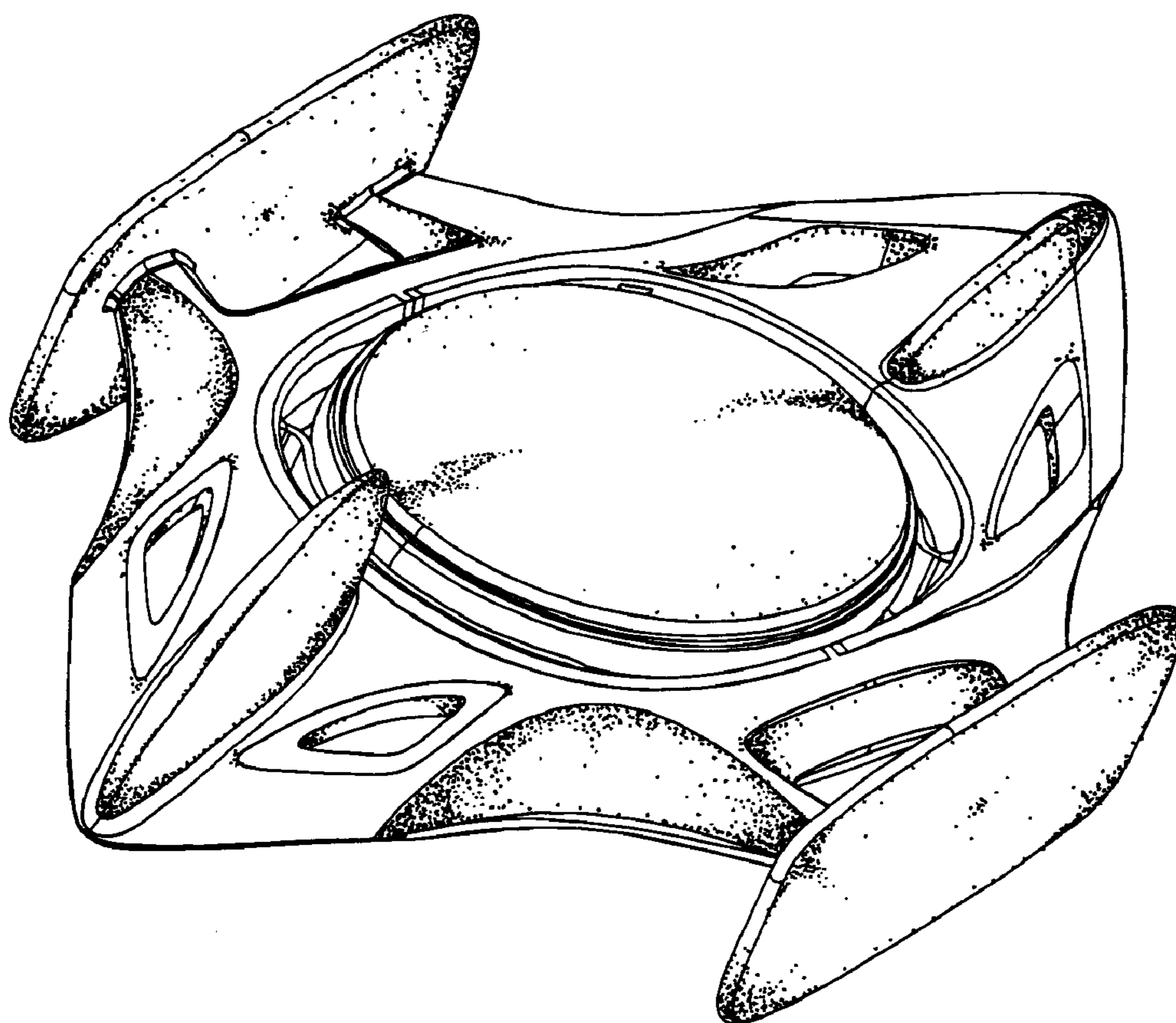
(57) **CLAIM**

The ornamental design for an aquatic fun toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of an aquatic fun toy showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevation thereof; FIG. 5 is a right side elevation thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is an exploded perspective view thereof.

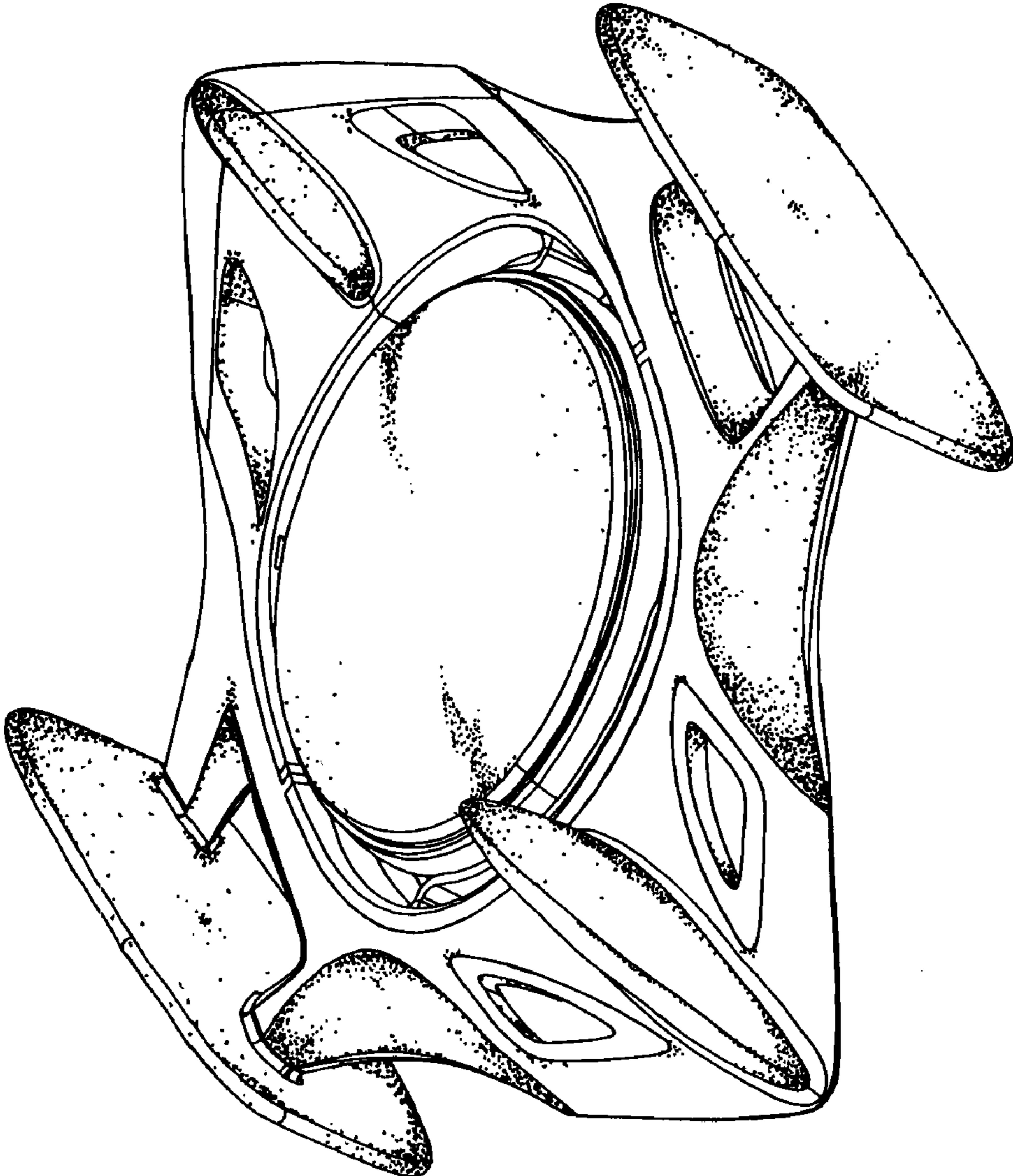

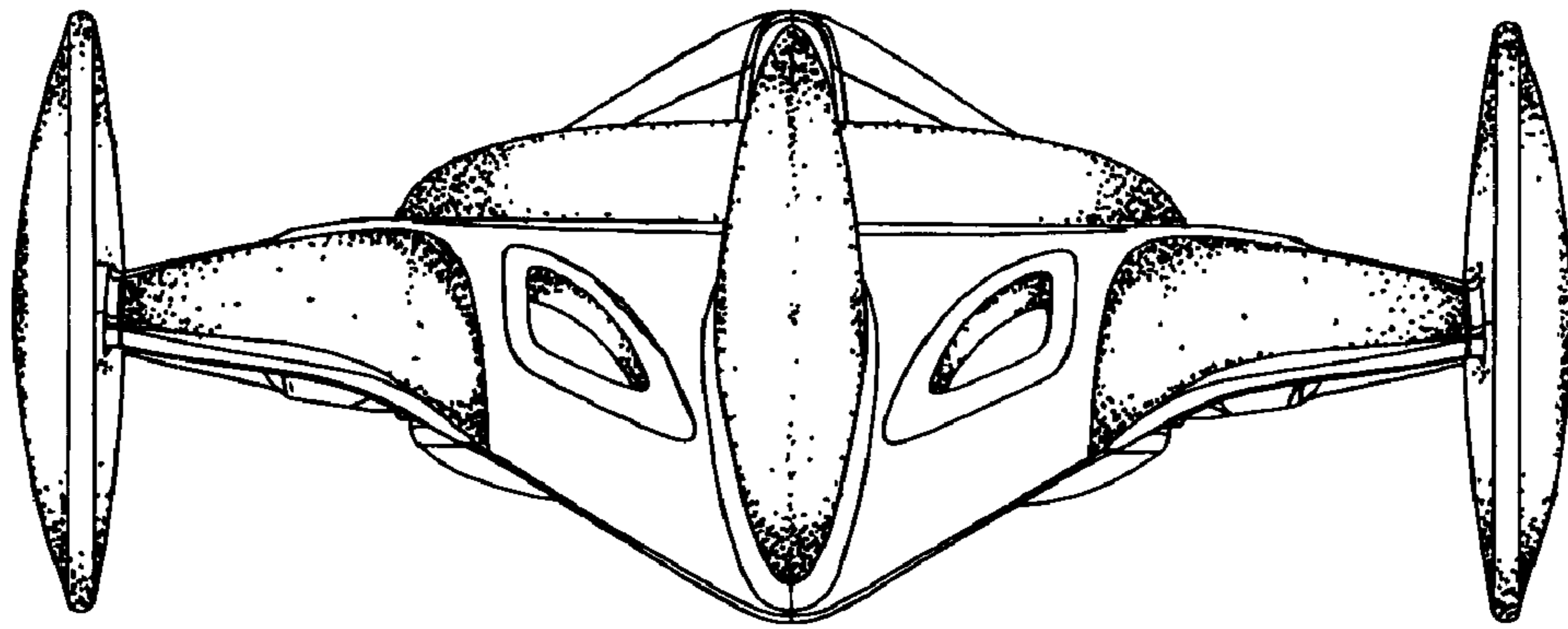

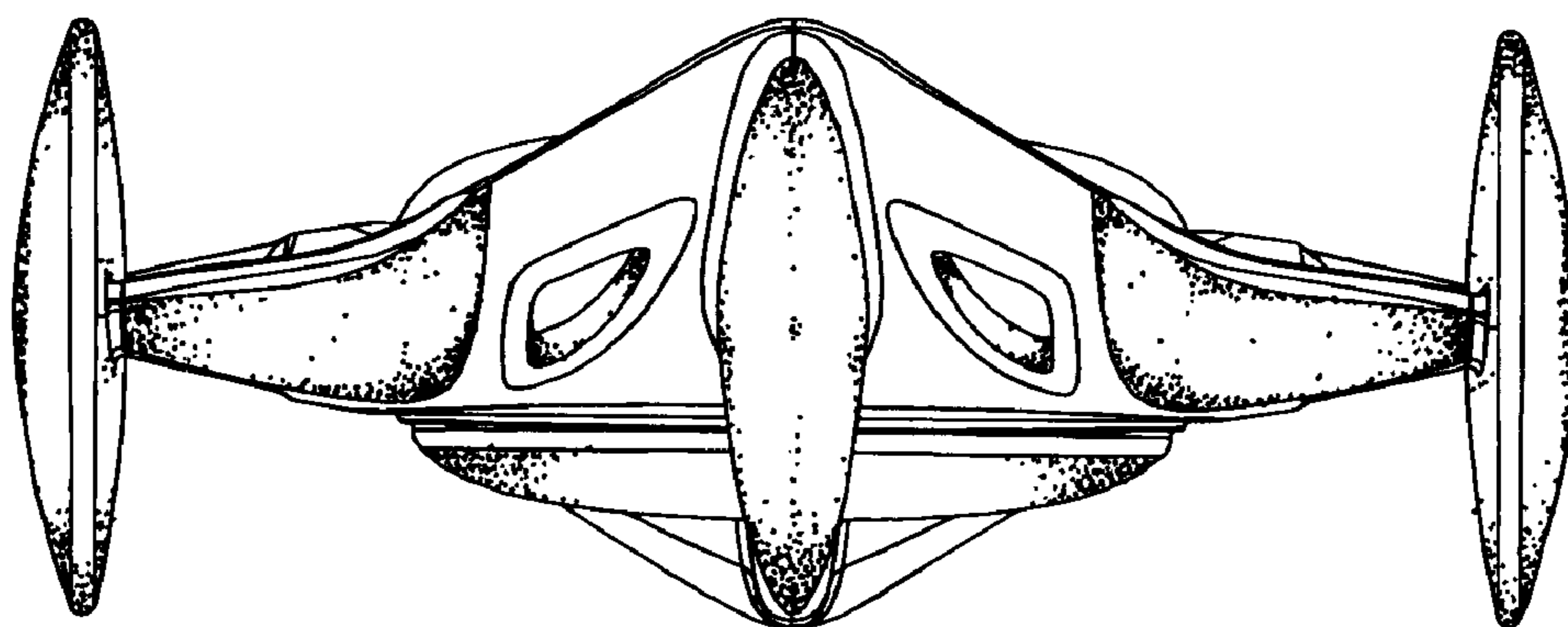

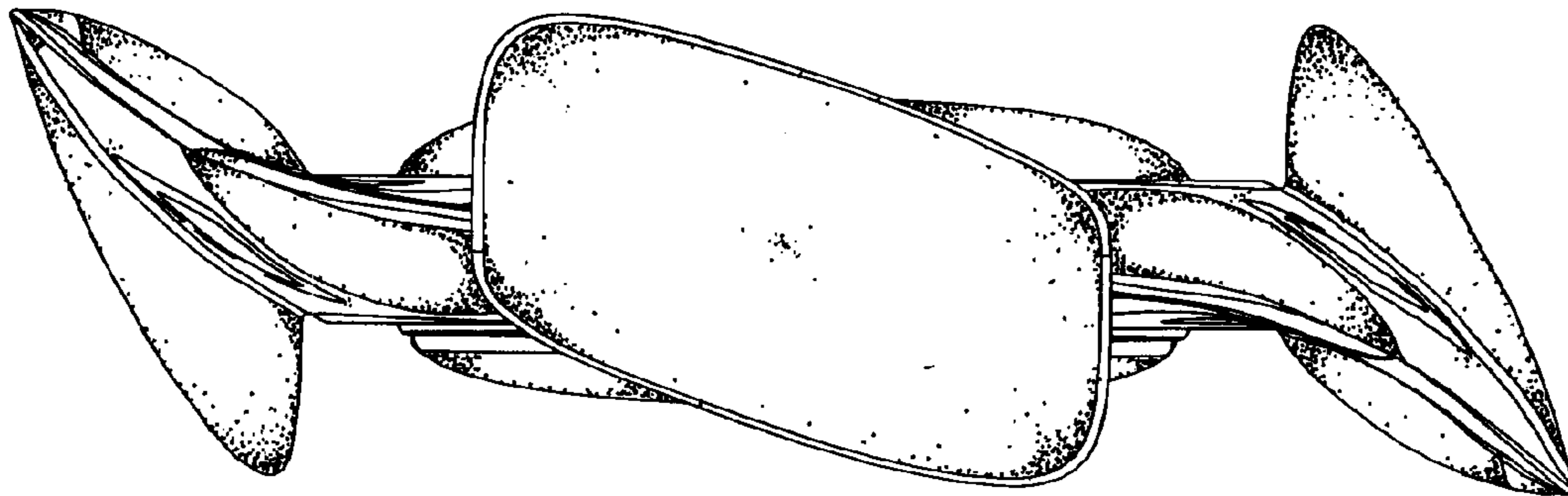

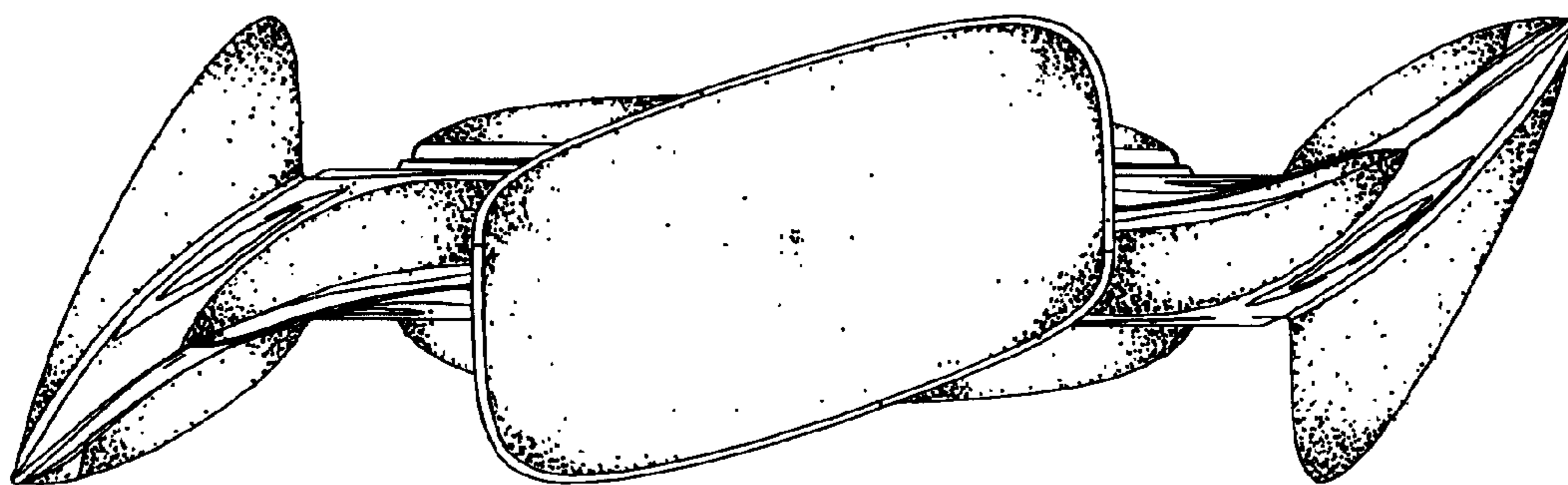

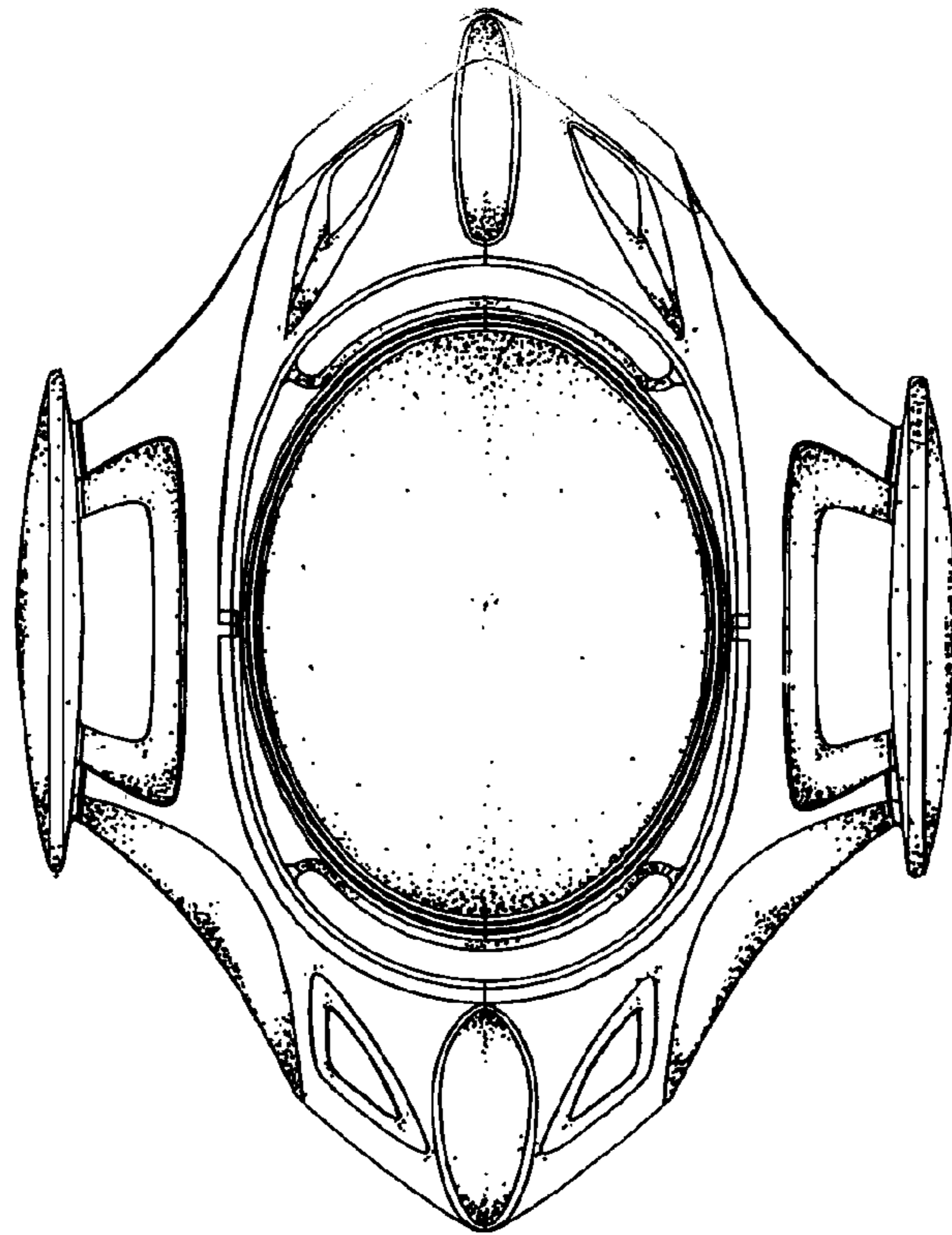

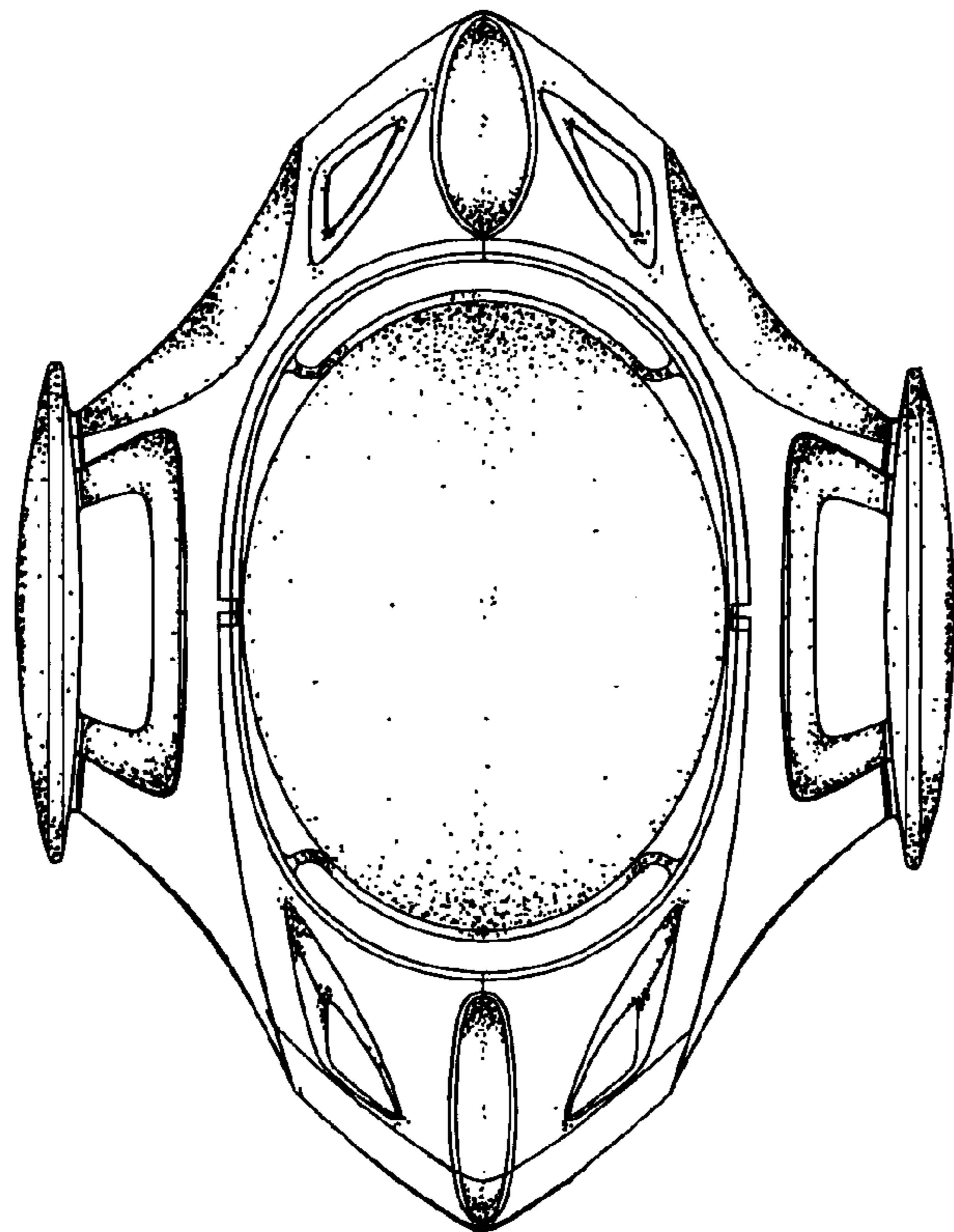

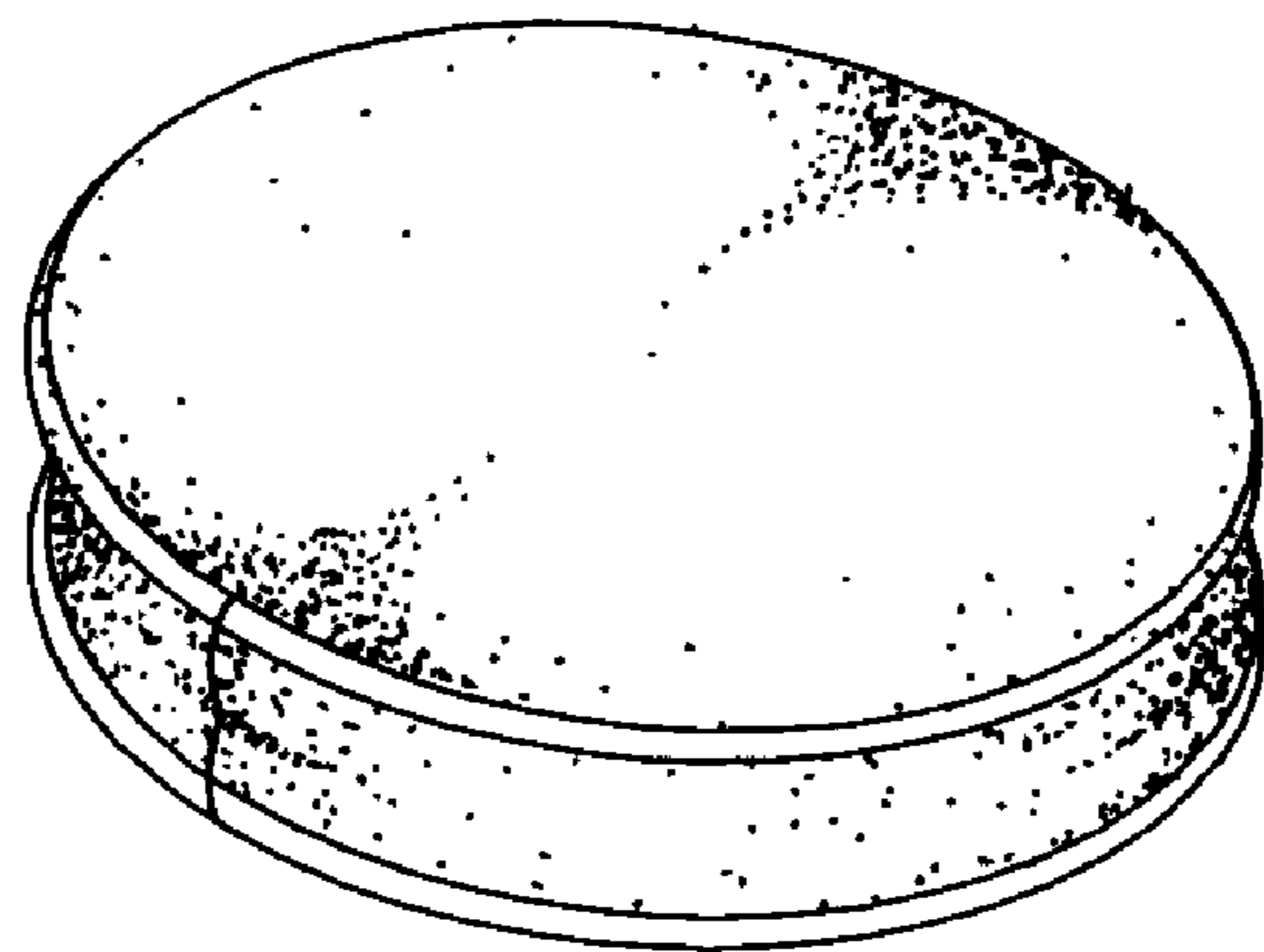
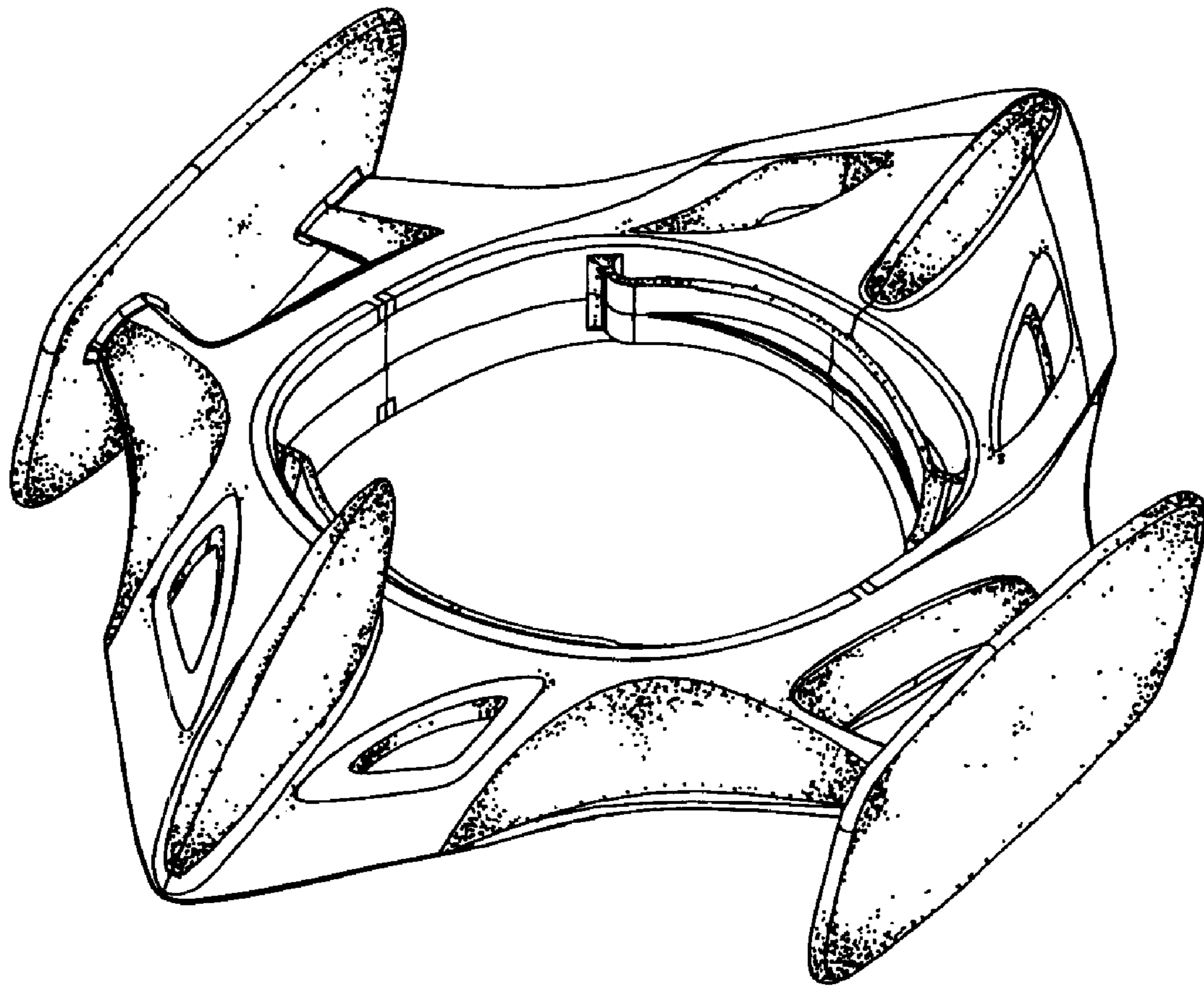
