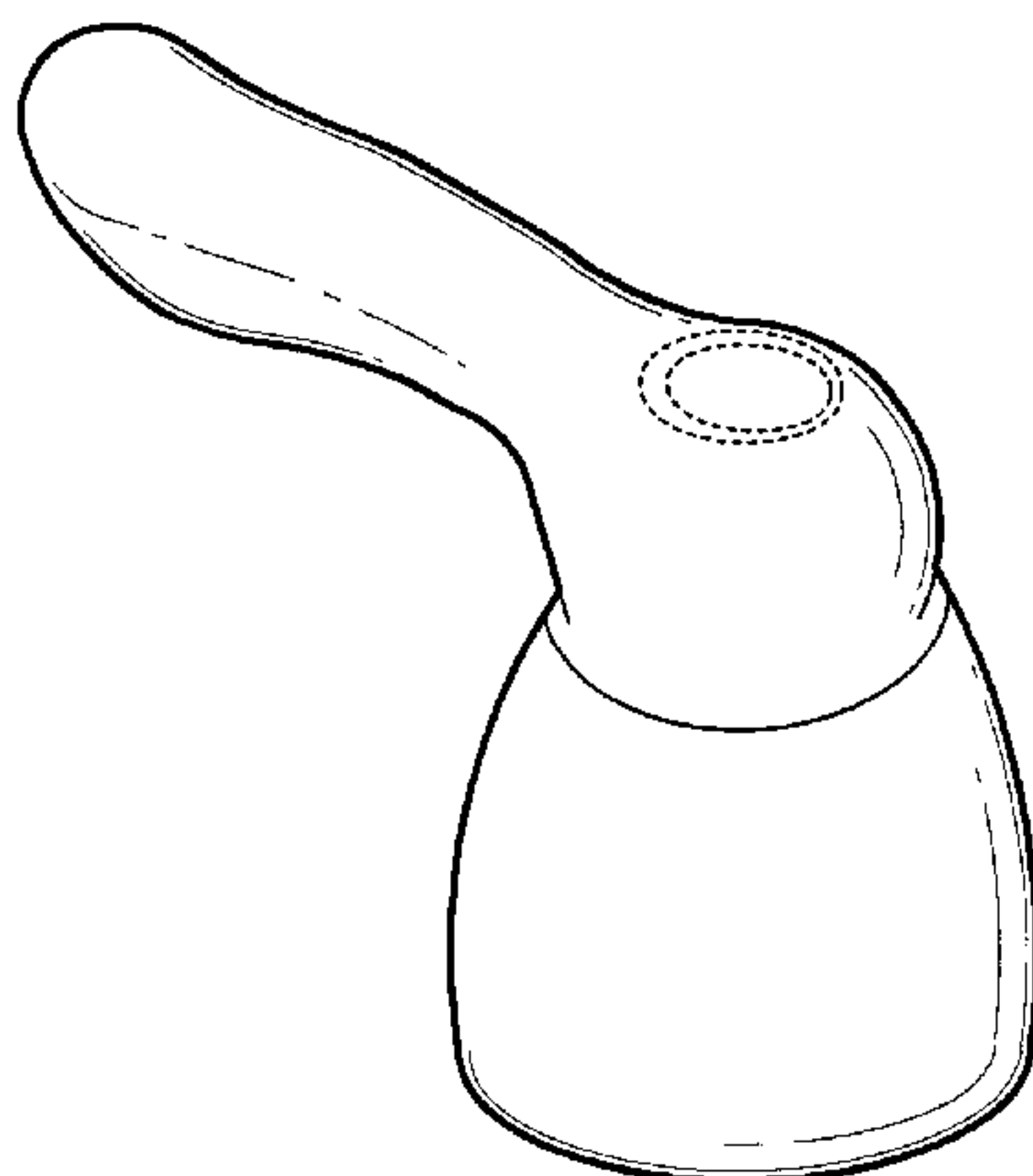
(57) **CLAIM**

The ornamental design for a handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle of the new design; FIG. 2 is a rear elevational view of the handle of FIG. 1; FIG. 3 is a top plan view of the handle of FIG. 1; FIG. 4 is a left side elevational view of the handle of FIG. 1; FIG. 5 is a front elevational view of the handle of FIG. 1; FIG. 6 is a right side elevational view of the handle of FIG. 1; and, FIG. 7 is a bottom plan view of the handle of FIG. 1. The portions of the Figures shown in phantom lines are not part of the claimed design and are for illustration only.

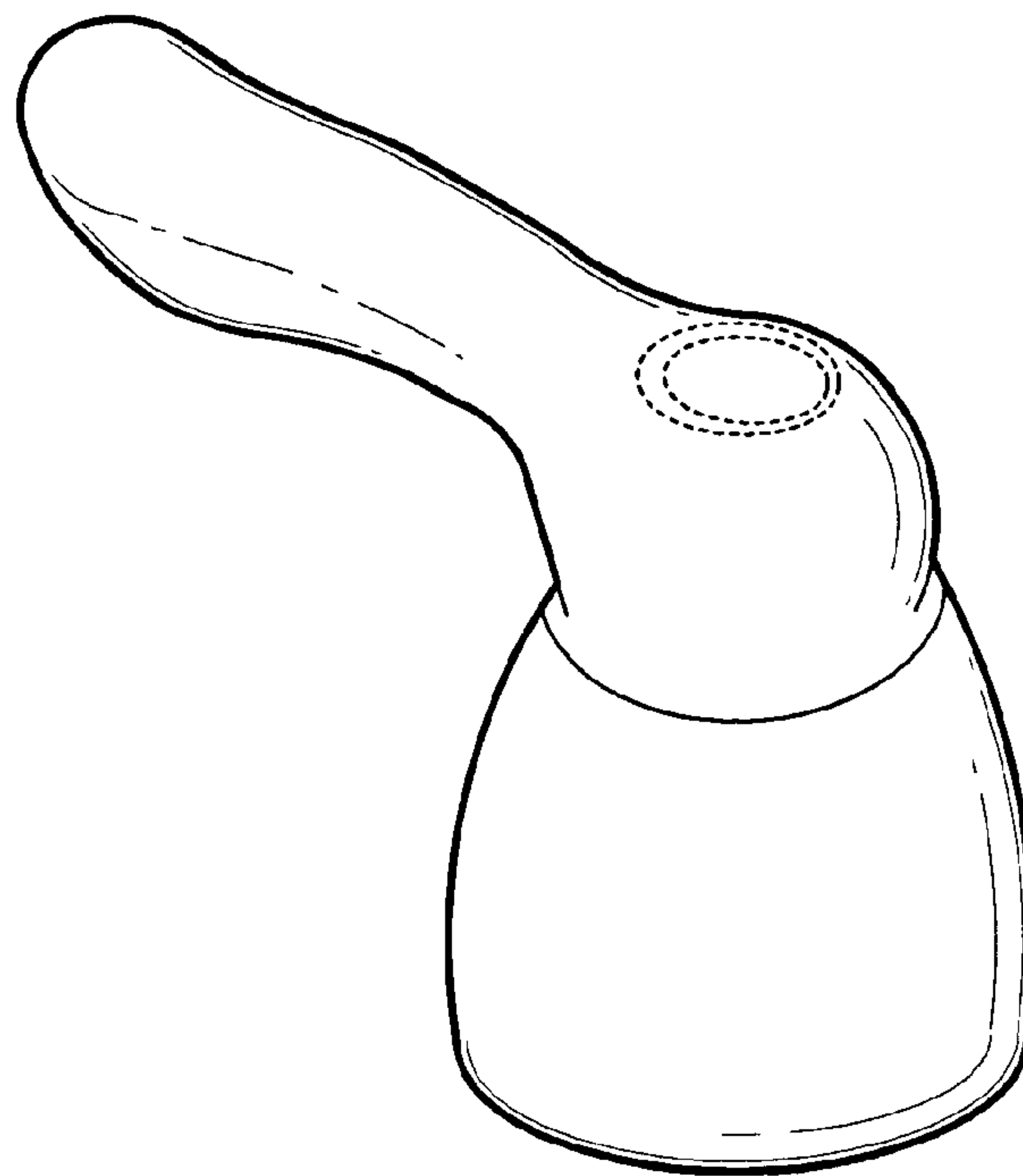

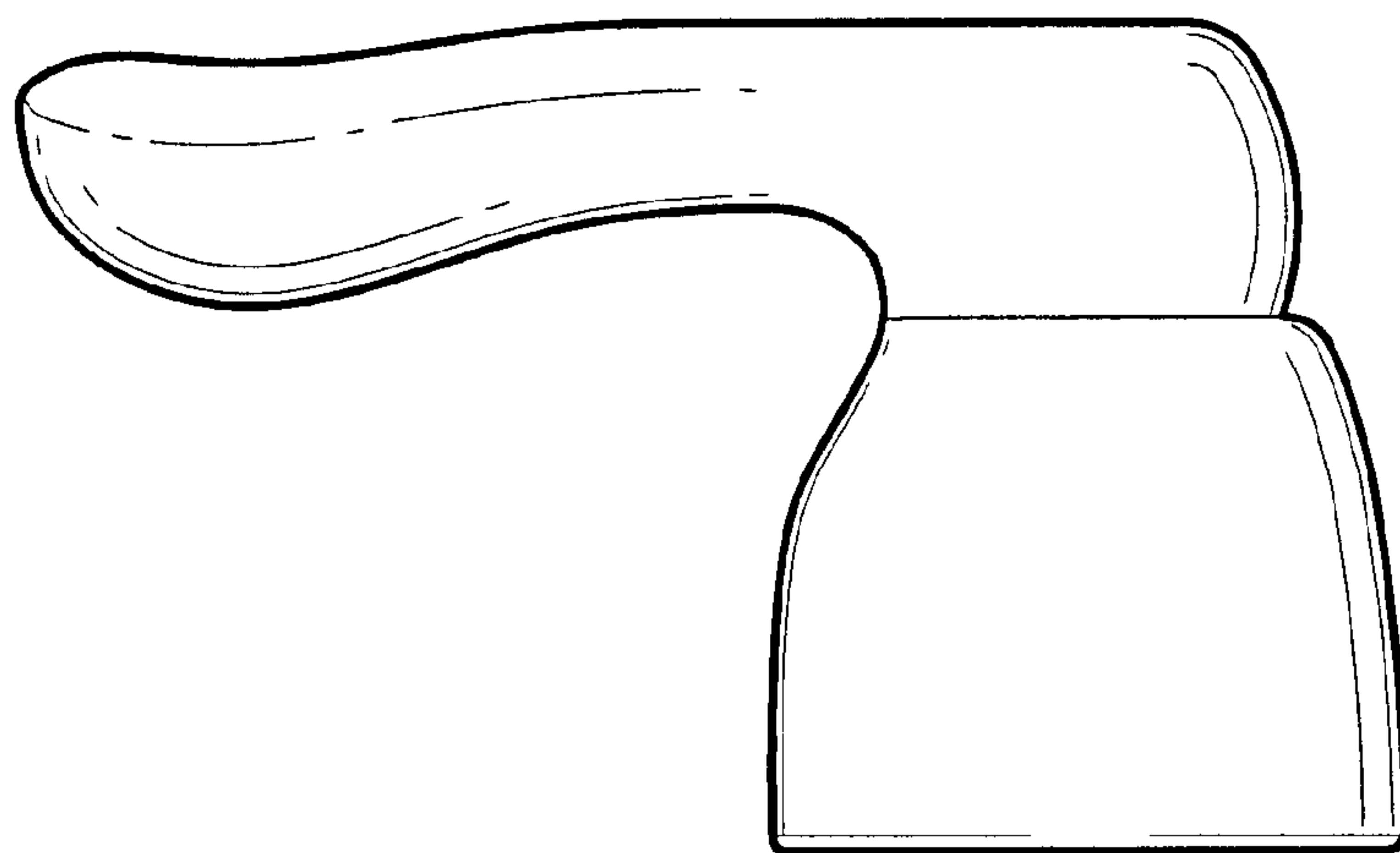

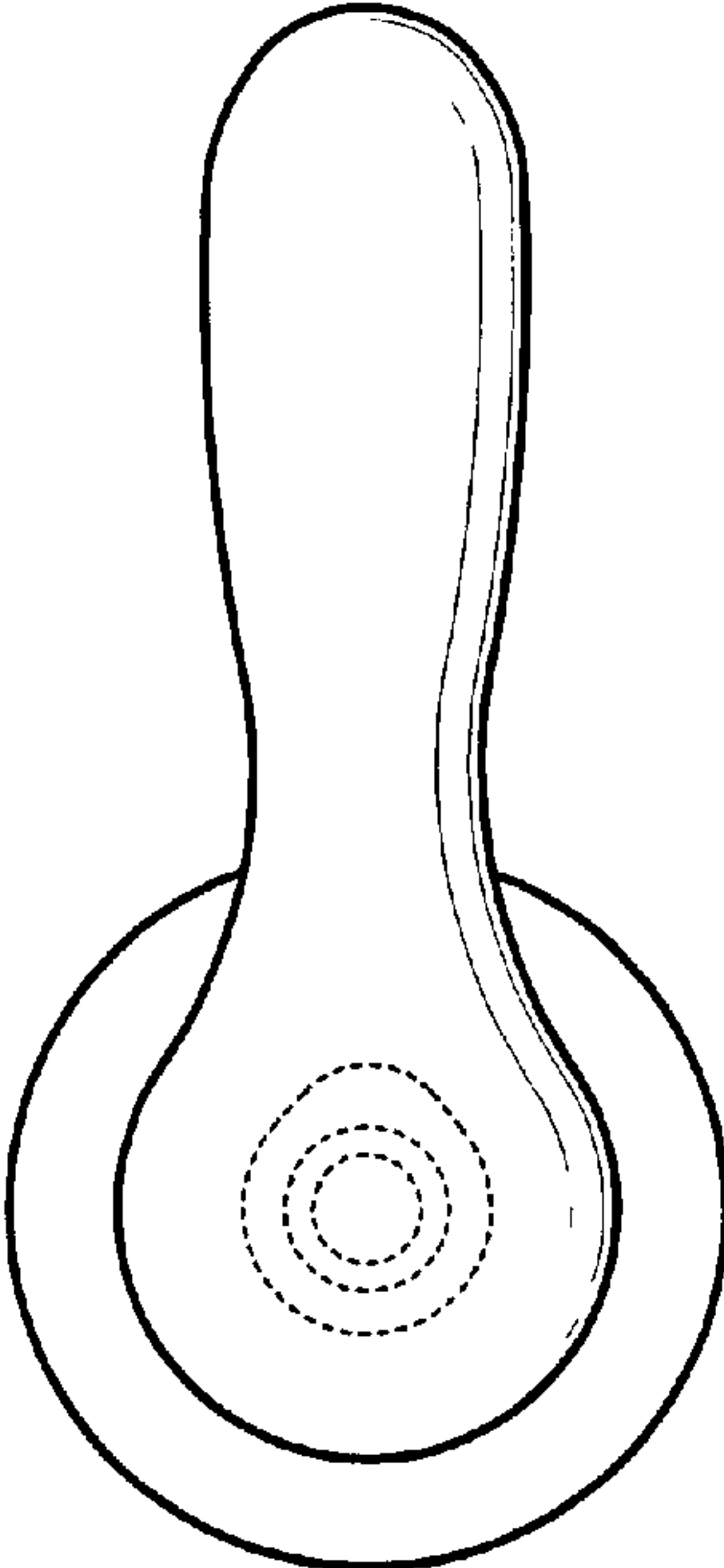

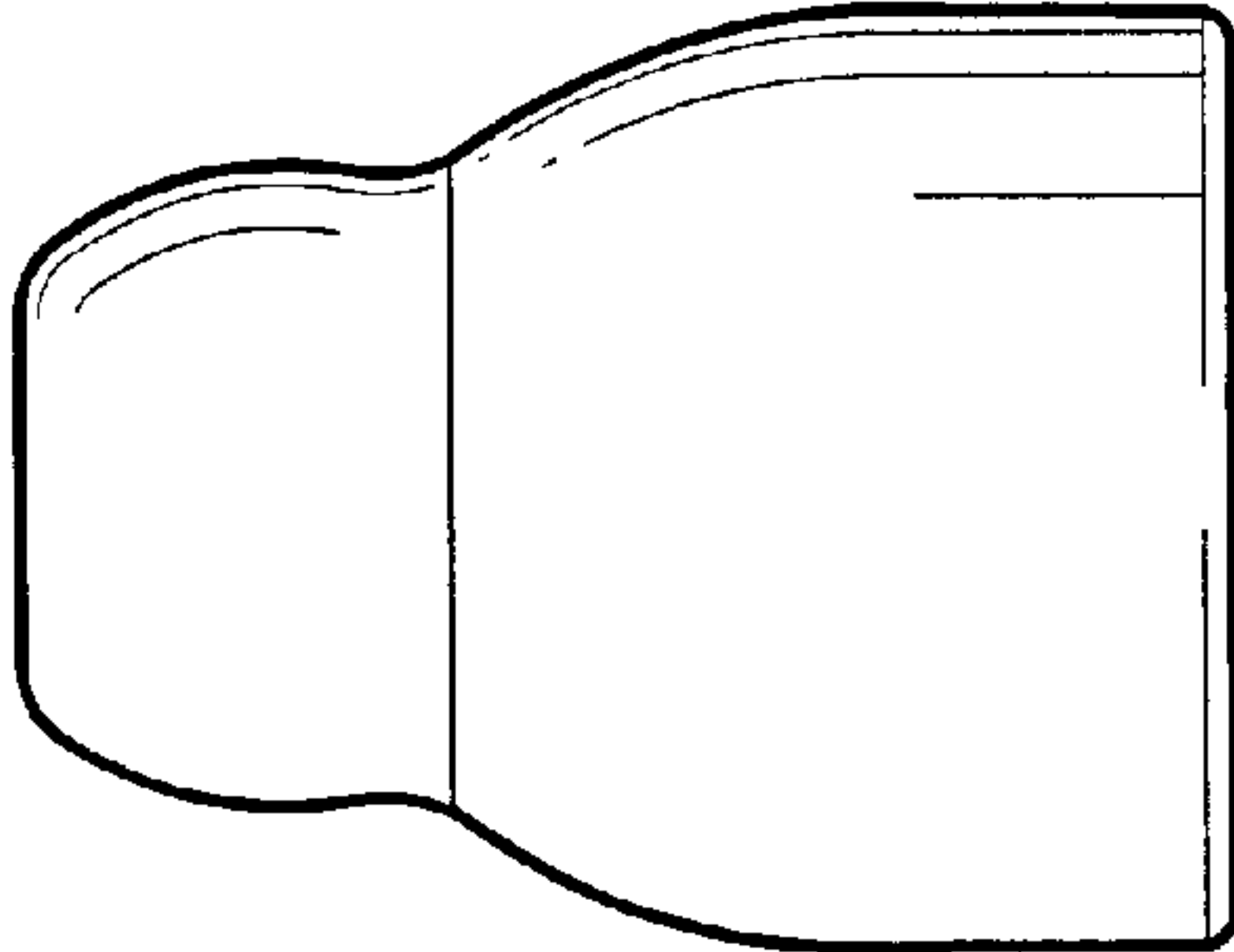

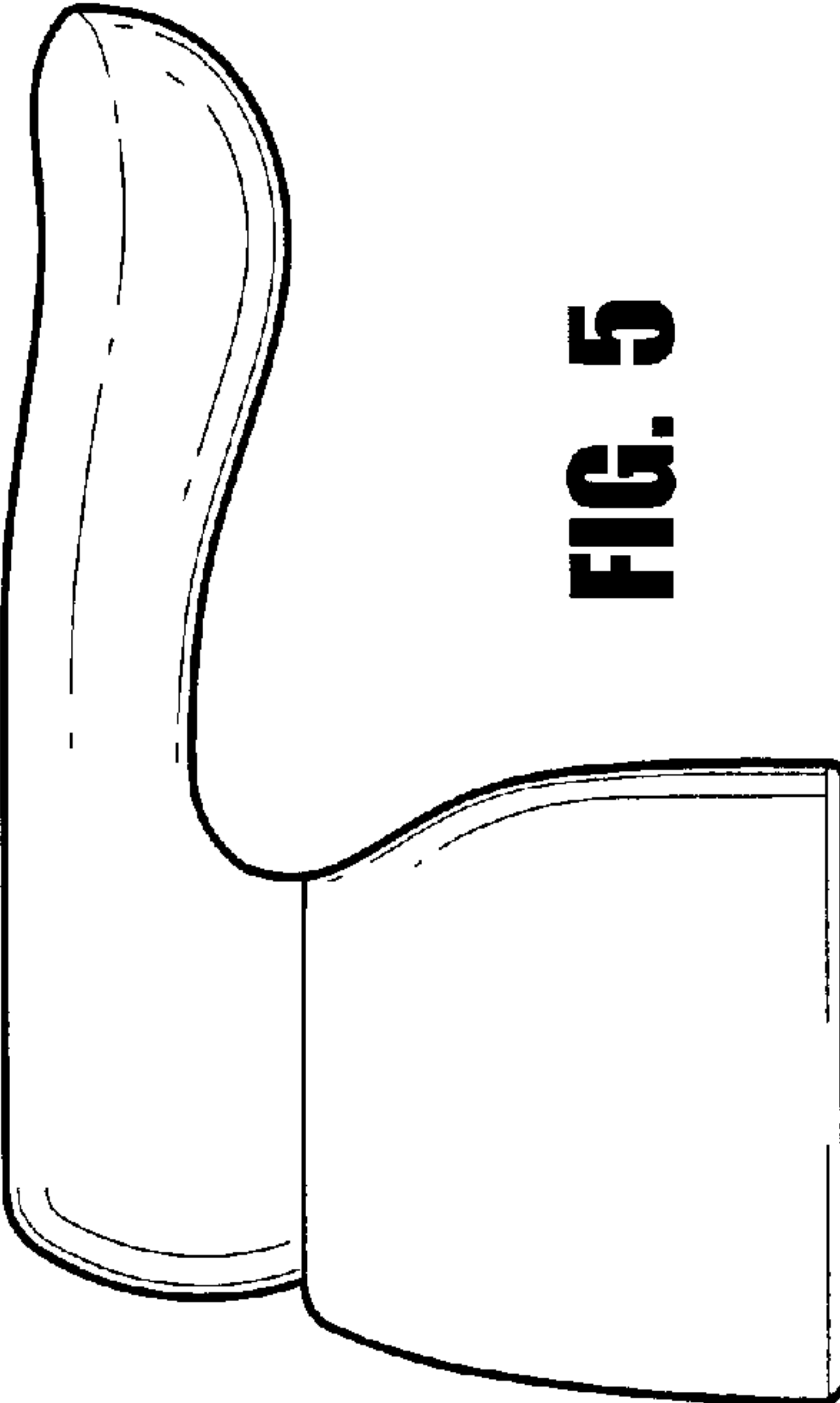

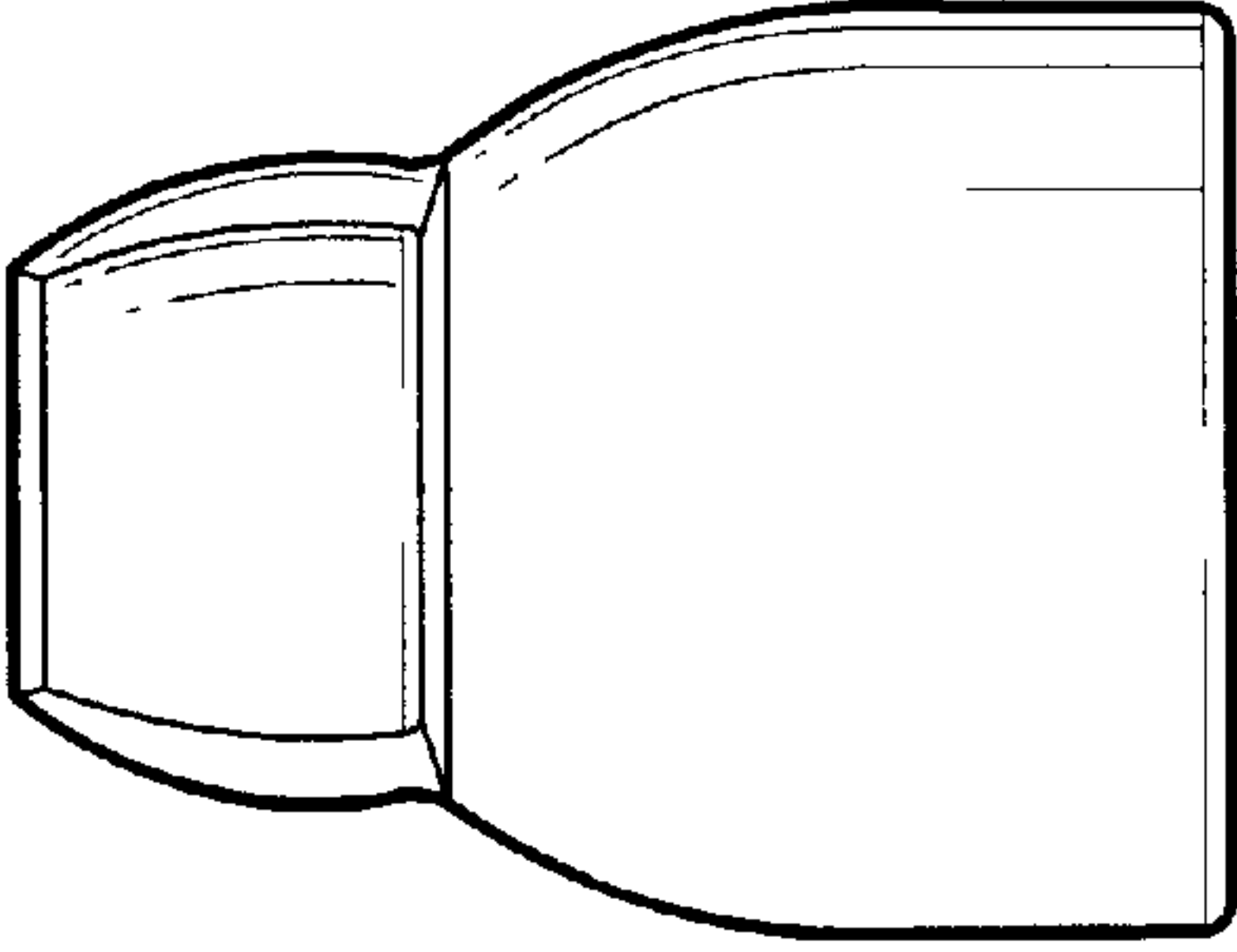

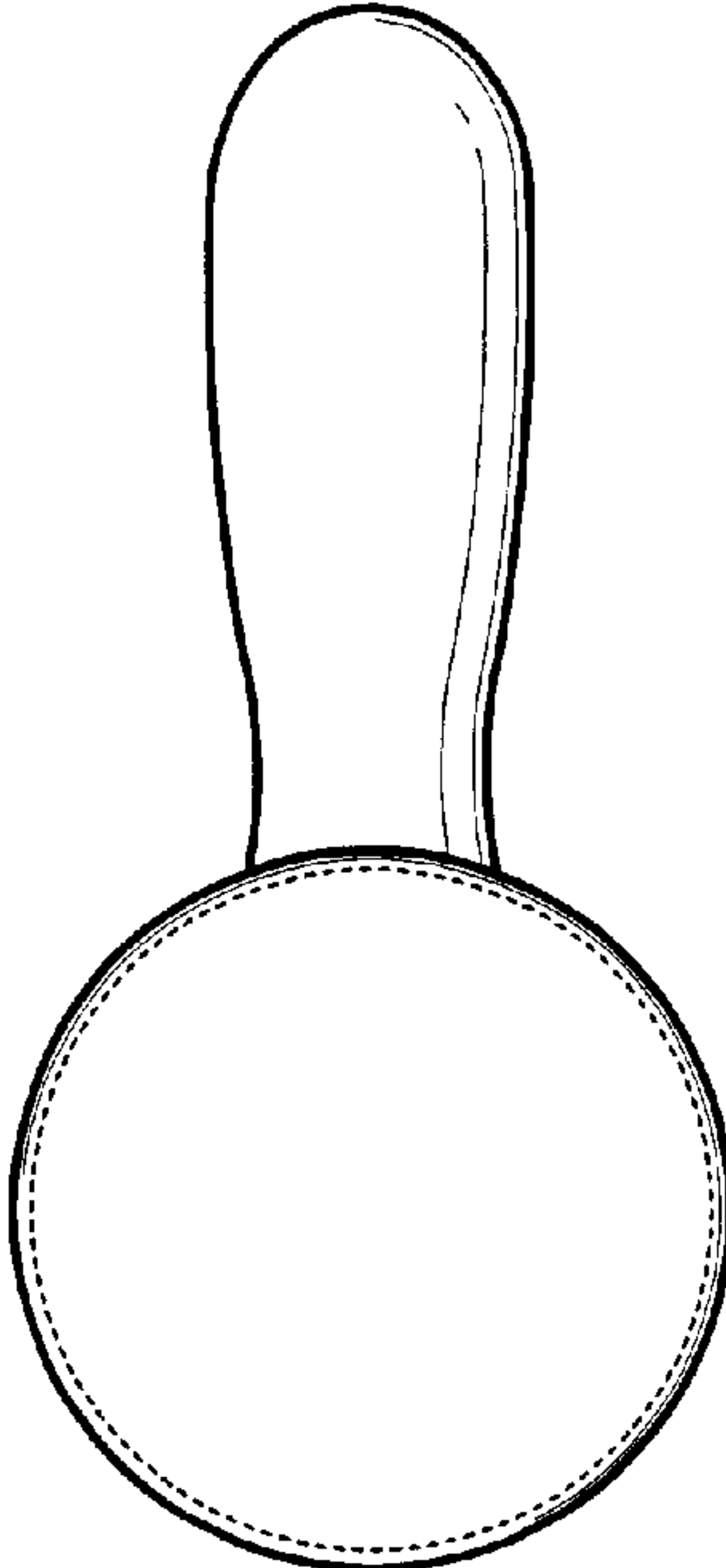
