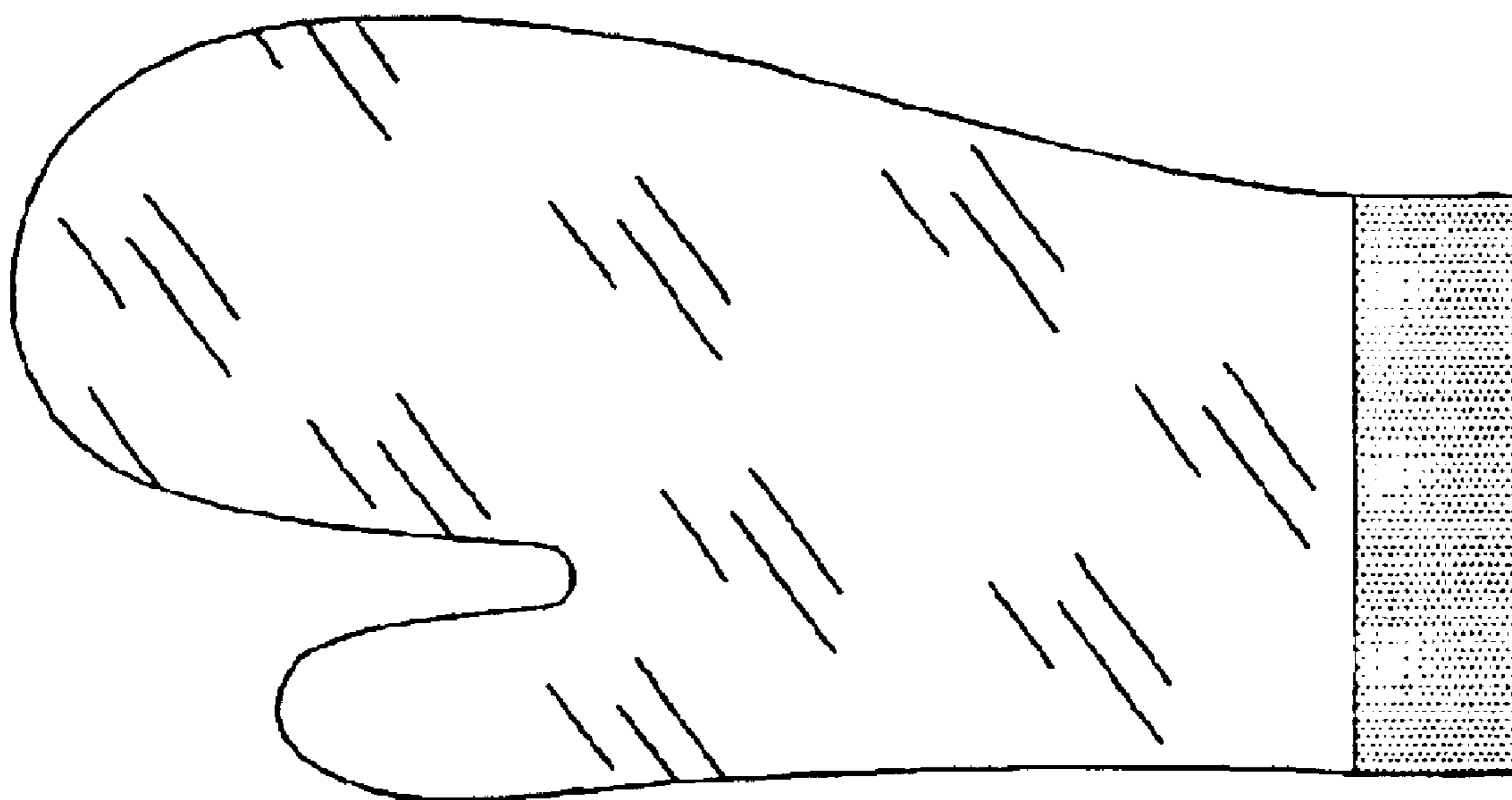
(57) **CLAIM**

The ornamental design for an I-V covering mitt, as shown and described.

DESCRIPTION

FIG. 1 shows a top plan view of an I-V covering mitt. FIG. 2 shows a bottom plan view thereof. FIG. 3 shows a right side elevational view thereof. FIG. 4 shows a left side elevational view thereof. FIG. 5 shows a front side elevational view thereof magnified three times relative to the scale of FIGS. 1-4; and, FIG. 6 shows a rear side elevational view thereof magnified three times relative to the scale of FIGS. 1-4.

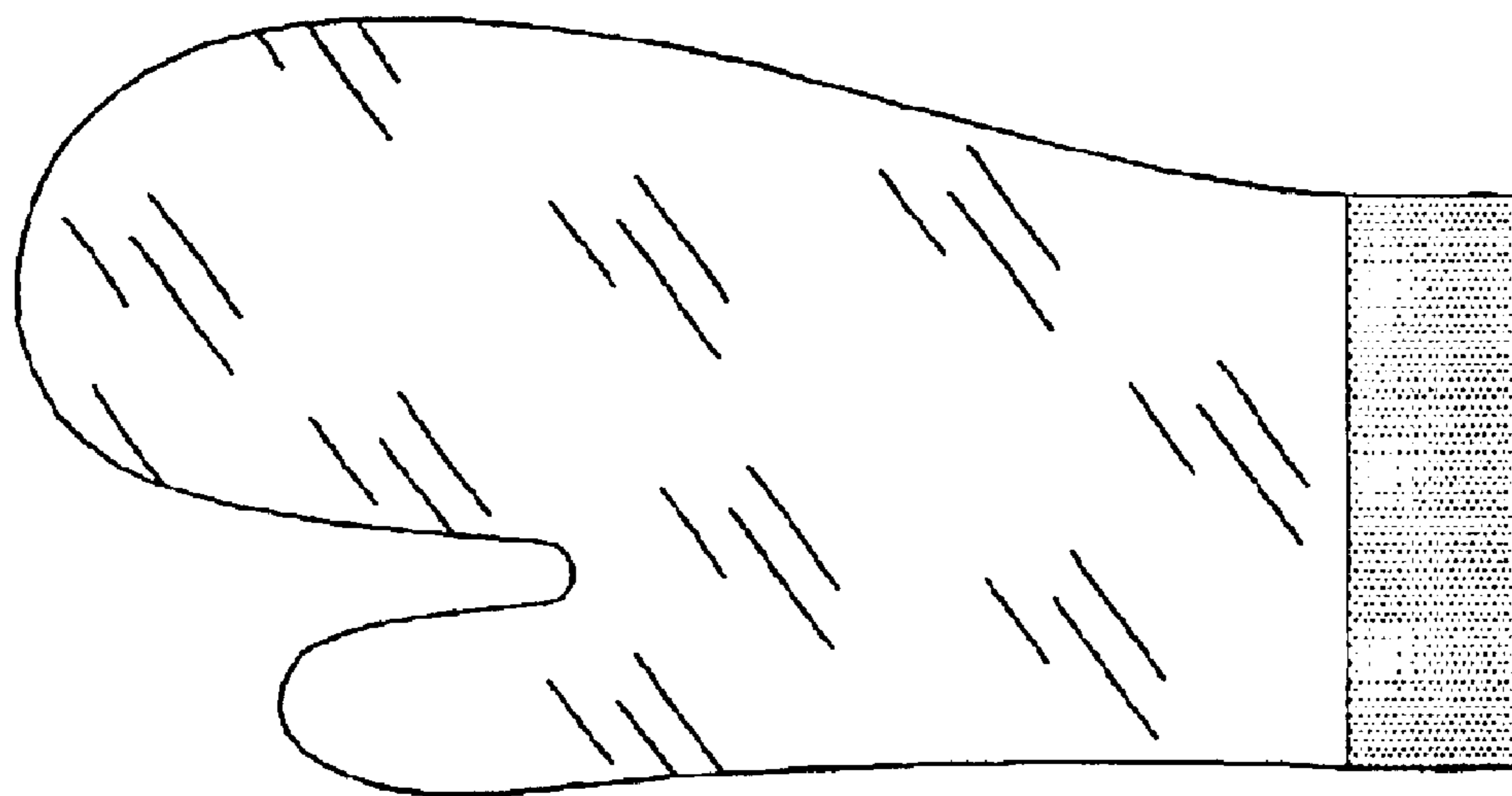

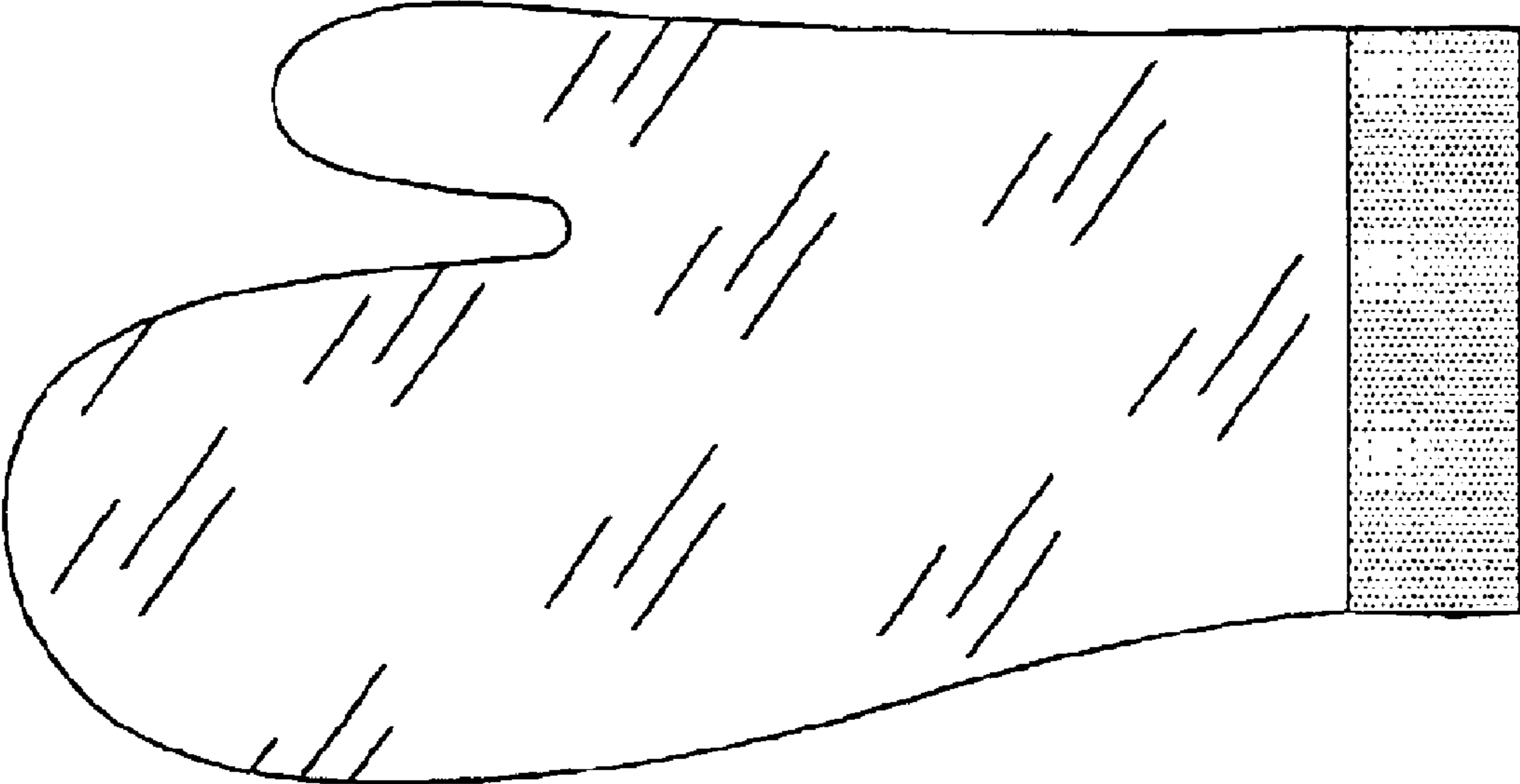

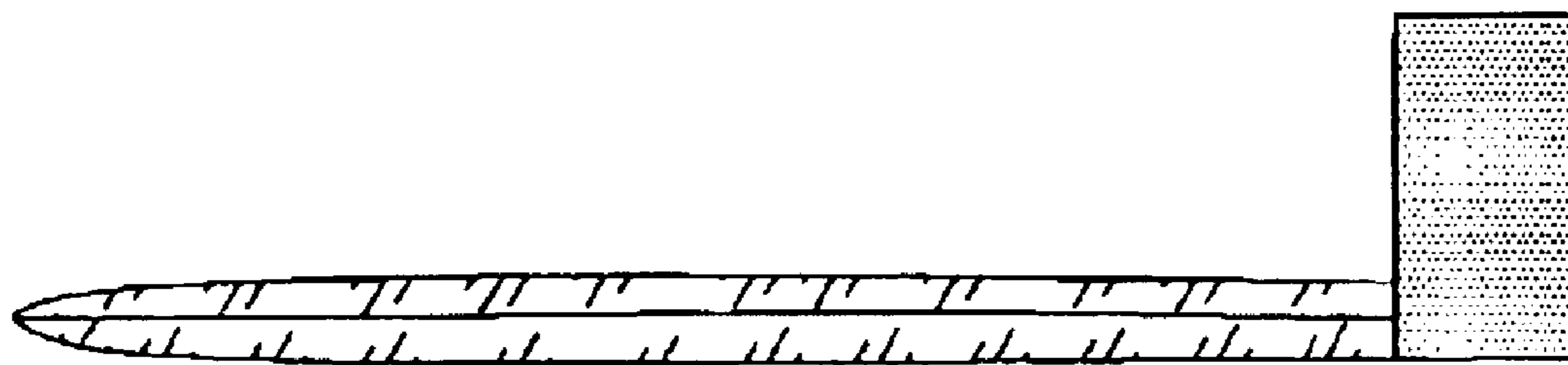

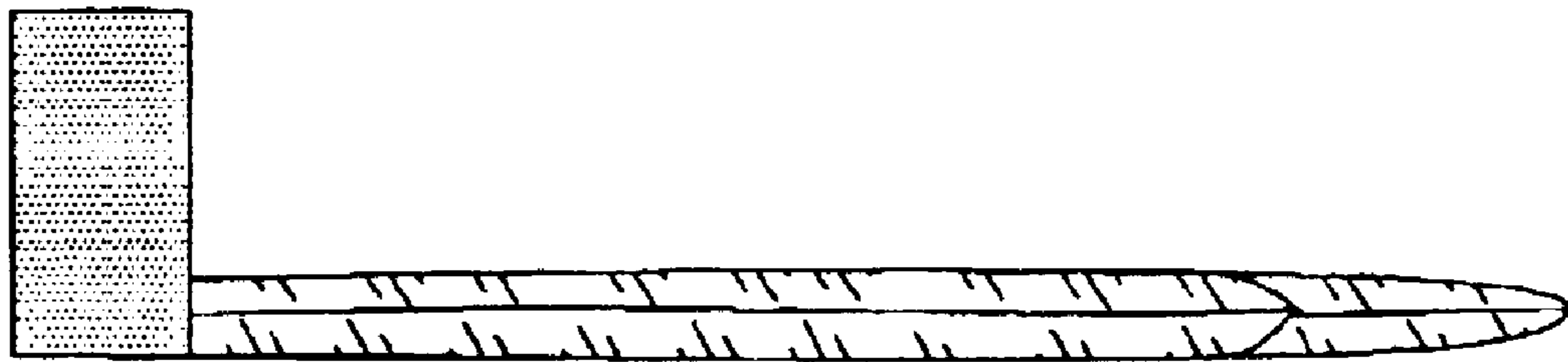

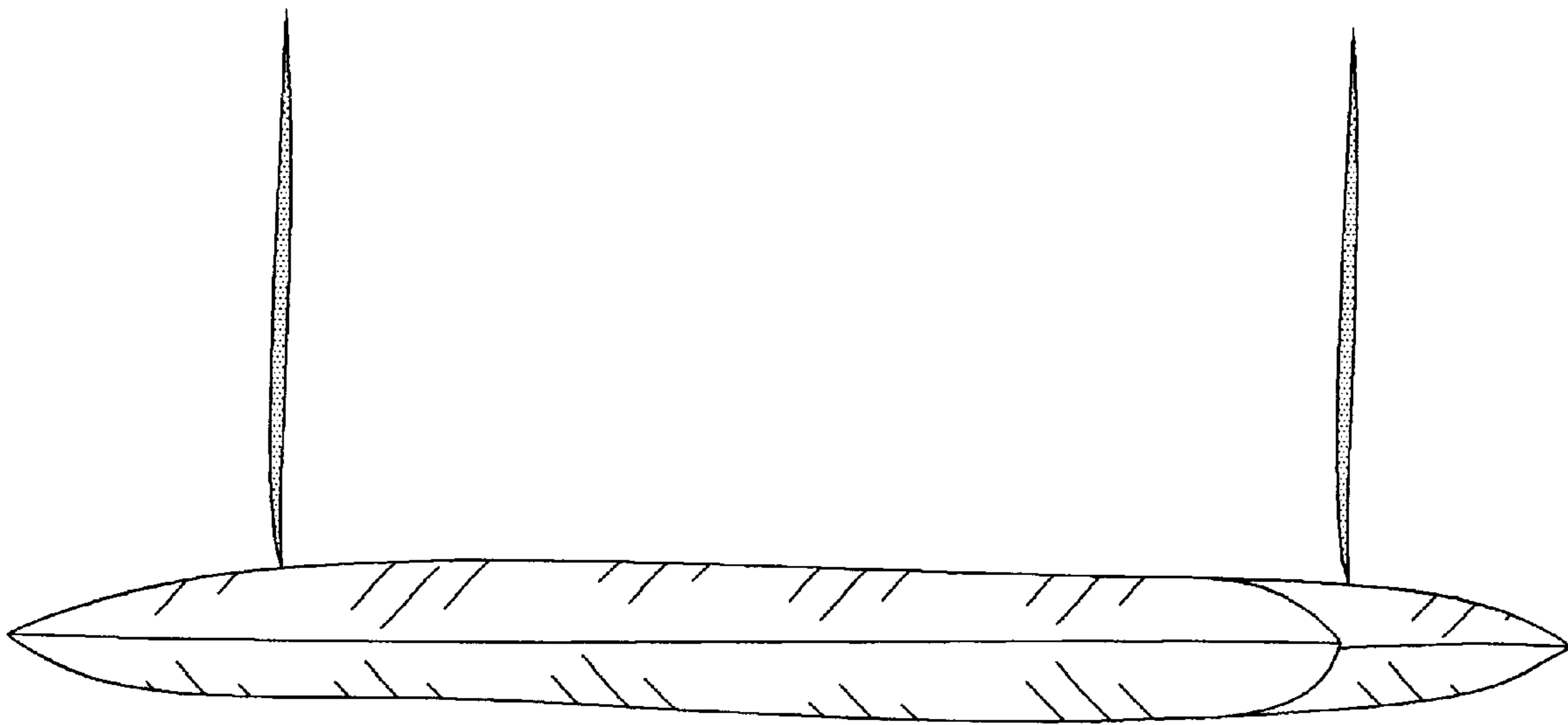

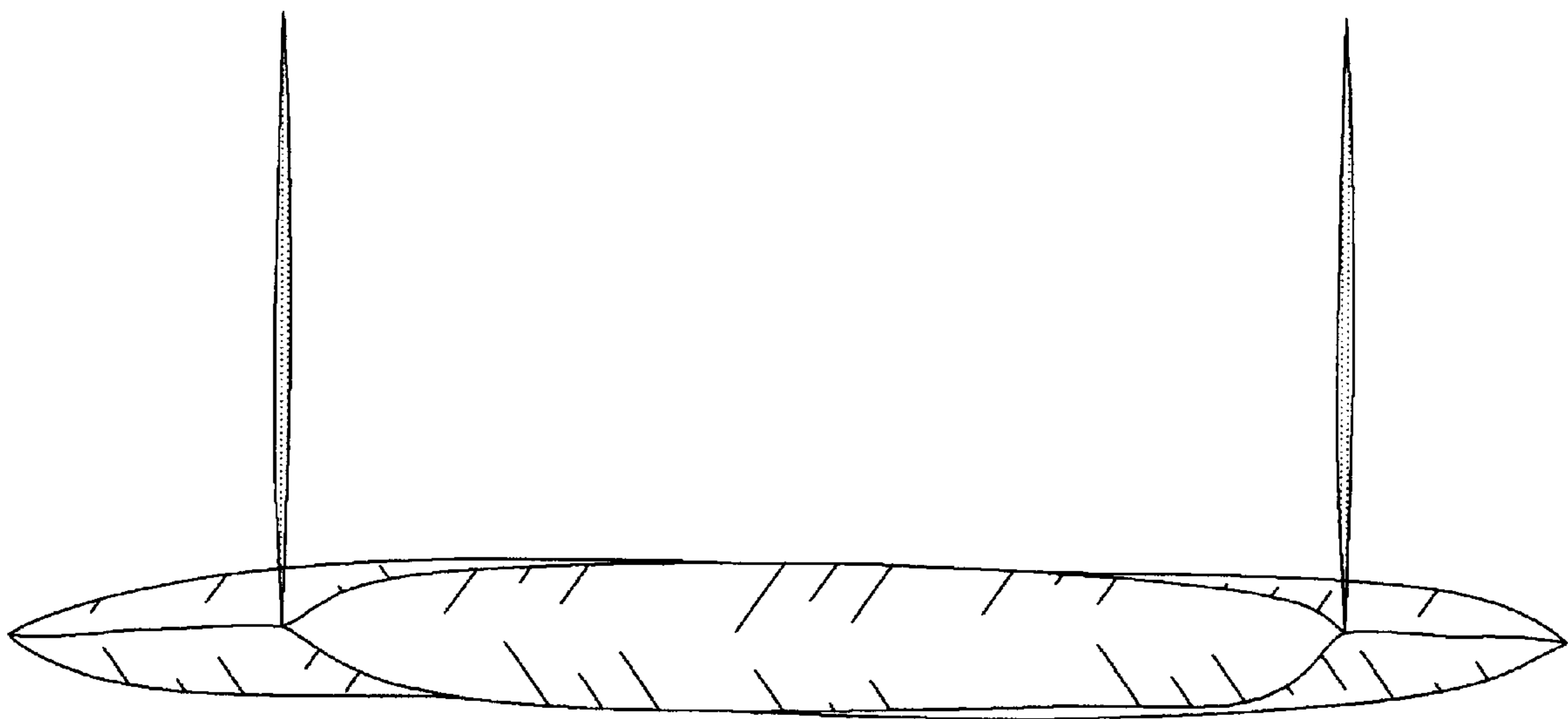
