(57) **CLAIM**

The ornamental design for a pier cap for capping foundation pier for manufactured house, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left, front, perspective view of a pier cap for capping foundation pier for manufactured house showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation view thereof; the rear elevation view being a mirror image;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a bottom perspective view thereof.

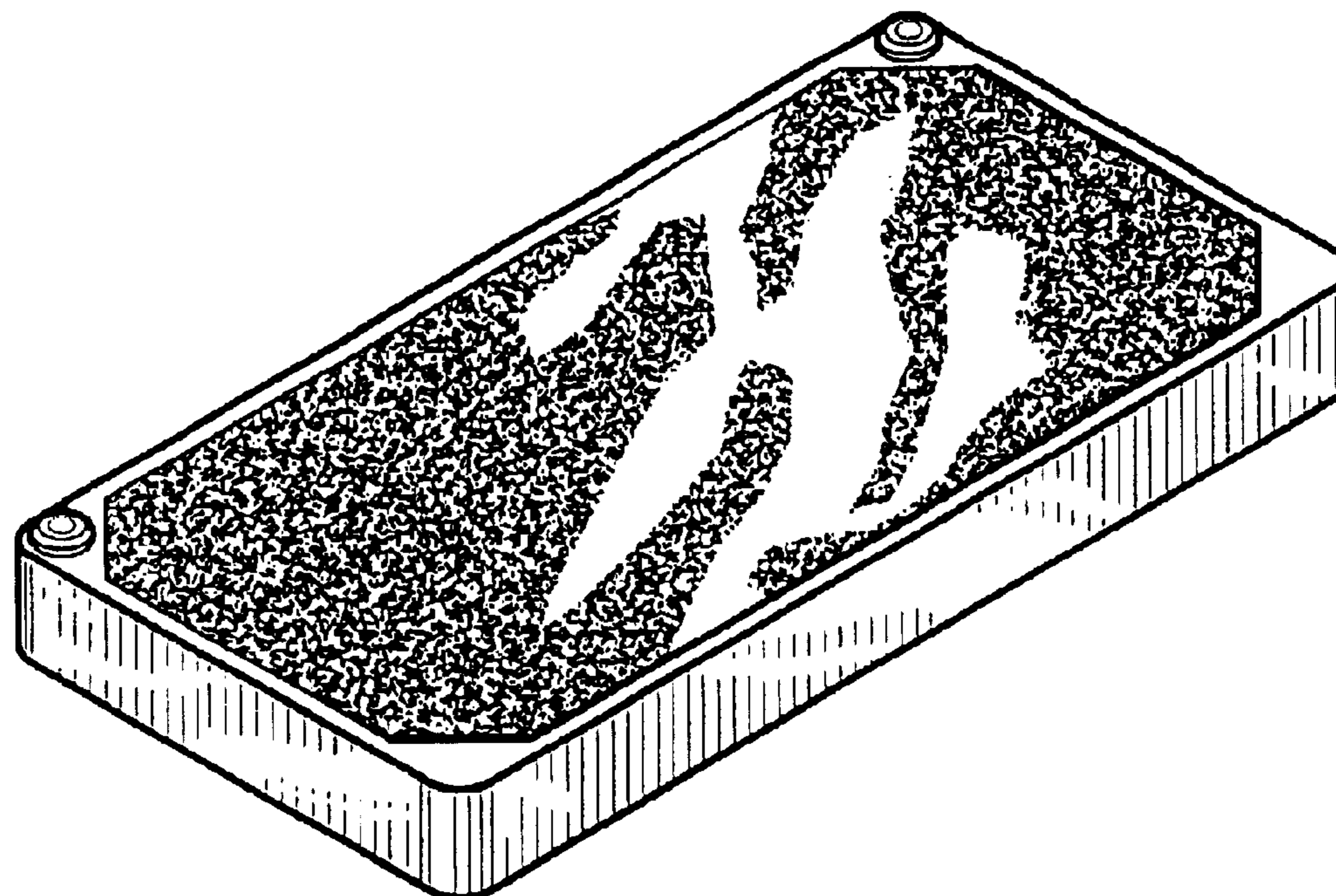

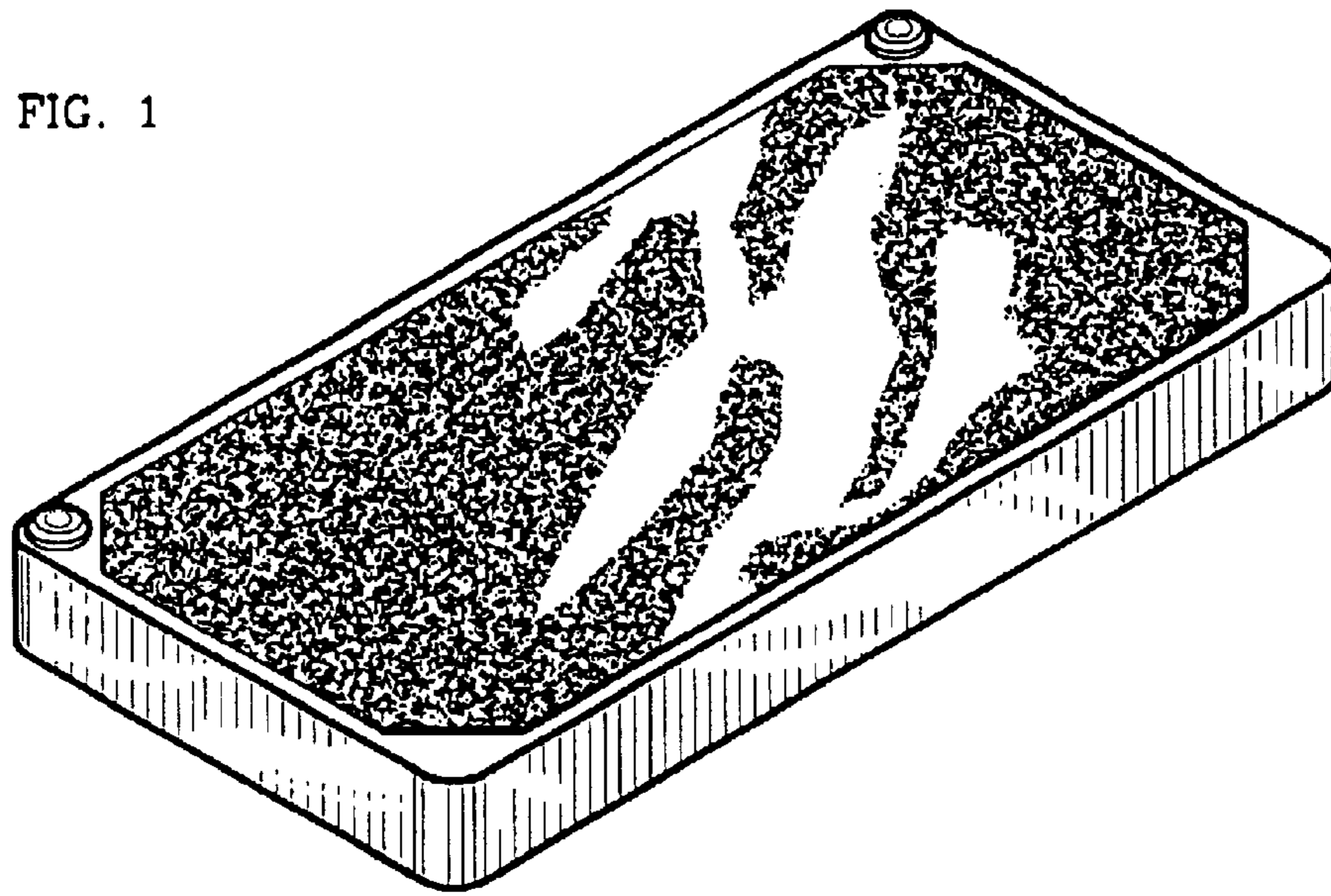

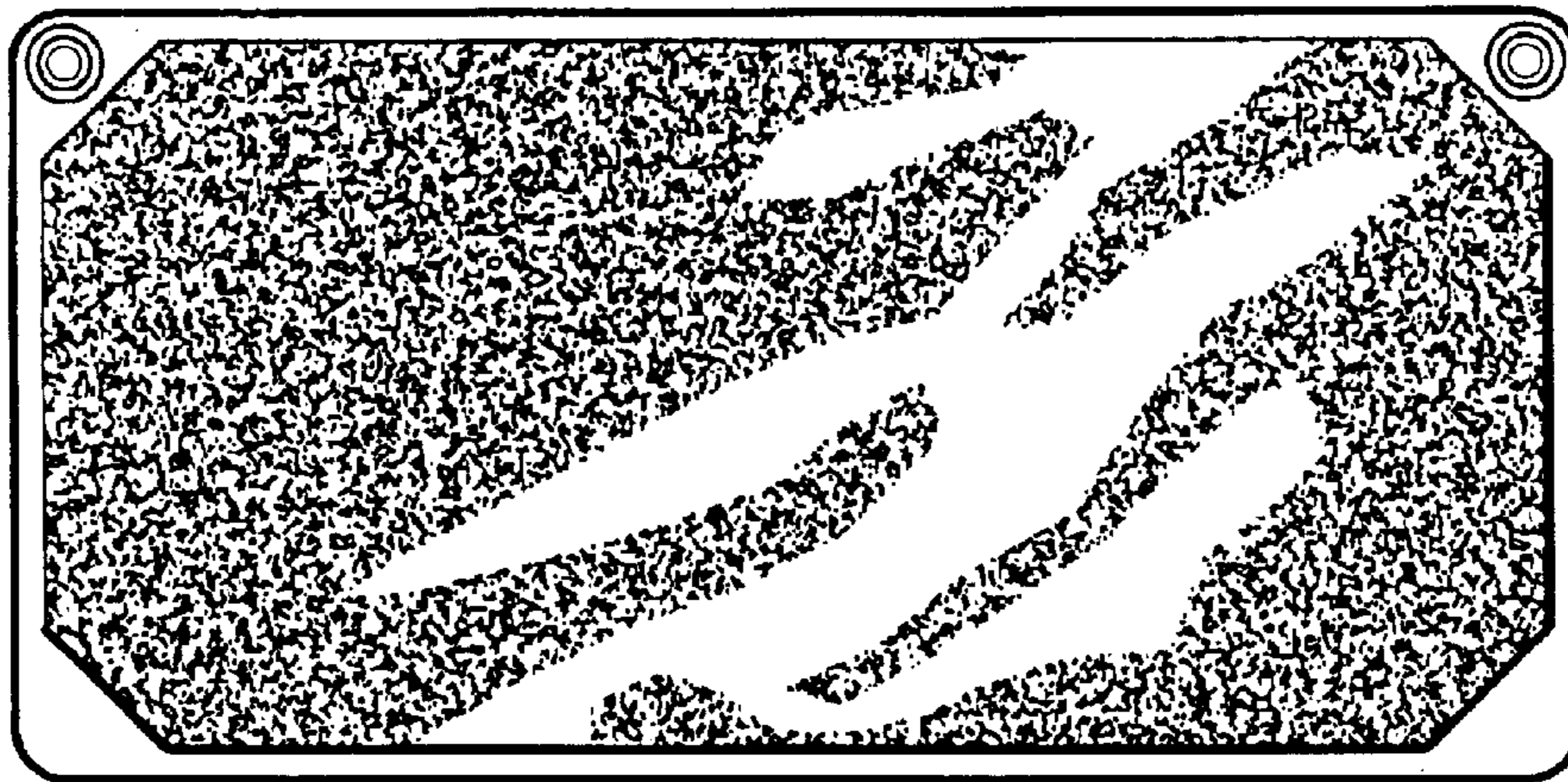

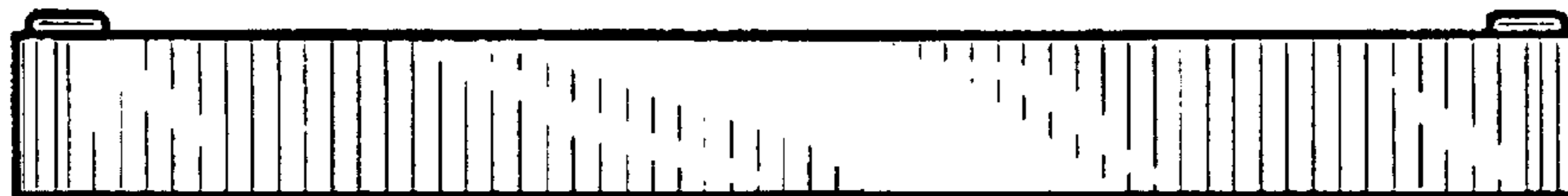

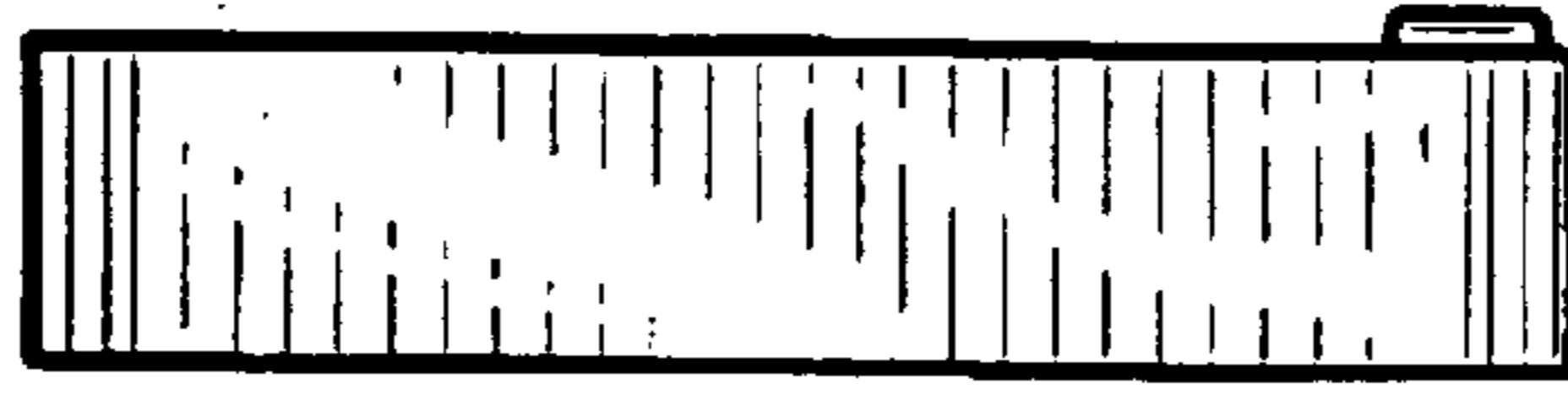

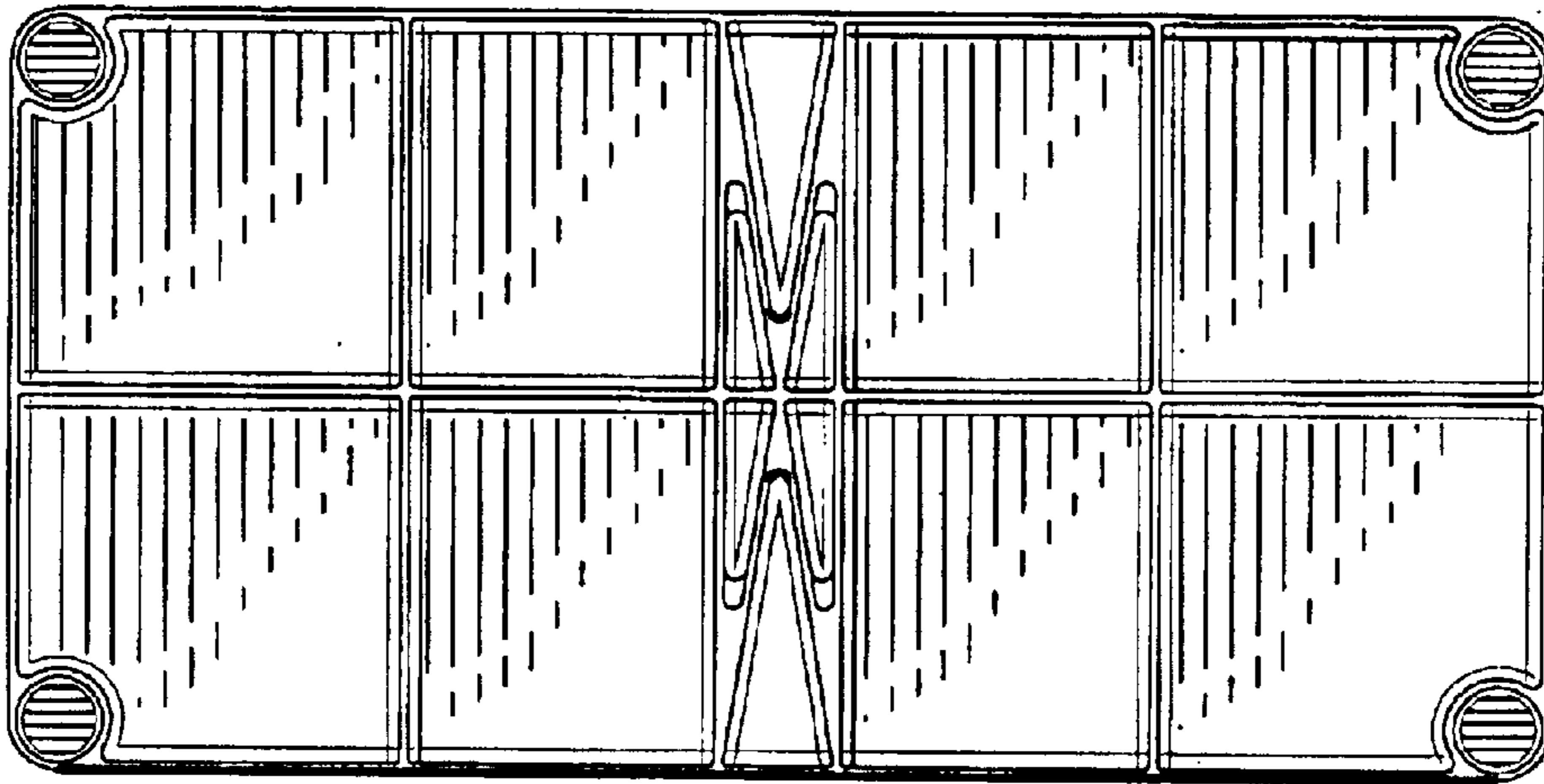

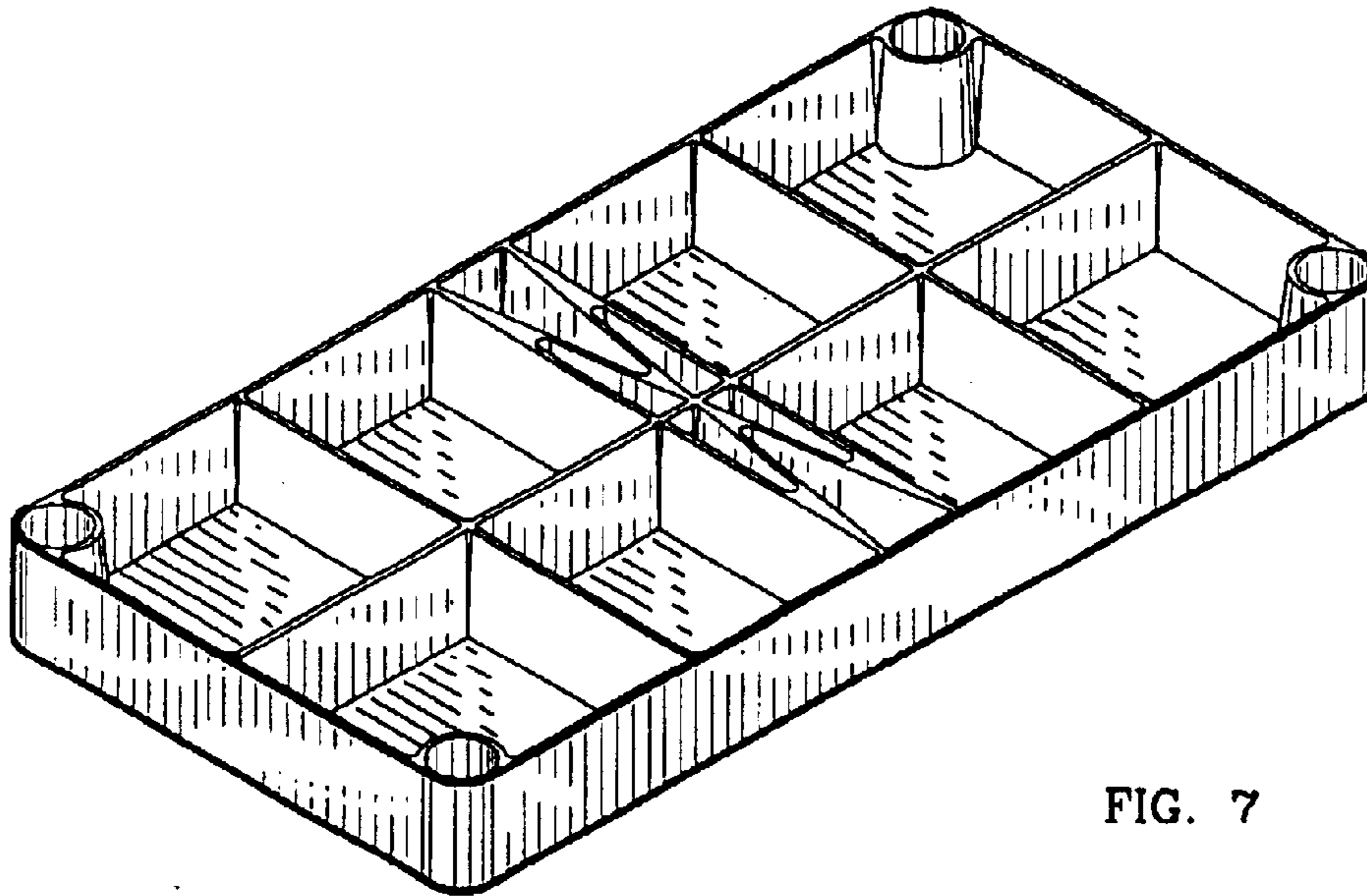
