The ornamental design for an outdoor light, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side and top perspective view of an outdoor light showing my new design;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a front elevational view thereof;

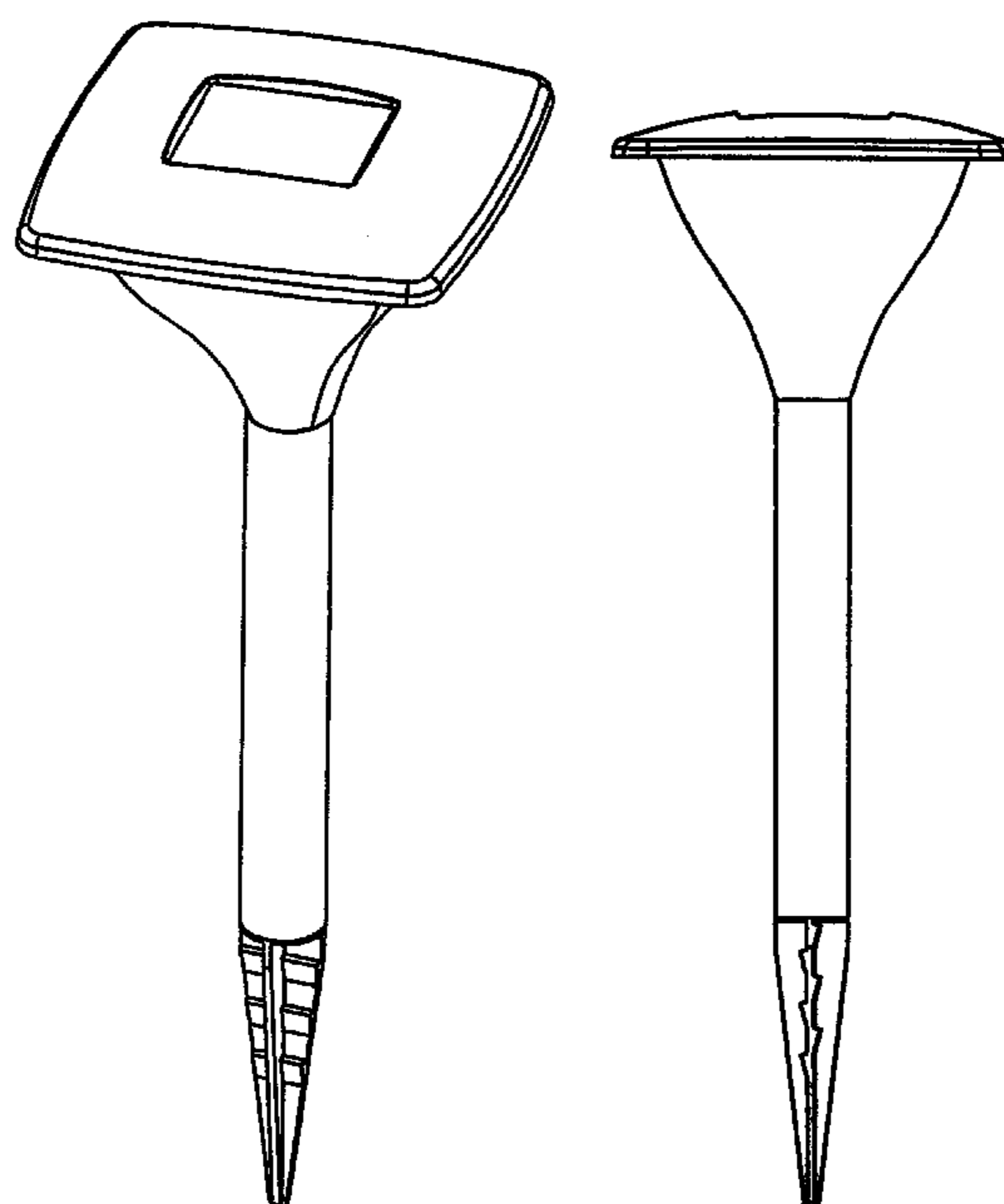
FIG. 4 is a top plan view thereof;

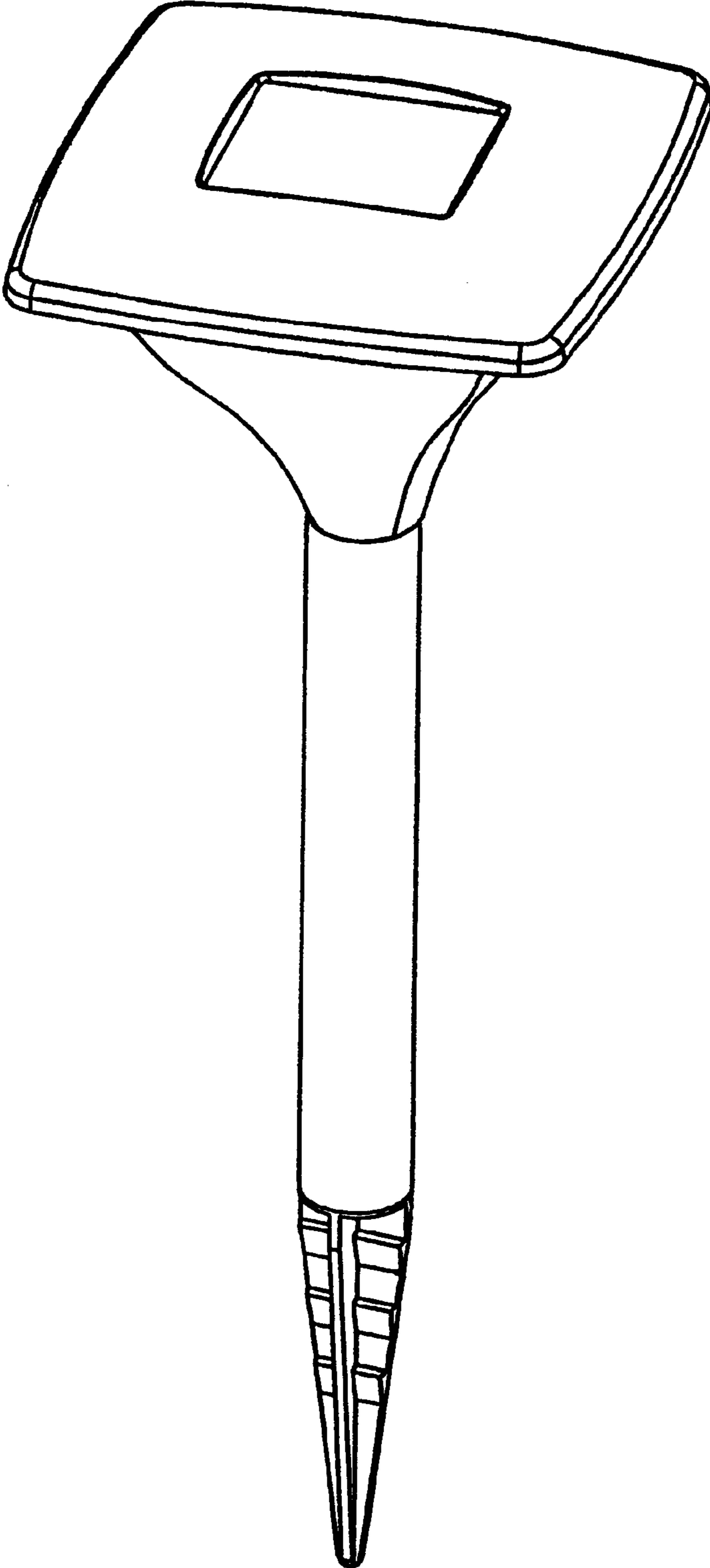
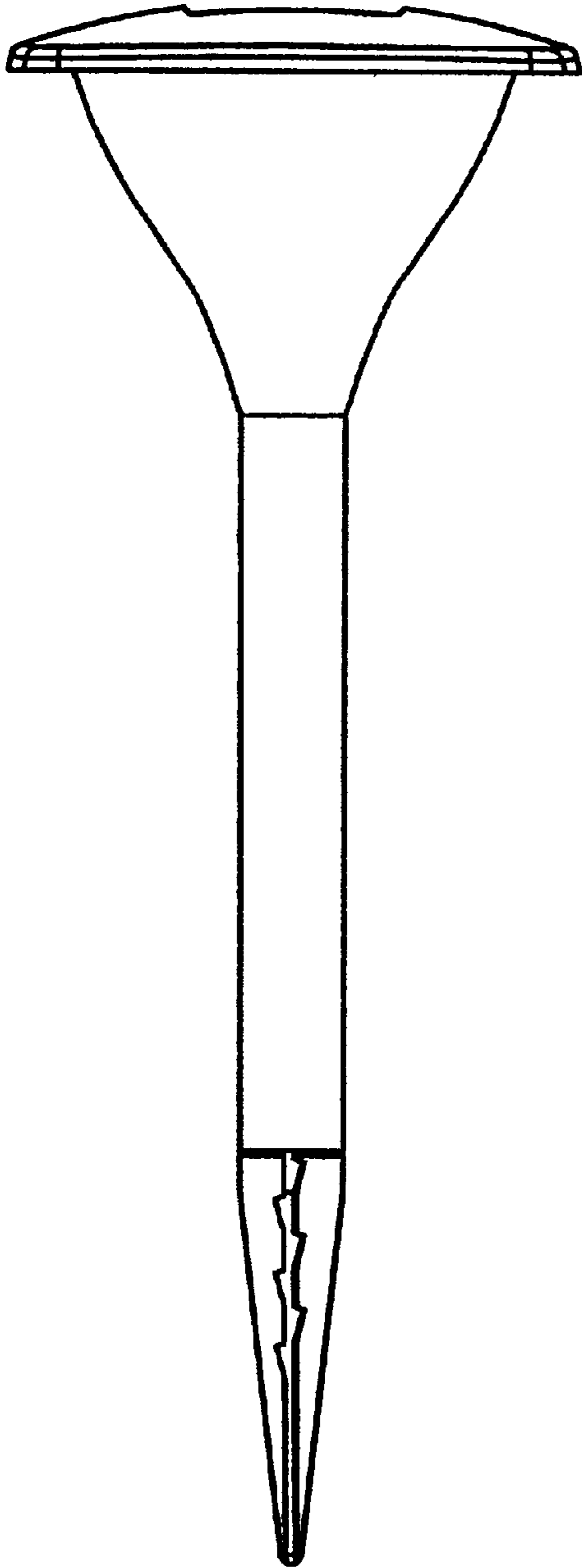
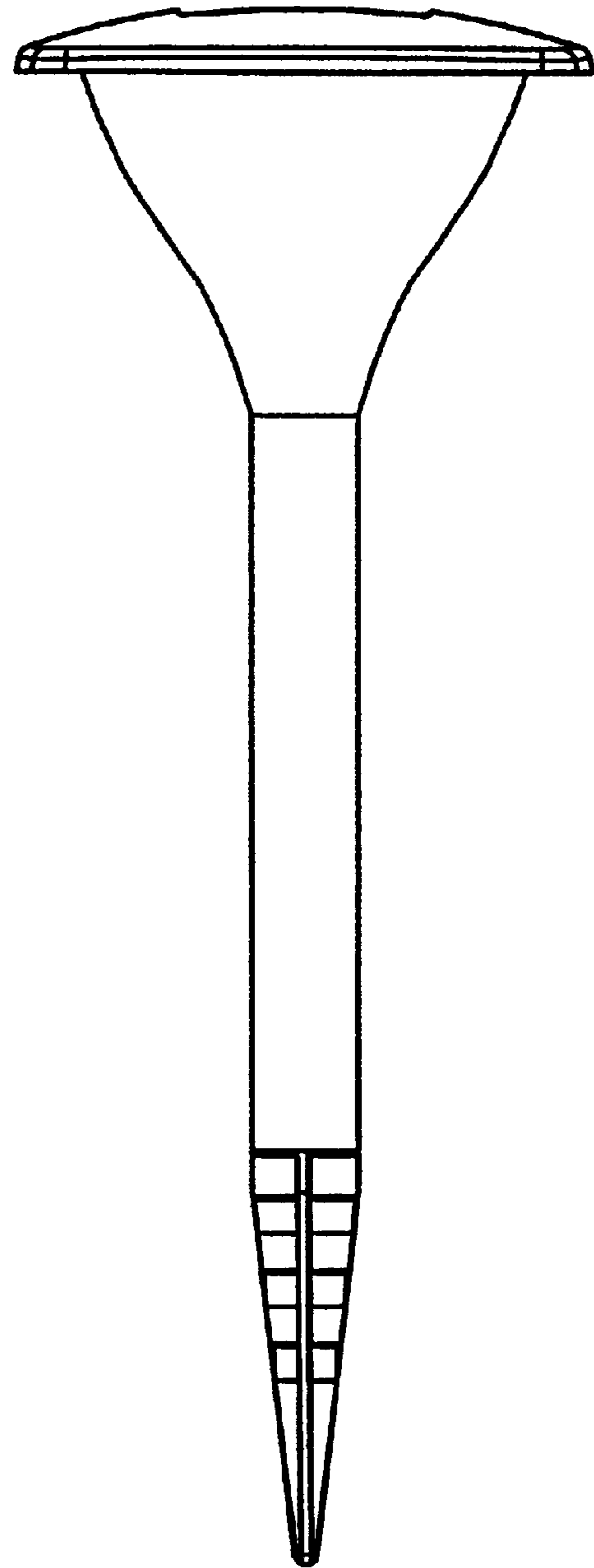


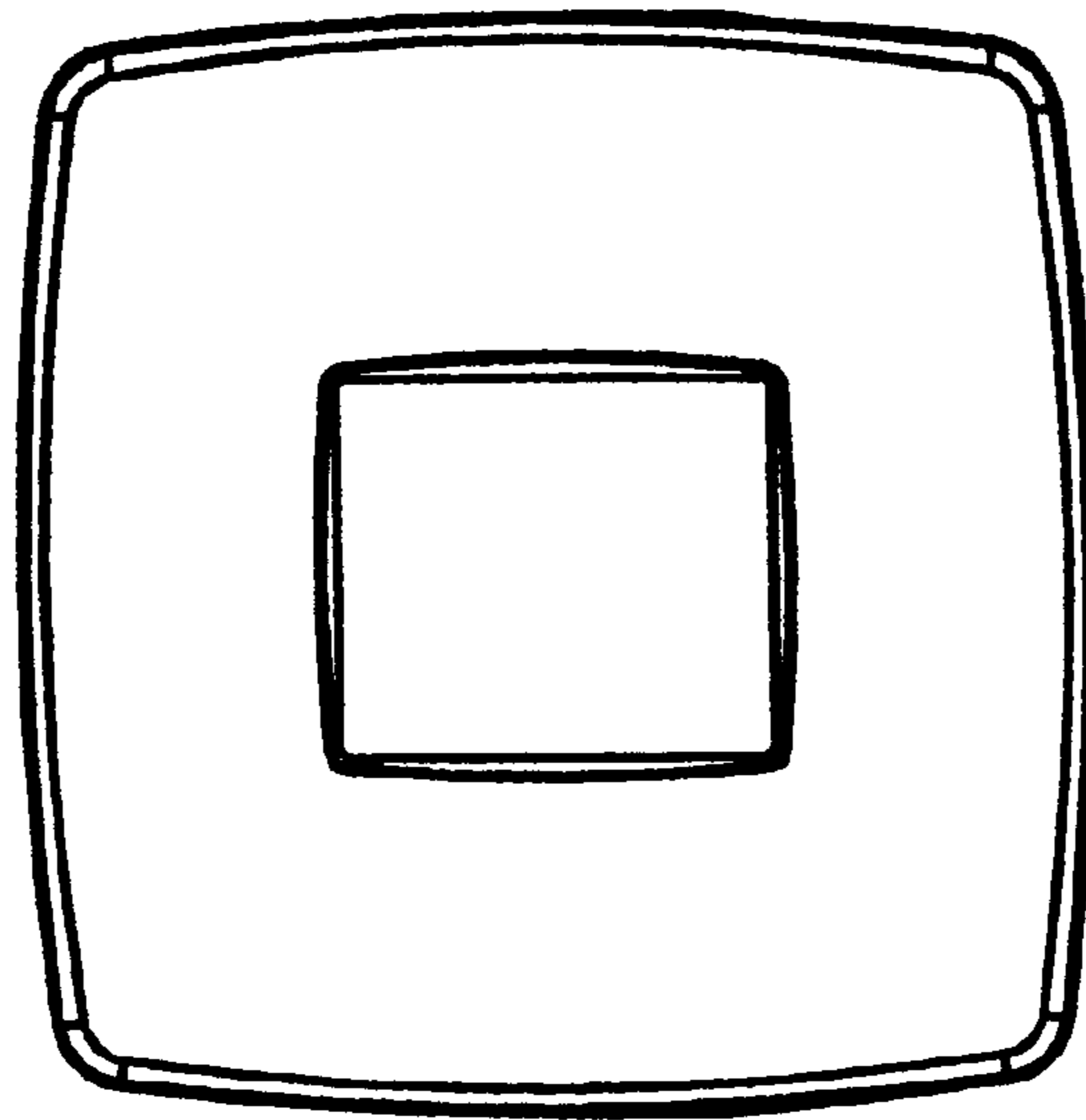

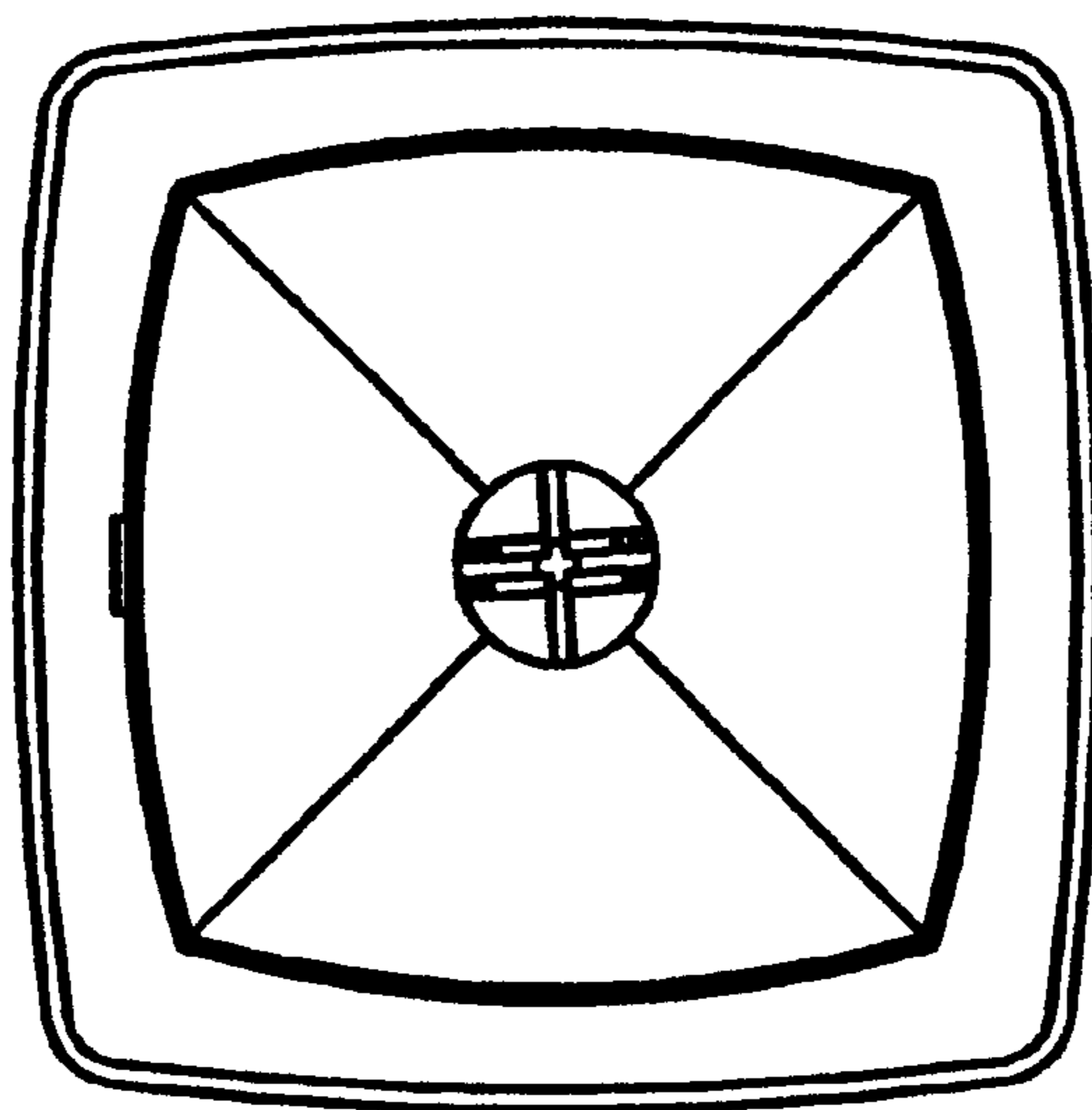

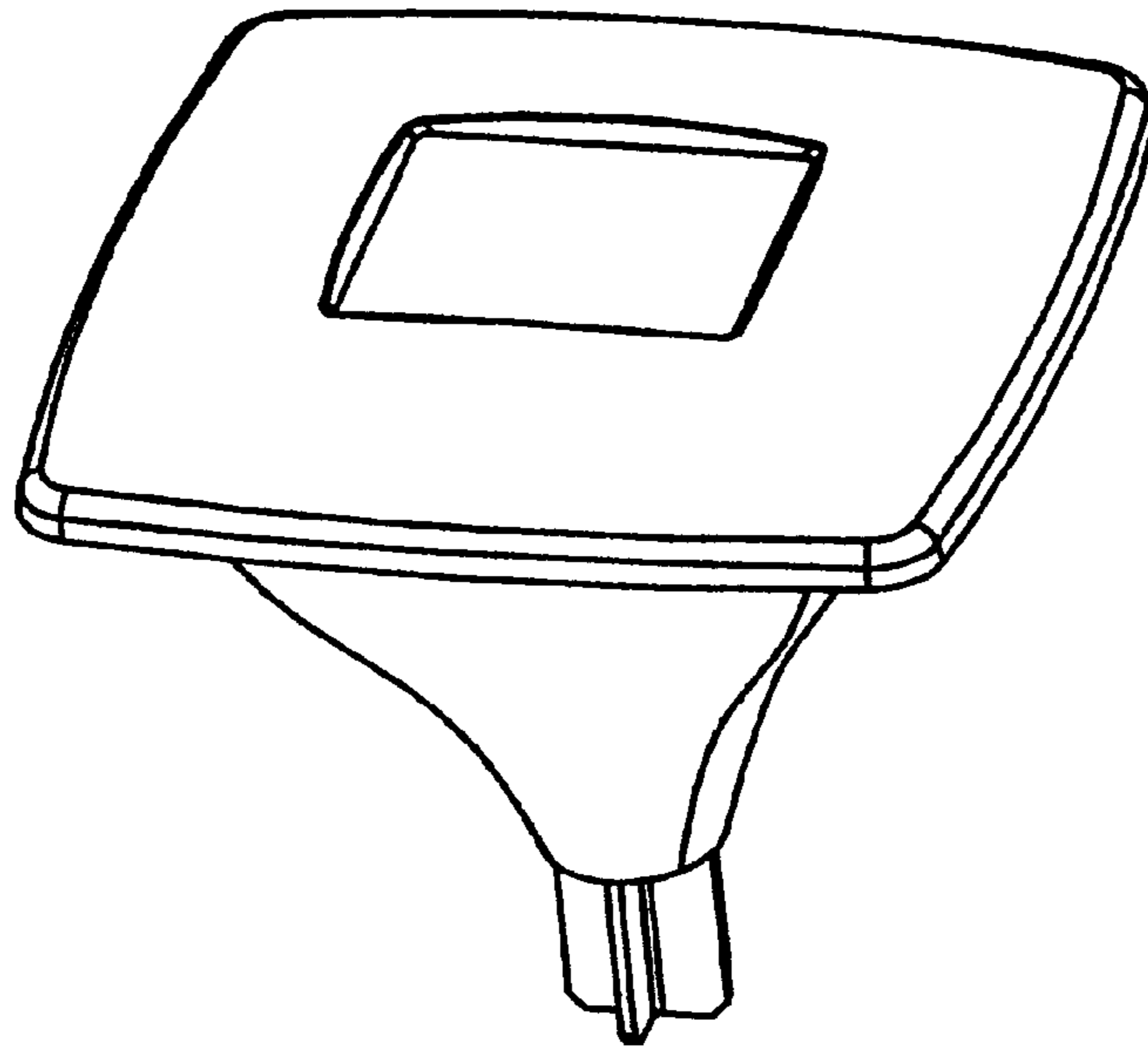

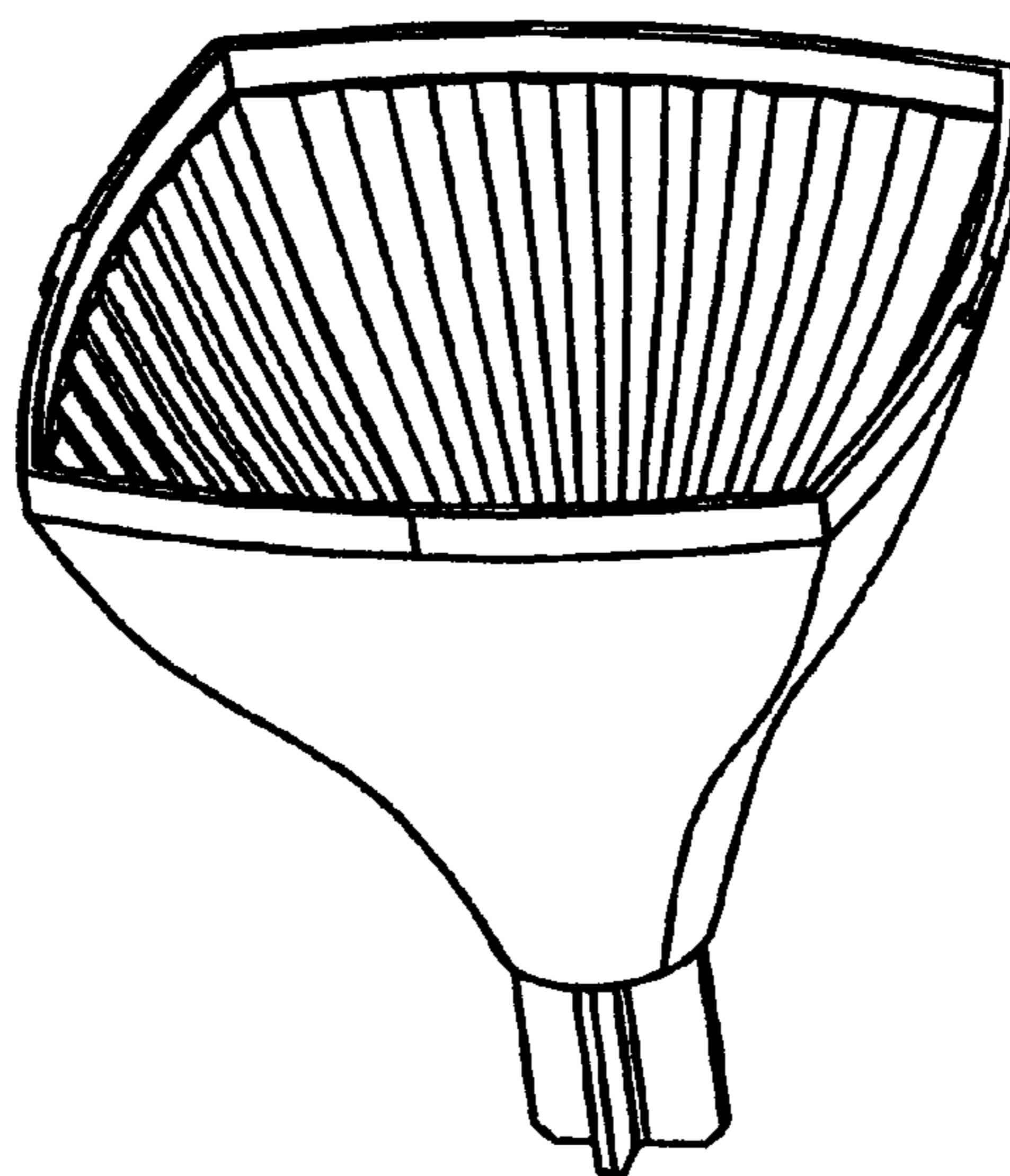
