The ornamental design for a hummingbird feeder, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a hummingbird feeder showing a first exemplary embodiment of our new design; FIG. 2 is right side view in elevation of the hummingbird feeder shown in FIG. 1;

FIG. 3 is a top plan view of the hummingbird feeder shown in FIG. 1;

FIG. 12 is a left side view in elevation of the hummingbird feeder shown in FIG. 8;

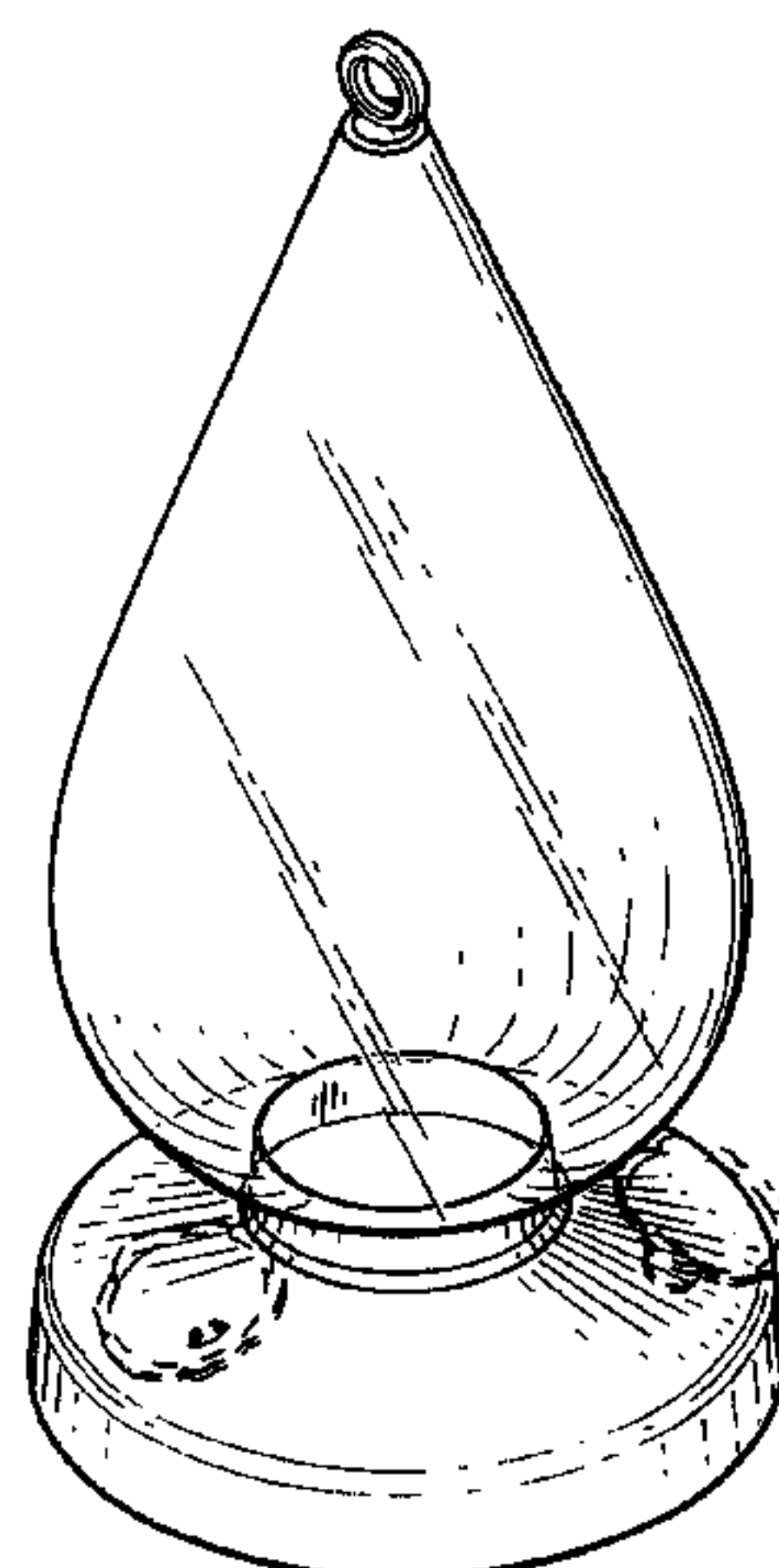
FIG. 13 is a front view in elevation of the hummingbird feeder shown in FIG. 8; and,

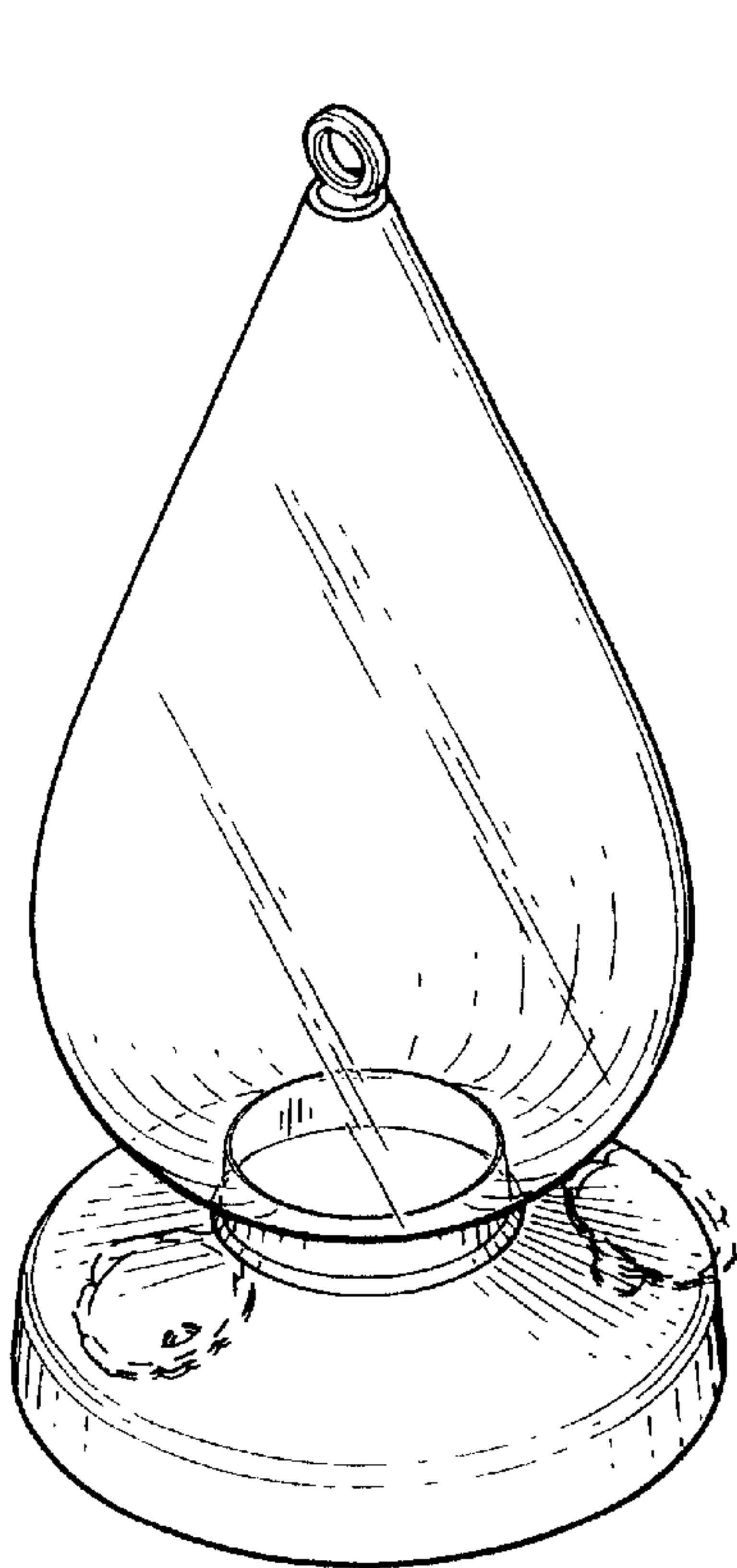

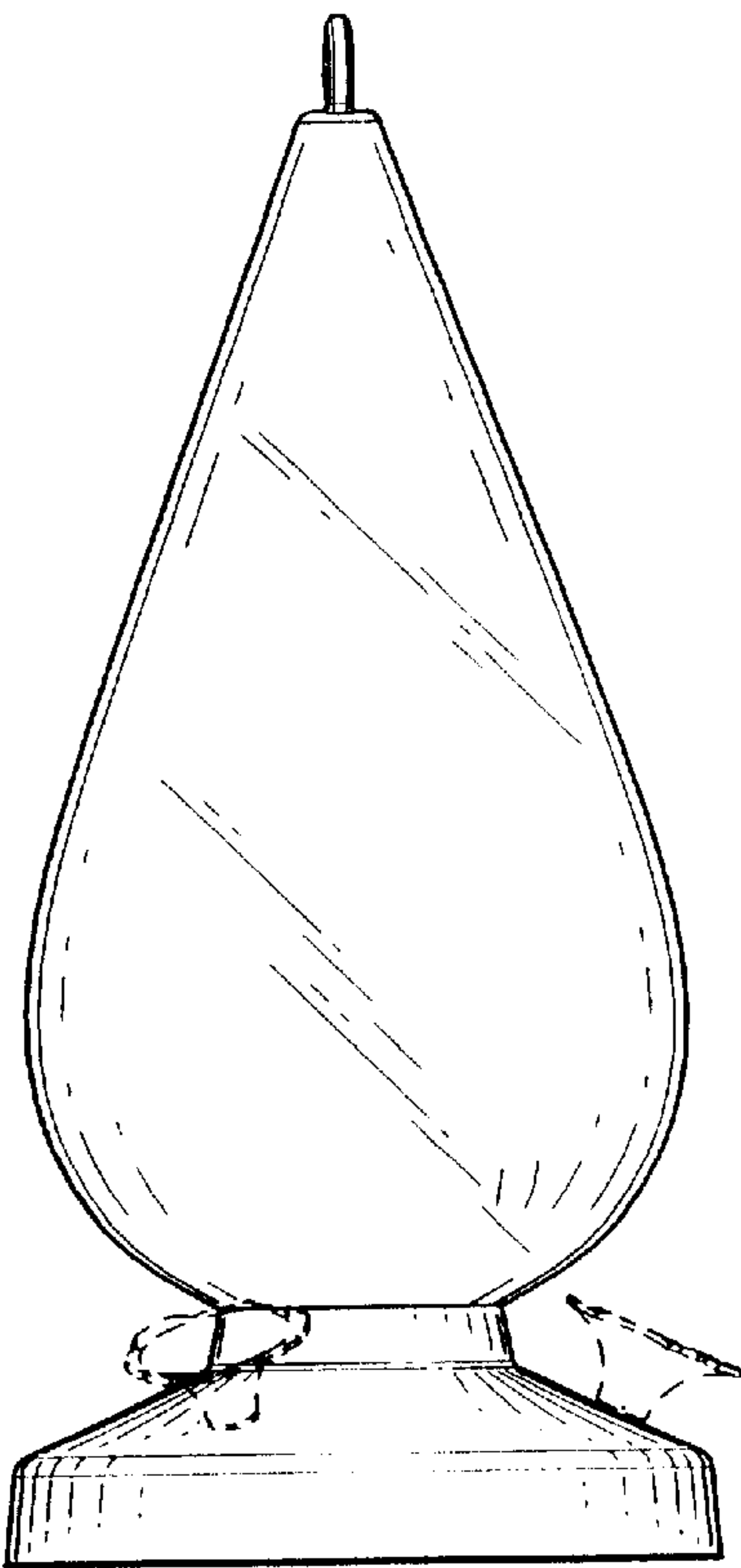

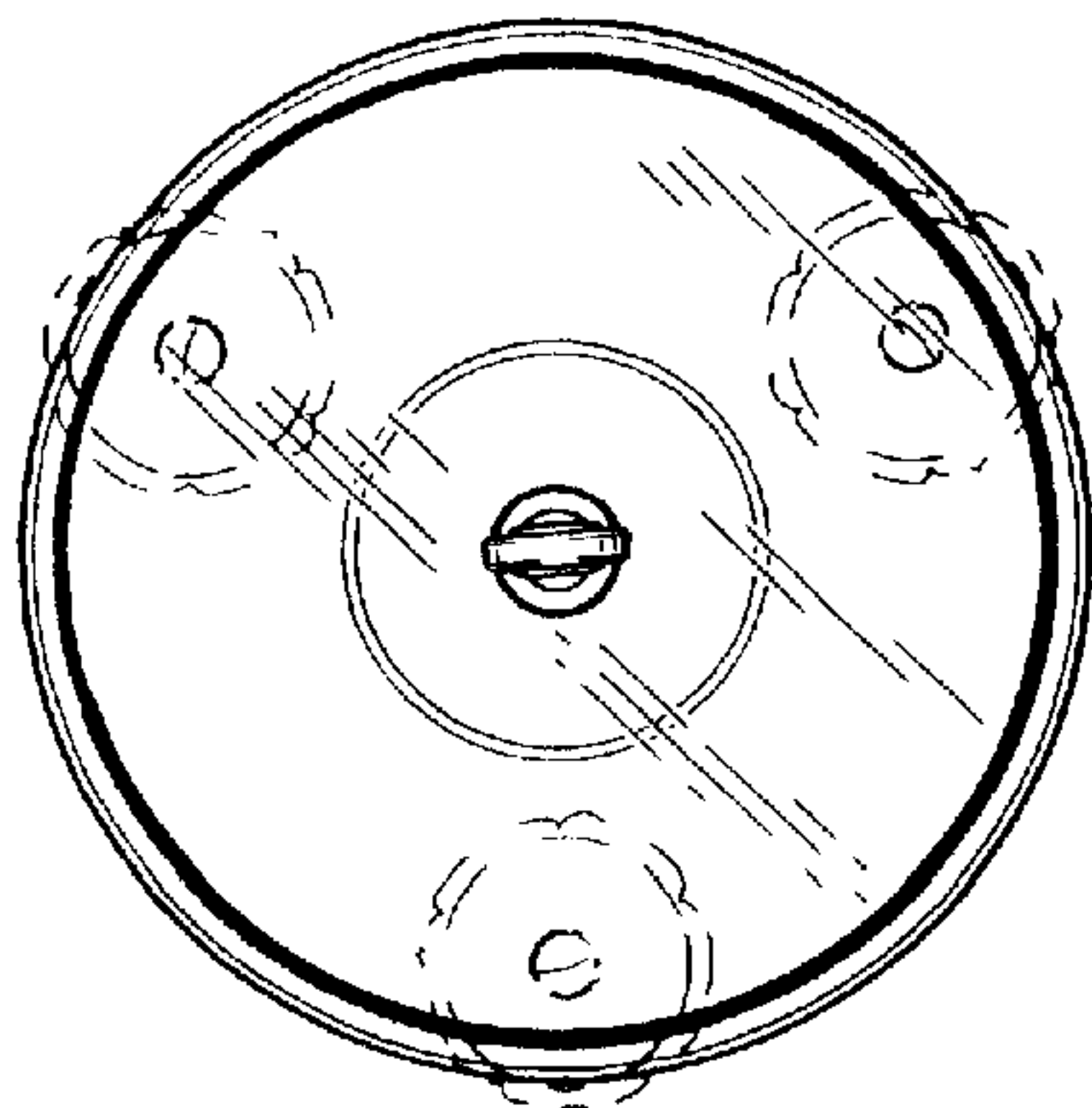

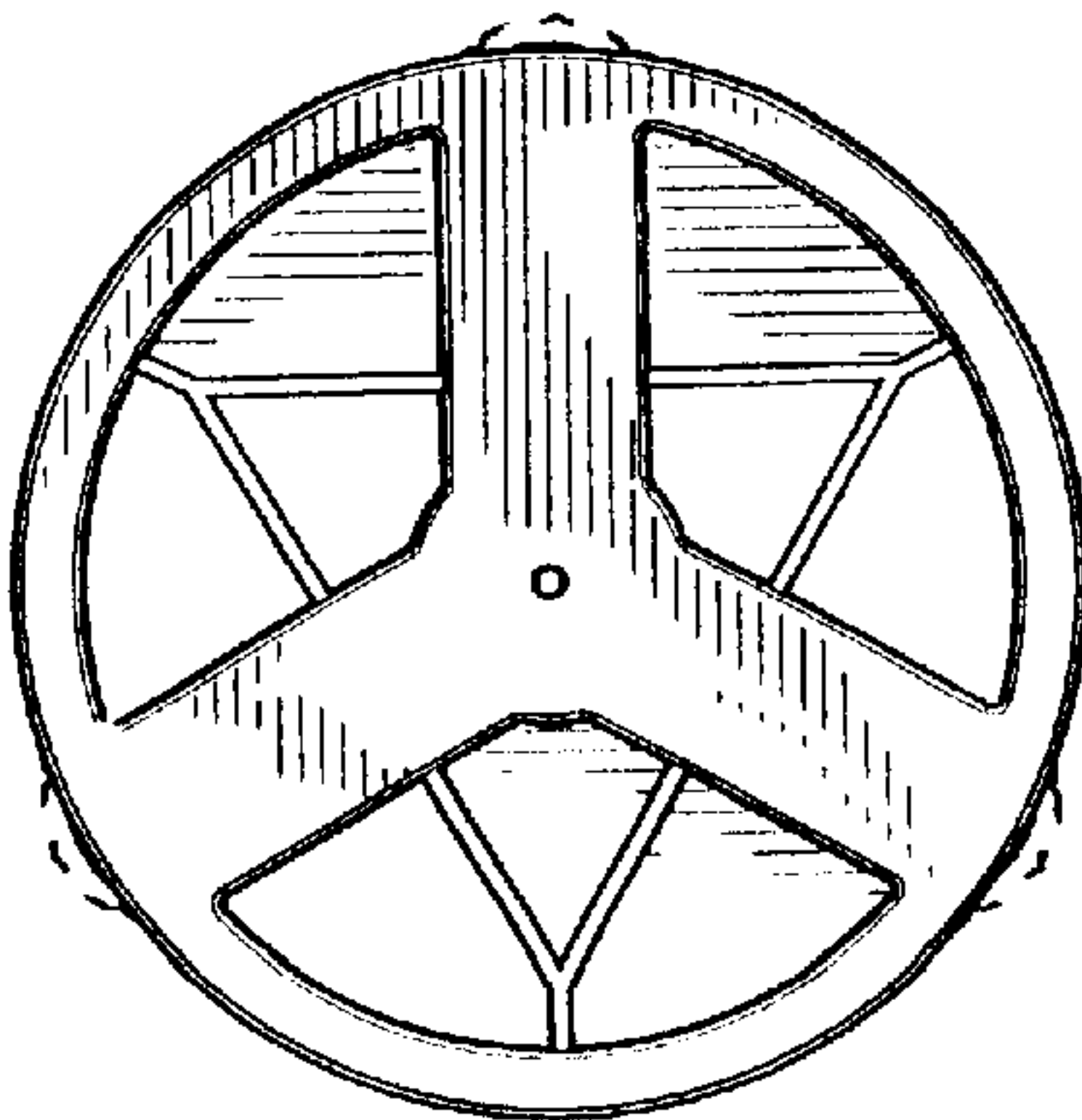

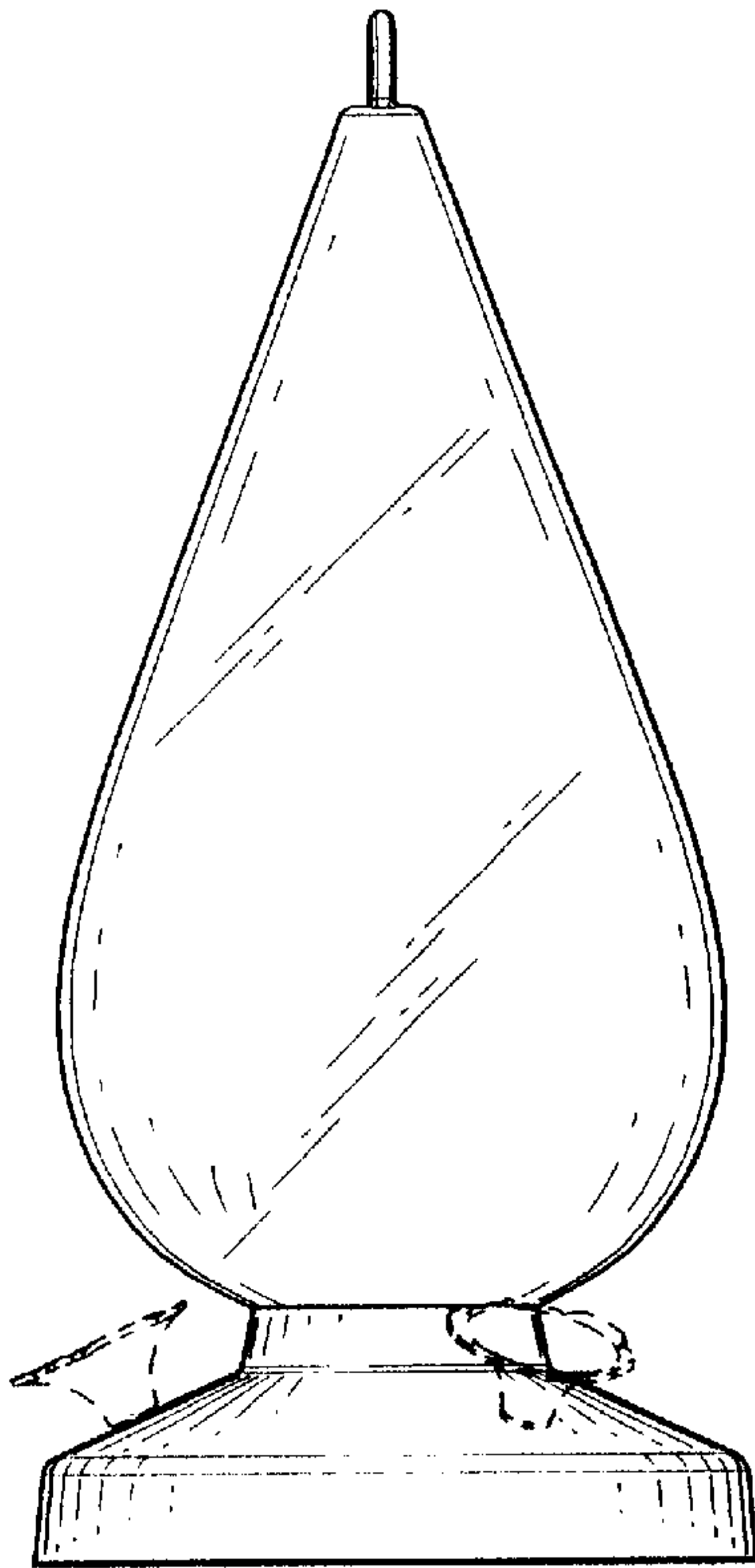

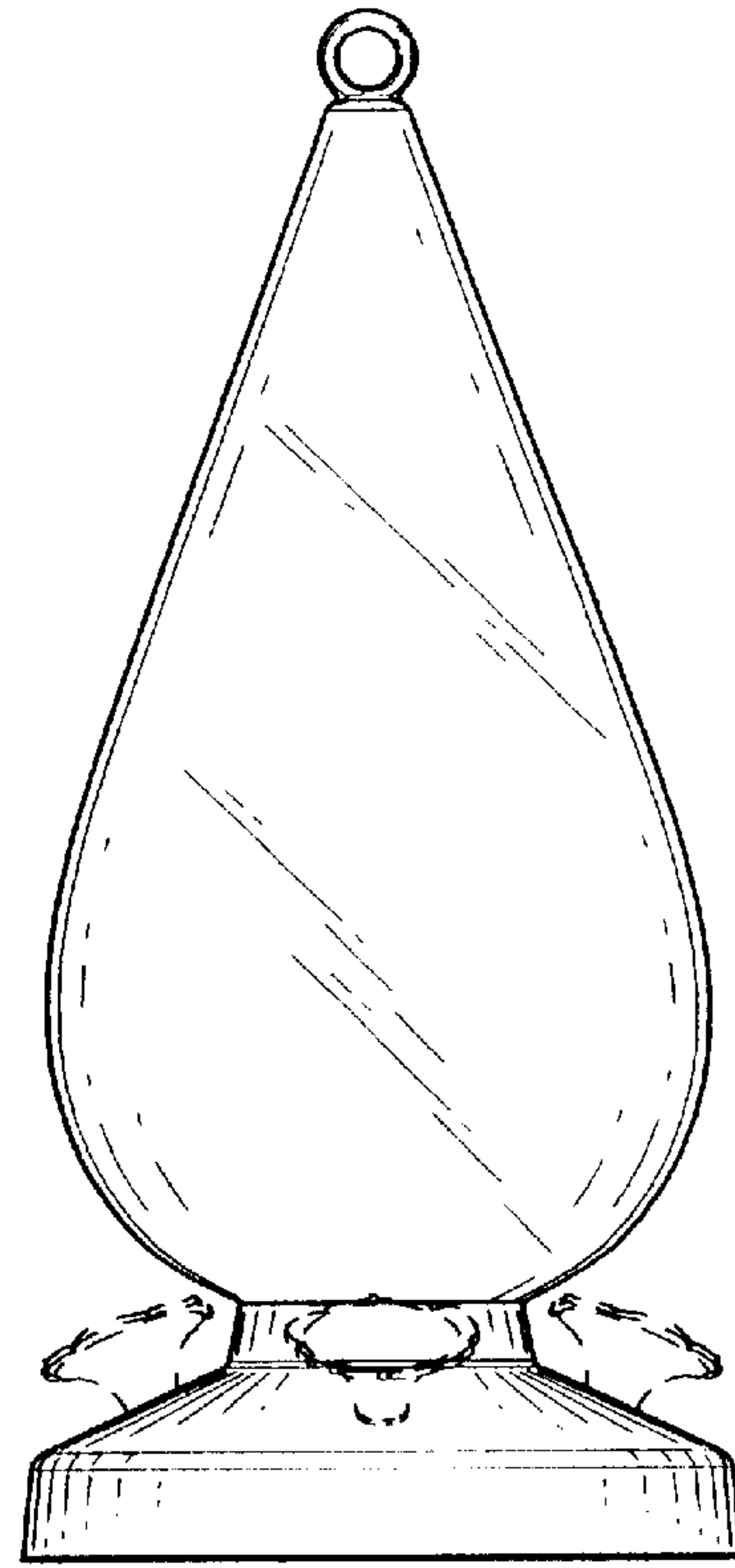

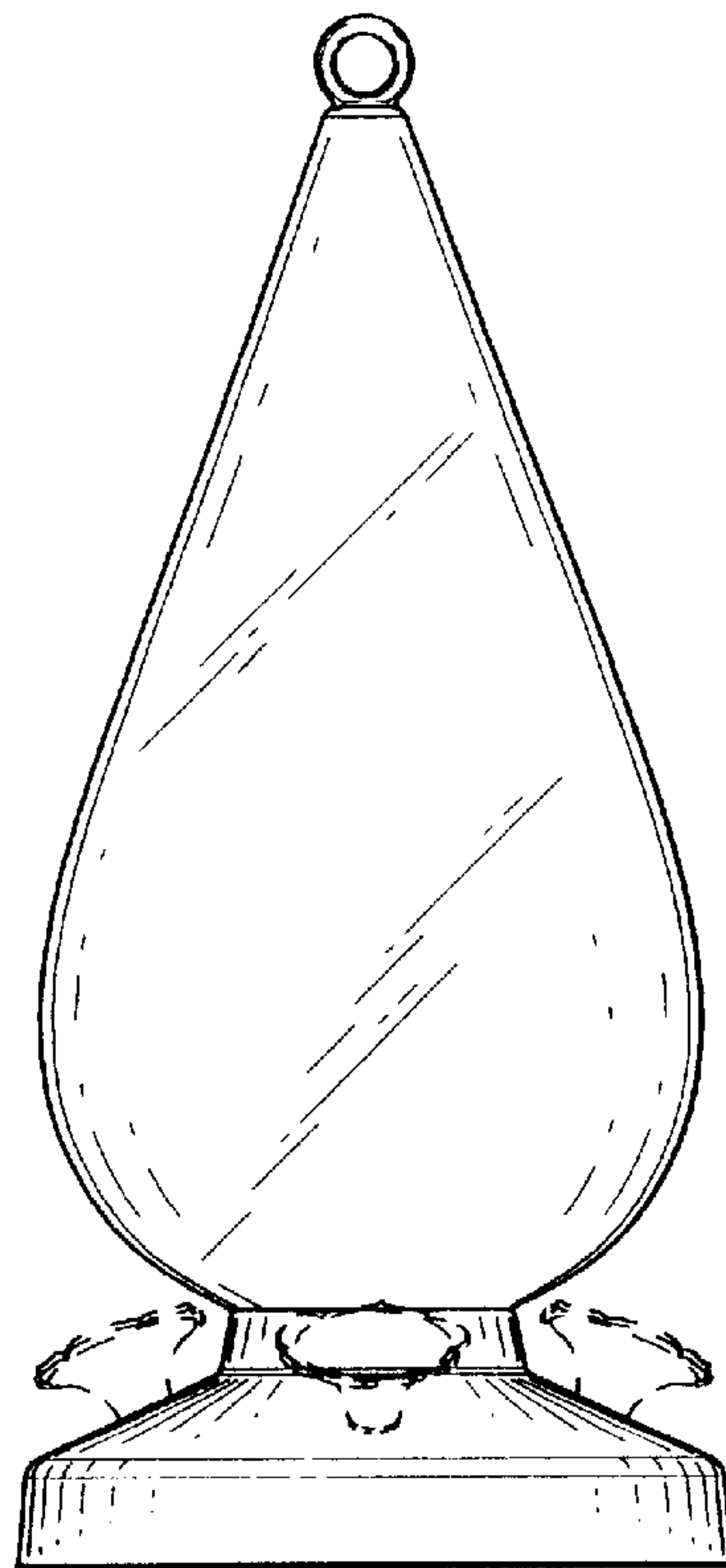

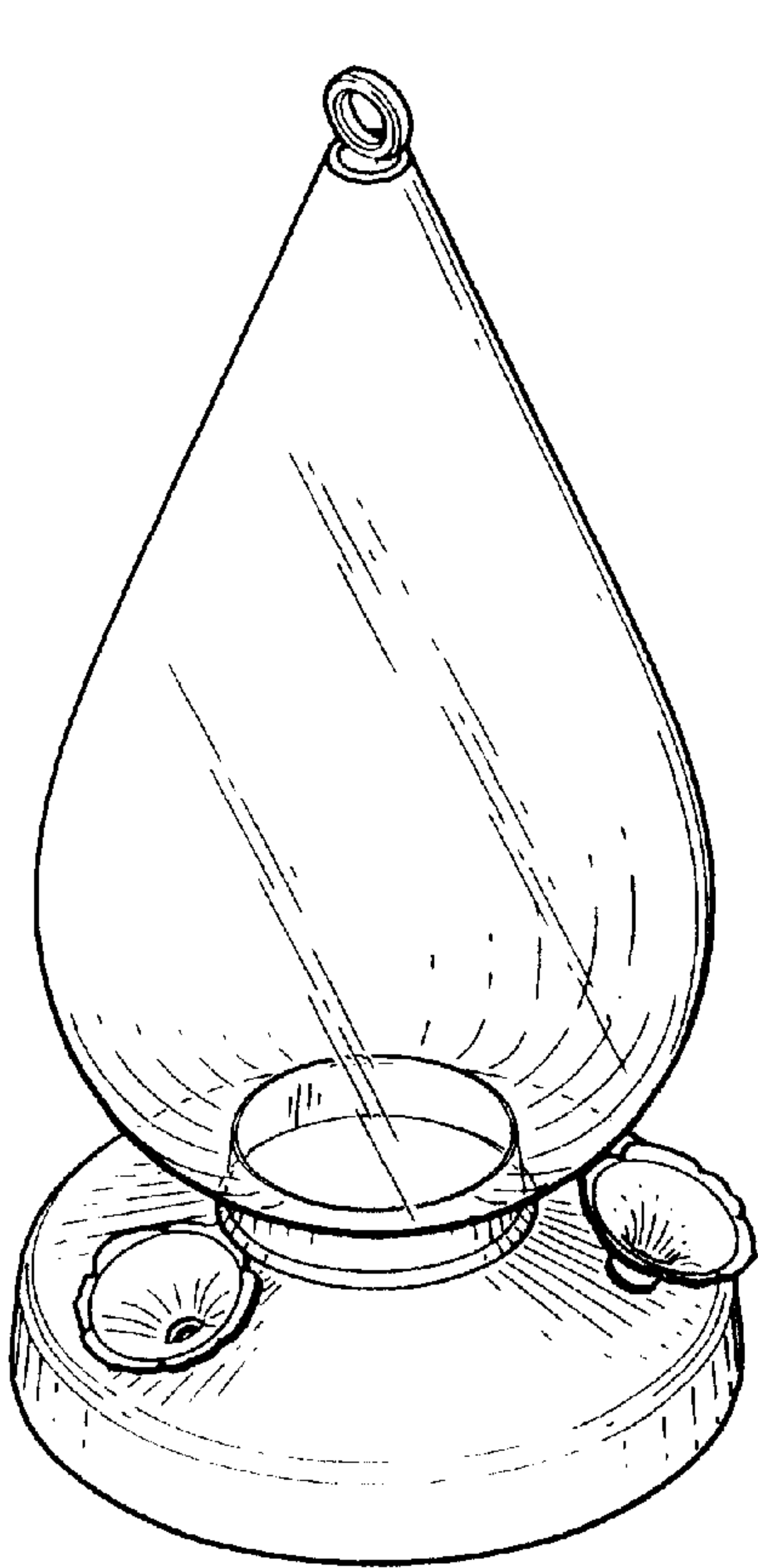

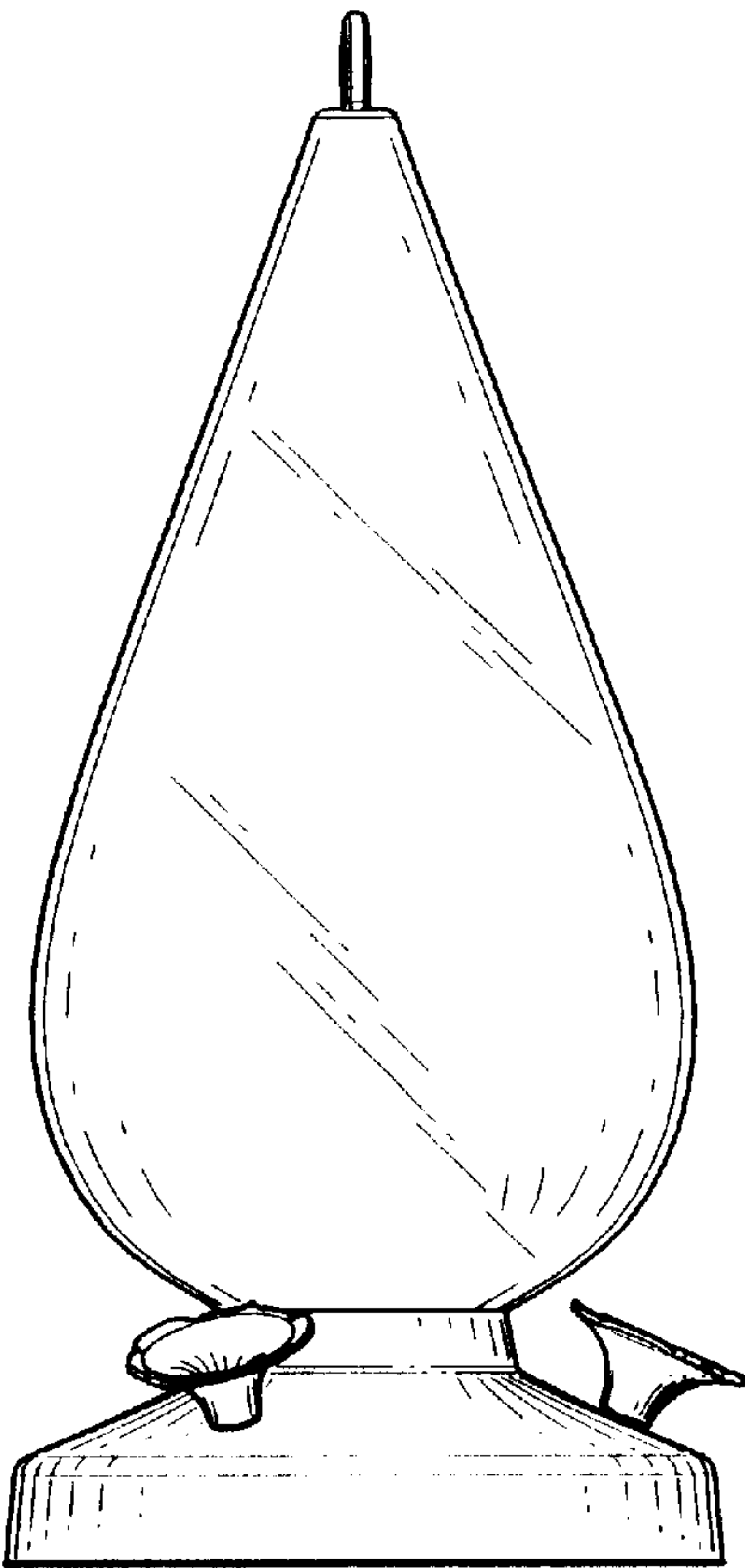

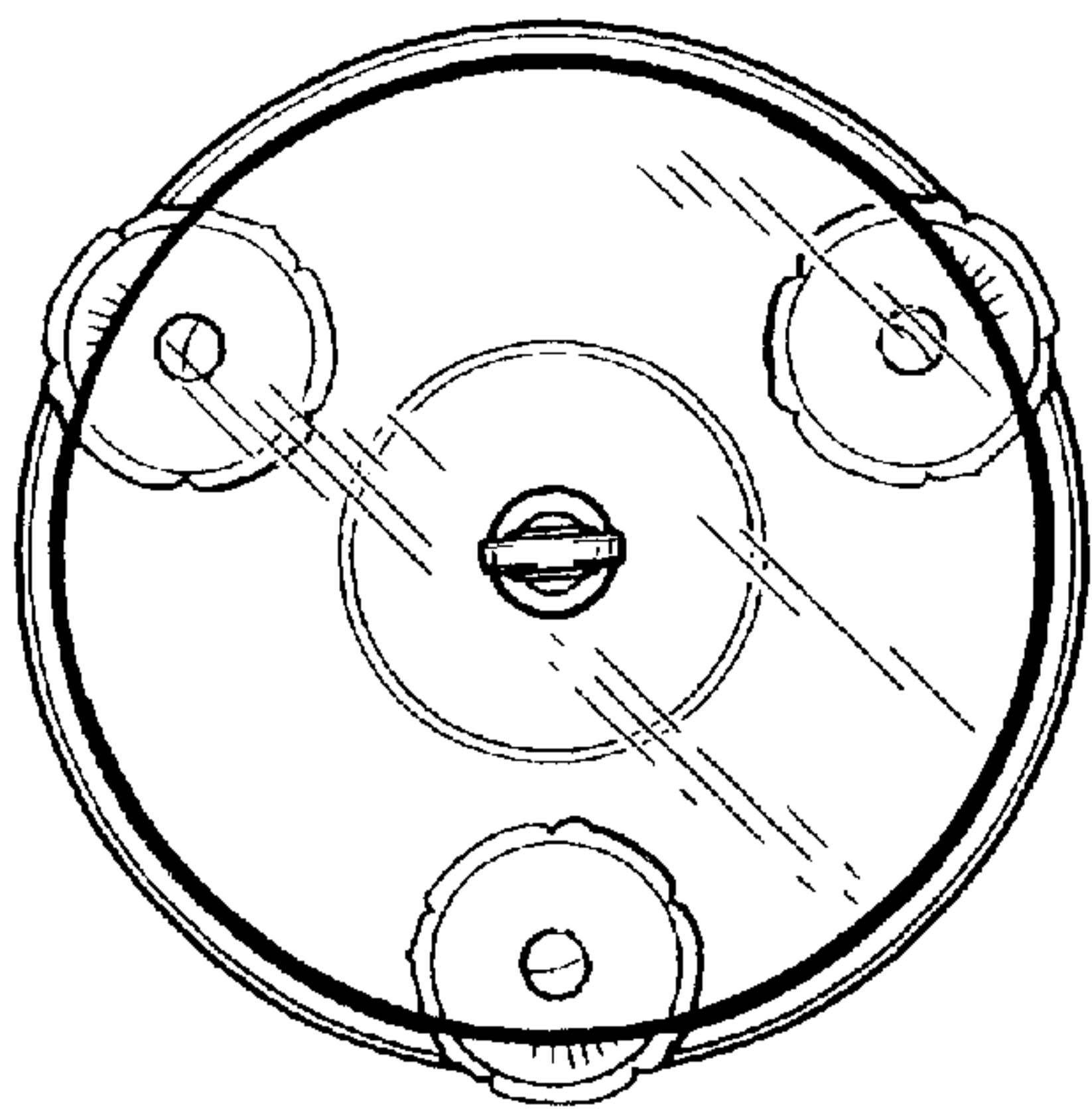

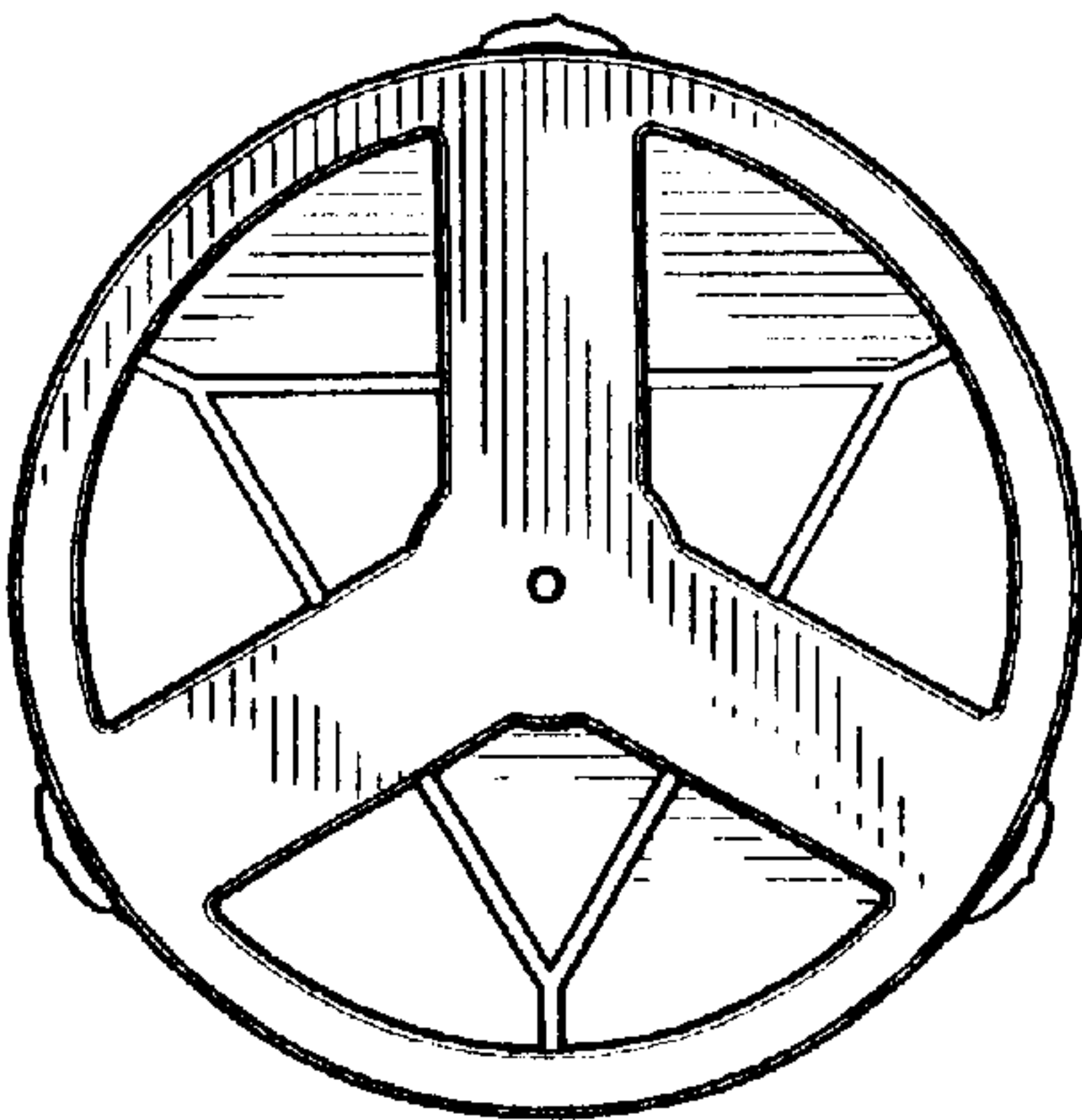

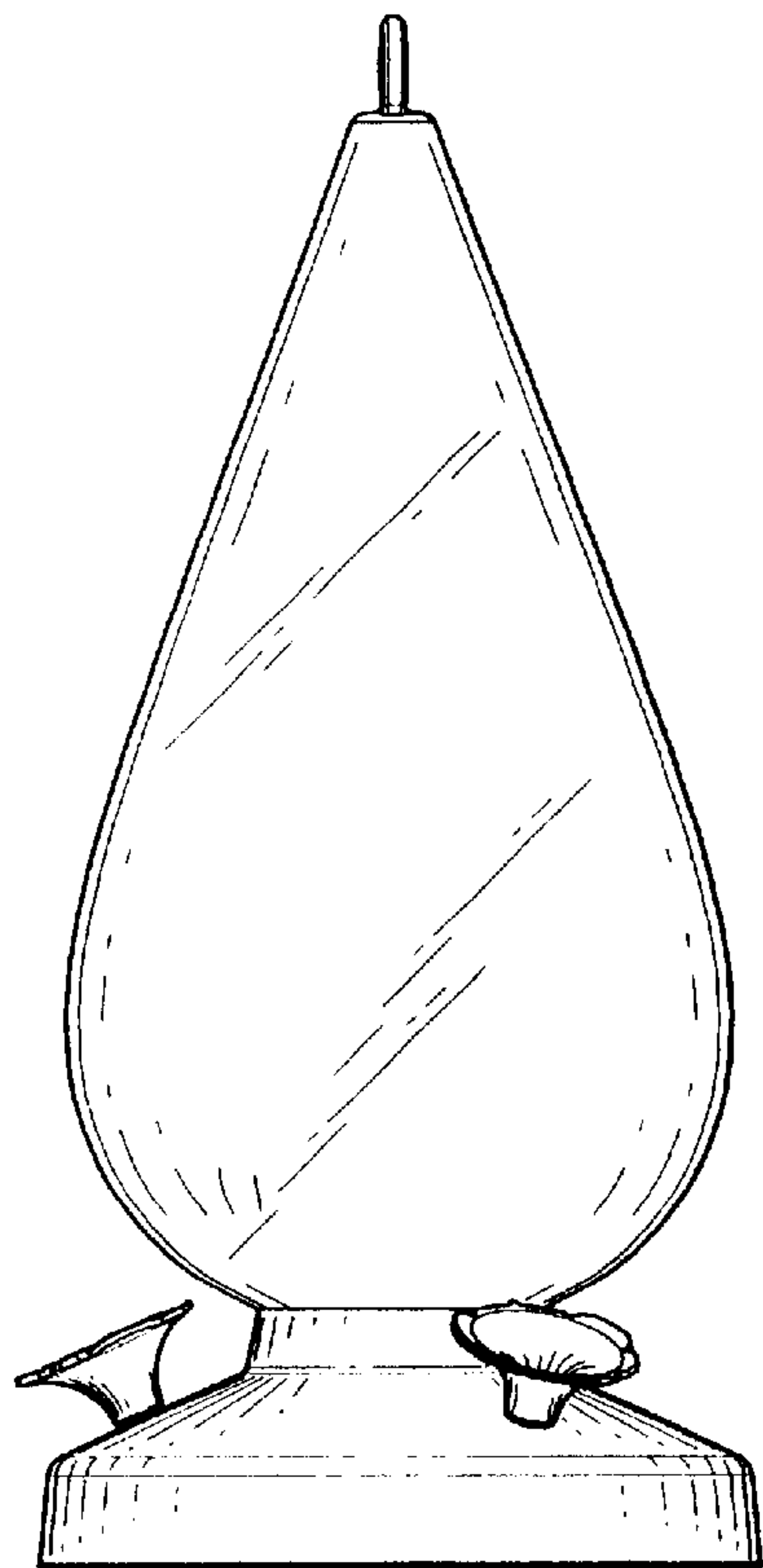

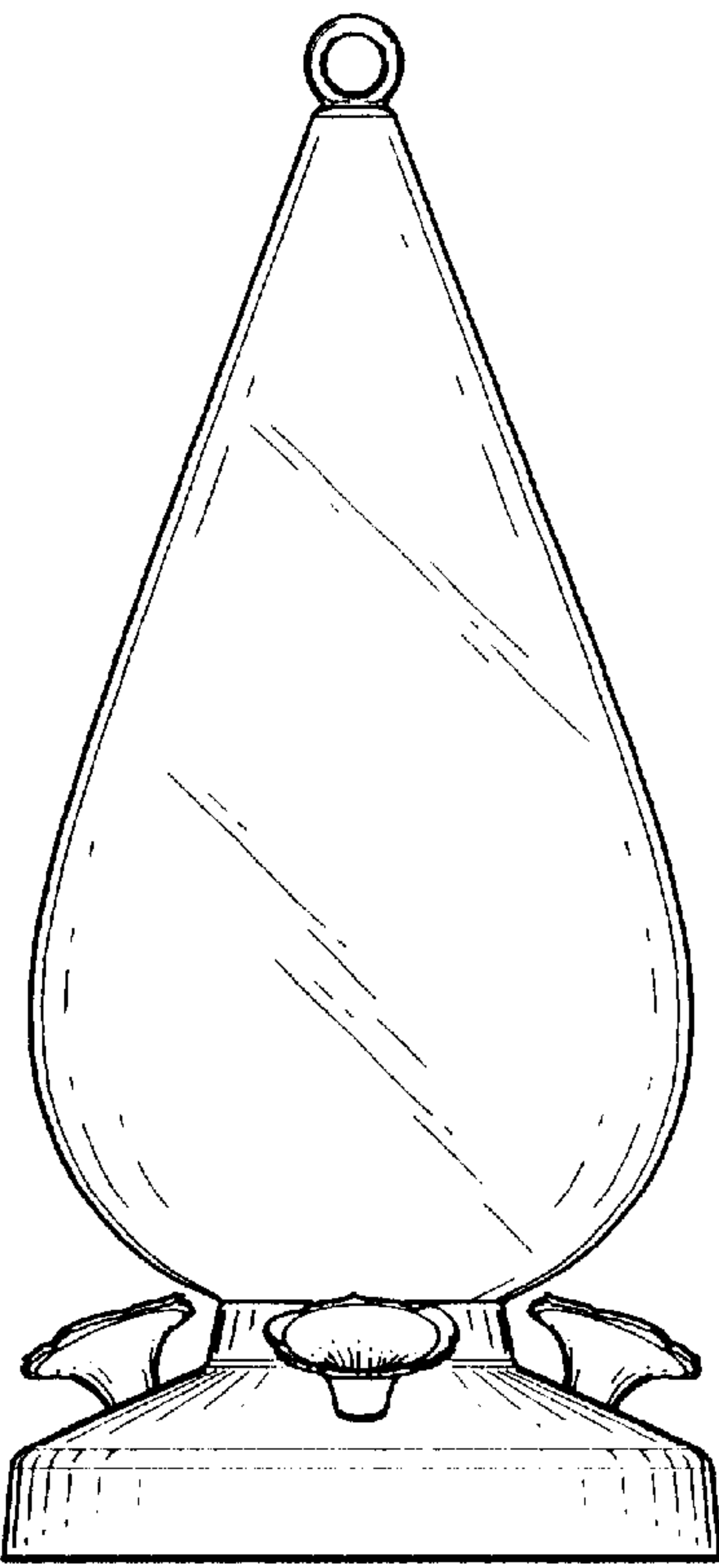

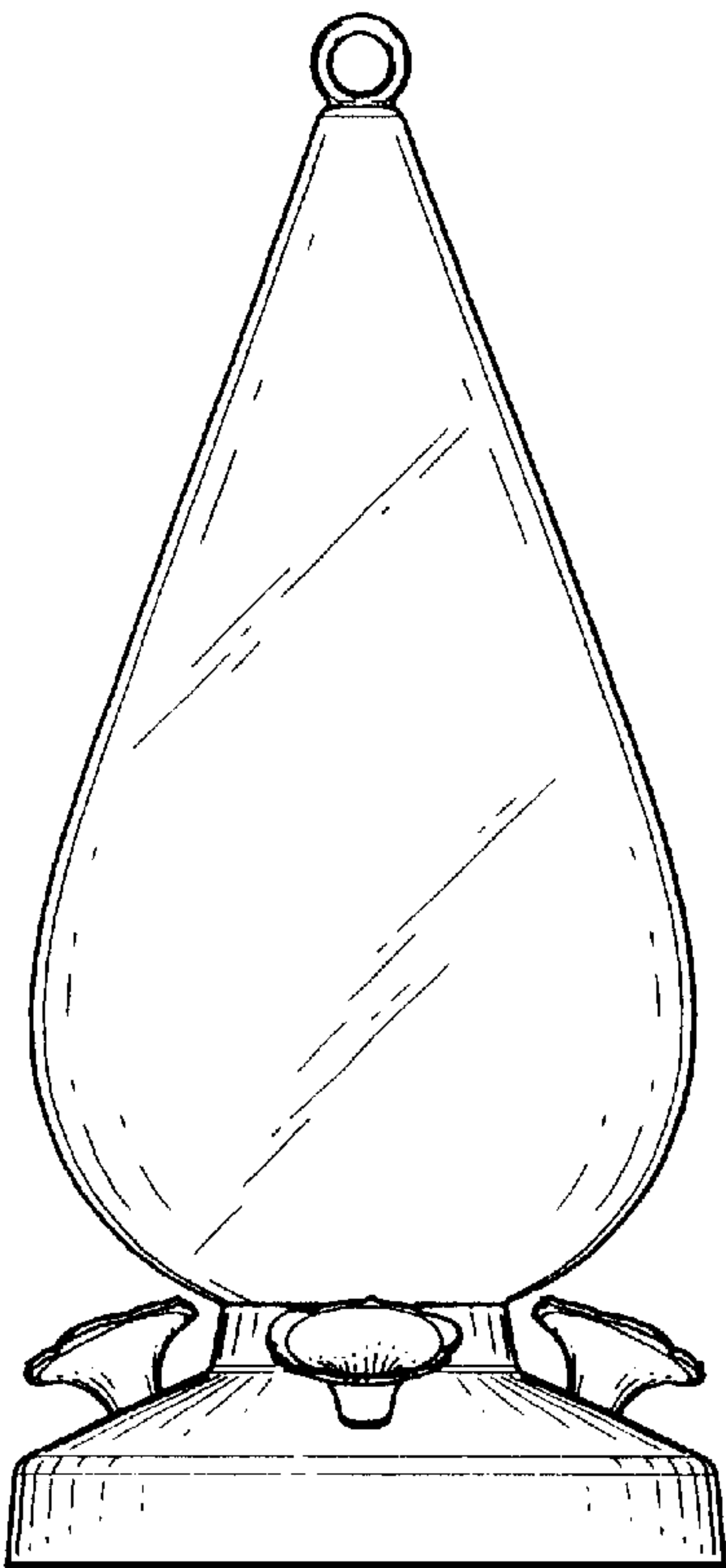
