FIG. 13 is a bottom plan view thereof.

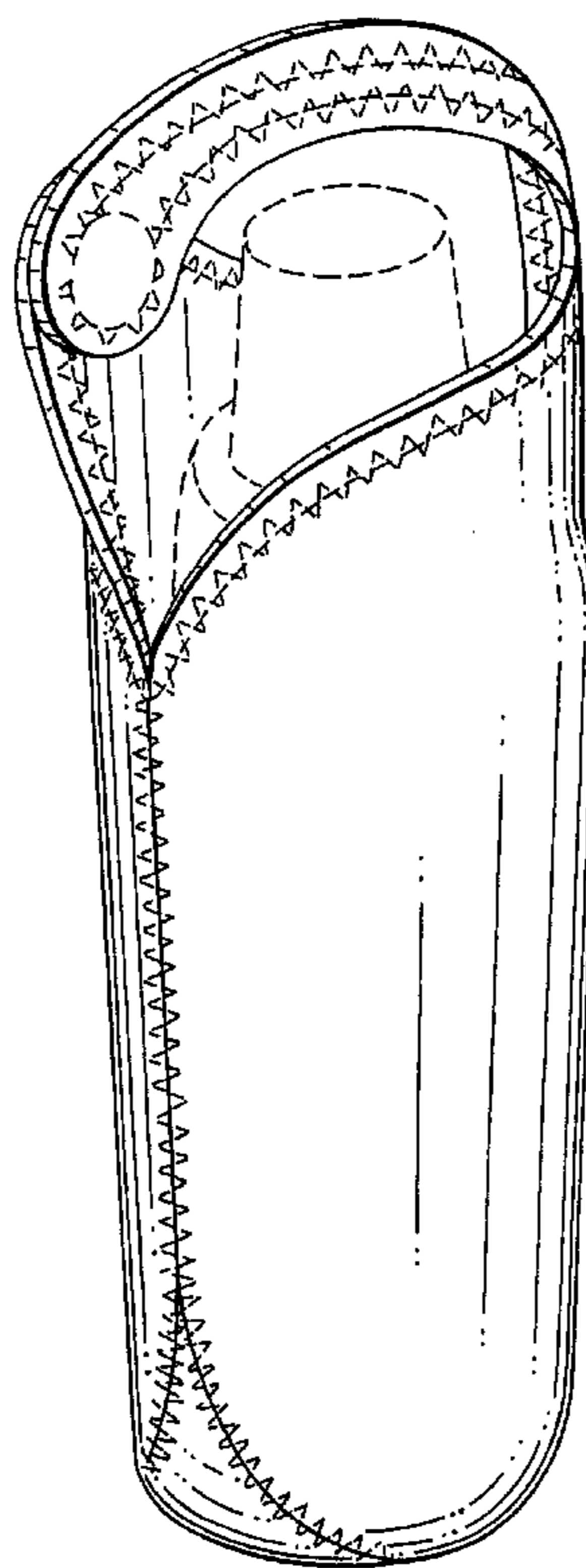
The broken line showing of stitching, a snap, and a bottle is for illustrative purposes only and forms no part of the claimed design.

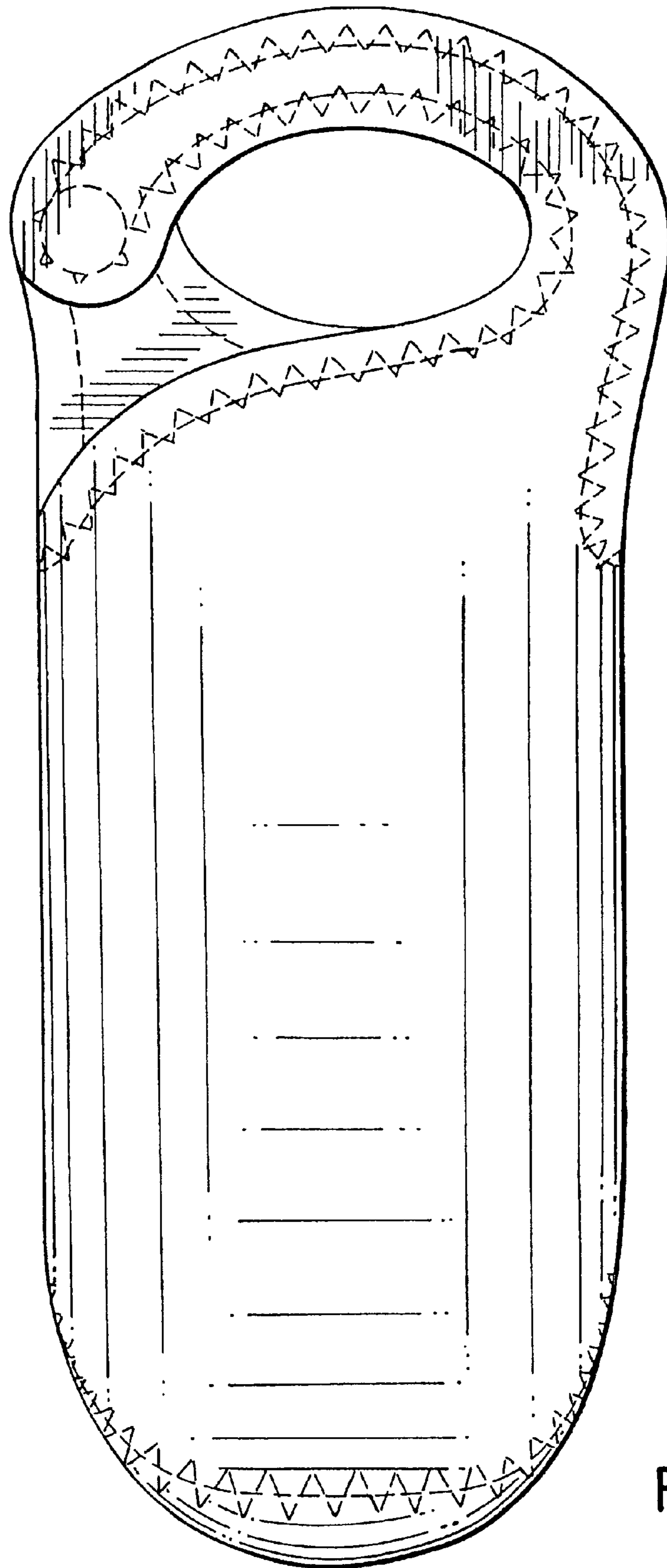

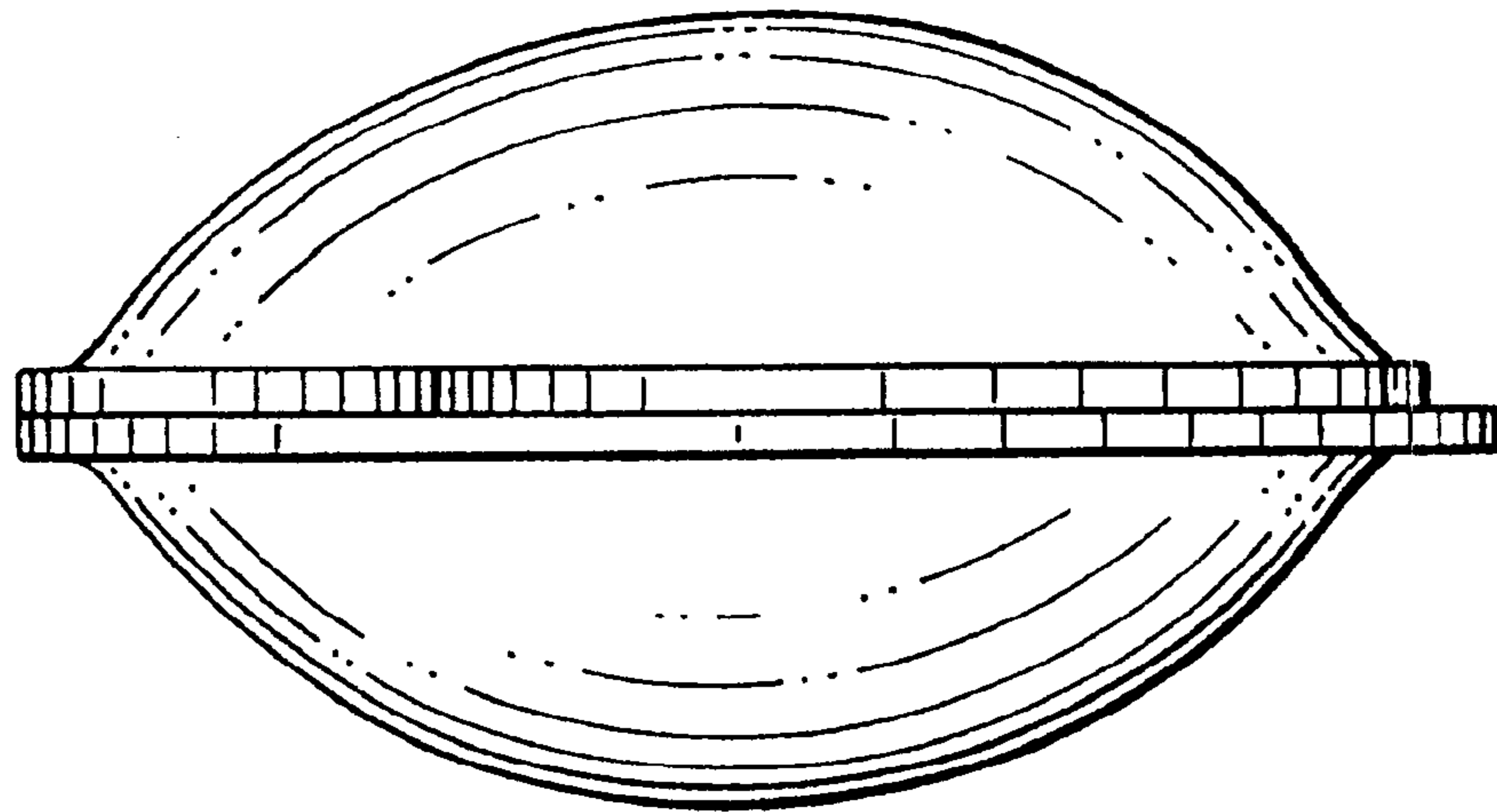

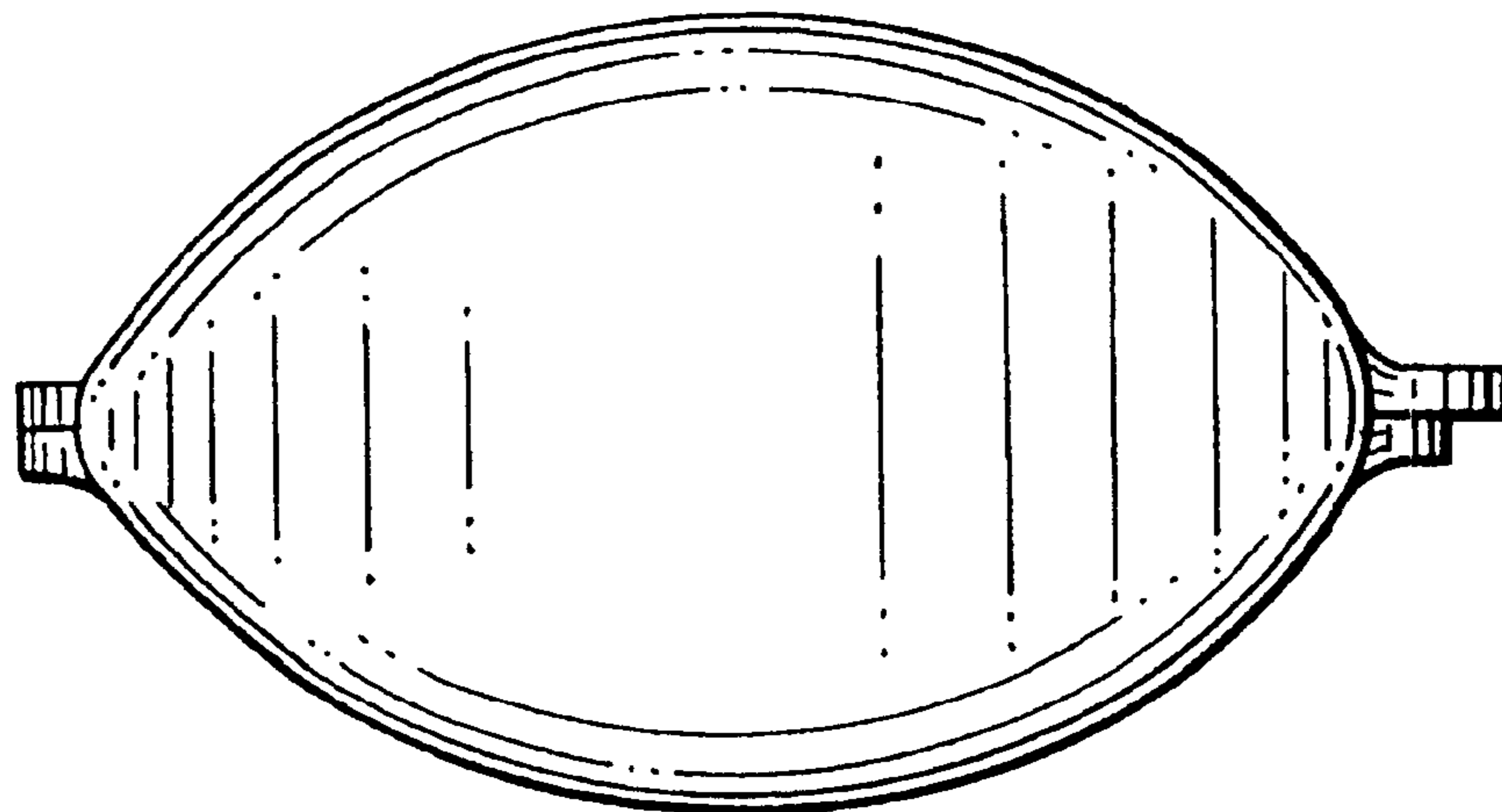

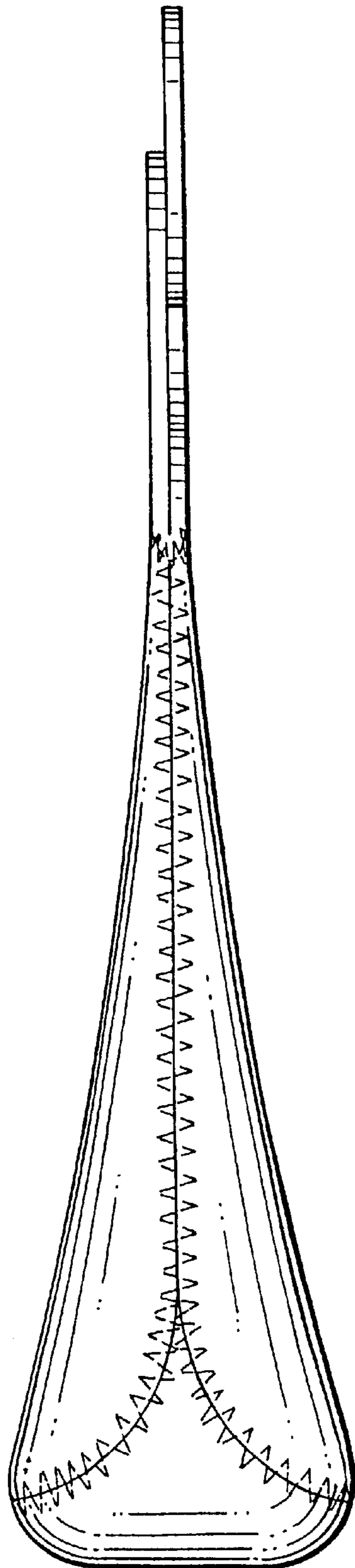
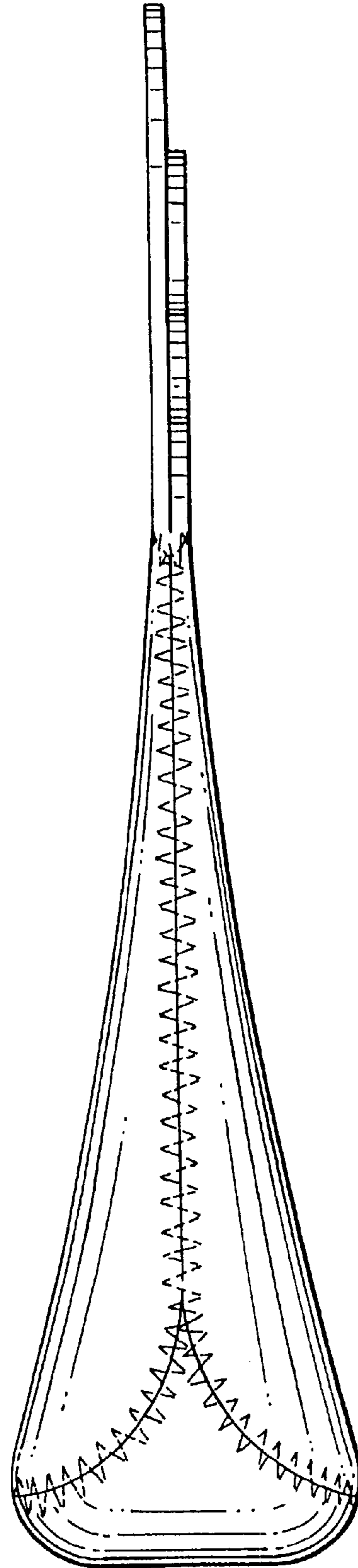

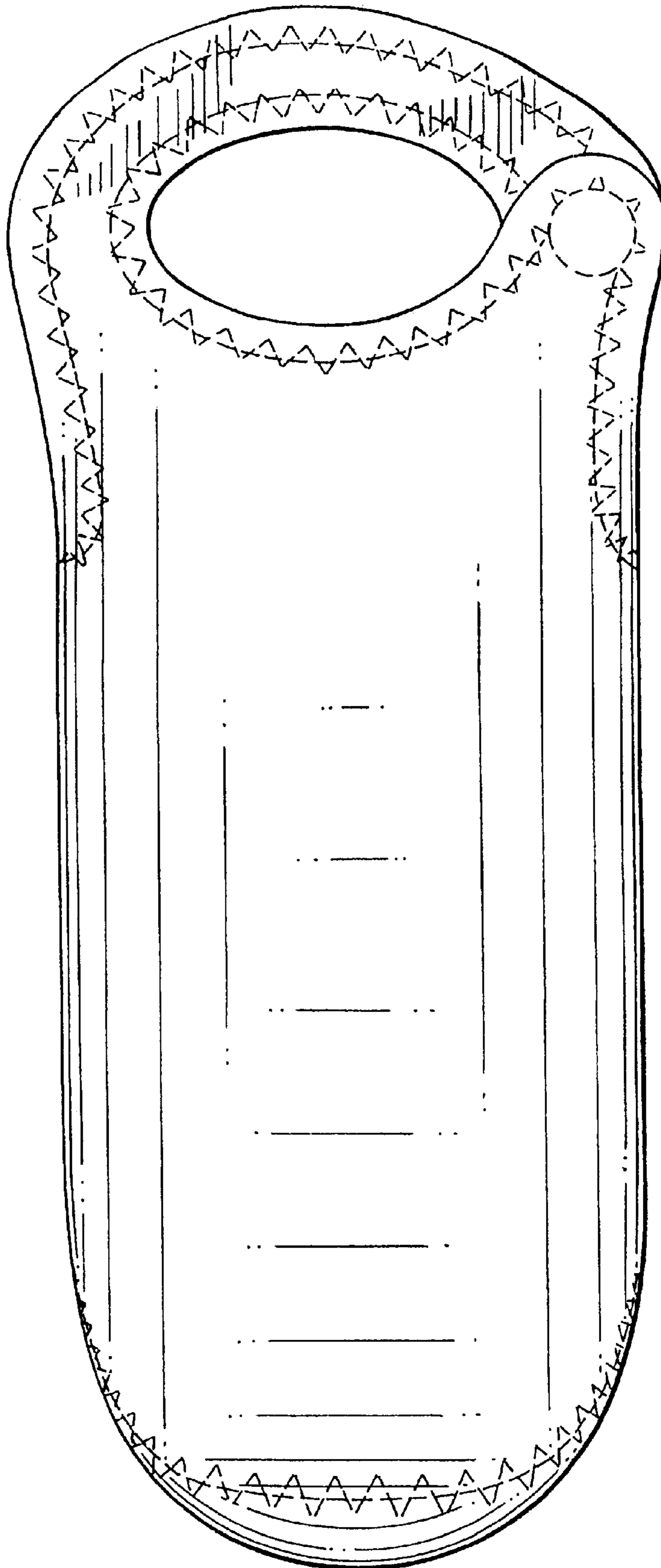

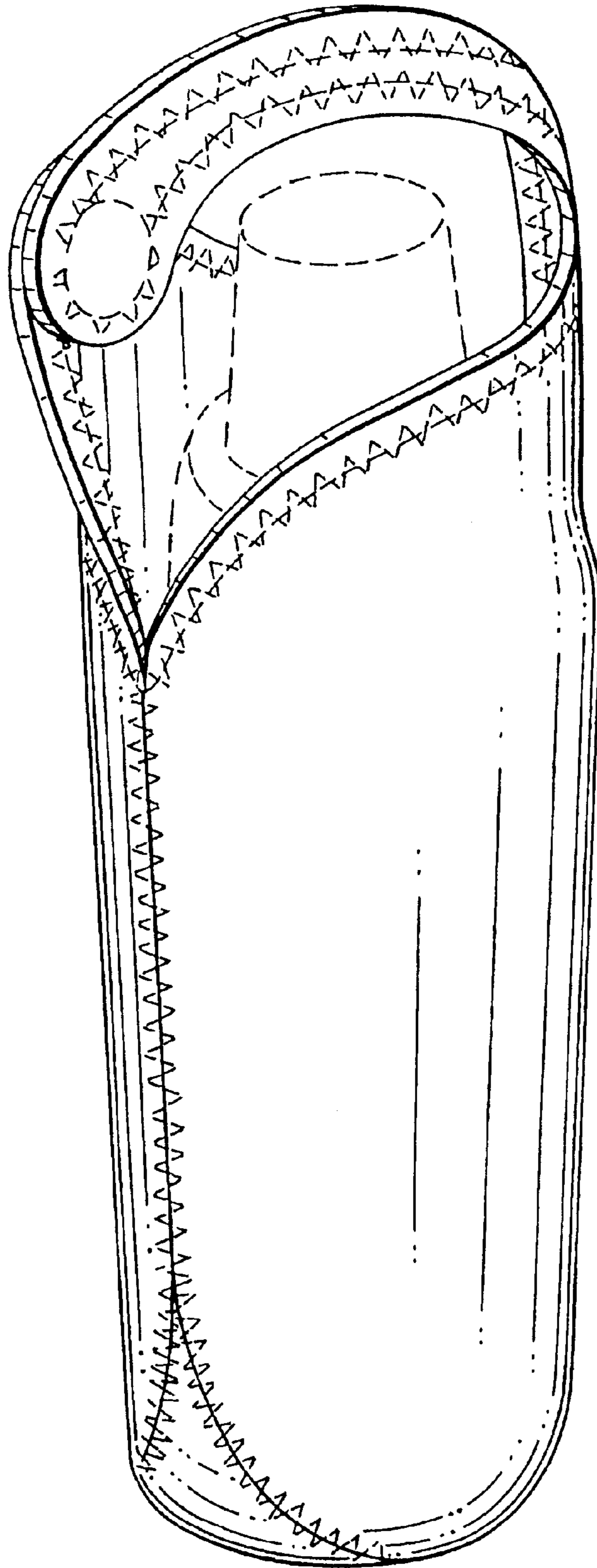

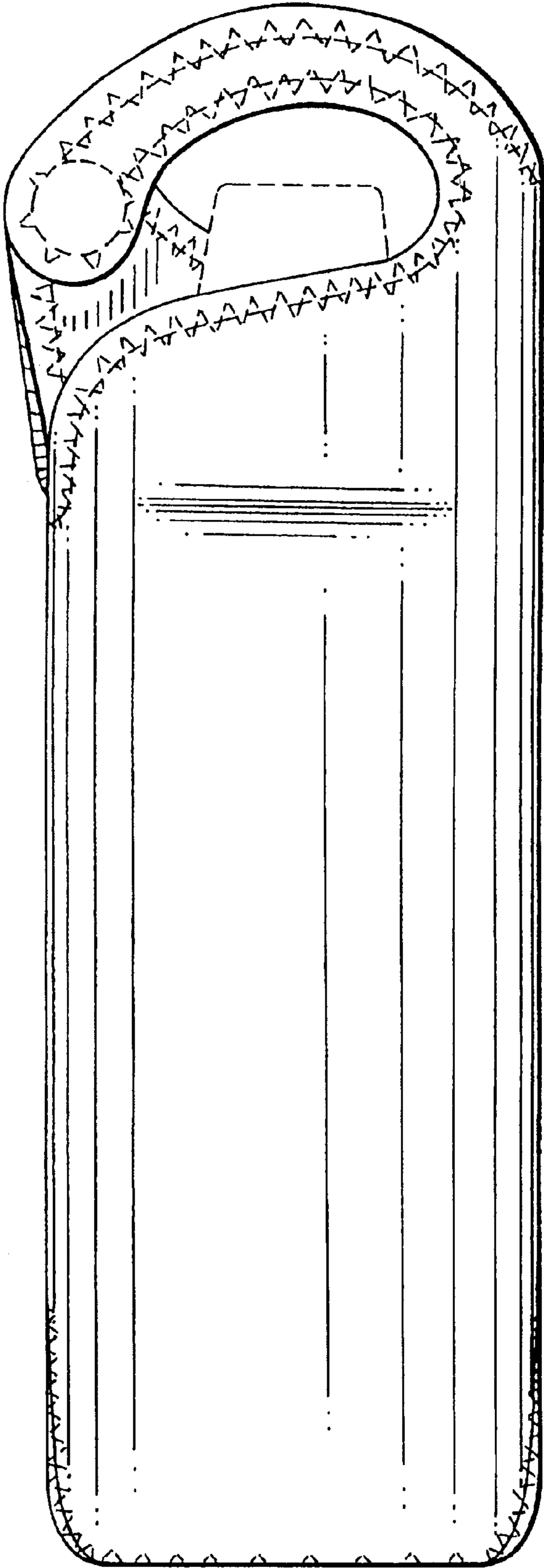

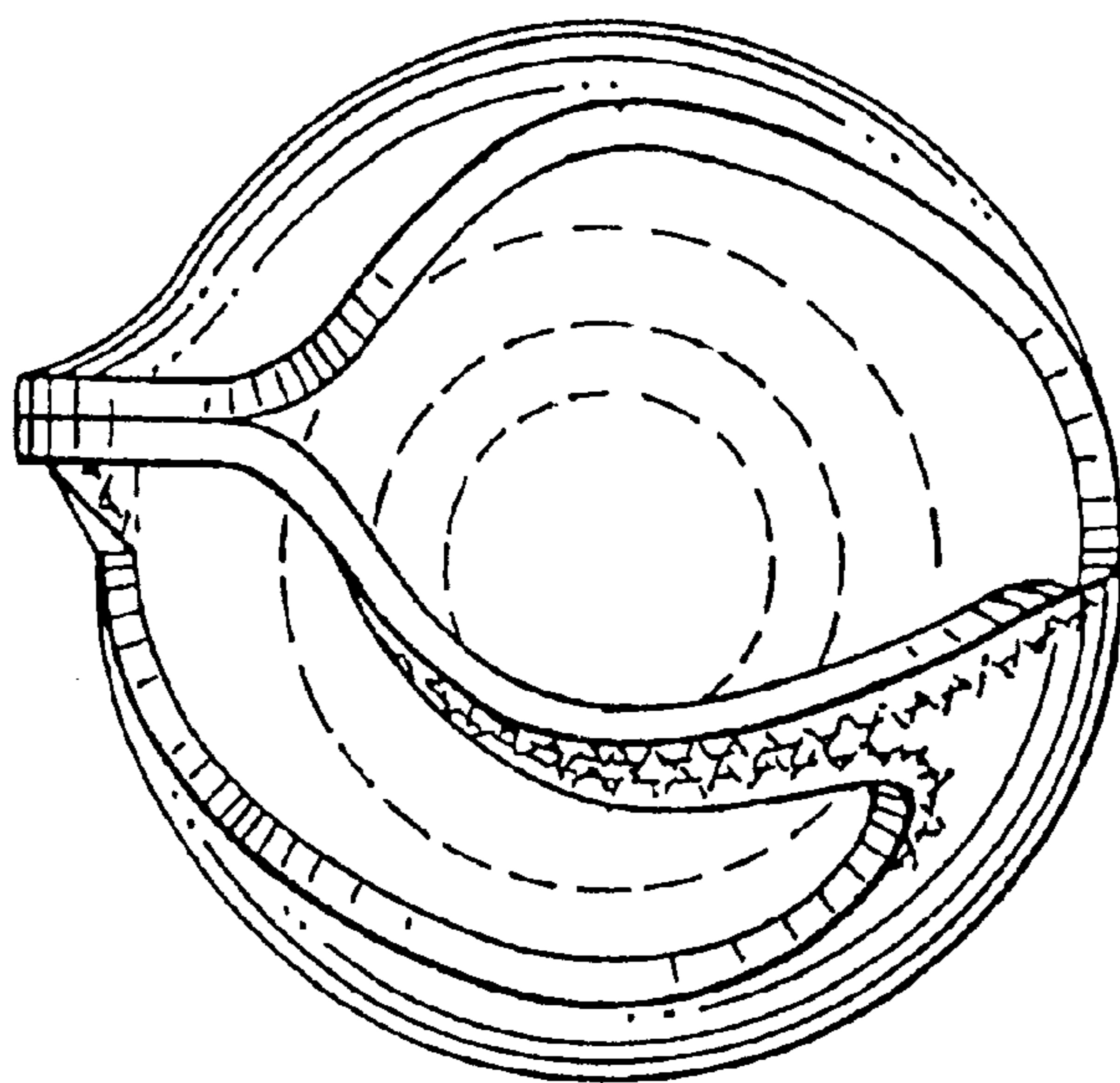

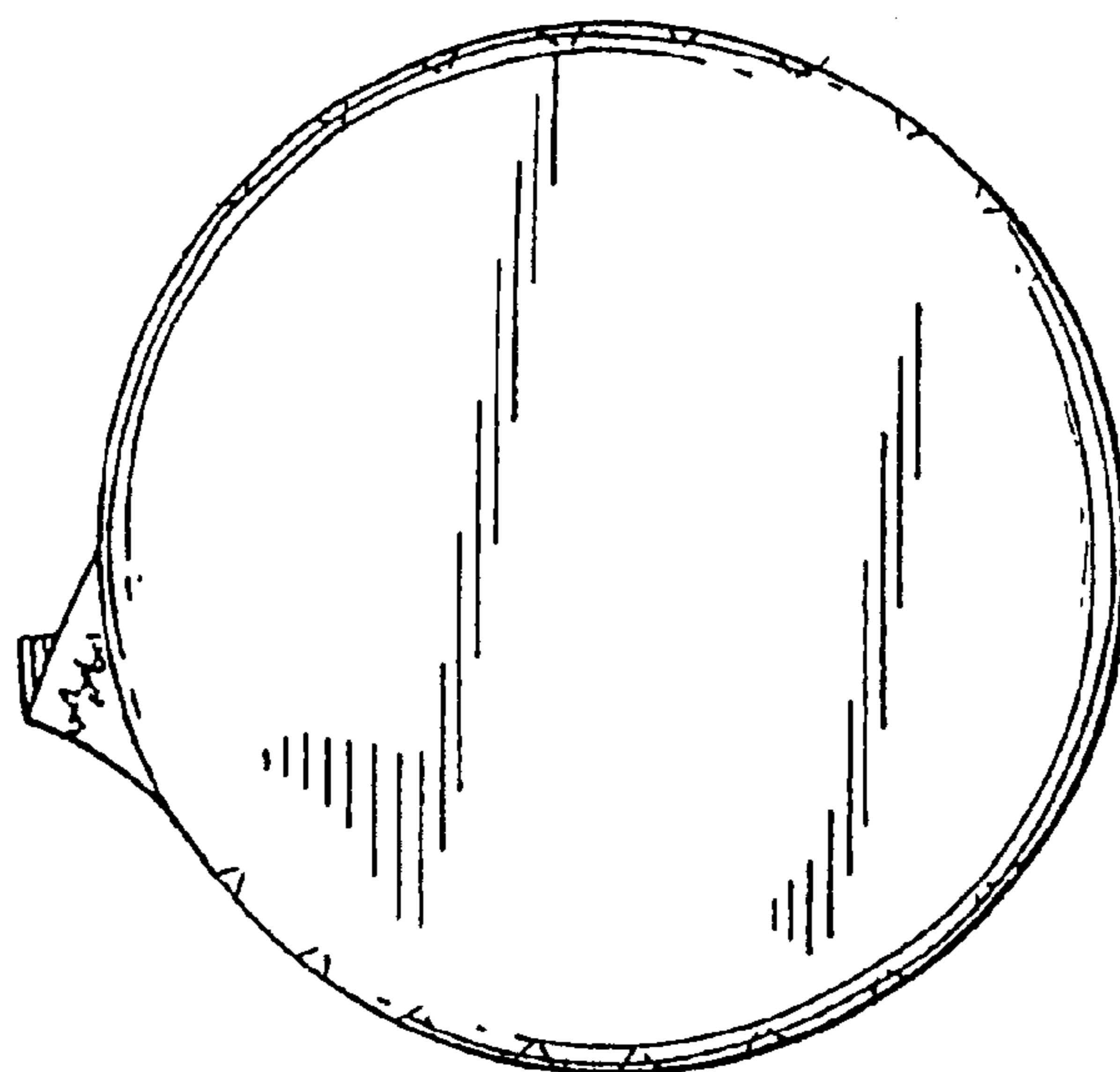

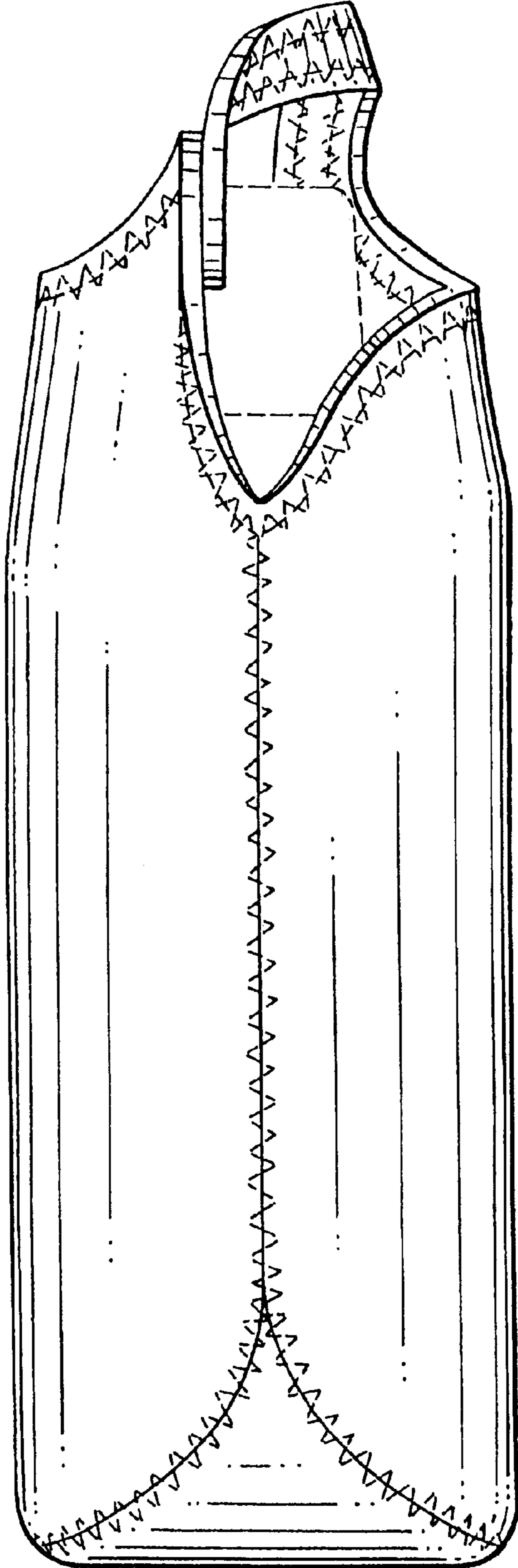

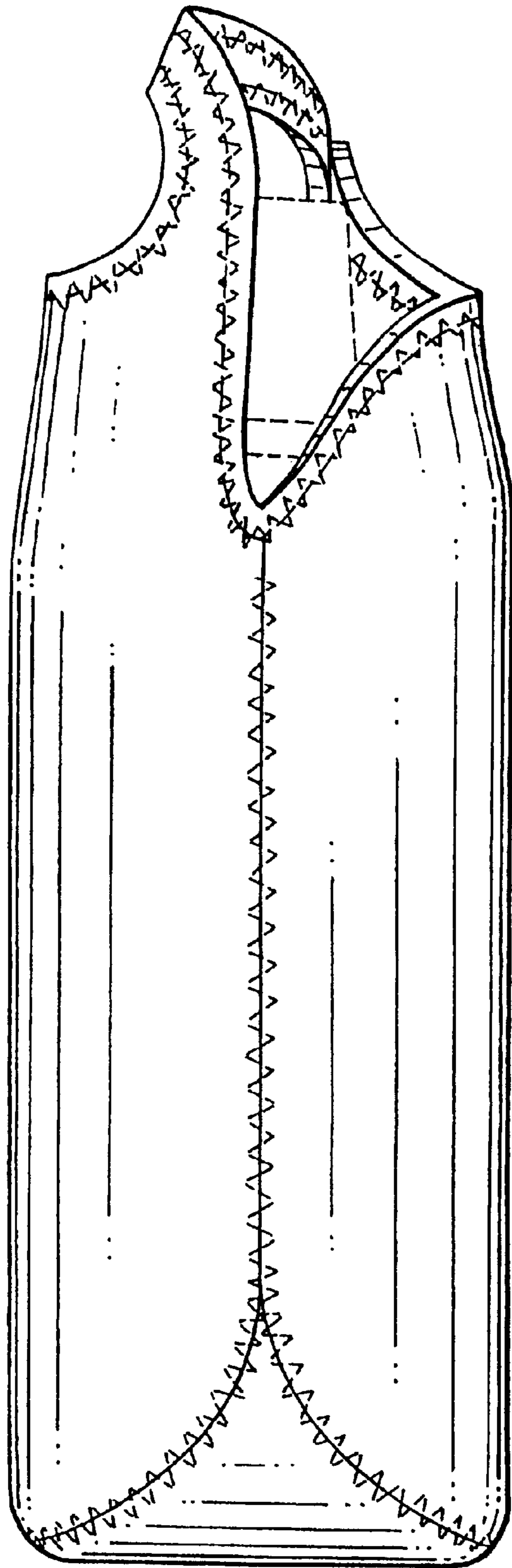

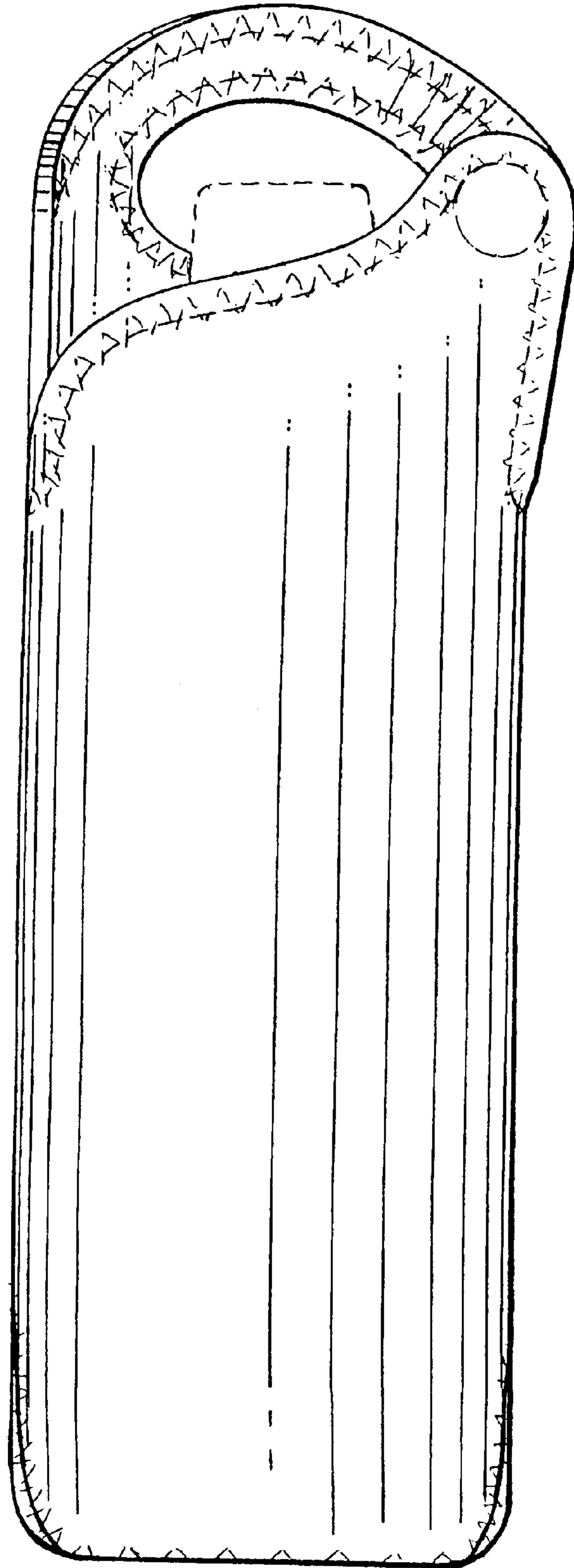
