The ornamental design for a front pack baby carrier cover, as shown and described.

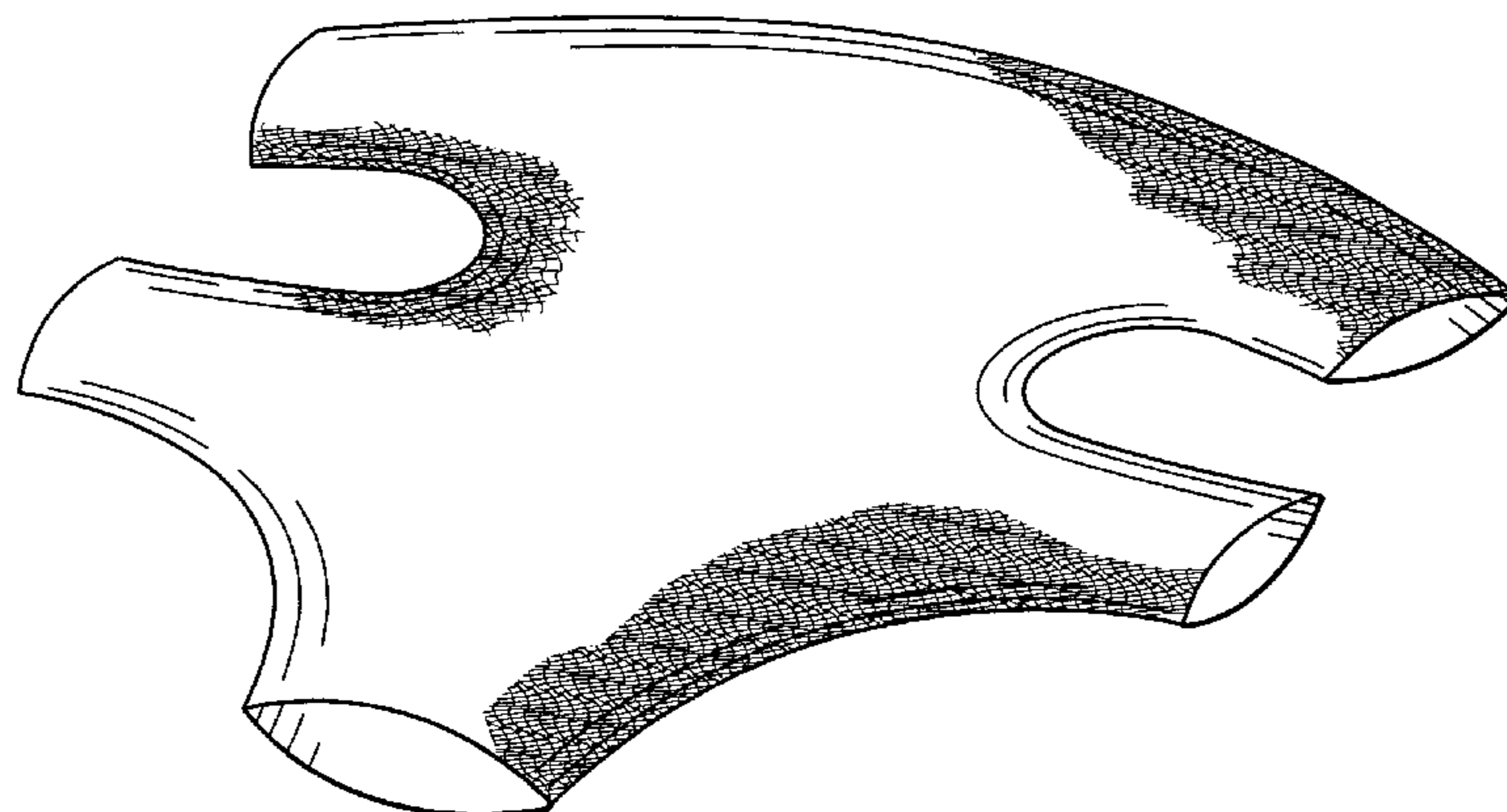
**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a front pack baby carrier cover embodying my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; and, FIG. 6 is a top plan view thereof, the bottom plan view being a mirror image.  
The crisscross pattern of lines in the drawings represents material and is understood to be distributed uniformly over the surface of the front pack baby carrier cover.

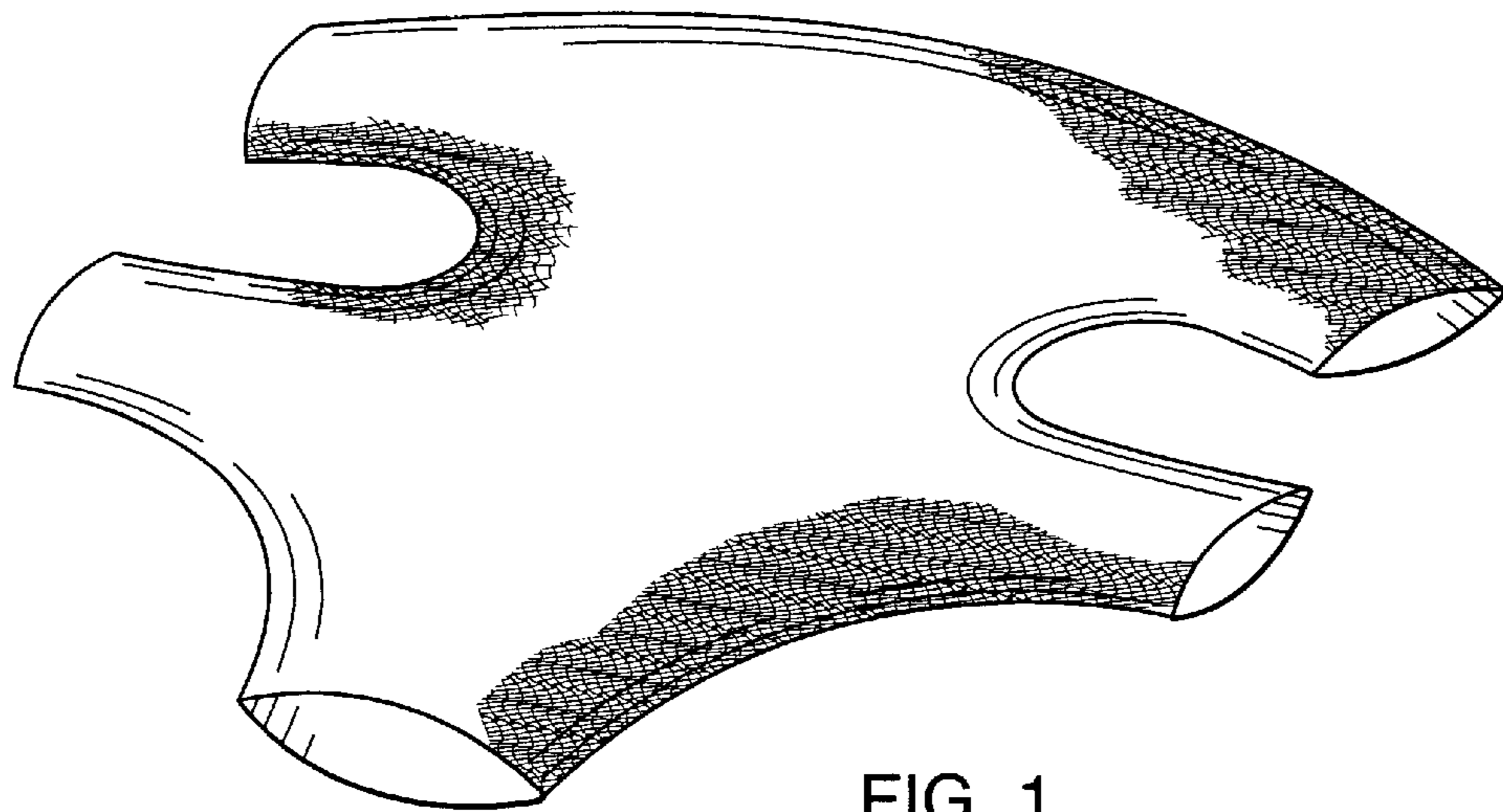

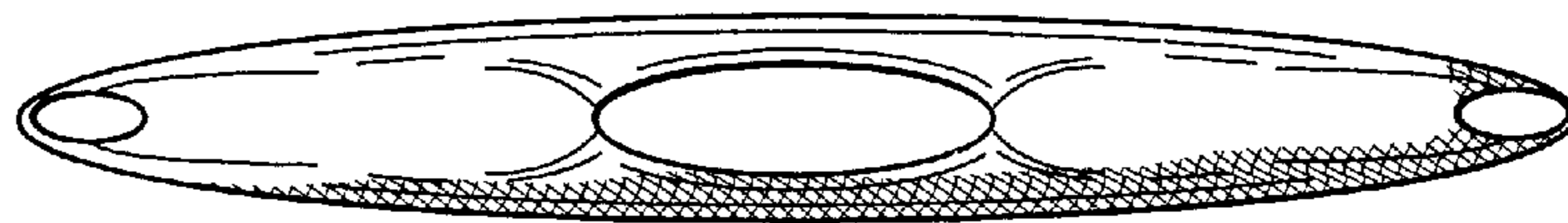

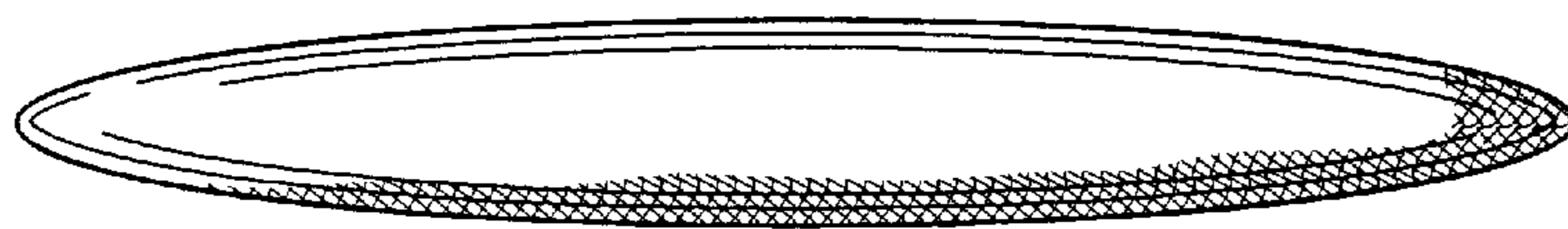

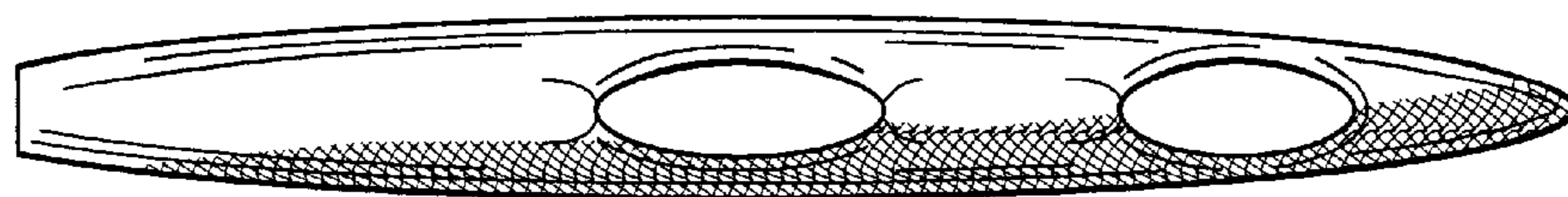

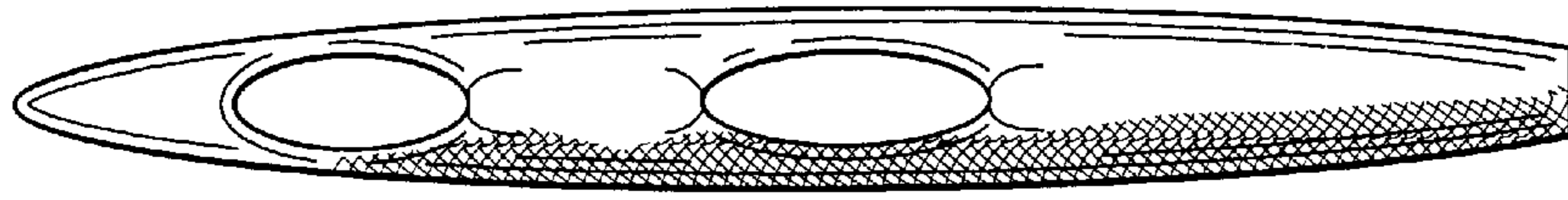

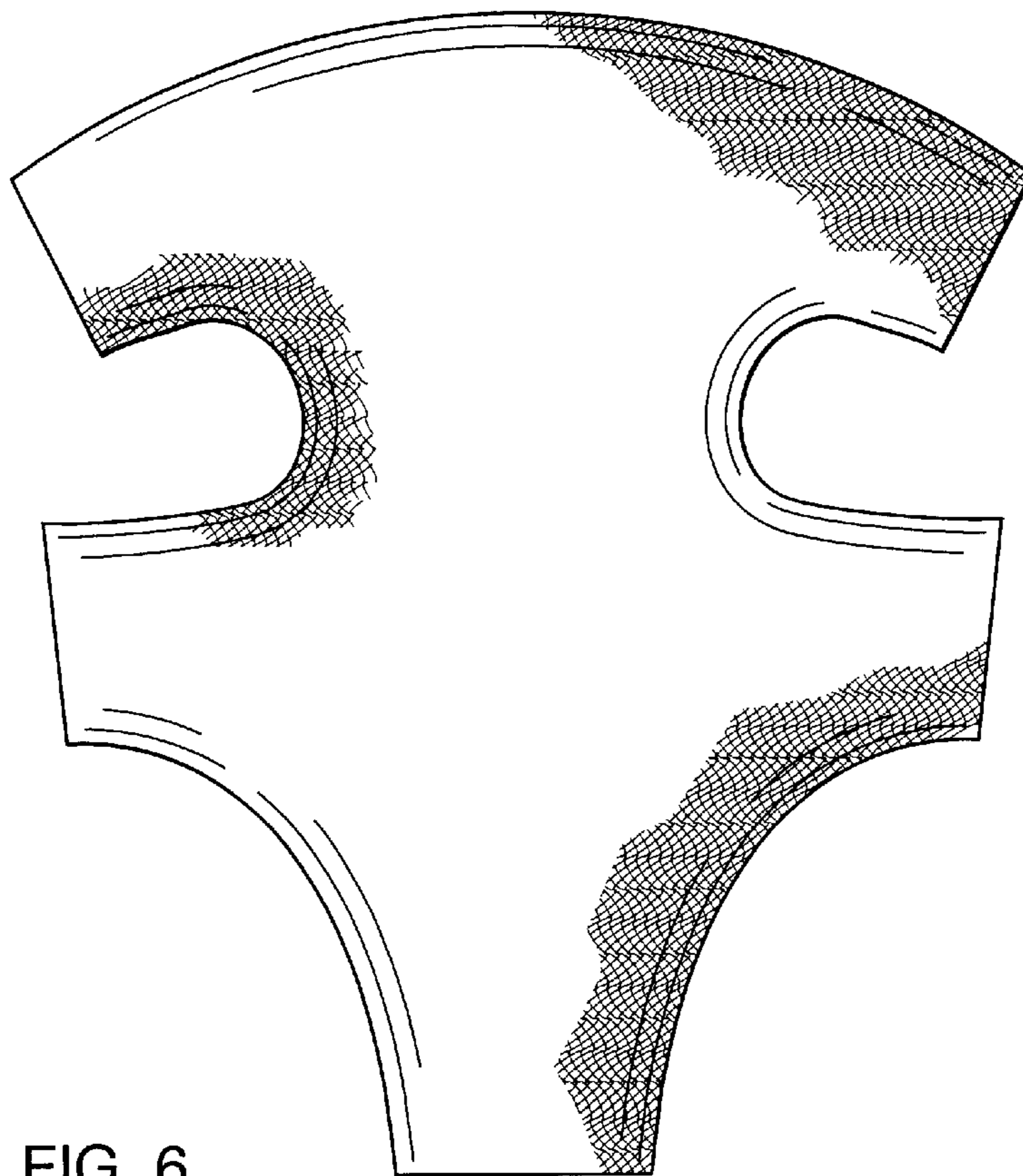
