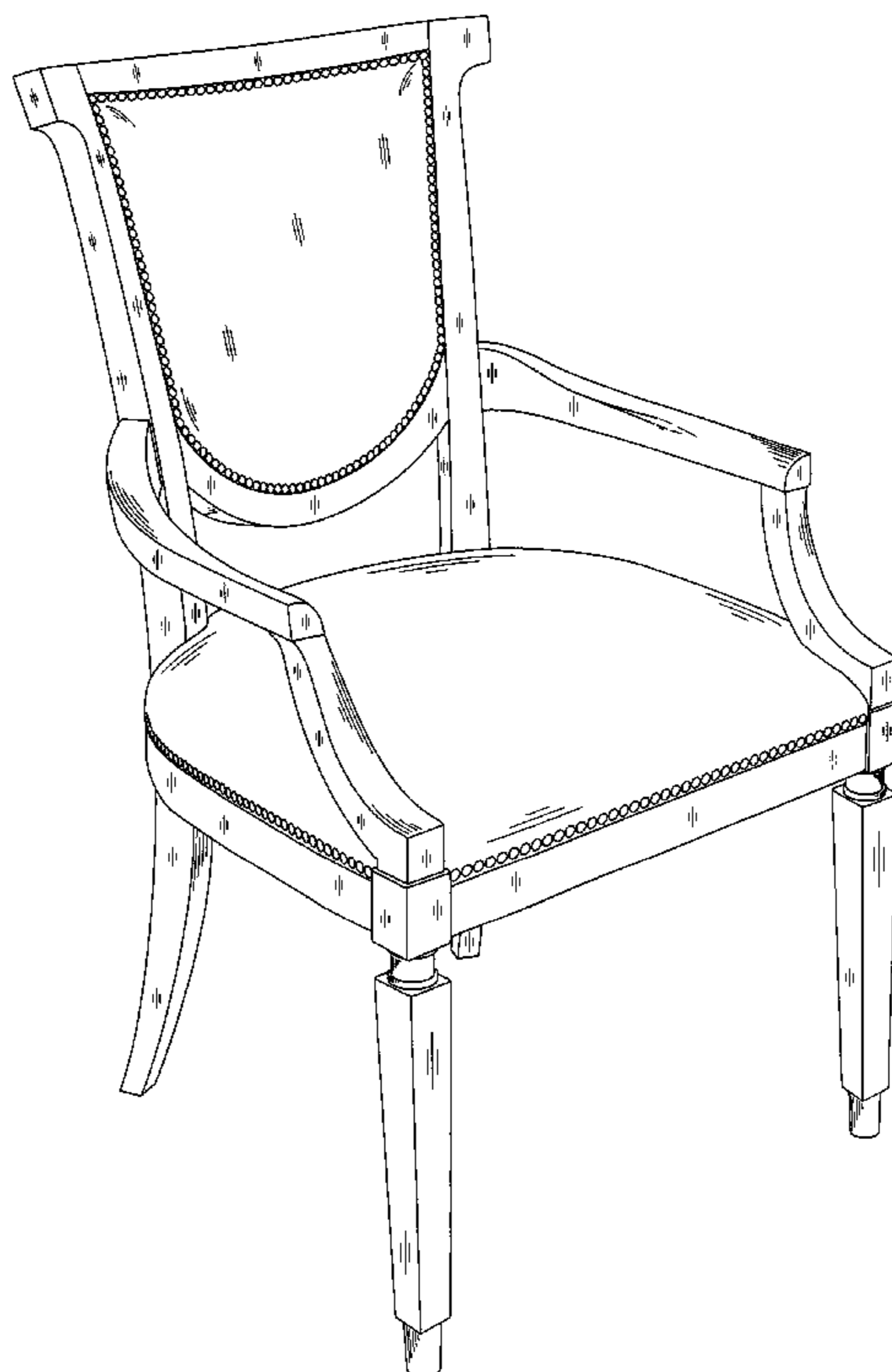
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a chair showing my new design;
FIG. 2 is a slightly enlarged front view thereof;
FIG. 3 is a slightly enlarged side view, the opposite side being a mirror image thereof;
FIG. 4 is a front perspective view of a second embodiment showing my new design;
FIG. 5 is a slightly enlarged front view of a second embodiment; and,
FIG. 6 is a slightly enlarged side view of a second embodiment, the opposite side being a mirror image thereof.

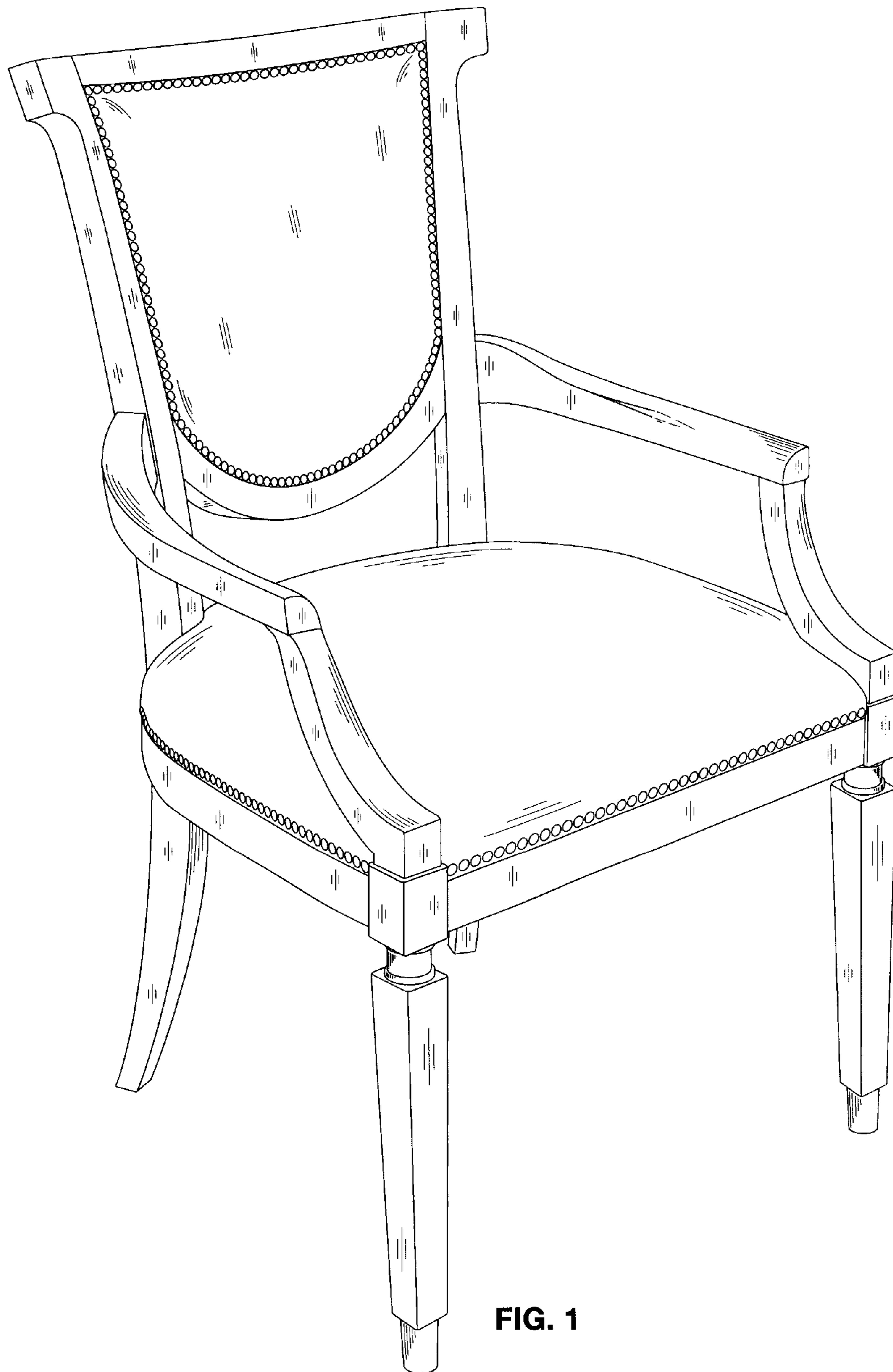

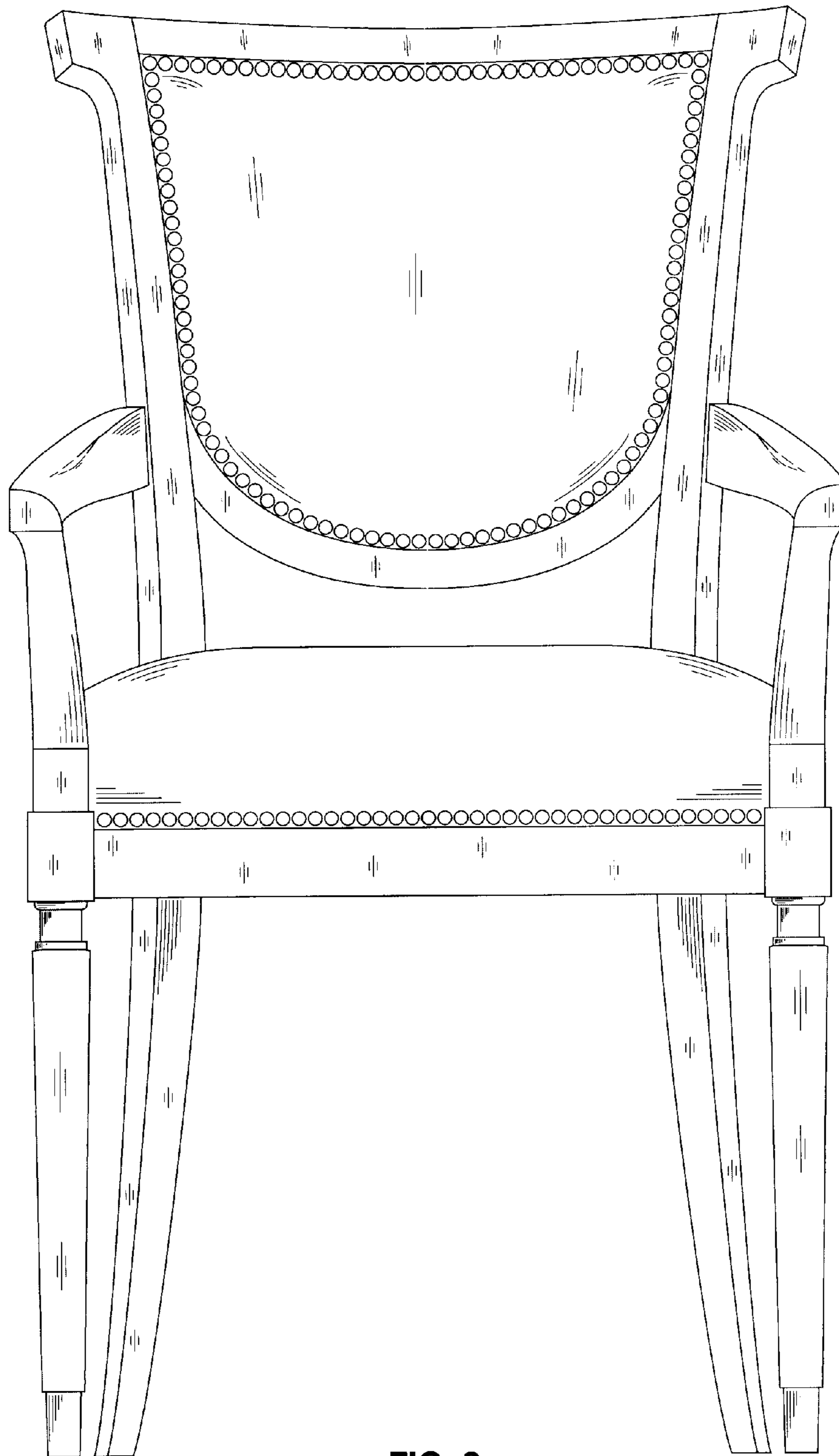

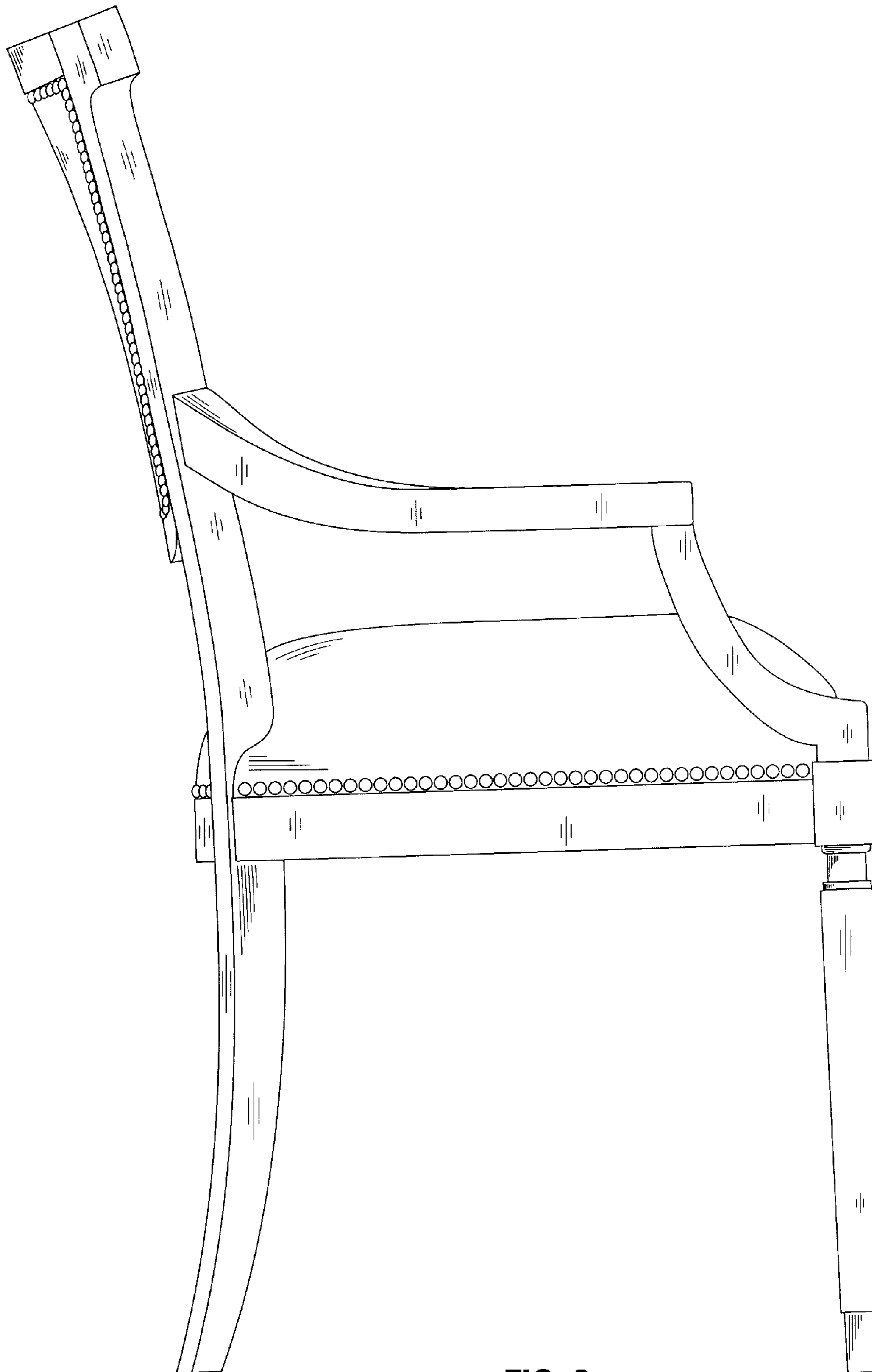

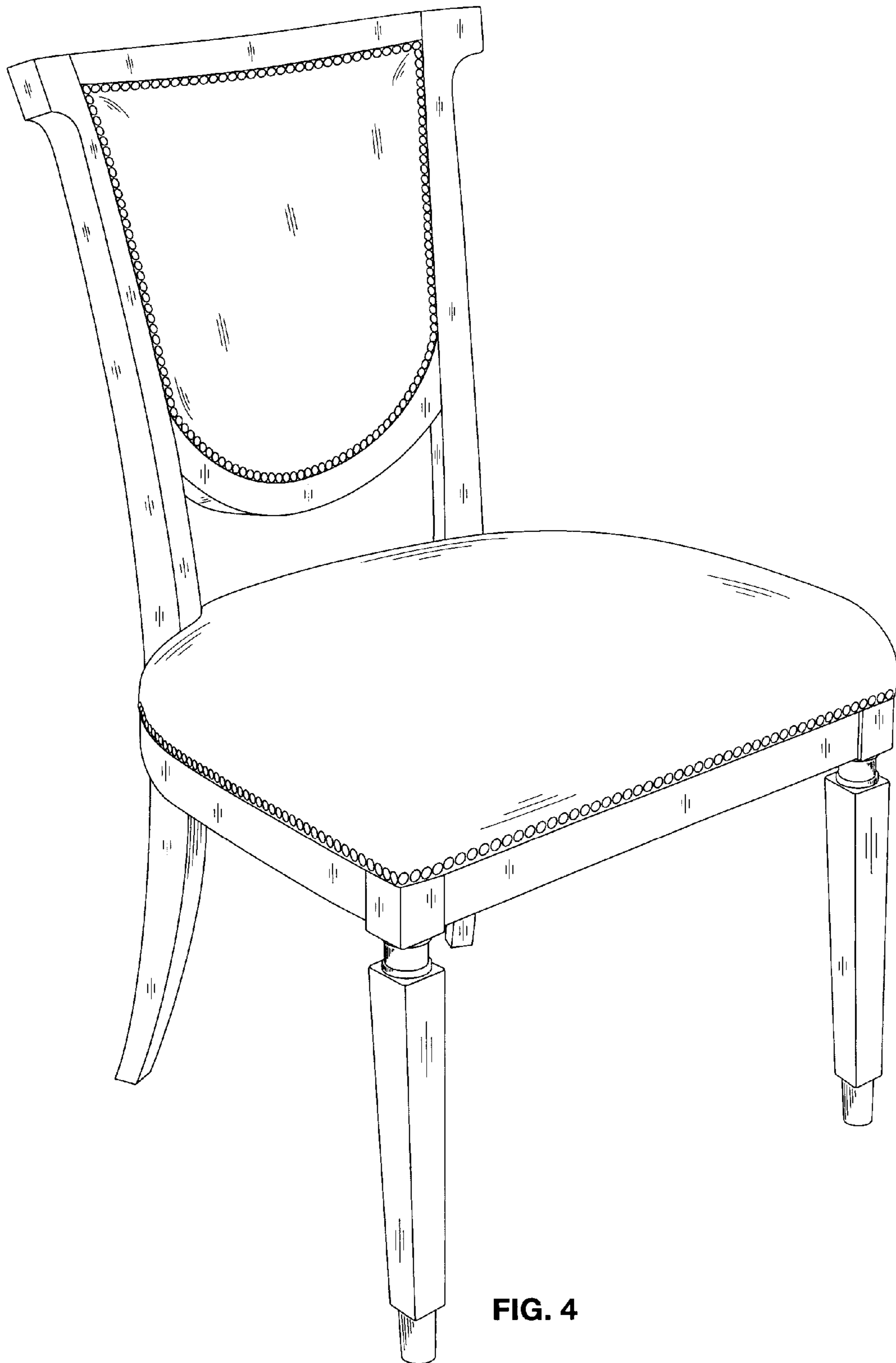

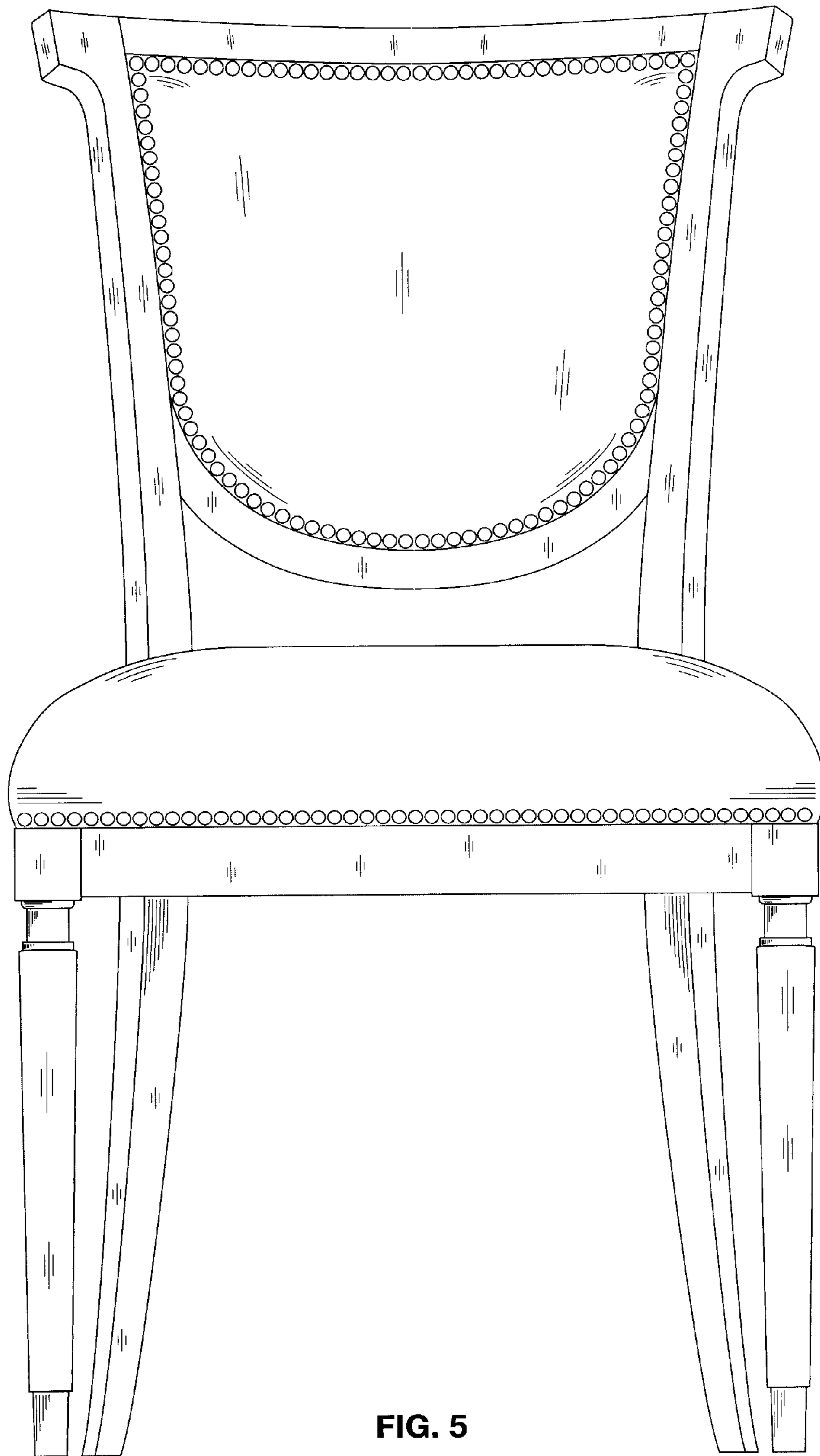

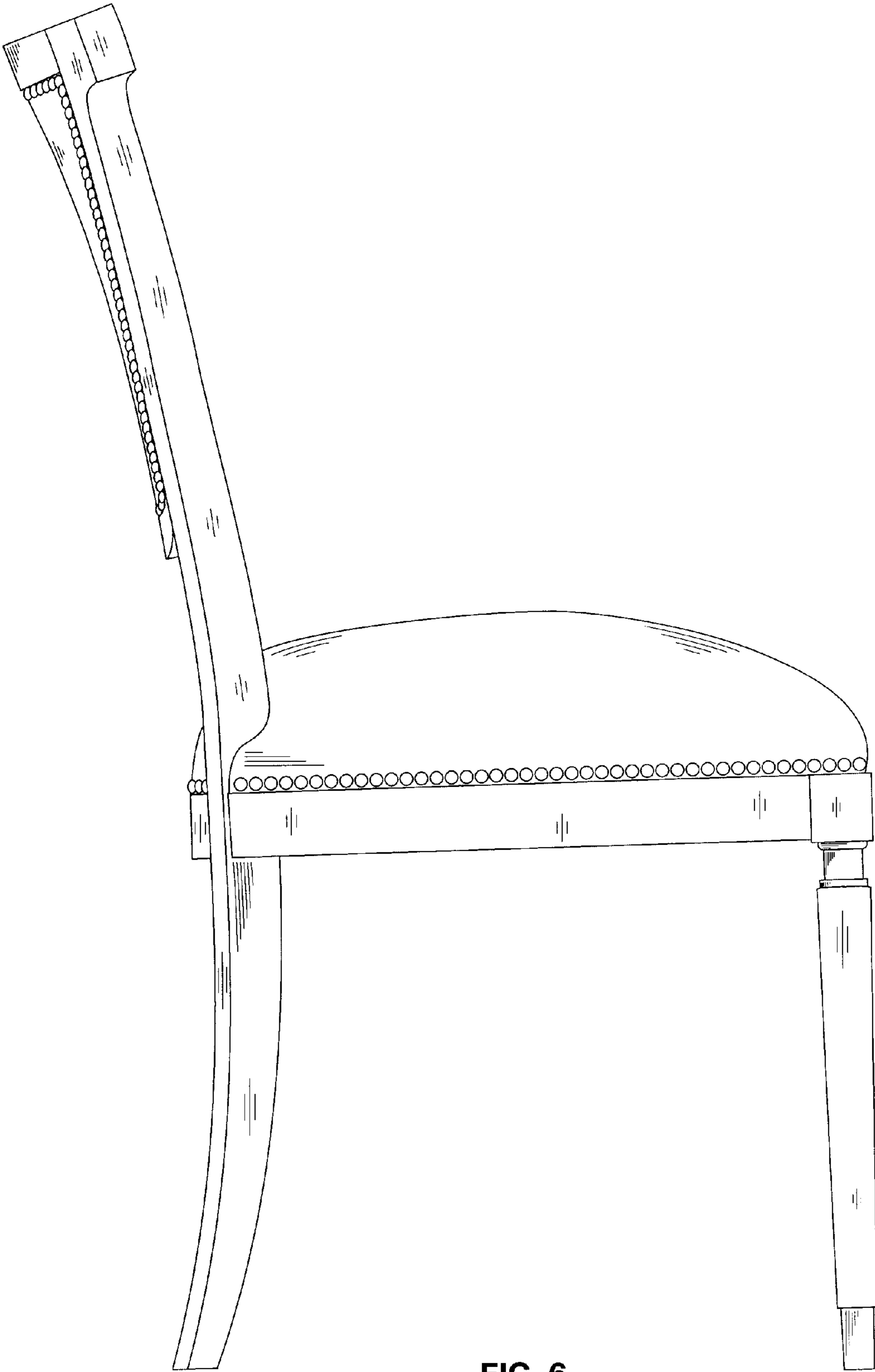
