(57) **CLAIM**

I claim the ornamental design for a knife clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a view of a side of a knife clip affixed to a handle of a folding knife.

FIG. 2 is a view of the bottom of the embodiment described with respect to FIG. 1.

FIG. 3 is a view of the top of the embodiment described with respect to FIG. 1.

FIG. 4 is a view of the front of the embodiment described with respect to FIG. 1.

FIG. 5 is a view of the rear of the embodiment described with respect to FIG. 1; and,

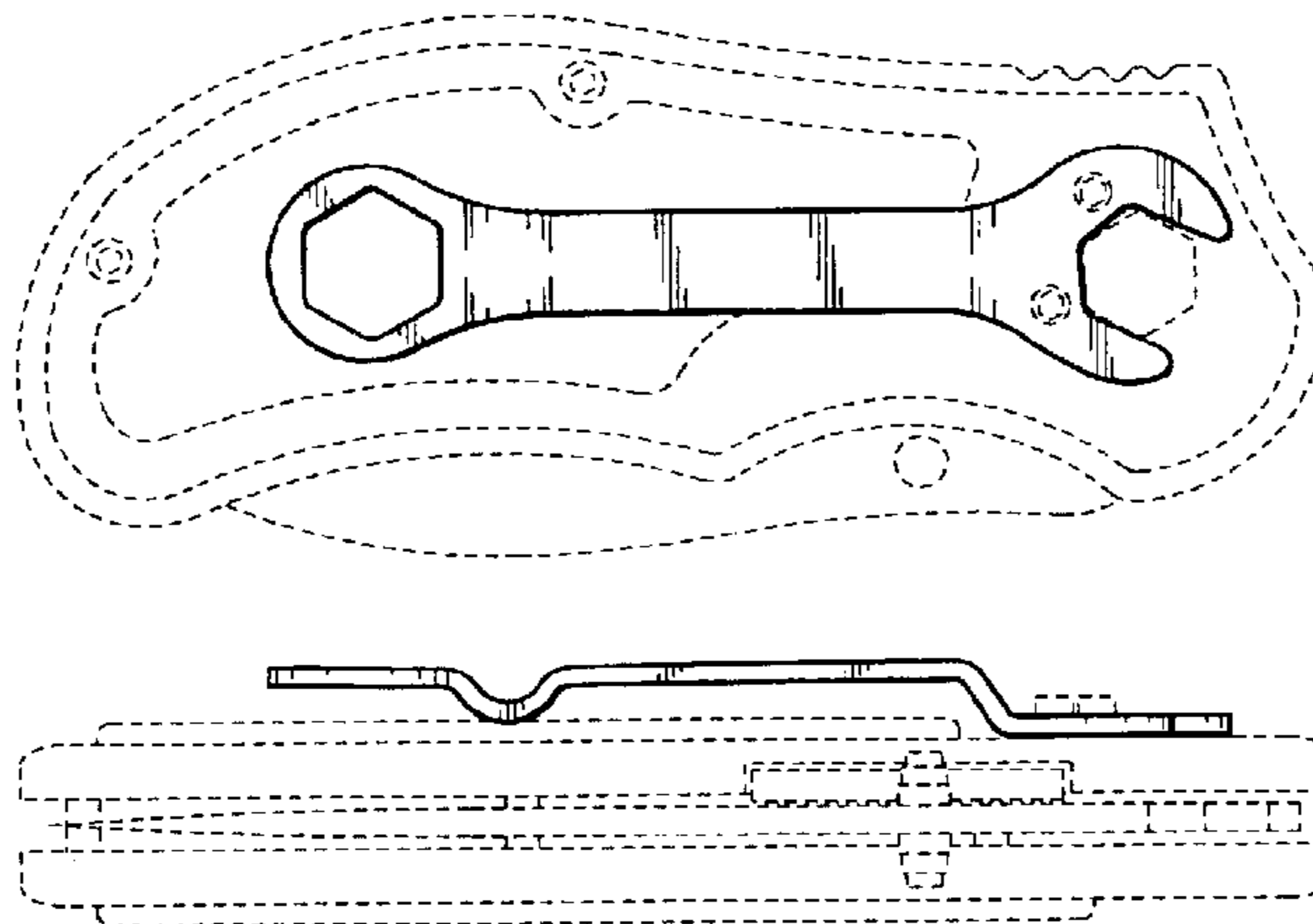
FIG. 6 is a view of a side opposite the side shown in FIG. 1 of a knife clip affixed to a handle of a folding knife with the blade extended outside of the handle according to an embodiment of the present invention.

The broken line(s) shown in the drawings are for illustrative purposes only and form no part of the claimed design.

The stippling and shading lines shown in the drawing(s) represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.

Portions of the knife clip that are not shown in the drawing(s) form no part of the claimed design.

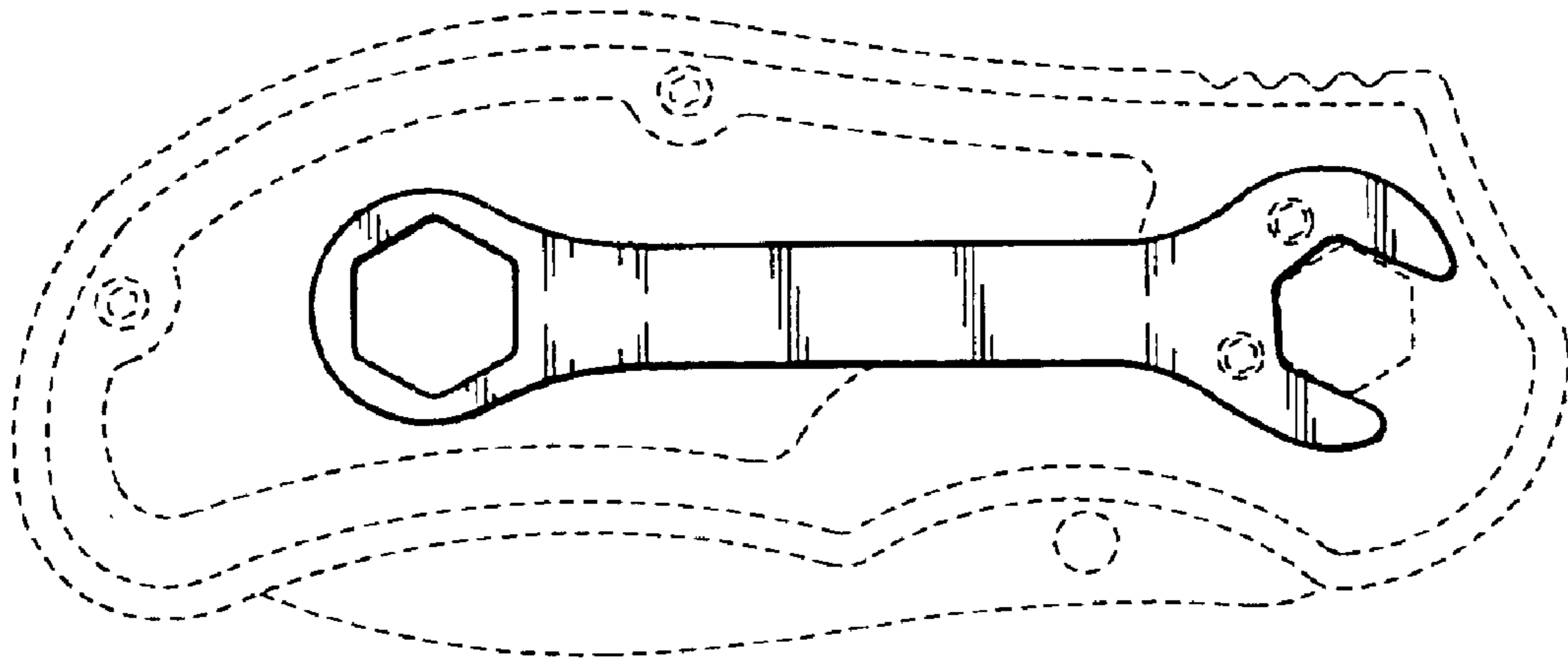

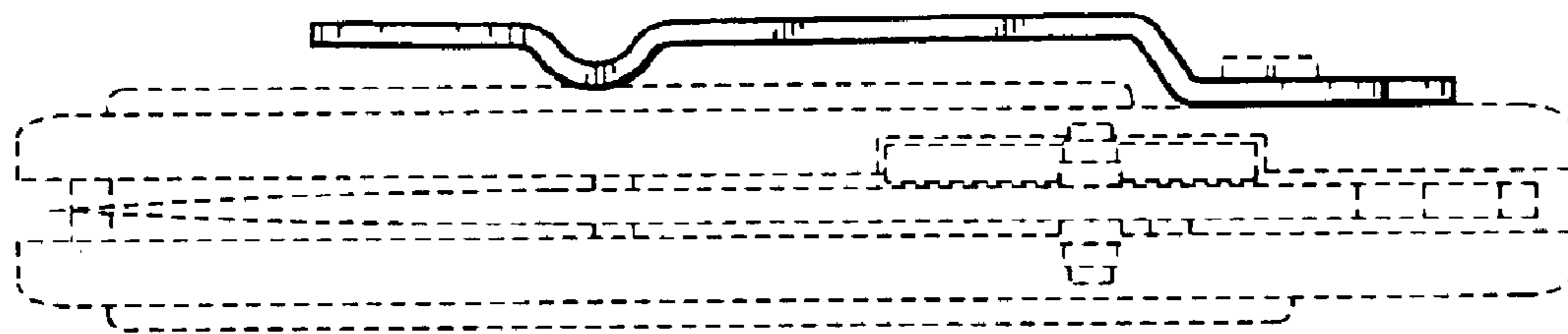

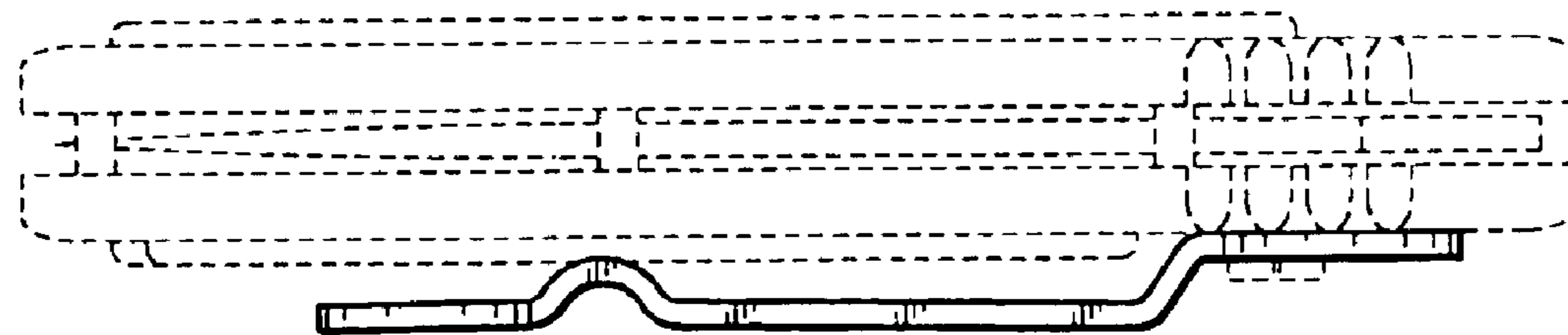

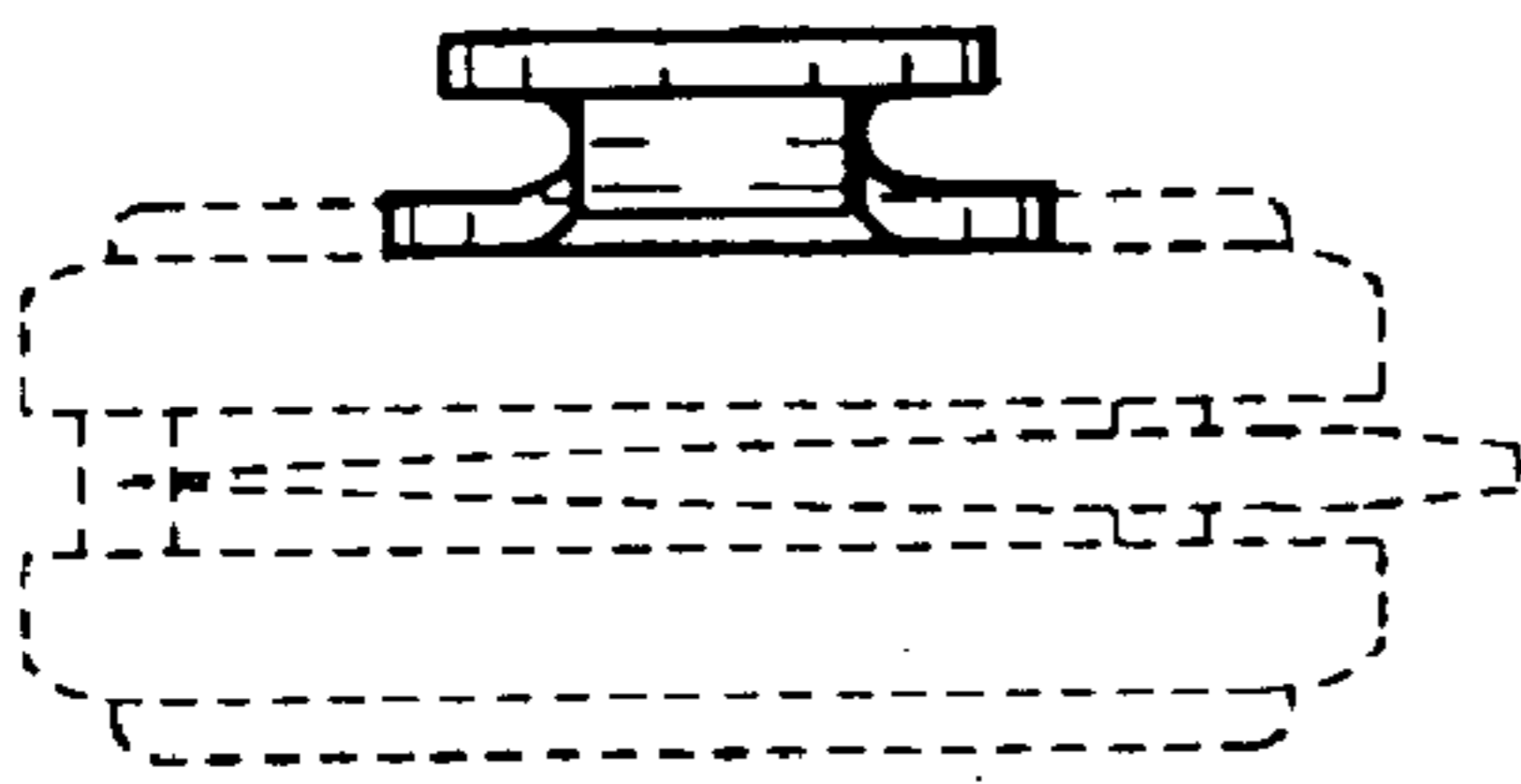

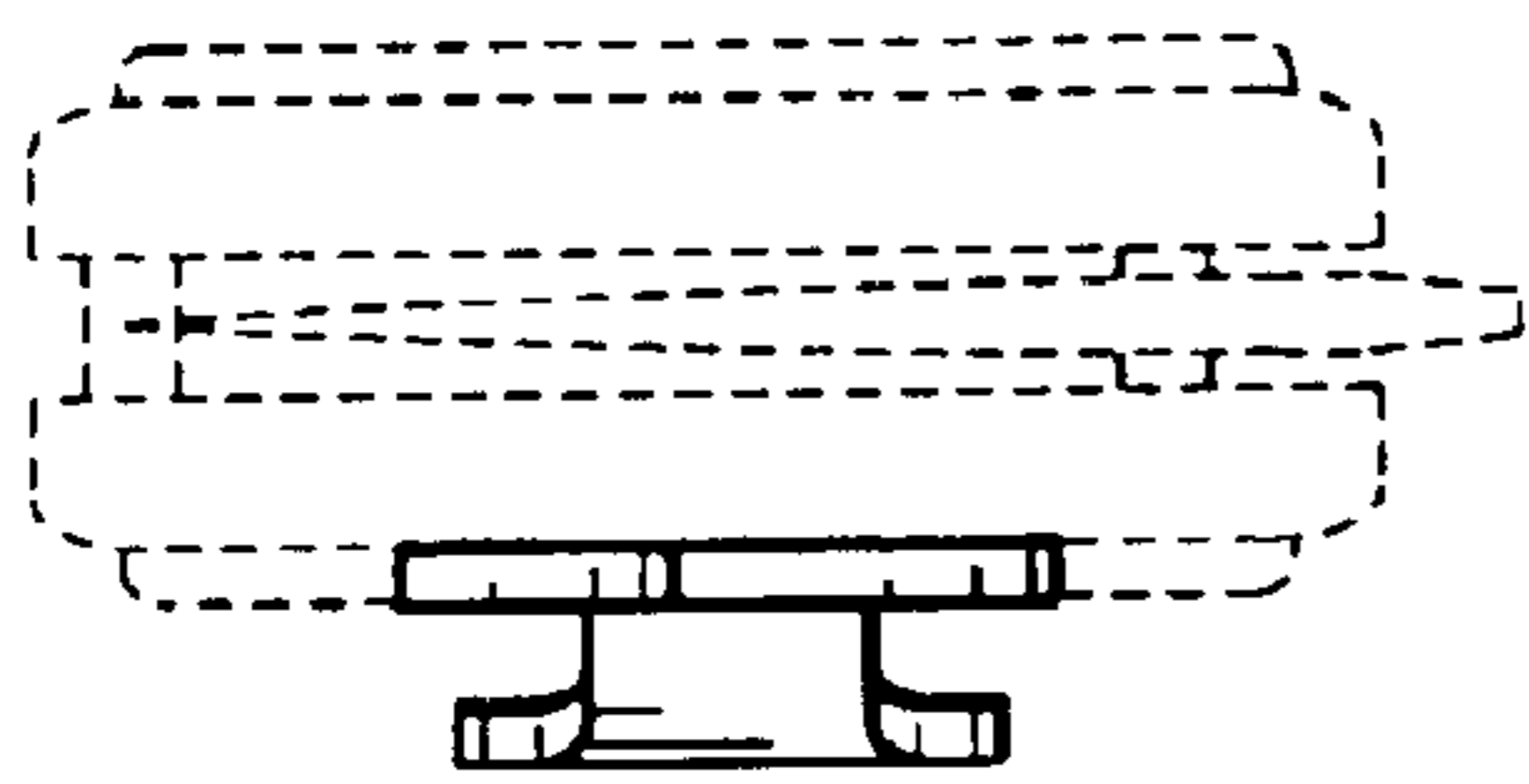

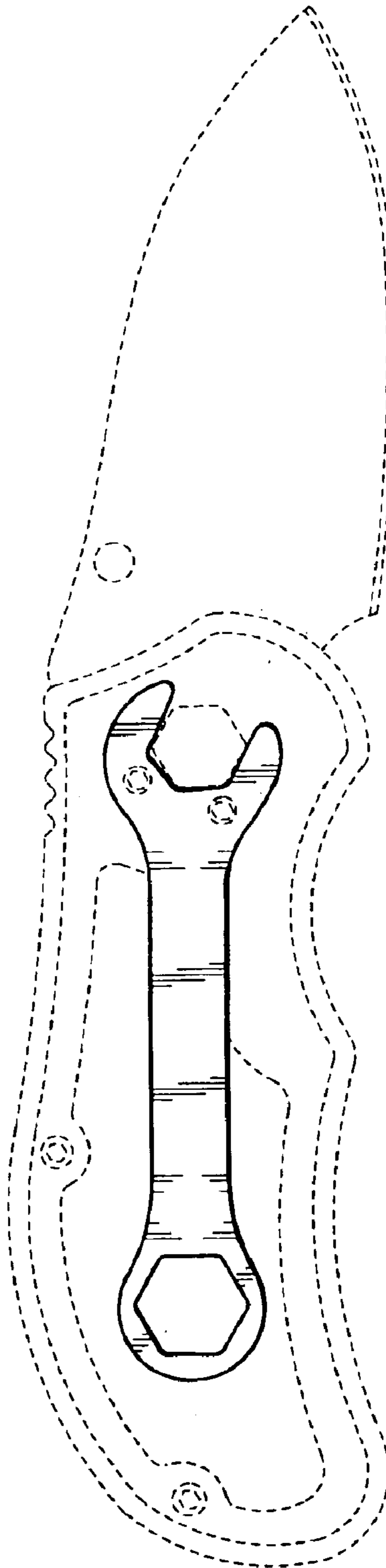
