FIG. 1 is a perspective view of a tow rope caddy showing my new design;

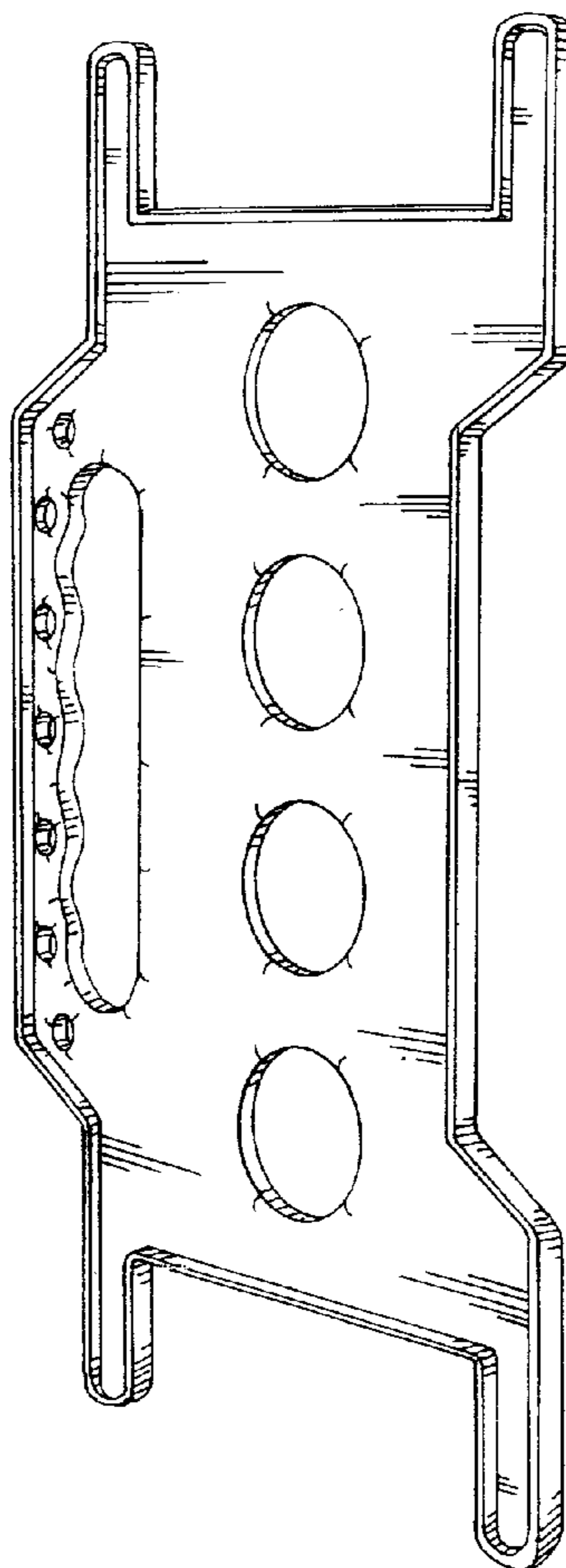
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image;

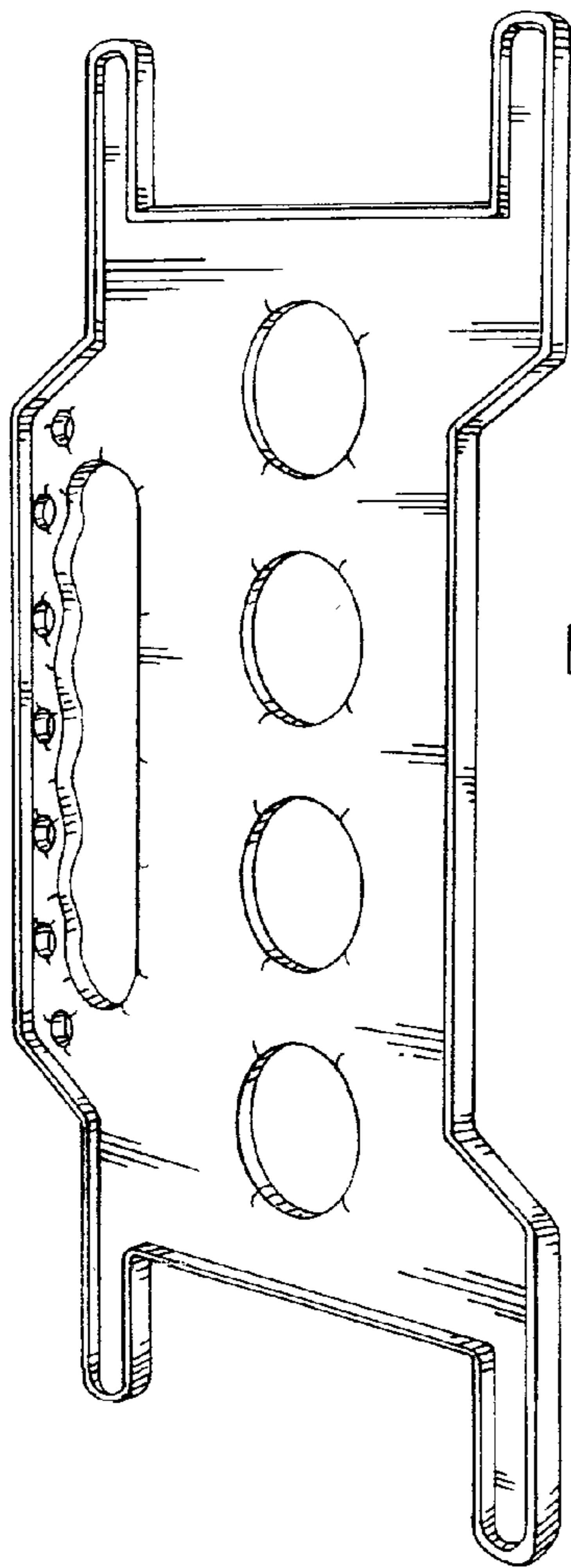
FIG. 3 is a left side elevational view thereof;

FIG. 5 is a top plan view, the bottom plan view being a mirror image thereof.

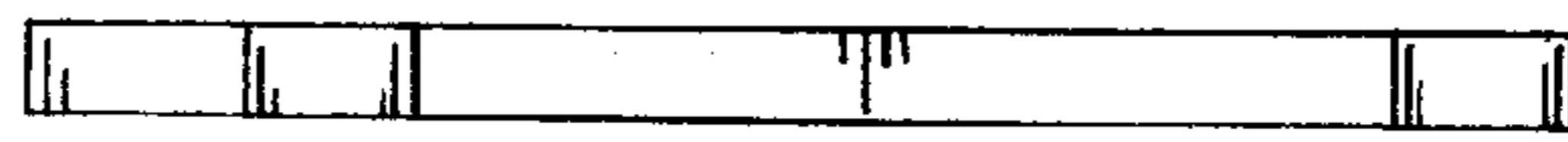

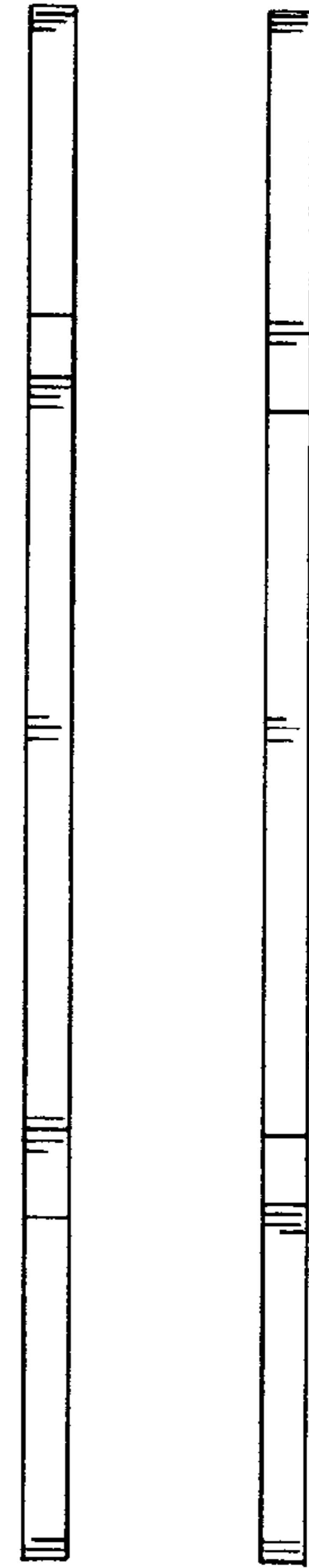

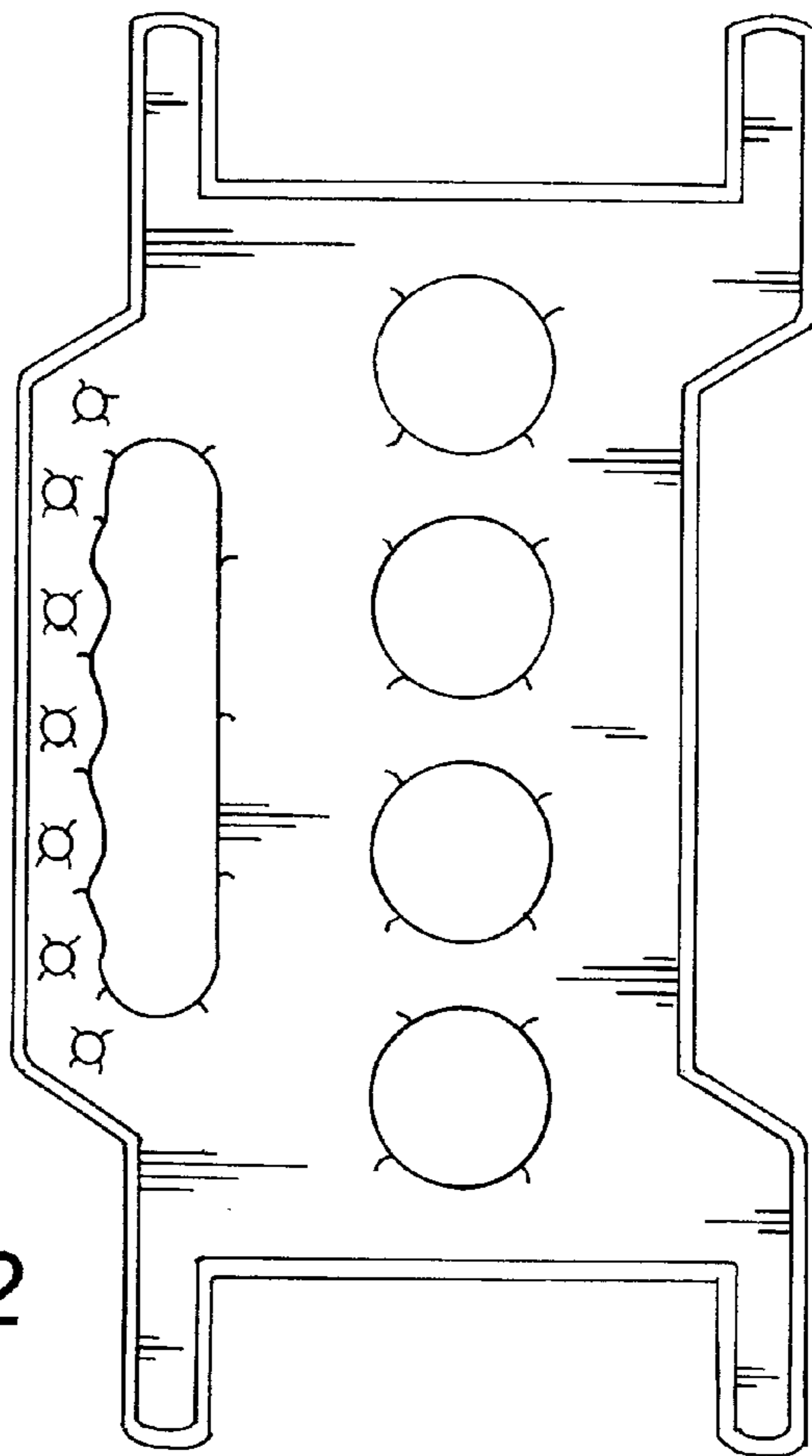
