**DESCRIPTION**

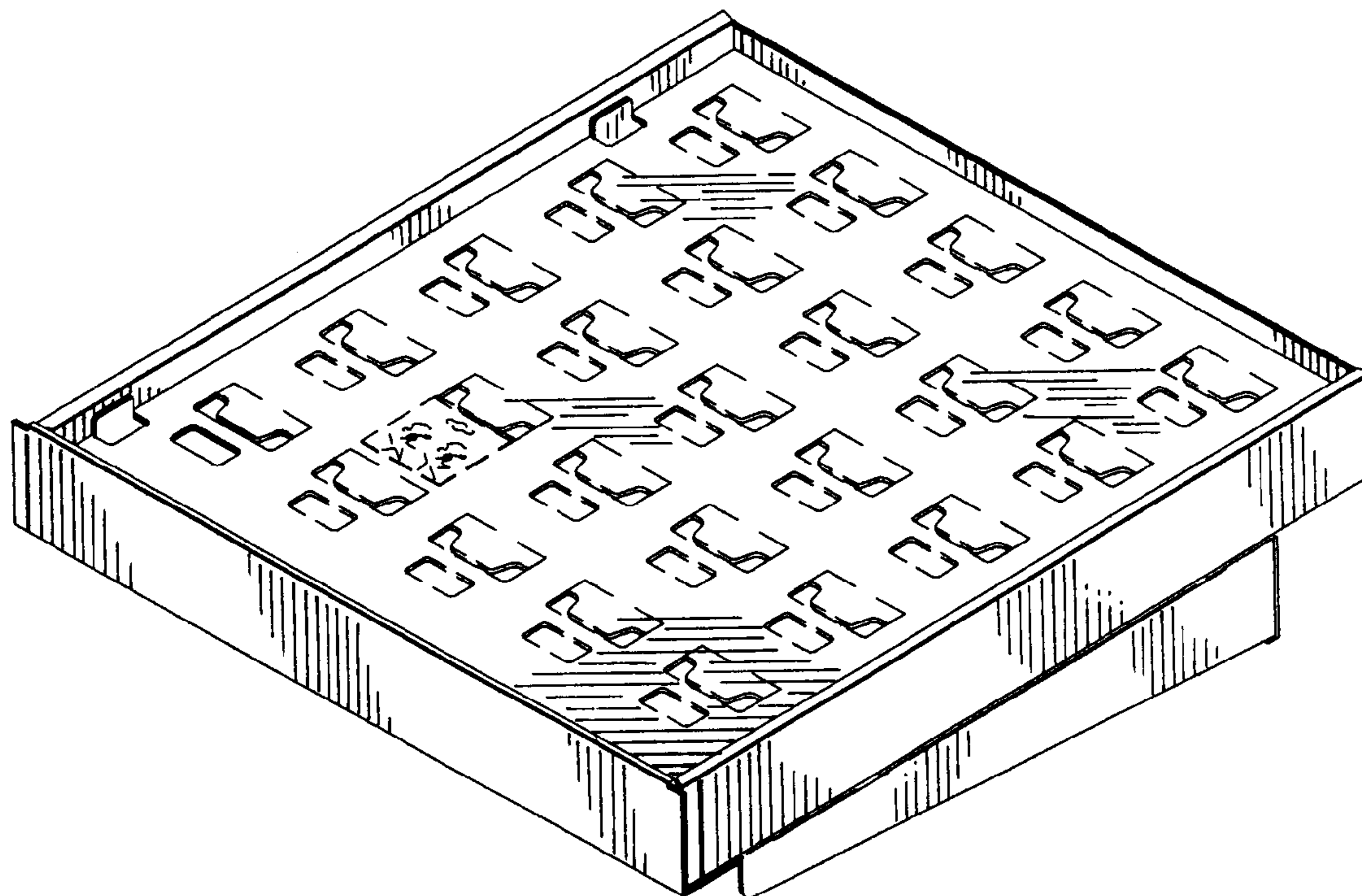
FIG. 1 is a perspective view of a display box for jewelry showing my new design;  
FIG. 2 is a right side view thereof, the left side being a mirror image;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevation thereof;

FIG. 6 is a rear elevation thereof.  
The jewelry and jewelry slots shown in broken lines in FIGS. 1, 3 and 4 are for illustrative purposes only and form no part of the claimed design.

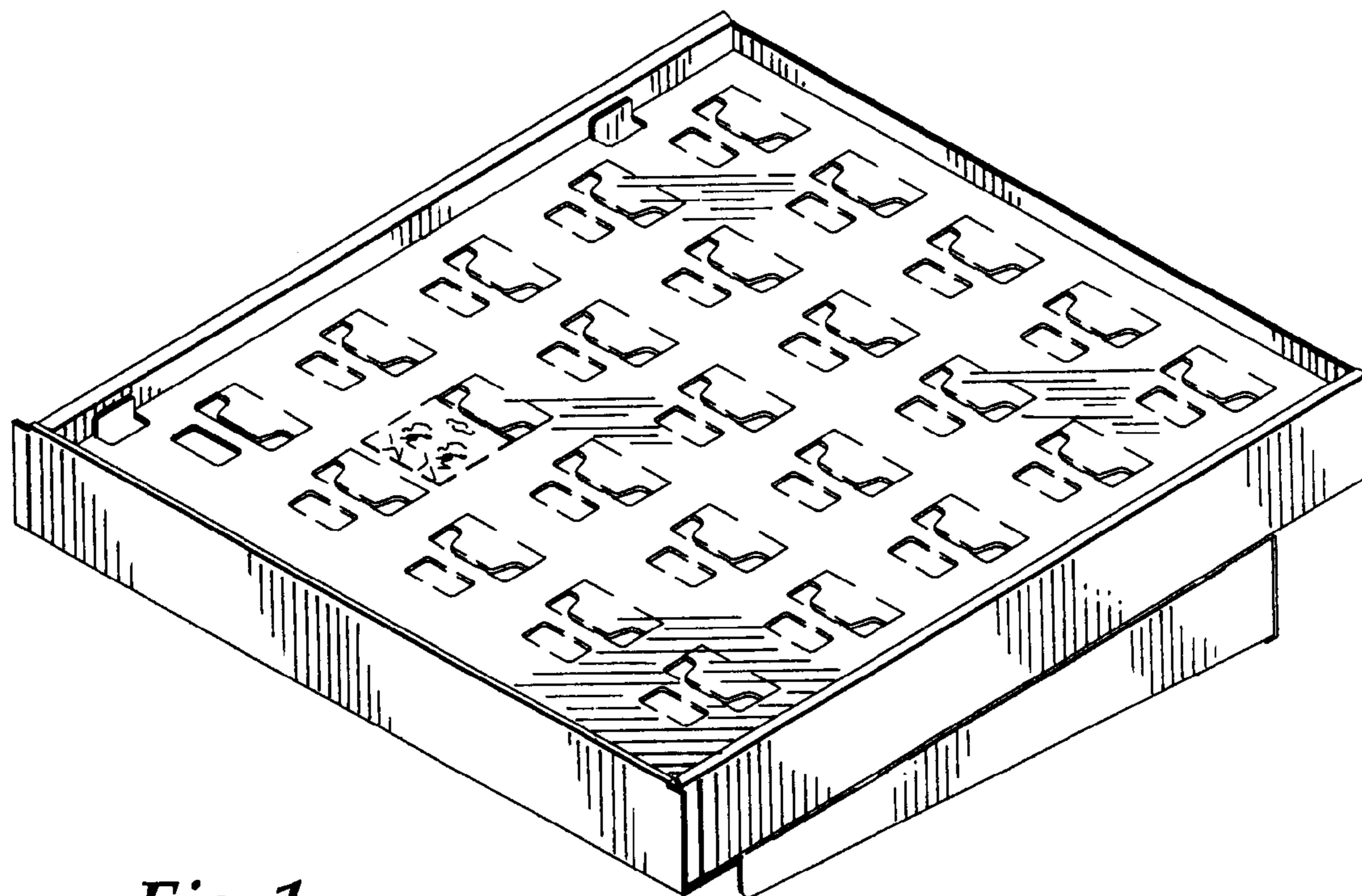

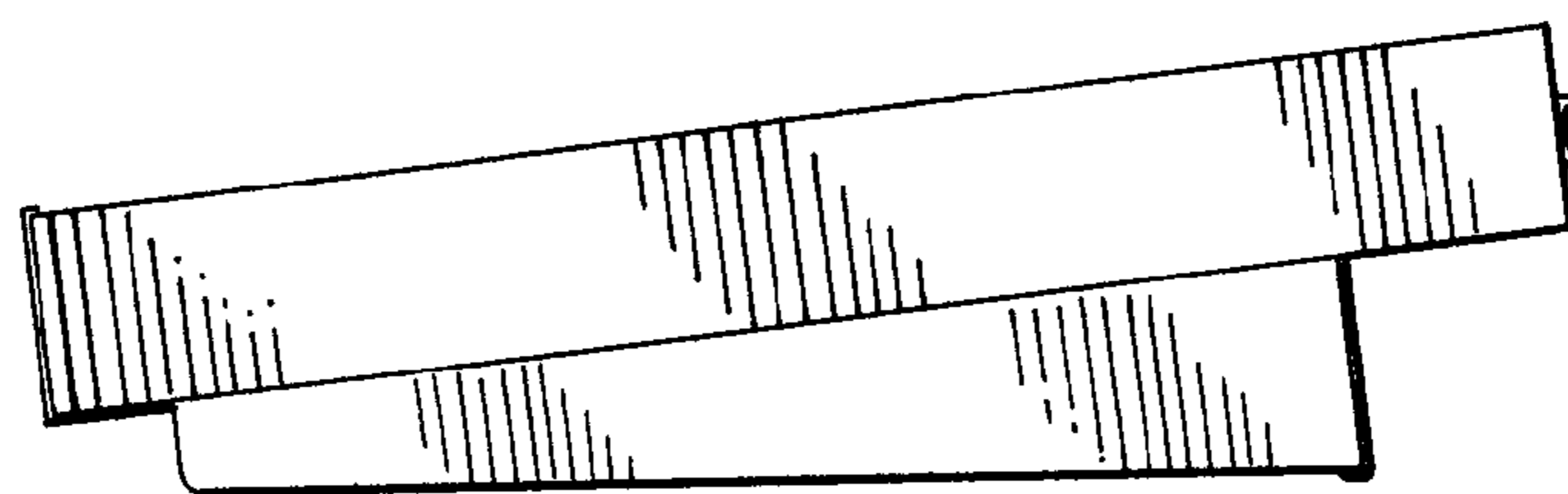

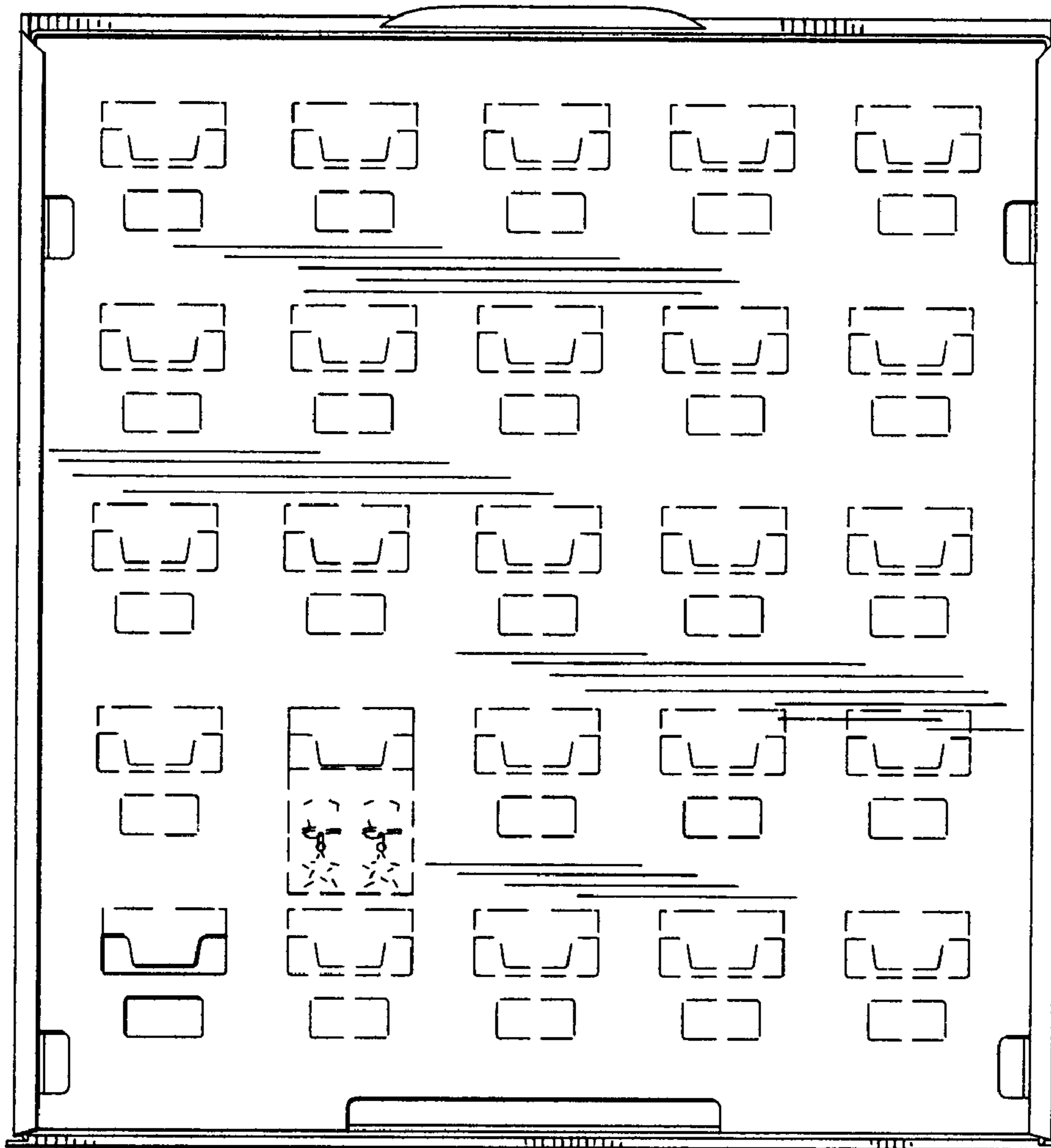




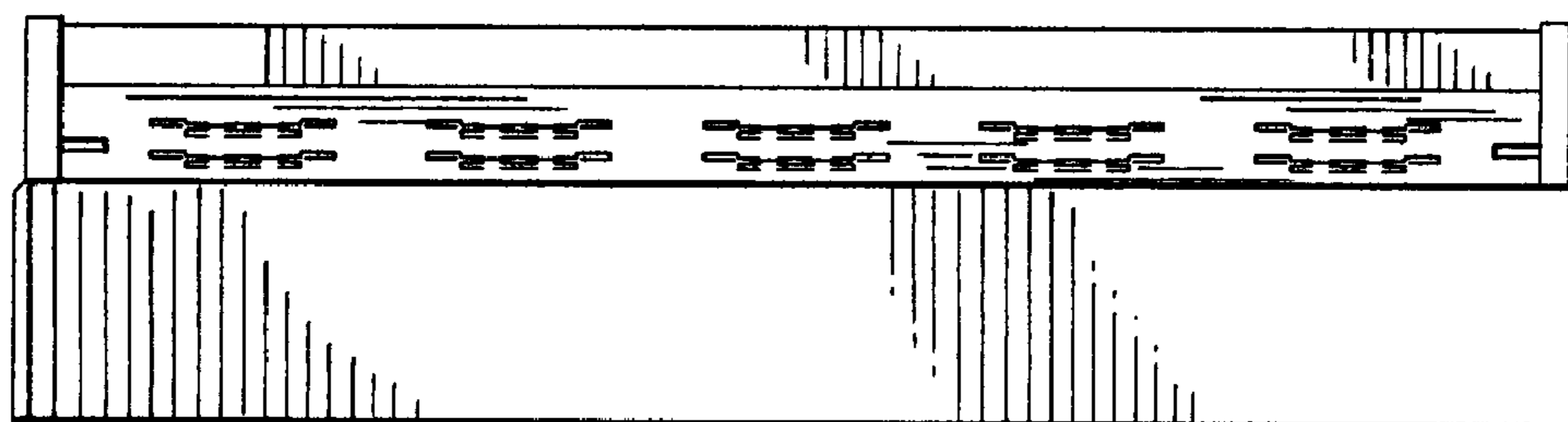

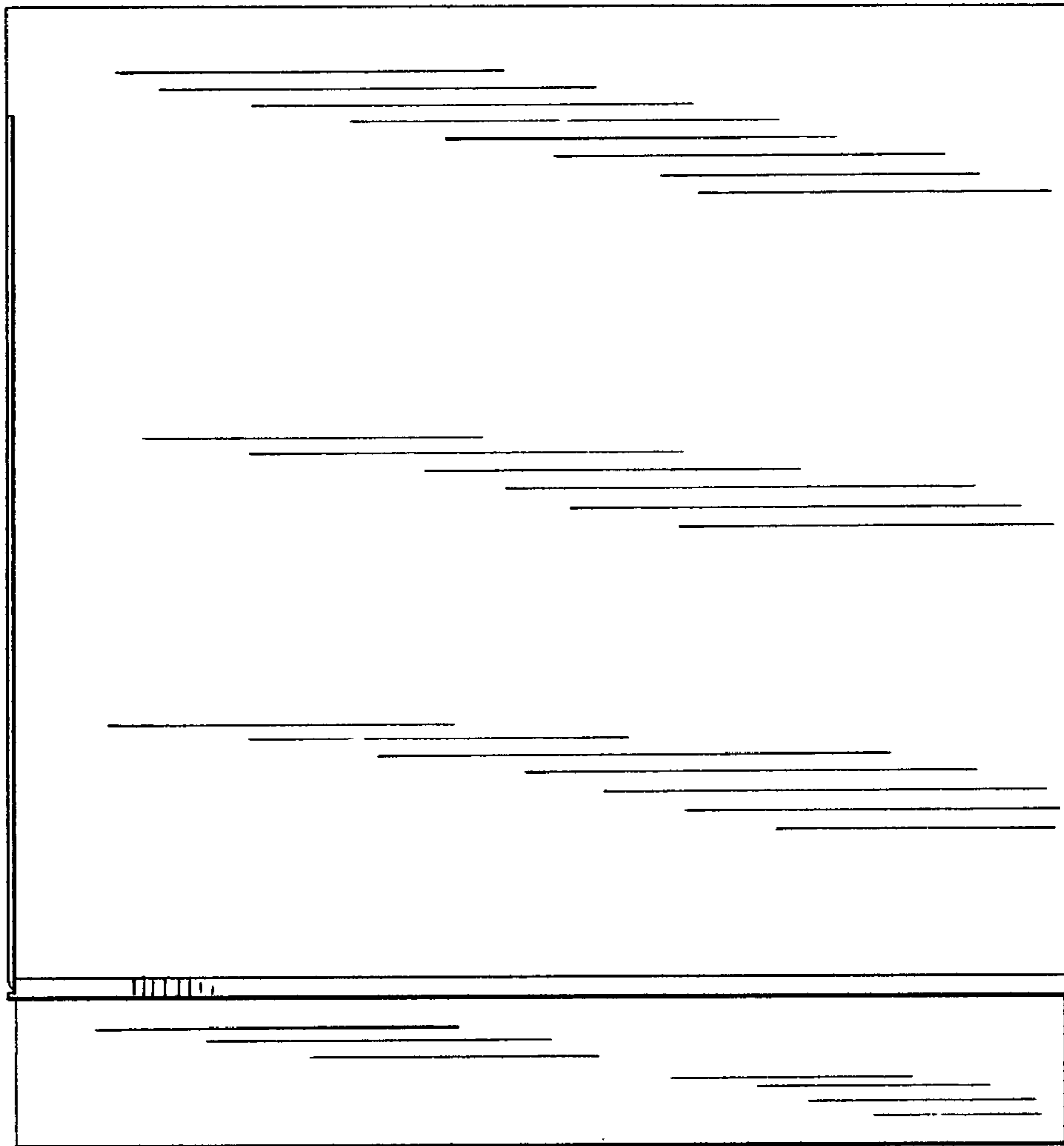

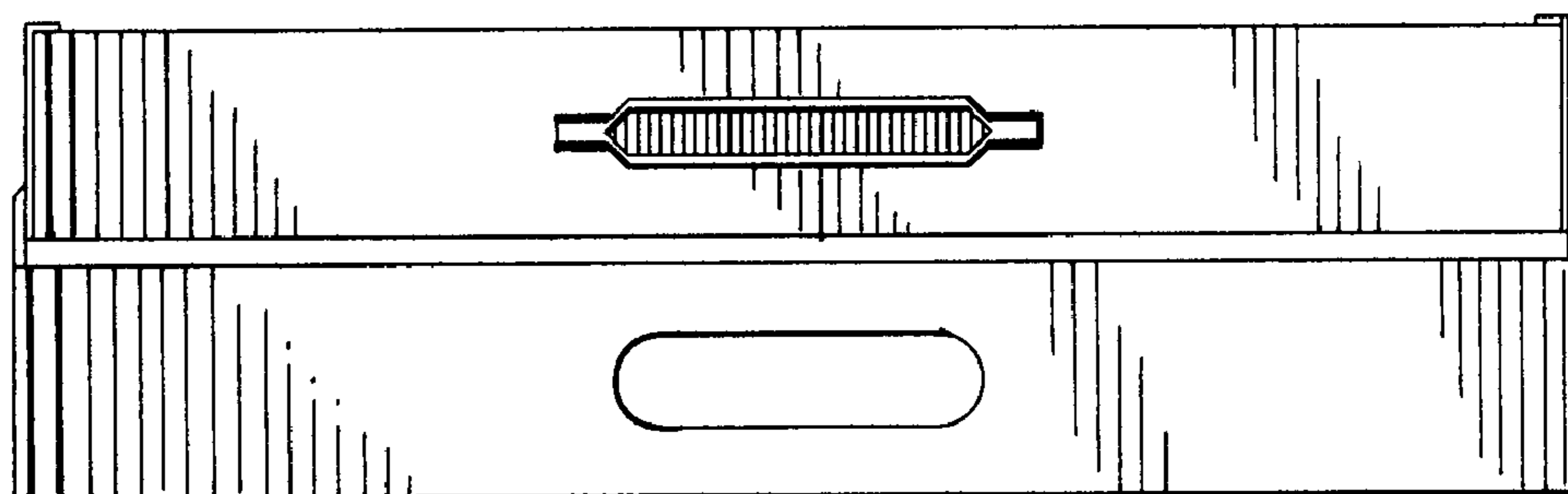
