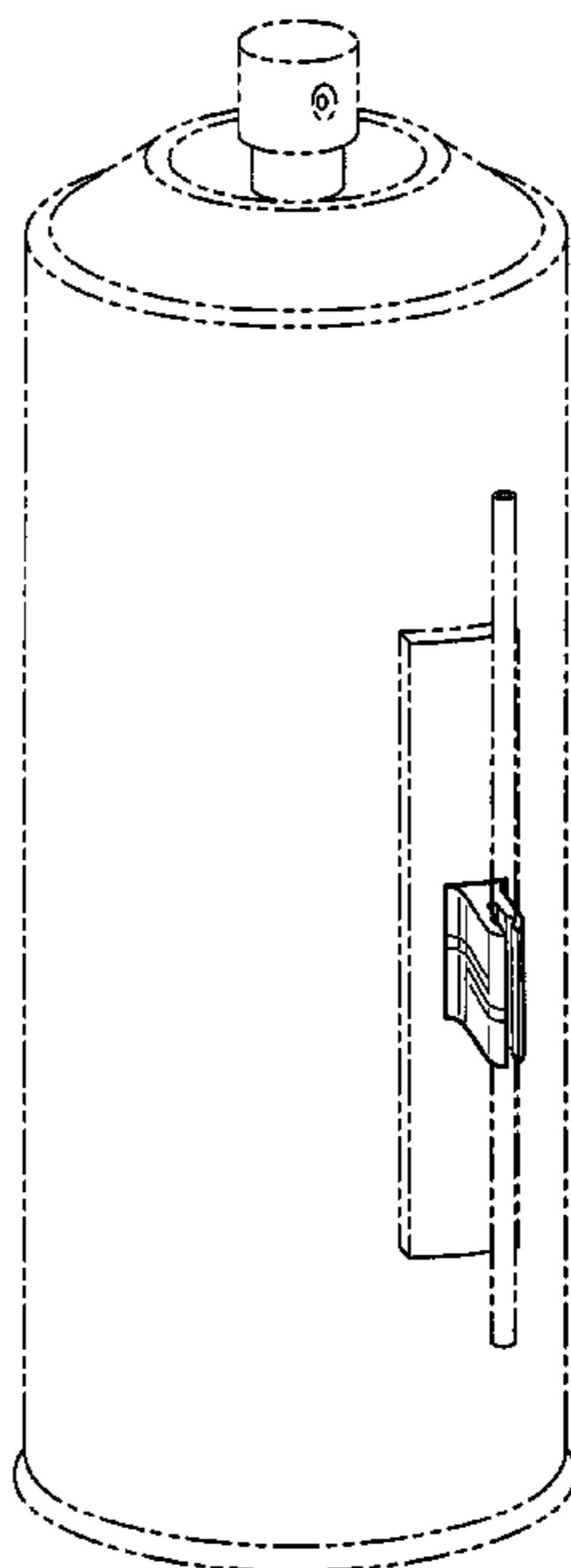
(57) **CLAIM**

The ornamental design for a aerosol spray tube holder, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of my new design shown attached to an aerosol spray can shown in broken lines; FIG. 2 is a top plan view of my new design; FIG. 3 is a front elevation view thereof; and, FIG. 4 is a side elevation view thereof. 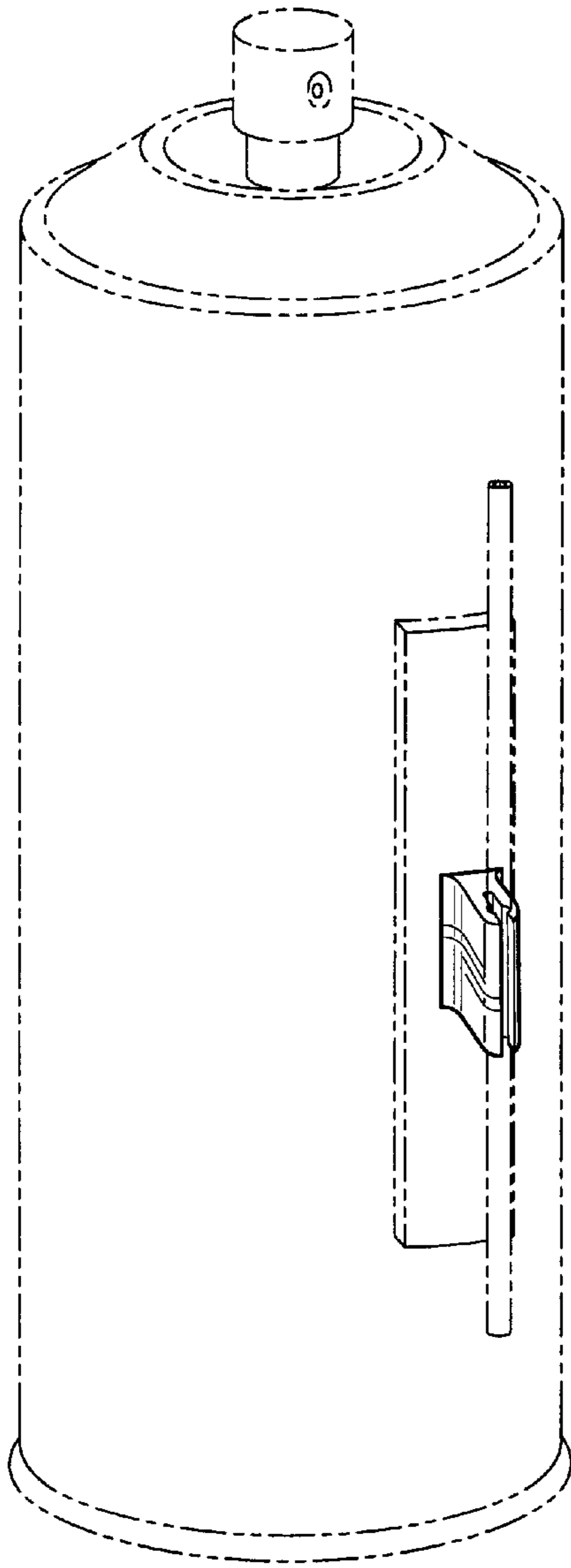

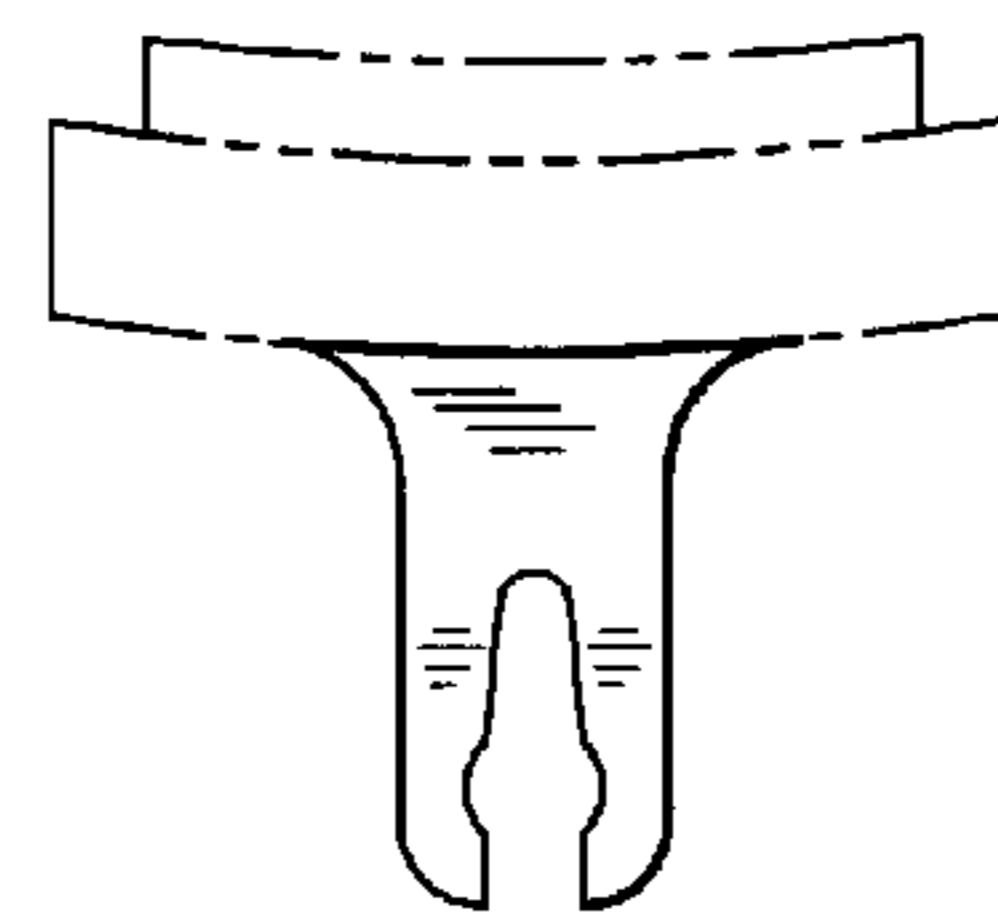

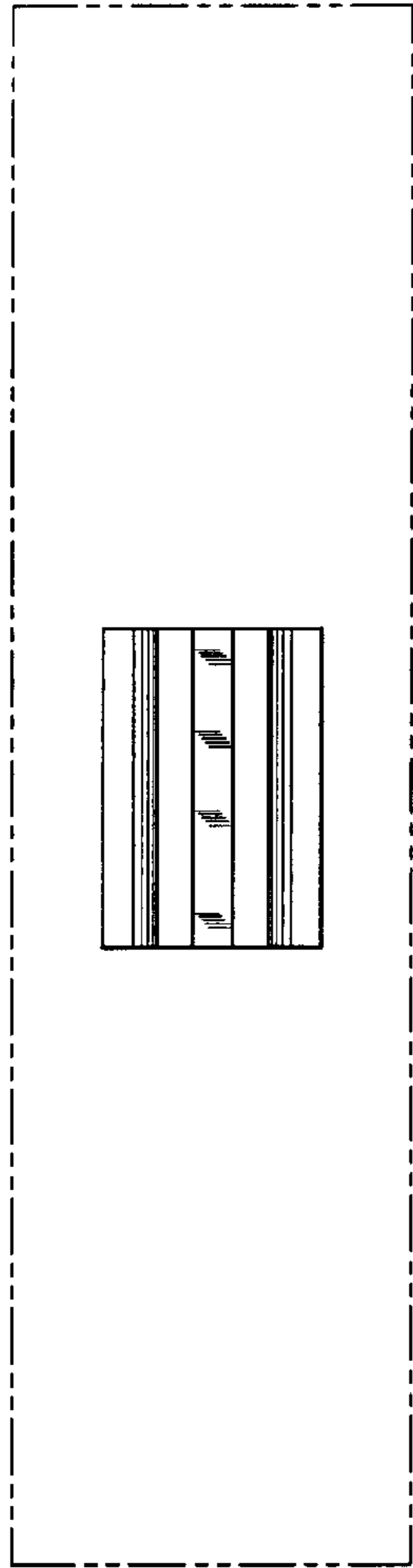

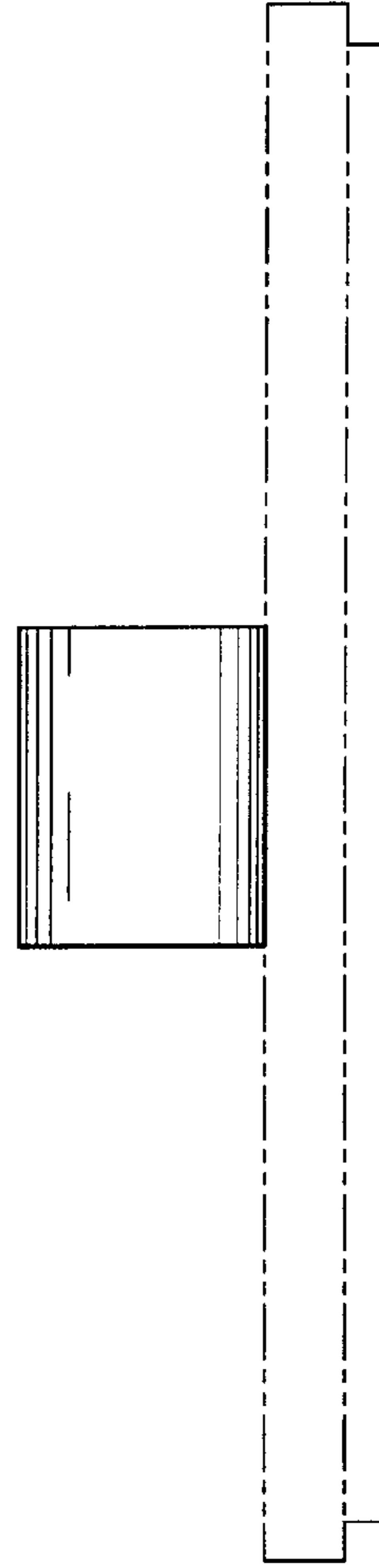
