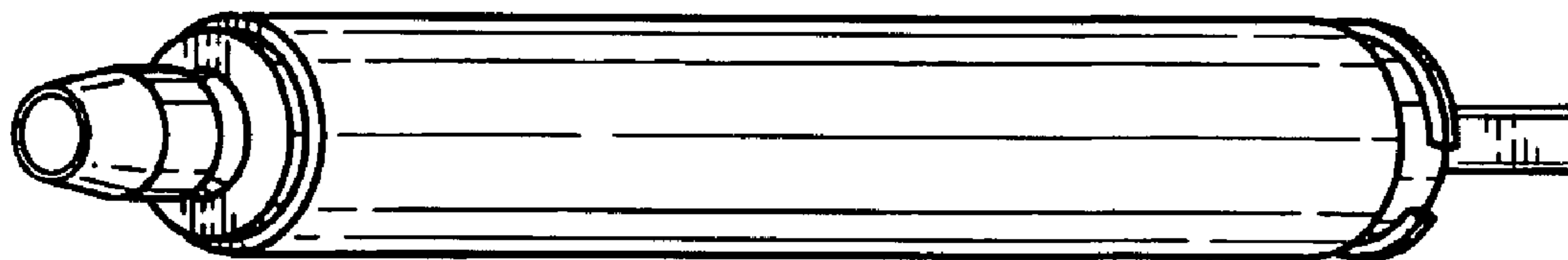
(57) **CLAIM**

The ornamental design for a pump for a soap dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front 3-dimensional prespective view of a pump for a soap dispenser.
FIG. 2 is a rear 3 dimensional perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a side elevation view thereof (opposite side is mirror image),
FIG. 6 is a top plan view thereof; and,

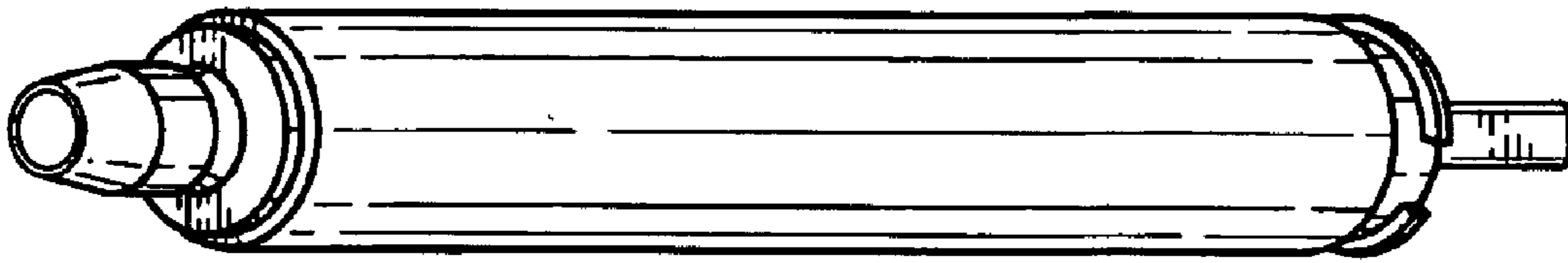

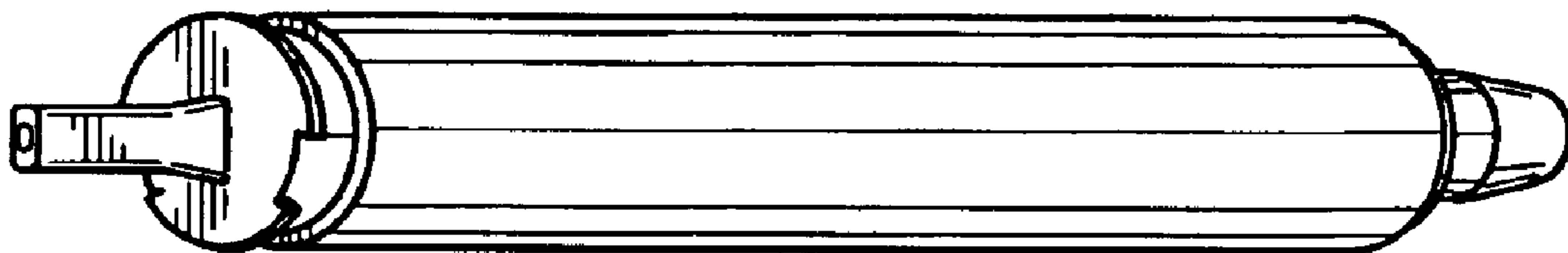

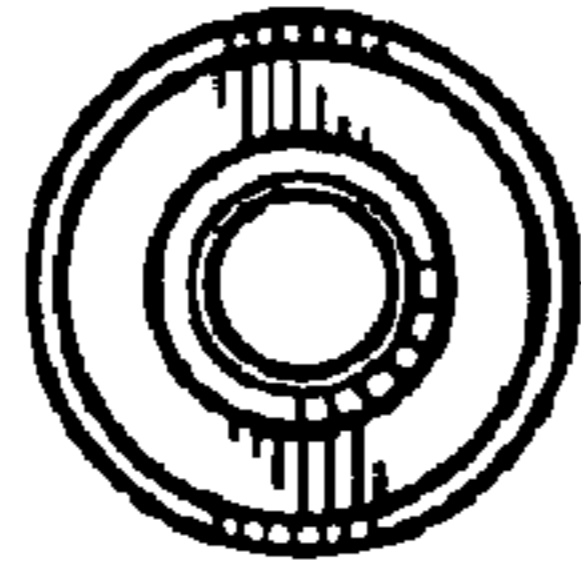

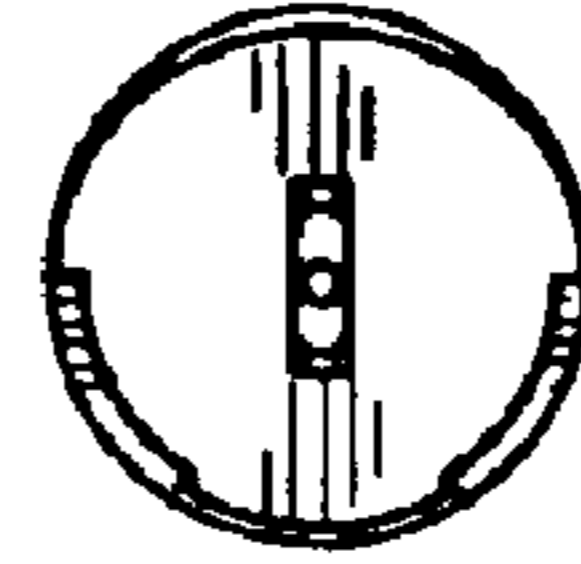

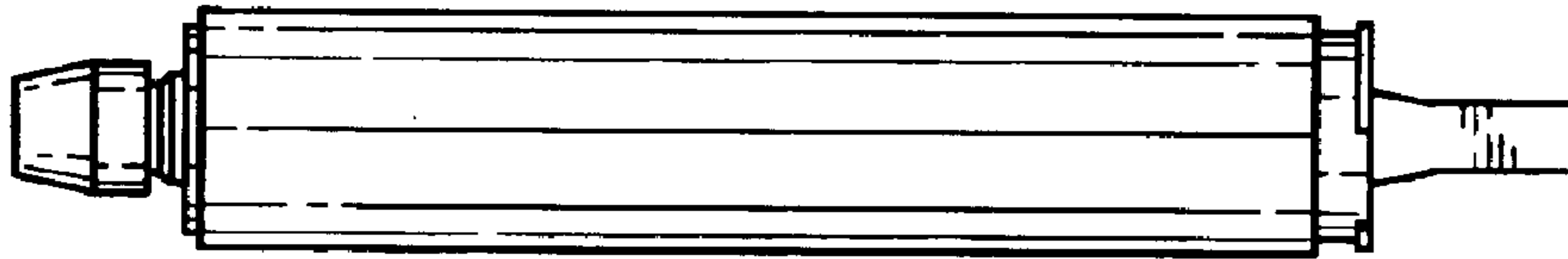

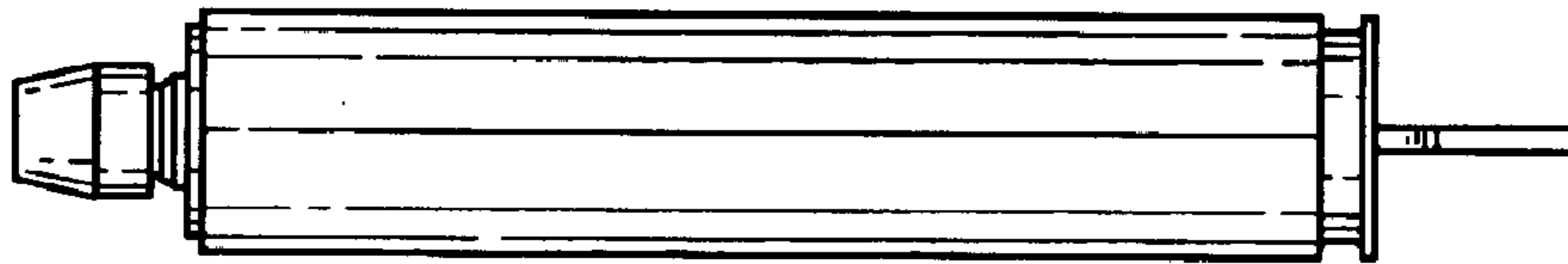

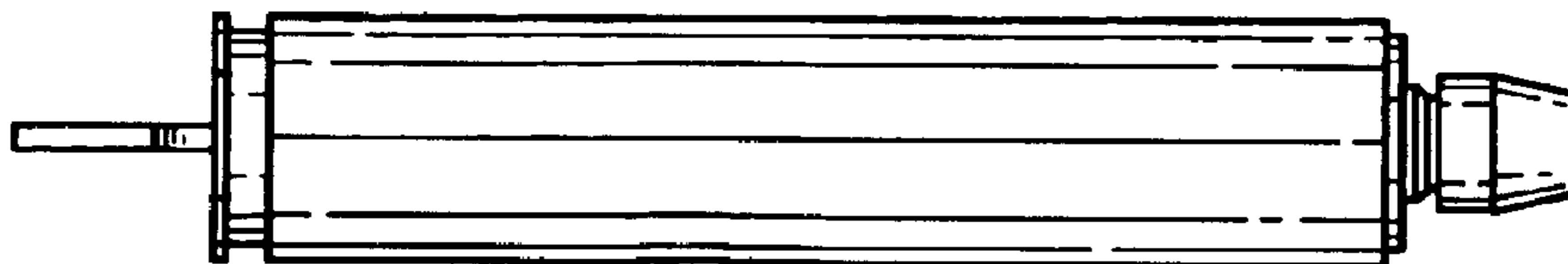
