(57) **CLAIM**

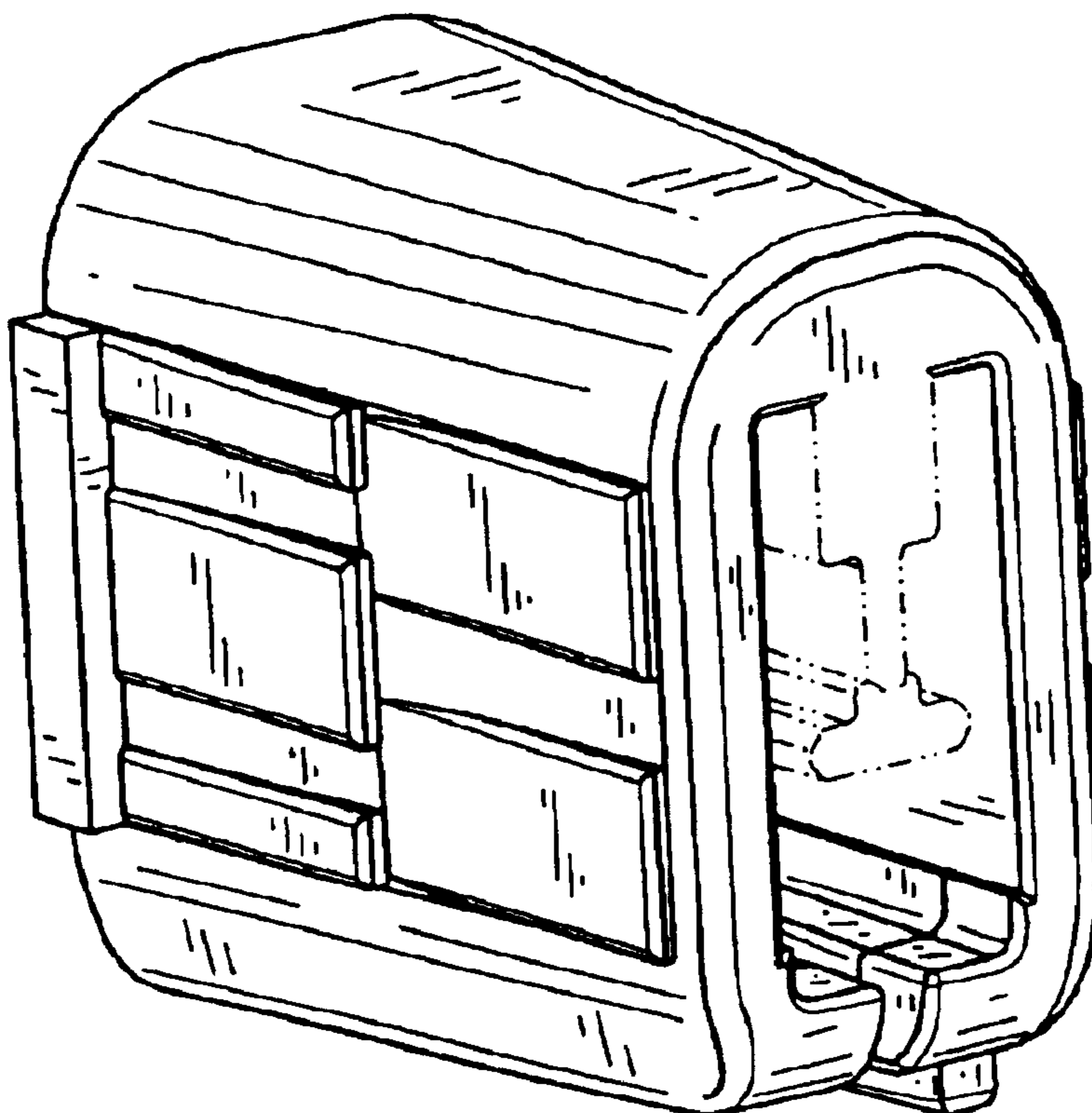
The ornamental design of a leak resistant slider device, as
shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a slider device for a
resealable closure in accordance with the present invention;
FIG. 2 is a top view of the slider device;
FIG. 3 is a left side view of the slider device, with the right
side view being a mirror image thereof;
FIG. 4 is a front view of the slider device;
FIG. 5 is a back view of the slider device; and,
FIG. 6 is a bottom view of the slider device.

The phantom lines shown in FIGS. 1–6 show the remaining
portions of the slider device and are for illustrative purposes
only and form no part of the claimed design.

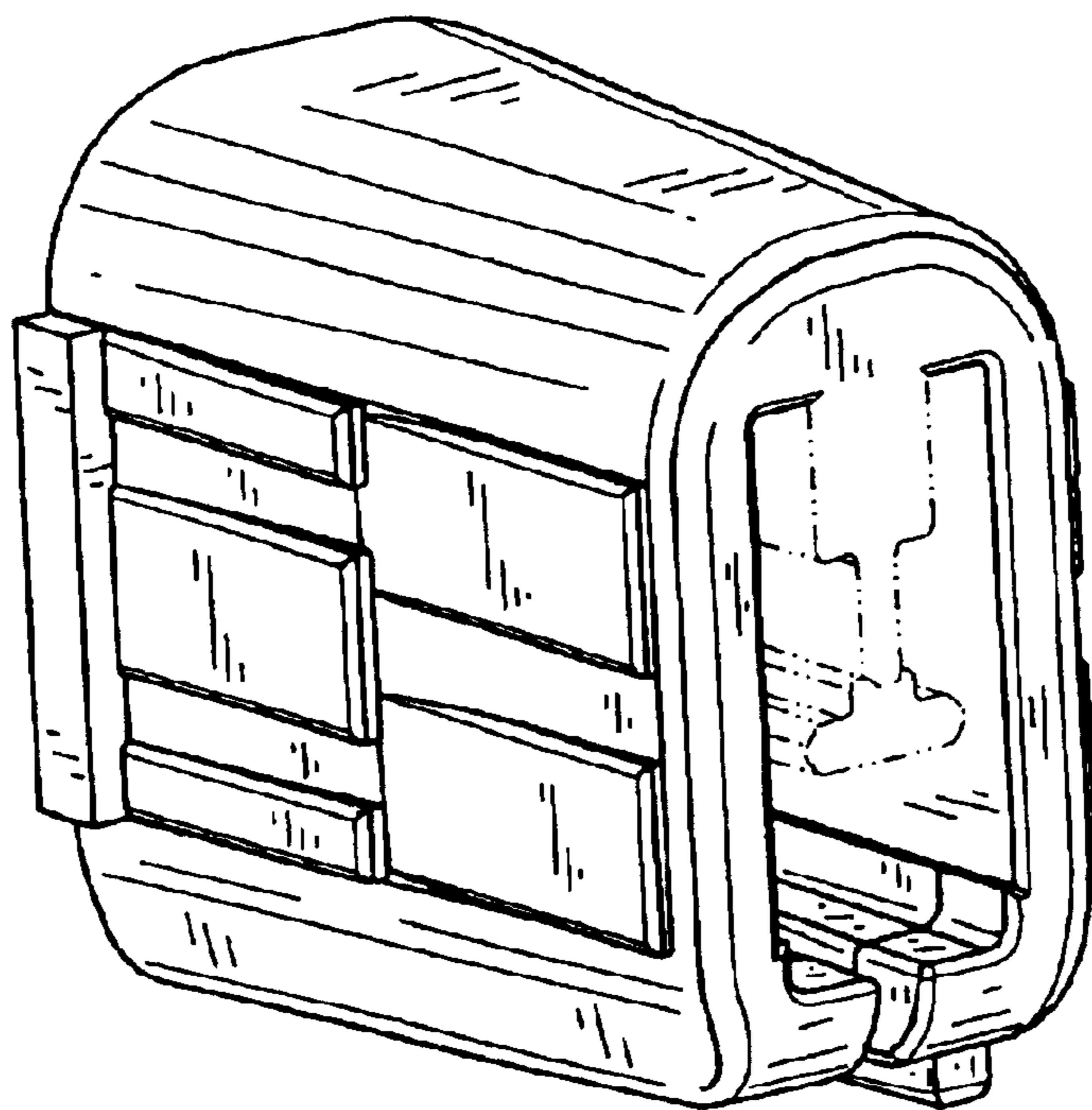

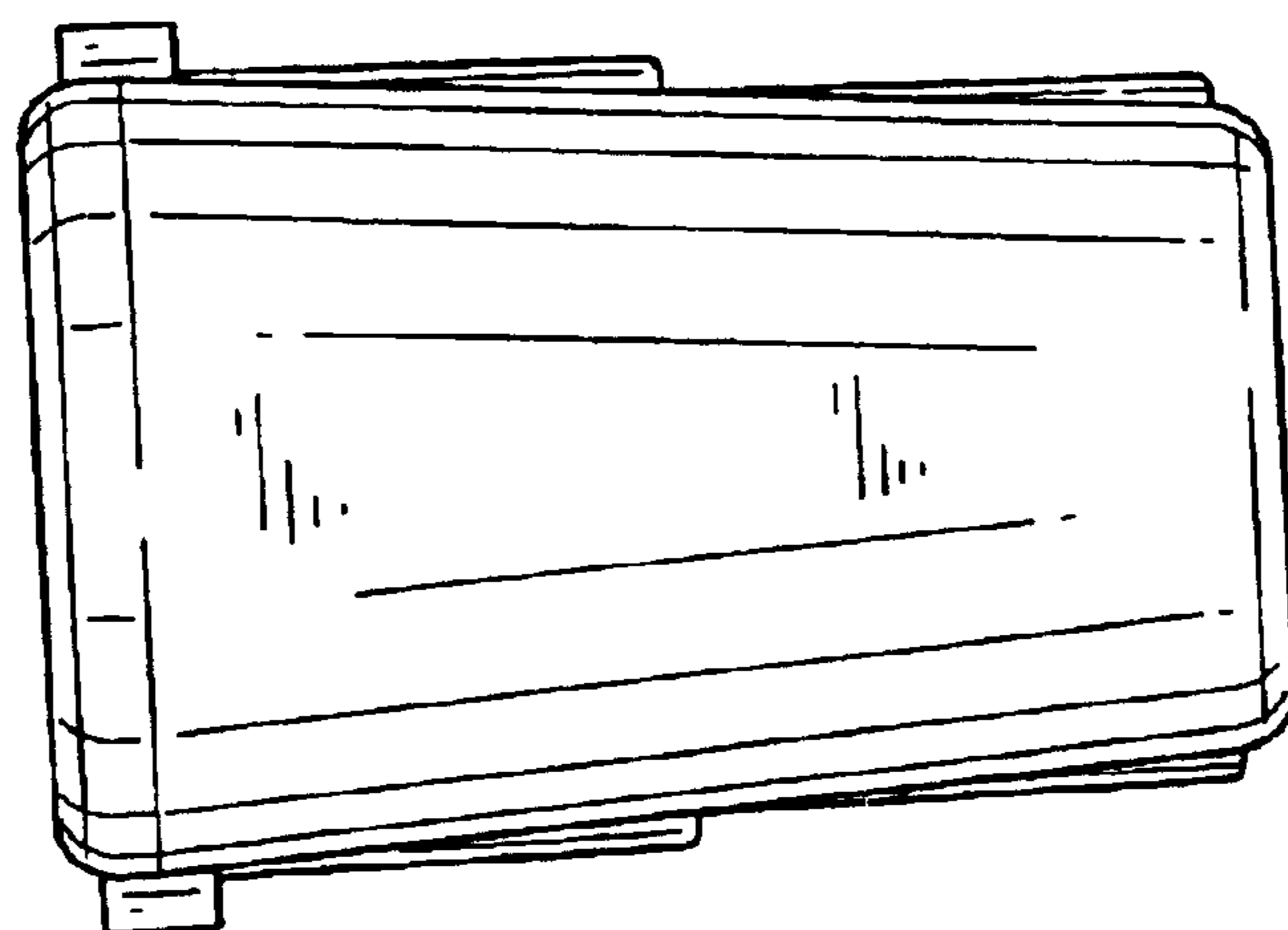

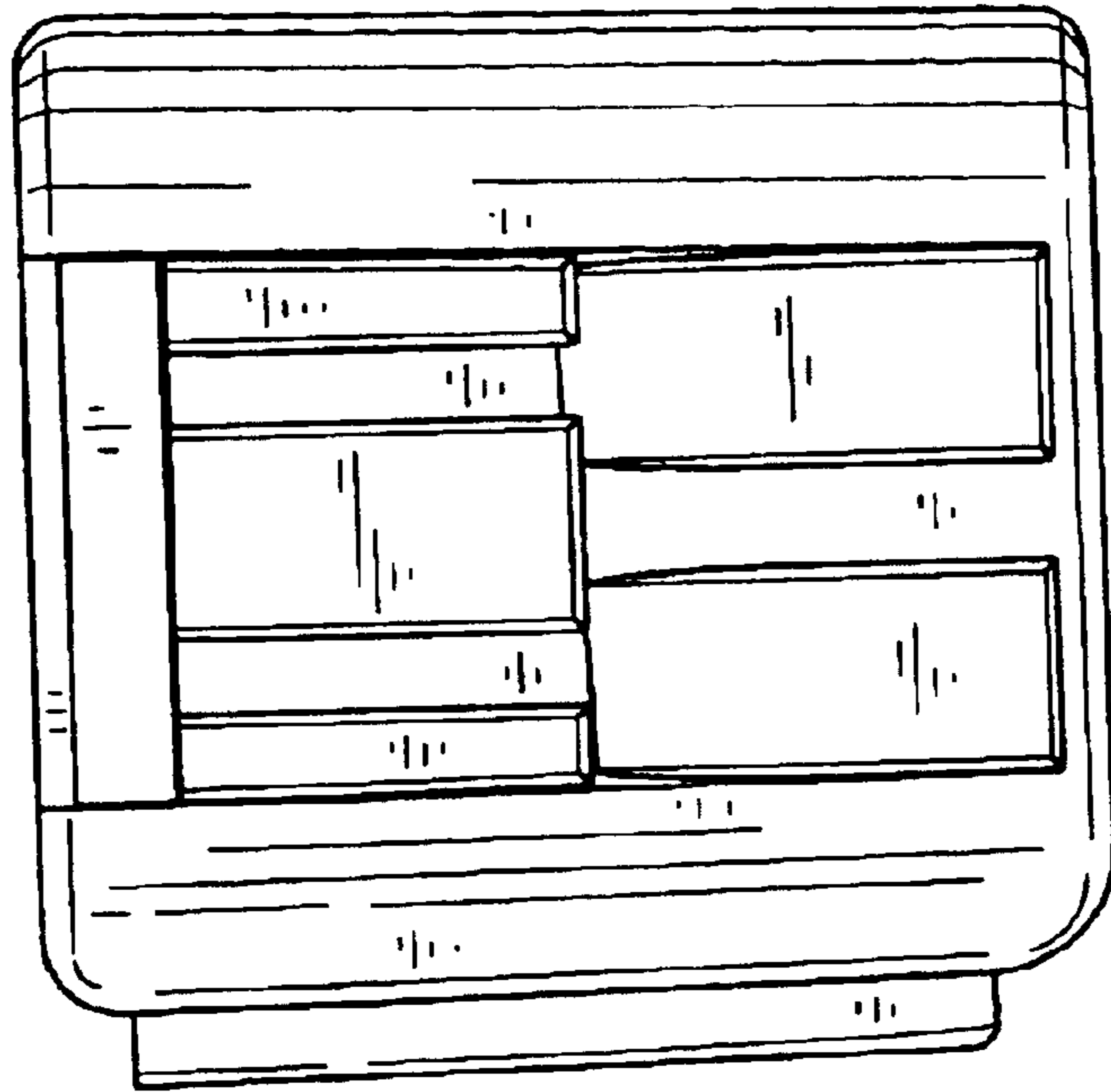

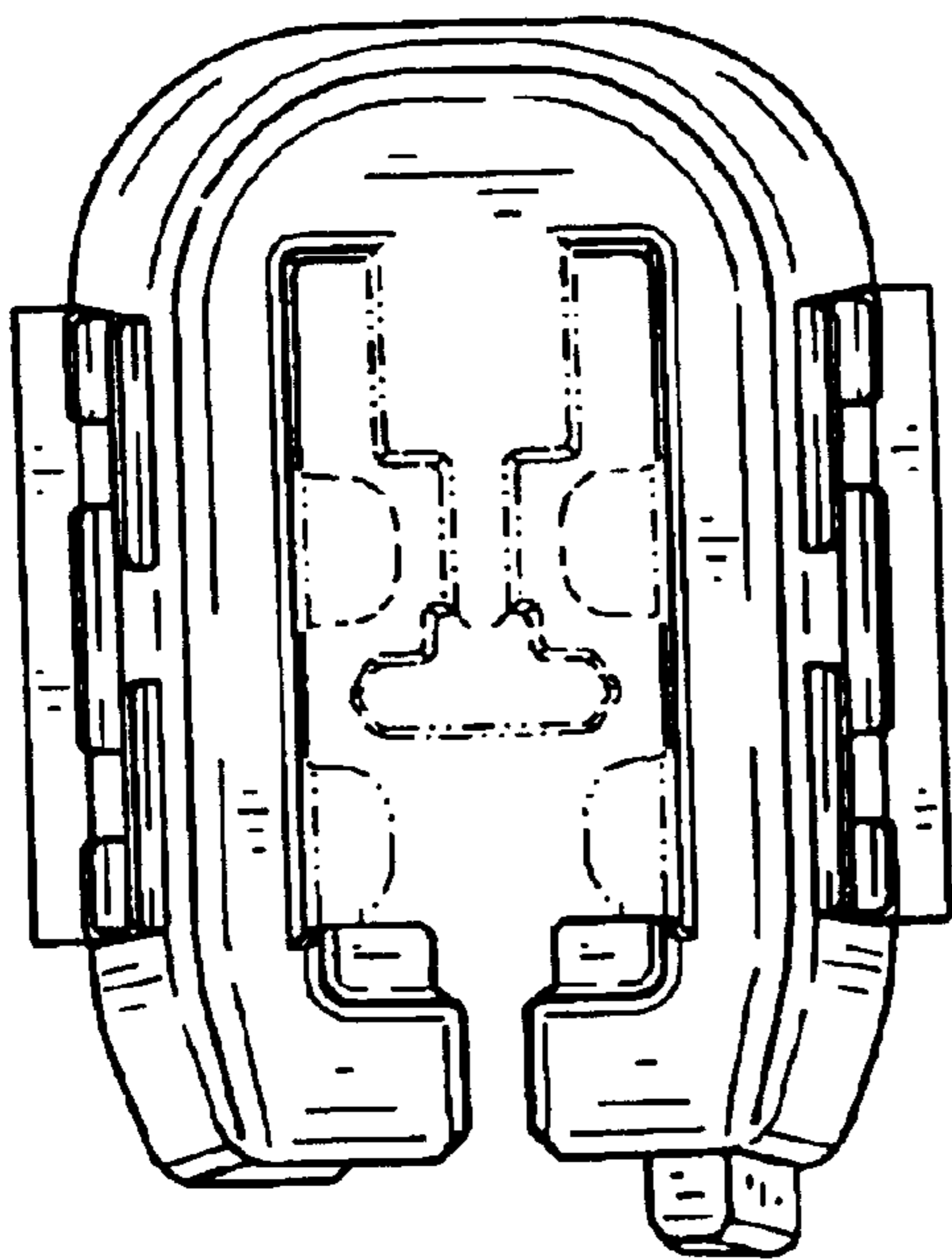

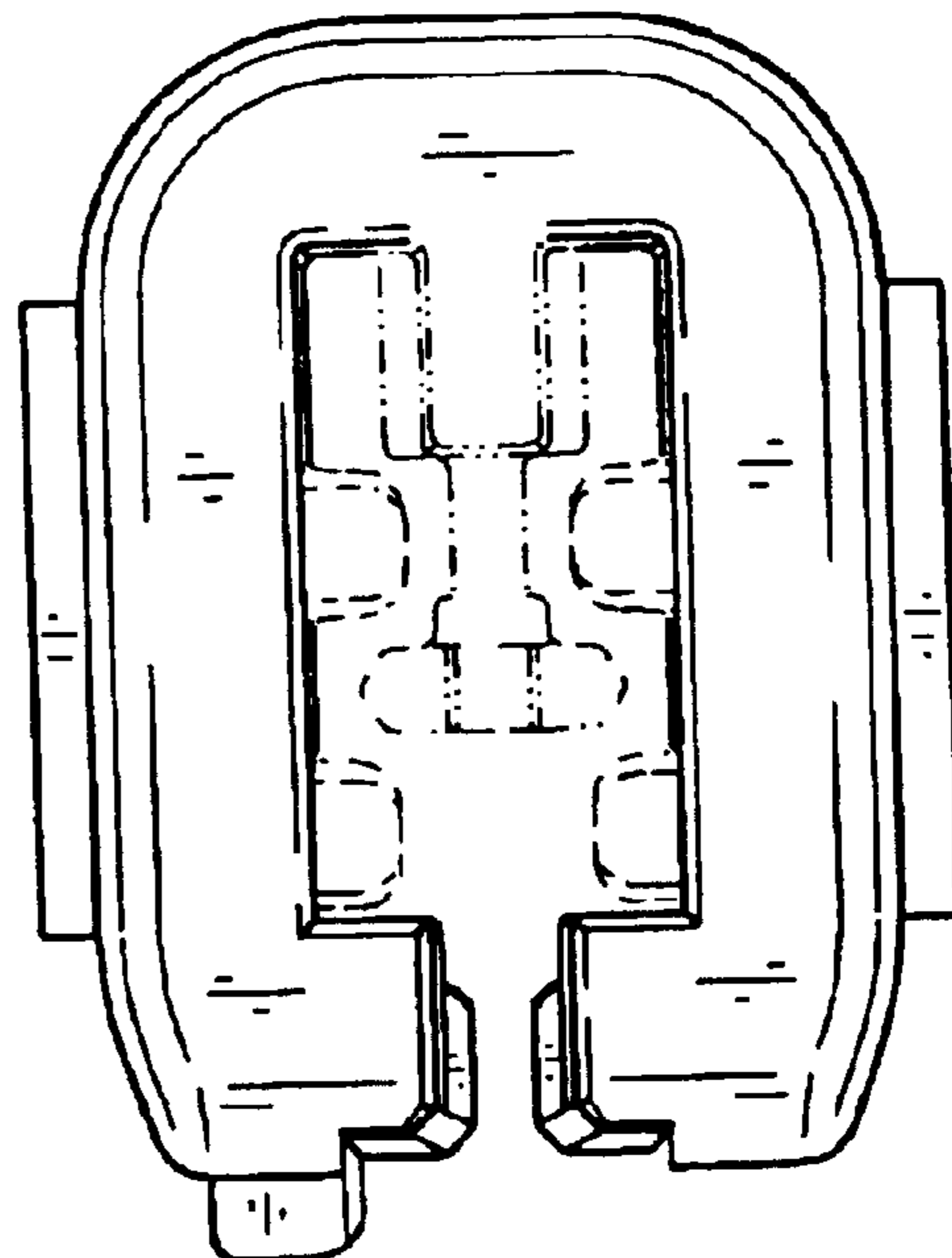

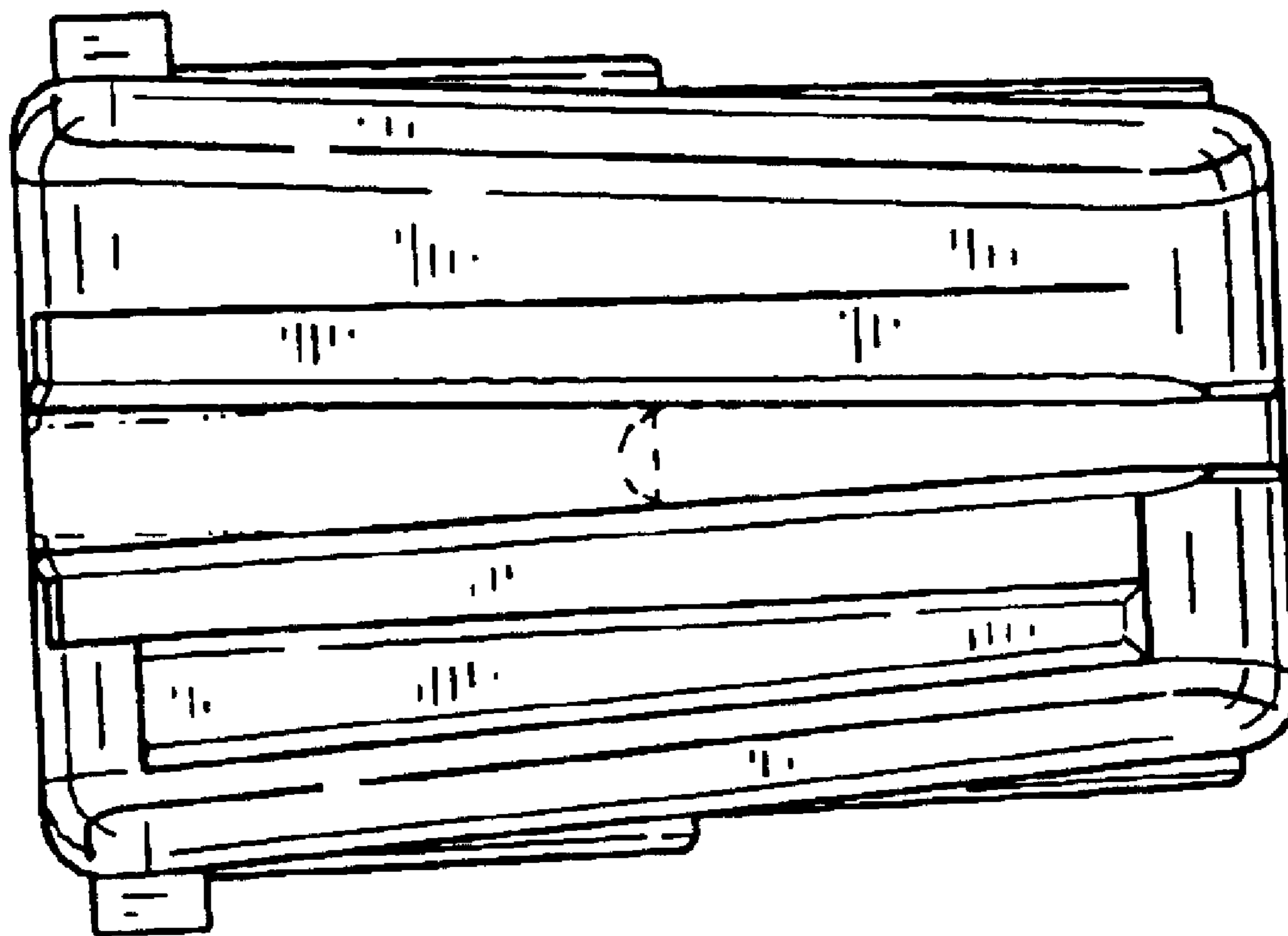
