FIG. 5 is a left side elevation view thereof;

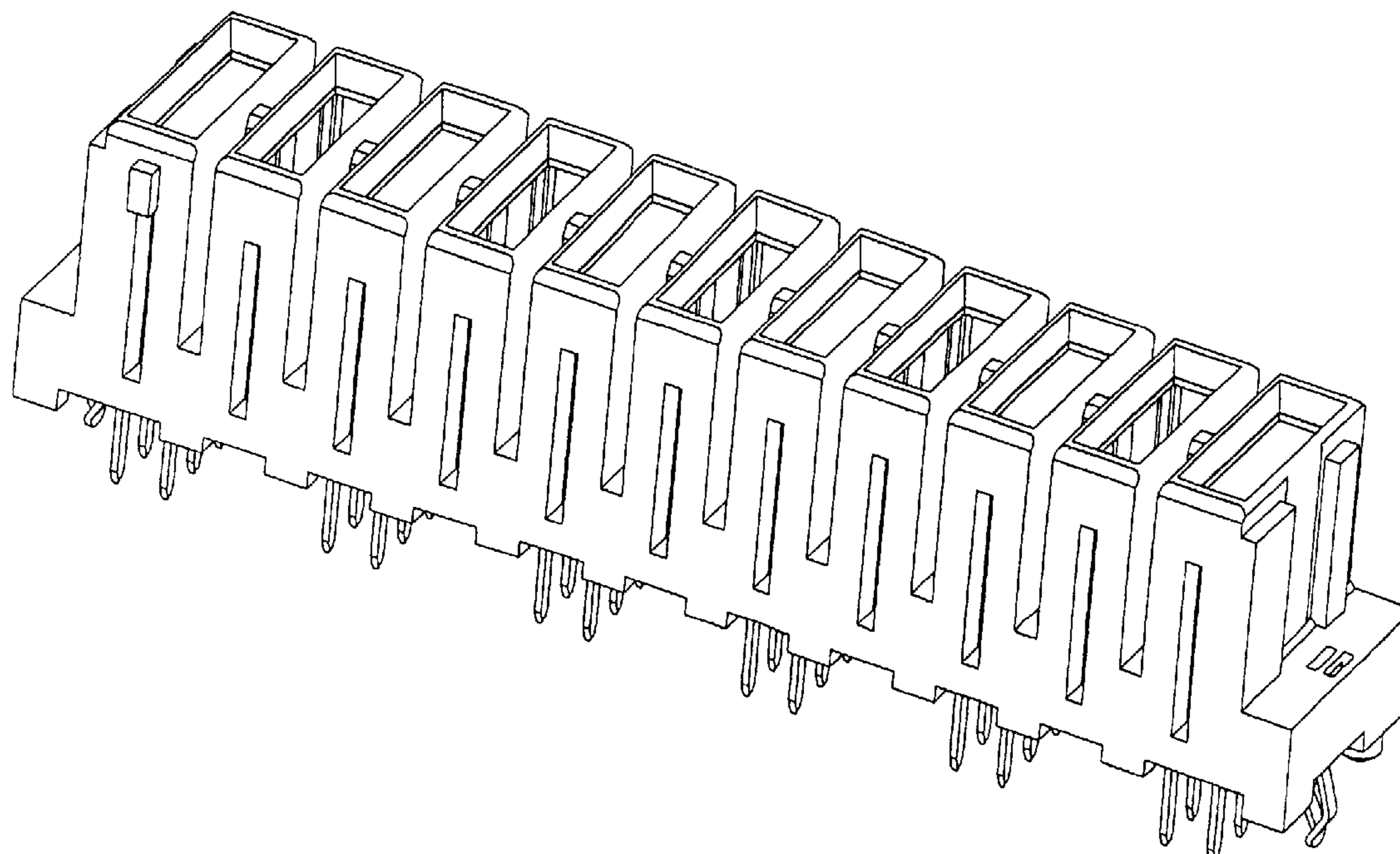
FIG. 6 is a rear elevation view thereof;

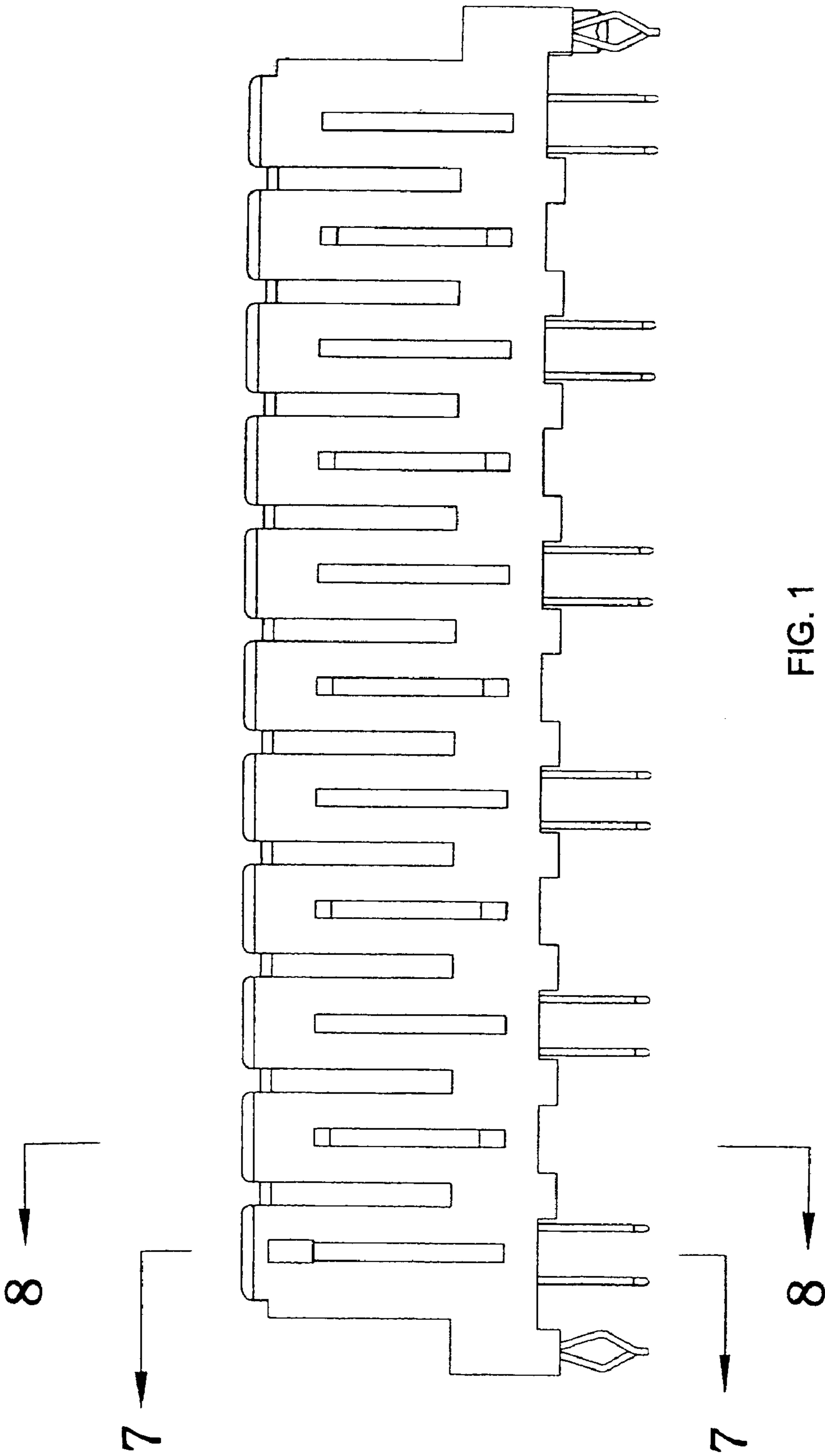
FIG. 7 is a cross sectional view thereof; taken along the line 7-7 in FIG. 1;

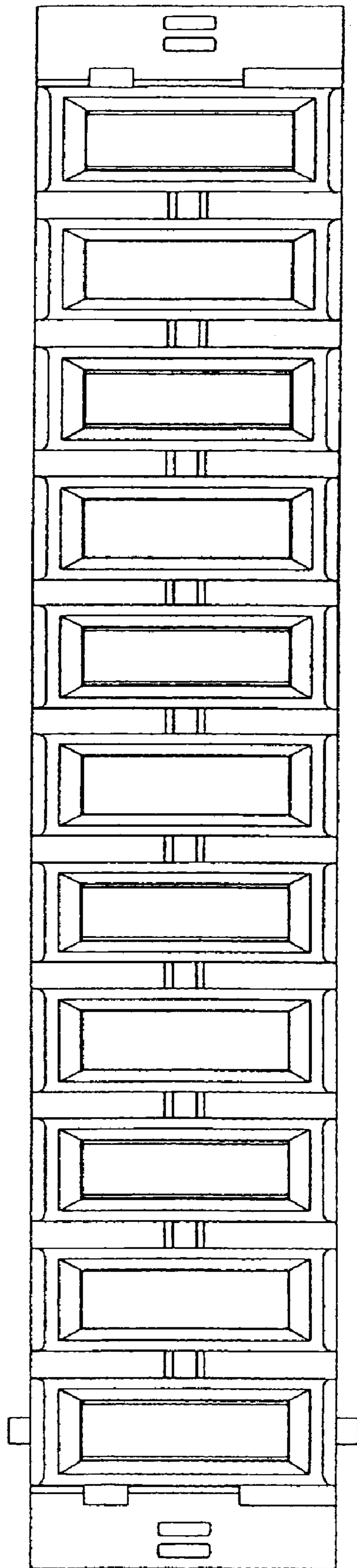

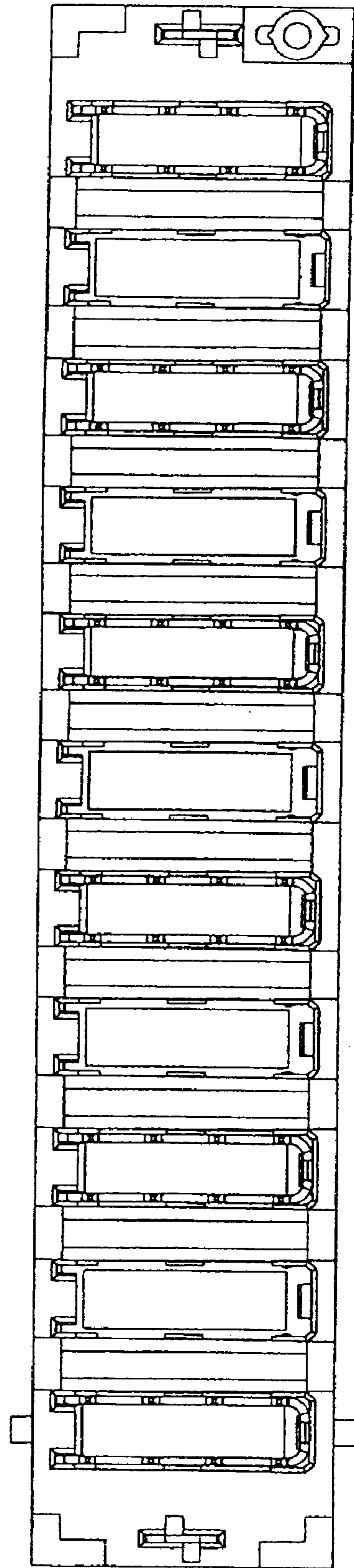

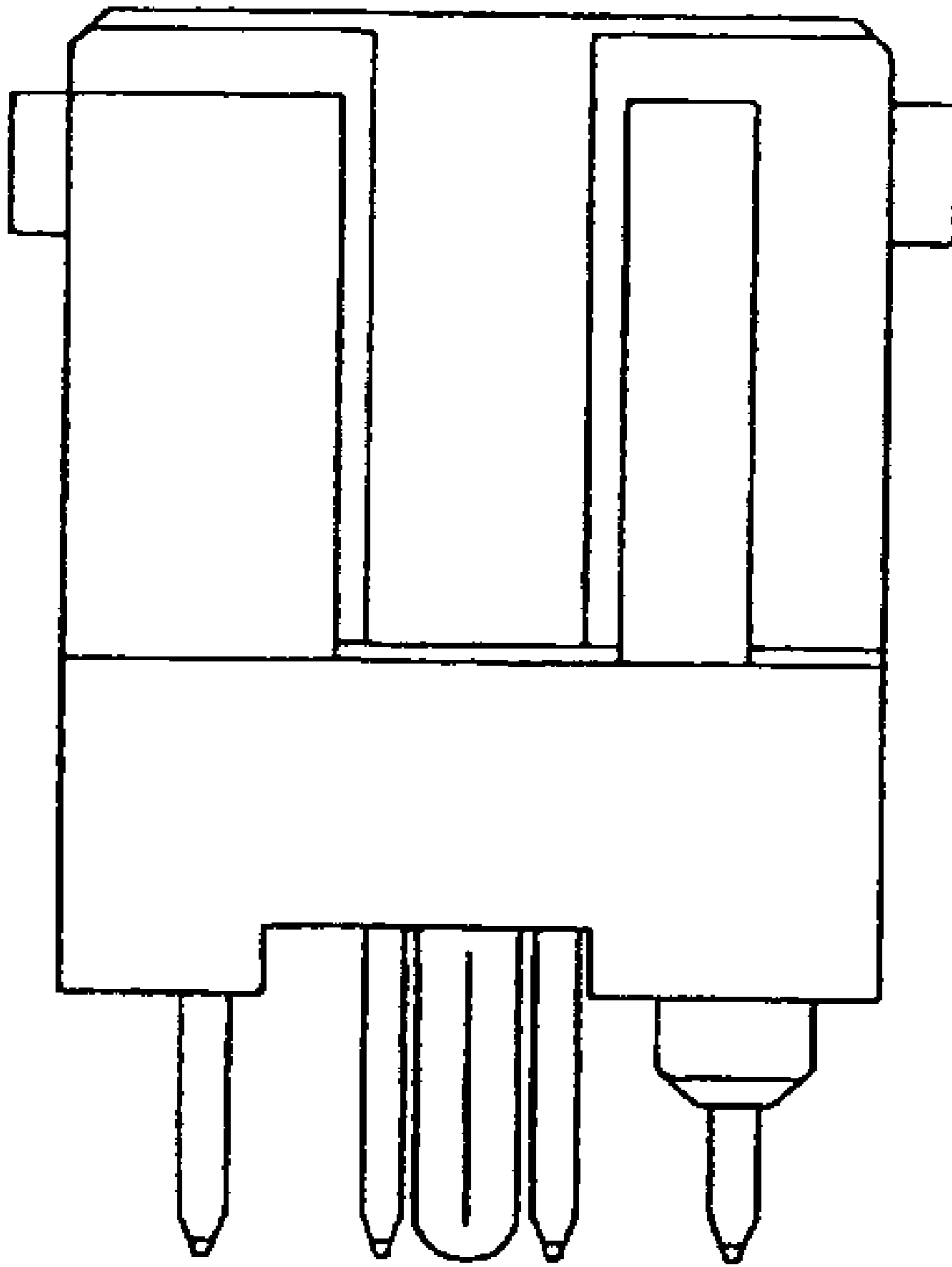

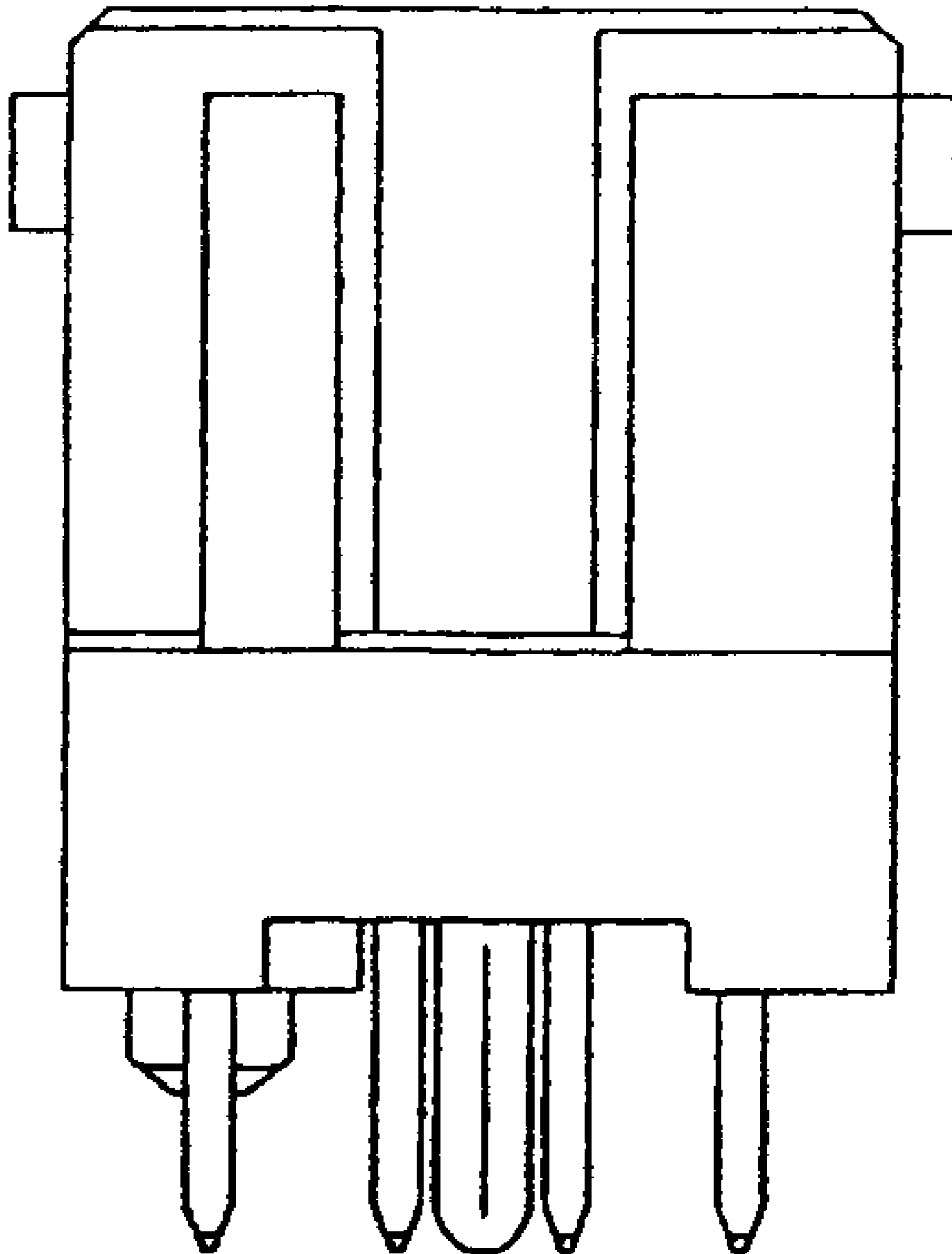

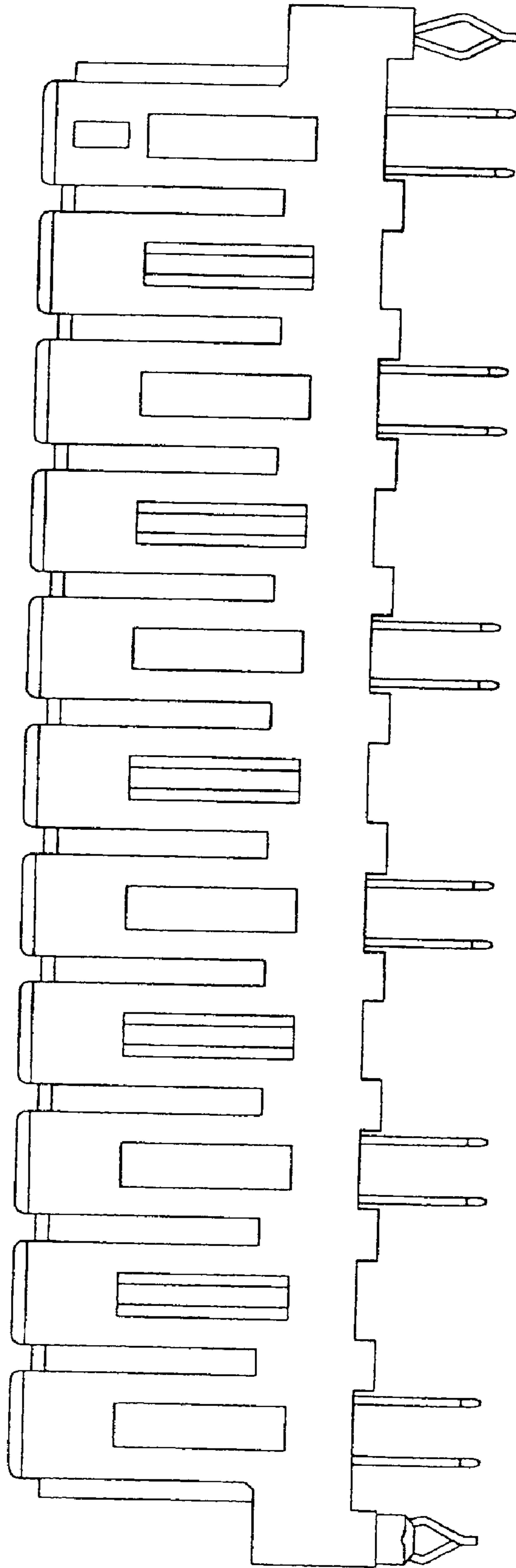

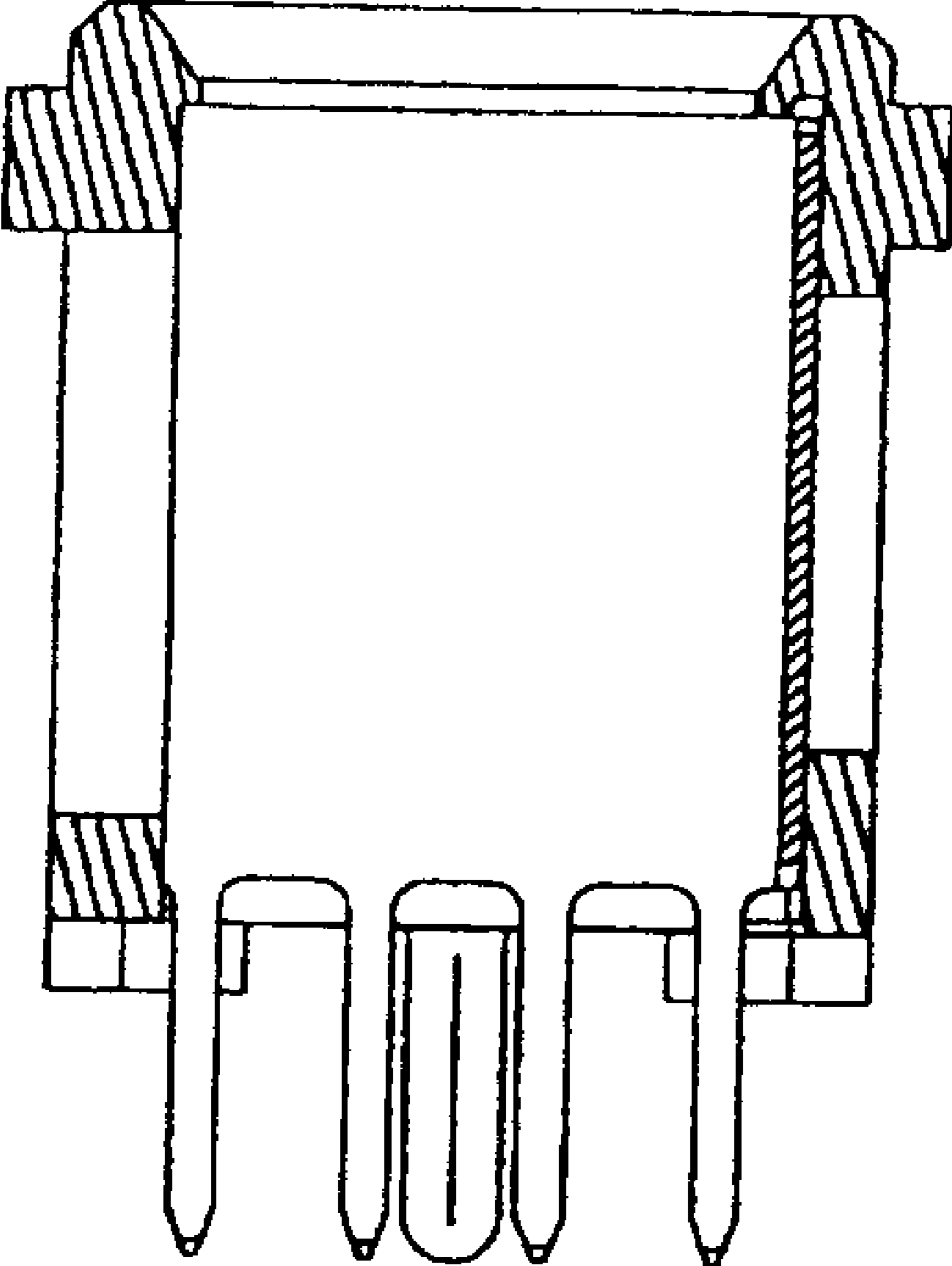

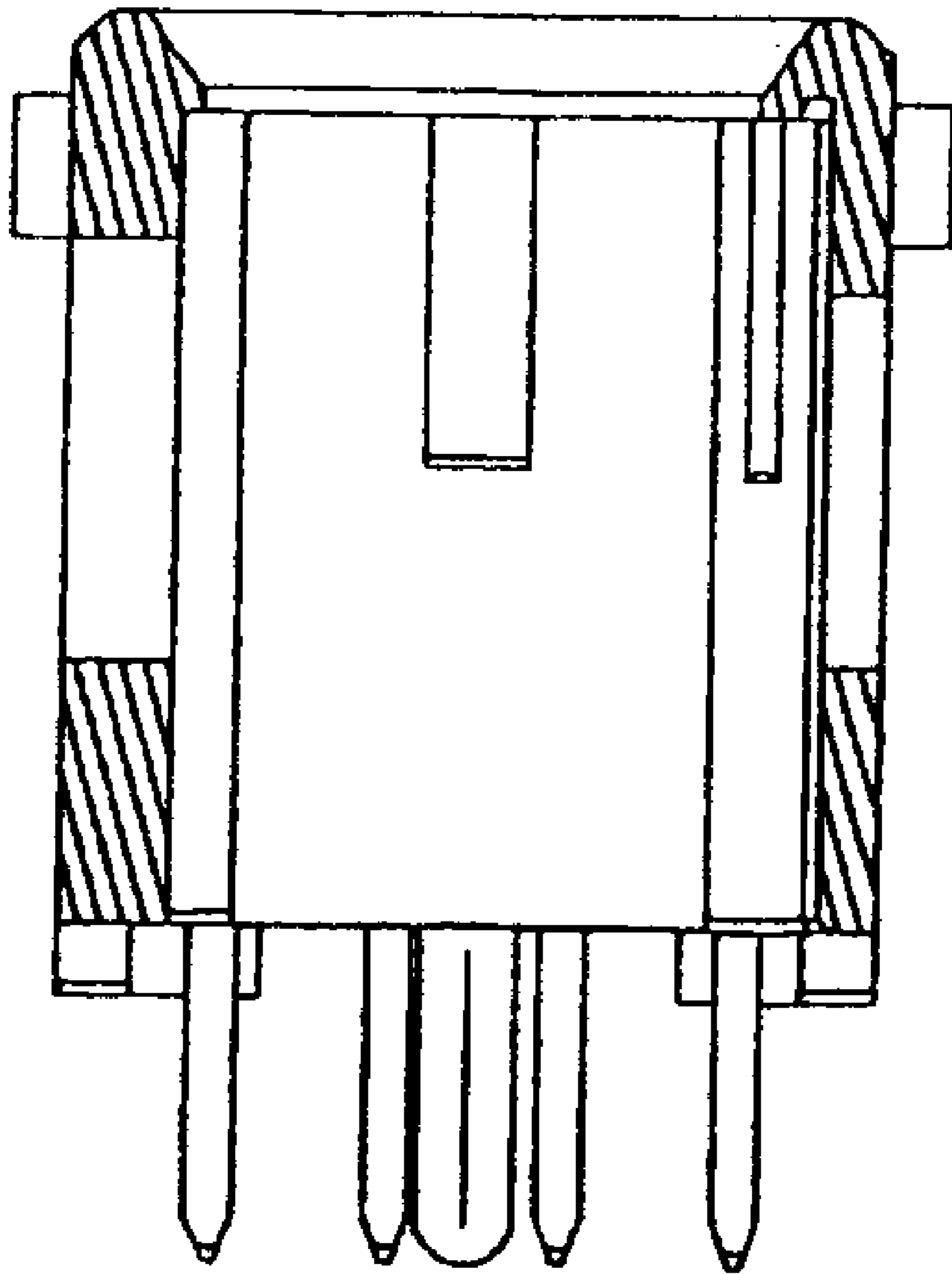

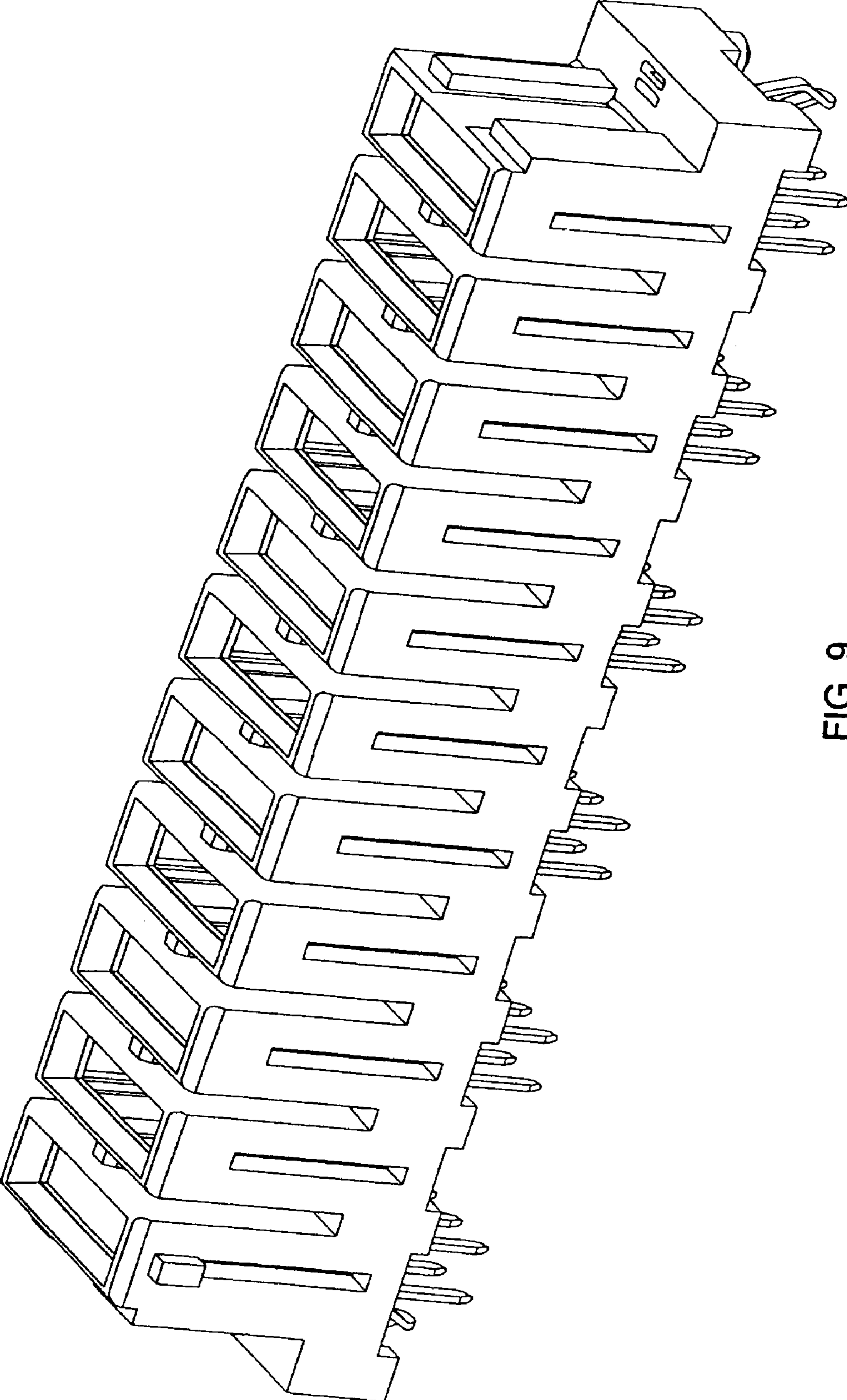
