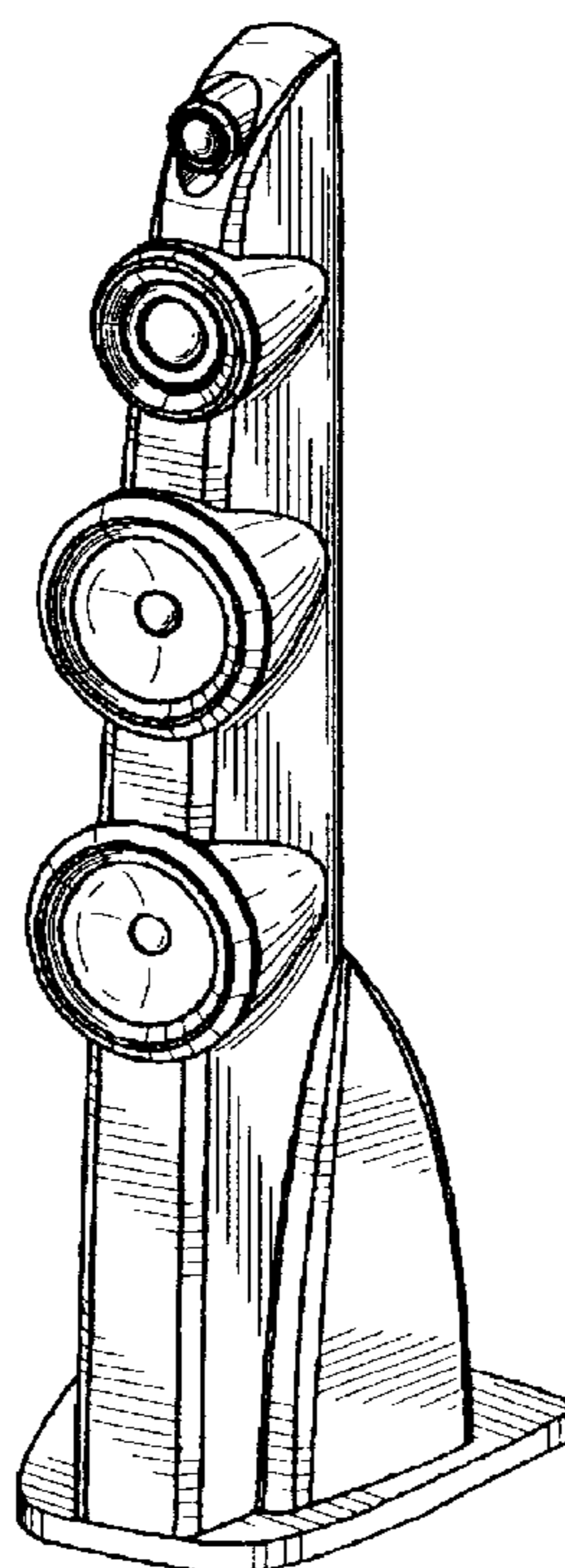
(57) **CLAIM**

FIG. 1 is a top perspective view of a speaker of the present invention;

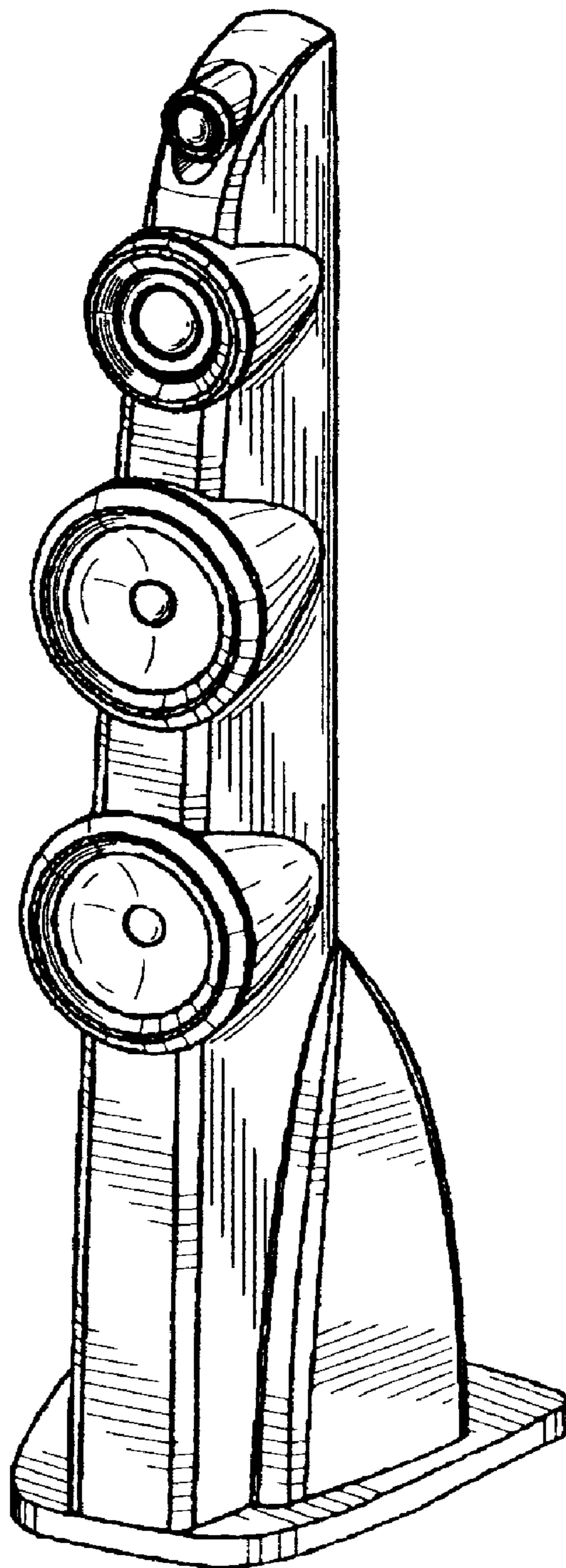

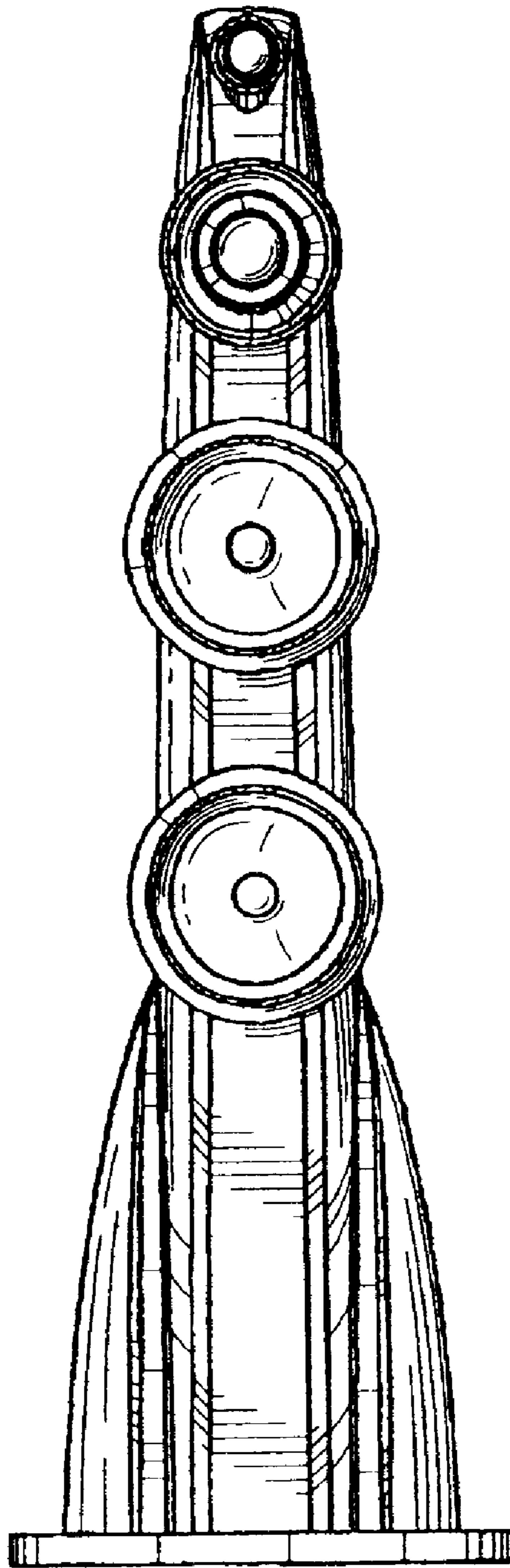

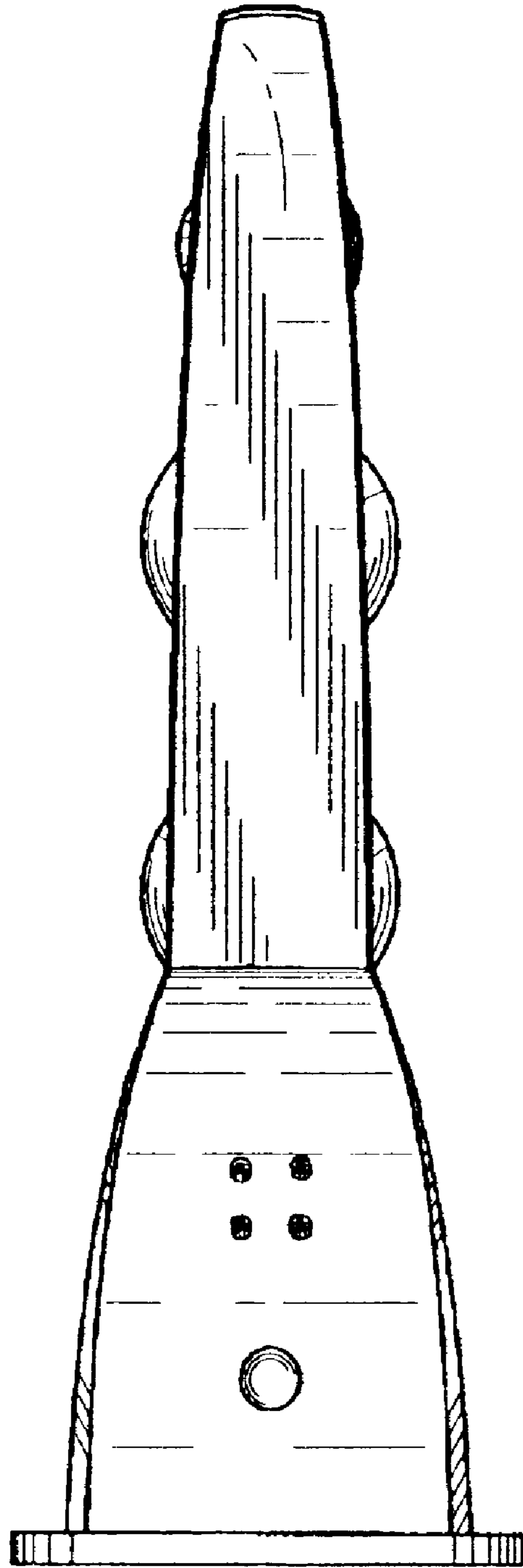

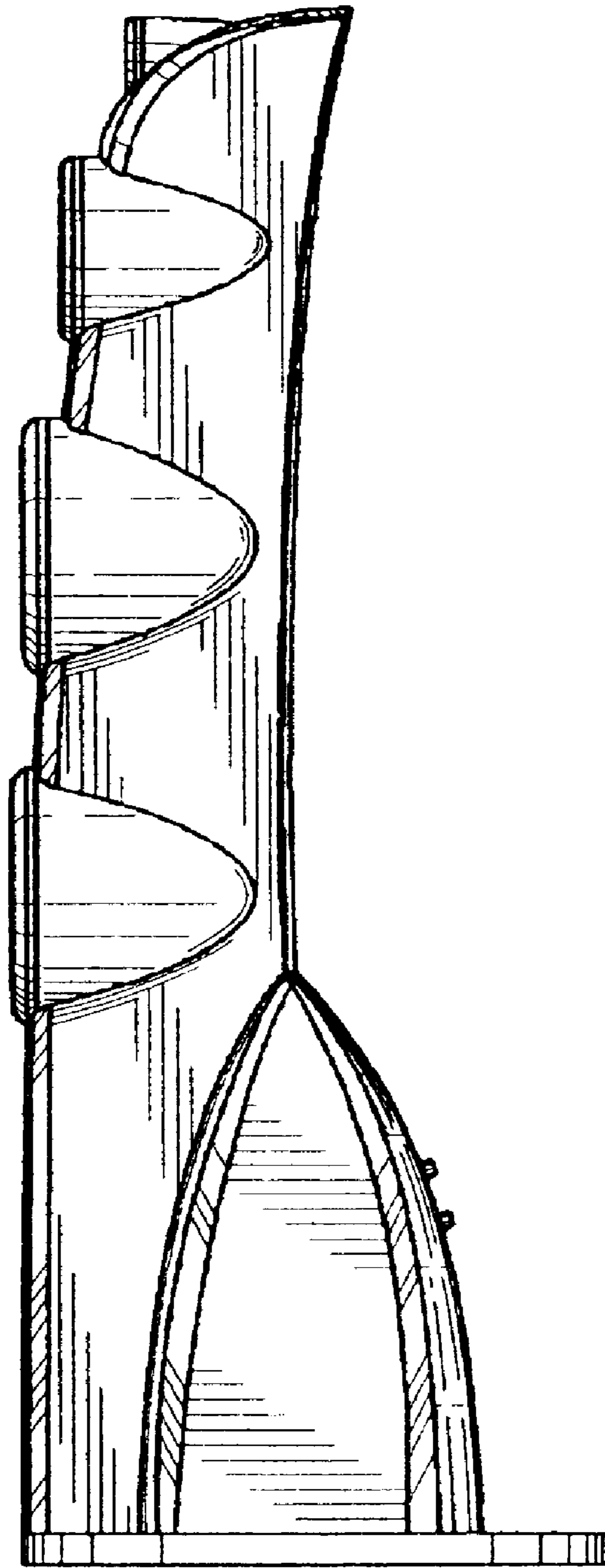

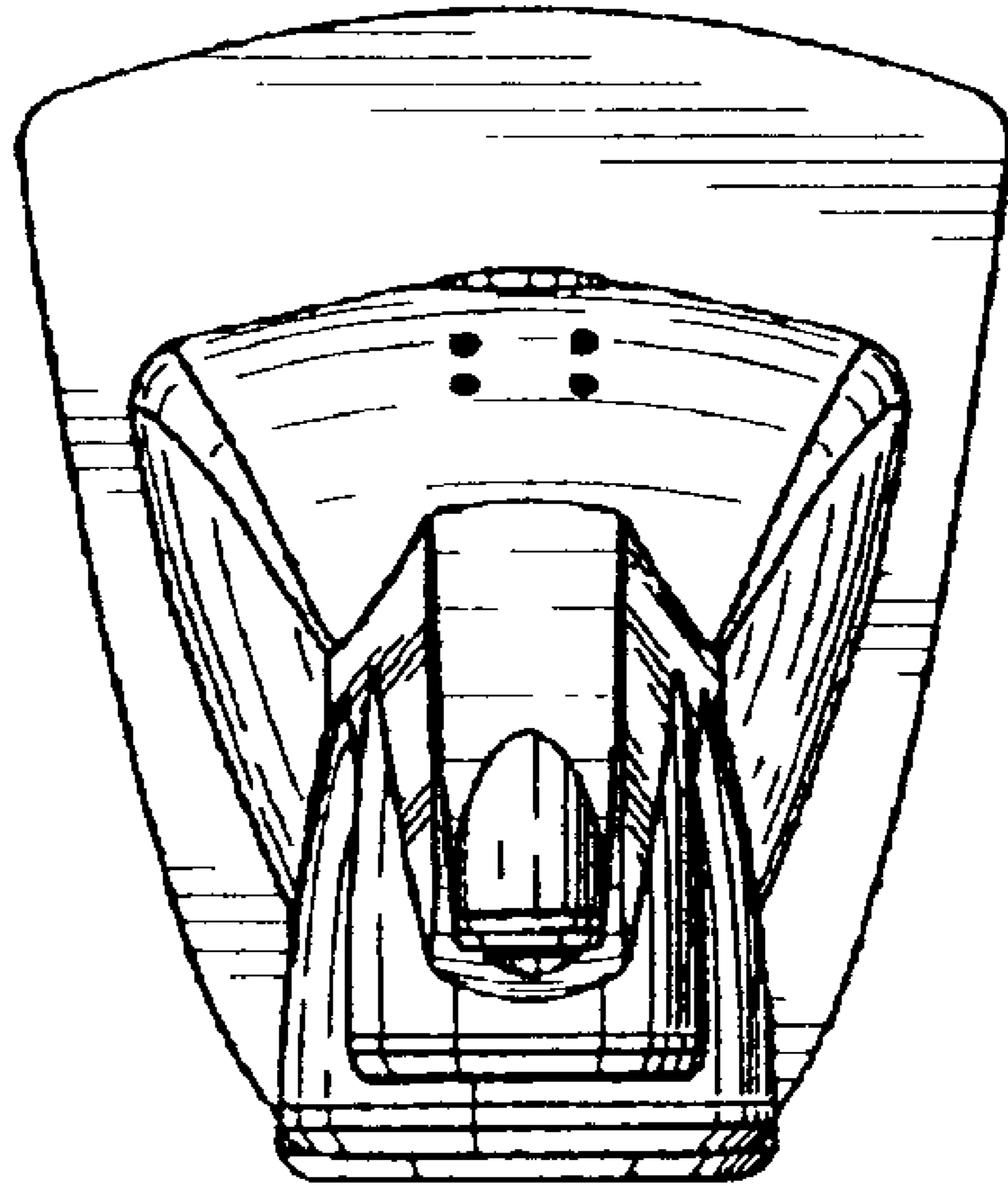

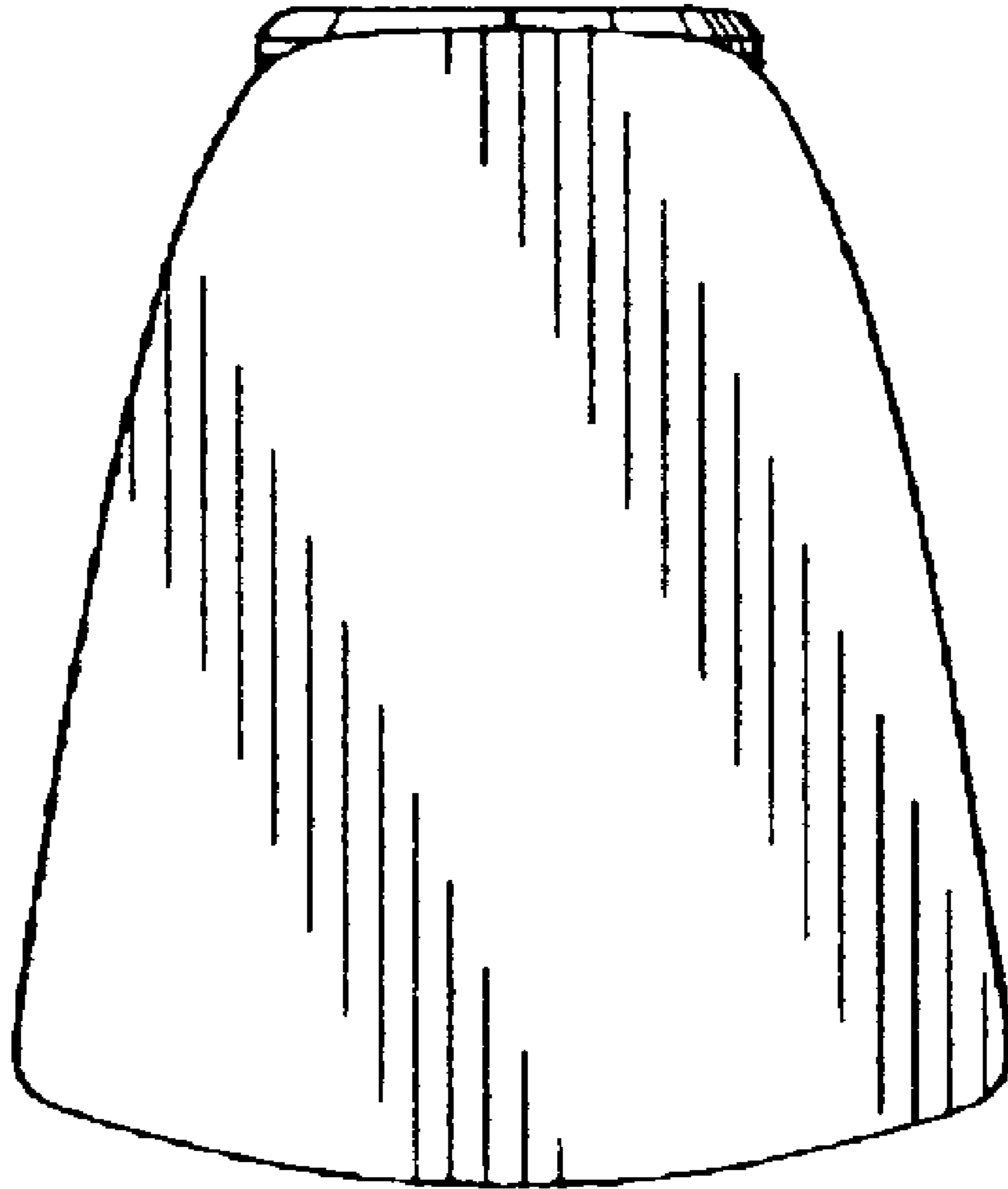
