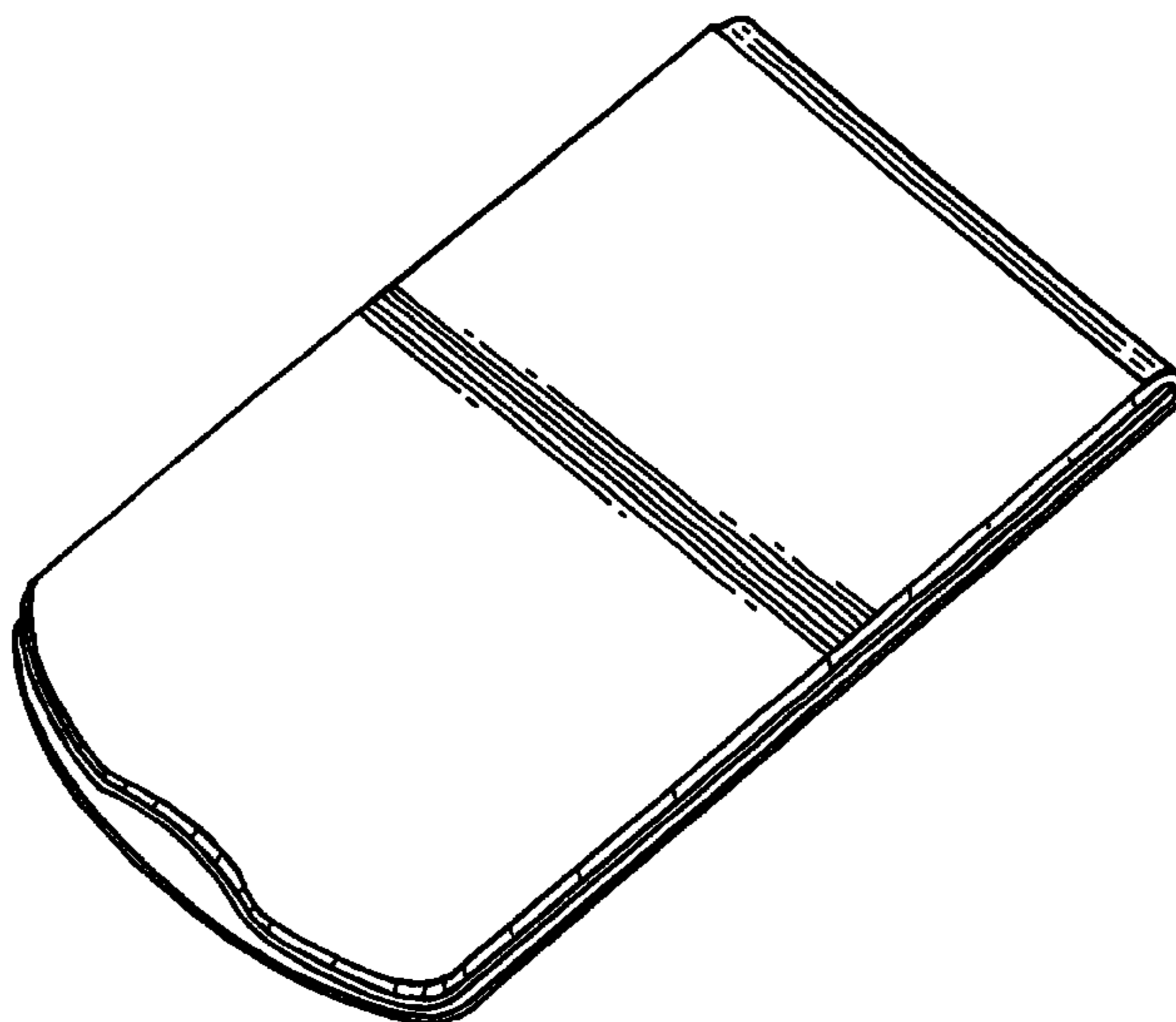
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view from the front of a note jotter cover incorporating the design;

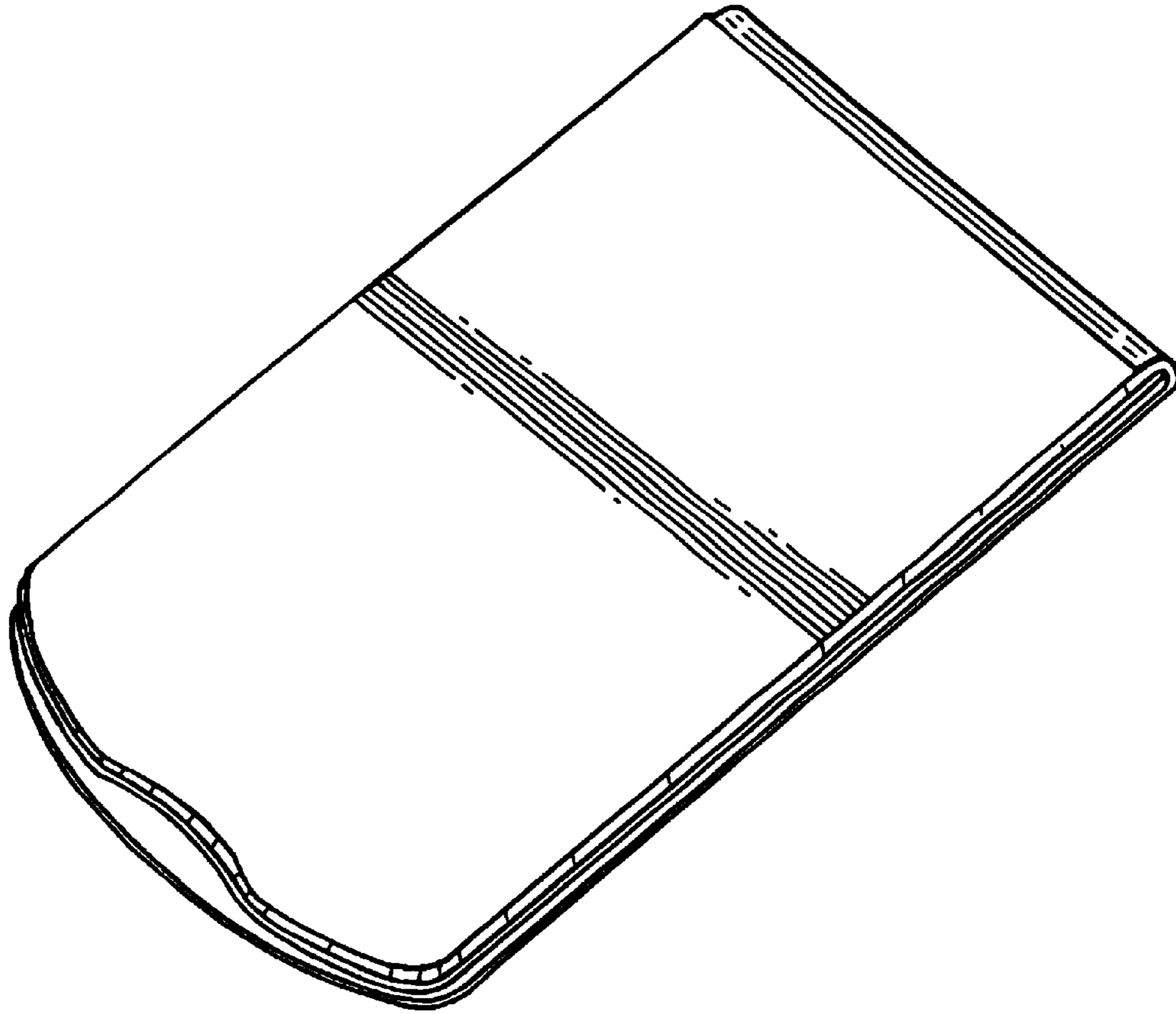

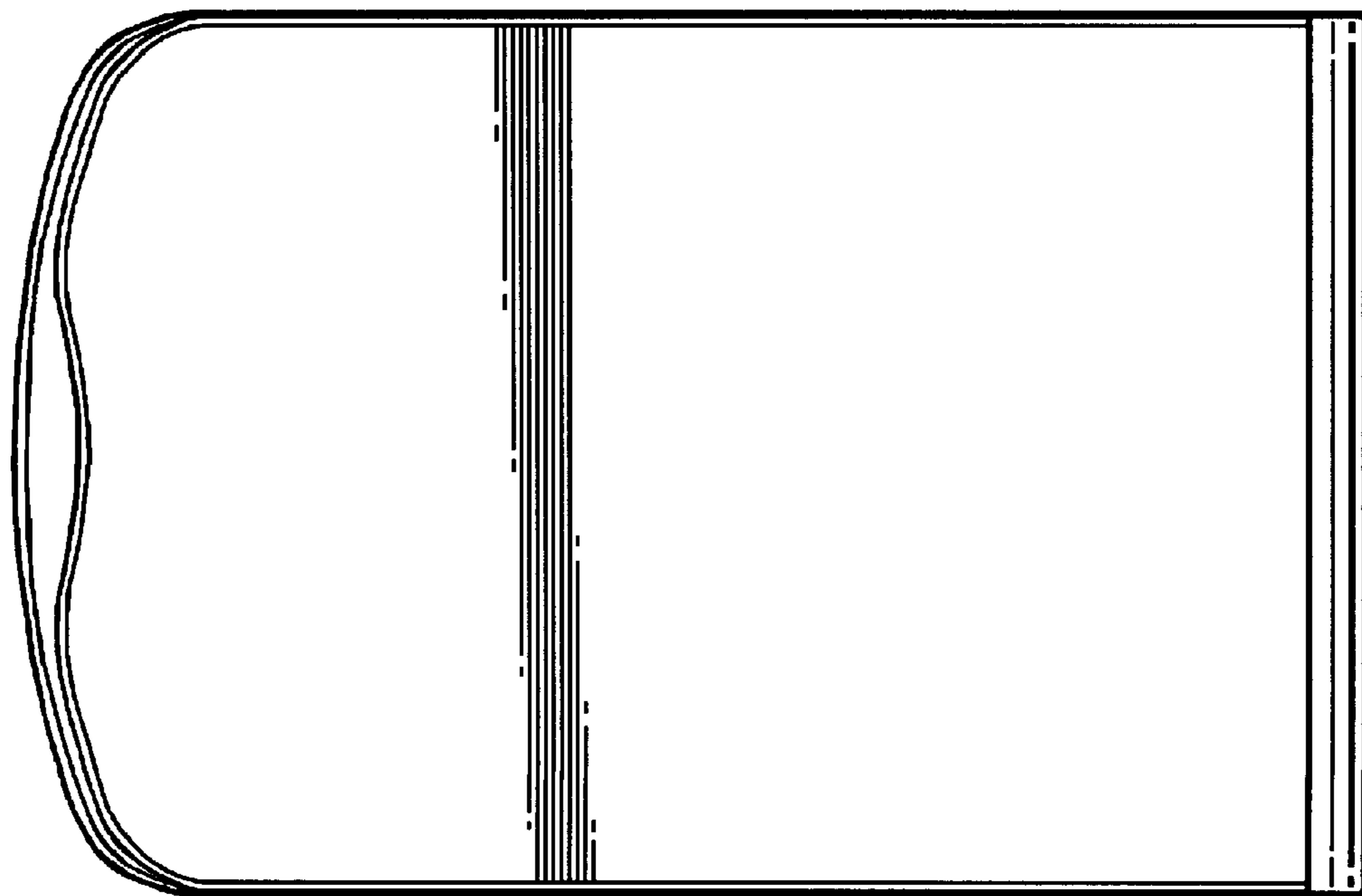

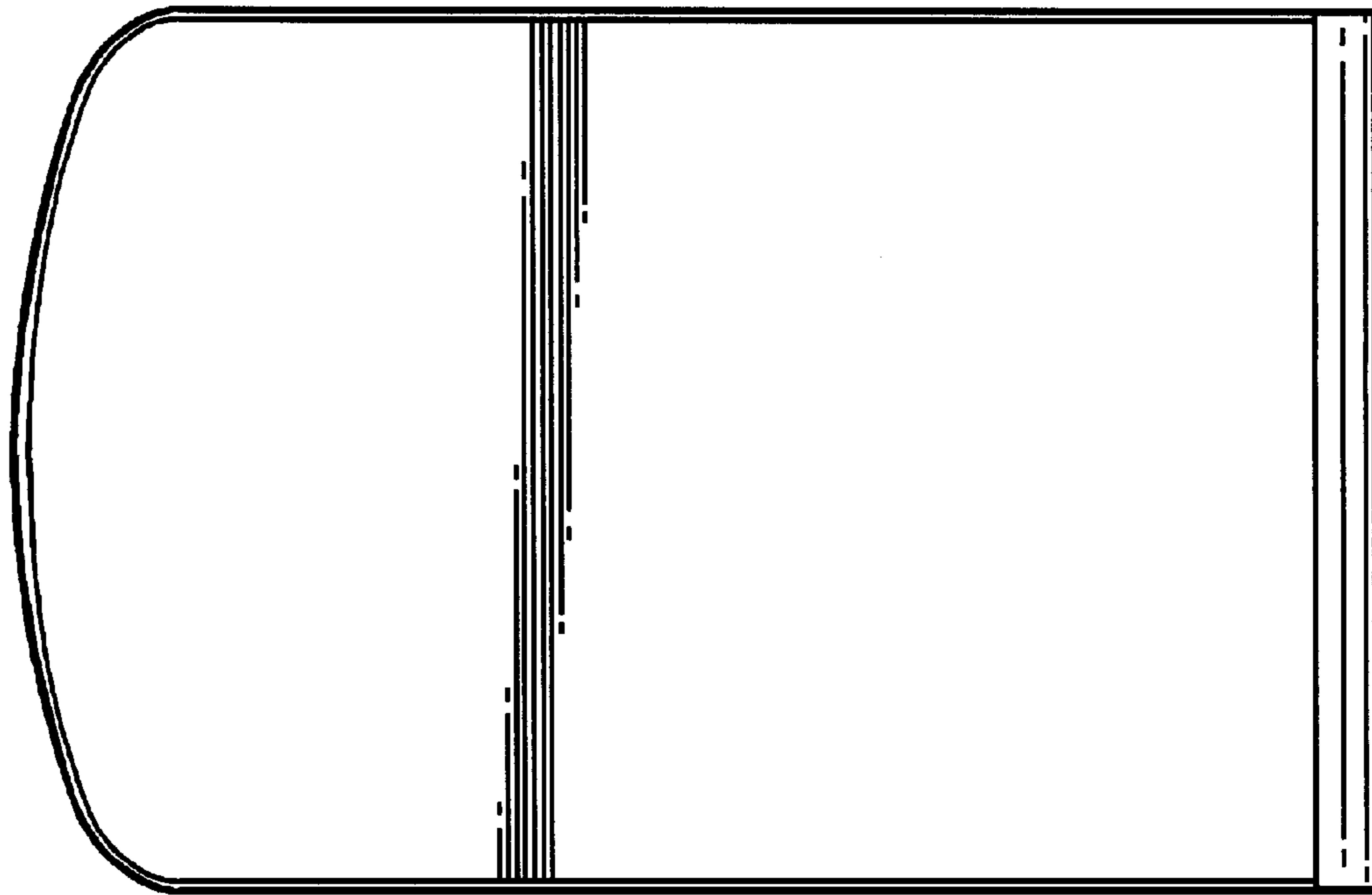

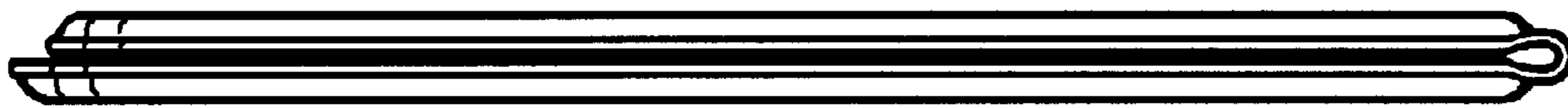
