(57) **CLAIM**

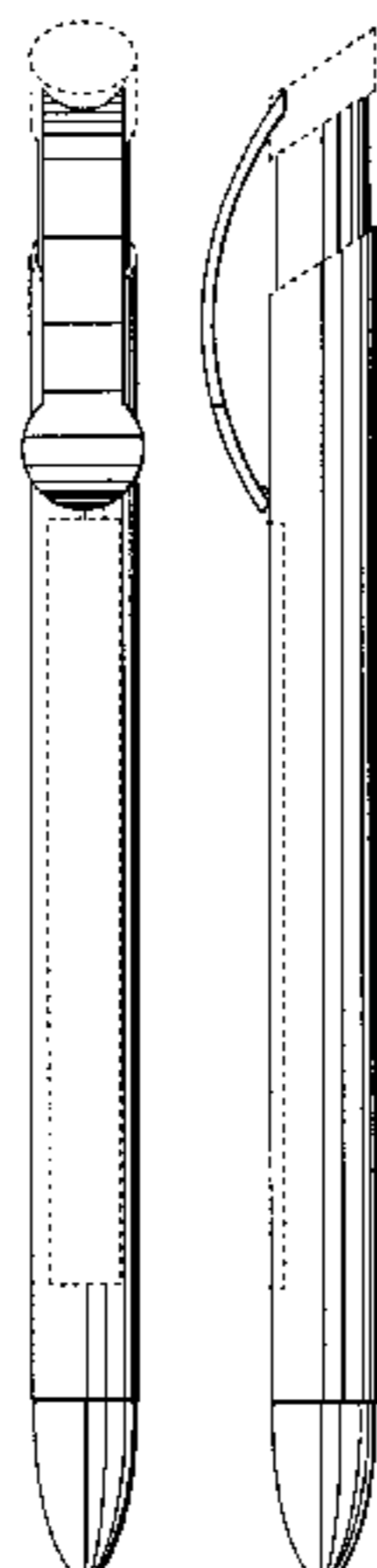
The ornamental design for a pen, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a pen showing my new design;
 FIG. 2 is a back view thereof;
 FIG. 3 is a right side view thereof, the left side being a mirror image;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front view of a second embodiment thereof;
 FIG. 7 is a back view thereof;
 FIG. 8 is a right side view thereof, the left side being a mirror image;
 FIG. 9 is a top view thereof; and,
 FIG. 10 is a bottom view thereof.

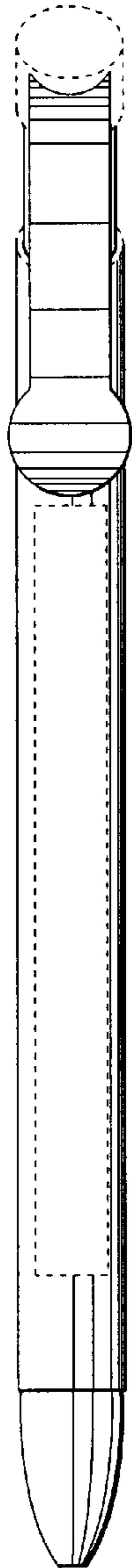

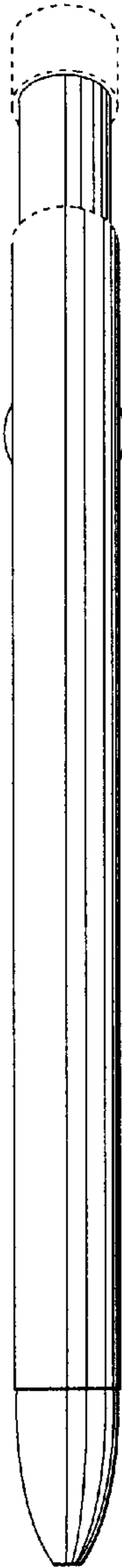

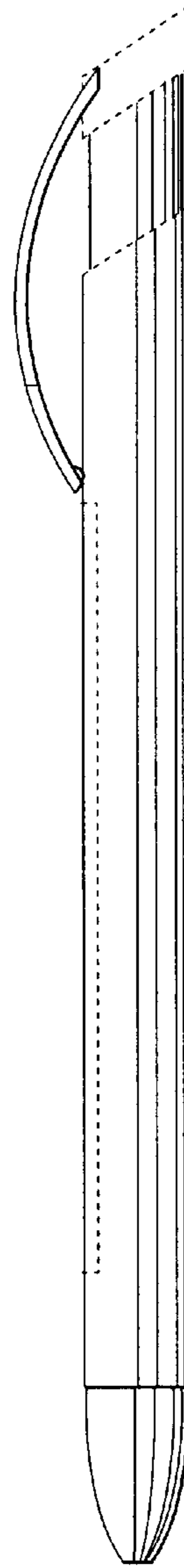

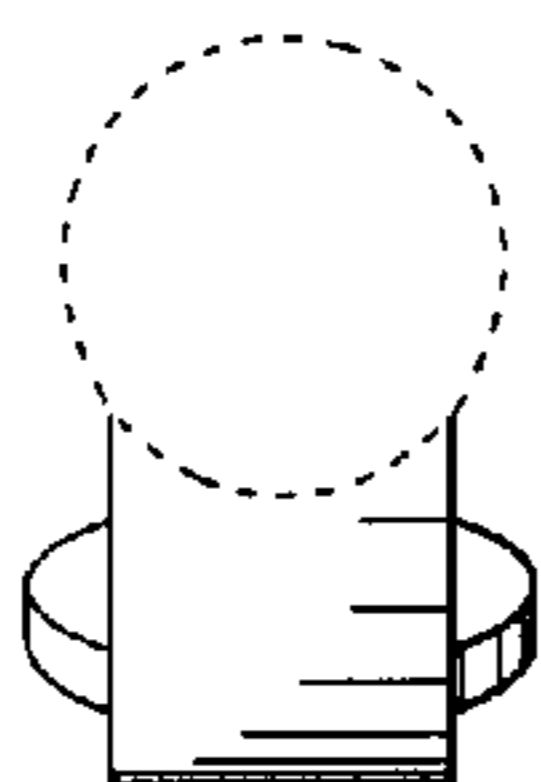

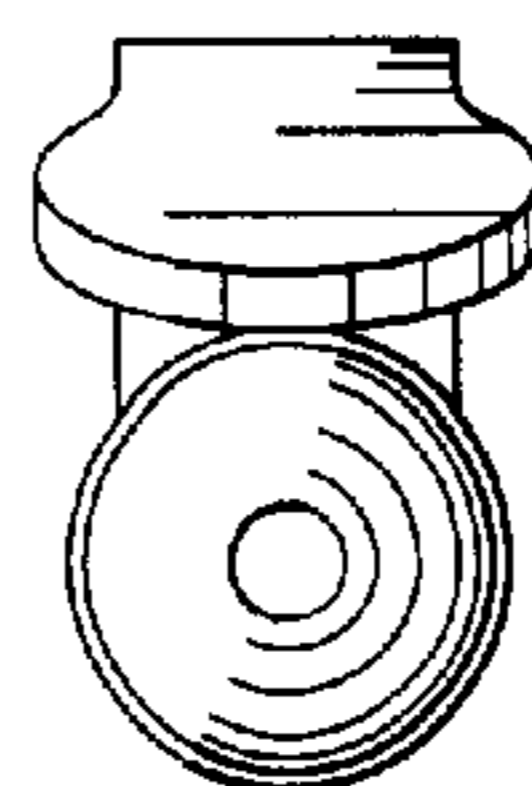

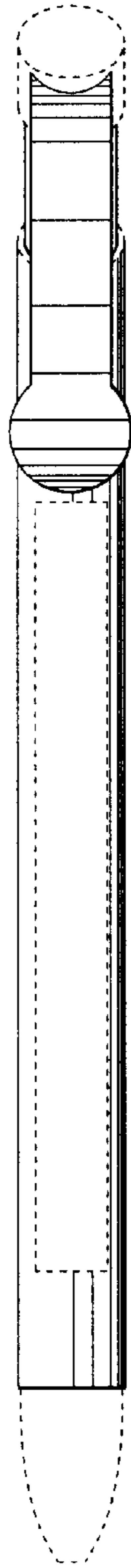

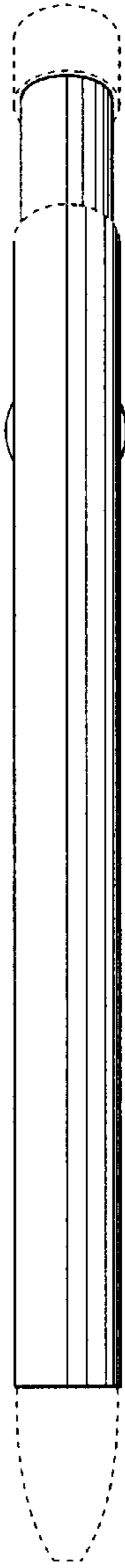

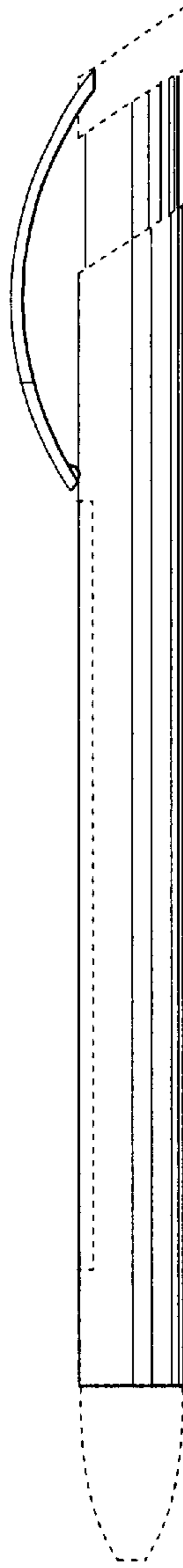

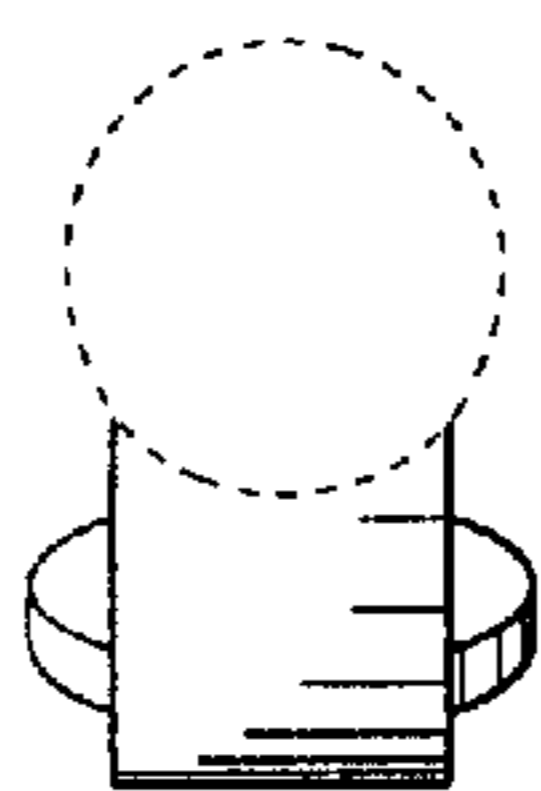
