(57) **CLAIM**

We claim the ornamental design for a folio filer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a folio filer according to the invention;

FIG. 2 is a front view of the folio filer of FIG. 1;

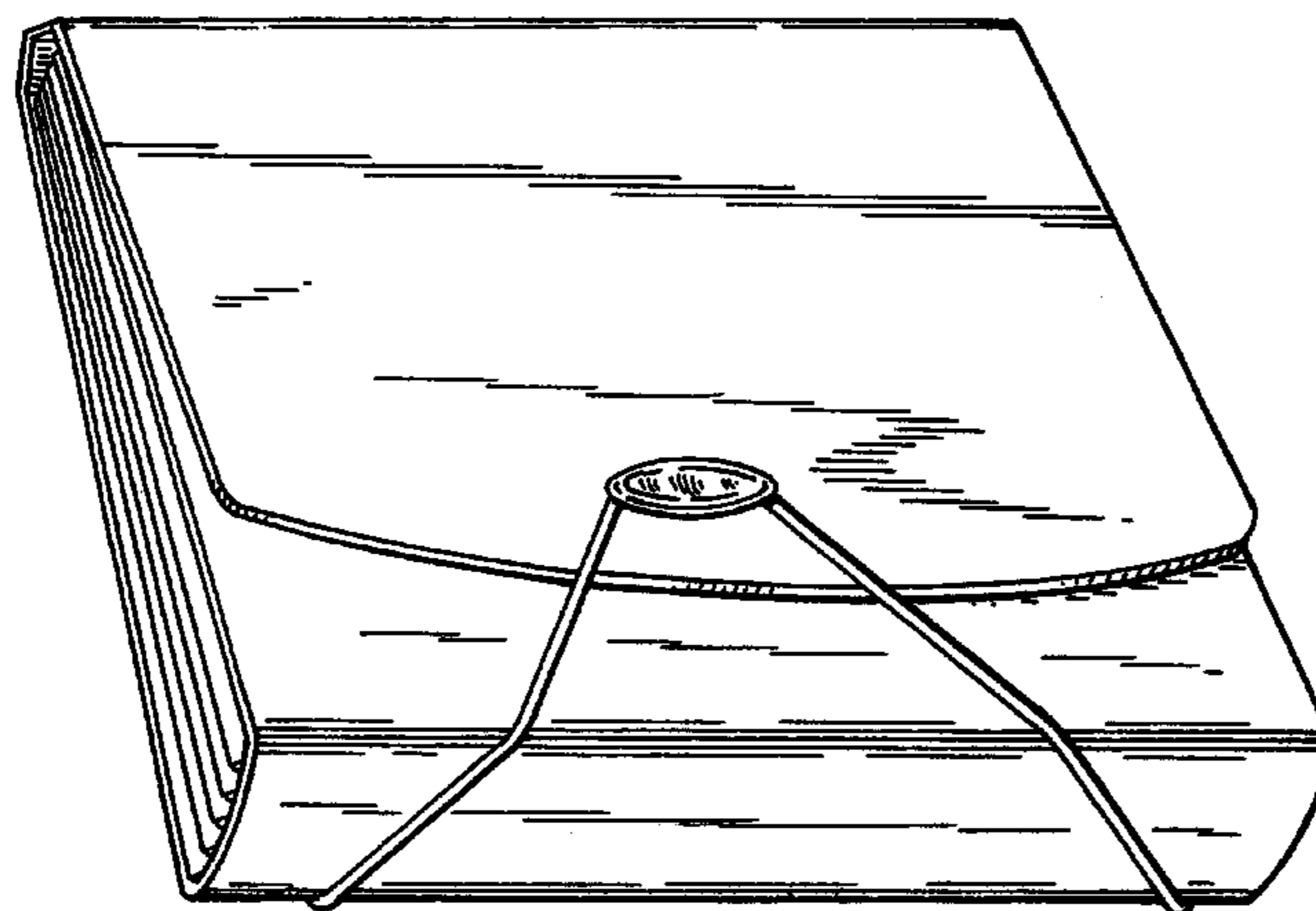
FIG. 3 is a bottom view of the folio filer of FIG. 1;

FIG. 4 is a top view of the folio filer of FIG. 1;

FIG. 5 is a side view of the folio filer of FIG. 1, the opposite side view being a substantial mirror image; and,

FIG. 6 is a rear view of the folio filer of FIG. 1.

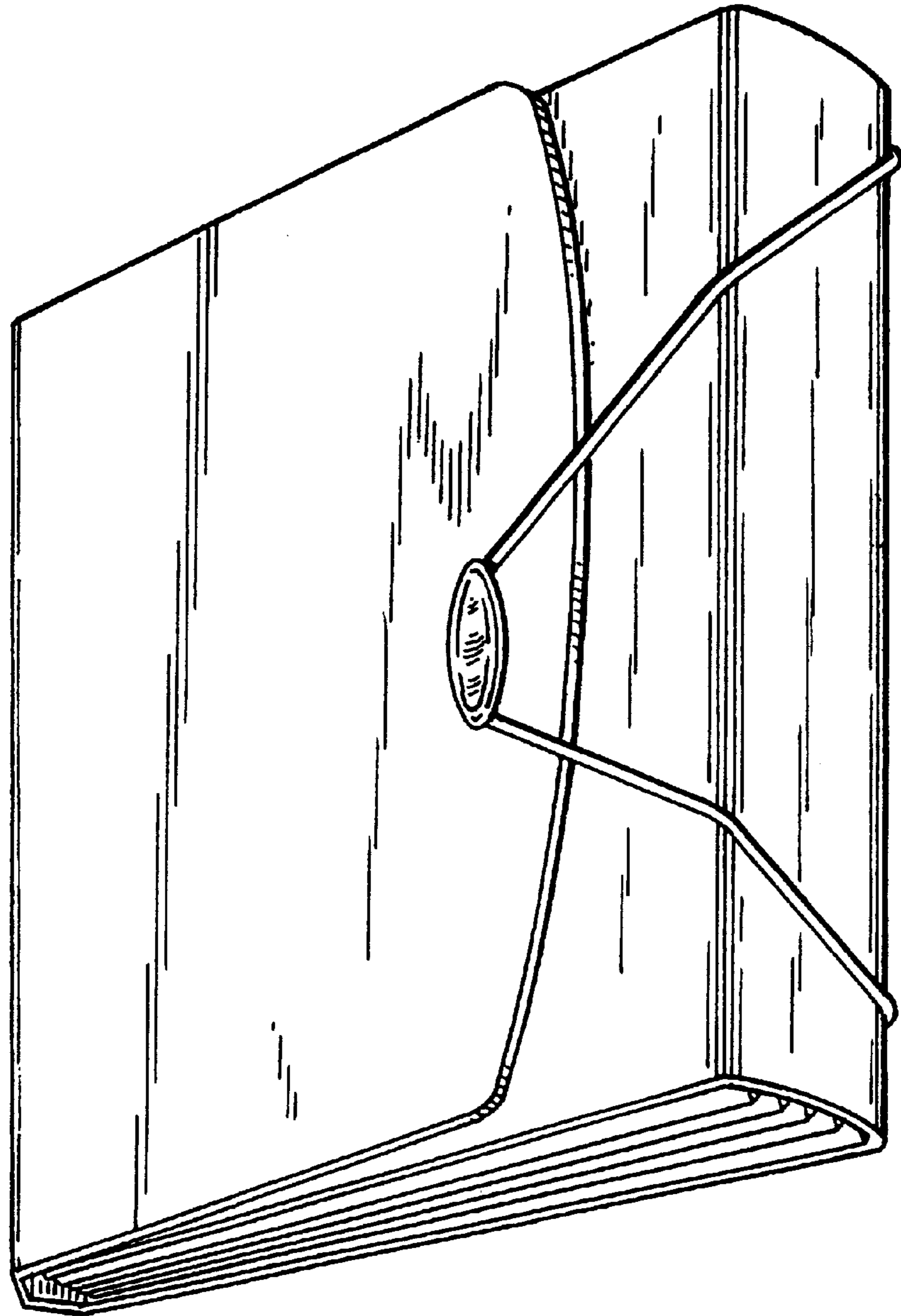

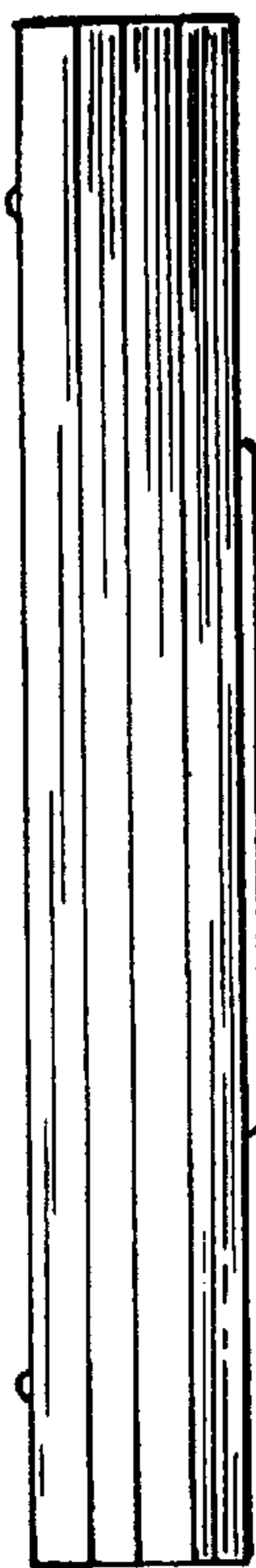

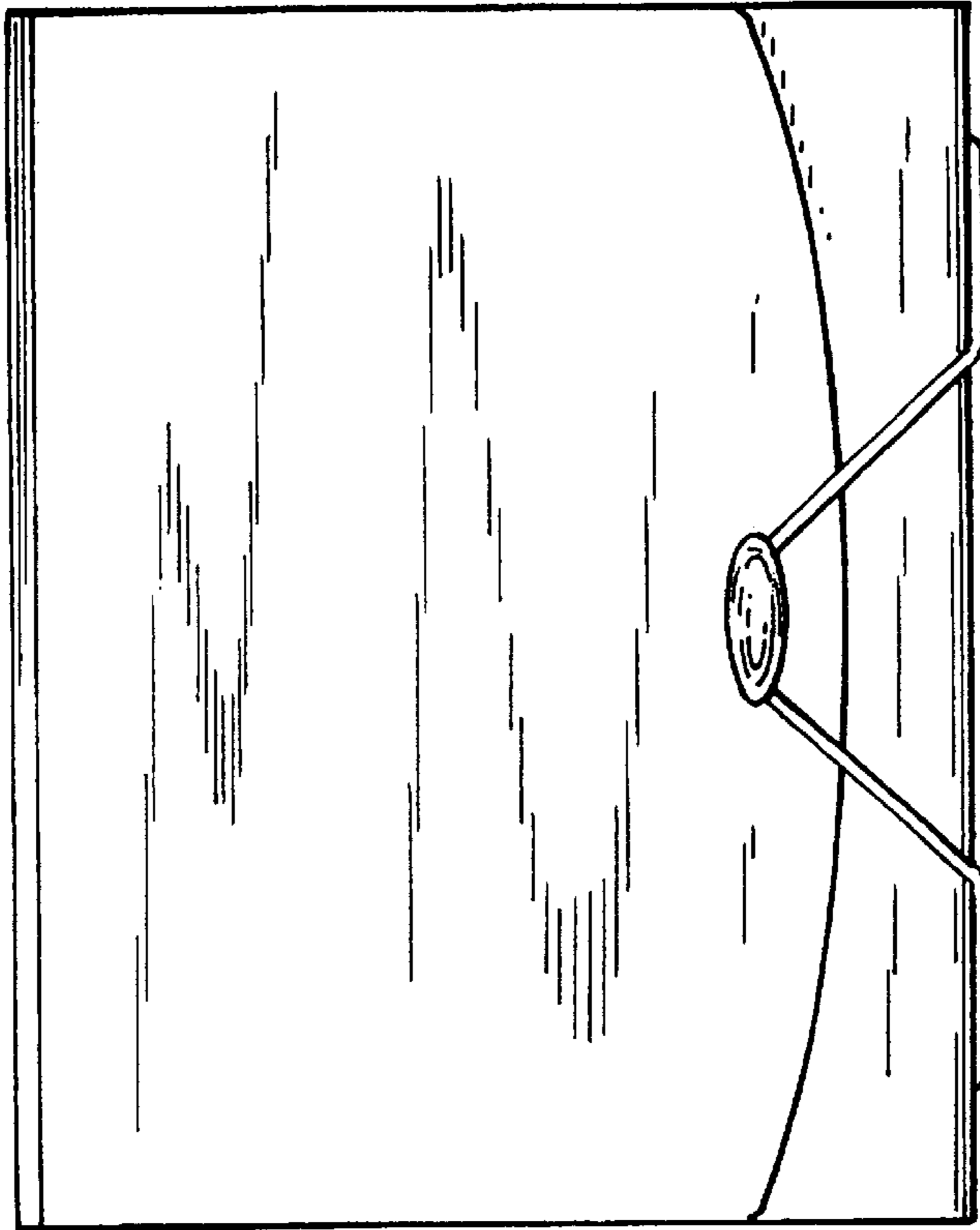

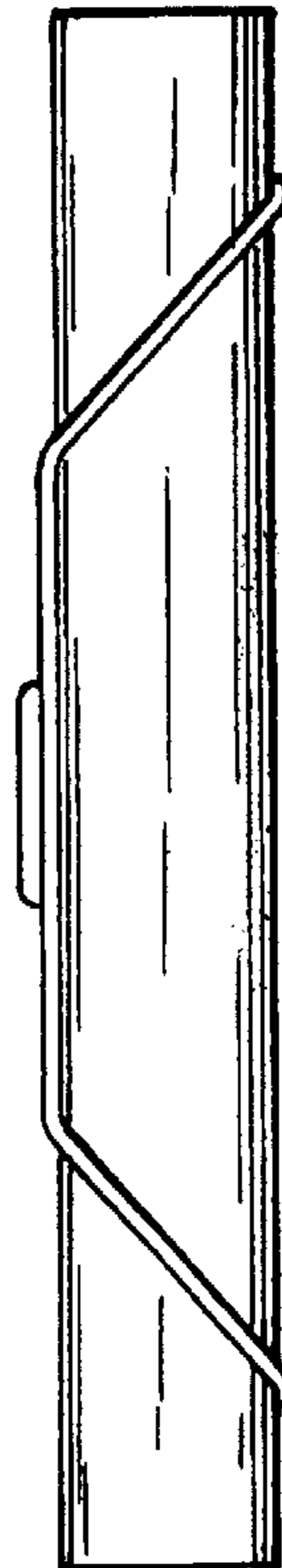

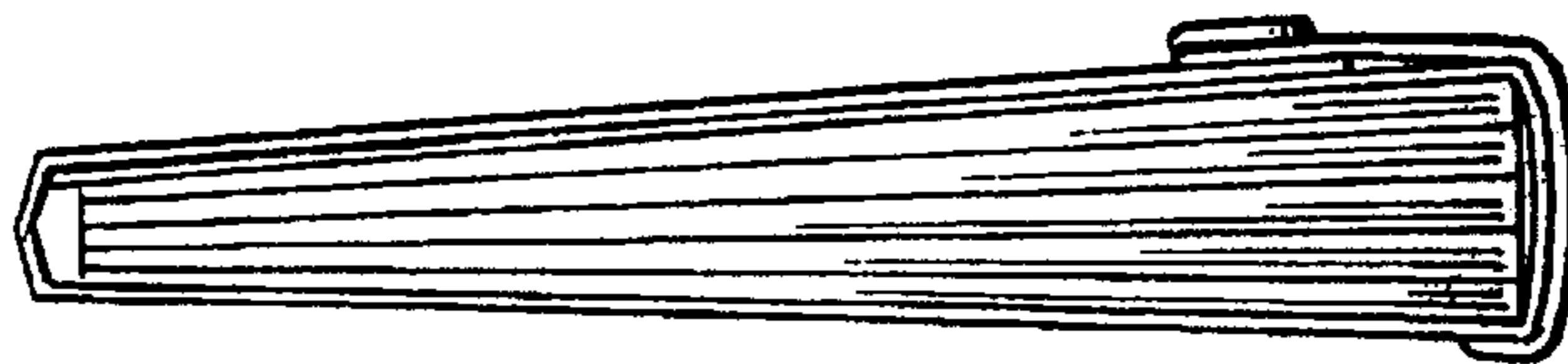

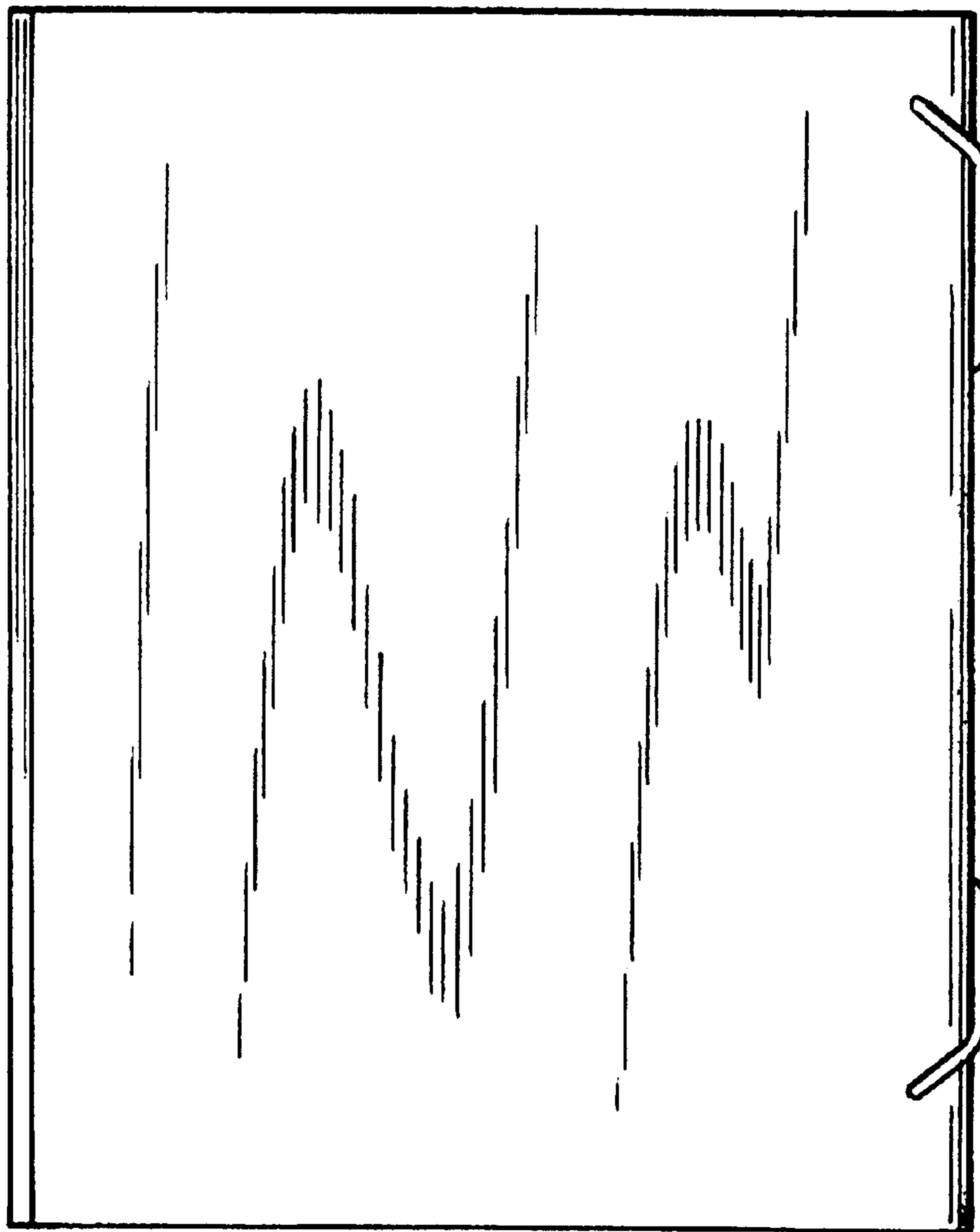
