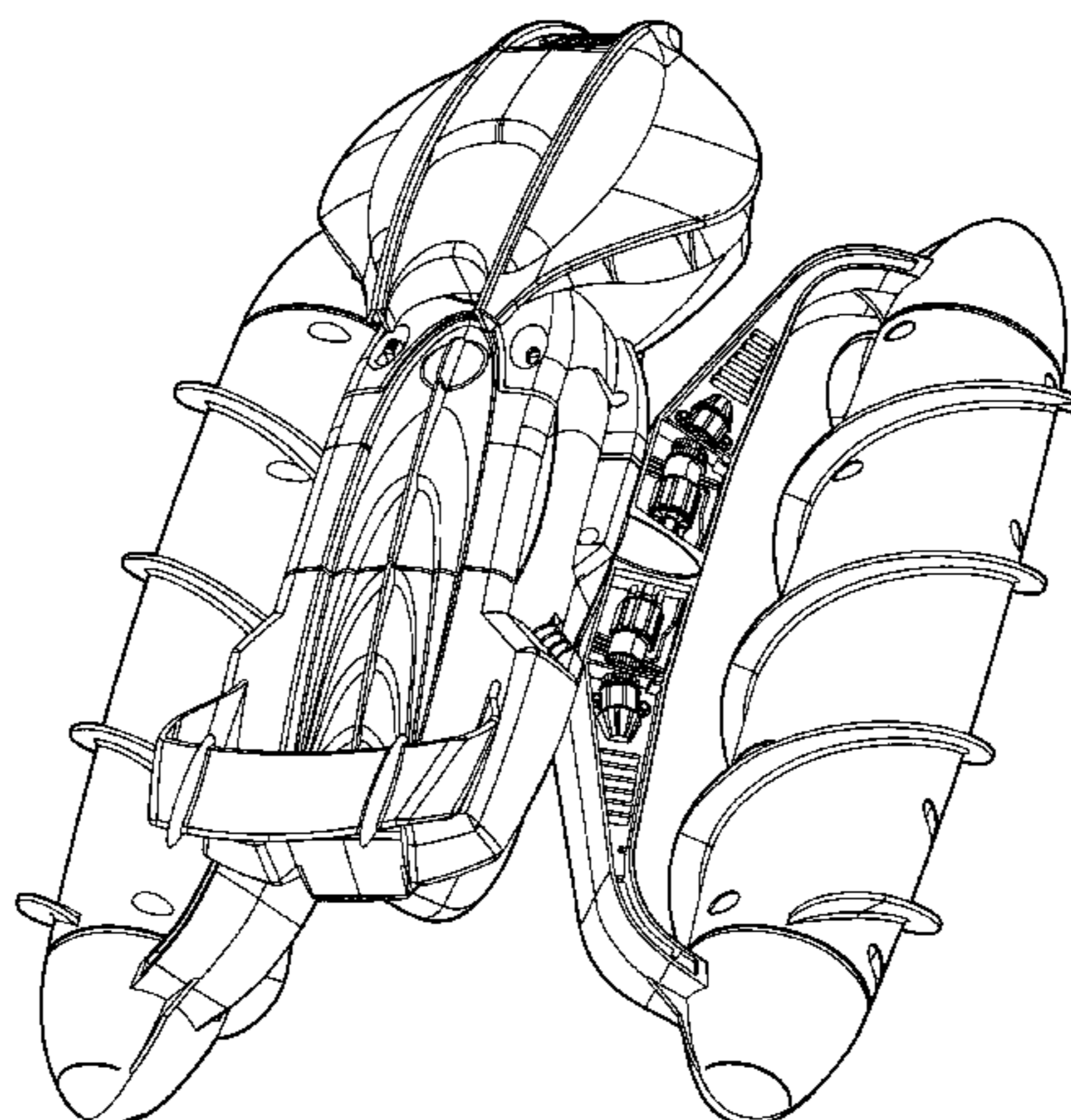
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top/right/rear perspective view of a screw drive toy vehicle in accordance with my new design;

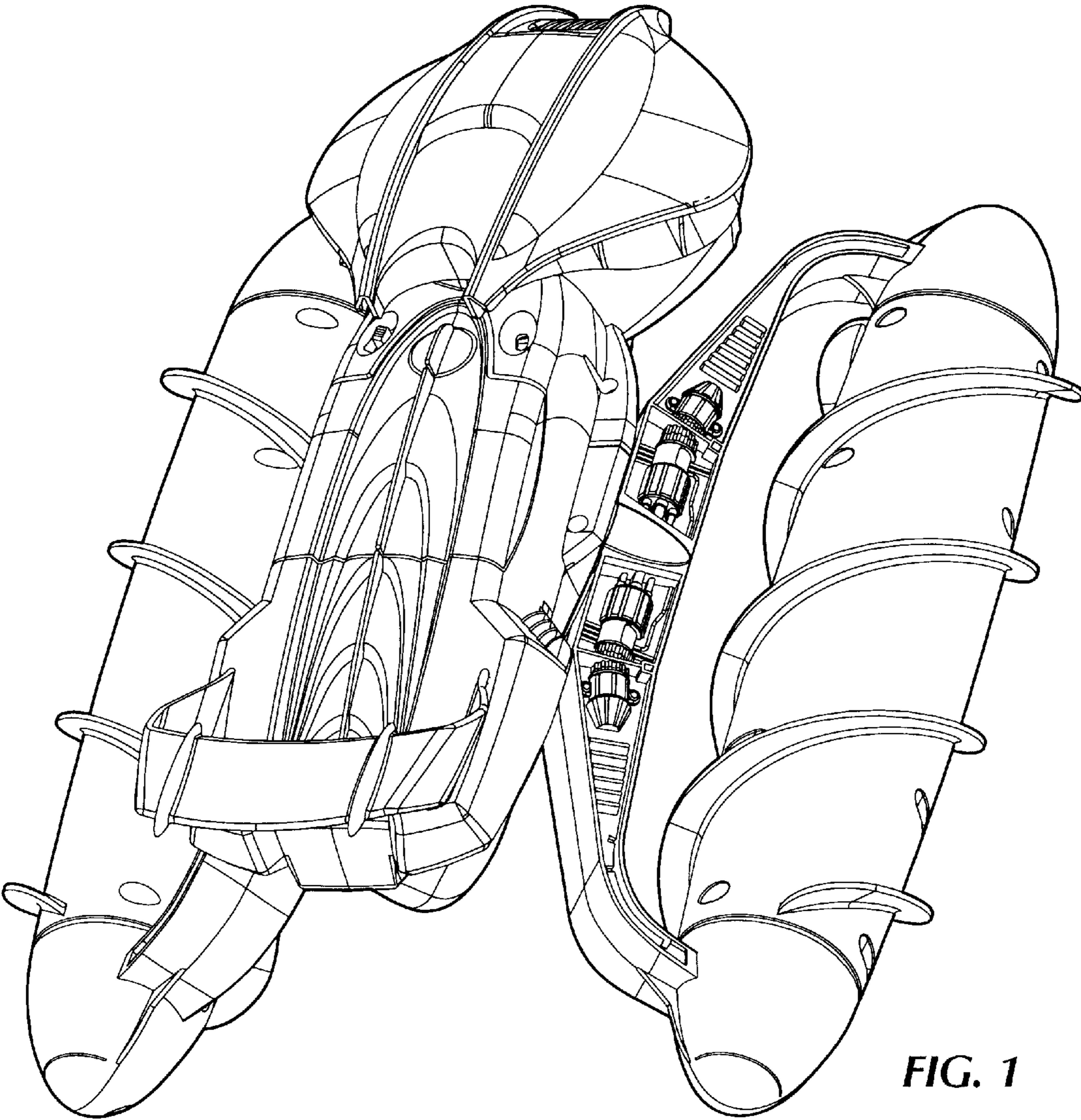
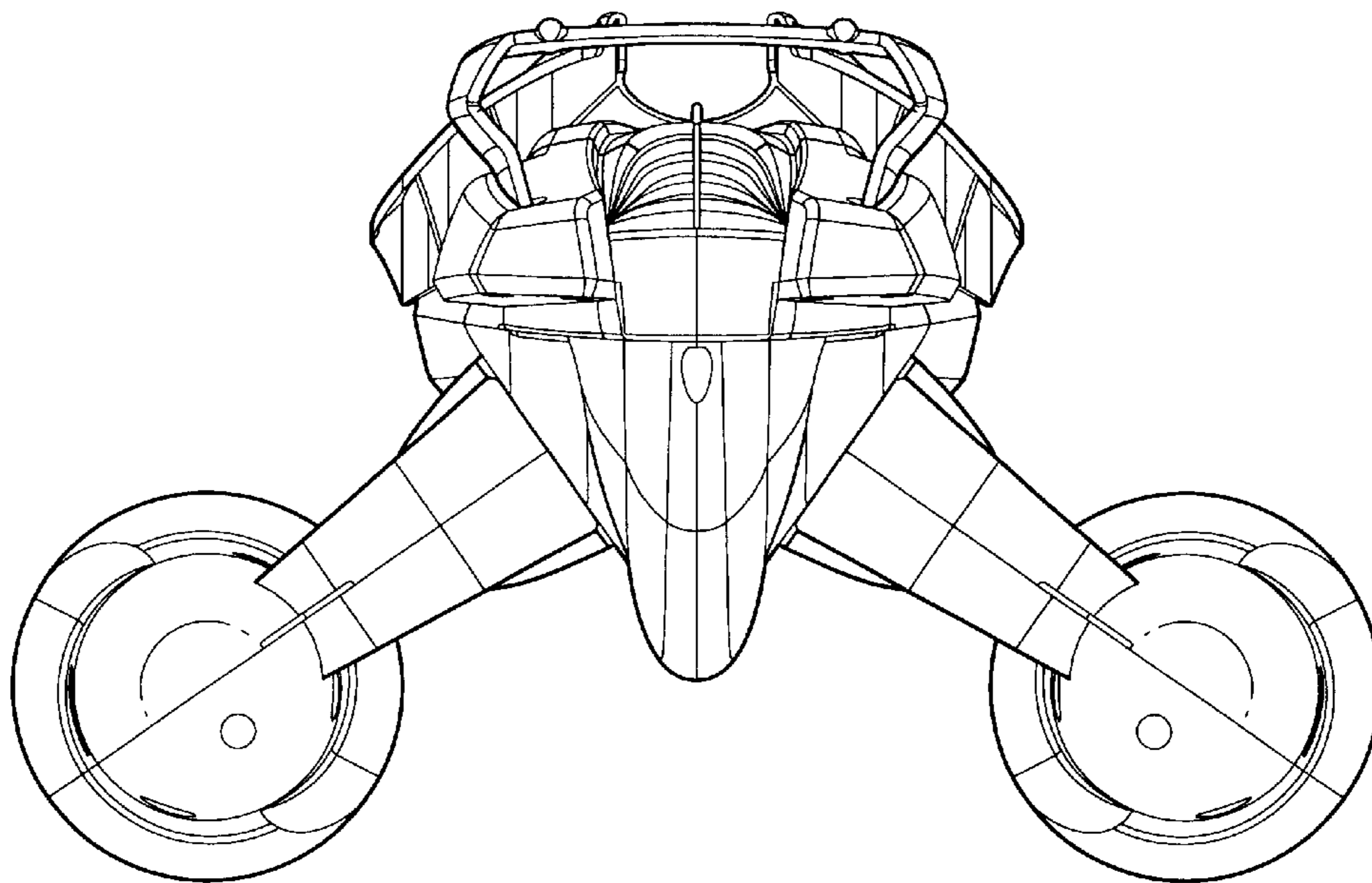
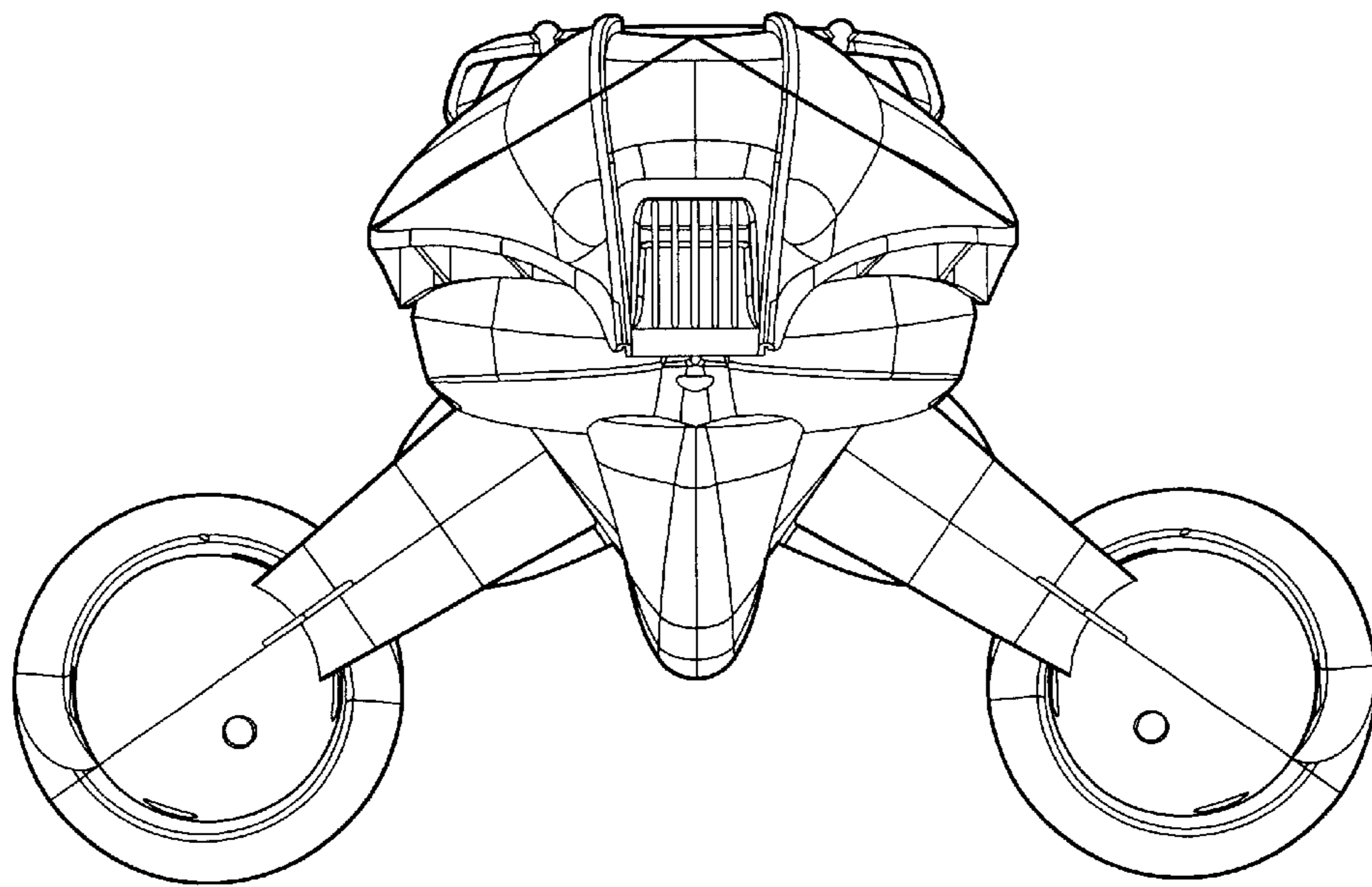

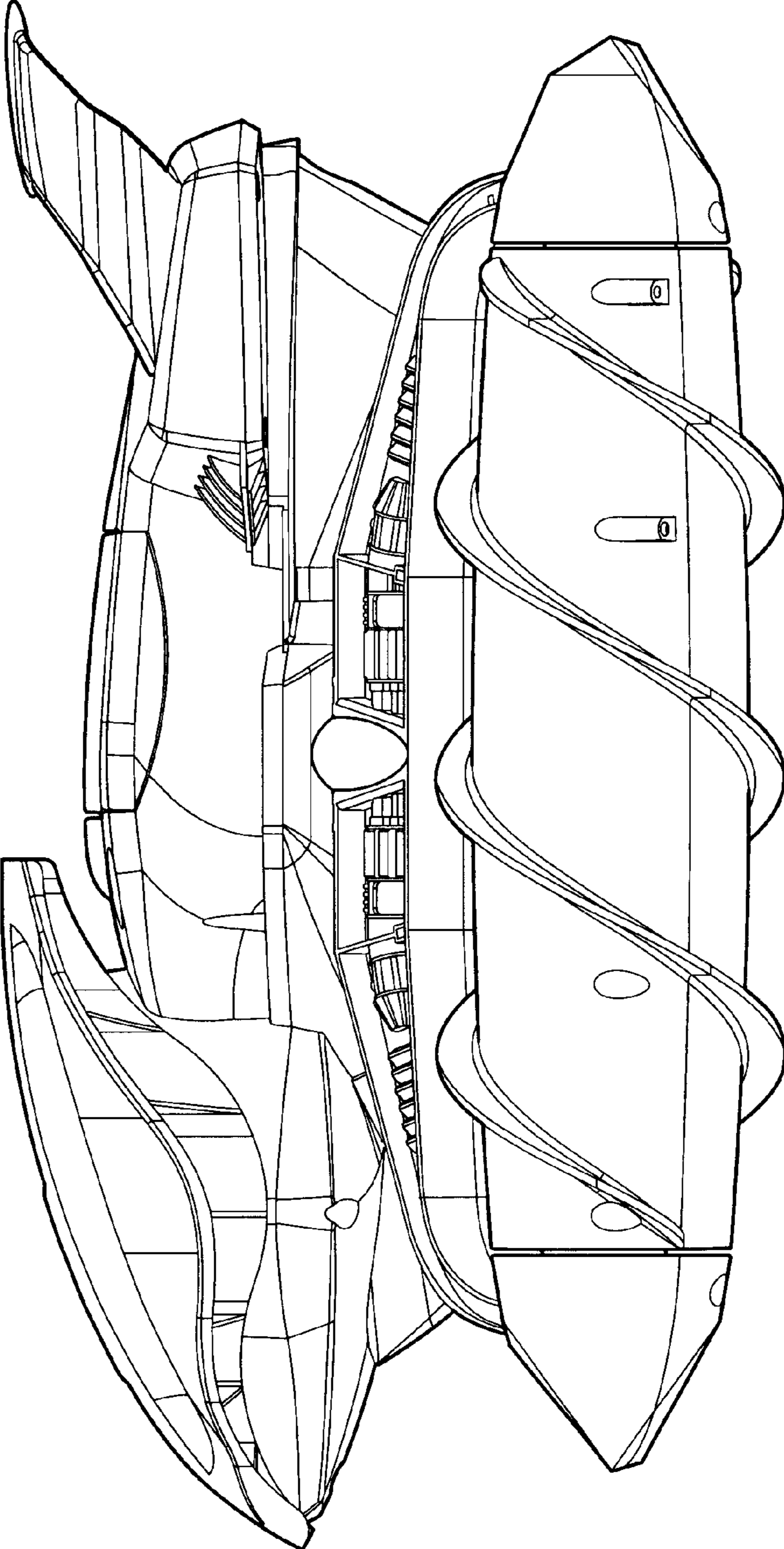

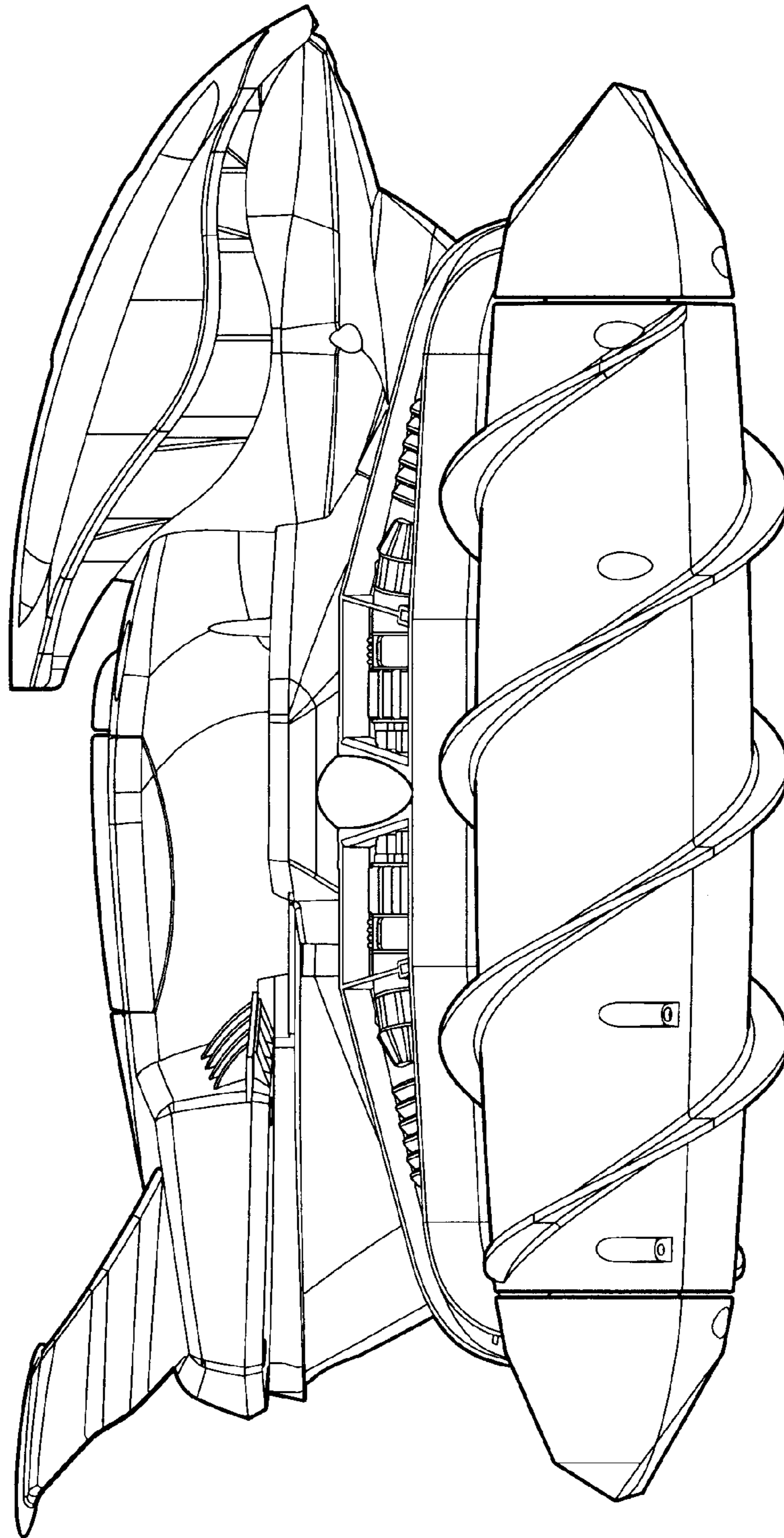

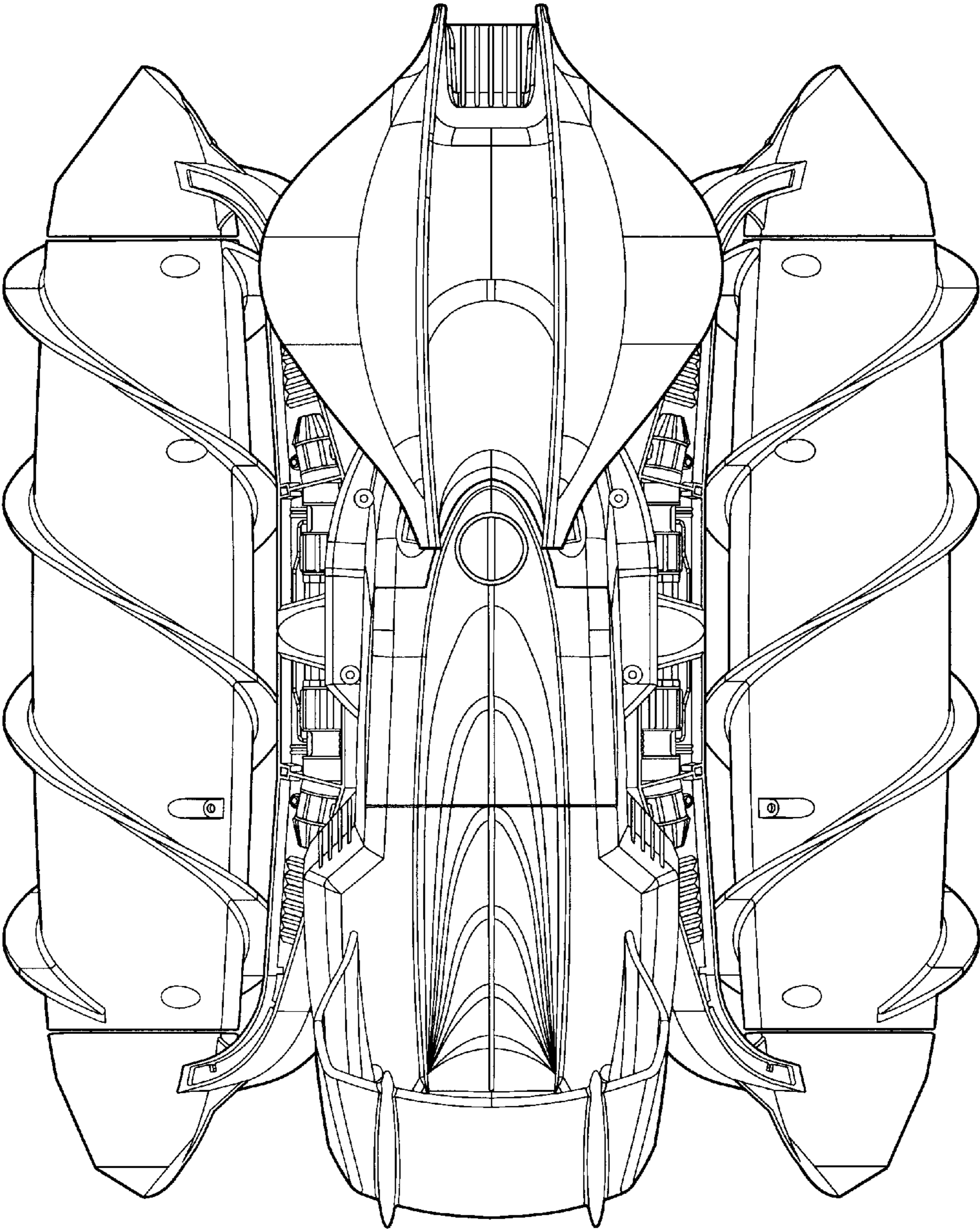

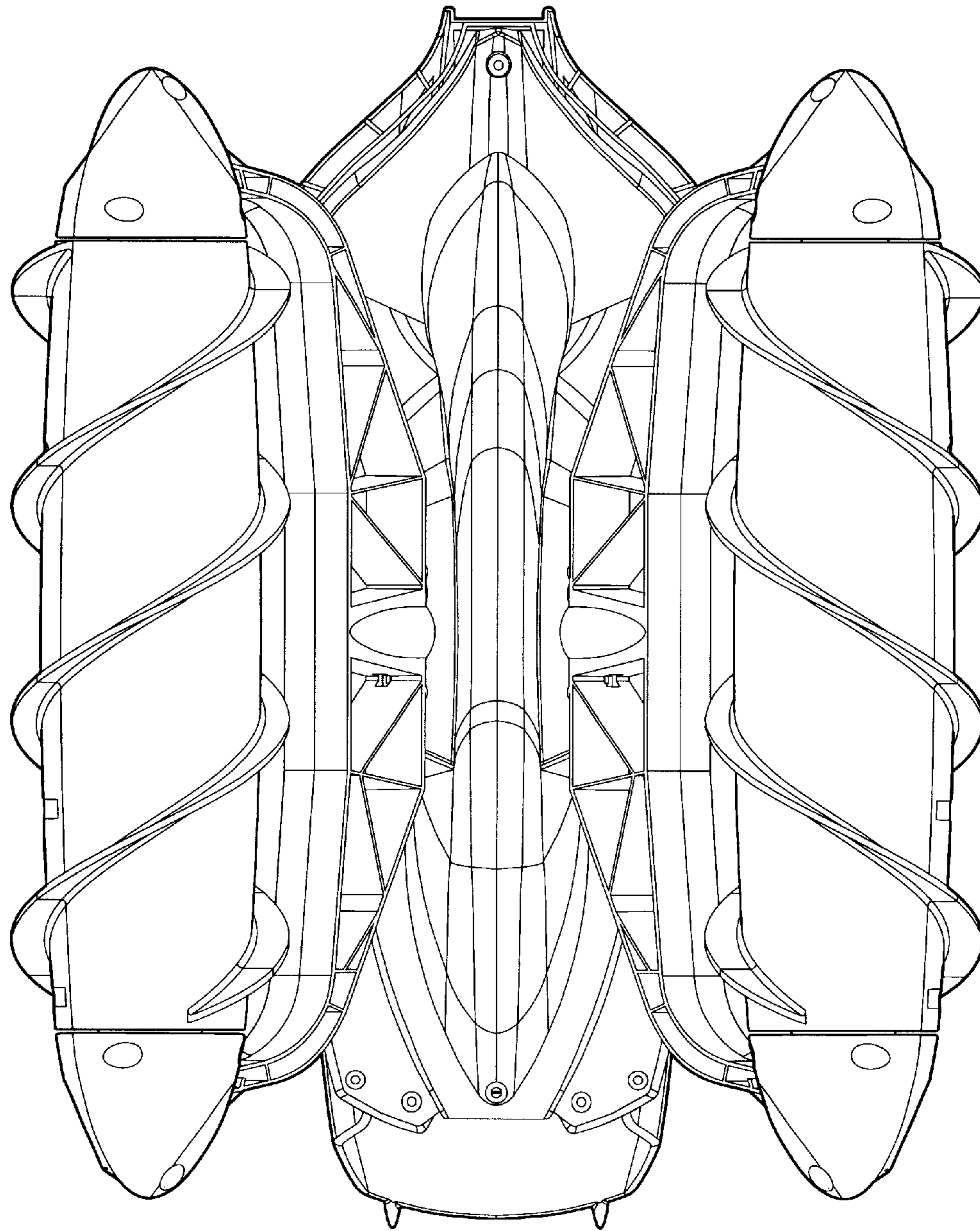
