described.

DESCRIPTION

FIG. 1 is front elevational view of an inhaler showing our
new design;

FIG. 9 is a front elevational view of a second embodiment
of an inhaler showing our new design;

FIG. 13 is a side elevational view thereof;

FIG. 14 is a side elevational view thereof, opposite that

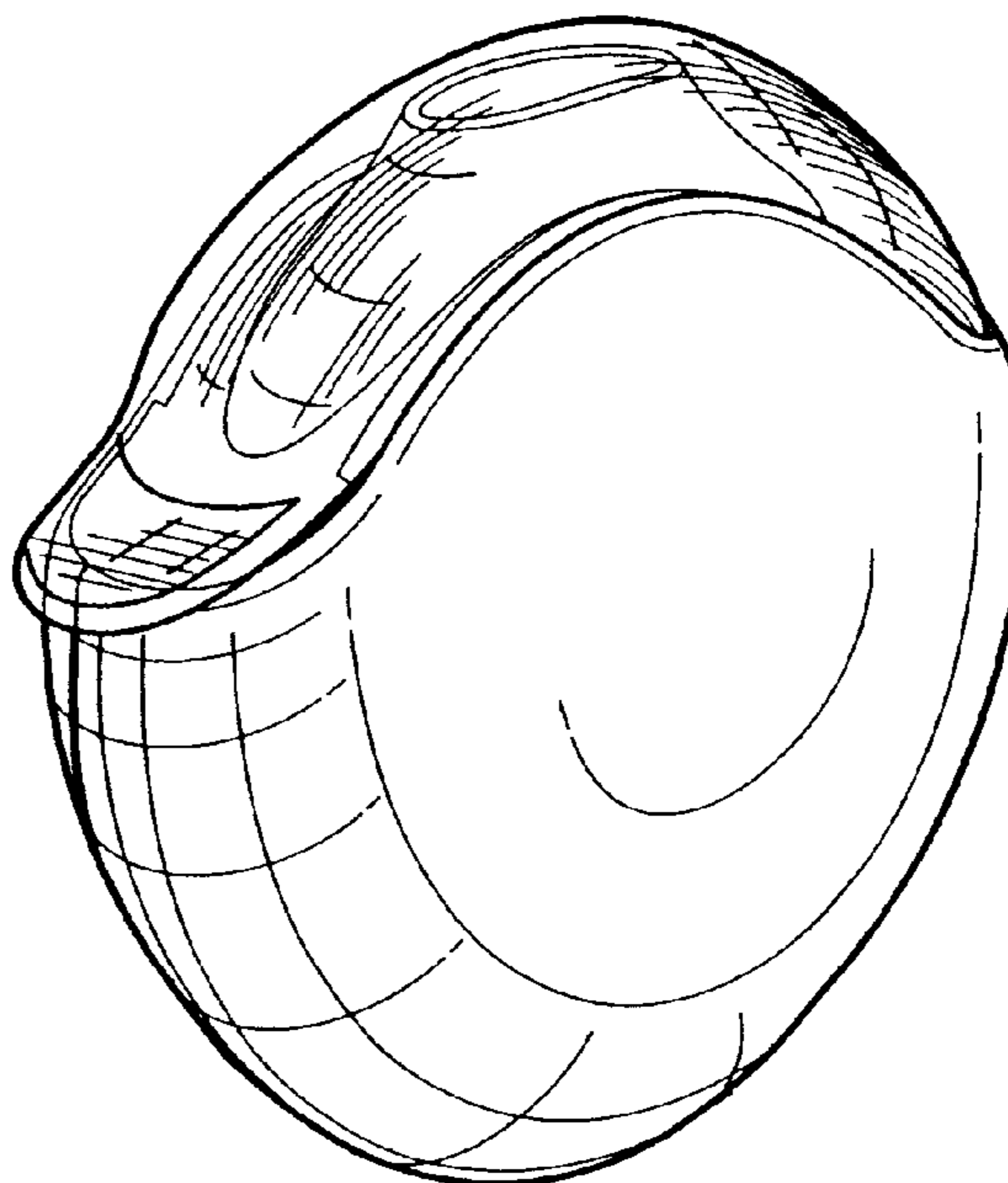
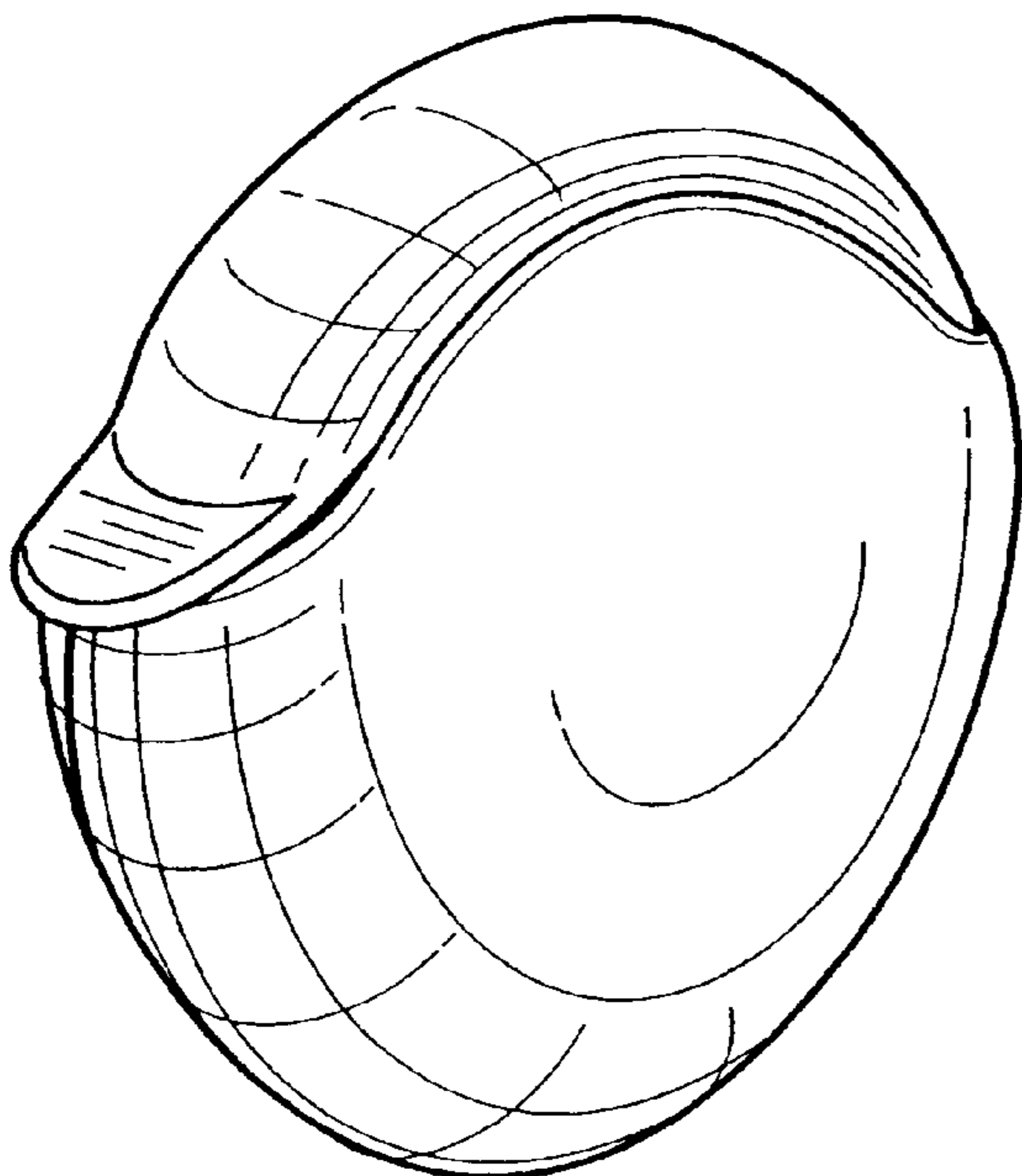

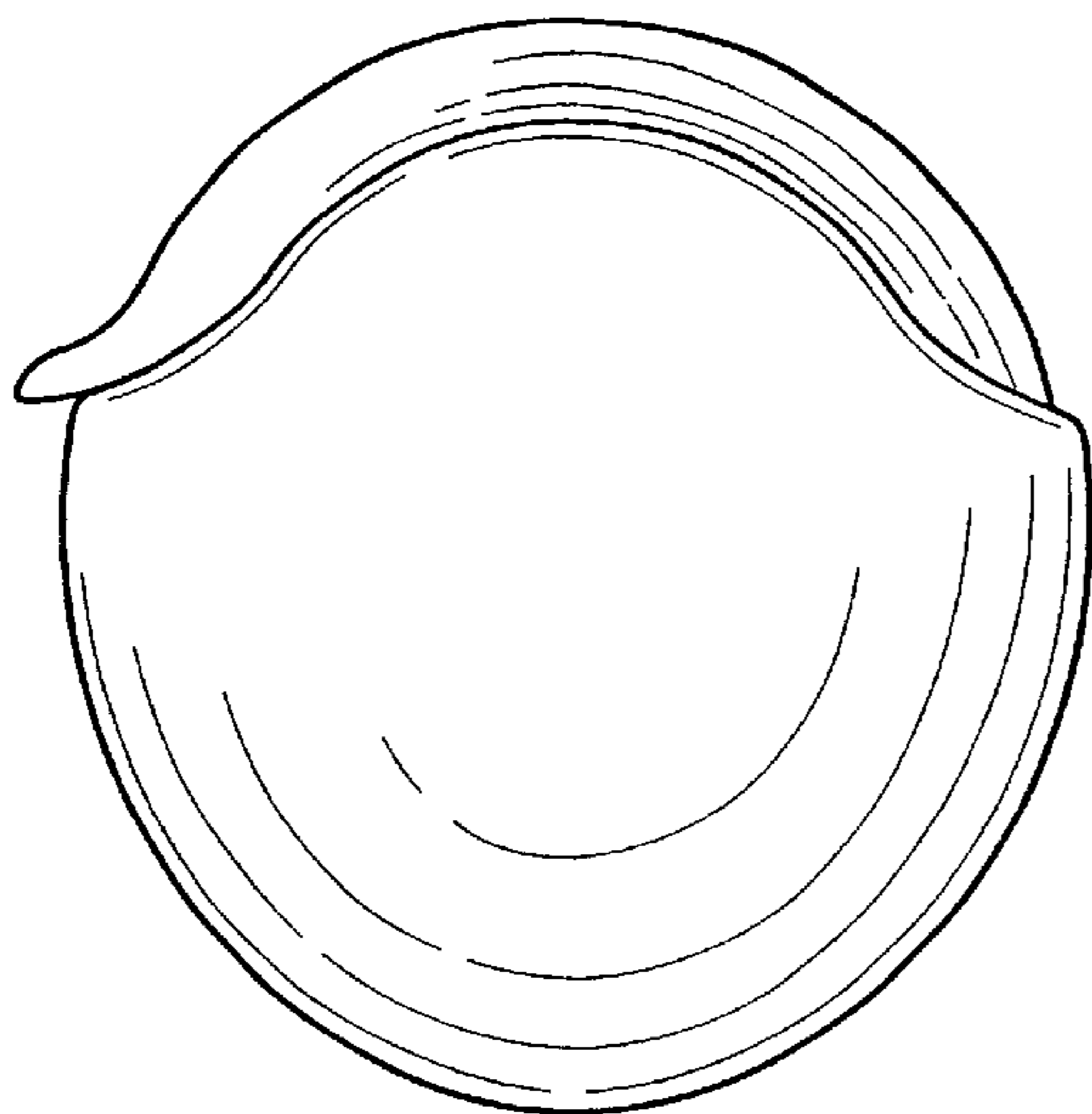

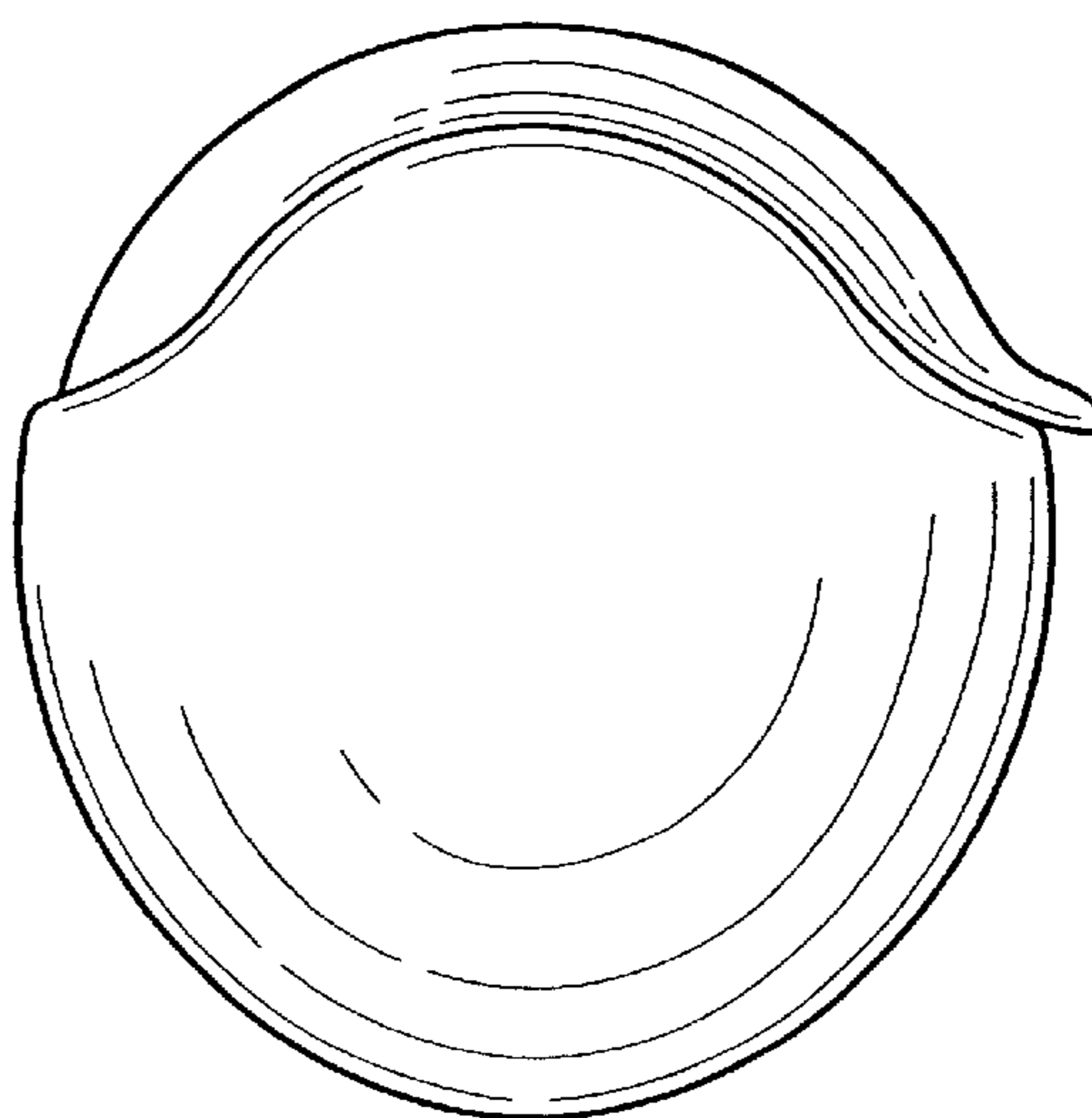

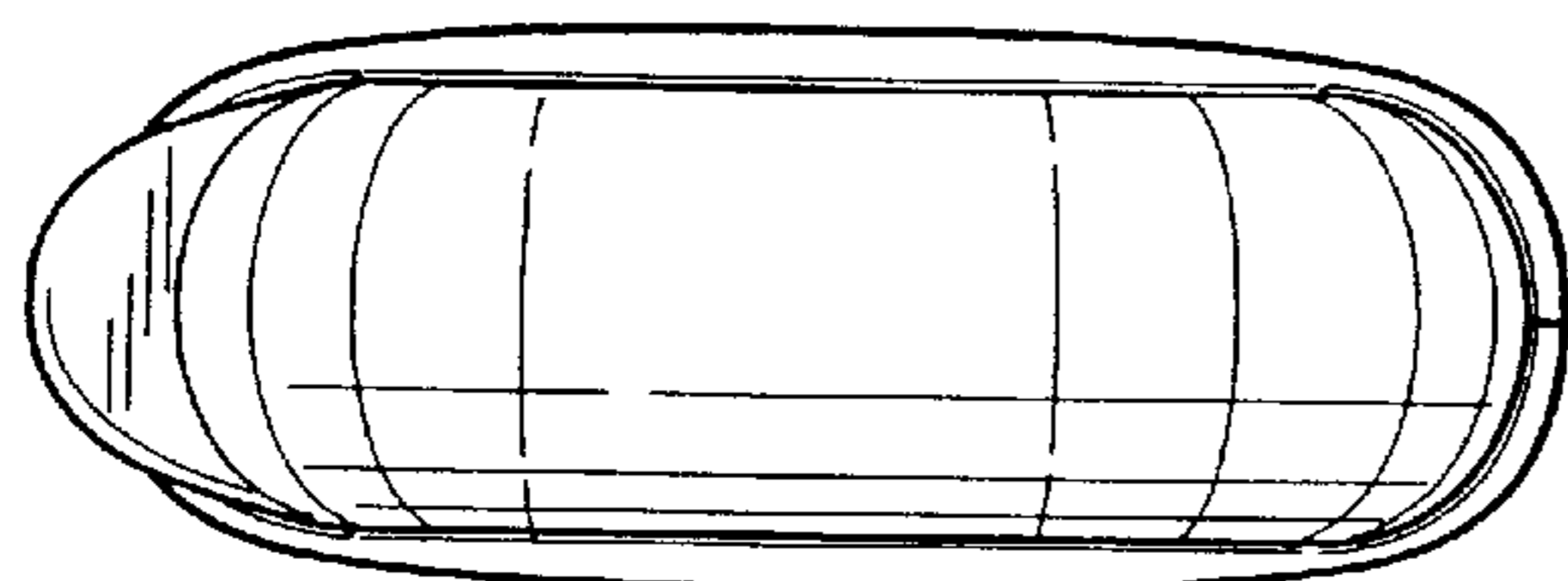

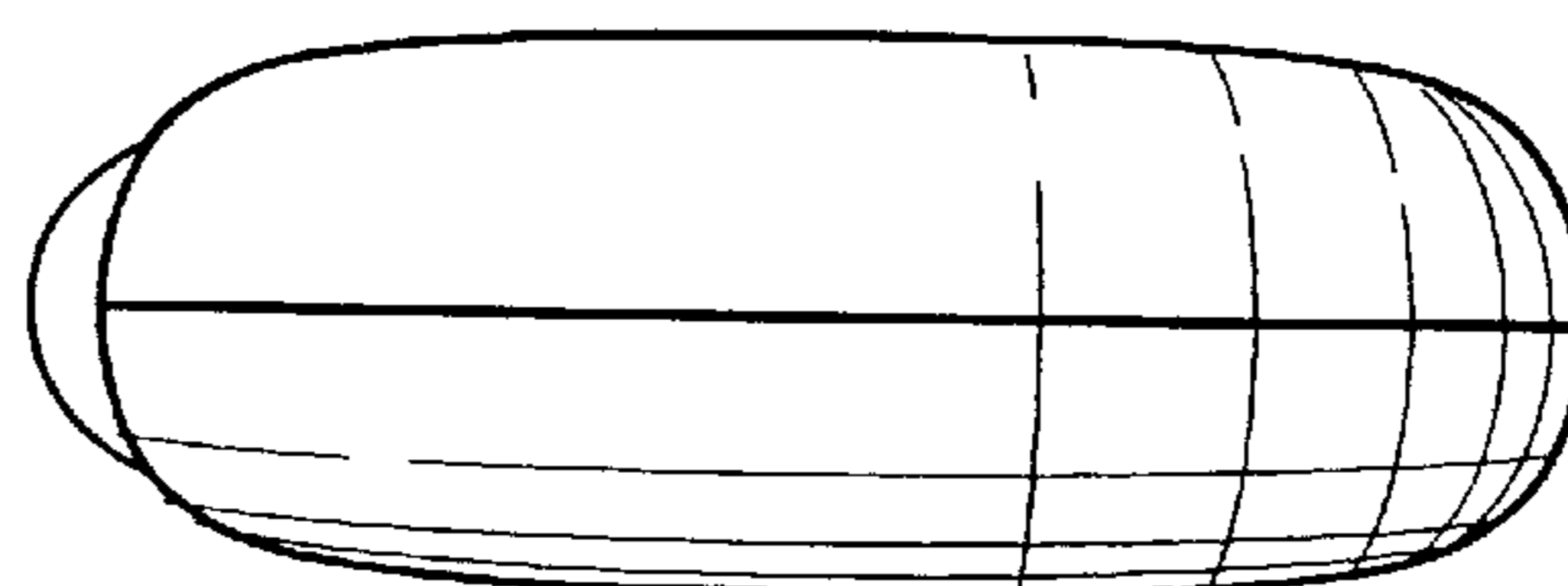

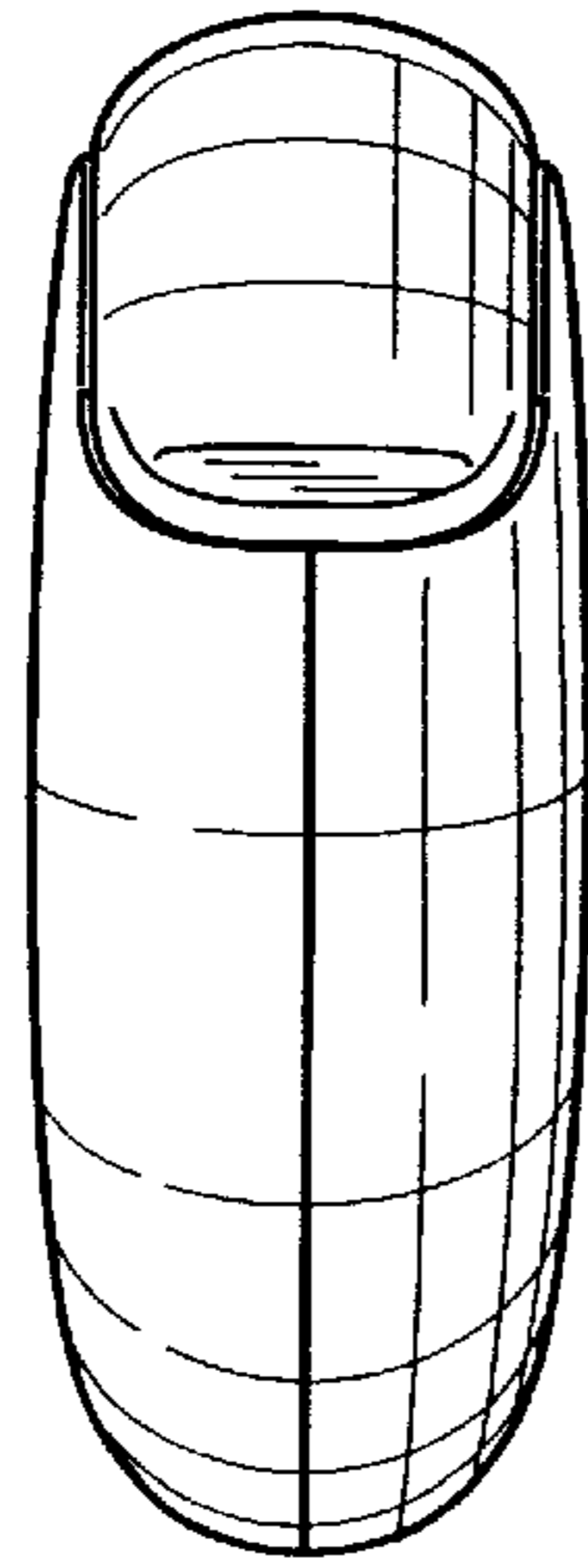

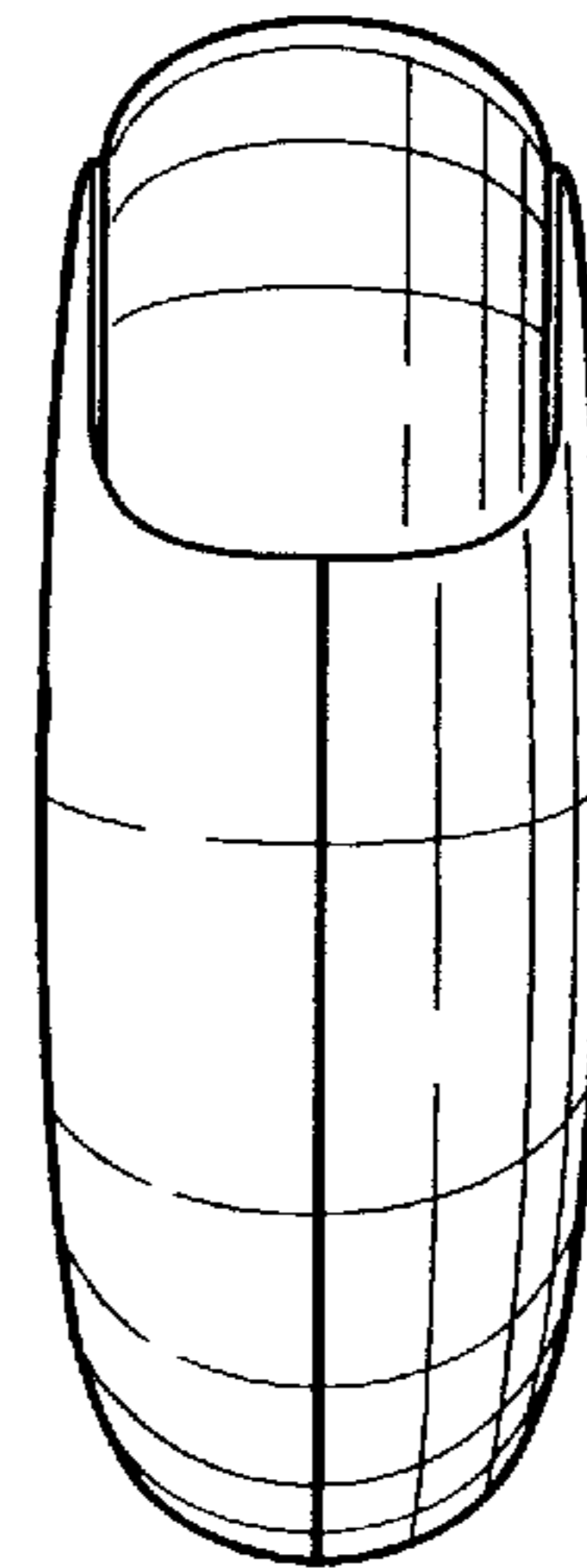

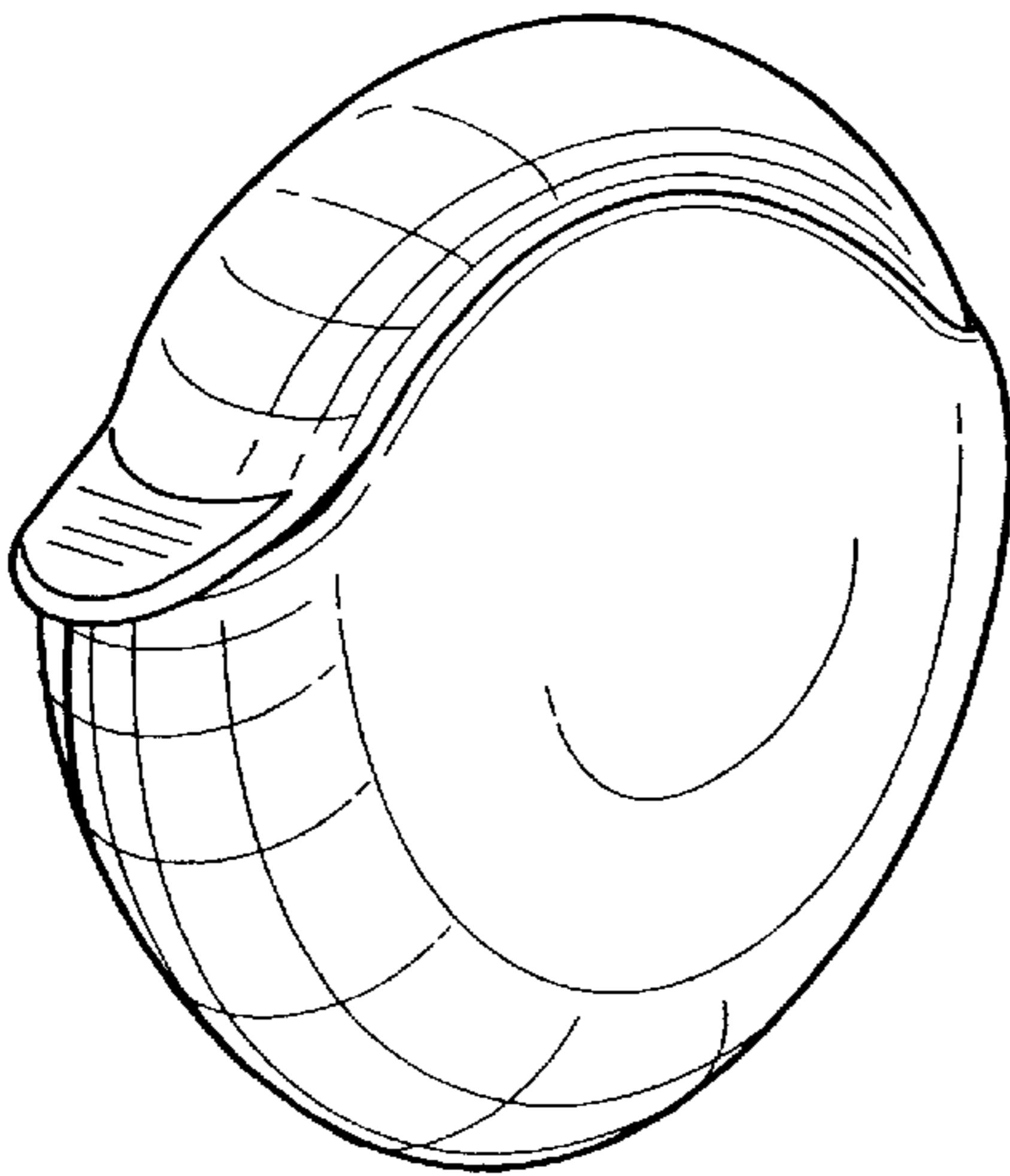

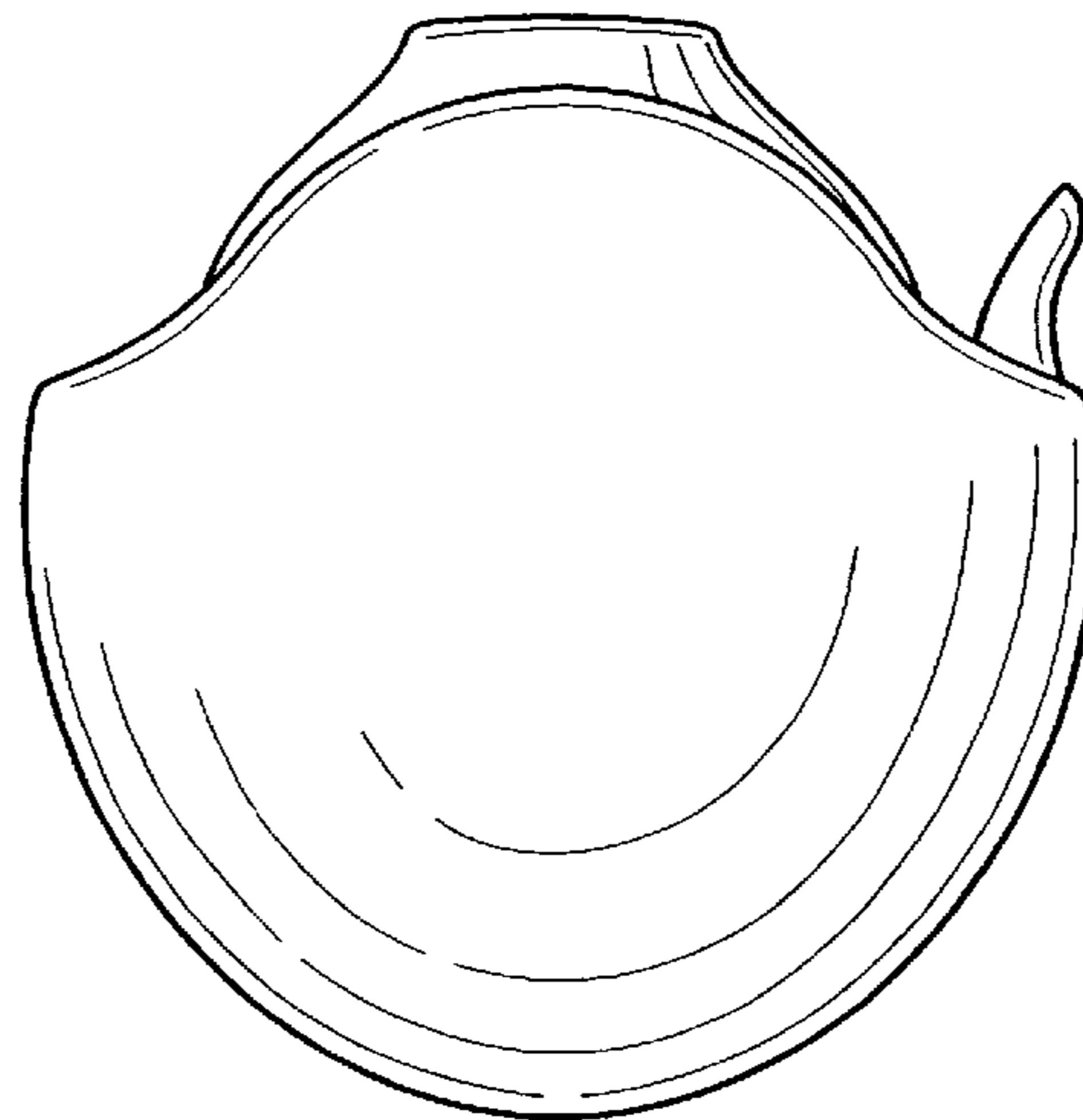

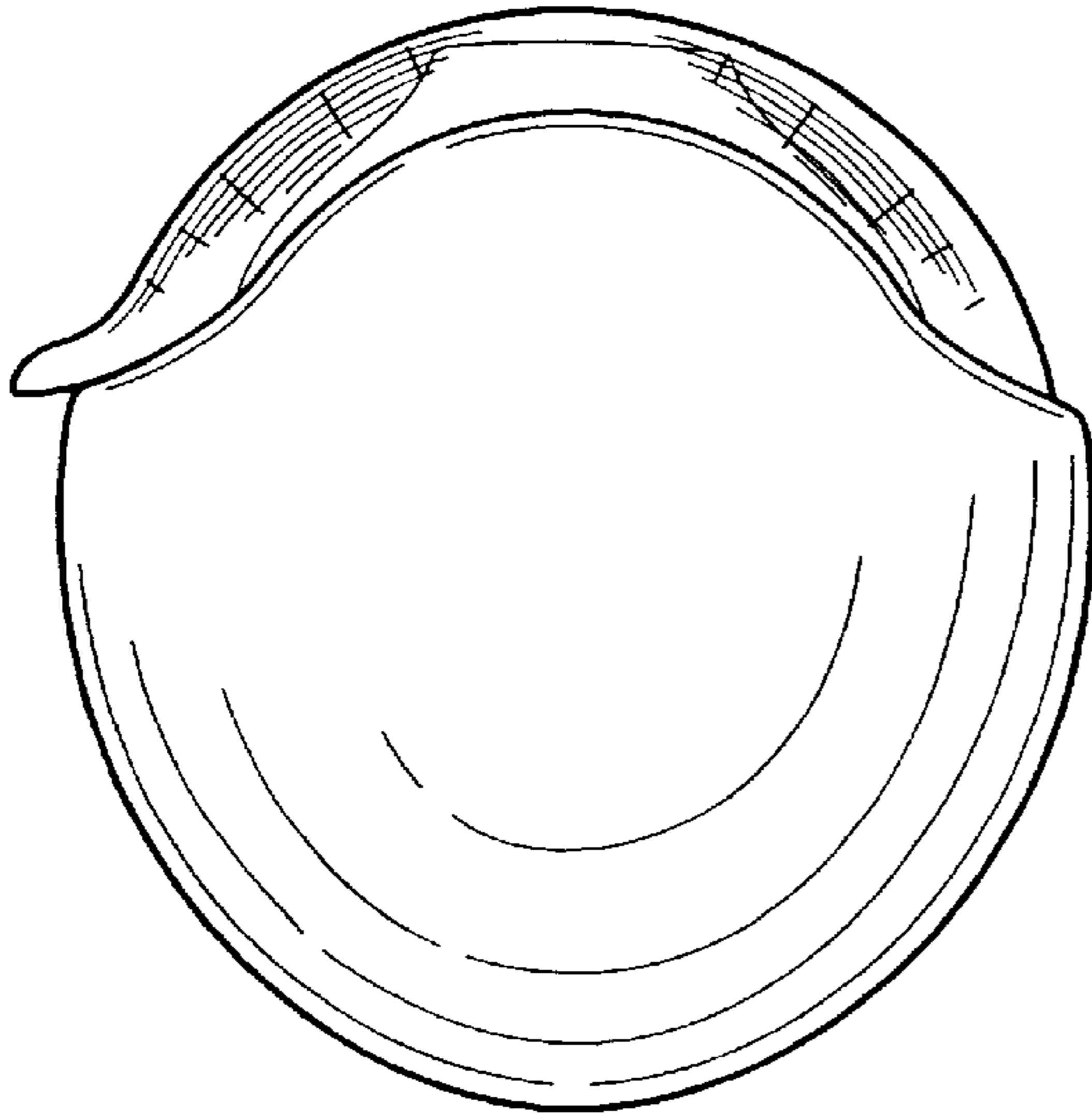

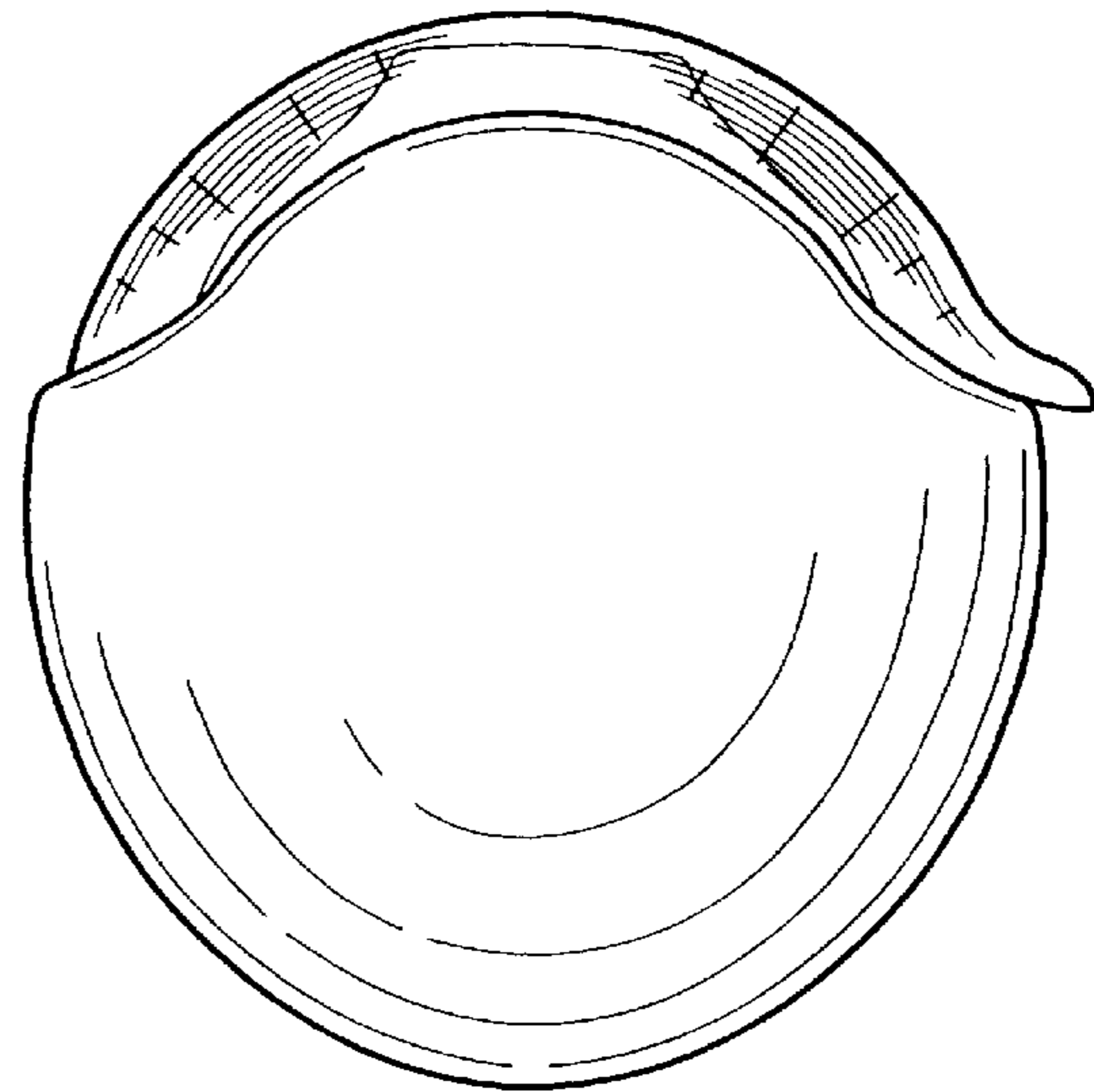

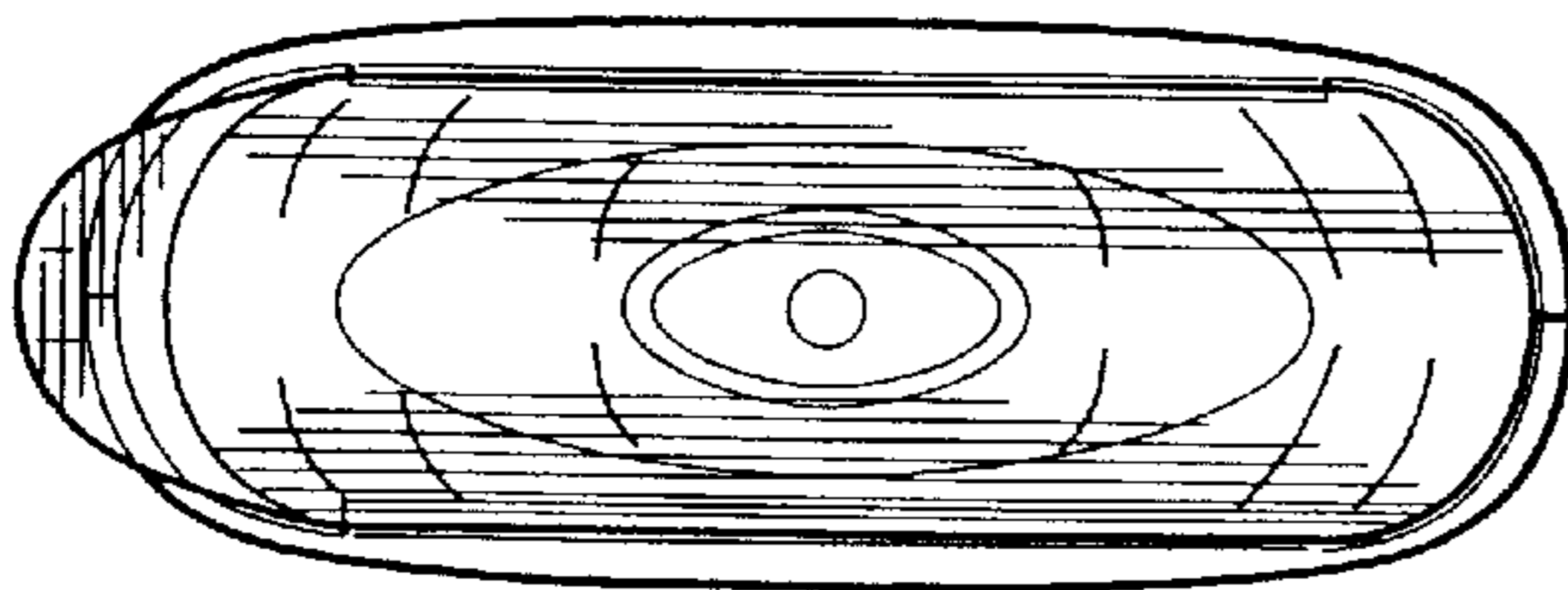

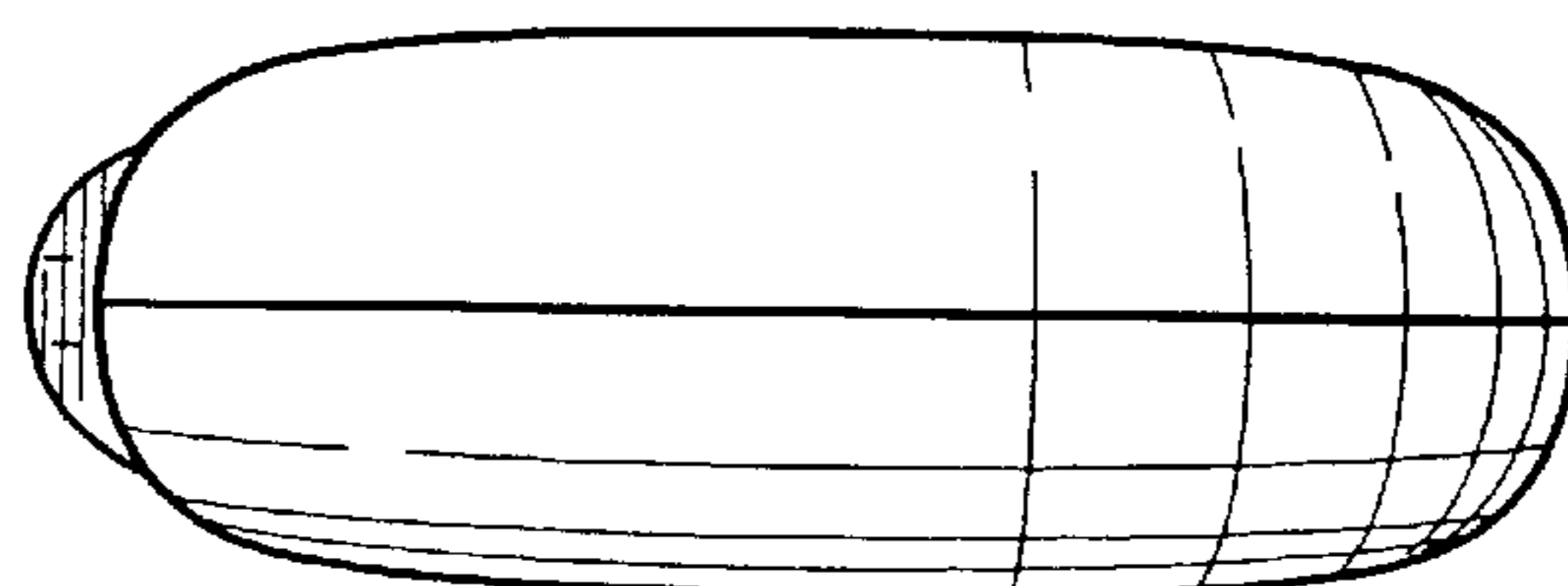

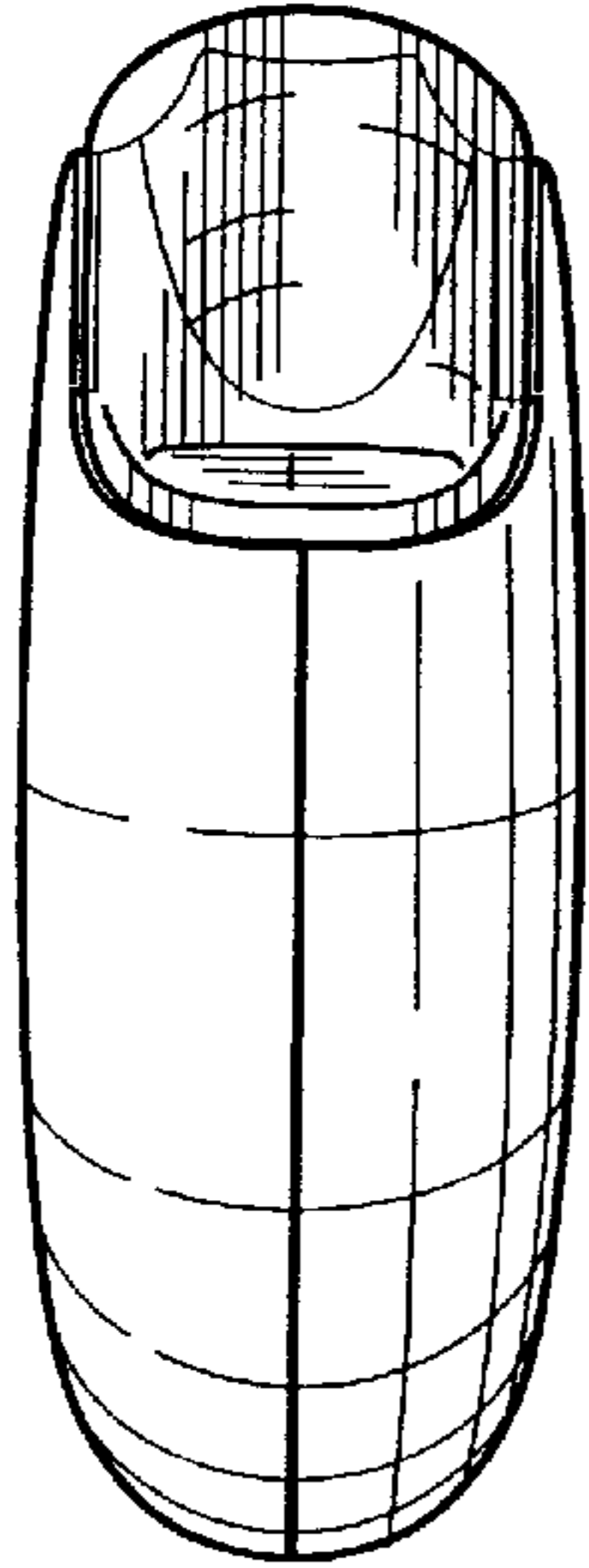

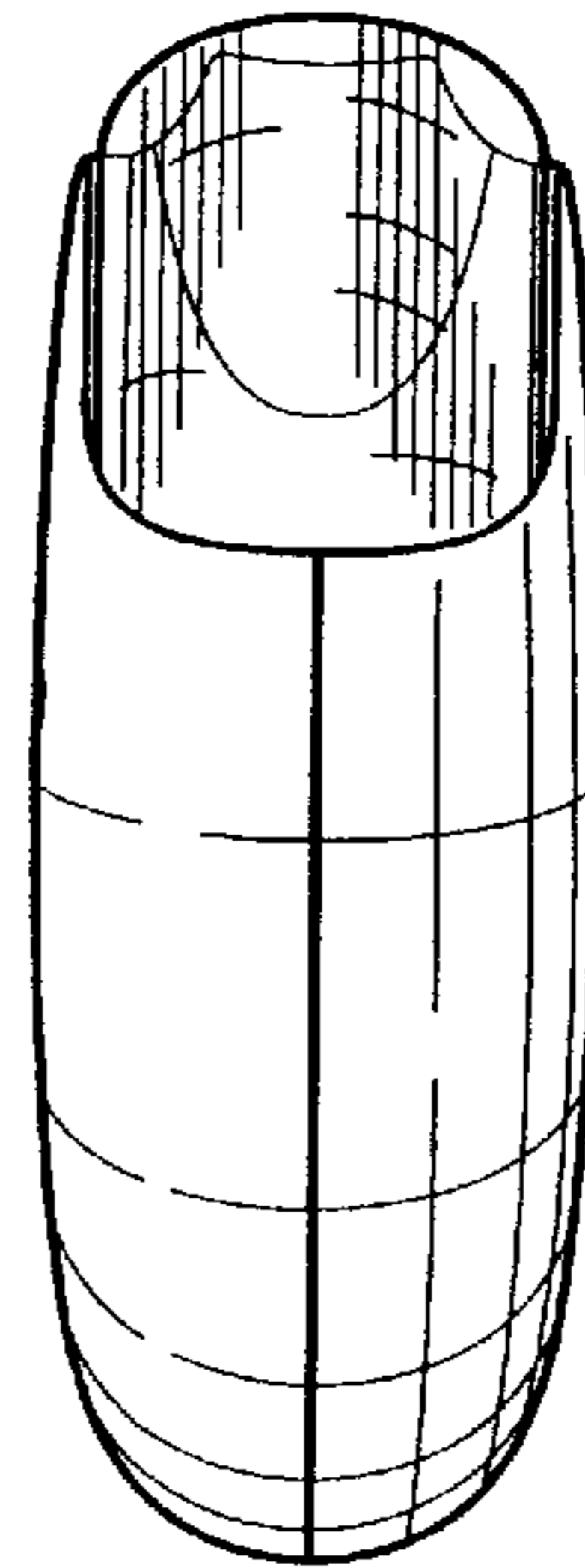

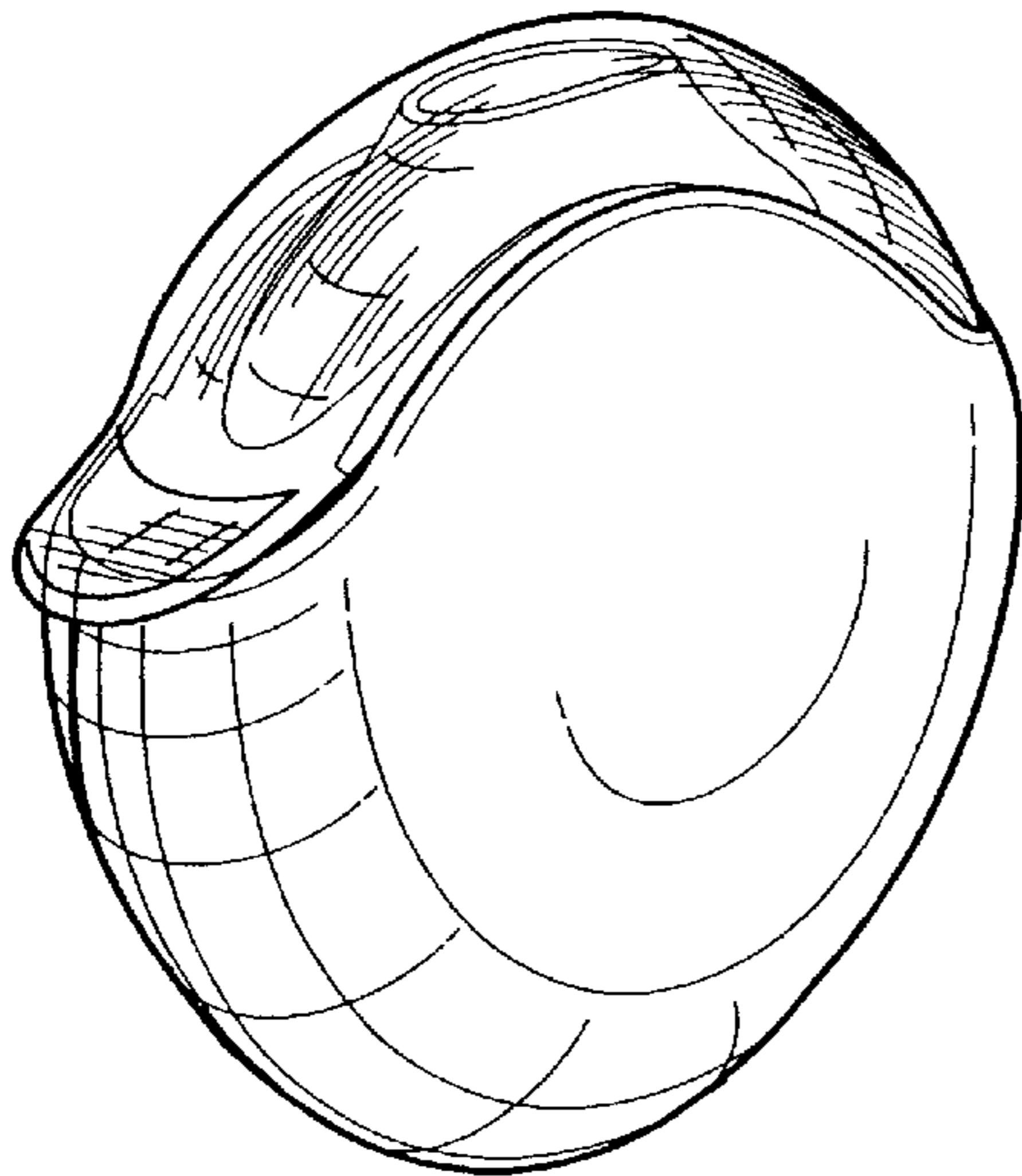
