The ornamental design for a handle for medical devices, and
medical device assemblies using a handle, as shown and
described.

DESCRIPTION

FIG. 1 is a top view of a first embodiment of a handle for
medical devices, and medical device assemblies using a
handle, showing our design.

FIG. 2 is a front view of the embodiment of FIG. 1;

FIG. 3 is a bottom view of the embodiment of FIG. 1,
showing the side opposite that in FIG. 1;

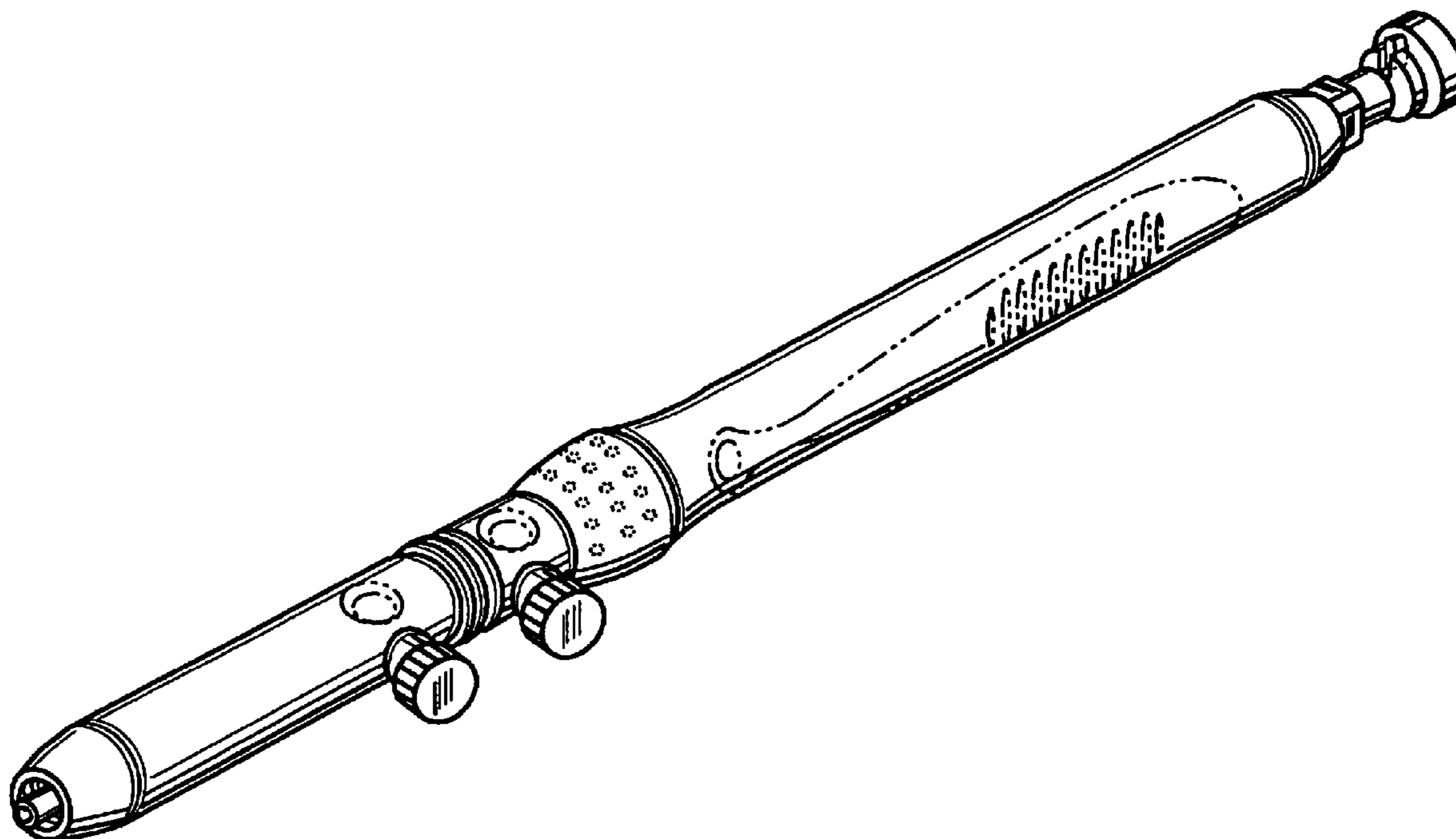
FIG. 4 is a rear view, showing the side opposite that in FIG.

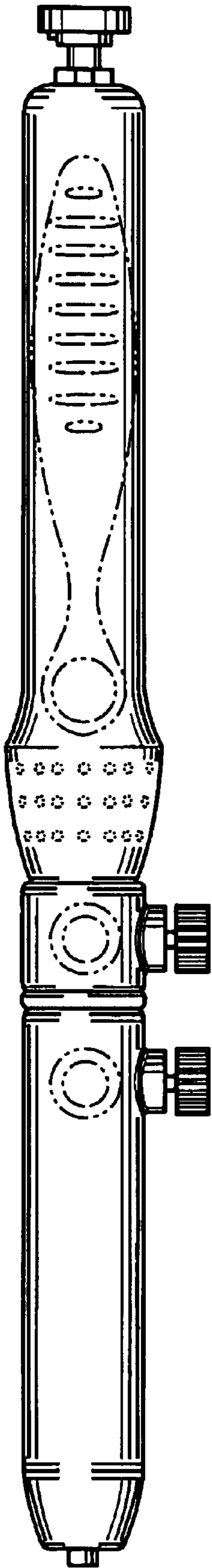

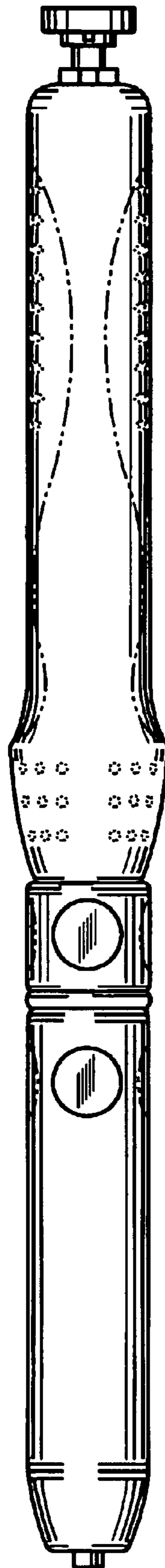

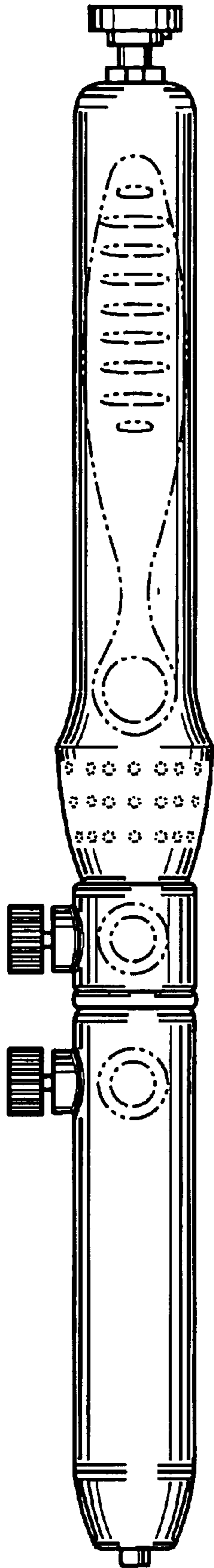

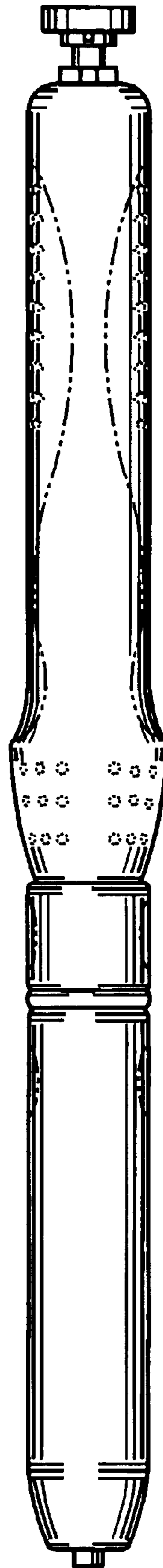

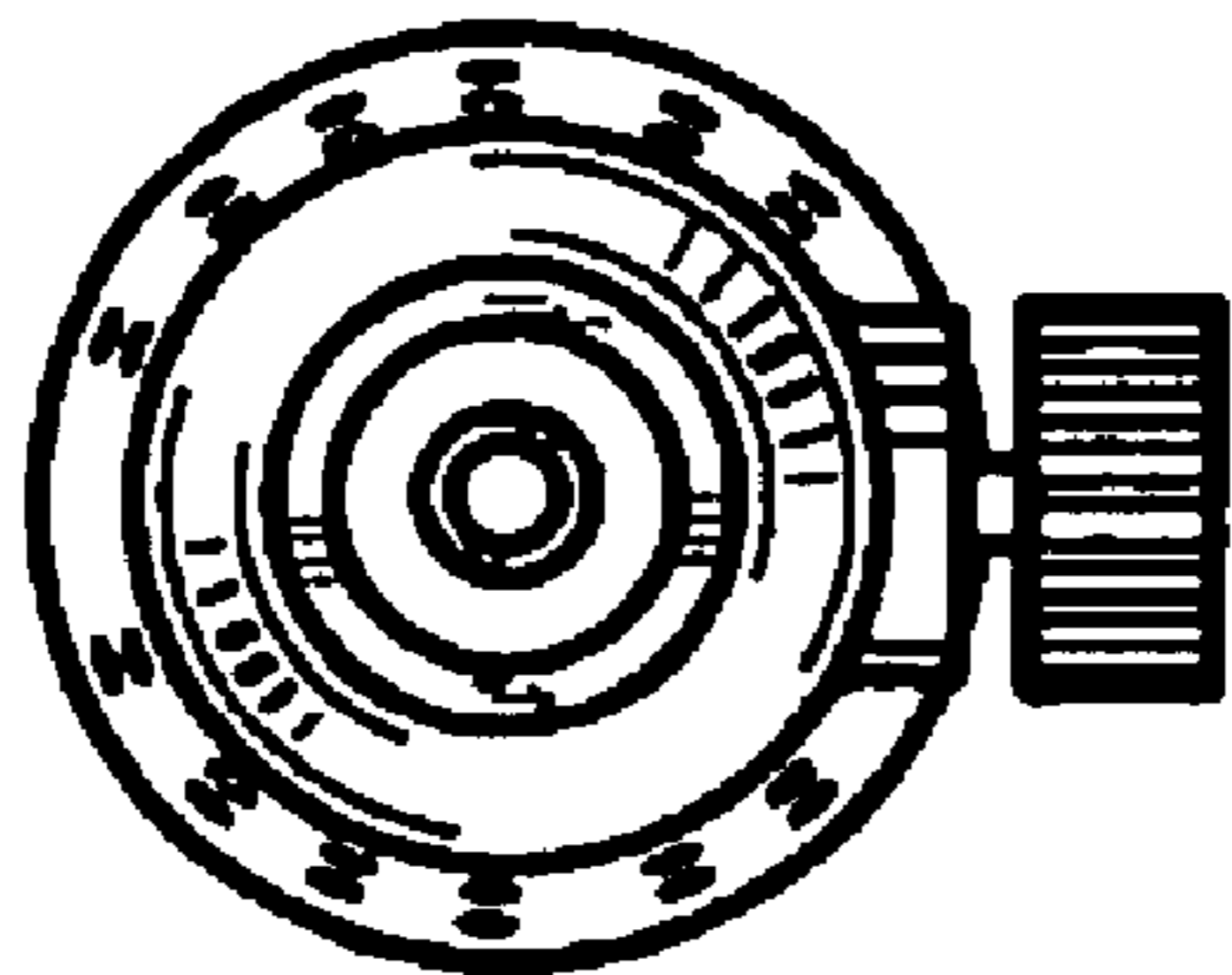

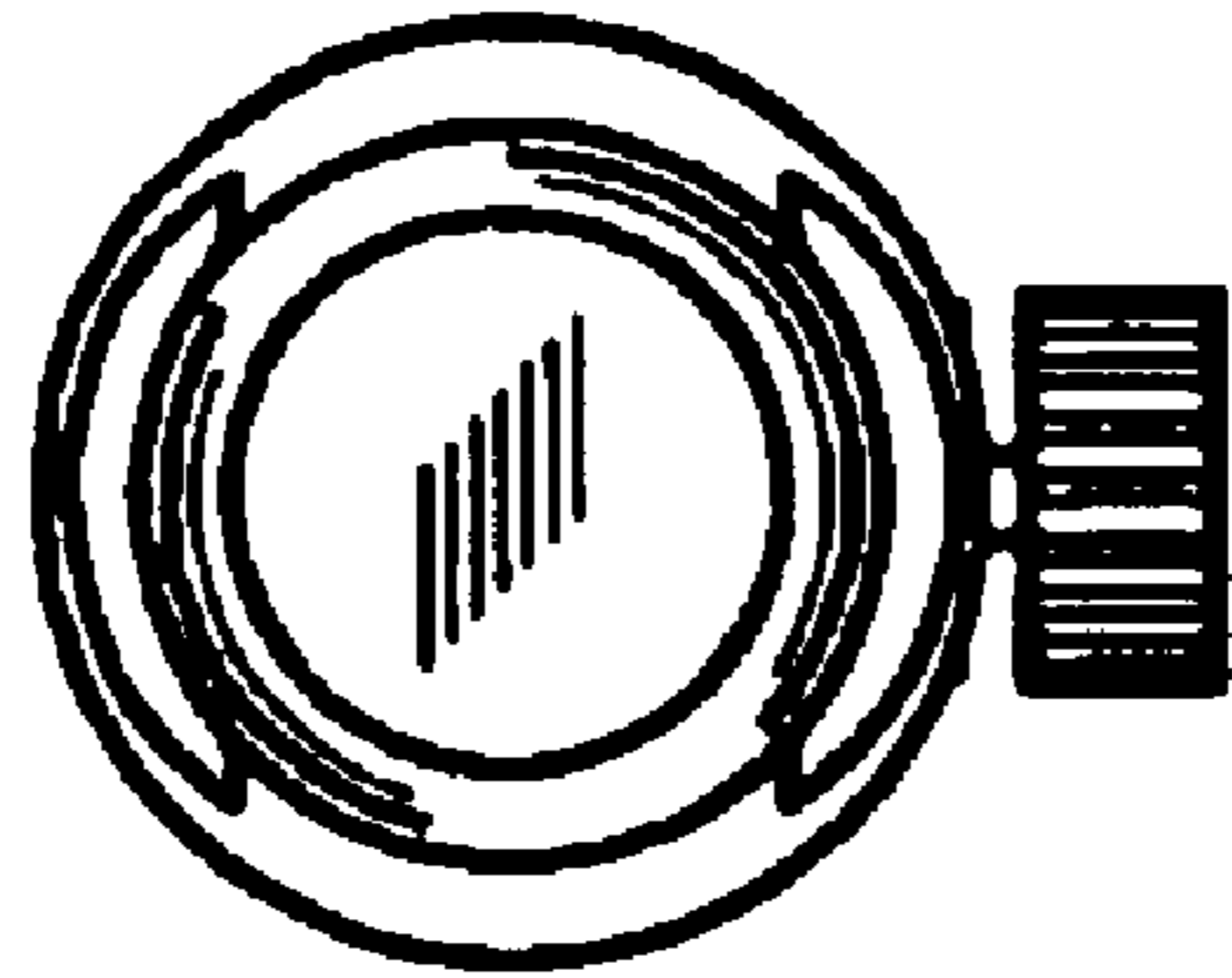

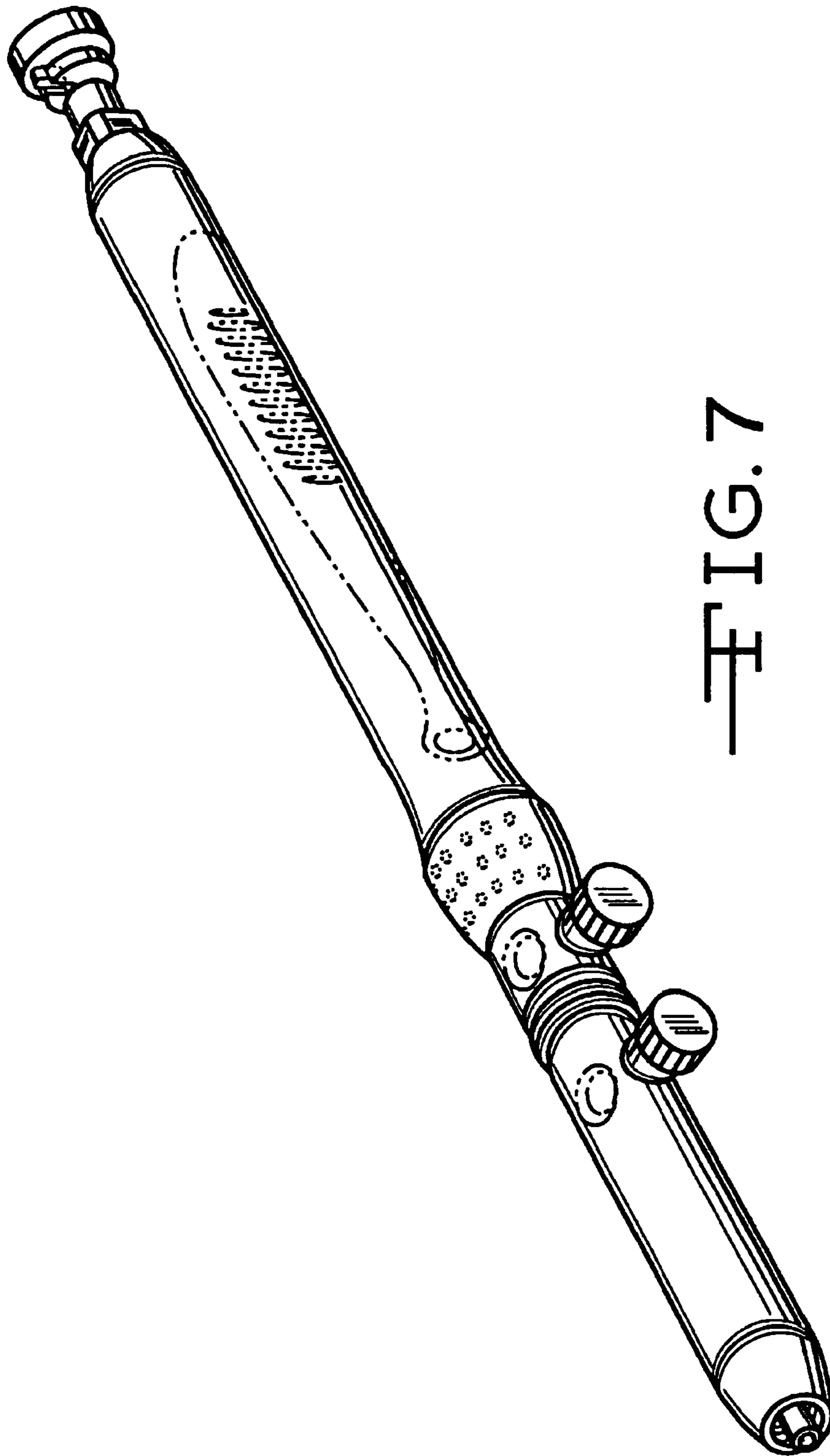
