(57) **CLAIM**

I claim the ornamental design for the cover for rail attachment, as shown and described.

DESCRIPTION

The present invention is the ornamental design for the cover for rail attachment. The nature and environmental use of the claimed design is as follows: The cover has an opening that receives an end of a rail. The cover hides or covers the attachment of the rail to a support post.

FIG. 1 is a perspective view of a cover for a rail attachment according to the present invention;

FIG. 2 is a top view of the cover for a rail attachment;

FIG. 3 is a right side view of the cover for a rail attachment;

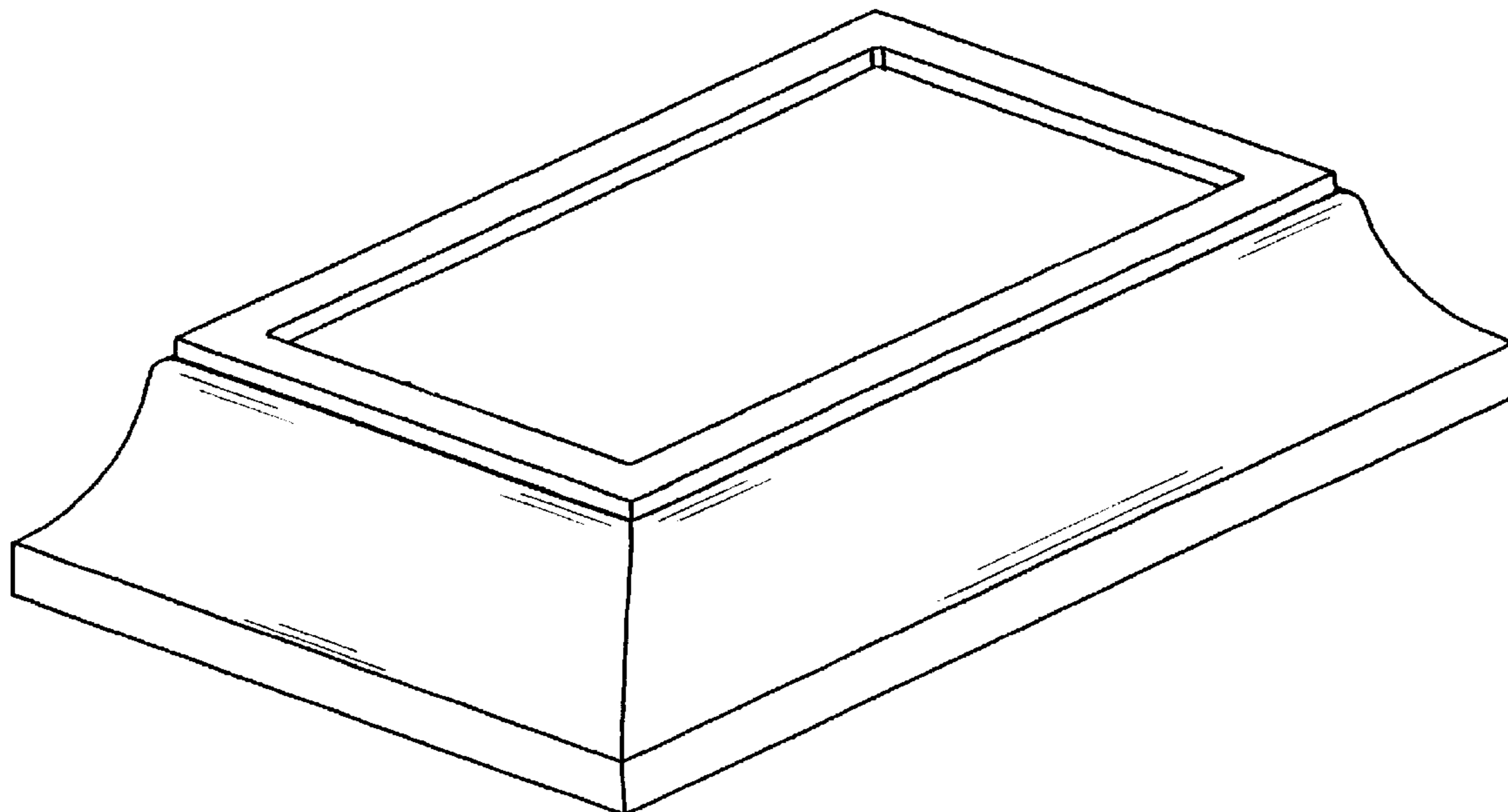
FIG. 4 is an inverted view of the left side of the cover for a rail attachment;

FIG. 5 is a front view of the cover for a rail attachment; and,

FIG. 6 is a rear view of the cover for a rail attachment.

Ordinarily, the bottom of the cover will not be visible when the cover is in use as a cover for a rail attachment.

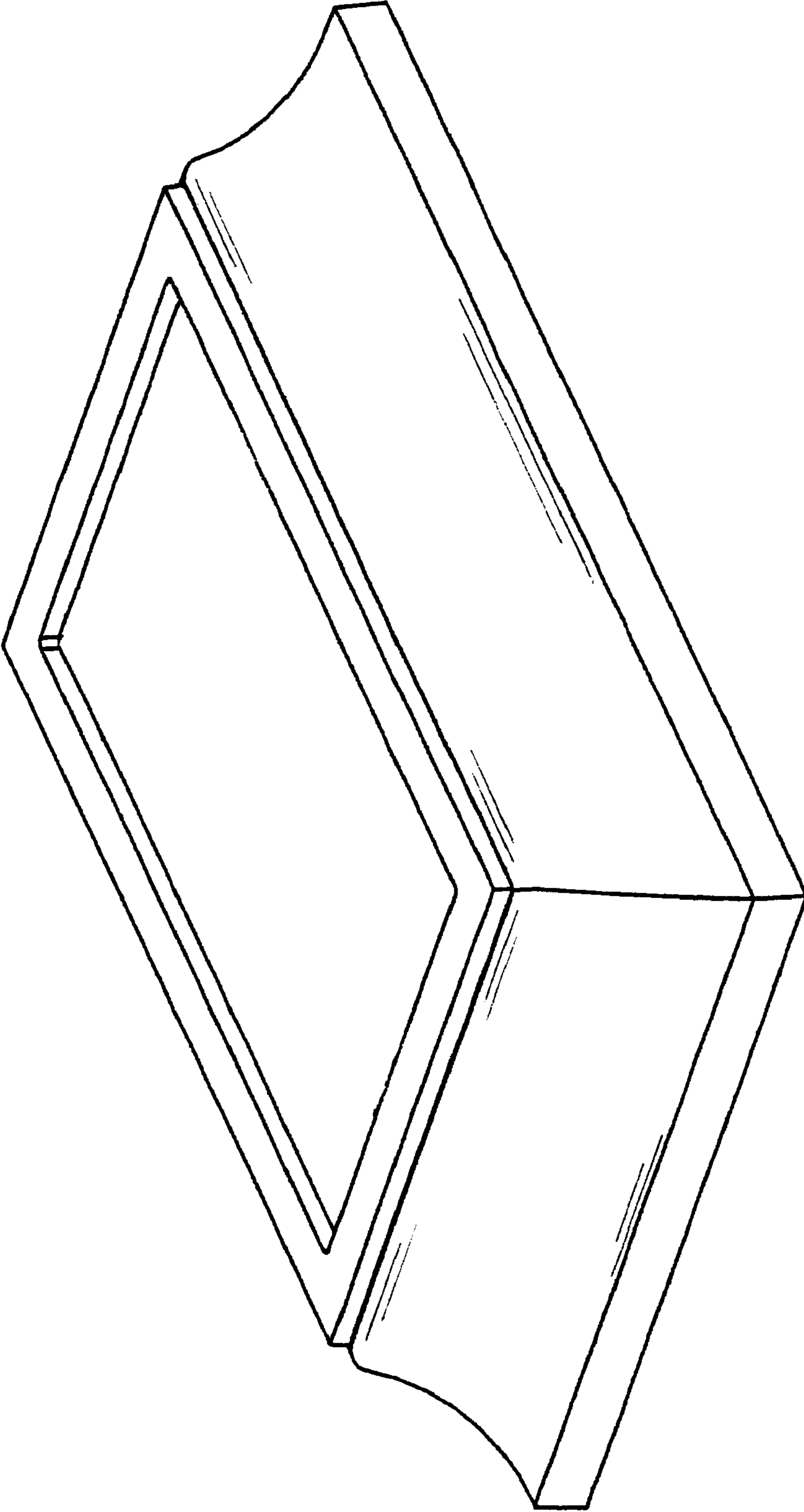

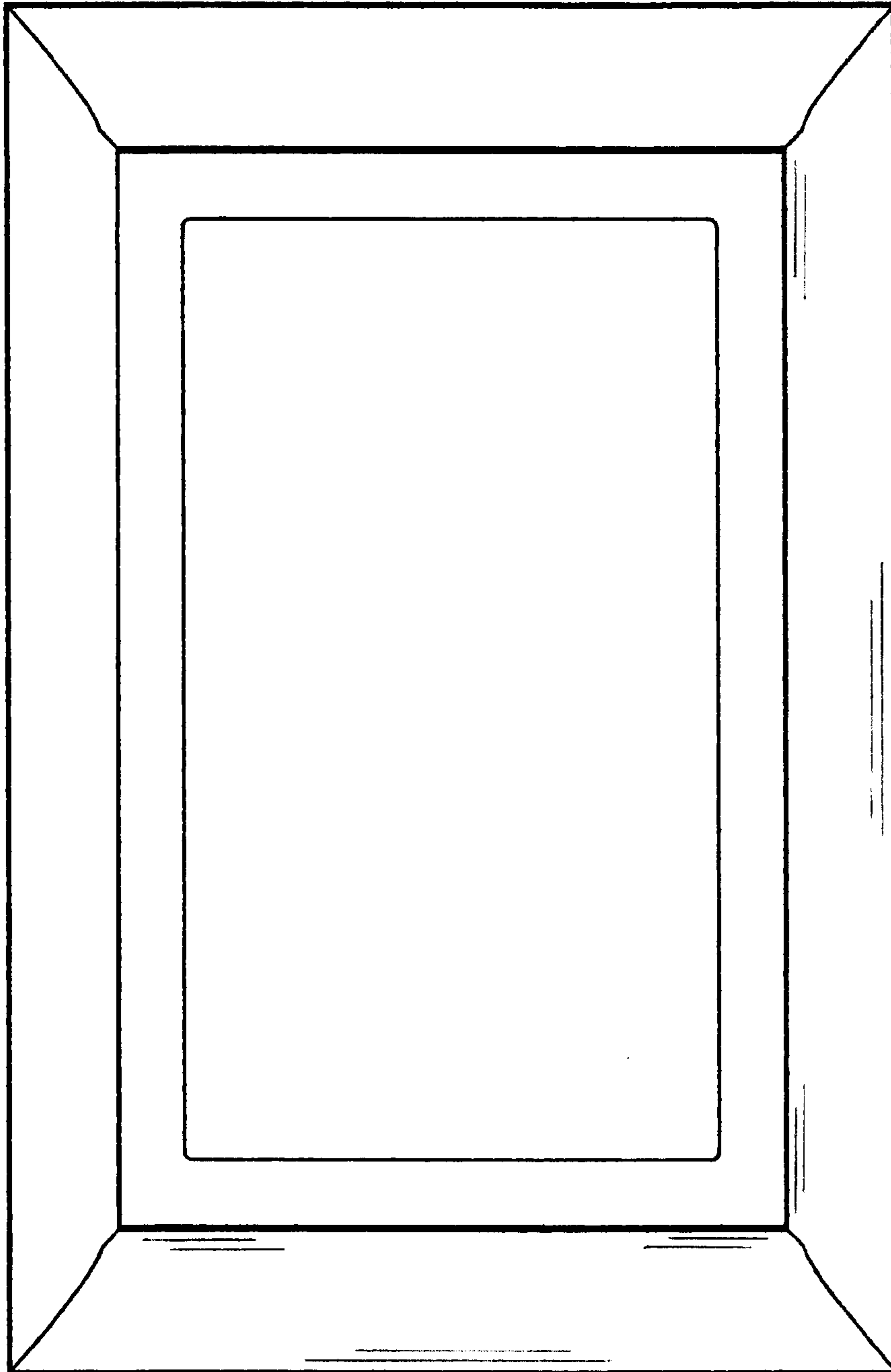

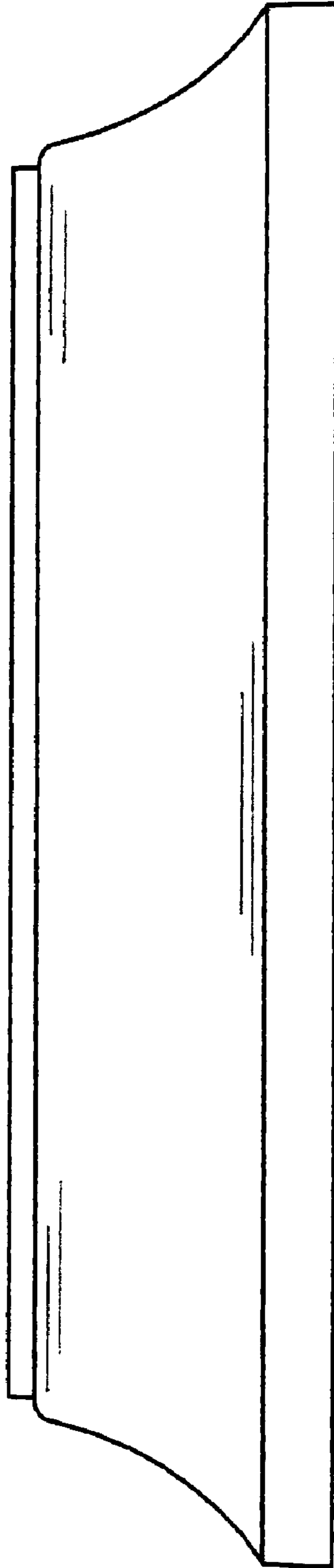

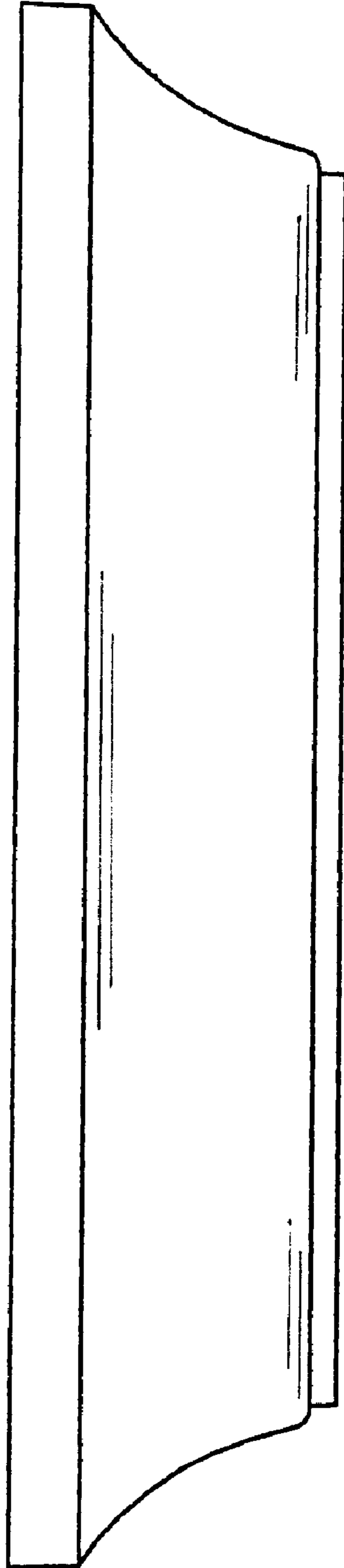

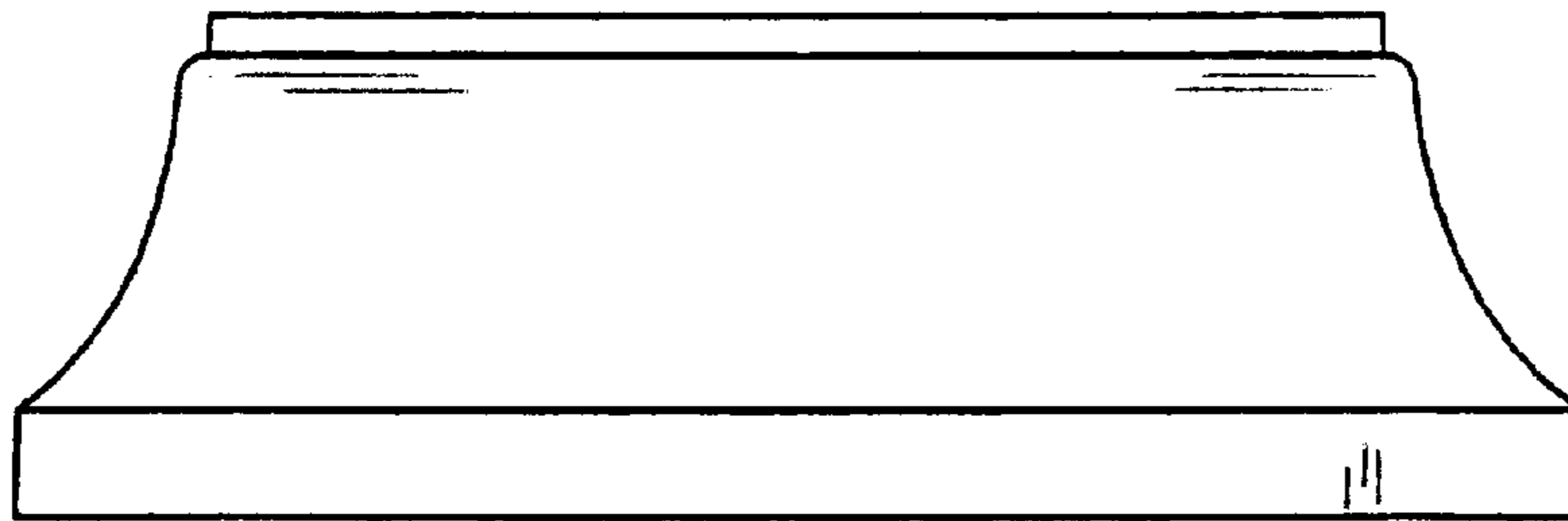

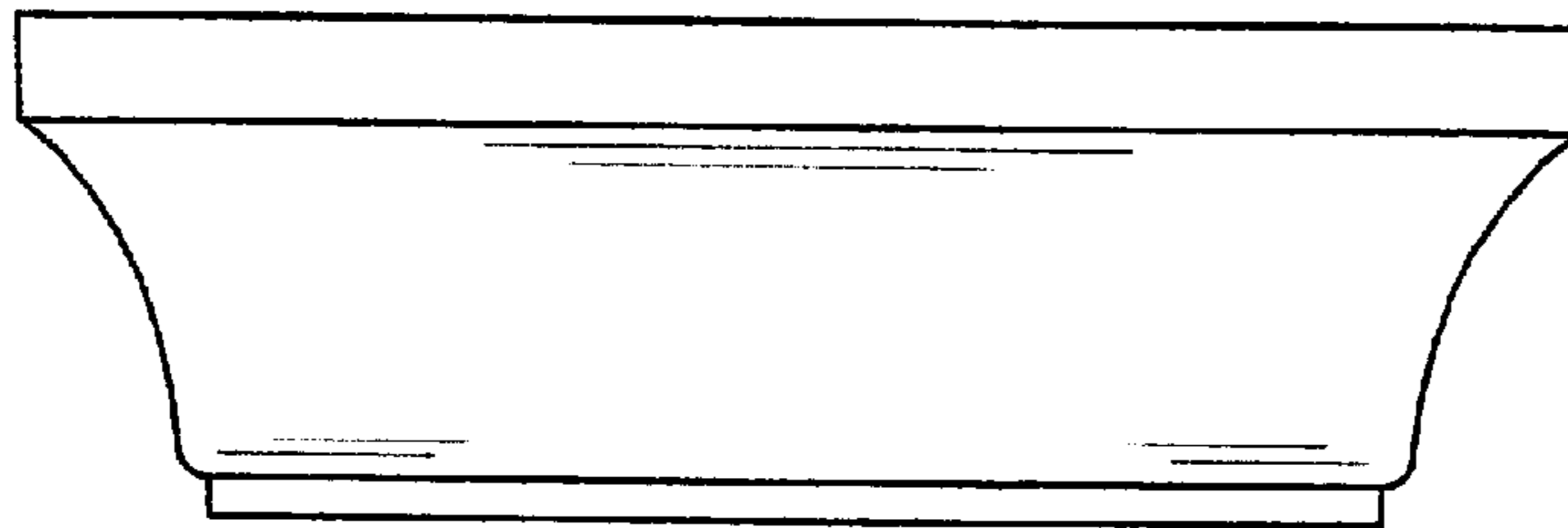
